Peace Proposals Pending.

San Antonio, Texas, March 28.—Francisco I. Madero, sr., father of the insurrecto leader, declared on arrival here today that peace in Mexico is assured, probably within 10 days.

Diplomatic exchanges had proceeded sufficiently, senior Madero added, to make it safe to state that the office of vice president, at present occupied by senior Corral, whom he termed obnoxious, would be abolished for the time being at least.

He predicted that the resignation of Corral would leave the functions of the office of vice president to the new foreign minister, senior De La Barra.

Diaz will save his face by remaining in office four or six months and then resign, Madero said. He will plead weariness owing to his many years. It will then fall to De La Barra to become the defacto president and call an election.

The administration party, it is said, will choose Limantour, minister of finance, as its candidate for president.

Two Brothers Killed.

The dispatches of Monday contain a statement of a fight in eastern New Mexico, near Kenna, Chaves county, in which two brothers were killed by William Zumwalt, who is now in jail awaiting trial. The Zumwalt mentioned is, his friends here say, the son of Noah Zumwalt, an old resident of this county and who now lives at Capitan. The dispatch reads:

Albuquerque, N. M., March 27.—Tom and Ed. Hall, brothers, are dead and William Zumwalt is in jail as the result of a three cornered duel of revolvers which occurred near Kenna, N. M. The men were all cattlemen and owners of small ranches near Kenna. The fight was the result of a dispute concerning the ownership of some cattle.

A small boy, the only witness of the tragedy, says all three men were mounted and that shortly after they met the shooting began. An empty six-shooter was found beside the body of Ed. Hall, while clutched in the dead hand of his brother was a revolver fully loaded. Zumwalt surrendered to the sheriff. Further than to admit that he did the shooting he would make no statement.

Americans Blamed.

The New York Tribune insists that Americans are to blame for the near approach to war in Mexico. The paper asserts that it is the Americans stirring up trouble in order to bring about war with this county. The article reads.

The serious interest of the case to Americans is greatly intensified

by the fact that some of the leaders of the insurgents are Americans, and that the train wrecking, the arson and the looting have been in part the work of American filibusters. Now it will not be pleasant to hear that American citizens have been seized and summarily shot or hanged without trial. Yet it is still less pleasant to know that as our correspondent reports, and as there has long been only too good reason to suspect. American citizens have been committing, or at least, directing, the wrecking of trains and the potential slaughter of women and children, and have done so far the deliberate purpose of provoking a war between the United States and Mexico. We should say that no American guilty of such conduct was deserving of more than a very short shrift. Yet it is desirable that the Mexicans shall make certain of the guilt of every victim of their summary justice, for it would be exceedingly unpleasant for all concerned to have innocent Americans thus done to death. It is a case in which Mexico can not afford to act rashly or to have her soldiers make mistakes.

An Interesting Lecture.

Dr. Frank H. H. Roberts, president of the Normal University of Las Vegas, New Mexico, arrived on the noon train Tuesday, and delivered an entertaining lecture at the Baptist church that night. The lecture was on the subject of education, but was not confined to the instruction to be gained only in the schools. He dwelt largely and forcibly on the life in the home, and interspersed his lecture with telling anecdotes and apt illustrations. The house was packed and throughout the lecture showed its appreciation of the man and his subject.

While here Doctor Roberts visited the public schools, meeting the teachers, addressing the pupils and in every way encouraging the work—a work which he has made his life work. He was also taken for a drive out to the malpais the following morning, to witness one of the curiosities of nature, and returning at noon took the train for Santa Rosa, where he was to deliver a lecture Wednesday night. His visit was much appreciated by our people, and they will be glad to see and hear him again.

Freak Rain in Kansas.

Wathena, Kans., March.—Citizens of this town were spattered with a rain of mud Sunday. The phenomenon is accounted for by the fact that a high wind and dust storm was prevailing when a light rain began to fall. It is explained that the drops of water collected the dust in the atmosphere, turning them into mud.

WORTH KEEPING IN MEMORY

Cleaning Hints That, Some Time or Another, Are Sure to Be Found of Value.

Cover marble with a paste made by mixing French chalk with alcohol, and allow the figure to become perfectly dry. Then brush the powder away. If the result is not satisfactory wipe over with a rag dipped in javelle water. This is a mild bleach.

In cleaning oil cloth little water should be used, because if any gets underneath each time it is washed the oil cloth will rot.

A little kerosene added to the water will brighten oil cloth unless it is much worn or has been washed with water so hot that the varnish has been removed during the process.

In this case, only a thin transparent varnish will remedy matters.


To remove the green from brass mix one teaspoonful of oxalic acid with one cupful of water, and with a clean rag rub the article to be cleaned thoroughly.

Wash off with hot soap and water, removing all the oxalic acid, and then polish with any of the good preparations that are on the market for cleaning brass.

STEAM AS AID IN COOKING

Simple Improvement That is Said to Produce the Best of Results.

By a very simple improvement in the familiar cooker, it is claimed that the preparation of food is greatly facilitated. The cooker consists of two pans, one nested within the other, and the improvement referred to lies sim-



ply in the making of a number of perforations along the edge of the inner receptacle, which is the one designed to contain the food to be treated. The lid fits over both pans in such a way that the steam from the water in the lower receptacle passes up to the interior of the chamber containing the food. Because of the additional heat the cooking is accomplished in less time and the moisture supplied by the steam prevents the food from becoming too dry.

Chocolate Chips.

Place in a saucepan one cupful of brown sugar and one cupful of Orleans molasses, and one tablespoonful of butter. Boil until it spins a thread or forms a hard ball when dropped into cold water; then removed from the fire and flavor with one teaspoonful of vanilla. Pull into long thin sheets, then cut into small pieces, When cold dip into melted chocolate flavored with vanilla.

Quick Broth.

One cup of chicken or turkey stock made by using bits of left-over meat and breaking the bones and cooking them until all the juice is extracted, one-half cup of cooked rice, one cup of vegetable puree, one-half carrot, one-half onion, minced. Add a pint and a half of boiling water, one teaspoon of salt or less. Let boil and skim well. Simmer for about an hour. Season, strain and serve.

FOR AFTERNOON TEA TABLE

Novel Little Cakes With Which Hostess May Please the Guests In Her Home.

The hostess who likes novel little cakes for afternoon tea will find these palatable. A sort of sweet biscuit, shaped like a ladyfinger, is made from the well-beaten whites of three eggs, into which is beaten almost half a pound of confectioner's sugar. Add four ounces of melted butter, and stir in quickly at the last four ounces of pastry flour.

Put this paste into a pastry bag and force through a tube on well-buttered baking sheets. Form finger shapes not too close together, as they spread, and bake in a moderate oven until a delicate brown.

For an almond cake, beat to a cream three ounces of butter and half a pound of soft A sugar, then add gradually half a pint of milk and enough flour to make a light dough. Stir in a quarter of a pound of blanched and minced almonds, lightly floured. Put on a floured board, roll about a quarter of an inch thick, and cut into diamonds and squares.


Almond macaroons are made by beating the whites of three eggs to a stiff froth, then stirring in half a pound of confectioner's sugar and the strained juice of half a lemon, and last half a pound of ground almonds. Put paper on a flat baking sheet, drop the mixture on by teaspoonfuls, and bake in a quick oven until a light brown.

Little German caraway cakes are made by mixing two cups of flour, a cup of butter, a cup and a half of sugar, flour and eggs, two teaspoonfuls of rosewater, and half a cup of caraway seed. Drop on baking sheet and bake in a slow oven from twenty minutes to half an hour.

NEW IDEA FOR COFFEE POT

Simple Contrivance, but It Will Be Highly Appreciated by Every Housewife.

How many housewives have burned their fingers by opening the hot lid of a coffee pot to permit of a freer flow



of the liquid? To obviate this an Iowa man has invented a coffee pot, the lid of which remains closed. By pressing the small lever on the handle air is admitted and it runs out rapidly in a straight stream, instead of gurgling out and splashing over the sides of the cup. This is one of those minor inventions which the average person does not appreciate but which add materially to the comfort and satisfaction of the housekeeper and should interest all men who are anxious to save their wives as much of the unpleasantness of cooking as possible.

Economical Family Pudding.

Bruise with a wooden spoon through a colander six large or 12 middle-sized potatoes, beat four eggs, mix with a pint of good milk, stir in a potato, 6 ounces sugar and flavoring; butter a dish, make half an hour. The recipe is simple and economical. Cold potatoes which may have been kept two or three days till a sufficient quantity is collected will answer quite well.

INEQUALITIES OF THE TARIFF.

The tariff question is one of the biggest questions with which the American people have to deal, and while that is so, it is also one that is generally approached with the most prejudice. Of course, there are many honest differences, but the man who is against or for tariff just because his party is against or for it is not entitled to consideration in the discussion of the question. That inequalities exist in the schedules, however, cannot be gainsaid, and the man who would attempt to defend some of the schedules in the present law either lacks an insight into the heart of the question or favors the schedule for selfish reasons. As a matter of fact, the whole tariff question smacks too much of selfishness, and a system founded upon a basis of selfishness must inevitably fail.

There is little cry of free trade in either party today; for nearly everyone realizes that expenses of government must be met, and to dispense with the tariff system altogether would result in such a radical change that few men would undertake to urge it. However, the inequalities of some of the schedules are such that a mere mention of the rate of duty on a certain class of goods, in a particular schedule, compared with a the same nature of goods, but a finer texture, is sufficient to condemn the schedule in the mind of any man not wholly warped in his judgment. For instance, suppose we were to consider the woolen schedule, and cite a comparison made by Senator La Follette. He said: "My objection is upon yarns valued at less than 30 cents per pound this bill proposes that the people of this country shall pay 143 per cent ad valorem, while on yarns valued at more than 30 cents a pound they will pay only 87 per cent. If you can offer any justification for those two different grades of duty on yarns differing only by the fraction of a cent in value, do it." And the same senator continuing his remarks on the same subject said: "Do not impose a 143 per cent duty upon the cheap grade (which the poor must buy for their clothing) and only about one-half that rate upon the grade purchased by the rich."

Senator Beveridge, speaking on the rate of another commodity, said: "Does the senator from Iowa mean to say that on the cheaper linoleum, commonly used by the people, the duty has been fixed at 60 per cent ad valorem, and on the more expensive linoleum, which is not used by the common people, it is only 25 per cent?"

These are questions that concern the mass of people of this country and they were not asked by free traders, either. Both

Senators La Follette and Beveridge are believers in the principle of protection. But dodge the issue as you will, prate about the protection of the American workman as you may, the fact remains that the protective tariff is written in the interest of the rich at the expense of the poor man.

Is there any reason, then, why the masses, who are poor, should longer be fooled into supporting a high tariff which has fathered the trusts, made the rich richer and the poor poorer? It seems superfluous to ask such a question after the result of last November, and yet there are still a few who consider the Payne-Aldrich tariff law a sacred document.

The fun begins in Washington on the 4th of April. President Taft wants congress to pass the reciprocity treaty with Canada, the lower house wants to reduce Tariff and the upper house wants to do nothing. With these conflicting wants it is not easy to see a favorable outcome for the short session.

Fire caused the death of 141 persons in New York last Saturday. The fire occurred in a shirt factory, and the victims were mostly women. Only one fire escape, it is said, was in operation in the entire building, and an investigation is now in progress in order to fix the blame for the disaster. Somebody should suffer for permitting hundreds of people to endanger their lives in a fire trap of such a nature. Human lives are held too cheap by money-mad concerns.

School Election Monday.

The election for school directors occurs next Monday, the third of April. Under the law, every district is required to elect at least one member of the board for a term of three years. If a vacancy exists, caused by death, resignation or removal and even if the position has been filled by appointment, the appointment holds only until the coming election, and another director must be elected for a term of two years; and if a third director holds office under similar conditions still another director must be elected for a term of one year.

In order to make the matter more fully understood, an outline of the situation in the Carrizozo district affords a fair illustration. Last year Jno. H. Boyd had one more year to serve, but because of the resignation of one of the members and the expiration of the third member's term, it became necessary to elect a member for three years and one for two years. The member elected for

three years has left the territory, and the member elected for two years is now in another district and probably wishes his position considered vacant, though this is still his home and he has not tendered his resignation. Should this member tender his resignation, it would, therefore, be necessary for this district to elect a full board of directors, one for three years, one for two years and one for one year.

Stuffed Onion One of the Best That Can Be Recalled—Varied Methods of Serving the Always Acceptable Potato.

The days are here when the average housewife who must cater for herself is put upon her mettle as a marketer. Gone for the most part are the tender peas, beans and tomatoes that made the summer bill of fare so easy to plan. Sweet corn is no more, and the shrinkage in possibilities seems general.

Onions we have always with us, however, and they are excellent in other ways besides plain boiled or fried, as they commonly figure in the household plan. For instance, they can be stuffed, the sweet Bermuda onions being specially good for the purpose. Here is one popular formula.

Large specimens are selected and boiled until nearly tender but not quite so. The inside is taken out, leaving just a shell. Mince the part taken out with three cooked sausages, a hard-boiled egg, two tablespoonfuls of bread crumbs, seasoning as liked, an ounce of butter, four drops of tabasco and a little minced parsley. The shells are filled with this mixture, cracker crumbs scattered over the top, a tiny bit of thin bacon is put on each, after which they are baked 30 minutes, or until agreeably soft.

Potatoes, the dependable, will figure henceforward more than they have done during the past months of abundance. They have the culinary virtue of being infinitely variable. For instance, when boiled and baked and fried, they have become a little wearisome and the homely tubers are no longer young enough to carry a sauce gracefully try them baked with eggs. For a moderate sized dish in this style you will need four cold-boiled potatoes and six hard-boiled eggs, all cut in slices about a fourth of an inch thick.

Put a layer of the potatoes in the baking dish, which must be well buttered, seasoning with salt, or salt and pepper, cover with a layer of the eggs. Repeat this and pour over the result two cups of thin white sauce. Cover with cracker crumbs soaked in butter and bake until brown on top. This is a substantial autumn dish.

For those to whose digestions the sturdy sausage filling would be anathema, this more delicate method may appeal.

Cook and scoop out the vegetables as before, but stuff with a filling made of equal parts of chicken (cooked), soft stale bread crumbs and the removed part of the onions. This should be slightly seasoned with salt and pepper if liked, and is to be moistened with a little cream or melted butter. Sprinkle with crumbs soaked in butter and bake as described above.


Home-Made Cheese From Buttermilk.

To make a simple, home-made cream cheese from buttermilk, put several gallons of buttermilk into a kettle or boiler over the fire and heat slowly till it curdles, but do not let it get warmer than the hands can bear if placed in it. When ready, remove from the fire and set on the back of the stove till the curd separates from the whey. Then strain through a sieve or cheese cloth. Work the curd fine with the hands, salting it a little, then add gradually enough heavy cream to blend with it to the proper consistency, mixing it in very thoroughly.

To Preserve Broom.

Do not discard a broom that shows signs of wear. Rather take measures to preserve it. If the broom is soaked regularly in hot suds and put out into the sun to dry it will get new life and have as much elasticity when half worn down as when new.



DAINTY IDEAS FOR MENU OF THE SICK ROOM.

Oyster Tea—Something Decidedly New for Supper or Luncheon—**Vermicelli Toast** Both Appetizing and Nourishing.

Oyster Tea.—To eight oysters, chopped very fine, add a cup of milk, put over the fire in a double boiler and bring slowly to the boiling point. Let it cook slowly for five minutes. Then strain through a fine sieve and flavor with a half saltspoonful of salt. Have a dainty porridge bowl heated in boiling water. Wipe dry, and pour into it the oyster tea. This makes a nourishing supper or luncheon dish, served with thin slices of dry, golden brown toast.

Vermicelli Toast.—Heat a half pint of milk in a double boiler. Put one tablespoonful of butter and one of flour in a saucepan and rub them together. Let this bubble gently over the fire for two or three minutes. Then add the hot milk, a little at a time, making a smooth cream. In the meantime, have two slices of bread thoroughly dried in the oven and toast them to a golden brown. Soak the toast in boiling milk, lay it on a small china platter or serving plate, and pour the cream dressing over it. Have the yolk of one hard boiled egg ready and quickly press it through a wire sieve over the cream toast. With a little care you can make a very attractive dish with the broken, crinkled threads of yolk. Care should be taken not to serve too ample a portion of a dish of this sort. One small piece of toast daintily covered with the cream and a little egg yolk would sometimes appeal to the patient where a larger portion might seem distasteful.

Chicken Panada.—This can be made from the remains of a roasted fowl. Cut the chicken meat carefully from the bones, making sure to avoid gristle and bone. Chop one cupful of pieces of the chicken very fine. Boil the bones and gristle of the chicken, making a pint of broth. In the meantime soak one-half cupful of bread crumbs in enough milk to cover them. Then press the crumbs through a sieve and mix with the chopped chicken. Pour the pint of chicken broth on this mixture. Flavor with pepper and salt as desired. Boil for one minute and serve very hot. This panada should be of the consistency of a thick gruel. A little of it served hot in a dainty soup plate or bouillon cup is a pleasant change from the regular meat broths.

Velvet Creams.—Soak a half box of gelatin in a half cupful of cold water for a half an hour. Add to this a cupful of sherry, and set the dish containing the mixture in boiling water over the fire. Heat this till the gelatin dissolves and add a teaspoonful of lemon juice and a half cupful of sugar. Stir for a few minutes. Strain through a cloth into a pan set in a dish of cracked ice and water to cool. When it starts to jelly add one and a quarter cupfuls of cream and stir till it thickens. Pour into a cut glass lemonade cup or any other attractive dish from which it is to be served. Serve as a dessert for supper or luncheon with cream.

Favorite Recipes

A tiny bit of butter is often an improvement to cake frostings, especially coffee, chocolate, maple or caramel.

Slices of orange may be served with afternoon tea instead of lemon. They should be about the same size as slices of lemon.


A fruit salad in which bananas are used with marshmallows, arranged in a circle upon a dessert platter and served with whipped cream, make another nice dessert.
