A subscriber writes from Bonita Park as follows: Sunday night it drizzled. Monday we had a constant drizzling rain all day long and during Monday night there was two and one-half inches of water fell. All of it came so gently that it soaked into the ground without causing the stream to rise but little. The fruit buds were never in better condition. The southeast wind we had last week may cause some of the buds to blast. The Japanese plums and narrow leaf Persian peaches never bear here; they bloom too early and the buds are too tender. Other varieties of peaches are still alive.

## Will Act on Statehood Soon.

Washington, D. C., April 25.--"Statehood occupies a definite place on the house program," said Chairman Floyd of the house committee on territories today. "It will be taken up just as soon as the free list bill and reapportionment bills are passed. These will not take over ten days. Then we will take up statehood. The only possible result of these hearings would affect the resolution reported in the house. If the democrats have their way a vote will be taken when the state officers are elected on the proposition to change article 19 of the constitution so as to make it more easily amendable."

The house committee met again today. Judge Fall finished his remarks and Judge McGill was on the floor when adjournment was taken until Wednesday. George Curry presented a telegram from W. S. Hopewell asking what stand Ferguson, Hand and Jones were taking in the statehood fight. This led the chairman to remark that he believed all New Mexico delegations, democrat or republican, were seeking immediate statehood, the democrats seeking, if possible, a "more easily amendable constitution."

## Congressional Reapportionment.


Washington, April 25 A bill for the reapportionment of the house on a basis of 433 members was reported favorably today by Chairman Houston, of the house committee on census. The size recommended is the same as provided in the Crumpacker bill, which passed the house in the last session, and is an increase of 41 over the present membership.

The Houston bill does not contain the provision of the Crumpacker bill authorizing the secretary of commerce and labor to reapportion the house after future national censuses. If the Houston bill becomes law, the representation will be one member for each 211,877 inhabitants.

## Mothers Day.

Governor William J. Mills has issued a proclamation designating Sunday, May 14th, 1911, as Mothers Day, and recommends that on said day all of our citizens attend divine worship; that each of them, if possible, wear a white flower as typical of the purity, sweetness and love of our mothers; and further suggests that all priests, ministers and preachers of the gospel on that day preach sermons taking as text Mothers and Mothers Love.

## GERMAN LAW OF ESPIONAGE

Amendment to Imperial Statute Proposed to Allow for Mitigating Circumstances.

It is announced that an amendment of the German imperial law of July, 1893, "against the betrayal of military secrets," is in contemplation. At the same time the press is informed that this is no new idea and has no particular connection with the recent trial of English officers at Leipzig.

The amendment of the law will remove its present absurdities of drafting by which the court is enabled to take mitigating circumstances into consideration in the case of conviction for espionage or attempted espionage, but not in the case of conviction for the minor offence of obtaining information "with intention" to communicate it to some other party. As the law stands the major offence can be punished with ordinary imprisonment or fortress detention, while the major offence must be punished by penal servitude. The result is that as soon as an acquittal seems to be out of the question it becomes the common interest of the judges, the prisoner and the counsel on both sides to secure a conviction on the major offence, although it may in the opinion of all parties be the minor offence of which the prisoner is guilty.

All this was well exemplified at Leipzig. The result was a dignified and acceptable compromise, and the proceedings were enveloped in a charming atmosphere of mutual good will. Circumstances, however, might alter cases, and it will be gratifying if Lieutenant Brandon and Captain Trench can learn in their respective fortresses that they have accelerated an important amendment of German law. It will be more gratifying still if the legislature either deletes or defines the term "secrecy," which is peculiar to this country and remained a controversial mystery throughout the Leipzig proceedings. If Brandon and Trench had not scaled a fence at Borkum they might still be free men. The legality of all their other movements during their tour may be questionable, but does not seem to have been disproved.—Berlin correspondent London Times.

### Novel Sleeping Portion.

A woman who suffered much from sleeplessness was relieved by the strong odor of mint breathed each night.

The remedy was one of those old wife cures that are often effective and was brought to the sleeper's notice by a clever friend who sent a bottle of strong essence of mint, a small sponge and a daintily embroidered lawn bag to hold the saturated sponge.

The bag had a spray of mint leaves done in colors on one side and on the other "Sweet Sleep." Through a casing at the top were drawn narrow green ribbons that could be hung over the head of the bed at night.




## SET OUT BRUSSELS SPROUTS

Are Great Delicacy and Represent Choice Dish of Cabbage Family— Allow Plenty of Room.

This plant deserves more attention than it usually receives in most gardens throughout the country. Many people do not grow it at all. The little sprouts borne in great profusion in the axils of the leaves are a great delicacy and represent a choice dish of the cabbage family.

They are cooked similar to cabbage. They are very hardy and may be grown in the north as well as the south, as they may be left out until

freezing weather begins. Light freezing does not injure this plant, and it is thought by many that freezing really improves it.

The plants may be started in the hot bed and handled similar to cabbage. They should be transplanted when the seedlings show the third leaf. Grow them rapidly and transplant to the open ground as soon as weather permits in the spring. Set out in a rich, moist section of the garden, and allow plenty of room. There are many varieties of Brussels sprouts, but one will have no difficulty in securing a satisfactory variety as most all of them are desirable.

### Sheep Raising in Palestine.

Sheepfolds are common in Palestine. In the villages there are corrals and sometimes caves in the hills. According to Mr. Frank Carpenter, the great traveler, the village sheepfolds are closed at night, and the shepherds keep the keys. Those of the mountains are usually open and the sheep go in and out as they will.

One of the most important duties of the shepherd is to water the flock. He does this at streams or wells. At the wells the women draw the water for the sheep, as they did in the days of the scriptures. They use bags of goatskin untanned. The skins are taken from the goats, and the legs and other openings tied up so that the skin is waterproof. There is but one hole, at the throat, and it is in this that the water is poured.


### Guard Against Stink Bug.

The squash stink bug must be guarded against on squashes as well as other cucurbits. Remove and destroy the leaves containing the shining brown eggs. The insects may also be trapped and killed under boards early in the spring and the young insects may be destroyed with kerosene emulsion.

## PLAN FOR SEED CORN HOUSE


Detailed Instructions Given for Construction of Building to Be Set on Concrete Piers.

The small seed corn house shown in the accompanying diagrams should be built at least 3 feet off the ground and set on concrete piers, writes J. Dwight Funk in the Breeder's Gazette. The building is 16 feet square and 10 feet from floor to square. There are five rows of piers 4 feet apart and the piers are 4 feet apart in the row.

Five 6x6s, which are 16 feet long, are laid on the five rows of piers. Sills answer for joists. The floor is of 2-inch stuff. The studding are 2x6 inches and are spaced 2 feet apart. The rafters are 2x4 inches and spaced 2 feet apart. Shingles are used for the roof, which is one-third pitch, and there are two ventilators in it. The studding is 2x6 inches and 10 feet long, making 10 feet from floor to square. There are two rows of uprights from the floor to the rafters, the uprights being 2 feet apart and the rows 4 feet apart; each row is 6 feet from the outside wall. Make floors of wire cribbing every foot from the floor to the square between the studding and corresponding rows of uprights, using 2x4s on which to lay the wire cribbing. These 2x4 supports are 2 feet apart in each floor. The floors are 1 foot apart. Place a 6-inch board at side of each floor to keep corn from rolling off. There are

doors on each side, eight doors to the side; they are 2 feet wide and 9 feet high. Keep them open in fair weather. Place 6 inches of corn on each floor. There will be 11 floors to each side of the seed house.



Clean seed is a big factor. Do not wet the hands at milking time.

Two garden crops a season means almost double profits.

Amber cane and kafir corn are good crops for rough forage.

For cheap roughage there is probably no better crop than the millets.

It is perfectly feasible to apply rock phosphate to ground recently manured.

## KEROSENE AS A CLEANSER

Almost an indispensable Article for Housewife Who is Particular About Her Home.

The soot that coats the frying pan can easily be taken off by sopping it with kerosene and scraping it off shortly afterwards with a pot chain.

To cut the grease on the kitchen range kerosene is indispensable, but the stove should be perfectly cold before applying.

First dampen a rag with the oil and rub over the stove and follow this with a thorough rubbing with old newspapers, after which go over it with a rag dampened with a little benzine to evaporate the oil.

Do not build fire in the stove until this is evaporated, which will be generally a few hours.

Then wipe off nice and clean, after which give a coat of varnish. You will be surprised how little it will need blacking after the stove has been varnished.

The top is about the only part that becomes soiled, and which will need to be attended to with brush and blacking; the rest will need nothing more than wiping off with a soft rag.

Putting kerosene and ammonia in water when washing glass ornaments will give them a brightened appearance.


Washing the window panes with kerosene will keep them from frosting in cold weather, while at the same time giving a brighter light within the rooms.

## THREE FLATIRONS IN ONE

New Invention That Will Be Appreciated by Housewife Requiring Different Weights in Irons.

Every housewife appreciates having a pressing iron suited in weight to the garment or cloth being pressed out, and for this reason two or three irons of different weights are often a part of the laundry equipment.

The Van electric iron, however, is designed to make it serviceable in all

capacities. It is so constructed as to be operated as any one of three irons of different weights. By removing the two top screws on the rear of the iron, then loosening the two bolts at the base of the handles the heater and connection may be pulled out and weights No. 1, 2 and 3, placed on the heater, making either a five, six or seven pound iron. Another special feature is the suiting of the iron to various voltages ranging from 100 to 125 volts by changing heaters in the same manner as the weight of the iron is varied.

### Buttermilk Doughnuts.

Put four cups pastry flour into a shallow bowl, sift in one and one-half teaspoonfuls each of soda and cream of tartar, one-half teaspoonful cinnamon and one of salt; add one cup sugar, one egg, unbeaten, and one cup buttermilk (better thick); mix well and proceed as for doughnuts.

### Caramel Sauce.

Into a clean saucepan put a cupful of granulated sugar and melt slowly, stirring all the time. When light brown and liquid, add a cup of boiling water and boil very gently for five minutes or until of the desired consistency. Set aside until cool and flavor with vanilla.



### STATEHOOD LINGERS.

Conditions for the immediate admission of New Mexico have not improved the past week. Indeed, if possible, they have grown worse. This condition has been accentuated by the position of the administration on Arizona, whose fate is inextricably linked with that of New Mexico, and the presence of a New Mexico delegation at Washington who are insisting that the New Mexico constitution be amended before admission.

In our opinion, there is little excuse for either. The Arizona people framed their constitution and adopted it by an overwhelming majority, and they are the ones who are to reap its benefits or to suffer from its defects. The federal authorities should not interfere. In New Mexico, while its constitution was unsatisfactory to many, a vast majority approved it, and its acceptance by the people of New Mexico should have the same force and is governed by the same principle as that of Arizona. Every man has a right to improve the condition of his people, and to a certain point, if our constitution could be bettered without endangering statehood, well and good, but nothing should be placed in the way of congress giving us immediate statehood; yet we fear such a condition is now confronting us.

### CONDITIONS VERY FAVORABLE.

Not in many years have conditions at this season of the year been as favorable as they now are, and certainly not for the past three or four. The ground has been moistened to a depth greater than usual, and grass and other vegetation are springing up everywhere. Everything has a tint of green, which is a joyous prospect over the general appearance of the sear and brown plains for the past few years at this season.

The increase in the sheep flocks this year should approach the maximum. The lambing season is now in full swing, and the green stuff, so necessary for the preservation of the lambs, is conspicuous on every hand. The weather is all that could be wished for, and if the flocks of this section do not enjoy a phenomenal increase, conditions other than climatic will have to be blamed. The cattleman is equally jubilant, and this should be a banner year for those engaged in the propagation of the bovine species. In addition to an abundant moisture which has caused old Mother Earth to put on her emerald sheen, the stockmen are further benefitted by the fact that the range will not be overcrowded, because so many sheep

and cattle have been shipped out of the country.

And the farmer—the man with the hoe—he's all right. He is willing to forget the past, and has his eye only on the future. His farm is in good condition, his crops are planted, and in many cases already up and growing. He too, is feeling hopeful and anticipates a big crop. And so it may be said, notwithstanding the lean years through which we have passed, we are now, in truth, on the upward climb, and effect of such conditions is bound to produce, and is producing, jubilant spirits among all classes of our people.



# TO REMOVE STAINS

ENGLISH WAYS OF TAKING OUT VARIOUS SPOTS.

Soft Soap and Paste of Salt and Water for Fruit Stains—Pure Alcohol Will Take Out Grass Stains.

Fruit stains should be treated at once, says an English writer in the Queen, for if allowed to set they are difficult to remove. Rub the stain with soft soap or good yellow soap, well wetted, then cover it with a paste of salt and water. Or rub the stain well on both sides with a good yellow soap, and then tie over it a little pearl ash, and let it all soak in hot water, boiling it if necessary; rinse well and dry in the open air.

If the stain is very persistent try the following: Crush four ounces of chloride of lime in a basin and work it to a smooth paste with a little cold water; when perfectly mixed, add to this from one and a half to one and three-quarter pints more cold water, using in all two pints of water, now stir the lime well, cover closely, and let it stand for a day or two, stirring it occasionally. Now leave it till quite settled, when you skim it, pour off the clear liquid, straining it into a bottle, and keep tightly stoppered.

To remove the stains rub the spot with a rag dipped in the mixture, rinsing it at once after the spot is removed in clean cold or tepid water. Should the article be badly stained soak it in cold water—to which you have added sufficient of the mixture to make the water smell slightly of lime; watch this, and directly the stains are removed lift out the linen, rinse well, and dry in the open air in the sun if possible. Care must be taken with this, for if the linen be left in too long the bleach will rot it. This remedy will remove almost any stains.

If grass stains on cotton are rubbed with pure alcohol they will disappear, but this should be done at once.

To make balls for removing grease stains mix well 1½ ounces of powdered French chalk and 5 ounces of powdered pipeclay, then work them to a paste with 2 ounces of spirits of wine, shape this paste into balls and leave them to dry. To use, moisten the grease stains well with warm water, then rub them thoroughly with the ball; now let dry, if possible in the sun; then brush well and sponge with a little water if any stain be left.

To clean discolored hearths mix whiting to a thin paste with skim milk, adding a drop or two of liquid blue or a morsel of stone blue. Put it on the hearthstone with a paint brush. This does not crack off.

White stains on polished wood caused by upsetting any spirit or by over-hot dishes or plates may be removed by applying to these spots a feather dipped in spirits of camphor. This must be used very sparingly and the furniture rubbed well at once with a cloth dipped in sweet oil, repeating the process if necessary. When the stain is completely removed polish well with beeswax and turpentine or any good furniture polish.

To clean ivory rub the stains with lemon juice, then with whiting made into a soft paste with lemon juice; allow this to dry on, and when perfectly dry wipe off with a soft cloth.

For mildew stains first brush off any loose mildew, then well rub in a little common salt, sprinkling it with powdered French chalk and thoroughly moistening it with clean cold water; after this dry slowly in the open air and then rinse well. This may require to be repeated. Mildew on leather may be removed by rubbing the place well with a clean, dry and very soft cloth to remove any fungus that may be on the surface of the leather, then rub over with a rag just moistened with pyroligneous acid.

## HOW TO COOK RICE

### CREOLE MAMMY'S METHOD MAKES PROCESS EASY.

Takes Place of Potatoes, is Easier to Prepare and Four Times as Nutritious—Should Never Be Mushy

If you want to know the right way to cook rice read how an old creole mammy does it. After you have learned to cook rice you will then be able to utilize and serve it in many different ways. Your household will like it and you will serve it often, instead of bread, with all gravies, especially the brown meat gravies, and with peas and beans. Used with gravy it will take the place of potatoes, and is much easier to prepare, easier to digest, and four times as nutritious. It should be served dry, steaming hot, not mushy, and every grain separate. One cupful of rice well washed, three cupfuls of boiling water, one scant teaspoonful of salt, and a saltspoonful of lard. Wash the rice through at least six waters, or until all cloudiness is removed. Drain thoroughly. Bring to the boiling point three brimful cupfuls of water, add the salt, and the tiny bit of lard. When the water is boiling briskly add the rice gradually, so as not to stop the boiling. Don't stir. The grains should be kept moving by the boiling water. It will take about 15 minutes for the rice fully to absorb the water. During this time keep the cover on, but slightly pushed to one side. At the end of the 15 minutes the grains should be soft, not the least gritty. Remove the cover and at the same heat let dry out for five minutes. If cooking on a gas stove, at the end of the five minutes lower the gas and let the drying out process continue for 20 to 30 minutes longer. If cooking on a wood or coal stove, at the end of five minutes place the cooked rice on the back of the stove or in the oven to dry out. By cooking rice in this manner every bit of nutriment is retained at a minimum cost of effort. Each grain will be puffed to almost three times the size of the uncooked grain. Always cook rice with a lid over the flame. On gas stoves, an asbestos lid is recommended. Never stir rice while cooking. A sharp knife passed around the side of the pot after the drying process starts is recommended. If lard is objected to it may be omitted; it is supposed to lessen the danger of burning, to prevent the water boiling over, and lends a brilliancy to the cooked rice.

#### Stewed Pigeons.

Pick clean and wash the pigeons. Put them into a pot with a cup of water to keep from burning and a tablespoonful of butter for each one. Shut the lid down tightly and subject to a slow heat until they are a nice brown, about nut color. Once in a great while turn them and see that each is well wet with the liquor. Take them out and cover in a warm place, a colander set over a pot of hot water is best, while you make the gravy. Chop the giblets of the pigeons very small, with a little onion and parsley. Put into the gravy pepper and salt; boil up and thicken with browned flour. Return the pigeons to the pot, cover again tightly and cook slowly until tender. If there should not be liquor enough in the pot to make the gravy add boiling water before the giblets go in.

#### Nougate.

Grease a square shallow pan with butter, fill with hickory nut kernels, almonds cut in thin slices, coconut chopped fine and a few bits of candied orange peel. Boil 2 pounds of granulated sugar and 1 cup of water together without stirring until it hardens, then add a tablespoon lemon juice and pour it in pan over the nuts. When cool mark in narrow strips.
