Jail Sentences Lifted by Court.

Washington, D. C., May 15.—Setting aside the sentences of imprisonment imposed by the supreme court of the district of Columbia for the alleged disobedience to the boycott injunction, the supreme court of the United States today held that Samuel Gompers, John Mitchell and Frank Morrison, president, vice-president and secretary, respectively, of the American Federation of Labor, had been erroneously sentenced to jail on the charge of contempt of the lower court.

The court unanimously held that the only sentences that could be imposed were fines. It found that the court of appeals of the district of Columbia and the supreme court of the district erred in treating the contempt proceedings as criminal cases instead of civil. This made a jail sentence impossible. To correct an error the case was sent back to the local courts with direction that it be dismissed.

At the same time the court expressly made it possible for a civil proceeding to be instituted against the Labor men by the Buck Stove & Range company, at whose instance the original contempt case was brought. Inasmuch as all differences between the state and the range company have been adjudicated, including the "boycott" case, out of which the contempt proceedings arose, today's decision is probably the last to be heard in this famous action.

The charge of contempt against President Gompers, Vice-president Mitchell and Secretary Morrison arose out of a bitter labor war between organized labor and the Buck's Stove & Range company, of St. Louis.

Standard Oil Knocked Out.

Washington, May 15. The Standard Oil company of New Jersey and its nineteen subsidiaries were declared today by the supreme court of the United States to be a conspiracy and a combination in restraint of trade. It also was held to be monopolizing interstate commerce in violation of the Sherman anti-trust law. The dissolution of the combination was ordered to take place within six months.

Thus ended the tremendous struggle on the part of the government to put down by authority of law a combination which it claimed was a menace to the industrial and economical advancement of the entire country.

Court Adjourns.

District court adjourned Wednesday morning at ten o'clock, the court having formerly opened here the first Monday in the month. Much business of public interest has been transacted, but much was left on the docket, in a criminal way, which went over to next term. All civil matters were disposed of, either by reference, motion or judgment.

Three jury trials have resulted since last week's issue of this paper, including the one in which the evidence was then being taken, and the names of the defendants, the crime charged and the jury's verdict is herewith given:

Juan Chavez, attempt to rape; verdict of guilty.

Adolfo Sais, assault with intent to kill; jury disagreed and were discharged; case went over.

Robt. J. Wood, drawing and flourishing deadly weapon; verdict guilty.

Summing up the results in the criminal cases at this term of court, we have the following:

Simon Sais, assisting prisoner to escape; 3 months jail sentence.

Jack Gerrard, impersonating an officer; 4 months in jail.

Casimiro Rameris, burglary; sentence 4 to 5 years in penitentiary.

Pablo Warner, burglary; sentence 3 to 4 years in reformatory.

Juan Chavez, attempt to rape; sentence 3 to 5 years in penitentiary.

Charles Bell, larceny of horse; sentence 3 to five years in penitentiary.

Robert Swan, larceny; sentence 2 to 3 years in penitentiary.

Robt. J. Wood, flourishing a deadly weapon; fined \$100 and sentenced to jail for sixty days, the jail sentence to be cut in two on a favorable report from sheriff.

F. M. Deel, selling liquor without license, and violation of Sunday law; fine and costs \$511.40, and 90 day jail sentence; jail sentence suspended during good behavior.

Court Expenses.

The expenses of the court just adjourned were not as heavy as anticipated. The actual figures were not obtainable Wednesday morning upon adjournment, because of the rush of business attending the last few hours of court, and the fact that a few bills were still outstanding. However, District Clerk Downs estimated that a little less than \$5000.00 had been expended. This sum deducted from the total in the court fund at the beginning of court, leaves remaining in the fund something over \$3,000.00. Collections in June and July will increase this balance to about \$7,000.00, which insures a good fund for a lengthy term of court in the fall.

WAYS OF SERVING BANANAS

Fruit is Nourishing and Should be Served Often, Say Stomach Specialists.

Palates that revolt at raw bananas can enjoy them well cooked. Stomach specialists—some of them—say this fruit is nourishing and should be served often.

Banana recipes are here given to help out the housekeeper troubled over her weekly menu:

A simple pudding is made from a custard of yolks of three eggs to a quart of milk, slightly sweetened. When the consistency of thick cream pour it over thin slices of banana in a pudding dish. Put meringue of whites of eggs on top and brown slightly in oven. Serve cold with cream.


Sliced bananas mixed with corn-starch just before it stiffens and served with fresh strawberry sauce are delicious.

Baked bananas are sometimes used as a vegetable. Peel and cut in half, lengthwise. Divide if large. To each banana allow a tablespoonful of sugar, two tablespoonfuls of water, a teaspoonful each of lemon juice and melted butter and a pinch of salt. Put slices in shallow casserole and bake slowly for half hour, keeping them well basted.

NEW KIND OF REFRIGERATOR

Has Drawers That Swing In and Out in Place of Having Shelves.

A different kind of refrigerator has been invented by a Georgia man and is shown in the cut. In place of the row of shelves with which the ordinary refrigerator is equipped this new ice chest has a series of drawers, which swing in and out and make the articles kept within much easier of access. The ice compartment is at the top, as in most other types, and alongside it in one corner is a row of shelves which lift up and on which may be kept those things which should be close to the ice. The




lower part of the refrigerator is equipped with drawers which swing in and out on a hinge at one side. They are rounded at one end and only come out a certain distance. That part of the bottom of the drawer which extends outside when the latter is moved to the limit of its outward range is solid, the other segment being perforated to permit the cold air to pass through more readily. In this type of refrigerator it is not necessary to remove the things in front to get at those in the rear.

Baked Apples.

Take as many apples as there are people to be served. Peel and remove core. Fill with chopped hickory and English walnut meats. Sprinkle with white sugar. Put in oven and bake slowly, basting all the while with strup, made of one cup sugar, one-third cup water, cooked until in threads. Bake until apples are clear. Serve with whipped cream.

TO LAUNDRER BLACK CLOTHES

Wash in Hot, Clean Soapsuds and Rinse in the Ordinary Way.

This is a problem which confronted me a few months ago, on going into mourning for a loved one. It is absolutely necessary to wear clothes that can be laundered if one keeps nice and fresh. This plan can be used for black lawn shirtwaists and corset covers, and sateen or any black undershirt except silk.

First, black clothes must never be washed in water that has been used for either washing or rinsing white things, as there is always fine lint in this water that sticks to the black, and no amount of rinsing will get it off. Wash in hot, clean soapsuds, and rinse in the ordinary way. To starch take a cupful of white cornmeal, place in a frying pan and set next the fire on the range. Burn this until it is black, pour in boiling water, stirring all the while. Then strain, and you have a splendid starch. Iron on the wrong side and your shirtwaists will be beautifully sweet and fresh.—Harper's Bazar.

NEW BROILER IS INVENTED

Can Be Used on Any Stove and Saves Savory Juices That Exude From Meat.

A new kind of broiler that can be used on any stove, but is intended primarily for use on a gas stove, has been invented by a Virginia man. Another feature, or rather, the feature of the utensil, is that all the savory juice that exudes from the meat and would otherwise drop into the fire is



saved. The broiler proper—the wire frame that holds the meat—is suspended from the apex of a casing that runs to a point at the top and has a front side that lets down on hinges. The broiler frame hangs perpendicularly and as the meat is cooked the essence drips into a trough below and runs out of a little spout on the side and into a cup that is fixed to the side of the casing. This can be utilized as a blood gravy, as it is very rich in flavor, or it can be converted to brown gravy by adding a little flour.

Jam Roly Poly.

Chop three tablespoonfuls of beef suet fine, add half a pound of sifted flour and a pinch of salt; mix with cold water to make a stiff dough. Cut it in with a knife; do not touch with the hands. Roll out an inch thick on a well floured bread board; spread with currant jam to within an inch of the edge; wet the edges, roll up the strip, press the edges together and roll up in a well floured cloth and steam two hours and a half.

Cabbage With Rice.

Boil a head of cabbage until tender, drain and cut out the heart and center, fill in the opening with a cup of hot boiled rice that has been highly seasoned with pepper, salt and butter, and pour over all a cream sauce. This makes an excellent cold weather dish when the meat course is light.

CANDIDATES AND CANDIDATES.

In the past New Mexico has had no part in the election of presidents, but has assisted in the selection of candidates for that office. Many profess to believe that will again be our position in 1912, but to us the contention does not seem reasonable and certainly is not just. Be that as it may, however, the people of New Mexico are interested just the same in the selection of a chief executive of the nation, and while the campaign is yet a year off, it is not too early to consider candidates.

In speaking of candidates it may, at the beginning, be wise to admit that President Taft will be named as his party's standard bearer. This admission must be made in spite of the unpopularity of the administration, the divisions that prevail in the republican party and the general feeling existing in that party that it will be almost impossible to reelect Mr. Taft. The machine—and it is a good one—will attend to the election of Taft delegates. Indications are not lacking that a truce has been patched up between the president and his predecessor. So it may as well be conceded that the republican nomination is settled.

On the other hand, with democratic victory in the air, there will be a number of candidates willing and ready to accept the nomination from the democratic party. Numerous names are mentioned, all with a substantial following, but the three most often spoken of are Governor Woodrow Wilson, of New Jersey, Governor Judson Harmon, of Ohio, and Congressman Champ Clark, of Missouri, the speaker of the present house. We have written these three names in accordance with our view of their availability and strength and also in accordance with our sentiment—Wilson, Harmon and Clark. However, availability and strength are not considered the essential elements in the coming campaign, for the belief is general that the democrats will sweep the country, let the nominee be whom he may. Nevertheless, it behoves the democratic party to place its best man in the chair. On this point there will, naturally, be a difference of opinion among democrats.

To many Wilson is regarded as peculiarly fitted to meet the new conditions that have arisen. He has accomplished much since he was elected governor of New Jersey. For many years the head of one of our great colleges, and had to overcome the prejudices of a century to the effect that college presidents were lacking in the intricate knowledge of governmental affairs. That he has overcome this prejudice and

is regarded by the country as one of the most formidable candidates for the presidency goes without saying. He has shown great executive ability as governor of New Jersey; he was the main instrument in the selection of a progressive democrat to the United States senate; he was equally successful in procuring a vast amount of progressive legislation through the state assembly, and in a state that is known as the home of the special interests, strongly entrenched and for years possessing dominance. He is regarded as especially strong in New Jersey, New York and New England, an alliteration synonymous with success.

Many others regard Harmon as a man of destiny. He was elected governor of Ohio in 1908, notwithstanding Taft carried that state by an overwhelming majority. It would certainly be no exaggeration to say he made good the first two years in that office, as he was reelected by a majority so big that they haven't yet quit counting it. He was attorney-general in the last Cleveland cabinet and is regarded as one of the soundest lawyers in the country. His weakness as a candidate, if he has a weakness, is that he is supposed to be too near the interests to suit the progressive spirit of the times. Add to this Bryan's opposition and an element of doubt might exist as to his election should he become the standard bearer of his party. There is really little cause for fearing he would not be in rapport with the times, for his expressions and actions as governor of Ohio has shown that he has kept step with the growth of modern sentiment. No one doubts the governor's ability to carry Ohio in 1912, be his opponent Taft or any other republican, nor is there any question of his strength in adjoining states. Your Uncle Jud is a still hunter, too, and will be on hand when the game is called.

Champ Clark says he's willing, and many approve the expression. He is also believed to be Bryan's choice, which is a tower of strength to the candidacy of any democrat. But in our opinion, and that's what we are trying to give you, he is third in the race with the three named. He now holds a position second in importance only to that of the president, and we are satisfied to have him remain there.

It may be inferred from the foregoing that we are for Wilson. We have no desire to dispute the inference.

Lincoln County Institute.

Notice is hereby given that the Lincoln county summer institute will convene at Carrizozo, New Mexico, Monday, June 19, 1911, and remain in session for a period of two weeks. The last two days of the session, June 30th and July 1st, will be devoted to examinations. The fee will be \$1 50.

An effort will be made to make this one of the most interesting and beneficial institutes that has been held in this county. A conductor and an instructor have been selected, both highly recommended for this particular work, and it is believed the opportunities offered in the Lincoln county institute are not to be excelled in the territory.

All teachers who expect to teach in the public schools of the territory are required to attend this or a similar institute held during the year. Excuses for failure to attend summer institute will not be approved except in urgent cases. A certificate to teach must be supplemented by an institute certificate.



EGGS IN EVERY LAND

HOW HEN FRUIT IS SERVED BY VARIOUS PEOPLES.

Variety of Recipes Which Offer Pleasing Change From Common Methods of Cooking Eggs—Fried Egg Popular in America.

Russian Eggs.—On delicate slices of toast spread a layer of caviar and place a fresh poached egg on top; pepper, salt and a few drops of lemon juice are added, and a garnish of parsley; serve at once.

Turkish Eggs.—Boil six kidneys and six chicken livers and hearts with an onion and a spice bag, throwing off the water six times. Make a rich brown sauce, adding a little wine, and add the kidneys; pour on a hot platter and place as many carefully poached eggs over the top as there are guests.

Norwegian Eggs.—Place on a platter large flakes of smoked salmon, scramble six eggs in butter, season and spread over the top of the salmon; serve hot.

Hungarian Eggs.—Arrange hard-boiled eggs and cold boiled potatoes in alternate layers in a pudding dish, with butter, pepper and salt, and pour over the top sour cream enough to just cover the ingredients. Bake a delicate brown.

Spanish Omelet.—Cut three slices of bacon into dice and fry a delicate brown, then add two sliced tomatoes, one onion minced, six sliced mushrooms, pepper and salt. Stir and cook ten minutes. Break six fresh eggs into a bowl, beat lightly with a fork. Put a small lump of butter into the omelet pan, and when hot pour in the eggs and shake gently until set, then turn on the other mixture and fold the omelet and serve quickly.

Irish Eggs.—On delicately broiled slices of bacon poached eggs are placed and covered with a rich cream sauce.

American Eggs.—Needless to say that the best known egg dish of the country is the fried egg served with fried ham, though the best known dishes of other nations find their way to all the menus of the best hotels and restaurants.

DON'T EXERCISE OUR TEETH

Reason Americans Have Such Poor Grinders, According to a Dental Authority.

The reason Americans have such bad teeth is that they don't exercise them enough, according to Dr. Herbert L. Wheeler, president of the American Dental Hygiene council, who is delivering a course of lectures at Columbia university. "We Americans are living in the lap of luxury," said Dr. Wheeler, in his opening lecture, "and our food is so well prepared for us that we don't use our mouths enough. Regular exercise for the teeth is as beneficial as any other kind of gymnastics."

He found from an examination of several hundred savages' teeth that the increased work which their teeth had been made to do had resulted beneficially for their teeth. It was also a fact that the front teeth of savages were more worn than those of civilized people, being that the savage cuts his food with his teeth.

Rhubarb Jelly.

Wash the stalks well, but do not peel them. Cut into pieces about an inch long, put into preserving kettle with about half enough water to cover and boil to a soft pulp. Strain through a jelly bag. To each pint of this juice add a pound of sugar. Boil, again, skinning often, and when it jellies on the skimmer remove it from the fire and put into glasses, having previously dipped glasses in cold water so that the jelly will turn out nicely.

KEEP KITCHEN CLEAN

IN NO ROOM IS CLUTTER AND DUST MORE UNSANITARY.

Should Be Times for Each Cleaning Process Besides Ordinary Daily Cleaning—Utensils Should Be Kept Immaculately Clean.

The thought of an untidy kitchen is abhorrent to the good housekeeper. The trouble lies with being more able to spot dirt and scold about it than to give rules for its prevention.

When a new maid arrives the mistress should tell her explicitly how she likes the work managed, instead of saying, "I expect your kitchen to be spotless!"

There should be times for each cleaning process, besides the ordinary daily cleaning up. Every girl should be made to sweep up the kitchen floor at least once a day, preferably after each meal, to wash off tabletops and sink after every dish-washing time and to dust thoroughly each morning.

In no room of the house is clutter and dust more unsanitary, yet little attention is often paid to systematic fighting of it. Sometimes this is due to lack of provision. Every kitchen should be equipped with a broom, roller, brush and pan, dustless dusters, scrubbing brushes, chamolis skins, pail and scrub cloths of its own.

Many cooks will wipe up a kitchen table with the same cloth used for the floor, or worse yet, with the dish-cloth. For this reason have sets of cloths distinct in color, for each operation and there is no excuse for mixing them. The same holds good of brushes; there should be a sink brush, another for vegetables, a third for table tops and a fourth for floors. Also have mops of different size and thickness to use on pots, pans and bottles.

The care of a kitchen floor depends upon the material with which it is covered. If there is a good quality of linoleum on it work is simplified, as beyond daily brushing up it will only need semiweekly scrubbing with skim milk. Never use soap on linoleum. To brighten rub with a cloth wet in linseed oil after the floor has been washed up and well dried.

A bare floor is liked by some because it can be scrubbed hard with soap and water. If a tablespoonful of kerosene is added to the pail of water the scrubbing will be more quickly done. Where the water is hard it should be softened with borax or ammonia.

A varnished floor can be cleaned more easily if sprinkled with coarse salt, which is allowed to stand for a few minutes then brushed up with a soft broom.

Tile floors should be washed up with water, then rinsed with skim milk. An occasional treatment of linseed oil will keep luster in the tiles.

Keep three white barred muslin curtains for each kitchen window for frequent changes. Have windows cleaned inside and out once a week. Do not use soap. A tablespoonful of ammonia to a gallon of hot water will give quick polish. Use two cloths and finish with chamolis or tissue paper.

Utensils must be kept polished. For copper use soap applied with a damp cloth, then sprinkle thickly with borax, if you have no regular copper polish. Brass can be cleaned by being moistened with kerosene then rubbed with a paste of powdered chalk and lemon juice, and polished with chamolis. Boil tin utensils occasionally in strong soda water, and if rusted rub with lard and let stand before washing.

Scrappie.

One and one-half pounds of beef and one-half pound of pork; boil them together and season with salt, pepper, and sage; drain and chop fine. Then add to the liquor corn meal, as you would for mush; add seasoned meat, mold, slice, and fry.

Tribute to Madero.

Whatever may be said in question of the abilities of Provisional President Madero, head of the revolutionary movement in Mexico, his sublime courage in saving the life of General Navarro from the blood-thirstiness of Orozco and Villa will, as it should, render him immortal wherever true courage is admired and humanity is applauded.

During this whole affair Gen. Madero's ideas, his plans and his purposes have been above the heads and beyond the comprehension of his followers, and his actions and the events have proven that his purpose was reform for the benefit of the oppressed people of his country, to be accomplished through peaceful means in preference to bloodshed. He did not favor the assault on Juarez, because he feared that it would render more difficult if not abortive his efforts to secure the reforms by peace pact, but his influence has been for law and order in preference to bloodshed and disorder since Juarez has fallen into his hands and his treatment of the captives has been most magnanimous and generous.

A man who can show the sublime courage that Madero has shown and who can treat his unfortunate foes with such broad magnanimity, must be credited with sincerity of purpose in what he advocates and no one familiar with conditions as they exist in Mexico can question the righteousness of his cause, the need of the reforms he advocated, although the wisdom of some of his demands as a prerequisite to peace is questioned.

But to Madero, the brave and generous, whose chivalry would add luster to the fame of the most illustrious knight of old, we bow in admiration.

Where Races are Mixed.

F. C. Speck in Southern Workman.

Since the period before the revolutionary war, the mountain range known as the Ramapo, in Rockland and Orange counties, New York state, has been the home of a mixed Indian, negro and white population which, interesting though it is, has remained practically unknown to outsiders. According to current tradition the tribe, so-called, seems to have been founded by the blending of a few families of native Algonquin Indians, probably Minisinks of the Delaware, with some of the Tuscaroras, who lingered for a rest in the Ramapo valley on their way from Carolina in 1714 to join their colleagues, the Iroquis, in New York state. To this small nucleus became added from time to time the runaway negro slaves and perhaps freedmen from the Dutch colonial plantations in the adjoining counties of New Jersey. Vagabond white men of all sorts also contributed a share to the community from the early days until now. The Jackson-Whites may be regarded, therefore, as a type of triple race mixture.

Traveling from east to southwest in the Ramapo range one encounters representatives, in

physical appearance at least, of all three elements, ranging from apparent full-blooded Indians through all possible degrees of inter-mixture. In the eastern hills nearer the Hudson river the population is sparser and shows more of the white strain.

Continuing ten miles toward the Ramapo valley, the mountaineers are numerous, running well up into the hundreds, but here the negro predominates, though Indian characteristics are apparent as well. Westward, however, toward the Delaware watershed, the negro strain is less apparent, and the white families boast of their Indian blood. Though no means of estimating the total population of the mountain people are to my knowledge, yet they can hardly number less than 1,500 or so. Interesting survivals of old respectable Dutch names, such as De Groat, De Fries, Mann, Sisco (Francisco) are general, and some are en-

countered who speak the language of Holland, though they are typical negroes in appearance. From time to time Indians from the five nations in New York state have wandered in. Such was one known as Mount Pleasant, probably a Tuscaroro, who many years ago returned to the Ramapo, about which he had heard from his elders, and lived out his days alone in the woods.
