Decapitated by Train East of Carrizozo

A man, name unknown, nationality Mexican, was found alongside the railroad track Tuesday morning at mile post 161, seventeen miles east of Carrizozo, by Conductor I. E. Schaeffer and crew, with head severed from body. Schaeffer's train was going east and the discovery was reported to this point and No. 3, the west bound Limited, was directed to pick up the body and bring it to Carrizozo. Engineer Frank Simmons and Fireman E. C. Fryor, accordingly halted No. 3 at the point of the accident and placed the body on that train.

Judge Massie empaneled a coroner's jury and an inquest was held. The train crews were examined and a verdict was returned to the effect that an unknown man had been killed by a train. No one was able to identify the dead man, and nothing was found on the body that furnished a clue as to his identity. The remains were interred in the local cemetery Tuesday afternoon at the expense of the county.

The exact manner of death can only be conjectured, and, if killed by train, as appearances indicate, it is difficult to find which train caused the fatality. One train was ahead of Schaeffer's train, going east, leaving here after midnight Tuesday morning, 5:30 to be exact, while Schaeffer's train left at 7:00 a. m. Two trains came through going west after midnight, No. 1, a passenger, and one freight. It is believed, however, that the unfortunate man fell from the east bound freight, leaving here at 5:30 that morning, as he had been seen in the yards late the night before.

Some Celebrations

The Fourth having fallen on Sunday, celebrations in Lincoln county began Saturday, the 3d, and continued until Monday, the 5th.

On Saturday both Nogal and Lincoln held celebrations, and both report big crowds and exceptionally pleasant times. The day was filled with interesting sports and at night each place had a most enjoyable dance.

Sunday a large crowd gathered at Fort Stanton to witness the ball game between Fort Stanton and Carrizozo. It was a very good game of ball, Fort Stanton overcoming Carrizozo's early lead and winning with runs to spare at the close of the game. The same teams played again the following day, and Carrizozo was walking away with her opponents when a questionable decision was rendered by the umpire in 9th, causing the Carrizozo team to quit the grounds and the claim was made that the game was forfeited to Stanton. This, however, was not agreeable to the greater number of the Fort Stanton people, and the game was passed up as though it had not been played. Unfortunate and unpleasant as it was so many of the Stantons expressed such sincere regret at its occurrence that the sting was largely eliminated.

That day, also, Jicarilla opened wide her doors and invited everybody to come. A large number did go, notwithstanding many had taken in the two previous days, and the last was said to be as good as the first. Jicarilla did herself proud and maintained her reputation for entertaining.

It was a series of strenuous days of celebrations and it has required as long to recover from all the strenuousness as it did to participate therein. But while that is true we shall probably be quite willing to repeat the performance when our next natal day arrives.

County School Notes

Blue Water School will commence a seven months term August 2d, with Mrs. Lurlyne Lane in charge.

August 9th E. F. Funk will start an eight months term at Nogal Mesa.

Mrs. S. H. Nickels will again teach the Parsons school, beginning a seven months term on the 19th of July.

Alto and Angus schools have about concluded arrangements for terms beginning early in August.

Mrs. Emma Craddock has been selected as teacher of the Baca Canon school.

R. A. Bruce of Temple, Texas, has been elected principal of the school at Corona.

Deeds of schoolhouse sites have been recorded for Tinnie, Mountain View and Upper Glencoe.

The fiscal school year ended June 30. The records show a marked improvement both scholastically and financially. County enumeration, 2446; enrolled in schools, 1926; average daily attendance, 1471. Expense for teachers, wages, janitor, fuel and supplies, \$28,572.18; total expense, \$44,540.71.

The extension department of the Agricultural College at Mesilla Park, represented by Prof. W. T. Conway and Miss Edna Ross, will give canning demonstrations in Lincoln county in July. The schedule as now arranged is Tinnie and San Patricio on July 15, Ruidoso on the 16 and Nogal the 17. Three days are all that could be obtained this year, and those dates were given first to the fruit and vegetable sections.

End of War Far Distant

According to Numa Reymond, once a prominent resident of New Mexico and well known to many early settlers of Lincoln county, the end of the European war is far distant. Mr. Reymond reached Santa Fe this week from his European home and the New Mexican of the 29th ult. has the following interesting article concerning Mr. Reymond's visit and his views on the great war:

"The European war will last at least three more years. The allies will never cease fighting until they have stamped out Prussianism and Kaiser-worship."

This is the opinion of Numa Reymond, a prominent merchant of Geneva, Switzerland, and of New Mexico, who arrived here today from Europe, having left Switzerland May 7, the day the Lusitania was sunk. Mr. Reymond embarked at Marseilles and after an uneventful voyage of seventeen days landed in New York City. He has extensive interests in Japan and China and now is on his way to California.

"I had no trouble at all in going through the French lines," said Mr. Reymond, "and I had ample opportunity to see with my own eyes how the French view the prospects of a long drawn out war. Already the French are sewing blankets for the winter campaign. I was told that the great French military genius, General Joffre, declared

Education of Individual, Slogan N. M. University

That the New Mexico State University has as its first function the education of the individual student and that this duty to the student comes before everything else in the university's various activities, is the theory of management upon which Dr. David Ross Boyd, the president, and the board of regents are proceeding. Too many of the universities, it is held by practical educators, are devoting themselves and their faculties to matters of research, exploitation of various theories of members of the faculty; extended investigation beyond the capacity or the demand of the average college student, and activities in affairs of state and national government and governmental problems which leave little time for the old fashioned work of teaching students how best to live and work.

The New Mexico State University is not that kind of an institution. A number of the members of its faculty are authorities in their several special lines, and some notable work in original research has been and is being done at the university. But in the selection of the faculty the first object sought by the university government has been ability to teach; to reach the individual student and by personal interest and direct personal contact, give him the most thorough and the greatest amount of practical education in the time available during his university course. It is this intense adherence to the importance of teaching, before everything else, that has made the remarkable advance in scholarship standards at the New Mexico University possible. It is the deep personal interest in and close relation with the student that has caused work in our state university to be accepted, credit for credit, at the greatest universities in this country. The University of New Mexico junior may enter Columbia or Cornell or Michigan for his degree, just where left off at the New Mexico University and without examination. It is the great advantage of the small university that it gives the student the benefit of individual and close association with the men and women who are instructing him. In the great colleges the freshman and sophomore, who needs personal attention and guidance, very seldom gets it. He gets no closer to a department head than the distance across a lecture room; often in four years of college he does not speak a word with the men who teach him, outside the class and lecture room and laboratory.

In the University of New Mexico students and members of the faculty are personal friends and associates. They meet outside the class rooms as well as inside and the student has the vast advantage of an aroused personal interest in his individual welfare on the part of the teacher. In every case ability to teach has come first in selection of members of the university faculty; and after that adaptability to sincere interest in individual students and their problems has counted most.

The university enters the next year, on August 17th, without a single change in faculty. President Boyd having completed an organization which meets his ideas as to what the State University should be and the way it should work under existing conditions in New Mexico.

he was ready to break through the German lines and carry everything before him provided he was given a certain number of tons of ammunition per day and allowed to sacrifice several hundred thousand men. 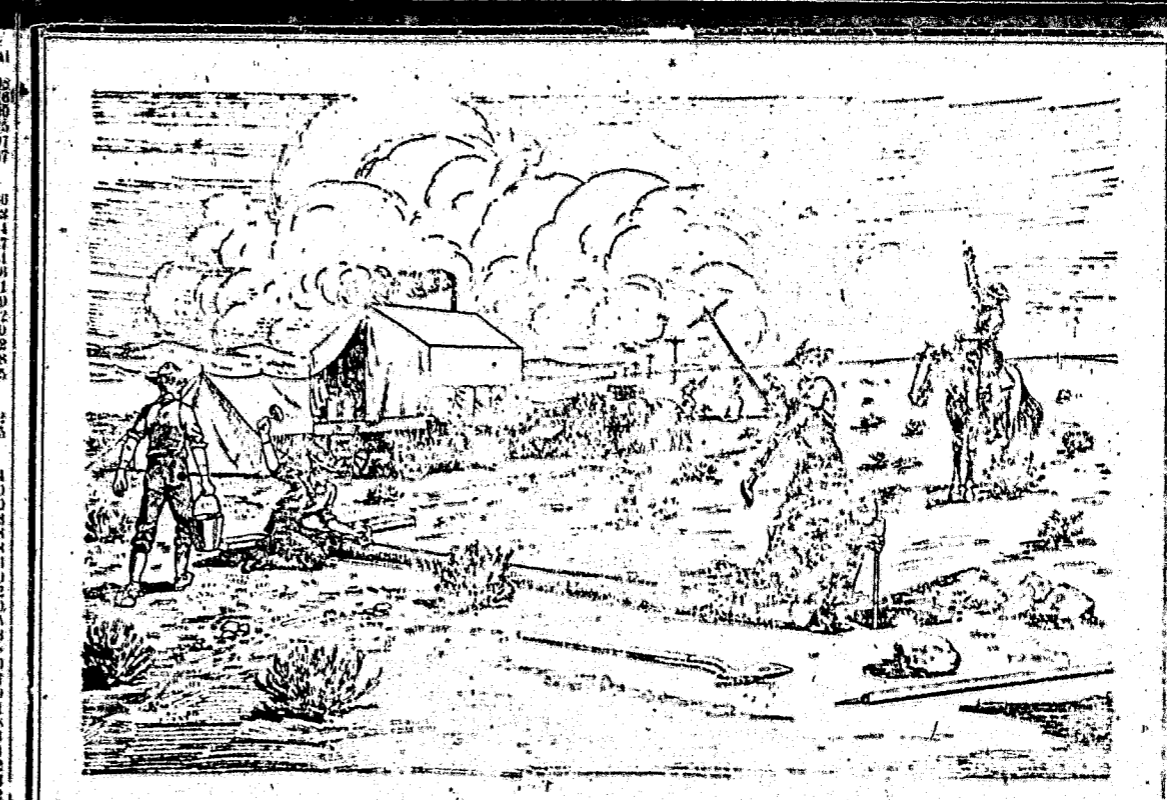

AN EVENTFUL PERIOD

We are living in an eventful period, and the past week has particularly been crowded with stirring events.

A crank took a couple of shots at J. P. Morgan, asserting that Mr. Morgan could stop the European but wouldn't. The crank was arrested and Mr. Morgan will recover.

A bomb was exploded in the reception room of the Capitol at Washington, but no one hurt, although the room was wrecked. It developed that the man who shot Morgan confessed to placing the bomb. He gave his name as Holt, but was afterward identified as Muentzer, a German.

The same individual claims to have deposited a large quantity of dynamite on an ocean liner and so adjusted it that an explosion would take place at sea; but no disaster of the kind has so far been reported.

Muentzer committed suicide in his cell, and thus closes the first chapter that had an ominous character.

The tentative reply of the German government has been received by the Washington government, and is said to be far from satisfactory. Further attempts will be made to reach an understanding.

The Germans continue their drive against the Russians and, while apparently succeeding, the slaughter on both sides is something appalling.

A combined attack by the English and French land and sea forces on the Dardanelles resulted in the capture of an important fort, but at the cost of an enormous loss of life.

In the western theatre of war the Allies claim some successes against the Germans, but it is reported that the Germans are preparing for a hard drive to the coast in the hope of reaching Constantinople.

Italy claims a number of important victories over Austria, and has occupied much territory, yet no decisive battle has been fought.

A decisive battle has been reported in Mexico resulting in a disastrous retreat of the Villa forces.
