Not a single New Mexico bank was distressed by the recent financial flurry. That may not signify much, but whatever it does signify is greatly to New Mexico's credit.—Socorro Chief-tain.

If, now, it should not be proved that there are at least a score of thieving scoundrels among the republican leaders of the territory, how disappointment would prey upon a few self-righteous critics and accusers!—Socorro Chieftain.

Governor Curry's trip to Washington to consult with the president in regard to matters of statehood and the president's reassurance that he will do all he can to bring New Mexico into the union as a state leaves little room for doubt as to the result of the present statehood movement. The people of the territory may be depended upon to do their part. They are nearly enough unanimous to make the objectors hardly worth counting. Let everybody boost.

The difficulty in the public land management of the west seems far from settled at the present time. On one hand we read in the papers of certain forest reserves being reduced and considerable amounts of land thrown open to entry, while on the other hand large tracts in other portions of the country are being withdrawn by the establishment of new reserves or the extension of those already existing. The question is strongly contested on the one hand by the settlers and citizens who claim that the land should be open to the use of the people, and on the other hand by the agents of the government who argue the necessity of protecting the forest. The arguments are undoubtedly influenced in both cases by personal interest and it is difficult to say which is the more correct. We believe, however, that there has been too much contention and not enough co-operation, and it is a hopeful sign when the people and the government agents get together in conventions to consider these matters as has been done during the past season, and we believe that the matter will eventually be settled in this manner.

Dispatches from New York say that, never in the history of Wall Street has there been such a rush of buyers on the market to take up the stocks being offered at low prices as during the past two weeks since the threatened panic. A notable feature of this buying is the fact that the greater part of it is being done by small purchasers, most of whom are strangers to the exchange, who have money saved up which they are now investing with a view to reap the benefit of the rise in prices which is sure to come within a short time. The very fact that the class of people who in former times have been the cause of continued hard times are now turning their money into the channels of trade is the best assurance we possibly could have that the present stringency will not last any length of time.

Several plans for providing an elastic currency have resulted from the recent financial flurry. One of the very best of these, and one which, by the way, is said to be favored by high government authority, is to the effect that national banks be authorized to issue a limited amount of emergency currency, but that it be taxed heavily enough to cause its withdrawal as soon as the emergency has passed. The plan is certainly feasible and good, and it will be interesting to note what reception it meets with if presented to congress.—Socorro Chieftain.

Says the West Union (Iowa) Argo: "Why," said the Argo man, "are the people behaving so sensibly in regard to the currency situation? Is it because they are so much wiser than at times of former financial troubles, or is it because the foundations of present prosperity are so firm that it is impossible to scare anybody?" The answer given by a judicious observer was as follows: "This is the first time the bankers have taken the public into their confidence. The minute trouble started this time they explained the situation fully, so the people believed them and co-operated to save the situation. On former occasions the bankers kept the facts to themselves until the trouble got beyond them, and then the public refused to be reassured."

Many of the democratic papers of the southwest are trying to make political capital out of the little financial flurry we are just passing through, but with hundreds of people coming to the front to purchase stocks and millions of dollars in gold coming from Europe in return for the products sold abroad, to say nothing of the general prosperous condition all over the country and the large amount of everything which is being placed on the market, the general run of people are too wise to be scared by these false alarms.

The Land Office records show twenty thousand original homestead entries during the past year in New Mexico. At this rate the public land of the territory will all be taken up within a very few years. In fact it is wonderful that fertile valley lands right on the main line of a trans-continental railway should be left open as they are in Carrizozo valley. The only explanation that can be given to this is the fact that no advertising has been done by our people, and in the din and confusion of other places shouting their advantages, people have failed to realize the conditions which exist here.




