THE COUNTY SEAT CASE

Lincoln Citizens' Bond Is Accepted By Judge-Injunction Still in Effect

COMMUNICATION FROM LINCOLN

Judge Edward R. Wright last Saturday December the 10th. approved the indemnity bond produced by Lincoln citizens in the county seat injunction case. Judge John Y. Hewitt and Ben Bechtel, contractor were present when the Judge examined the bond. The instrument contained amounts aggregating almost \$30,000 and the required amount was but \$10,000.

The defendants counsel Hewitt and Hudspeth were given forty days in which to reply to Quo warranto after which time the case will presumably be heard in the District court and possibly appealed to the Territorial Supreme Court. The next point to be heard from in the case will be, however, the hearing by the Supreme court of the old injunction case once decided against Lincoln which will be given a rehearing by the Supreme court which convenes early in January at Santa Fe. The latter case will determine whether injunction is the proper procedure or not.

LINCOLN SPEAKS UP

That this paper believes in the rule of the majority and is unquestionably with Carrizozo in the county seat controversy is known without doubt; but we also believe in the minority being 'heard' and for this reason alone we are publishing the following communication received from Jacob J. Aragon yesterday with a request that it be given space. We wish the people to consider our columns open to them at all times for the expression of their opinions. Lincoln has no paper closer at hand than Carrizozo. Being received at such a late date and our space being limited we will not be able to comment on the article until a later issue. But here goes for the article.

Some of the people of this county are beginning to understand that it is not Jacob J. Aragon alone who is worrying the denizens of the windy town lying close to the mal pais, but instead, many tax payers are sustaining the suits to keep the county seat at Lincoln and thereby save themselves and their property from heavy taxation hereafter on account of a proposed bonded indebtedness created to benefit the few at the expense of the many citizens of this county. This awakening is thoroughly evidenced by the Injunction bond

recently made by these tax payers whose aggregate returns of property for taxation shown by the records, amount in value to about \$30,000.

Judge Mc Fie first granted this injunction and subsequent events prove conclusively that he was right under the law in so doing, because his action was affirmed by Judge Wright, the only difference being that the latter Judge required a bond to continue the restraining order, now the query arises? Will a mass meeting be called and held in Carrizozo to condemn Judge Wright in the same public manner that Judge Mc Fie was condemned, and will the Department of Justice at Washington be requested to investigate the action of Judge Wright in the premises, the same as was done in Judge Mc Fie's case, if not why not? Another amusing feature which might be designated an antic, i. e., the pilgrimage of leading citizens to Alamogordo to have Judge Wright turn down the Injunction bond; This pilgrimage reminds some of us down this way of the Three Tailors of Tooty street, London, who wrote a petition to Parliament, beginning "We the people of England."

Mass meetings condemning Judges and the influence of leading citizens don't count with the courts in New Mexico.

WALTON SPEAKS FOR IT

Chairman of the Democratic Territorial Central Com. Favors Constitution

MANY DEMOCRATS ARE FOR IT

Hon. W. B. Walton, of Silver City, chairman of the New Mexico Democratic executive committee, declares himself strongly in favor of the adoption of the New Mexico constitution. In the last issue of his newspaper, the Silver City Independent, Chairman Walton says:

"The principle question before the people of New Mexico in the matter of the constitution is whether or not we honestly and sincerely desire statehood.

"The constitution adopted by the convention which recently adjourned is not all that it should be, especially from a Democratic standpoint, the chief objection being that it does not contain any provision for the initiative and a rather stringent form of referendum. On the other hand it possesses many good features and is as a matter of fact a very fair fundamental law. Such being the case the people, independent of party affiliations are justified in accepting it.

"But for those who earnestly desire statehood there are stronger reasons. If adopted there is every justification to believe that it means immediate statehood as there can be little room to doubt that congress and the president, or the president alone, will approve of the document in its present form.

"On the other hand, should the constitution be rejected by the people of the territory there is no telling what the outcome would be. Under the terms of the enabling act the constitutional convention would again be convened in Santa Fe with the same delegates and another constitution would be placed before the people of the territory, but too late for action at the coming session of congress. The delegates would of course be the same as those who sat in the last convention, and a personal knowledge of the situation makes it certain that very few changes would be made, certainly none of great importance, as about all the concessions that could be expected were made at the recent convention.

"If the second constitution was voted down statehood would in all probability be delayed for years."

LARRAZOLO WILL WORK

That the constitution will have a strong advocate in Hon. O. Larrazolo is shown in a recent interview given out by that distinguished democratic leader.

The constitution will be surely carried by the people of New Mexico on January 21, for to the united republican ranks the democrats will lend aid, their own leader, O. A. Larrazolo, former democratic candidate for delegate in Congress, pledging to stump six counties to carry it, and like Chairman W. B. Walton, the territorial chairman of the democracy, pledging himself to work for it.

FOUR GOOD REASONS

Four good reasons are given by the Pecos Valley News for its advo-

cacy of the ratification of the constitution They are:

1st. It was made by men elected by and representing the sentiments of the majority of the citizens of the various counties in New Mexico.

2nd. It is a document that is fair to all classes and in no way favors any one class above another.

3rd. It is an excellent example of fundamental law, in no way encroaching upon the privileges or duties of future legislative bodies.

4th. It eliminates chances for unfair salaries of county and state officers and places the election of officers with the voters.

HAVE YOU READ IT?

HAVE YOU READ the constitution of the new state of New Mexico?

Read it. Begin now and read a section a day. It won't take you long to read one section. Don't take anyone else's word for what it contains, or whether or not it is worthy of support. It is framed in clear concise English, about the meaning of which there can be no quibble, and if you really wish to know whether it is for the people, the best way to find out is to go to the document itself.

You will find that the constitution provides for a new state wherein the burden of taxation will be more equably distributed and where the abolition of the fee system will reduce the cost of running the government by thousands of dollars. You will find a constitution which is something more than a collection of hastily made laws, to be changed when some coterie of kickers desire, but which may be amended as easily as that of almost any of the older states. You will discover provisions which makes it impossible for legislators to waste the people's money, which assure that public funds will be placed in approved banking institutions where they will make money for the public. You will find stringent provisions for the regulation and control of the great corporations and common carriers, by a commission which you will choose with your votes. You will find provision for the election of your judges; for adequate redress for employes against negligent employers; a fair appointment on the new state; a sensible and rational referendum; that no legislature or municipality may grant exclusive privileges or franchises of any sort. You will find wise provisions for the administration of public lands and the proper conservation and development of resources; provision for a splendid public school system; provisions which guarantee, as nearly as an organic act may, equal rights to all, special privileges to none, and a square deal for every citizen.

You will find a constitution upon whose articles one hundred picked New Mexicans, representative business and professional men, were very nearly agreed. You will find omitted various hobbies supported by small minorities and legislative matter advocated by small groups, which a large majority decided were not suited for incorporation into an organic law, a framework for legislation, a foundation for government. You will fail to discover class legislation under the guise of fundamental laws; you will find only provision for a representative form of government. What you will find is the product of the representative form of government, the work of men elected by the people to do the work, because it is a fantasy to conceive of the three hundred thousand population of New Mexico holding a mass meeting to make a constitution.

But don't take our word for it. We urge you to read the constitution and draw your own conclusions. The only stipulation is, that not taking our word for it, you will neither take the word of the opponents of the constitution.

Go to the root of the matter. There is an election next month which will decide whether we are to enter the union. It is important that you be prepared to vote intelligently at the poll.

LAST WEEK just before going to press we received a telephone message from Capitan telling of Lincoln's making the required bond in the county seat injunction case. In hurriedly writing the matter up we stated that Lincoln celebrated the completion of the bond and it might be taken, we noticed on rereading other than in the jocular way in which it was intended. It was not our intention to reflect on anyone personally in anyway; we merely wished to note that Lincoln had celebrated the winning of a point in the case just as Carrizozo would have done. We trust that none of our readers misunderstood the remarks and hope they took the matter in a joking way as written. We would keenly regret casting any reflections on anyone's character and trust the article was not so taken.



WESTERN MINING NEWS IN BRIEF

THE TREND OF METAL PRICES.

Colorado.
A good strike is reported from the Neptune mine on Fall River, Idaho Springs district.

Baker & Burns are prosecuting work upon the Black Swan mines in the Adit tunnel, Idaho Springs district.

The old Prussian at Rowena, Boulder county, has been taken over by Wisconsin people and will be vigorously worked.

The Standard mine on Gibson hill, Breckenridge, is shipping high-grade silver-lead-zinc concentrates, the ore averaging in value close to \$90 per ton.

The National tunnel on Pine creek near Central City has broken into a nice streak of copper-iron, some of which can be seen on the dump at the mine.

A new strike is showing in the Lucky property on Mineral hill, in Breckenridge district, the ore body being eighteen inches wide and running high in lead and silver.

The Yankee Girl, Ouray district, which is credited with a production of \$7,000,000, is taking out ore and shipping a carload a day. The San Antonio is making a similar production.

The Reilling dredge, Breckenridge, has just made a clean-up of over \$8,000 in gold as the result of one week's run. This dredge has had a prosperous summer and is handling a large amount of gravel, from which good values are being recovered.

The Wellington mine continues as one of the biggest shippers in the Breckenridge district, its daily output being about fifty tons, and important finds occasionally are being made. A late strike in this property is a five-foot vein of silver, lead and zinc ore, found in the main shaft.

Eighteen inches of solid ore has been exposed in the drift run from the bottom of the eighty-foot shaft on the Star property in Peru district, that runs as high as 800 ounces silver per ton. The ore carries bismuth and yellow copper. The Star is owned by William Jacobs of Georgetown.

What promises to be one of the richest and greatest mineral discoveries made in years in the upper Clear Creek district is reported from the Mendota mine. In ground under lease to the Mendota Mines Company, above the Victoria tunnel level, a body of solid smelting ore has been opened that is twenty-three inches wide and test mill runs show 150 ounces silver per ton, with thirty-six per cent lead. It is stated that the lessee has refused a cash offer of \$20,000 for his lease.

James H. Meyers of Breckenridge and General J. C. Overmire of Ohio are promoters of a new enterprise designed to drive a mining drainage and transportation tunnel from a point near the Lenawee mine on the upper Blue river directly through Lenawee mountain to a point in Clear Creek county. The total length of the bore will be something over 17,000 feet. Good ore already has been discovered, which will be removed and shipped simultaneously with driving the tunnel.

New Mexico.
Pete Franston is taking out a six-foot streak of ore in the Alice mine, Mogollon district, which will average \$19 a ton. There is ten inches of ore on the hanging wall which will go \$60 a ton; this average has held good over 100 feet.

A rich strike of gold ore in the North Homestake mine, Mogollon district, was made on the 900-foot level, in a drift running in the direction of the South Homestake property.

Six thousand troy ounces of refined gold and silver bullion were melted and sixty sacks of concentrates were produced during last week by the Ernestine mine, Mogollon district. Five hundred and eighty-four tons of ore were treated taken largely from development which is being advanced in parts of the mine with encouraging results. It is authoritatively stated that there is now over \$1,000,000 more ore blocked out than at the beginning of the year.

Wyoming.
Drilling for oil and gas is actively going on in the neighborhood of Greybull. So far, every well drilled in that vicinity has proven a success.

Considerable development work is taking place on Copper Mountain, notably in the McGrath mines. Those properties are expected to become famous producers. The Fremont Development Company are investing about \$8,000 and in the same territory.

Tarsus, the ancient city in Asia Minor, where the apostle Paul was born, is now illuminated by electricity. The power is taken from the Cydnus river. There are now in Tarsus 450 electric street lights and about 600 incandescent lights for private use.

PRESIDENT HOPES TO GET TWO
JUDGES FOR SUPREME
BENCH.

COMBINATION FEARED

SUBMITS DESIRABLE TIMBER FOR
CONSIDERATION OF THE
SENATORS.

Washington.—President Taft is still worrying about his Supreme Court appointments. The refusal of Senator La Follette to go to the White House to consult with the President about the matter has not added to the latter's peace of mind.

It is known that the President fears a Senate combination which will reject any appointments he may make and force the question of filling the Supreme Court vacancies into the next Congress and before a Senate which will probably be controlled by the Democrats and the insurgent Republicans.

In order to avoid this calamity, the President has submitted to a number of senators a list of the nine men he is considering for the Supreme Court. The list has been permitted to reach the press. It is believed that the President is anxious not only to placate the senators but is desirous of sounding public sentiment.

In addition to Justice Charles E. Hughes, who was put down as the probable new chief justice, the list from which the President hopes to select two associate justices follows: Justice Francis J. Swayze of the Supreme Court of New Jersey.

Joseph R. Lamar of Augusta, Ga., former justice of the Georgia Supreme Court.

Justice Gordon Russell of the United States District Court of Texas.

Justice William C. Hook of Leavenworth, Kans., now a judge of the Eighth United States Circuit.

Justice Willis Vandevanter of Cheyenne, also of the Eighth Circuit Court.

Justice John C. Pollock of Topeka, Kans., United States District judge.

Chief Justice John Bradley Winslow of the Supreme Court of Wisconsin.

Senator George Sutherland of Utah.

W. D. McHugh, an attorney, of Omaha, Neb.

"Drys" Use Bible; Election Void.

Frankfort, Ky.—Because the "drys" of Powell county, Ky., used the Bible as an emblem on their ballots in a recent local option election and carried the county, the State Court of Appeals declared the election void. On each ballot was the picture of an open book with the words "Holy Bible" under it. The "wets" for an emblem used the picture of a whisky bottle and a glass, out of which protruded the head of a snake.

Mob Earns Union Quarters.

Fresno, Calif.—A mob here burned the headquarters of the Industrial Workers of the World, severely beat members of the organization on the streets and surrounded the county jail, where other members are being held. The demand was made that the Industrial Workers of the World prisoners be turned over to the mob, but no effort was made to enter the jail.

Charlton Returns to Italy.

Washington, D. C.—Porter Charlton, young American charged with killing his bride, who was Mrs. Mary Scott Castle, actress, in Italy and burying her body in a chest in Lake Como, will be returned to that country for trial. This is the decision of Secretary Knox.

Retired Officer Suicides

Washington.—Despondent because of ill health, Major General Wallace F. Randolph, U. S. A., retired, aged 69, former chief of the coast artillery corps, committed suicide at his home here by shooting.

Notwithstanding that both are grandparents with grandchildren in their teens, F. J. Evans, aged 65, a wealthy farmer, and Mrs. Eliza Cowley, aged 50, a well-to-do widow of Windsor, eloped to Greeley and were married.

TURNING ON LIGHT

PRESIDENT VAIL'S BOLD MOVE
MARKS EPOCH IN FINANCE.

"Accuracy" Reduced Western Union's
Surplus \$13,000,000.—"Publicity"
Inspired Such Confidence That
Its Stock Went Up.

Are the great financiers of the country beginning to see a new light? Time was, until recently in fact, when the men at the head of the big corporations "kept their business to themselves," as far as the law would allow. Capable men at the head of the big concerns, long realized the weakness of their position, but what was needed obviously, as in all great reforms, was an unmistakable occasion and a courageous man. The occasion arose in the purchase of the Western Union Telegraph company by the American Telephone and Telegraph company, and the man appeared in Theodore N. Vail, President of the purchasing corporation.

It was last December when public announcement was made that the Gould holdings of Western Union had been taken over by the Telephone company.

On account of the high esteem in which the management of the telephone company is so generally held, great things were predicted as a result of the absorption of Western Union. By the press of the country the "deal" was most favorably commented on, it being widely pointed out that under the direction of such men as Theodore N. Vail and his associates, the telephone company was bound soon to work itself into a position where it could offer the public far more efficient service than it had ever before been able to offer.

But a very few months had elapsed when it became apparent to the new management that a modern and up-to-date appraisal of the company's assets would make possible a far greater degree of efficiency of operation. "Here," they said to themselves, "we've bought control of this property and we know it's immensely valuable, but we don't know just how valuable. These appraisals of real estate and securities owned were made a long time ago. If we have a complete inventory made of every thing we've got we can announce the facts to the public, start a new set of books, and begin our responsibility to stockholders right there."

How Inventory Was Taken.

The most expert accountants and appraisers to be had were put at the task. Their labors lasted over eight months. Their report and its publication by the company marks an epoch in finance.

It began by recommending an adjustment of the difference between the appraised and book values by a charge of \$5,595,089 against surplus. Book values of securities held were reduced to market values, bad and doubtful accounts were "charged off," an allowance of \$2,000,000 was made for "depreciation," another of \$500,000 for "reserve," and so on, until the old surplus of \$18,867,000 came down to \$5,136,000.

It required courage, the publication of this statement to stockholders, saying in effect: "The property of your company has been revalued: the surplus isn't nineteen millions, as you have been led to believe, but five millions," but it was the truth, and President Vail did not flinch. "Accuracy and publicity," he declared, was essential. "The stockholder has a right to know. The shares of this company are scattered from one end of the Union to the other. This is more than a private corporation. It is a great national enterprise. The public is entitled to the facts."

The report was ordered published forthwith. Financiers of the old school and speculators generally were aghast. What would happen? Would the bottom drop out of Western Union when the shareholders realized that their property was worth \$13,000,000 less than they had supposed? But the amazing thing happened. The stock went up and stayed up. The public had responded to this remarkable display of frankness and confidence; to the new motto, "Accuracy and Publicity."

The full significance of the action of the new board is stated concisely by Harper's Weekly in these words: "Is this policy of publicity and of open-handed dealing with shareholders and public the forerunner of a similar movement on the part of other big corporations? Certainly it is to be hoped that it is. In the case of these big companies, dependent upon public patronage and doing business under public franchise, can there be any question of the right of the people to know?"

"That right is being recognized. It is recognized now in this epochal act on the part of the telephone and telegraph interests. It is the dawn of a new era in corporation finance."

LITTLE NEW MEXICO ITEMS.

Minor Occurances of More Than Ordinary Interest.

The new Magdalena opera house has been formally opened to the public.

Territorial Secretary Nathan Jaffa has put to work a clerical force of six. The Pecos Valley Teachers' Association will meet in Clovis next Thanksgiving.

Artesia makes a bid for the new Normal school because it has no schools.

The contract for the cement and brick work on the new school house in Deming has been let.

The plans for the incorporation of a large Polish sanitarium for Roy, Mora county, are almost complete.

The School of American Archaeology in which copies of the constitution will be mailed to the citizens of the commonwealth.

The poultrymen of New Mexico have formed an organization to be known as the New Mexico Poultry and Pet Stock Association.

The general store and tailor shop of O. N. Thompson, in Vaughn, containing about \$4,000 worth of stock, was entirely destroyed by fire.

A motion has been filed in the District Court at Roswell, asking for a new trial in the Bat Harris case, who was convicted for murder of Clabe Merchant, in the second degree.

J. R. Stanley, the well contractor, has moved a well rig on the farm of N. J. Winchell, south of Roswell, and will dig an artesian well there.

The football team of the New Mexico Military Institute, after an uphill fight of many years, is at last recognized as the undisputed champion of New Mexico for the year 1910.

Kirby S. Woodruff, formerly the only Republican sheriff Chaves county ever had, died at San Antonio, Texas, of Bright's disease and complications, aged forty-four years.

The New Mexico Military Institute football team is now the undisputed champion of New Mexico, having defeated the University, the School of Mines, and the Agricultural College.

To file upon desert land in New Mexico with the intention of immediately assigning it to other parties, is held to be fraud by Judge Welborn of the United States District Court.

Word was received in Santa Fe that the postoffice at Bluewater, Valencia county, was robbed of \$296. The alleged thief was taken off a Santa Fe train and lodged in jail at Albuquerque.

The homes of nearly 2,000 people will be inundated when the water is finally turned into the big Elephant Butte reservoir, and six villages whose history runs back 200 and 300 years will be obliterated.

Not only must the money of the people be safe guarded but it must yield interest, which interest must be used for the benefit of the people as is provided by Article 8, Section 10 of the constitution of New Mexico.

The Elephant Butte dam will not only supply the life giving waters of the Rio Grande to the chain of valleys along its course, but it will also supply power for operating machinery, for lighting and transportation in these valleys.

Fred Muller, receiver of the Santa Fe land office, reports that in November the rush for New Mexico's public lands, of which there is still 36,000,000 acres, was not affected by the cold weather. More than 25,000 acres was filed upon during the month, the fees exceeding \$12,000.

The fourth annual meeting of the Mountair Chautauqua will be held August 2 to 13 next year. The normal in connection with the Chautauqua will begin two weeks earlier and last four weeks and the Santa Fe has granted a rate of one and one-fifth fare for thirty days, beginning with the date of the normal.

Under Thomas P. Gable, the office of territorial game warden has become self-sustaining. Last month \$3,800 were collected in fines and licenses. The balance in the treasury to the credit of the office at the beginning of the last fiscal year was \$5,000; this year it is \$8,700, and that despite the fact that \$2,000 was expended for fish during the past season for stocking New Mexico streams.

The average precipitation for the Territory, determined from the records of 135 stations, was 0.72 inch, or 0.33 inch below the normal, and 0.9 inch less than the month of October, 1909. The greatest monthly amount was 2.76 inches at Swastika Ranch, extreme northwest Valencia county, and the least none at seven stations, while but a trace occurred to seven others. The greatest amount in any twenty-four hours was 1.66 at Aspen Grove Ranch in eastern Rio Arriba county, on the 20th. The average snow fall was 2.2 inches, almost three times that of October, 1909. There was an average of three days with precipitation.

LATE NEW MEXICO EVENTS

Santa Fe Bridge Destroyed.
Roswell.—The Santa Fe railroad bridge over a tributary of the Pecos river, fifteen miles north of Roswell, was completely destroyed by fire.

Ex-Governor Leaves State.
Santa Fe.—Ex-Governor Charles A. Reynolds, who has been a resident of Santa Fe about eighteen months and during this time associated with the United States general land office, has gone to Denver, having been transferred by the Washington authorities to the United States general land office there.

Where Women Can Vote.
Santa Fe.—The women of New Mexico will be granted the permission of voting at school elections and may hold office of school director or county superintendent, if they so desire, but cannot vote at municipal elections. The qualifications imposed on them as to residence and age is the same as those imposed on men in this respect.

Throw Dice for Estate.
Albuquerque.—An unique document was presented for record here being the will of the late Carl Schroeder. Unable to make up his mind to which of his two sons, Carl and Julius, he should leave his property, the will provides that they shall throw dice to see which has first choice of the property, which consists of two houses and lots and a slaughter house.

New Mexico Leads Them All.
Washington.—The population of Oklahoma is 1,657,155, an increase of 242,978, or 17.2 per cent over 1900. A recapitulation of census returns covering the detailed figures for eighteen states, shows that Iowa only suffered a decrease. New Mexico made the greatest percentage of gain, then came Arizona, and then Florida with 50 per cent less than New Mexico.

New Mexico Cotton.
Carlsbad.—The cotton crop under the Carlsbad project is nearly all gathered. The total yield will be about 1,000 bales. The two gins have been working over time all fall. The price of cotton is very satisfactory. The last sale was made at 15½ for middling, netting the grower here about 14½ cents. The seed is worth \$25 a ton, making a bale of cotton worth anywhere from \$88 to \$90 to the grower. The growers who have given their cotton proper attention are making a bale and a half to the acre. The cotton grown here grades very high most of it better than middling. The acreage of cotton next season is likely to be larger than in the history of the project.

Appointments and Estimates.
Washington.—President Taft sent to the Senate the following recess appointments: For associate justices of the Supreme Court of New Mexico, Clarence J. Roberts, of Raton, and Edward R. Wright of Alamogordo; for register of the United States land office at Fort Sumner, Arthur E. Curran of Clovis; for receiver, E. H. Salazar of Las Vegas. For U. S. district attorney for District No. 2, Bernard S. Rodey of Albuquerque.

The following are estimates for appropriations: Indians in New Mexico and Arizona, \$330,000; Indian school at Santa Fe \$58,500; Albuquerque \$60,000; an increase of \$4,000; salaries \$26,300; governor \$3,500 an increase of \$500; secretary \$2,500, an increase of \$700; contingent \$1,500; legislative \$2,400; reduced from \$24,000; surveyor general \$22,000, an increase of \$8,000; inspector of coal mines \$6,000, an increase of \$2,000.

Saloon License Raised.
Dexter.—At an adjourned meeting of the town board the board voted to raise the saloon license from \$360 per year to \$800 per year. The ordinance became a law by a unanimous vote of the members present to suspend the rules and advance the ordinance to the third reading. The figure determined upon was a compromise measure. A part of the board holding out for \$1,000, while another faction thought \$750 ample. As the territory requires a \$400 license, a total of \$1,200 is required for the privilege of running a third parlor within the confines of Dexter.

New York-to-Pacific Project.
Santa Fe.—The arrival in Albuquerque of T. DeWitt Cuyler, a director in both the Santa Fe and the Pennsylvania railroads and a number of Santa Fe officials, headed by Vice President J. W. Kendrick, in charge of operations, caused an immediate revival of the report made public some months ago that the Pennsylvania road planned to operate trains from New York city clear to the Pacific coast, using the Santa Fe from Chicago.



NEWS TO DATE IN PARAGRAPHS

CAUGHT FROM THE NETWORK OF WIRES ROUND ABOUT THE WORLD.

DURING THE PAST WEEK

RECORD OF IMPORTANT EVENTS CONDENSED FOR BUSY PEOPLE.

WESTERN.

The population of Nevada is 81,875, an increase of 39,540, over 1900.

The population of Idaho is 325,594, an increase of 259,229, over 1900.

The population of Oregon is 672,765, an increase of 259,229, over 1900.

The War Department will sell the old Fort McKinney military reservation near Buffalo, Wyo., containing 16,000 acres.

James Radley, the English aviator, made a flight in his Bleriot monoplane from Castroville to Del Monte, Calif., sixteen miles, in twelve minutes, or at the rate of eighty miles an hour.

Cesario Sanchez and Rafael Barela were hanged in the penitentiary in Florence, Ariz., for the murder of Gregorio Conejo, an aged Mexican, near Bellemont, September 27.

During the past year there were fifty-one fatal accidents in Montana metallurgical mines, according to the annual report of State Mine Inspector William Walsh, submitted to Acting Governor Allen.

While he was frolicking with other boys who worked with him in a factory in New York, Louis Scheerer fell into a vat filled with a solution of cyanide of potassium. He opened his mouth to scream, swallowed some of the solution and died immediately.

The Seattle board of education put an end to negotiations that have been carried on between Chicago and Seattle promoters for a football game Christmas between the Oak Park (Chicago) and the Lincoln (Seattle) high school teams, by passing a rule prohibiting the holding of such a contest.

Twenty-five newsboys were arrested in San Francisco upon complaint of the city prosecuting attorney and charged with having sold copies of papers printed in San Francisco and other cities which contain racing forms. The publication of such forms and racing odds and tips is contrary to a city ordinance, the penalty prescribed being a fine of \$500 or six months' imprisonment.

Fourteen Shoshone Indians are supposed to have been killed, and their bodies, with those of their horses, buried in two trenches in Elk county, Nevada, according to a communication sent to the department of justice by T. Hartley Lee, prosecuting attorney for Cassia county, Idaho, who seeks to have the department aid in bringing the murderers, who are said to be white horse thieves, to justice.

WASHINGTON.

Washington.—While it is not definitely decided, it is probable that orders will be issued shortly for every clerk in the various departments here to put in half an hour more work each day.

A fashionable wedding of interest to both naval and diplomatic circles took place in Washington, when Miss Eleanor Terry, daughter of Rear Admiral Terry, became the bride of Lieutenant Filippo Camperio, an officer of the Italian navy.

SPORT.

Paddy Lavine of Buffalo and Buck Crouse of Pittsburg signed article to fight a twelve-round bout at Akron, Ohio, on New Year's Eve.

Young Miller of St. Paul retained the welterweight wrestling championship of the world by defeating, in that city, Eugene Tremblay, of Montreal.

The business men of Colorado Springs showed their appreciation of the splendid record made the past season by the Colorado Colleger Tigers and the high school Terrors, by giving an elaborate banquet.

Yusuff Mahmoud, the Bulgarian wrestler, through his managers in Chicago, claimed the heavyweight catch-as-catch-can wrestling championship of the world, following the positive statement of Frank Gotch that he had retired from the mat for good and never would wrestle again in public.

Low Powell, of California, again demonstrated superiority over Young Otto of New York at the National Sporting club in the latter city. Otto had the advantage in the early rounds, but Powell's ability to punch and his gameness gave him a decided lead in the latter rounds. Young Otto was badly marked about the face.

FOREIGN.

The latest election results in London merely confirm the opinion formed that as the results of recent contests the Unionists have now no possible hope of replacing the Liberal government in power.

As the result of the extraordinary agitation in recent months by Chinese anti-opium societies, in Peking, the imperial senate almost unanimously passed a resolution looking to the extermination of the drug.

A balloon owned by the International Ballooning Club of Munich, which rose from that city and moved first in the direction of Switzerland, landed near Kirkwall, in the county of Orkney, Scotland, after a wild flight across the North sea, during which one of the three aeronauts, Herr Metzger, lost his life.

GENERAL.

Tamer than for years, more than 1,000 deer were killed, it is estimated, in Massachusetts, during the season.

At the age of 108 years, Martha Gammons has been declared to be sane in the Howard county (Mo.) Circuit Court.

Fifteen persons were seriously injured when a Missouri Pacific passenger train was wrecked near Knobnoster, Mo.

Elbert H. Gary of New York, chairman of the United States Steel Corporation authorized a denial of reports intimating that curtailment of operations and the discharge of thousands of employes is contemplated. "There is no reason to look for the discharge of a number of men," he said.

Mrs. Mary Baker Glover Eddy, the leader and founder of the Christian Science church, is dead. "Natural causes," explained the death according to Dr. George L. West, a district medical examiner, who was summoned a few hours after Mrs. Eddy passed away. Later Dr. West added that the more immediate cause probably was pneumonia. Mrs. Eddy was born in Bow, N. 



RED CROSS SEAL IN HISTORY

First Used During the American Civil War—Now an Aid in Fighting Tuberculosis.

Red Cross Christmas seals date back in their origin to "charity stamps," first used for the soldiers' relief funds in Boston in 1862, during the Civil War. After the war, this method of raising money was discontinued in this country for a generation, although it found vogue in Portugal, Switzerland, Australia, France, Spain, Denmark, Norway, Russia, Sweden and other European countries. There are now several hundred different types of charity stamps used in all parts of the world.

Stamps or seals were first used to get money for the anti-tuberculosis crusade in Norway and Sweden in 1904. After being used in these countries for three years, as a direct result of the interest of Jacob Riis in Tuberculosis association, headed by this movement, the Delaware Anti-Miss Emily P. Bissell, and the Red Cross society of Delaware combined in issuing a tuberculosis stamp. So successful was this campaign that nearly \$3,000 was realized, and the next year, in 1908, the American Red Cross was induced to issue a national Red Cross tuberculosis stamp. From this sale, \$135,000 was realized, that amount being almost doubled in 1909. This year, for the first time, the sale is organized on a comprehensive basis, taking in all parts of the United States. A million for tuberculosis work is confidently expected.
