NATIONAL BANK IS NOW A CERTAINTY

Charter Approved by Department and Carrizozo is Soon to Have Another Banking Institution.

CAPITAL STOCK SUBSCRIBED IS 50 THOUSAND DOLLARS

Carrizozo gets another bank, this time a national bank.

Such is the announcement made this week by E. M. Brickley, of Corona, who has been chosen as cashier of the new institution. Mr. Brickley further states that "The First National Bank of Carrizozo" will be ready for business very shortly. It is planned by the new organization to erect a modern building as early as practicable but for the time being a building will be rented in which to house the new and expensive fixtures which they have planned to install. According to announcements the new bank's equipment will be of the most modern and substantial throughout, including one of the new Burroughs posting machines ("human" mechanical bookkeeper) which are revolutionizing the clerical work of the bank, doing away with extra bookkeepers and reducing errors impossible.

The application for the charter for the First National bank of Carrizozo was approved December 19th and the new institution will be under the same management as the First National Bank of Tucumcari, First National Bank of Santa Rosa, Torrance County Savings Bank, Willard; Roy Trust and Savings Bank, Roy, and the Stockmen's State Bank, of Corona, New Mexico, with the addition that David T. Beals, assistant cashier of the Inter-State National Bank, of Kansas City, Missouri, one of the heaviest stockholders, will go on the board of directors and his bank will be added to the chain already mentioned. Also a connection will be formed with the National Bank of Commerce, of New York City.

Cashier Brickley further states that practically all the equipment, stationery, etc., has been ordered and the bank will be ready for business very soon, and that the First National Bank of Carrizozo expects to give to the people of Lincoln county all that could be required of an up-to-date progressive bank.

The total wealth of the stockholders of the First National is said to be more than a million dollars. The following are subscribers to the \$50,000 capital stock of the new bank: H. B. Jones, David T. Beals, Paul Mayer, E. M. Brickley, Dr. J. W. Laws, O. Z. Finley, J. C. Brickley.

STATE FACING WARM FIGHT ON PROHIBITION

Wets and Drys Lining Up Forces for Initial Struggle in State Legislature.

Santa Fe, N. M.,—A vigorous fight by the liquor interests on the proposed submission to the voters of a statewide prohibition amendment, pledged by both parties, will be inaugurated immediately after the opening of the legislature session Tuesday. In the event it appears impossible to head off submission, it is expected the liquor men will demand a clause providing for their compensation and reimbursement while brewers will seek to have been excepted. Indications are now that the liquor interests are prepared to force such a fight to the limit. The prohibition forces also for the first time have an efficient statewide organization which was responsible for securing the submission planks in the Republican and Democratic platform.

Committee Fixes Date for Convening of Recently Organized Parent-Teachers' Local Association.

A number of the school patrons of Carrizozo met with the teachers at the Crystal theatre again Monday night, following the announcement made at the initial organization meeting which was held Friday, December 29th, at which time the association was perfected and committees chosen.

French who has awakened a lively interest in the spirit of the meetings, being exceptionally well qualified for the position held in the organization on account of the many years devoted to and her familiarity with school work. An address by H. C. Franklin on "The Proper Attitude of the Pupil Toward his Work" was well received and was plainly to the point. W. H. Osborn was made secretary of the Patrons' Club.

Mrs. E. J. Jewett, Mrs. J. B. French and A. J. Rolland, the committee appointed at the last meeting to investigate and recommend a regular time for meeting made their report Monday night, the frequency of the meetings being recommended monthly and the date set for the 2nd Monday of each month.

Three musical numbers were highly enjoyed. The first was a mandolin duet by Mesdames Mason and Fairbanks, accompanied by Superintendent McCurdy. A vocal solo by Miss Blanch Garvin and piano solo by Mrs. Donaldson were very commendable. The program committee is composed of Mrs. J. F. Kimbell, W. H. Osborn and Superintendent McCurdy.

Next meeting of the Patrons' Club will be held February 12th at the Crystal theatre at 8:30 p. m. at which time every patron in Carrizozo is urged to be present and assist in this important movement.

A. H. Harvey and A. Vega Elected Peace Officers

At the precinct election held here Monday, Albert H. Harvey former county clerk, was elected justice of the peace over three opponents, and Antonio M. Vega was elected constable without opposition. Considerable interest was shown in the justice of the peace race and the voting was rather spirited.

The vote polled for each candidate follows: Harvey, 79; Bentley, 54; Brady, 38; Perkins, 35. Vega received 206 votes.

\$55,000 Road Bond Election to be Held March 7th

March 7th was the date set upon which to hold the election to vote for or against the bonding of the county for \$55,000 for the making of good roads by the commissioners at their last regular session. The petition was presented to the commissioners by Dr. S. M. Johnson, of Ruidoso. Representatives of brokerage companies were present and made bids for the bonds, same being disposed of, subject to passage, at par.

A Federal act provides for the duplication of any amount furnished by the various counties of the states to be applied on the roads of the county. There is practically no opposition to the bond proposition and upon its passage March 7th the United States will "kick in" with a like \$55,000 from the road fund which will make available \$110,000 to help make good Lincoln county roads.

640 ACRE HOMESTEAD BILL BECOMES A LAW

President Wilson Signs Bill for Enlarged Homesteads in Arid Regions.

President Wilson has signed the Ferris bill opening 640-acre homesteads for stock raising and grazing purposes. It is accounted of great importance to the western states.

The bill authorizes the secretary of the interior to designate the land which will be subject to entry under this bill. It will require some time to do this and those who attempt to make filings under the bill prior to such designation by the secretary must do so at their own risk. The bill provides, however, that settlers may file on lands before the secretary has completed the work of designation. The application must be accompanied by affidavits showing that in the opinion of the entryman the land is of the character contemplated by the act. In addition to that the entryman must deposit with the land office the regular fees and thereupon the land will be withdrawn from entry until the secretary of the interior shall have an opportunity to determine its character. The entryman, however, will not be permitted to occupy the land until the secretary has actually designated it as subject to entry.

Any person qualified to make entry under the general homestead laws of the United States may make a stock raising homestead entry. Instead of cultivation, as required by the general homestead laws, the entryman will be required to make permanent improvements upon the land of a value of not less than \$1.25 per acre, and at least one-half of the improvements must be

TRIO SERIOUSLY HURT IN AUTO ACCIDENT

Car Turns Turtle When Parallel Rod of Steering Mechanism Snaps Under Heavy Strain.

ACCIDENT VICTIMS REMOVED TO LUCAS HOSPITAL

BULLETIN:

Gordon Pine died this afternoon at Hotel Dieu in El Paso where he was removed this morning to undergo an operation in the hope of saving his life.

Dr. E. H. Pine, well known veterinarian of this city, and his two sons, Herold and Gordon, aged three and fifteen respectively, sustained more or less serious injuries Saturday afternoon about 3:30 o'clock when the automobile in which they were riding turned over. The scene of the accident was about a quarter mile east of town. Early in the afternoon Dr. Pine received a call to go to the stock pens of the local railway company to inspect a herd of cattle. It was desired to complete the inspection before the arrival of the late northbound freight which was to take the

to do this it was necessary to make all possible haste. The doctor, it is stated, was driving at a good rate of speed when he attempted to steer the car around a wagon, the parallel rod of the machine snapping in two, promptly upsetting the car.

Gordon, the older son who was with his father was holding his little brother on his lap when the accident occurred, and for a moment the danger threw the little fellow as far as he could out of the way but did not have time himself to leap from the tottering car.

The injured trio were picked up by passers-by and hurried to town and immediately taken to the Lucas hospital where, upon examination, it was found that the doctor had sustained a broken shoulder blade in addition to minor injuries, Harold the younger son had sustained a dislocation of the arm, and Gordon, the most severely injured of the three, suffered a broken back.

Gordon's recovery is considered doubtful while the other injured are getting along nicely.

"Every day spent in school
the children earn \$9."

This statement was recently
made by State Superintendent
C. P. Cary, of Arkansas, who
bases his estimate on the official
records of the Bureau of Educa-
tion at Washington. Here is
what he offers as proof of the
statement:

"Uneducated laborers earn on
an average \$500 a year for 40
years, a total of \$20,000.

"High school graduates earn
on an average \$1,000 a year for
40 years, a total of \$40,000.

"This education requires 12
years of school of 180 days each,
a total of 2,160 days. If 2,160
days at school add \$20,000 to the
income for life, then each day at
school adds \$9.02.

Cary, "it tells but one side of

OVER HALF BILLION OF COPPER.

The production of copper in the
United States in 1916 surpassed
all previous records, according to
the United States Geological Sur-
vey. Preliminary figures and esti-
mates have been collected by B.
L. Butler, who has received re-
ports from all plants known to
produce blister copper from domes-
tic ores and refined copper. At
an average price of about 27 cents
a pound the output for 1916 has
a value of \$520,000,000, compar-
ed with \$242,900,000 for the out-
put for 1915 and with \$189,790,-
000 in 1913.

The production of copper from

the mines of the United States
for 1916 was more than double
that of 10 years ago and more
than four times that of 20 years
ago. The profit resulting from
the domestic production was far
greater in 1916 than in any pre-
vious year. It is probably safe
to say that it exceeded \$300,000,-
000.

The average price of copper
for 1916 showed a marked in-
crease over that of the preceding
year, being slightly above 27
cents a pound, compared with
17.4 cents in 1915.

Arizona made a record produc-
tion. The total may reach 675,-
000,000 pounds as compared with
432,000,000 pounds in 1915. This
exceeds the total output of the
United States as late as 1902.

The production of New Mexico
will probably reach 90,000,000
pounds as compared with 62,800,-
000 pounds for 1915.

640-ACRE HOMESTEAD BILL BECOMES A LAW

President Wilson Signs Bill for Enlarged Homesteads in Arid Regions.

placed on the land within three years from the date of entry.

The bill provides that settlers who have made filings under the general homestead law and amendments thereto may make additional filing sufficient to give them 640 acres. However, they must show that the land on which they originally filed is of the same character as the land affected by the 640 bill. In other words, that it is chiefly valuable for grazing and raising forage crops, does not contain merchantable timber, is not susceptible of irrigation from any known source of water supply, and is of such character that 640 acres are reasonably required for the support of a family.

The land covered by an additional entry must be within a radius of 20 miles from the settler's first entry, and entrymen is required to file on contiguous areas which may be open to entry prior to filing in not-contiguous land.

Homesteaders who are living on their original entries are not required to establish residence on their additional entries. When they come to prove up it will only be necessary for them to show that they have made the required permanent improvements. In case a homesteader finds he is within the prescribed radius of 20 miles he may, if he sees fit, surrender his original filing and make a new entry covering 640 acres. The second entry, however, must be in the same land office district as the first. Homesteaders who are entitled to make additional entries have preferential rights to file on land for 90 days after the secretary of the interior has designated the land subject to entry under the provisions of the bill. In case this preferential right leads to a conflict between homesteaders the secretary is authorized to make a division of the land.

Building New Grade.

Workmen began this week near Oscura at constructing a new grade for the Southwestern line, the purpose of which is to straighten the curves near this place which will materially shorten the line and improve the service. The line will be run straight, cutting through the hills and making fills where necessary. Many of the fills will require 25 or 30 feet of dirt while some of the cuts will be 35 feet or deeper and it is estimated that it will require six months with the 260 men now at work to complete the proposed grade.

Car Strikes Ambulance.

It was reported here this afternoon that the ambulance which met the party consisting of Dr. R. T. Lucas, Mr. and Mrs. H. E. Pine and their son, Gordon, whom they were taking to

Hotel Dieu to undergo an operation, was struck by a street car in El Paso and the occupants were somewhat shaken up. Dr. Lucas is said to have sustained slight bruises. Gordon Pine was rushed to the El Paso hospital early this morning where it was thought an operation would save his life. He underwent the operation successfully and apparently rallied from the effects of the anaesthetics but death came about three o'clock this afternoon.

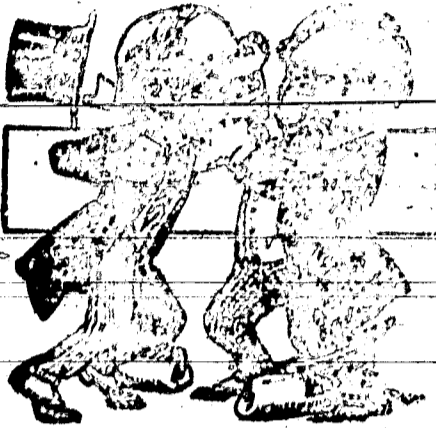
