

# Candidates announce intentions to file for Lincoln County offices

## Democrats take lead in filing for offices

Tickets of both the Republican and Democratic parties for offices in Lincoln County are beginning to shape up following meetings of both parties—the Democrats last week and the Republicans this week.

Following their meeting in Capitán last week, presided over by their county chairman Hollis Cummings, the Democrats came up with the following slate of candidates who either announced formally, or stated they were seriously thinking of filing for an office:

For County Assessor—Austin Wooten and Ramon Luna.

Mr. Wooten, a Carrizozo business man, informed the News following last week's meeting that he definitely will file March 1 for the office of assessor.

Mr. Luna, also of Carrizozo, is a former county assessor.

For County Treasurer—Lewis E. Cummins, incumbent, of Capitán.

For State Senator—Herman Kelt of Carrizozo and Dan D. Swearingen of Ruidoso.

Mr. Kelt said this week that he is considering filing for State Senator, but that his decision is not definite at this time.

For Sheriff—Frank Barajas, present chief deputy sheriff, of Ruidoso, who had previously announced his candidacy, and Abe B. Sanchez of Nogales.

For County Commissioner, District 1, Roman C. Nunez, incumbent.

For District Attorney—Dan Sosa Jr., incumbent.

For District Judge, Third Judicial District—W. T. Scoggin, incumbent.

# Capitan Services for Joe Rench

The esteem with which Lincoln County regarded Joe Rench, late mayor of Capitán, was expressed by the throng that attended the funeral services held for him on Tuesday, January 12, in the Capitán High School.

The county was shocked by the sudden death of the popular Capitán mayor at his home around 6:30 Saturday evening, caused by an aneurysm of the aorta.

The Reverends Kater, Abney and Stalter officiated at the service, with music by Mrs. Fletcher Hall, Mrs. Bill Hall and Mrs. Leota Pfingsten.

Full military grave services were held with personnel from the Red Canyon Range Camp. Interment was in the Angus cemetery.

At their regular monthly meeting this week, the Lincoln County Board of Commissioners passed a resolution of sympathy, to be sent to Mrs. Rench.

Joseph Edward Rench was born in Elkhart, Ind., April 13, 1900. After serving in World War I, he moved to New Mexico. Here he was well known for his brick masonry craftsmanship and for his association with the AA fellowship.

He was a past president of the Bricklayers of New Mexico and a number of their achievements as an organization were credited to him. He was also a vice president of the Federated Bricklayers of the State.

Mr. Rench was elected mayor of Capitán in May 1938. He was also president of the Capitán Chamber of Commerce and building chairman of the Smokey the Bear Museum, his favorite project.

In his capacity as mayor of Capitán he devoted his efforts toward a number of improvements, among them, the new bridge north of Capitán, sewage for the village, additional paving where needed, and a "Clean Up Our Village" campaign.

Mayor Rench was known by all for his love of his fellowman, whom he was ready to help at any and all times. His faith in the future of Capitán was unlimited.

He is survived by his widow Margaret of Capitán; by two sons, Joseph E. Rench Jr. of Houston, Texas, and Boise E. Rountree of Temple City, Calif.; and by five grandchildren, Sharon and Beth Ann Rountree of Covina, Calif., and Susan, Craig and Marcia Rench of Houston, Texas.

Funeral services were held at the Capitán High School, with Rev. Fletcher Hall, J. G. Otero, Bert Cheney, Ray Provine, Fred English and Tranquilino Silva.

Arrangements were under the direction of the Shaw Mortuary.

## 54 inches of snow recorded at Corona

CORONA—Mrs. R. E. Risinger, depot agent at Corona, says the records at the depot show that 44 inches of snow fell at Corona in December and 10 inches of snow fell from January 1 to 16, making a total of 54 inches of snow.

The greatest snowfall was on December 14, 15 and 16 when over 30 inches was measured.

December's highest temperature was on the 2nd—51° above. The lowest temperature was 8° above on December 23.

Highest temperature in January, up to the 9th, was 52° on January 8. January 6 it was a—5°.

Corona had more rain Monday night of this week and a trace of snow Tuesday morning.

A few warmer days the first of this week melted the snow, except where it was drifted and in ditches.

Most of the school buses were unable to make their daily rounds because of muddy roads and the Corona schools were dismissed one day last week because of a broken water line and the school had no water for the boilers or for use in the lunch room.

## New Mexico Chronicle

It wasn't enough for the Navajo to have to protect themselves from the U. S. Army in the 1860's. Also fighting them were the Zuni, Apache and Pueblo Indians.

In an unsigned report to Santa Fe from Ft. Wingate and dated October 6, 1863, a major in the First Infantry, California Volunteers, said:

"I have the honor to report that in accordance with instructions received from Lt. Col. Graves, I left this post on Tuesday the 15th ult. with 40 men each of Co's "H" 1st Inf'ty, C. V. and "B" 1 N. M. V., for an expedition against the Navajo Indians.

"I proceeded from this post direct to a rancheria, in the vicinity of the Sierra Dattil, about one hundred miles distant from here, but on my arrival at that point, found it had been attacked two days before, by a party of about three hundred Pueblo Indians, who had killed the Chief Barboncito, with 18 others, and captured 44 squaws and children, and about one thousand head of sheep—losing themselves two men. This had scattered the Navajos from this vicinity.

"While I was here the Indians passed close to me, with two or three hundred head of horses, and a large quantity of sheep, but having no mounted men, I was unable to overtake them. They passed north and I was informed were going to the Sierra Chusca.

"I then proceeded about fifty miles south to the Cienega Amarillo. In this vicinity there were signs of having been large lots of stock, principally horses, but they were driven off on our arrival, and we were not able to overtake them. We succeeded in taking a horse and a mule at this place.

"After searching this country thoroughly, I marched in accordance with my orders to the Little Colorado River, which stream I reached at the point of its issue from the Sierra Blanco, and proceeded down the river, examining the country for about forty miles; everything in that vicinity showing that the Indians had left there.

"I directed the command by the Ojo Redondo or Jacobs Wells on Beales wagon road to California. At this point I found a few Indians, capturing two. I also found large fields of corn, watermelons and pumpkins, which I destroyed, also a large Rancheria which was burned by us.

"From this place I returned to Fort Wingate, having been absent 21 days, and travelling with Infantry Companies, very nearly four hundred miles. I cannot speak in too high terms of the officers and men of this command; no men could be more anxious to do their duty, or more cheerfully incur the hardships of a campaign. After a march of 25 to 30 miles, the whole command would cheerfully volunteer and march the whole night on the slightest prospect of doing any service.

"In passing Zuni I found those Indians had declared war against the Navajos, and at the time I was there, were having a war dance over some scalps taken by them. Their chiefs requested from me that in case of the Government making a peace with the Navajos, they should be informed of it, as they intended to continue fighting them, until this happened.

"It is the opinion of all who have facilities for gaining information, that the Navajo tribe has been more severely punished this summer than ever before. They have been closely hunted in almost every direction, by the troops and of late by Zuni, Apache and the Pueblo Indians.

"In the large scope of country over which I have travelled during the past month, every evidence tends to show that in that section they have no longer permanent abiding places, but are fleeing from one part to another, in a continual state of fear."

## New salary schedule for county officials effective first of next year

A resolution was passed by the Lincoln County Commissioners at their regular meeting January 11, setting the salary schedule for county officials as that of a first class county.

Lincoln county has moved into the bracket of a first class county with an assessed valuation of over \$14,000,000, but under \$27,000,000, as provided in Sec. 15-34-4.4, New Mexico Statutes 1953 Annotated and supplements thereto.

The following shows the present salary schedule and the one which will go into effect January 1, 1961:

A lease purchase agreement was entered into with the Border Machinery Company of El Paso, for a "preparator" road machine, the price being \$20,232.42.

County Clerk Inice Huft has been advised by District Attorney Dan Sosa that the required 352 first year's annual salary, required of those filing for county office, be based on the new salary schedule which goes into effect January 1, 1961.

He added, "Farm wages are reported on a yearly basis. The report covering employees who worked in 1959 must be filed with the director of internal revenue during January 1960." The report must be filed for

(1) any employee who was paid \$150 or more in cash wages during the year or

(2) any individual who worked on 20 or more days in 1959 for cash wages figured on a time basis (for instance, by the hour, day, week, etc.) regardless of the total earnings for the year.


"There was a sharp increase in the number and quality of reports filed by area farmers last year. Correct and complete reporting helps guarantee that the employee receives full social security credit for the work he has done.

**Opportunity in Navy for qualified sub personnel**

Lcdr. D. L. Fuller, commanding officer of the Navy recruiting station, Albuquerque, has announced the Navy's latest policy covering the re-enlistment of personnel who have held active duty rates in the Navy's submarine service.

Effective immediately certain personnel who were qualified and designated for submarine duty at the time of discharge or release from active duty, and who have been discharged or released less than three years, may re-enlist in the regular Navy in the rate held at time of discharge or release to inactive duty.

Due to the urgent need for qualified submarine personnel this extreme departure from the normal 90-day re-enlistment time has been instituted. 



# TALKING BACK

By HOMER REID

Dear Jack: I've received a number of letters in reply to your letter—some of them agreeing with your attitude toward the "place" of a minister in the community.

I grant you that a minister can spread himself too thin by trying to participate in too many community affairs. Usually he's asked to do the things that "busy" people just can't get around to doing; but if he is supposed to bring "spiritual enlightenment" to the community, it's certain that he must spend most of his time seeking spiritual enlightenment himself.

Any faculty that is not used tends to atrophy—that is true in the physical and intellectual. You don't use the muscles of your arm for a few months and those muscles will gradually become useless—you will not be able to use them.

If you refuse to use your higher mental and spiritual "muscles," the time will come when you no longer have them to use at all. If constantly you choose sensual, physical and materialistic things in preference to spiritual things, you will lose that power to choose at all.

I become impatient with that neighbor who leans over the garden wall when I'm getting ready to go to church and says complacently: "Y' know, I'm not a religious man. You go on to church—but actually we are traveling the same road and we're all going to the same place after all."

I don't like to be unneighborly, but I can assure you that we are not traveling the same road and we're not going to get to the same place! If your sensitiveness to God is increasing, you are going to heaven. If it is decreasing, you are on the road that leads to hell! You either use your spiritual perceptions to "see" God or else you lose the ability to use them at all—your spiritual sense can atrophy as quickly and even more quickly than some physical sense!

People who go to church do not claim to be better or more righteous than non-church goers—the fact of the matter is they feel a need for the spiritual inspiration to be found in a church and go there hoping to find it. I admit that it is not always found in a church, unfortunately, but you will have much more chance of finding spiritual inspiration in a church than you will in a bar or in a movie or at a dance!

A hypocrite is a person who "acts a part" he doesn't believe in. The church member admits quite frankly: "I'm far from perfect! I need spiritual help and enlightenment. I think I can get it in church. There will be others seeking the same thing here—there will be a fellowship and I can be helped and can help others!"

The real hypocrite is the man who thinks he's so spiritually advanced, or intellectual, or "smart" that he doesn't need the church and what it has to offer. You'll find more hypocrites outside the church than you will inside! The church is not perfect—ask any church member and he'll tell you that; but at least he's trying to make it better and is willing to give some time and effort to make it so!

When you say you are not going to participate in the church because there are people belonging to it that you don't like, or don't practice what they preach, or are mean and cantankerous, you are judging something by individuals. The church is bigger than any individual! Modern medicine has helped mankind; you wouldn't refuse to have anything to do with it because you thought one of the doctors was unethical!

You mentioned art and science and music and so forth, as contributing to the welfare of mankind. That's true, and because you didn't like the life of Michelangelo, you have nothing to do with art; or because you don't like the way the boy next door plays the trumpet, you are not going to have anything to do with music; or because some scientists are of a different social set than yours, you are going to have nothing to do with science. You see how childish this sounds when you stop and think about it!

I realize that "historically" the church has made many mistakes, but where would we be if the

The religious shoemaker is as much a servant of God as the man who hands you the sacrament. He is, in fact, in God's world doing God's work for God's people. Because he is a religious shoemaker, he cannot put cardboard instead of leather into shoes. Making a good pair of shoes thoroughly is a divine service because it is a contribution to the welfare of men, and aid service to men is the only way of serving God.

I think the church has sinned in this regard also in implying that there is something ungodly in appreciating the joys of the senses. In olden days the saints talked much about "withdrawing from the world," but their Master did not withdraw from the world. He did not climb up a mountain and live in a cave as an ascetic, to be consulted as an oracle by men who made a pilgrimage to a lonely, withdrawn figure.

He climbed up the mountain for prayer—and I would not speak one word which would seem to disparage the value and necessity of set times of prayer. That's one way of developing that "spiritual perception" we spoke of before—but then He came down into the world and enjoyed himself so much that His happiness became a scandal. He was called "the friend of publicans and sinners." "This man receiveth sinners and eateth with them." "A gluttonous man and a winebibber," they said because, frankly, he loved to go to parties, and all the time he was living in God's world.

I expect He was the life and soul of the party. I should like a manuscript to be discovered which said that he told funnier stories than anybody and had the table in a room of happy mirth. Indeed, though all his parables the grace of a lovely humor lightens the lessons he tried to teach.

Jesus did not withdraw from the world, for there is nowhere else to go. It is all God's world. The saints who started the theatre—and you will remember that the first plays were in churches and only the ordained were allowed to play them—were far more in harmony with Christ's mind than the Victorians who thought it wicked to go to the theatre.

Jesus said that when the prodigal son came home there was a tremendous feast and plenty of dancing. Yet many of our young people have a suspicion that religion frowns upon them if they stay out late at a dance!

In both these crops the heaviest costs will be for irrigation and harvesting. And this applies to the irrigation of all crops.

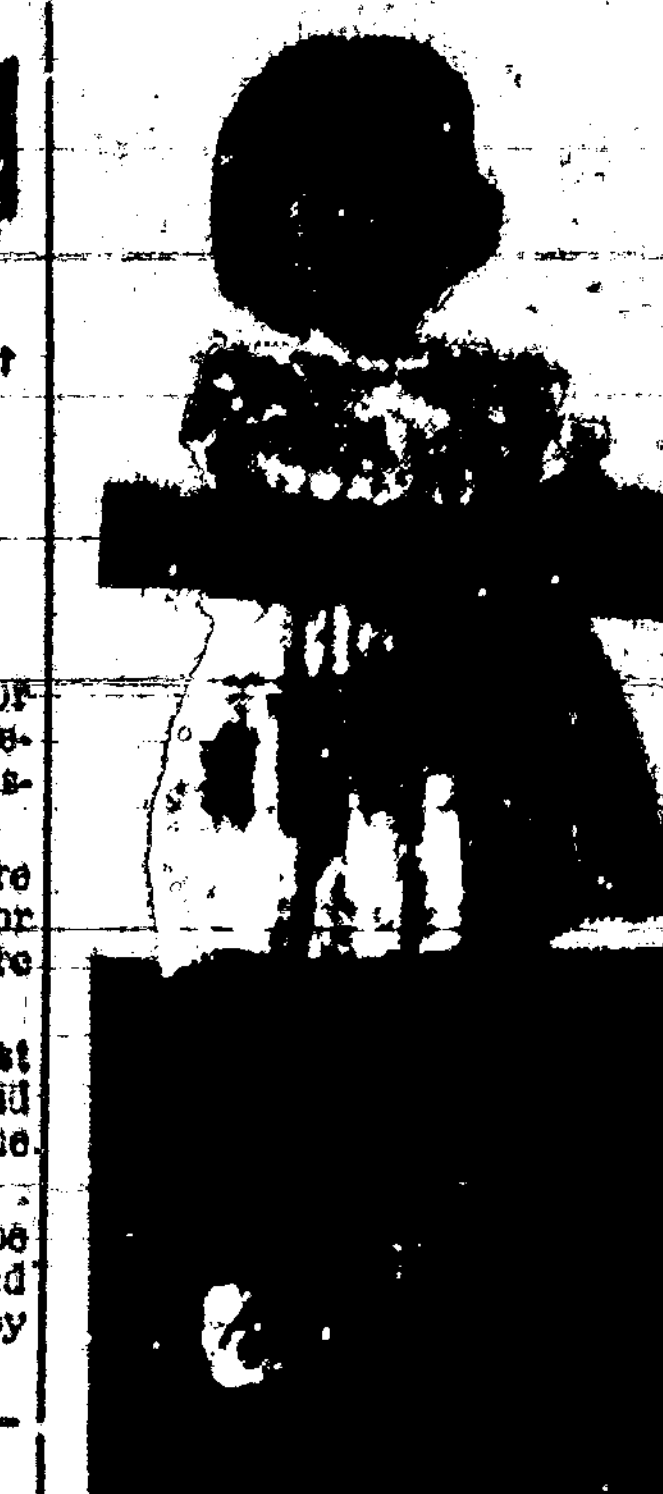
Irrigation labor costs can be reduced by using more lined ditches, by siphon tubes and by land leveling.

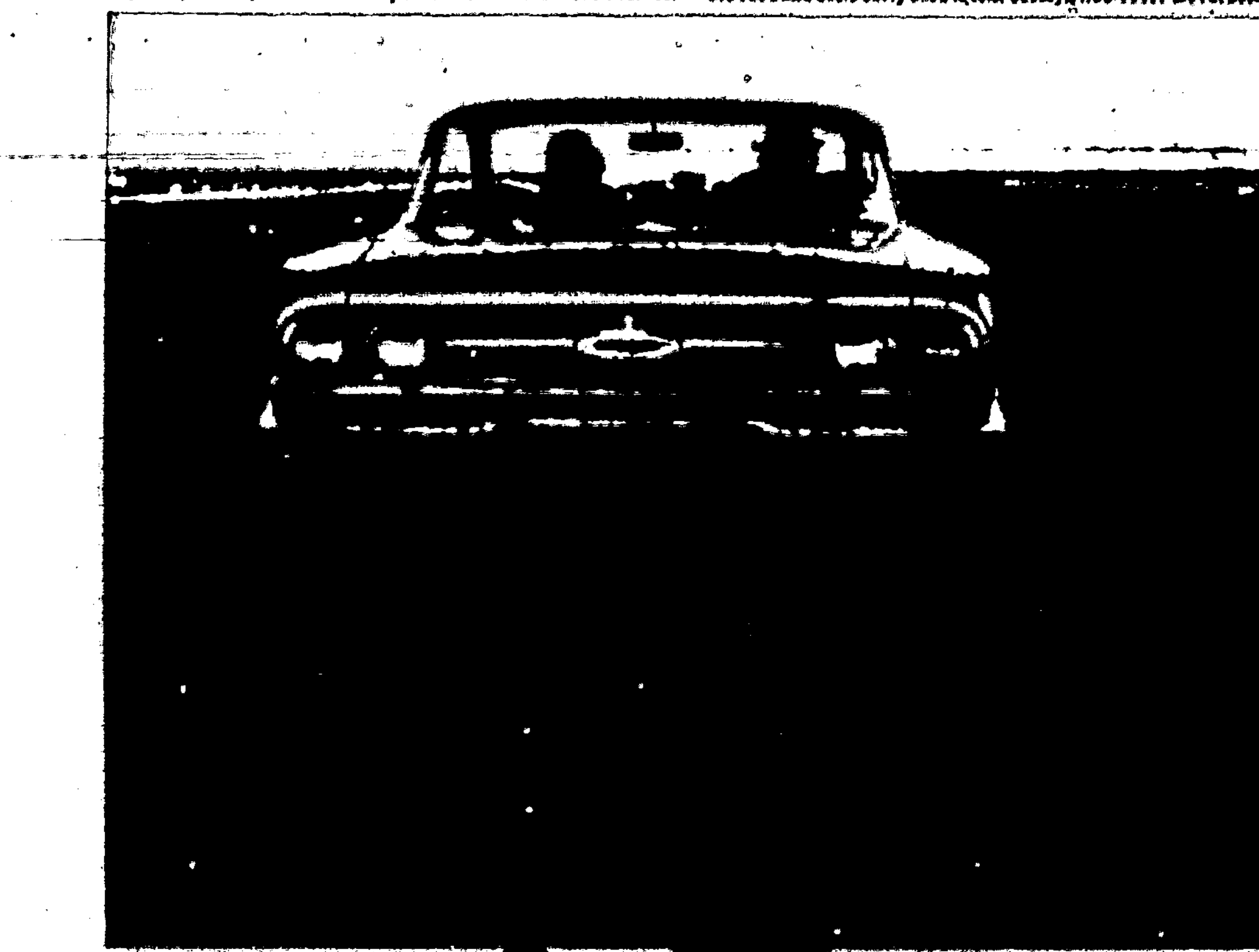
