

Final planning for Lincoln County Fair Friday and Saturday, Sept. 9 and 10

The Lincoln County Fair Association members met last Friday night and completed plans for the Lincoln County Fair, to be held at the Capitol fairgrounds September 9 and 10.

A greater number of entries are anticipated, along with a larger participation of the surrounding communities.

Ralph Dunlap, fair book chairman, announced two changes in the fair book, which are:

In the Lincoln County Fair Queen contest, the ages listed 16 through 19, should read 16 thru 21. The parade as scheduled in the fair book reads 10 a.m. Saturday, should read 1 p.m. Saturday afternoon.

Outstanding contests of the fair for the junior residents of Lincoln County will be the Fair Queen contest, Apple Pie contest and Junior Division in agriculture and home economics.

In the Fair Queen contest, the contestants will be judged on 50% housewifery and 50% on personality. The cowgirl must be between the ages of 16 and 21 years of age and be a resident of Lincoln County. She should be sponsored by some organization or group. The queen will be crowned Friday, Sept. 9, at 1:30 p.m., to ride over the fair and lead the parade Saturday afternoon at 1 o'clock, September 10. The queen will attend the New Mexico State Fair in Albuquerque, representing Lincoln County.

The Apple Pie contestants will be judged 50% on finished product, 25% on method of preparation and 25% on personal qualifications. Contestants' ages are from 14 (January 1, 1960) to 20 (January 1, 1961). Contestant will enter the Apple Pie contest at the New Mexico State Fair.

The Junior Division of agriculture and Home Economics is restricted to bona fide members of 4-H Clubs, FFA, Boy Scouts and Girl Scouts. Entries in the agricultural division are owned and managed at least five months prior to date of showing. Home Economics entries must be enrolled in projects which they are exhibiting.

TO AWARD SCHOLARSHIPS

The Lincoln County Farm and Livestock Bureau is sponsoring two scholarships of \$120 each (one boy and one girl) to New Mexico State University. These scholarships are to be used toward a degree in agriculture, home economics and education and will be awarded to any high school student who is a senior in the fall of 1960 who enters any exhibit in the Lincoln County Fair. The scholarship will be awarded on the following basis: Scholarship, 50% need, 25% attitude and outside interest toward agriculture and home economics, 25%.

Two non-commercial booths, added last year, will be in the exhibit building again this year. They are the Hobby and Fort Stanton booths. The Fort Stanton booth will show the skill of the patients at Fort Stanton VA Hospital in leather tooling, loom weaving, ceramics, embroidery and crocheting.

Last year a number of the patients received blue and red ribbons on their exhibits. The Fort Stanton school children will also have displays in the Ft. Stanton booth.

HOBBY BOOTH AGAIN

The Hobby booth was such a success last year that Mrs. John Lacy was again asked to take charge. Mrs. Lacy urges any resident of Lincoln County to enter their hobby in the Hobby booth—such as ceramics, oil painting, free hand sketching, leather tooling, rock collection, polished or native stones.

The roping and riding events (rodeo) are open to school children of Lincoln County and the adult events are open to residents of Lincoln County. The fair rodeo will take place the two days of the fair.

Fletcher Hall, arena director, with Ed Goodloe, completed arrangements for the stock to be used in the rodeo events.

A greater number of entries in the second annual Quarter Horse Show is also anticipated. The approved show is held under the registration requirements, show rules and point system of the American Quarter Horse Association. The judge will be Ray Lewis of Dell City, Texas, an approved judge of the AQHA.

The Lincoln County Fair Association members extend an invitation to all Lincoln County, surrounding counties, state and out-of-state, to visit Captain during the two-day fair and see what Lincoln County has to exhibit in the way of agriculture, flowers, grass, skill in home economics and quarter horse showing.

Members participating in the final meeting were from Ancho, ranchers north of Captain, Nogal, Timmie, Double Crossing area and Captain.

Grizzlies to tangle with Wildcats Friday evening

A large crowd is expected Friday night at the new Carrizozo athletic field for the opening of the football season for the Carrizozo Grizzlies and Tularosa Wildcats. Game time is 7:30.

Carrizozo, winner over Tularosa last year, 12 to 0, is given a fair chance to repeat the victory. The story will probably be in the line, and if the play is fairly evenly matched there, the Grizzlies should have the edge, with a heavier and more experienced backfield.

Coach Robert Herrera of Tularosa says his team is building, with a number of sophomores on the roster.

Coaches Donnie Lamb and Garrel Dode of the Grizzlies say the local team is getting a later start than last year and may not reach last year's performance until mid-season.

The Carrizozo new athletic field will be seen by many fans for the first time. Temporary portable bleachers will accommodate 250 fans and there is allocated parking facilities for cars around the playing field.

Home town fans are asked to again use the west side bleachers and parking facilities. The east side space is limited and would not accommodate local spectators.

Two auto gates will be open on the south side of the field. A pedestrian gate will be used on the northwest corner next to the tennis court.

The gate on the northeast end, next to the Junior High building, will not be open for admissions. At the end of the game, however, it will be opened for the exit of parked autos on the east side of the field.

Drivers of autos are asked to follow the directions of parking attendants, especially in the west parking area. Cooperation of the public will aid in getting the new season off to a good start.

Apple packing at Hondo nears peak

Apple packing at the shed of the White Mountain Fruit Growers' Association in Hondo, is soon to reach its peak, the News was informed this week.

Hail damage has been extensive and it is estimated that this year's crop of high grade apples is only about a third of normal. There is a market, however, for the hail-damaged apples and trucks are arriving at the shed to load these apples.

The market for choice Red Delicious apples is around \$5.50 per box this week and \$3 for a 40-lb. bulk box of Jonathans. They are also being bag-packed for school lunches.

The apples are coloring later this year than normal, due to hot weather and absence of rain.

Willard Moran and Richard Hooper are in charge of packing operations at the shed.

A group of growers around Hondo are said to have the best crop of first grade apples this year. Hail damage was quite extensive along the upper Ruidoso and Bonito valleys.

Mrs. Dunn told the meeting about plans made to date. They include bull dozing a parking area for cars and arrangements for attendants to give parking checks to motorists so that cars can be taken care of in an orderly manner.

Mrs. Dunn extended an invitation to all Democrats everywhere to attend the barbecue, as well as any outside of the party who may be interested in coming.

The meeting was presided over by Hollis Cummins, chairman of the Democratic county central committee. Mrs. Barbara Pearson, county chair-woman, was also at the speakers' table.

Cummins introduced the county candidates for office.

The group voted to take part in the Lincoln County Farm & Livestock Bureau's "Meet Your Candidate" forum, to be held in the five school districts in the county.

The Republicans had previously voted approval of the plan.

Speaking about the forum, Chas. A. Jones said the Farm Bureau had tried it on a state level and it proved very successful. Rules and regulations for the forum would be worked out, he said, and the moderator of each forum would be from out of the county.

NEED OF CONGRESS ACTED FOR LOAN

Santa Fe — New Mexico's \$16 million mortgage on a boat needs an act of Congress to make it absolutely secure and a hurry up demand has been placed on Our Clint the senator to get the law through in the closing days of the current session.

Meanwhile it was learned that the state lost \$2,000 a day interest during the several days of the first foul-up of the huge mortgage and the makeshift deal of shifting it from the state to the individual Joe Callaway, state treasurer.

Gov. John Burroughs assured Land Commissioner Murray Morgan that he would investigate the careless handling of the \$16 million. A week later there had been no indication of such a probe.

MADE TWO TRIES
AND NOW A THIRD
First, the state investment council bought the 5% mortgage on the tanker SS Defender from the Bank for Savings of New York. After the money was gone it was learned that the state was not eligible for federal guarantee of the mortgage.

Second guarantee is available only to a citizen of the United States and a state is not a citizen.

Asst. Atty. Gen. Boston Witt was flown to Washington and New York where he worked out a deal to shift the mortgage from the state to citizen Callaway as trustee officer.

Then trouble developed proving that Callaway was a citizen. He couldn't produce a birth certificate or any of the usual records accepted for proof and finally signed an affidavit that he is a citizen.

At this point lawyers from all around started questioning the legality of transferring the \$16 million state mortgage to Callaway or any other individual, citizen or not.


That was when it was decided an act of Congress was needed to secure the mortgage, one that would make states eligible for the federal guarantee of payment.

Miss Ula Edmonson, assistant cashier of the First National Bank in Carrizozo, was to attend the State Bankers convention in Santa Fe.

Callie White, in from Rudoso, said that three days had been the longest time between rains since July 3.

Carrizozo recruit in Navy's Waves finds first weeks in the Service pass quickly

Miss Jean Gott reports that life in Carrizozo is like heaven after following a rigid eight weeks' schedule as a seaman recruit in the WAVES.

Your life would be arranged thus, were you to become a part

of the U. S. Navy:

The first three weeks you would spend "processing," which includes receiving all issued clothing, getting clothes in order, learning to march, receiving "shots," learning general rules and regulations, and getting acquainted with Uncle Sam's Navy in general. If you cannot swim, you are given six weeks to learn.

Classes begin early in the fourth week and a daily routine is established. Now your time is no longer your own and the days go by very quickly.

The day starts at 5:20 a.m. You have 20 minutes to dress and make your bunk before breakfast. Breakfast lasts 20 minutes; then you return to the barracks and spend 15 minutes cleaning.

Three days a week you attend morning quarters, which is the daily announcements. Then you march to one of the six classes you are required to take.

The classes consist of Navy history, jobs and training, orientation, ships and air, first aid, and citizenship. Each class lasts 40 minutes.

Now it's time for lunch. After lunch, it's back to class until 4:10 p.m., then you can have a whole 40 minutes to yourself before supper. This 40 minutes is usually taken up by washing or ironing clothes for a clean uniform every day is a must.

Supper time at last! Supper is customarily 20 minutes and then it's back to the barracks to continue putting your personal belongings in order.

At 8 p.m. the barracks must be cleaned and half an hour is usually spent on this task. Comes 8:30 and you can start getting ready for bed. By the time taps comes, at 9:30 p.m., you are ready for a good night's rest.

The last two weeks are spent taking tests, among which is the swimming test. If you still cannot pass this test, you are set back two weeks and cannot graduate with the rest of the company. You also have to learn to make a float out of your dunnage.

The rest of the tests are on the material covered in the classes and in the lectures.

The last few days on your first station are spent preparing for that leave home. You get your uniform for your next post, make reservations for the trip home, say goodbye to your newly made friends and depart — no longer supporting Seaman Recruit stripes, but wearing the insignia of a Seaman Apprentice!

Jean says it feels mighty nice just to walk leisurely, after having to march everywhere she went in the past eight weeks.





outlaw, hiding out in the hills. He sold his share for forty dollars, a bottle of whiskey, and a pair of boots.

Subsequently, countless millions of dollars in ore were mined and, around 1900, the town boasted four weekly newspapers, churches, hotels and the usual complement of saloons and gambling casinos.

When the railroad bypassed the town, it began to die, and today most of the buildings are in ruins, although a few families still live there.

Some of the popular ghost towns around the state include Elizabethtown, five miles north of Eagle Nest; Hillsboro, on State Road 160 in Sierra County; Kelly, two miles southeast of Magdalena; Kington, nine miles west of Hillsboro; Lake Valley, 17 miles south of Hillsboro; and Mogollon, eight miles east of Alma in Catron County.
