Winter has arrived here

Billy the Kid back in the news, court hearing set for Nov. 16

Billy is back in the news! The case to determine the final resting place of the oft-misunderstood young gunman will be heard in Ft. Sumner November 16. The court action was started some months ago to change the burial place of Billy the Kid from Ft. Sumner to Lincoln County, on the charge that his grave was being exploited as a tourist curiosity. Filing the action was Miss Lois Teller of New York City, who is Billy's nearest living kin. Representing her is C. C. Chase, Alamogordo attorney. The hearing before District Judge E. T. Hensley will be held in a motion filed by the De Baca county commissioners and Mrs. J. W. Allen, defendants in a civil suit seeking removal of the Kid's body to Lincoln County. The motion seeks to throw out the original suit, filed by Lincoln County commissioners and Miss Teller.

Use stored feed for livestock after nuclear attack

In the event of nuclear attack, fallout particles will probably contaminate green or growing forage. That's why it would be wise to store feed before fallout occurs and not allow them access to fresh forage until authorities advise. Stored feed, which has not been contaminated by fallout, should be used after a nuclear incident. If fallout particles settle on feed, only the water portions will be contaminated. However, do not handle contaminated feed until authorities advise that this can be safely done. Because of radioactive decay, contaminated feed may become safe to use after a storage period as specified by those who will be in charge after an attack.

KENNEDY SLOW WITH JOBS HERE

More about public land mess

The existing policy and practice of the Commissioner of Public Lands is apparently calculated to appeal to our countrymen, and additional half a million persons and others without regard to the future of our school situation or the existence or destruction of the livestock industry dependent upon grazing use of the public lands with the early settlement of the New Mexico Territory and now 50 years of statehood. Under the guise of the desperate need for our schools, the Commissioner indulges in a practice of destruction of a back log of security for our schools, and the heart of the state's oldest and most enduring source of revenue and security against a future need when all else may have failed. Slight familiarity with Federal land departments in Washington, both Agriculture and Interior, now indicate that an all-out policy of multiple use of all public lands must be accurately interpreted as a project of all-out exploitation of the public lands, and indirectly if not directly, of lands of every status as well, threatening to involve the security and morals of all our people. Confusion has become so great within the state that confidence and sound thinking are annihilated. Public impression on the one hand is that inflation and speculation in the State lands is a panacea to be used without thought of depletion, or consideration, of the economy of the State as a whole and the many and varied interests to be affected. Another segment of our people, full well realize that the Enabling Act with our States Constitution, calculated to safe guard the value of our State lands with assurance of a source of revenue for support of the schools, may now be playing into the hands of irresponsible persons without thought of the future

discussion, and to be enshrouded in secrecy and dread of impending calamity of retaliation for any sort of effort to arrive at any sort of understanding of the actual status quo of the state lands. On October 12th, a meeting extraordinary of the South Eastern New Mexico Grazing Association was held in Roswell to discuss the situation and to be informed as to what remedial action could be taken to check the stampede in sales of state land held in lease contracts by legal permittees and ranch operators; the cloud of dust stirred up by a herd of Texas wild horns, of years ago, on a wild rampage, was small and only of local notice, by comparison to the fall out from the commissioners action with utter disregard of welfare or economy in a single instance of unnumbered interests adversely affected. To repeat the old adage "Fodds may enter where angels fear to tread"; we would say "That some fods may enter where others fear to tread." This we already understand, and that the matter of sale or lease of state land, is admitted to be entirely in the matter of discretion of the Commissioner, and with out thought or consideration of consequences following his action. Now please follow these points closely: Is the highest bidder, necessarily the best bidder? Is uncontrolled inflation and speculation the answer to our schools immediate needs? To whom do the state lands belong after being ceded to the State of New Mexico? Do original state lands remain under federal control after being sold under the conditions of compliance with the constitution? Do state lands under grazing lease by the commissioner in compliance with the constitution and the commissioner's set grazing fee, yet remain under federal control? Where does federal control lie? To a highest bidder, or awarded under lease contract under any sort of condition. From an alleged authoritative source from as yet undisclosed correspondence, quote "to wit": "Under the Enabling Act, our constitution and the statutes based thereon, the Commissioner of Public Lands has complete dominion, which is to say, complete control over state lands. "Section I, Chapter 7, N.M.S.A. 1933 compilation, creates the State Land Office, Adding detail to the provisions of the Enabling Act, it reads in part as follows: A State Land Office is hereby created, the executive officer of which shall be the Commissioner of Public Lands, hereinafter called the "Commissioner" who shall have jurisdiction over all lands owned in this chapter by the state, except as may be otherwise specifically provided by law, and shall have the management, care, custody and control and disposition thereof." This we already understand, and that the matter of sale or lease of state land, is admitted to be entirely in the matter of discretion of the Commissioner, and with out thought or consideration of consequences following his action. Now please follow these points closely: Is the highest bidder, necessarily the best bidder? Is uncontrolled inflation and speculation the answer to our schools immediate needs? To whom do the state lands belong after being ceded to the State of New Mexico? Do original state lands remain under federal control after being sold under the conditions of compliance with the constitution?
