

N. M. trout farm doing a splashing business

Bert Pfingsten and C. R. McConnell, partners in the Spring Ranch Trout Farm at Hondo, are old hands at the business of taking care of fish and game. A dream of theirs for many years has been the establishment of a private trout farm and within the past year they have seen this dream come true.

Spring Ranch is true to its name. One of the best springs in Lincoln County sends out a steady stream of fresh water which is piped through a chain of ponds inhabited by rainbow trout in all stages of growth.

Trout eggs are shipped in by air express from Soap Lake, Washington. These are carefully incubated and as the fish grow they are shifted from one pond to another until they reach a growth of 12 to 14 inches, when they are ready for catching in the big pond. The eggs cost \$3.50 per 1,000.

The annual production of trout is around 40,000. The feed is not cheap, and is one of the major costs in producing trout.

The Lincoln County News editor and Ellsworth (Kansas) Messenger editor and his two

boys tried this fishing spot last week — it was a real thrill for the boys and the dads had fun too. A person can catch fish in Lincoln County's two lakes by hitting a hot-biting period or staying a full day. If a person likes to eat trout and likes the fun of catching them, you can't beat Spring Ranch.

You can go to this fishing place and catch your limit, for a small fee, using any kind of bait you choose, spinners, fly fishing, or just plain cast. It doesn't take long either because the McConnell-Pfingsten fish

are a wee bit on the hungry side — they bite right now.

We had a red Daredevil out in the water, got a strike, missed it, and before the lure was pulled in another trout was on the hook.

Trout put on about an inch a month, according to McConnell who spends his full time in management of the operation. They get feed several times a day, instead of one big feeding.

McConnell is a former information and education officer of the N. M. Game and Fish Department, and has done con-

siderable work in the fish hatchery field. Pfingsten is in the orchard and livestock business up and down the Hondo Valley, in addition to being a partner in the trout farm.

Business has been good so far and the trout farm is just getting started. As the word gets around about the fun of catching a good mess of trout, Spring Ranch Trout Farm will do even better. It's a new industry for Lincoln County, one that fits right in with the natural beauty and enchantment of the country.

Working agreement signed to use Ft. Stanton land for ag research

Dr. Phillip J. Lyendecker, dean and director of NMSU at Las Cruces, notified Rep. W. G. Shreengost Wednesday morning that he had just signed a working agreement with the Bureau of Land Management which permits NMSU to conduct livestock and range management research on 27,700 acres, just over 43 sections, of the Ft. Stanton range, effective April 1963.

About this, Dr. Lyendecker stated that at present we are unable to take possession or to initiate research programs

until funds are available. We are hopeful, however, the state legislature will provide funds for the initiation of our research plan by July 1, 1964.

In the meantime we, as well as the state department of game and fish, will conduct surveys and become familiar with the range in order that no time will be lost when funds do become available for our proposed research project.

This particular project has been brought along so far with push from the Lincoln County Rural Area Development Com-

mittee, and good cooperation from County Agent Ralph Dunlap and the State University.

Rep. Shreengost said he was very enthusiastic about this research project, that it is something needed by agricultural people of New Mexico. The land around Ft. Stanton is ideal and typical of range land in the state. Rep. Shreengost said he felt certain that people of Lincoln County would support and encourage Sen. Joe Skeen and himself in seeking funds for the Ft. Stanton research project during the coming of special legislature.

Committee will select Valley of Fire park site

Floyd Cross, superintendent of the state park and recreation commission, with Jim Dillard from the commission, were present at the meeting of Lincoln County commissioners Monday in Carrizozo to discuss future development of the Valley of Fire State Park.

Representing several organizations in Carrizozo at the meeting were: Peggy French, Clara Snow, Cleo Dugger, Johnson Stearns, Fred English, Herman McKibben, Ralph Dunlap and Rep. W. G. Shreengost from Lincoln.

The bill introduced by Rep. Shreengost and passed in the last legislative session provided \$1600 to purchase land. The next step is selection of the site and purchase of land.

In discussion Dillard brought out that establishment of a botanical garden had created much interest in other similar state parks. Clara Snow said that several varieties of foliage grew in the Mal Pais that were not found anywhere else in the world.

Of the several likely sites discussed at least three will be investigated by a committee representing the Womens Club, Chamber of Commerce and Town of Carrizozo this week. This committee will meet with park commission architect in the next 30 days.

A first possibility is across the Mal Pais, 10 miles from Carrizozo, and up the west side of the black rock a distance approximately 4 miles. Second good possibility is a turnout from U. S. 54 on the old Corona road and a park location on the east side of the Mal Pais some 4-5 miles north of Highway 380. Another possibility is the old sheep camp, a short distance north of Highway 380 in the center of the Mal Pais.

There are numerous Indian ruins and relics in the Mal Pais pits, but these are not considered as interesting as the rock formation, particularly to tourists, because other historic points have such artifacts of much greater interest.

Cost of operating the park will run a minimum of \$15,000 a year which will include salary for caretaker. It will take at least \$15,000 as a minimum figure to start development of the park.

Charles A. Jones, chairman of Lincoln County Commissioners, said that they would help in every way possible with road construction to the park location. Bryce Dugger drilled a

well near the Mal Pais north of Highway 380, the log of this well will be made available to the park commission to use in locating water. Plenty of water is available in this area.

Carrizozo Women's Club is given credit for originating the first park of any club in the state and has been very instrumental in the establishment of the Valley of Fire State Park. Mrs. Dugger told the park commission representatives that the club appreciated their help in this project.

Clara Snow said that biology classes from Highlands University at Las Vegas regularly visit the Mal Pais on exploration trips and had issued a bulletin about plants in this area.



Proposed Lincoln County Court House



Lincoln County Commissioners Charles A. Jones, Ramon Nunez, and Kenneth Nosker received the preliminary drawing of the proposed Lincoln County courthouse Monday at their regular meeting.

The drawing and plans were presented by Jim Voll, representing Voll and Buffington, architects, of Roswell. Mr. Voll submitted a cost and sq. ft. breakdown as follows:



Courthouse, 13,725 s.f. at 15.00 per s.f., cost \$205,500, includes refrigerated air conditioning. Jail with washed air cooling, 7,155 s.f. at 10.50 per s.f., cost \$75,200. Remodel courthouse annex, 1st and 2nd floors, 7,440 s.f. at 2.10 per s.f., cost \$15,600. Paint basement of annex \$500. Add 6400 s.f. of screen wall to annex at 3.50 per s.f., cost \$22,400. Total \$398,680.

Mr. Voll stated that office furnishings, landscaping and architect fees would bring the total cost to around \$500,000.

A revised drawing will be made immediately which will move the clerk, commissioner and records area across the hall. The courtroom will be cut down in size to seat 150 people, at a saving of some \$7,500.

Construction material and appearance of outside is not definite, several materials are being considered. An outstanding feature is a covered walk around the outside and around the courtyard on the inside.

A colored drawing will be made in the near future, then the commissioners expect to call meetings in every section of the county to acquaint people with the project. The old courthouse will remain in use during the construction period. There is ample offstreet parking on the NW side.

A Right For A Wrong

Thank the Lord for the coalition of Southern Democrats and Republicans. If any grouping of different political labels can save this country from further socialism and expanded federal power... this coalition should do most to stop the trend.

It is to be regretted that the racial crisis has clouded this fight between the Kennedy Administration and the coalition of Southern Democrats and Republicans. The end aim of the Administration will be to provide more jobs, more housing, more schools for both white and Negro races. The means will be an expansion of federal power. We frankly doubt that the means justifies the end.

Walter Lippman, writing in a national magazine, favors the expansion of federal power. If we read him correctly, here is Lippman's closing paragraph, "It will prove to be impossible to approach the equality of opportunity for the Negroes without reviving and renewing the progressive movement in American politics, which has been quiescent for some ten years". We read this to mean that Lippman favors the use of Federal power to expand the American economy and to develop the public facilities of the nation.

How much public opinion such writers as Lippman might sway is a question we can't answer. We do feel that the Southern Democrats and Republicans, who are holding the reins on the progressive movement in American politics, understand that after Federal power has been expanded in an attempt to justify one wrong there will still exist a wrong thrust on American people of all races... which is far greater — that of a government taking away rights under the guise of helping people.

As Far From Us

The News editor's favorite cartoon characters were up to their usual tricks this week... which means their kind of humor stabs you with no pain whatsoever. One can forget about worries of all kinds while reading "Pogo".

This week Pogo and Howlin' Owl were out in the S. S. MacDougall. Owl fishing, Pogo just sitting. Pogo says to Owl, "Did I ever look around and notice how far we is away from ever-thing?" Next panel, Owl says, "Works out even... ever-thing is just as far from us, too."

Somewhat that "us" as far from us" message brought to mind the Valley of Fire park which will be a reality in a short year or so. This new park is far away from people who want to see it (local citizens have little spectator interest in local scenery), and the tourists are equally far from the park.

Got to make a connection there, between those far-off people, and the far-off park. The reason is — one thing is

not so far off, and that is Carrizozo, the county seat of Lincoln County... which just happens to be situated real close to one of the most interesting geologic formations in the country.

Synonym For Dictatorship

The late Samuel Gompers, referred to as the father of organized labor, had opinions about the welfare state. "Doing for people what they can and ought to do for themselves is a dangerous experiment. In the last analysis, the welfare of the workers depends upon their own initiative. Whatever is done under the guise of philanthropy or social morality which in any way lessens initiative is the greatest crime that can be committed against the toilers." Early Lincoln Co. banks listed

New Mexico Business, a publication of the University of New Mexico, June 1963 issue catalogues banks and bankers in New Mexico through 1912. The earliest known was the Banking House of Santa Fe, David Hood banker, the outcome of this bank started in 1850 is unknown. A. N. M. banking was done in Santa Fe, or out of territory during the decade 1860-70. Cimarron had a bank started in 1872, Mesilla in 1875, Las Vegas in 1870, Silver City in 1877, Albuquerque in 1878.

The first Lincoln Co. Bank was started in 1890 at White Oaks. Little is known about the outcome of this bank except that it may have been succeeded by the Exchange Bank in 1892.


Mr. R. E. Lemon of Carrizozo fills in the N. M. Business Bank report on the Exchange Bank started at White Oaks May 31, 1892. Jefferson Reynolds and George L. Ulrich were owners, Frank J. Sager was the first cashier.

The Exchange Bank was moved to Carrizozo in 1905 with a new building now the Masonic Hall. It failed 10-6-23.

J. J. Jaffa had a bank in Lincoln, last listed in 1906. The Stockmen's State Bank was organized in 1908 at Corona, moved and became First State Bank of Estancia between 1920-24, later moved to Mountair in 1923.

SANTA FE — Land Commissioner Johnny Walker is talking to most everyone he meets for Guyton "Sheepherder" Hays for Demo nomination for land commissioner next year, and giving his own run for Congress second place billing.

Hays is chief man in the land office and Walker's buddy thru high school and UNM. Walker has been telling that his first interest is getting Sheep into the land office even if it costs him the nomination for Congress.

Liberto Ortiz family receives first checks

EDITOR'S NOTE — In order to better inform the people of Lincoln County and the surrounding area of the benefits payable under the disability provisions of the Social Security program, Mr. and Mrs. Liberto Ortiz have given written permission to publish the facts regarding payments they are receiving under this program.

Recently the Liberto Ortiz family received their first Social Security benefit checks under the disability provisions of the Social Security Act. The family includes Mr. Ortiz, his wife Pina, and three children, ages 4, 3, and 1. Mr. Ortiz is hospitalized at Ft. Stanton. Mrs. Ortiz and the children live near by in Captain. Last fall Mr. Ortiz had to stop working because of illness. He was employed at Sandia Base in Albuquerque, where he had worked about nine years.

He entered the hospital in Ft. Stanton in September, 1962. There he contacted a social security representative and inquired about Social Security payments. As Mr. Ortiz learned, in order to receive Social Security disability payments a person must have an illness or injury which makes him unable to do any work and the condition must be expected to continue indefinitely. Also, a person must have worked and paid Social Security taxes 5 out of the last 10 years.

It was found that Mr. Ortiz met all the requirements, and was entitled to disability payments beginning with March, 1963, six months after he became disabled. The law requires this six month "waiting period" before payments can begin. The law also provides for payments to certain dependents, as Mrs. Ortiz and the children became entitled to benefits in March.

OFFERED TRADES FOR CONGRESS

That sounds like loose talk but most observers think he is entirely sincere.

Some backers of Highway Commission Chairman John Sudderth for land commissioner have tried to entice Walker off Hays in return for support for Congress, but with no luck so far.

MURRAY MORGAN ALSO FOR HAYS..

Hays has another important sponsor in former Land Commissioner Murray Morgan who is secure in a corporation commission term with five and a half years to run and with no other demanding political chores outside helping Hays for the land job.

Walker's land office crew of a hundred and the eighty payroll-ers of the corporation commission continue a powerful political force in the Demo primary.

TWO IN CONTROL FOR SIX TERMS

In 1956 as Walker was completing his first two terms as land commissioner he picked Morgan, a GI buddy, to succeed him and got him in over such formidable opposition as John E. Miles, the former governor, land commissioner, congressman, and Demo state chairman.

Morgan responded with the same kind of help for Walker when he returned to the land office in the election of 1960, and now they're shooting at another four years domination of the big agency with Sheep Hays.

THREE BUDDIES COULD TAKE OVER

Morgan and Walker cooperate with the Demo administration of Gov. Jack Campbell but are politically independent with a compact political force of their own which isn't as big as the governor's but better organized and more efficient, and with its own money.

If Walker makes it to Congress, and it looks like he will, and Sheep Hays gets in as land commissioner the three buddies will be in a fair way to take over the Democratic party in the state from the aging and quarreling group now in control.

MACK EASLEY FACES FATEFUL DECISION

Lt. Gov. Mack Easley of Hobbs who would probably be governor had he not lost his run for speaker of the house to Jack Campbell by one vote in 1961 is at a crossroads in his political career.

He has been feeling out his prospects for the anticipated vacancy in the U. S. House that Walker is seeking.

And he's been weighing the advisability of staying on as lieutenant governor for another term with the remote possibility of succeeding to the governor's chair.

CLINT MIGHT WANT A REST

There has been so much in the press and in capitol conversations about Sen. Clint Anderson's several health problems that most everybody in politics thinks there is some chance that he will retire before his term is up at the end of 1966 if there is a Demo governor to appoint his successor.

Such a governor could appoint himself with the lieutenant governor moving up. Our Clint works like a draft horse and if he got to the place he couldn't continue the pace would probably prefer retirement to lying around Washington as an inactive senator.

NOT MUCH FUTURE FOR SECOND MAN

If Easley got a second term as lieutenant governor and by some development succeeded to the governor's chair he would not be eligible to run for governor in the 1968 election or for any other state office.

Hampering Walker and Easley and all the others coveting Joe Montoya's place in the House is the detail that Joe hasn't relinquished the job. Most all think he will pull out to challenge Republican Ed Mechem for the Senate, but he doesn't have to make that fateful crossing until the Demo convention in February, eight months away. Meanwhile his would-be successors will have to run on assumptions.

MACK OR JACK ON TIE VOTE

Speaking of fate, the caucus of state house Democrats that elected Jack Campbell speaker also elected him governor like giving him a certificate of election.

Campbell ran against Speaker Easley who had been chosen by John Burroughs Democrats for the 1962 nomination for governor. The vote was a tie with a ballot in dispute on whether it said "Mack" or "Jack." A committee appointed to decipher the writing ruled it "Jack" and Campbell won the springboard that flipped him into the governor's office. He wouldn't have had a chance without it.



Bids for the building improvement projects at the Hondo Valley Public Schools were opened on the night of July 11. Side-walks to connect the buildings, an overhanging shade porch for classrooms and a storage room for the cafeteria were among the items listed in the bids. Painting of the exterior of the high school is scheduled to begin Monday. Already completed is a walk connecting the elementary and high school entrances. Later in the summer, black-topping will be applied in the parking area.

Also on the meeting agenda was the hiring of new teachers for the high school science and industrial arts classes, an elementary teacher and a driver for the school's own bus in the San Patricio area. Applications are still being accepted at the office of the superintendent for the teaching positions.

Pedro Salcido, bus driver from Alamo Canyon for 22 years, requested that the board consider his voluntary retirement. Also discussed were routing changes for the Pechocho bus, driven by Albert Kimbrell.

An inventory of all school equipment has shown that there are many items no longer useful to the educational program. Supt. Montes recommended that certain of the items be sold by bid to members of the community, including among these some used typewriters, a treadle sewing machine, used refrigerators, teacher and student desks. Band instruments have been in storage for several years and it appears unlikely that the band program can be re-installed. Before the instruments deteriorate further Supt. Montes asked the board to consider offering them for sale also. Several schools have already indicated they would be interested in purchasing them. It is hoped that by disposing of these items new and more modern equipment will be utilized in all the school's departments.

Job descriptions for the system's non-certified personnel, secretaries, janitors, and cooks were presented to the board members so that they might be

better informed of the duties of the staff and the time required to perform their work. These descriptions were prepared by Supt. Montes and Principals Booky and McPeigue.

A report was given of the progress of the evening home economics classes, taught by Mrs. Lucio Zamora, and being offered in cooperation with the vocational home economics department of the NMSU at Las Cruces. Some 25 women of the district have enrolled and meet each Tuesday and Wednesday night at 7:00 p.m. in the high school home economics lab. Other ladies interested should contact Mrs. Zamora or Supt. Montes for information.

Board members at Hondo are Mrs. Rosemary Simerco, John Cooper, Mrs. Martha Fresquez, Frank Titworth and Robert Gutierrez.

Let's keep the record straight

Re: Location of U.S. 70 from Biscuit Hill east to Hondo, a distance of some 17 miles.

In your edition of July 4 you had an article on U.S. 70. Please print the following remarks in relation to the statements therein:

Everyone knows this particular stretch of Highway 70 is in need of rebuilding. As far back as 1943 the Bureau of Public Roads sent a location crew into this area and located all but approximately 4 1/2 miles of this highway. The State Highway Department has completed some 5.2 miles of this road as far as location work is concerned and it is ready to let. Most of the alignment is on the side of the hill, a stone's throw above the old road now in use. Most, if not all, of present U.S. 70 is being left intact for use of the local people. This project ends at Ranger Hill near Glencoe.

The N. M. Highway Department has two alignments marked on the ground from Ranger Hill east to a point 4 1/2 miles west of Hondo. One constitutes a widening program, and the other follows the alignment with few exceptions set by the Bureau of Public Roads in 1943. This alignment, like the one west from Range Hill to Biscuit Hill, lies a stone's throw up the side of the hill above the present road, and like the one above has excellent alignments and-grade and is exposed to the sunlight throughout.

After the New Mexico Highway Engineers had reached a point some 4 1/2 miles west of Hondo with their location work which followed that of the Bureau of Public Roads they suddenly abandoned that alignment, moved back to the beginning of the project, and began an alignment that constitutes a widening program, crowding and entering the fields and orchards, and residential buildings throughout.

The Hondo Valley Committee for Traffic Safety was organized for the sole purpose of encouraging the New Mexico State Highway Location Engineers to go back on the side of the hill from whence they came and follow through with this alignment to Hondo. They also proposed that present US Highway 70 be left intact for use as a Service Road for the local people for School Buses, Mail Cars, Farm Equipment and local commuters otherwise. This thinking is in line with AM aspects of Safety and efficient use in the construction of AM Highways throughout the continental United States. All charges locally to the contrary have the earmarks of selfish motives and originate from individuals who have something they hope to sell for some ridiculous price to the Right of Way Department. No more, no less. Thank you, Jim Tully

The two men were friends and had been seen together since Saturday morning. Able stated that he and Holloway had been swimming, when Holloway drowned.

Holloway's clothes, billfold, identification, a 22 rifle and a 1960 Rambler were in Able's possession when he was arrested and when asked what he was doing with the dead man's belongings replied, that his friend didn't need them any more.

Sheriff Smith of Roswell transferred Able to the Chaves county jail Thursday. Identification was made by the Department of Public Safety in Austin, Texas.


