State's growth mainly in **Bernalillo Co.**

Over four-fifths of New Mexico's growth during the 1960's took place in the State's single Standard Metropolitan Statistical Area (SMSA), Albuquerque, which includes all of Bernalillo County, according to a report issued by the Bureau of the Census, U.S. Department of Commerce,

The report, based on the 1970 census, shows a State population of 1,016,000, 2 gain of 64,977 (6.8 percent) over 1960. The SMSA population totaled 315,774, an increase of 53,575 (20.4 percent) over 1960. By contrast, the population living outside the SMSA increased 1.7 percent, from 688,824 to 700,226.

New Mexico's white population grew by 5 percent from 876,000 to 916,000, the report says, and the American Indian population, which constitutes about three-fourths of the popu---lation of races other than white. grew by 29 percent from 56,000 to 73,000. Between 1960 and 1970, there was a net out-migration of 129,691 persons, the equivalent of 14 percent of the 1960 population. The entire net out-migration occurred in non-metropolitan areas. The fact that New Mexico did not lose population was due to its high natural increase (births minus deaths) of 194,668,

But in spite of his increasing importance to a growing. population---and in spite of his constantly rising efficiency and performance---the economic abollongo facing today's farmer

and rancher, becomes more formidable each year. More and more farmers and ranchers are being forced off the farms and ranches because of an inadequate income.

The price and income problems of farmers and ranchers have stimulated and unending stream of proposals to cure the situation--all to no avail.

These proposals have been mainly some type of government program.

An antiquated and inefficient marketing system is the major cause of agriculture price and income disparities. If the agriculture industry is to prosper and receive its fair share of the national income, it is time that farmers and ranchers turn their attention to the solid task of developing a greater bargaining power so that they can get the full market price and have an opportunity to improve it.

Forest Reopened

at noon, June 21

The Lincoln National Forest closed since last week due to the extreme fire danger, has been re-opened as of noon, June 21, 1971. For est Supervisor Robert A. Cook, announcing the re-opening, said "The rains of the past several days, while sporadic, have reduced the fire danger on the forest to the point. where we can again allow public! use." Cook said that rainfall' varied from nothing on some areas to nearly two inches at Cloudcroft and emphasized that the fire danger is still very high throughout much of the forest.

are often immediate and obvious. However, the major aim of retail advertising should be to increase overall store traffic.


Usually when a customer enters a store to look at an advertised product, he will buy ther things before he leaves. More important, when adver-

a. In this connection, the sales manager of a department store chain tells how his stores evaluate advertising:

"Day to day returns on individual ads mean little to us. We have learned that our total sales show a decline when we cut advertising, and that the sales curve rises when advertising is increased,"

If you're a home sewer, then you've been faced with the tecision of which thread to use for your outfit. A general rule of thumb is to select a thread comnatible with the fiber content of our fabric. For an animal fiber such as wool or silk, select a silk thread. On rayon, acetate, cotton and cotton blends a 100 per cent mercerized cotton thread is the best choice. Mer-



cerized cotton thread is less susceptible to shrinkage, is. stronger, and smoother. The polyester-core cotton wrap and 100 percent polyester threads are best for knits. This thread helps provide the necessary stretch in the seam that gives knits their comfort and allows freedom of movement. If you're looking for a thread especially for decorative stitching, top stitching or working hand buttonholes, then select silk buttonhole twist. ****

Some Important Pointers on . . .

**Proper Tire Care** 

Proper tire inflation is essential. Underinflation causes extreme sidewall flexing, builds up excessive heat, and causes rapid wear on the tire tread's outer edges.

Overinflation causes tires to run hard, subjects them to damage and weakening of the carcass, and causes excessive wear in the middle of the tread.

Check your owner's manual for recommended tire pressure

• •

Inspect tire exterior regularly for excessive or abnormal wear, fabric breaks, and cuts Remove imbedded foreign matter.

> TUNE-UP for Safety

Add an extra three or four pounds of pressure to cold tires prior to long trips where you anticipate driving at sustained high speeds.

• •

Replace tires when tread is thinner than 2 32 of an inch, or the "wear indicator" on the tire appears.

Use the "air loss" method of spotting a potential tire failure. A tire that loses three or more pounds of pressure in a week or less, when the others remain the same, should be removed and inspected.

Carry a spare tire that is properly inflated and in good condition.



# Increased Car Safety and Smoother Ride Are Rewards of New Shock Absorbers

Standard operating procedure in many homes at this time of the year is installation of screens in windows and doors. It is the time to check hardware, tighten a <u>few screws here and there</u> and add a drop of oil where necessary.

You may find an adjustment needed in the door closer, too. A combination of wear on the plunger and the lighter screen insert makes the door close differently.

This plunger is not unlike the shock absorbers on your car, which may be showing signs of wear after the rigors of winter. Shock absorbers are, essentially, plungers.

As the plunger on your screen door is designed to resist the forces of the closer spring, allowing the door to close gently, so the shock absorber resists the tendency of the wheel on your car to hop

A. .

as it bounces off an obstruction in the road.

#### Maintain Status Quo

Shocks also keep the car's body from bobbing up and down like a rowboat at sea. The shock absorber's philosophy is to maintain the status quo; the wheels shouldn't hop and the body shouldn't bop.

Eventually, with age, a worn shock absorber loses its control of the situation. Instead of easing your wheels over bumps in the road, it lets them bounce, sometimes setting up an oscillation like a ball on a long rubber band.

If this only caused an uncomfortable ride, it would be bad enough. But there are other problems created by worn shocks. Most importantis the safety factor.

When the wheel is bouncing a few inches in the air, it

cannot contribute much to the steering and/or braking of your car. During this short but critical period you are virtually out of control.

#### Worn Shocks, Higher Bills

Tires and suspension parts also take additional punishment when shocks lose their control. If a worn shock absorber permits these parts to suffer two or three rebounds after a bump, they will have taken double or triple punishment. You'll feel this in your repair bills sooner or later.

As a rule of thumb, any time after your shocks are two years old, they may be due for replacement. New ones will give your car a whole new lease on life. Think about it the nexttime you are driving over a bumpy road. Or better yet, before you do.





# New Car Service Equipment Saves Time, Money

### Mechanical Technicians Now Use Electronic Instrumentation To Speed Auto Repairs

In automotive service, necessity has literally become the mother of invention. New developments in service equipment and techniques have been brought about by a growing shortage of mechanics.

In 1960, there was one mechanic for every 60 cars. Today the ratio is over one to 90 and conservative estimates raise that figure to one mechanic for 120 cars during the present decade.

How to handle the increased load? The automotive service industry has come up with several approaches to the solution, not the least of which is improved facilities, from build-

### ing design to space-age equipment.

Electronic instrumentation, power equipment and specialized tools make it possible for mechanics to diagnose and correct car troubles in a fraction of the time it took just a few years ago. Imagine having four tires installed, wheels aligned and balanced . . . all during a lunch hour stopj

#### Some Repairs Routine

Accident repairs which would have been prohibitively expensive if not impossible, now are routine, thanks to impressive new equipment which scientifically "decrashes" the car. Electronic testing equipment makes it possible for a technician to analyze an engine's condition with extreme accuracy, pinpoint potentially troublesome components and put the car back into optimum performance condition in much less time actually, than the old fashioned "guess and replace" tune-up used to take. In the long run, such service is a true bargain, since the owner is paying for the parts and service he needs, yet no failure-prone components go overlooked.

The tremendous increase in the popularity of air conditioning in cars has added another dimension to automotive service. Whereas these units once were handled only by a limited number of specialists, many shops now offer air conditioning service.

Developments in tools and training techniques have made this possible.

New training facilities are being made available to service stations and repair shop personnel by car factories as well as by manufacturers of parts and services equipment. This promises to add to ranks



of qualified service technicians needed today and in the future.

Easing the Load

Improved dissemination of, information on new models, available to all service personnel, means that most routine maintenance operations can be handled by literally hundreds of thousands of service stations, garages and other outlets throughout the country. This helps to ease the load on franchised car dealers who then are able to accommodate customers with special problems requiring their service facilities.

Equipment such as that in use at the Auto Club of Missouri's St. Louis diagnostic center takes the guess work out of car service. This machine checks ignition condition in a matter of minutes with complete accuracy. It's just one of the new tools available to technicians to help them do their work more quickly, accurately and at a lower cost to the motorist.

**Federal Requirement** 

Evaporative control systems were required for new vehicles sold in California

starting with the 1970 models. Their introduction, under federal requirements, on a national scale is the third big step auto makers have taken in the past decade to eliminate emissions as a factor in air pollution.

The first two steps were eliminating emissions from crankcase ventilation and reducing pollutants that emanated from the exhaust pipe.

On cars built prior to the introduction of emission controls in the early 1960's, 60 percent of hydrocarbon pollutants were traced to the exhaust pipe, 20 percent to evaporation and 20 percent to crankcase ventilation.

#### **Pollutant Reduction**


Improvements in the design of engine components and modification of many engine adjustments resulted in sizeable reductions of pollutants emitted through the exhaust pipe.

Hydrocarbons which were formerly released into the atmosphere from engine crankcases are now sealed and recirculated for burning in the combustion process. Cars of today are 60 percent more pollution free than those of 1964 and in a few years the internal combustion engine will be virtually non-polluting. But conscientious maintenance will still be needed to keep them that way.

# New Anti-Pollution Devices Are Built Into '71 Cars

Starting with the 1971 models, all new cars sold throughout the United States feature fuel evaporative control systems to help reduce air pollution that may be caused by automobiles.




The evaporated fuel, which formerly was vented into the atmosphere, now will be eliminated by a system which stores the vapors in the crankcase or in activated charcoal canisters until they can be drawn into the engine The motorist can now do his share towards obtaining cleaner air by maintaining his car.

The backfiring car almost seems a relic of bygone days. However, the modern car can backfire, too — especially when the fuel mixture is too lean and the engine cold. Automotive Editor, Cleveland Plain Dealer Spending a little money on proper car maintenance actually can save you money in the long run. Sound confusing? Actually it isn't, and here's why.

If you have bought a shiny new car, naturally you want to keep it in proper shape, not only because it is safer to drive. but because eventually, if you're like most people, you will want to trade it in A well maintained car, according to both new and used car

dealers, is worth more at trade-in time than a car which has not been properly maintained. In many cases the difference can be as much as several hundred dollars.

We love to see a car that's in good shape both inside and outside, and especially maintained well under the hood," said one new car dealer. "We give top dollar in trade on those cars and we just don't get enough of them.'

There's another good reason to keep a car maintained properly, and that's the warranty which came with your new car. While the provisions of warranties are different for each

of the major auto companies, and may vary from year to year, all of them require periodic maintenance to keep the warranty in effect.

Seat belts save lives, but you have to use them to find out.

Watch Your Warranty This means that if something miljor goes wrong with your car and is covered by warranty, you don't have to pay for replacement of it But if you haven't taken the proper steps to keep the warranty up to date, you will have to pay for the repairs yourself - and that might turn out to be very costly.

In general the provisions of a warranty require routing maintenance at specified in

tervals. This includes oil change and lubrication, plus checks of the various parts of the engine, such as the cooling system, generator, brakes and

steering. A modern car is composed of many complicated parts. any of which might go wrong ( at any time. It just makes/ good sense to have things inspected, and minor work performed at regular intervals

Tune-Up Important

A smart motorist also gets an engine tune-up which includes new distributor points, spark plugs and condenser, at regular intervals Generally this interval is about every 10,000 miles.

Tires should be checked regularly for proper inflation and should be rotated for proper wear, usually every 12,000 miles or so

Many people have their tires checked, and rotated, about twice a year — usually when they put on or take of snow tires.

Incidentally we probably won't have any more snow until late this fall, so if you've still got snow tires on the wheels, it's a good idea to take them off now.

Keeping the outside of the car clean also is a good idea. In weather like this many people prefer to wash, and wax when necessary, themselves. Others prefer to use the services of a car wash.

The story started back in March of 1971 when the Ruidoso State Bank filed an interpleader suit asking the District Court for release from obligations of scrow agreement whereby Newco Industries was to purchase the defendant Gene Hensley's interest in Ruidoso race track for total purchase price of \$1.513.590.00.

Subsequent to this action the Ruidoso State Bank paid into the District Court fund the sum of \$451,166,85 pending determination as to disposition of this tender. Shares of stock were also delivered to Clerk Penfield for safe keeping, amount not known because Penfield has not opened this envelope.

A lawyer representing the Internal Revenue Service presented himself at the District Court office in Carrizozo Monday and handed Penfield a Notice of Levy, made out to Lincoln County Clerk, Courthouse , Carrizozo, N.M. Starting with the premise that complicated problems can sometimes be solved with simple answers, I have done some reading which I thought might enlighten me, I now find myself more confused but certainly more receptive and open-minded.


I t is easier to begin with the obvious and proceed to the more obtuse because t is easier to deal with the known than with the hypothetical. Therefore, let me comment on the unbelievable confusion and inefficiency that has resulted from the organizational and jurisdictional trichotomy in New Mexico public education.

It is inherently inefficient organizationally to run a public school system in which the State Department of Education. headed by an elected board, is autonomous from the governor. the Public School Finance Division and the legislature. It is inconceivable that public education has progressed or regressed, to its present point

in New Mexico without attempting to alleviate this obvious inadequacy. To allow this triumvirate of overlapping, often warring bodies

bodies continue to direct education in New Mexico without radical change is unimaginable! To allow the continuation of the seperation of policy and philosophy from that of planning and finance should not be tolerated. First, the State Board of Education should be appointed rather than elected, Only those qualified should be selected for this most important board,


