Sellers case was worst miscarriage

"Judge E. Korrest Sanders of the District Court of Dona Ana County, in Carrizozo last week to preside over the case of State of New Mexico vs Johnny Lee Sellers, called the jury verdict of "Not guilty" the worst miscarriage of justice I have experlenced since I have been on the bench. I certainly do not agree with your verdict.

The case was brought to Lincoln County-from Dona Ana on a change of venue requested by the defendant who stated he could not get a fair trial in Dona Ana County.

Sellers was charged with armed robbery upon the persons of Mr. and Mrs. Manuel Sandoval at the Dona Ana Apartments on For about March 2, 1971 in Las

Cruces. The robbery was reported to have taken place at 4:00 p.m. in broad daylight, \$3,000 in cash and \$2,000 in checks were taken and have not been recovered.

A witness for the state was Resse Wimberley, a 6th grade student in Las Cruces who made the following statements, selected from Exhibit 1.

Q. Resse, as I understand it. you witnessed part of what happened during the armed robbery at the Dona Ana Park Apartments on Tuesday, March 2. Is that right? A. Yes.

Q. You saw the car drive up to the office of the apartments? A. I was on the sidewalk where they play volleyball when the car

drove up. Q. Who was driving it?

A. Billy Lawson. Q. Was there anyone else in

It's a rare town, or county, or family that is really ready for a stroke of disaster.

It's so nice to work at our job, (maybe you don't have to) then enjoy leisure time that comes after the job is done without any worse worries than maybe a lousy TV program, weeds in the yard, or the sports page lost.

Living in Oktoberfest country is so pleasant, all year around, that we don't really worry about---

Water shortage Trash disposal.

Old-junk cars, buildings, lots. Forest closure. -Customers and business in the

next year. What the heck. It's always rained. Neighbor's trash (not yours) has always blown around some. Those old run-down buildings and junk cars don't look so badafter you passed them a jillion times."

Many cattle feed applications taken

One good rain does not stop a drouth. Much of Lincoln County received a dandy rain Monday night, and a few areas had good rains ahead of that date, but the county remains close to drouth conditions this week - pending more rains that will fill the tanks and start grass to growing.

Bill Trammell, executive director of A.S.C.S. office in Carrizozo said they'd had a lot of applications for cattle feed at a reducéd price:

For primary livestock, milo is selling at \$1.42 per cwt. and corn at \$1.90 per cwt. For secondary livestock, calves and lambs which will be sold, the prices are \$1.89 for mile and \$2.54 for corn under the Federal

drouth assistance program.

Federal programs now permit drouth-area stockmen to use setaside and cropland adjustment program acres for haying and grazing. These lands are available to replace rangelands and hay crops lost to the drouth.

The president's disaster fundis paying two-thirds of the cost. up to twenty dollars a ton, to transport hay purchased by those who suffered losses in the drouth.

Federal feed grains are being sold far below market price to those who have suffered losses as a result of the drouth. To determine whether you qualify for this program, contact the Agricultural-Stabalization and Conservation Service or your County Extension Agent,


