A line started forming at the voting booth in' Carrizozo fire hall early in the morning and people were waiting their turn to vote most of the rest of the day. A record total of 292 voters were registered, compared with turnout of 138 voters in the 1972 election.

Election judges Joan Means, Sharon Helker, Margaret Chavez and Jaunita Chavez finished their vote counting at 10:00 p.m. This all-female board of judges chine about when Judge Friday Sherrill entered the local hospital Sunday night and Mrs. Means was appointed to this position on the election board.

Bill Payne won the mayor job with 157 votes to 109 for Ed Jones

The voting machine used in Carrizozo ran out of ballot paper at the end of the day and four paper ballots were used to finish the voting. Most of this shortage was caused by the large write-in vote.

Roy Harman was elected to fill Position 3 as Trustee with 63 votes. Rox also received 44 votes in Position 4.

Willie Silva won election in Position 4 with 63, and he also received 55 votes in Position 3.

There was a list as long as your arm of people getting 1-2-3 votes for the several positions. The only serious write-in voting was for Leandro Vega Sr., 51 votes in Position 3 and 36 votes in Position 4. Dale LaMay received 28 votes in Position 3, Ramon Luna 19 votes in the same

position. Luna received 23 votes in trustee Position 23 and 27 votes for municipal judge. S. M. Ortiz won the municipal judge position with 183 votes.

Fuller is mayor at Corona, Johnston re-elected at Capitan

-- The Village of Corona, elected three new officials Tuesday. Ken Fuller won the mayor position on a write-in total of 32 votes. Ronald Dempsey received 7 votes.

Positions of councilman for four-years terms were both filled by write-ins. L. L. Carnell got 14 votes. Position 1 and Lee Mulkey 25 votes in. Position 2 to win these spots. Village Clerk Gertrude Allen told the News that 52 votes were cast in the Corona election.

The Village of Capitan had a full ballot. Incumbent Mayor J. T. Johnston was re-elected with 98 votes in his favor. Fletcher Hall received write-in total of 41 votes for mayor.

There were three candidates for Councilman for Hour-year term, position 1. Valton Hall 87. votes. Norman Renfro 101 votes were the winnors. Virgil Hall Jr. received 64 votes.

Chuck Panky was only candidate for councilman for term of two years, he received 120 votes, no write-ins of consequence.

Mrs. Gertrude Huey was re-elected as municipal judge with 110 votes total over 38 for Dorothy Johnston.

Our County Budget in 1972-73 was \$524,857.00 and this year 1973-74 it was raised to an outstanding figure of \$1,109,505.00 - an increase of \$584,648.00. This is a complete double in our county expenditures, but did we improve our general county welfare twice as much?

Our general county expenditure in 1972-73 was \$187,469.00. In 1973-74 it was raised to \$483,691.00.

Where did we better ourselves at antoken of \$367,609.00 in one year?

Our road department expenditure in 1972-73 was \$187,469.00. In 1973-74 it was raised to \$311,736.00. Have your roads been improved to equal this \$124,267.00 increase? Also, are yourroads in better condition now with 9 graders that they were one year ago with 5 graders?

If all of the deprements received the same amount of an increase, this includes salaries,... roads, etc. each department would have received a total increase in their budget over the past year of \$58,465.00. Or according to the increase of the entire budget, which was doubled, and with equal distribution each department budget would have doubled also. *

It is my understanding that none of the men on the road department received a raise in salary, and if they did receive some, it certainly was not doubled.

This appears to me that there has been a vast "spending spree" with our tax dollars.

These are not my figures, but they were taken from the Lincoln County Official Budget, approved by the County Commissioners and also approved by the Department of Finance and Administration in Santa Fe.

2 Another concern of mine is the welfare of our citizens of Lincoln County in case a disaster strikes. The past commissioners set aside an amount of \$150,000.00 more or less, in case we had another natural disaster such as the flood in the Valley in 1965. This has also been spent, but . for what?. In general, disaster victims react in an active manner and do not wait around for assistance from outsiders. Now we do not have adisaster fund to help out in case we have another flood, for bridges, etc. We will have to obtain fedral help and assistance.

3 One of the least understood of the responsibilities that go with the job of County Commissioner, and one that can get all levels of government in hot water the fastest when a disaster occurs, is the safeguarding of the lives and property of your citizens and friends, who elected you for the position of County Commissioner. You have at your disposal a means by which this particular responsibility can be made easier. This is your Lincoln County Defense. This agency, however, can and will be only as active and effective as you and the other members of local government want it to be. It needs your interest and your understanding and the full active support of all county and local government.

I believe that if a man is elected to serve as your county commissioner he should be able to do these duties with no interference from his business and be in a position to devote all the necessary time to this elective office as it demands. . . .







Excludable items considerable savings

In another article we brought out some differences in tax treatment between the state of New Mexico return and the Federal return such as tax rates, credits, etc. Allowed by the Federal but not by New Mexico. What exclusions or credits are allowed by New Mexico but not applicable to the Federal return?

The Federal government taxes all interest an individual might receive from obligations of the United States of America, i.e. E bonds, H. bonds, etc. The state of New Mexico does not tax these U.S. obligations and they should be excluded -from the taxable income on the state return. Pensions, under the provisions of the New "Mexico Public Employees" Retirement Act of New Mexico or the New Mexico Educational Retirement Act may be fully or partially taxed on the Federal return but are fully excluded

from taxable income on the New Mexico return. Federal Civil Service Annuities received by retired Federal Civil Service workers may be fully or partially taxed by the Federal government but may be excluded in an amount not to exceed \$3,000, per annuitant, of taxable income from U.S. Civil Service Annuities.

These excludable items can be of considerable savings for qualified New Mexico taxpayers.

Hell-For-Leather Horsemen Open New Buz Kashi Season

Washington-It's buz kashi season again. The Turkomans are hitting the line, and bones are breaking.

Football fever has nothing on the hot-blooded enthusiasm for this national sport of Afghanistan. Gridiron heroes crunching through . with the old pigskin are no more heart-stopping than buz kashi horsemen slamming ahead with the old headless goat carcass.

For that's how the game is played: two teams of hell-for-leather horsemen using a dead goat or small call for a ball. A rider somehow grabs it and gallops off in a full-scale chase to register a score.

Actually there's no line of scrimmage. Instead the whole swarm of riders is a sort of non-stop scrimmage, racing the length of the playing ārēa, perhaps a mile long. Anything Goes .

In buz kashi--meaning goat drag--almost anything goes, and tureh, or bravery, is everything. Back from a year along the Turkomans' homelnad in Afghanistan, Sabrina and Roland Michaud remember these "Bold Horsemen of the Steppes" in the November National Geographic.

Any number can play, from ten upward. Team's may have identifying colors riding before grandstands in cities such as Kabul, the capital, especially during \independence day. celebrations. In country buz kashi, the team effort becomes every man for himself.

As game time approaches, the buz kashi "ball" is prepared in a ritual bound to impress a football equipment manager. As the Michauds

"On the eve of the game the animal isslaughtered, gutted, filled with sand; then sewed up and soaked in water during the night to increase its weight. It ends up somewhere between 60 to 80 pounds." In a wearing four-hour game, it may have to be replaced several times. Rough Game Plan

. The game plan is bare-knuckle basic: "The game opens with the carcass in the center of a circle, drawn in lime, which is called the hallal, or circle of justice. The chief of the buz kashi signals. The horsemen, ranged about the circle, plunge for the prey."

Leaning far out of the saddle, a horseman seizes it, and thunders away to a distant pole on the steppes. If it hasn't been grabbed from him, he wheels around the pole and tries to outrace

It is no game for the timid, but Turkomans survive in a harsh world stretching from the Caspian Sea into Afghanistan, between Iran on the south and on the north their traditional homeland of Turkistan in the U.S.S.R. They still hold to the old ways--and amusements--of their nomadic forefathers who once terrorized Central

Many of these bold horsemen have been killed riding in a buz kashi or come home with new awareness, of an old Afghan song: "Better.come home stained with blood. Than safe and sound as a coward. ..."

Nine bridges planned in area


Prior to 1973 repairing or widening bridges on the state highway system was a part of the High Department's continuing highway maintenance and improvement program. During the 1973 legislative session, the governor and the legislature recognized the urgency of the roadbridge situation and requested that the Highway Department make an extensive study of the bridge problem in the state and recommended that the Department establish and accelerated program for bridge replacement,

As a result of the study bridge replacement was planned all over the state. In the Carrizozo area nine new bridges are in planning-stage and one on US54 about eleven miles south of town is nearing completion.

The overpass at Carrizozo is on schedule for widening, another 18 miles east on US380, another 17 miles east of Capitan, a bridge 18 miles west on US380, and five bridges on US54 30840 miles south.



N. M. Livestock board files burro suit against Interior Dept.

The New Mexico Livestock Board filed a suit in federal court in Albuquerque Monday which challenges the Interior Department Wild Horse and Burro Act as unconstitutional and illegal. The Wild Horse and Burro Act is intended to protect unbranded and unclaimed horses and burros as endangered wild species.

The case came about from the impoundment of 19 unbranded, unclaimed burros which were rounded up south of Carrizozo and sold at auc-

The suit maintains that on Jan. 20 Kelley Stephenson, owner of I - X Ranch which joins Carrizozo on the south, requested the Livestock Board to capture and corral 19 head of burros which had been wandering upon his private property and upon public lands which he has leased from the government. Stephenson also stated that the burros were harassing and molesting his cattle, destroying his feed on both the private and public land and were otherwise interfering with ranching operations...

The Livestock Board contends the burros are 'estrays" and come under the jurisdiction of the state's stray laws which were enacted in 1907 and give the state full authority to dispose of stray unbranded horses and burros:

The court action asks for a permanent and final injunction restraining and enjoining the féderal government from confiscating horses and burros. It also asks the court to declare the state strays law in compliance with the Constitution and statutes of the U.S.

County Agent Report

Avoid Problems In House Plants

Many plants grown indoors suffer from insufficient light and low humidity. Temperatures can also cause problems.

Many foliar plants prefer a relatively strong, filtered or diffuced light. Places near windows or light fixtures are usually suitable. But plants should not be in direct sunlight or in very dark areas of the home. Generally, ost house plants need a thorough soaking once a week, the watering should only be done when necessary, and don't let the post stand in saucers of water.

Most plants grow well in temperatures of 60 to 70 degrees. Plants should not be in drafty places where temperatures suddenly change. When adding fertilizer to plants follow all directions on the container. Too much fertilizer can kill your. plants.

.. To enjoy your plant for many years, watch for common symptoms of foliage plant troubles. Brown tips or burned margins of leaves are caused by too much fertilizer, plants dried out temporarily or windburn. Yellowing and dropping of leaves can be caused by gas fumes, chilling, overwatering, poor drainage and poor aeration.

Weak growth or light green or yellow leaves indicates (too little) light, lack-of-fertilizer or a poor root system. If the plant wilts, it is getting too much heat or it lacks water, these other spindly growth and small leaves indicate too little light or too high temperatures.

A two-or-three-inch layer of an organic mulch over the root system of plants will produce several beneficial effects on both the soil and the

plants. Mulch conserves soil moisture by reducing the evaporation of water from the soil. Mulch prevents crusting of the soil surface, thus improving absorption and percolation of water to the solid areas where the roots are growing. Mulch maintains a more uniform soil temperature by acting as an insulator, reduces weedproblems when the mulch material itself is weed-free and is applied deeply enough to prevent weed seed germination mulch adds to the beauty of the sandscape by position ding a cover of uniform color and also pre .ts fruit and plants from becoming mud splashed and thus reduces losses.

Morrow cited these legislative ac-10-3p-eomplishments also: State-employee-minimumpay raised from \$347 to \$400 a month: a substantial tax cut with a projected \$21.4-million unappropriated state surplus June 30, the public school finance law. Sen. Morrow said the school finance law "makes more money available so it can be distributed locally."

Rep. Richard Carbajal, D-Belen, chairman of the University Study Committee, said the USC will follow state universities activity in energy reseach. Larbajal added: "We're going to get more in-depth-into universities' budgets."

Rep. Carbajal said the USC will hold meetings on university campuses. The first will be at New Mexico State University, Las Cruces, March 20-

Sen. Kenneth Schlientz, R-Quay-Curry, said the \$2 million voted by the legislature for energy. research "will help the state universities, especially UNM, New Mexico State and New Mexico Tech." Schlientz is also a USC member.

Sen. Schlientz applauded the \$2600000 deficiency appropriation voted by the legislature to Eastern New Mexico University to get its bond payments in balance. The money is intended to eliminate all ENMU-debt service deficiencies.

Sandia Savings and Loan Association, Albuquerque, applied to the State Banking Department for authority to establish a branch office at Rio Rancho,

Gov. King signed a bill by Rep. Fred Luna, D-Los Lunas, appropriating \$100,000 to renovate three old buildings at-Los Lunas Hospital and Training School,

King also signed a bill creating five more district judges. The new judgeships: One in District 6 to be Luna County resident; one in District 9 (Roosevelt-Curry); one in District 11 to be a San Juan County resident; one in District 12 (Lincoln-Otero) and one in District 13 (Valencia-Sandoval) to be a Sandoval County resident.

The Sandoval County judge will be effective July 1 this year to serve until 1976. The other judgeships will be filled initially in the 1976






