Corona was named an official Bicentennial town after completing a new park to commemorate the nation's two hundredth birthday; enthusiasm has been high this summer in the ranching community.

The parade will start at 10:30, Sat. July 31. Judy Chavez is still accepting parade entries & particularly wants additional musical groups. The Shriner Bagpipers of Albuquerque will be marching as will a mounted cavalry group from Ft. Bliss.



Fenter said the burglar evidently knew what he wanted and took only that. This was the second robbery of the store this year.


### Teams fight **ŚW** wildfires

Wildfires burning in Arizona and New Mexico have destroyed thousands of acres of timber and brushlands that will take years to regenerate. But it could have been far worse. The Forest

Service, Southwestern Region, and the State Foresters each spring lay plans for combating the wildfires that can be expected during the dry, windy months from March into July. Trained manpower is the first line of defense

said Lynn Biddison, Director of Fire and Air Management for the Forest Service in Albuquerque. Fifteen Hot Shot crews, totaling 20 men each, are assigned to National Forests and Ranger Districts most likely to have trouble with fire. These crews are made up mostly of young people who are highly trained and conditioned for the rigors of fighting fire in rugged country. These crews, led by experienced Forest Service fire specialists, make initial attacks and almost invariably stop blazes before they exceed an

Twenty helicopters with their special "helitack" fire crews can reach a fire in minutes. Even faster are the 25 smokejumpers based at Silver City. They parachute into five, areas when they are small in the remote mountain areas.

### Hay cubes bearing set

An informal hearing to take testimony about the possibility of including field processed alfalfa hay cubes (mini bales or wafers) under the Commercial Feed Law will be held July 23 at 1 om: in the New Mexico Department of Agriculture Building on the campus of NMSU, Las Cruces.

At this time hay cubes are exempt from the law which requires registration of feed products and a guaranteed analysis. A fee is charged to cover inspection and analytical costs.

The New Mexico Department of Agriculture will conduct the hearing and take oral testimony. Written statements in support or in opposition and signed by the maker will be accepted if received prior to 5 p.m. on July 23. Statements may be sent to New Mexico Department of Agriculture, Box 3189, New Mexico State University, Las Cruces, New Mexico 88003.

Capitan is leaving two other ordinances for consideration the regular August 2 meeting. The trustees at that time will hear residents opinions on a second attempt to annex part of the Mesa Verda subdivision.,

The previous annexation methods were unconstitutional.

The Capitan trustees will also consider for final passage an ordinance giving minors under 18 years old a 10 p.m. curfew.

A number of New Mexico communities are enacting such ordinances following a report which said that a high percentage of crimes are committed by minors who are not under supervision in the late hours of th evening.



like to form an organization where there is no need for baby sitters, dressing up, dues, refreshment committee, president, secretary, treasurer, etc.?" That was the beginning of the Cookie Experience'. We consider ourselves

connoisseurs in search of the best cookie recipes. If you would like more information, ask me next time you see me or ask around. Your neighbor might already be a member.

Your race, politics, education, finances, or religion beliefs should not hold you back. Qualifications for belonging are; being fairly sanitary (not necessarily sterile) and labeling your cookies on a card with your phone number ; (no recipe). For example: Polly's sherry wafers, Laura's date pin wheel, Lavenia's pineapple


Come November we should have a collection of old favorites, unusual and even foriegn country cookies recipes that will come in handy for our Christmas giving and holiday entertaining.







That reminded Red of a story about a friend of his who was asked where he got his new barrel. "It's not a new barrel," he replied. "Looks like a new barrel," his questioner allowed. "Got new hoops, new staves, new bottom, looks new to me," "It's not new, though," the friend insisted. "Those are just new fixings around the same old hole."

Carrizozo ought to have the title of "National Law and Order Town!'. We decided the other day that we probably have more lawmen per capita than any other city in the nation: maybe in the world.

According to the census, Zozo has about 1200 people - men, women and children. We have a town police force of 6 men. There are two state police officers living here. Sheriff Vega lives in Carrizozo and there are always a couple of deputies around the courthouse; make it an average of one and a half, or to be fair, cut it to one just in case there is a riot in Corona

someday... That makes about one officer for every 120 people. Using the national average of five people to a family, Carrizozo has an officer for each 24 families. Sounds like we are expecting another Lincoln County War.

It is hard to understand how that burglar who broke into Fenters Variety Store Saturday didn't stumble over an officer of the law.

I heard somewhere that an officer for every 1000 population was considered pretty good. But Scotland Yard, that ancient citidal of law enforcement charged with protecting London and the surrounding area, at one time had only 1 officer for every 10,000 residents and the bobbies do not carry guns (nor do they usually get shot

There is one city of Mexico with a low crime rate that has more gardeners that policemen. How about that for flower power?

We are not criticizing our policemen, but maybe we should take a look at the cost of such a police force in one town in the U.S. These men get paid a salary-as low as it is. It takes gas and car up keep to have them mounted, and the town recently uniformed the officers.

Four of these officers (it was five until last week) are not paid by the town. When questioned as to the need for such a force, the common answer is: why not? They are free,

Free? How in the Sam Hill does anyone think they are being paid? Instead of town tax dollars as Marshall Choncho is paid; instead of county tax dollars as Sheriff Vega and deputies are. paid; instead of state tax dollars as Officers Max. and Dale are paid; the Carrizozo police are paid with federal tax dollars under a CETA program.

This may be an unpopular observation but a lot of us who fuss and fume about welfare, federal handouts, irresponsible federal spending and high federal taxes are the first in line when it comes to anything the feds give out to the county or the town. My friends, it is our tax dollars that are being spent on those programs.

Now it seems fair to apply for and accept funds for all the federally sponsored programs that we need. Certainly I, for one, favor revenue sharing where our locally elected folks decided which dollar to spend where.

I don't know how we could get by in our generally dollar poor area without some of the federal funds coming back. We need help in-Lincoln County towns on sanitary plants, water works and a lot of street building. And we are

'If you can't go on a vacation -- here is something for the children to do. Make bread dough, the recipe is: 1 cup of flour, 14 cup table. salt, 6 tablespoons water.

Place flour and salt in a mixing bowl and mix thoroughly. Add water slowly mixing continually with hands on a pastry blender. Dough will seem stiff and crumbly at first but do not add more water. Knead thoroughly until dough is pliable. If it seems to stiff for kneading, work in a little more water a few drops at a time, and knead well after each addition. Then place in plastic bag, take out only as much as needed for each part of sculpture & keep rest of dough in bag. It crusts quickly when exposed to air. The dough can be made into small background, such as a board or card board covered with felt, velvet or burlap. 



### Sands Spacemen training deadlines July 30

A training program for astronaunt-pilots assigned to the space shuttle program will be conducted at White Sands Missile Range starting in August, National Aeronautics and Space Administration officials announced.

A spokesman for the NASA Johnson Space Center in Houston said the simulated shuttle-raft descents and landing approaches will be practiced at the Northrup Strip, a wide and relatively flat area in the middle of the range. The training program will continue through the life of the space shuttle program.

A specially modified Grumman Gulfstream-II ietraircraft will be used in the training program. Designated the Shuttle Training Aircraft, or STA, the aircraft has been modified to match the drag and lift characteristics of the shuttlecraft.

The space shuttlecraft is a reusable launch vehicle, resembling a high-speed aircraft, that will have expendable propellent tanks and solid rocket boosters. After performing a normal space mission it will re-enter the earth's atmosphere and coast to its landing site like a large glider.

"Since the shuttlecraft does not have normal aircrash engines," said Charles Haines, project manager for shuttle training aircraft with Johnson Space Center, "the pilots will have to be proficient in controlling the orbiter during descent! Their final approach will have to be made at just the right speed, altitude and sink

These "energy management" techniques will be learned in the training program at White Sands, Haines added.

The Gulfstream STA's modifications include in-flight thrust reversers on its jet engines and large vertical stablizers under the wings to aid in controlling side forces. The shuttlecraft's flight instruments have been installed on the pilot's side of the cockpit, while the conventional instruments and controls have been retained on the instructor's side for use during the training

In charge of planning for the program is Al Manson, one of Johnson Space Center's shuttle instructor pilots. He described a typical training flight approach as starting at an altitude of 40,000 feet, with the STA's drag devices set up to match the shuttlecraft's handling characteristics.

"The student pilot then will control the STA down to an altitude of about 30 feet above the ground," Manson said, "This is about the same eye-height as that of the pilot in an actual shuttle orbiter as touchdown.

"The STA will not be landed, however, instead it will be flown around and will be taken back up to 40,000 feet, where the descent will be repeated."

At Northrup Strip, engineers of the NASA White Sands Test Facility have graded and marked a runway 20,000 feet long and 300 feet wide. Easily visible from earth orbit, the strip is in an ancient dry lake bed just northwest of the White Sands National Monument.


According to Al Paczynski, the White Sands Test Facility engineer in charge of coordinating the runway program with the Army at White Sands Missile Range, the area selected because "the terrain is ideal."

extended to 35,000 feet, or seven miles long. Normally, the NASA officials said, two sets of training flights will be conducted each week. The astronaut-pilots and instructors plan to land the Grumman STA at Holloman Air Force Base for servicing between missions and to be billeted there when required to remain overnight in the White Sands area.

Support for the training program also will be provided by the Army-operated National Range at White Sands, which will furnish range control, restricted air space, range communications support and range scheduling functions.

## Antelope license

Application deadlines for antelope and bighorn sheep licenses is July 30, the Department of Game and Fish reminds sportsmen.

Applications can be made in person at any Game and Fish Department office or by mail to the department's Santa Fe headquarters.

Applications, to be made on Form E, available from license vendors and Game and Fish Department officers, must be accompanied by a -\$1.00, non-refundable-application-fee, plus-theproper license and vendor fees. If an applicant's name is drawn, his license and vendor fees will be returned."

This year's game regulations will allow up to 4,500 total antelope licenses.

The number of Rocky Mountain bighorn sheep permits has been increased by the State Game Commission to 20 resident and four nonresident licenses. Desert bighorn licenses are limited to five resident and one nonresident licence. A prospective bighorn sheep hunter can apply for either a desert or a Rocky Mountain. bighorn license, but not for both.
