Capitan Schools First Phase Drawings Shown

Schematic drawings of the proposed Capitan Elementary school were revised and approved at a special meeting of the Capitan School Board.

Meeting with architect Ron Hutchinson, the board approved a fourteen classroom building to be constructed facing Forest Street south of the gymnasium-cafeteria complex. The building will fill the present parking-lot and will be tied onto the intermediate building, a possible 17-rooms. Floors will be carpeted and 2 boys and girls bathrooms as well as toilets in the kindergarten rooms will be included.

A student commons, an interior relaxation area will be situated near administration and custodial rooms. The board agreed to go with understoor forced air gas furnaces and

thermo-plane glass on the windows. A metal building was discouraged for the high cost and Hutchinson suggested a split-face clock construction. He explained the block unlike traditional cement block, has a higher insulation rating and has a decorative exterior face. Construction with it eliminates the need for stucco.

A built-up roof will be hidden by a parapit. Bus parking and vehicle

traffic will be rerouted with an, entrance from Forest Street and exit onto. highway 380.

The architects will now go to a design development, a detailed working hen onto a construction document phase. Hutchinson stated bids will possibly go out by July.

The schematic drawings may be viewed at the Capitan School Administration Building.



Letter to Editor - Last Week's My Time

Dear Editor:

Concerning your latest editorial, I agree with you up to a point. You stated that the first problem is that people spend too much money out of town and out of this county. I, too, feel this is the greatest problem we face as a community. It is in essence a vicious cycle. The people feel that their demands and wants aren't met by many of the merchants and the prices are high, so they take their business out of town. The merchants, thusly, feel that the townspeople will go elsewhere to shop so why should they invest in stocking a large inventory. And so it goes. Of course, their are several businesses in our community despite this that couldn't be better and do have fair prices.

A possible solution to this problem would be to investigate through our Chamber of Commerce a task force that would specifically set as their goal to find how much money does leave this community given any one month. A questionnaire might be a possibility used for such a task force. As a first step this would let us know more than an estimate of how much money does leave. No doubt, it would be astonishing. Any money leaving this community does hurt whether it be in this county or another. And, of course, we are all guilty, but not totally by choice.

The next step, I feel, would again be working through our Chamber of Commerce to work with merchants in an optimistic and guided effort of "Buy

Now, I have spoken to your first and second problem as you stated in your column. The third problem you have solved. You solution being that as of your last edition, you'll no longer print any informative news (as I define itfree ads as you define it) in your paper concerning certain fund raising events. I'm really not sure which ones, but I do know of four. They include; St. Judes Hospital sponsored by Mrs. Dale Goad, American Cancer Society sponsored by Mrs. Craig Nelson, Red Cross sponsored by Mrs. Truamn Spencer, Jr., and March of Dimes sponsored by Mrs. Stirling Spencer. I feel this is slightly dictatorial. I am not surprised at you mentioning all of the fund raising that we have had in our community and asking for possible solutions to this problem; but I feel that maybe you as a person who does have power in our community have certainly acted in a negative way. It does hurt us that we no longer can ask you to print our news for we are only at your mercy. But I do think your thinking is wrong and I hope it does not reflect totally the thinking of our merchants.

We are all plagued at times by too many requests for money. A kind and simple "no" has never been misunderstood. The merchants can certainly do this for themselves without the help of you. I also feel if they truly wanted to advertise constantly with you, our fund raising would not stop them. There are several other effective ways to advertise one of them being showing support for their community and interest in the different organizations. A supportive merchant of their community, as in all communities, is a wonderful asset. In the same token, a merchant must not feel he has to give in order to keep that person's business. That is not profitable thinking.

This community is, of course, not perfect, but working together does make the difference. I do hope to convince you to change your mind. short of money, that we are only trying to help in mainly our own community. nevertheless, many of these national organizations have helped many of us directly and indirectly and they, too, deserve some attention. We want no one to feel that they have to give, but we do wish the opportunity to inform our community of what these organizations do and what we're doing for them. I don't think that is asking too much after all what is a newspaper suppose to do? I still have some things on my mind, but at this point, I feel, if you do not censor this letter and print it in total, it is a step forward.

Paul P. Harris (1868-1947) a lawyer in Chicago, organized the first Rotary Club in 1905. It was named "Rotary" because the members met in rotation at their places of business.

Rotary International is a world-wide organization of all Rotary Clubs. A Rotary Club is a group of men, each in a different profession or business in the community. Rotarians take part in community welfare, foster good citizenship, promote high business and professional standards, improve rural-urban understanding and advance international peace, understanding and good will. Rotarians encourage and foster the application of the ideal of service by every Rotarian to his personal, business and community life.

The Carrizozo Rotary Club charter night was April 11, 1959 at the Carrizozo Country Club. Marvin Roberts, president of Carrizozo Chamber of Commerce gave the general welcome. 20 years ago. The sponsoring Rotary. Club was from Alamogordo. The first Carrizozo Rotary president was Ralph Petty. Charter members today are Albert Roberts, Johnson Stearns and Fred English.

Carrizozo Rotary met for a long time at the Village Inn Cafe, until it burned down. The NEWS now is located in this restored building. The club meets once a week for their fellowship meals at the Rec Center to exchange indeas and create more and better understanding of the business community. Rotarian ideas are carried out.

In a NEWS issue of March 26, 1964
Rotarian and former NEWS publisher
and editor wrote in his 'The Way of the
West' column: 'The Zozo Rotary Club
is real proud of its president, Johnson
Stearns he conducted a Rotary meeting
last Saturday with more guests than
Rotary ever saw before, some 400, and
did an fine job. When it comes to telling
stories with a castus flavor, Johnny
tops the list." — Paul Payton —

The Rotary has many interesting programs each week. They encourage individual and groups to speak. 




schoolrooms and endowed educational institutions by the thousands.


The caller asked for information concerning disaster unemployment assistance programs, Told that the office was closed, he was asked to please call back the next day.



Personal Glimpse Of Wash., D.C.

by Ralph R. Dunlap

After seven months of waiting, I received the phone call asking me to go to Washington, D.C. for a month's orientation in preparation to going to Tunisia.. They gave me less than ten days to make final arrangements and get to Washington by March 5th to start classes. I will be going to Tunisia March 31st as a Sheep Production Specialist with the United States Agency for International Development, which is partof the Department of State.

Quite a bit of the orientation included information on forms to fill out. procedures and getting the forms completed on overseas shipment. The medical officer from the State Department gave me a few guidelines for staying healthy overseas - some

Boil water for 10 to 20 minutes before drinking; Do not eat green salads in resturants; Avoid cream puffs and similar bakery products: Recommended shots of gama goblin for hepititis, tetanus; polio and probably yellow fever; If a soda does not "fizz" do not drink it as it may be deluted with water; Have lo-motile tablets for use for diarrhea.

One of the other outstanding classes was on how to read a foreigner. It went into how your hands, body and feet can be used to get a message across. Often our use of hands gives an extremely obnoxious meaning. For example, youdo not disturb the hair on the head of a child in that area, as it will disturb the spirits to the detriment of the child. It is very offensive to get food or give a gift with-the-left-hand-in-the-Moslemicareas, you always use the right hand. In the Phillipines, you motion a person to come to you with the palm of the hand down. The palm of the hand is up if you call a dog or servant. In Germany and Italy the thumb indicates one and the index finger indicates two. If you want one drink and hold up the index finger, you get two because they assume the thumb was held up also. 


