### MEMORY LANE

A big crowd was on hand for the grand opening party last Saturday at the new Citizens State Bank. The event will become a part of Carrizozo's history.

In 1966, this same bank held an open house to show off their completely remodeled building, now vacant. Soon the site will become a parking lot. For some, this may be sad, but that is progress in the works.

Another important event in 1966 was the dedication of the Valley of Fires State Park on U.S. 380, three miles west of Carrizozo. A crowd estimated at 1,000 was on hand of this event. The late Clara Snow was recognized as one of the

early boosters for the park.

Rumor had it that a second eruption of the Mal Pais volcano would occur on May 6, the date of the park's dedication. Johnson Stearns, then vice president of CSB, Boyd Harper, former Telephone employee and others rounded up tires and gas. Their plan to stimulate the smoke of the ancient lava flow blew in their faces. The smoke did not shoot upward as anticipated but drifted around the special effects team.

Other news worthy happenings in 1986 were... Leandro Vega Sr. wins mayor contest, 198-118 ... First fire in 30 years put two out of business - 54 Cafe (Armstrong) and Central Package Liquor Store (Vlahovic) ... The familiar Food Mart sign was replaced by Piggly Wiggly sign ... Peter Hurd puts finishing touches on portrait of President Lyndon Johnson, with Bud Payne standing as model for the president's hands ... Clara Snow and Ruth Armstrong had over 100 signers for natural gas in Carrizozo ... First mentally handicapped students moved to Ft. Stanton ... C and H Pure Cane Sugar, 5 pound bag 49 cents ... Town grants 25 year franchise to Capitan Carrizozo Gas Association ... The NEWS moved to new quarters, formerly occupied by 54 Cafe and Central Package ... Lloyd Virgil is elected Lincoln County Assessor ... Jackie and A.N. Spencer give the town of Carrizozo a Christmas present - the Rec Center.

### HELPFUL HINTS

- Flower stems too short for a vase? Slip into plastic straws to desired length.

- Can't get ketchup out of a new bottle? Insert a drinking straw, push to bottom and then remove. Enough air will be admitted to start the ketchup flowing.

### WHAT'S COOKING

With everyone trimming calories intake, it was only a matter of time before the arrival of "skinny gravy." The gravy is made in the pan to take advantage of the crisp morsels that cling to the pan, but it is made after all the fat has been poured off.

Although corn starch and flour

are equal in calories, corn starch has twice the thickening power of flour so only half as much is needed. Corn starch leaves no pasty aftertaste and creates a translucent end result, a bonus for dieters who value the flavor and appearance of low-calorie foods.

After roasting meat or poultry, pour off drippings in roasting pan leaving brown crusty parts in pan. Place pan over medium heat. Stir in 2 tablespoons Argo corn starch and desired seasonings until smooth. Remove from heat. Gradually stir in 2 cups bouillon or broth until smooth. Stirring constantly, bring to boil and boil 1 minute. Makes about 2 cups.

### QUILTING BITS

The simplest thing in handwork is the cross-stitch. Use your favorite color embroidery thread on quilt blocks (squares) on cross-stitch designs which have been stamped or transferred onto white muslin. When finished, they can become part of an attractive quilt top. Alternate with solid blocks to match or contrast with your cross stitch design.

The cross stitch is the easiest of all stitches in beginning a quilt top. It is an ideal stitch for children to begin with and can be a good "quiet time" project.

If a quilt top is too big a project, a few cross-stitch designed squares can become dollies or pillow tops. Cross-stitch work is easy to carry around. Work squares one at a time and then assemble into article wanted when all squares are finished.



Yes! Mabel I'm still on this Xmas Jag!!! And I want to tell you an old fashioned, real spiritual Xmas that was originated by the late Dot and Pa Burkstaller, (Agnes and Herman Burkstaller's Mother and Dad).

would quietly go back in the kitchen and have a beer. Sometimes he offered the daughters-in-law a little wine, but they were never served anything but candy and cokes. The tree was fairly medium size with simple lights that twinkled on it. Before we opened the presents, each grandchild performed — some took dancing and some sang and etc. Then when it was time to open the presents the youngest one took his presents out first. He opened and thanked the giver for it then he folded it and laid it aside to open the next. When the youngest was finished the next-oldest came and on and on until the oldest one had finished. Then we took our presents and went home to have our personal Xmas trees the next morn. My children will remember this German Xmas always as the warmest days of our life.

Since I have been talking about tradition, why don't you start your own tradition in the family? It will mean so much in later years. Here are some suggestions for tradition:

1. You could read aloud on Christmas Eve, taking turns. Or write each other a poem.
