





The US Department of Defense spent \$113,746 to transport candidate Jackson and his entourage of \$2 on the Jan. 3 return from Syria with Navy Lt. Robert Goodman. Two planes were put at Jackson's disposal, and he will not be required to pay for the cost of the trip which also included Secret Service agents and 18 reporters (who also made the trip at your expense). It was a small price to pay for the release of Lt. Goodman, but Jackson doesn't deserve all the credit. The release could not have been effected without your generous support. J. A. Parker, editor of the Lincoln Review and a leader of black conservatives, says Jackson's action was sheer "opportunism" and that if Lt. Goodman hadn't been black, "Jackson would have ignored him." (There will be a slight pause here to allow readers to look up the definition of 'racism.'')



Inside Hodding Carter's "Inside Story" on the press and Grenada

By Lester Kinzolving WASHINGTON—Senator Robert Dole, the Kansas Republican who has one of the Nation's most devastating political wits, faced some one thousand members of the media elite at the annual black-rie banquet of the Washington Presss Club on Jan.

"President Reagan has informed me:that in the event of another incursion like Grenada, the press will definitely go along," declared Dole, to loud applause. "No soldiers - just reporters!" (Groans and light applause) (And for some reason or other, this was not reported in the extensive coverage of this banquet by The Washington Post.)

Four nights earlier, the federally funded Public Broadcasting Network had telecast a 30-minute program on this issue, which continues to rage in our nation's capital. Host of this show, entitled "Inside Story," is Hodding Carter, former State Department press officer during the Carter Administration.

On his program, Carter emphasized that there was no reason to exclude reporters from the landings, because the Cuban government had been notified "about five hours before the (U.S.) operation, or at least two" hours before the landings began.

According to Carter's aide, ne Stoddard (since Carter was

filming of this statement took students and girl friends." place in December. November 10 letter from Sen. Malcolm Wallop (R., Wyon.), Secretary of State George Shultz wrote:

"Press reports claiming that the Department of State notified Cuba several hours in advance of the introduction of U.S. troops into Grenada...are totally false. 





Sheriff's office going computer

By P. E. CHAVEZ on the computer system. The a cooperative environment Wichita KS. county commission has approved between local law enforcement: installation of a new system to be known as the Lincoln County Crime Information Center (LCCIC). Operations will begin sometime in March. The computer terminal will be located in the dispatch room.

The computerized system will improve the effectiveness of the department. This move will. modernize the county law enforcement agency and make it comparable with top law enforcement agencies in the nation.

. LCCIC data will include arrest and jail records, evidence and stolen property lists, department budget and vehicle expense. The intelligence file will contain information on all known criminals and their activity.

LCCIC will facilitate work in preparing the Uniform Crime Reporting (UCR) that is sent to the FBI. This monthly statistical report is utilized by the FBI to record the national average on" types of crime.

Part of the LCCIC process is the creation of a computerized 'outstanding warrant file'. In order for this program to succeed, it requires the cooperation of all the courts in Lincoln County. The Sheriff's Office has contacted the nine judges (3 magistrate, 4 municipal and 2 district) in the county to ask for their cooperation in the outstanding warrant file program.

Chief Deputy Sheriff Charles Cox said that the program will make the courts more effective. Law enforcement agencies would avoid the possibility of false arrest due to duplication of an arrest. Outstanding warrants will be removed from the computer immediately when the person named in the warrant is

Outstanding warrants will be entered in the computer immediately upon receipt. The file will include municipal warrants. Also included will be petty misdemeanor to felony crimes.

Each court will have a printout of all warrants issued at any time the judges want the information. This would be an aid to the courts in accounting for all outstanding warrants. In conjunction with this, the Sheriff's Office would request a disposition from the courts of all persons arrested, and this information will be filed in the computer for immediate recall whenever such information is requested.

LCCIC's outstanding warrant file will interface with the National Crime Information Center (NCIC) and the New Mexico Crime Information Center (NMCIC). All warrants will be entered into NMCIC and extraditible warrants will be entered into NCIC.

The Sheriff's Office has been with NCIC service since April, 1983. NMCIC operations in the Sheriff's Office will coincide with LCCIC in March.

NMCIC was established as a service to all law enforcement agencies in New Mexico. The objective is to allow all agencies access to the wants-warrants of each of the other agencies; improve the effectiveness of law-



ORDINANCE NO. 84-2 ORDINANCE RELATING TO THE MAN-DATORY FINANCIAL RESPONSIBILITY ACT OF THE STATE OF NEW MEXICO; REQUIRING ALL OWNERS AND OPERATORS OF A MOTOR VEHICLE TO CARRY EVIDENCE OF FINANCIAL RESPONSIBILITY:

PROVIDING PENALTIES FOR THE VIOLATION OF THIS ORDINANCE; AND OR-REPEALING ALL PARTS DINANCES OR HEREWITH:

LEGALS

Section 1. Every owner of operator of a vehicle subject to the requirements of the Mandatory Financial Responsibility Act of the State of New Mexico and the requirements of this Ordinance, shall carry evidence of financial responsibility, as defined in the Act and in this Ordinance, in the vehicle at all times while the vehicle is in operation on the streets, public

ways and highways of the

municipality. Section 2. "Evidence of Financial Responsibility", as used in this Ordinance, means evidence of the ability to respond in damages for the liability, on account of accidents occurring subsequent to the effective date of the evidence arising out of the ownership, maintenance or use of a vehicle of a type subject to registration under the laws of New Mexico. Evidence of financial responsibility includes a motor vehicle liability policy, a certified motor vehicle liability policy, a surety bond or evidence of a cash deposit with the state treasurer in the amounts specified-below:

A. twenty-five thousands dollars (\$25,000) because of thereof, heretofore repealed. bodily injury to or death of one person in any one accident:

(\$50,000) because of bodily injury to or death of two or more persons in any one accident;

C. ten thousand dollars (\$10,000) because of injury to or destruction of property of others in any one accident; and

D. if evidence is in the form of a surety bond or a cash deposit with the state treasurer, the total amount shall be sixty thousand dollars (\$60,000).

Section 3. Exemptions. -Exempted from the mandatory financial responsibility provisions of this Ordinance are the following:

A. a motor vehicle owned by the United States government, any state or any political subdivision of a state;

B: an implement of husbandry or special mobile equipment which is only incidentally operated upon the streets or highways within the limits of the municipality;

C. a motor vehicle operated upon a street or highway within the limits of the municipality only for the purpose of crossing such street or highway from one property to another;

D. a commercial motor vehicle registered or proportionally registered in New Mexico and any other jurisdiction, provided such motor vehicle is covered by a motor vehicle liability policy or certified motor vehicle liability policy or other form of financial responsibility in compliance with the laws of any other jurisdiction in which it is registered;

E. a commercial motor vehicle approved as self-insured by the state corporation commission.

Section 4. The office of the Municipal Court shall notify the Division of Motor Vehicles of the Transportation Department of the State of New Mexico of the conviction of any person

BE IT ORDAINED BY THE GOVERNING BODY OF THE THEREOF IN CONFLICT MUNICIPALITY OF CARRIZOZO, NEW MEXICO.

violating the provisions of this

Ordinance. Section 5. PENALTY. Any person found guilty of violating this ordinance shall be fined not more than one hundred (\$100) or imprisoned for a definite term of less than thirty days (30) or by both such fine and imprisonment; provided however, that no person charged with violating this Ordinance shall be convicted if he produces in court evidence of financial responsibility valid at the time of issuance of the citation.

Section 6. SEVERABILITY. Should any section, paragraph, clause or provision of this ordinance, for any reason, be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this ordinance.

Section 7. REPEALER. All ordinances or resolutions, or parts thereof, inconsistent herewith are hereby repealed to the extent only of such inconsistency. This repealer shall not be construed to revive any ordinance or resolution, or part

Section 8. This Ordinance shall be in full force and effect B. subject to this limit for one five days after its adoption, person, fifty thousand dollars approval and publication as provided by law.



Bernalillo County District Judge Thomas J. Mescall, formally announced today his intention to seek the Republican Party's nomination for the position of New Mexico State Supreme Court Justice, eight year term.

The New Mexico juris has two children and resides in Albuquerque. He is a graduate of the University of Albuquerque, John Marshall Law School and the National Judicial College.

Prior to his election as district judge, Mescall served as Chief Assistant District Attorney and Assistant City Attorney before entering into private practice for six years. Mescall was elected to the Albuquerque Municipal Court and later to a 4-year term on the District Court where-he-serves as the State's sole Republican District Judge.

A veteran campaigner, he plans to wage a vigorous orgånized state-wide campaign. Mescall has appointed Mrs. Kay Shollenbarger as his campaign chairman and Jack J. Clifford as his treasurer. Mescall will appoint regional coordinators and establish a campaign committee in each of the state's 33 counties.

In announcing his candidacy, Mescall stated: "Seven years of judicial service has given me the experience and the desire to be a Justice on the New Mexico Supreme Court."

formation, when asked about this retired admiral, explained that they are unaware of any other Naval officer in American history who has been so widely and publicly denounced by his fellow flag officers than LaRocque.

Last summer no less than 440. of this fellow retired admirals took a full page ad in one of Washington's daily newspapers to announce the following:

"While we unequivocally defend his First Amendment rights to express his views, we question Admiral LaRocque's judgement in using a totalitarian state's controlled medium for the purpose.

"To an equal degree, we question the wisdom of the people, both in and out of the government, who rely on selected and biased institutions of quasimilitary spokesmen to oppose initiatives to rebuild the nation's defense.

"As a recent daily publication pointed out, in part, those 'who consistently oppose almost every new U.S. weapons system - while just as consistently apologizing for every new Soviet weapons deployment, may be — and should be — losing their credibility because of that consistency.'

"As a case in point, we agree with the Chairman of the House **Armed Services Committee when** he questions the bias of the Center For Defense Information (a private, non-government organization). in its implied assumption regarding a satellite system; that there is 'no threat to peace that the Soviets have a system deployed as they do, that it somehow would risk a war in space if the United States even tested such a system.' (Congressional Record, House, June 14, 1983, Page H-3907)

"We deplore the attempt of certain officers, without access to the latest classified information, to advance, under the cover of their retired rank, their own biases for the reasoned conclusion of the professional active military officers, who are

briefed daily on Soviet progress in weapons development and

deployment. "We particularly consider reprehensible the use of Soviet television by a retired flag officer, in this case Rear Admiral Eugene LaRocque, Director, the Center for Defense Information, to condemn the policies of the United States, his own country. (Washington Post, June 13, 1983) Time magazine, June 27, 1983)

"We the undersigned believe we are only a sample of the overwhelming majority of lifetime professionals who, regardless of individual views on specific weapons systems, would never, under any circumstances, permit themselves to be used as 'front men' for Soviet propaganda."
