## Youth kills self

Nathan Scott Zamora, 19, of Carrizozo died Friday night, Nov. 6, from a self-inflicted gunshot wound, according to the Lincoln County Sheriff's Department.

Zamora was a 1986 graduate of Carrizozo High School and was employed by ShopRite Grocery in Carrizozo.

Rosary was recited for the youth on Sunday, Nov. 8 at 7 p.m. and Mass of the Resurrection was celebrated Monday, Nov. 9 at 9 a.m. at Santa Rita Catholic Church in Carrizozo with Father Ed Griffith officiating.

Interment was in Our Lady of Guadalupe Cemetery in Carrizozo with La Grone Funeral Chapel in charge of arrangements.

He is survived by his parents, David and Sally Baca; a brother, Duane Zamora; a sister, Luanna Zamora; maternal grandmother Bernadette Zamora; paternal grandmother Raquel Baca, all of Carrizozo; and numerous family members.

Pallbearers were Joey Otero, Charles Zamora, Ruben Zamora Jr., Ray Romo Jr., Pete Narvaez and Robert Guevara. Honorary pallbearers were Daniel Zamora, Donald Zamora, Peter Morales, LeRoy Lopez Jr., Benny and Gaby Zamora.

## Prison escapee sought

Kenneth McCullough, 32, was the subject of an intensive manhunt on the Mescalero Apache Reservation Saturday. McCullough is wanted for murder in Louisiana and is an escapee from the Tennessee Penal Institution.

The manhunt began after McCullough was sighted in the area. Investigation revealed that he had been staying in a stolen motorhome on the reservation. The motorhome was recovered but had been burned by the time it was located.

The Lincoln County Sheriff's Department, Otero County Sheriff's Department, Bureau of Indian Affairs, FBI, State Police and a US Customs helicopter were involved in the search.

The Lincoln County Sheriff's Department reported that the fugitive was heavily armed and very dangerous, but it is believed that he is no longer in this area.

## Hightower concerned about the county's financial condition

Lincoln County Commission Chairman John A. Hightower presented a letter at the Nov. 10 county commission meeting stating that he was concerned about the financial condition of Lincoln County.

In the letter, which was entered in the minutes of the meeting, he states: "We continue to get requests for more money. It is a fact and should be common knowledge to the heads of the departments in the county government that we have no excess cash balance to go to. All of our projected income has been budgeted; therefore, it is critical that the departments stay within their budgets. If you have an unexpected expense, it will be necessary that you make cuts within your budget to cover it. There is no general fund bail out."

Hightower further asked that purchasing procedures be strictly followed, and said the treasurer's office is presently faced with the Alto Paving Assessment District collections.

Concerning the Sierra Blanca Regional Airport, Hightower reminded the three members of that commission (the county commissioners) that, "We passed a one mil levy to match federal grants only and not to be spent on developing the airport. I expect to defend that position vigorously," he said.

During the regular meeting, a letter was received from county road department employees requesting that the commission reconsider the resignation of road superintendent Earl Krieg.

Krieg said that he wished to withdraw his resignation and agreed to continue as road superintendent. Commissioners agreed to reject his letter of resignation and reinstate him as road superintendent.

—The county road inventory was approved with 1,086.7 miles in areas A - F and 304.52 miles in subdivisions. The inventory was certified by the state highway department.

—The county received a request from Ruidoso for base course for the Sierra Blanca Regional Airport parking lot. County attorney Gary Mitchell was to get more information as to the area and amount of base course needed.

—Tony Sanchez of Carrizozo, representing the Clauch-Pinto Soil and Water Conservation District, asked the commission to continue to fund the district and said the money is used for brush control. Clauch-Pinto services Torrance, Socorro and Lincoln counties.

Hightower suggested the district reapply in the spring for the next budget year.

—Agreement with Ruidoso Care, Inc. was approved. The county will purchase a storage cabinet, contract labor and miscellaneous supplies not to exceed \$2,250 and Ruidoso Care, Inc. will furnish meals for senior citizens.

—Lease agreement for the SCS office was approved.

—Steve Massey of the

Southeastern New Mexico Economic Development District (SENMEDD) conducted the public hearing for the Community Development Block Grant (CDBG) program. Requests will be solicited at a future meeting.

—The 11th billing for the Alto Village Paving project was approved in the amount of \$246,076.51 due to McCarty Construction and \$26,428.57

due to Pajo Technical Services for engineering, survey and soils testing.

—Change order No. 7 for a 21-day time extension for the Alto Village paving project was approved. Joe Shain of Pajo Technical Services explained that the paving is complete and the time extension is for work on culverts and manholes. The sand seal and fog seal will be complete next

### 'Sierra Blanca Blues'

## Money for airport a continuing problem

Money continues to be a problem for the construction of the Sierra Blanca Regional Airport that is being built on Fort Stanton mesa. Members of the Sierra Blanca Airport Commission (SBAC) are not in agreement as to where the 10 percent for the local share will come from.

John A. Hightower, chairman of the Lincoln County Commission and a member of the SBAC, stated that he expects to defend the position vigorously that money from the one mil levy assessed on property in the county is to be used to match federal grants only, and not to be spent on

developing the airport.

Excess money from the mil levy is designated to be used for courthouse improvements.

Other money available to be used for the 10 percent match could come from interest money earned on the \$2.7 million bond issue. The bond money itself is to be used for construction.

When SBAC approved the budget the interest money was approved to be used for the 10 percent.

The subject of eligible and non-eligible items, meaning whether costs are eligible for FAA funding, are another pro-

blem for SBAC. The SBAC has not approved final bills submitted by former SBAC attorney Steve Sanders and former SBAC administrator Heckman and Haworth. Both bills were sent to FAA for their decision as to what amounts of both bills do qualify as being eligible for FAA funding.

Installation of a non-directional beacon is not an eligible item, but the cost of equipment will be reimbursed by the state through a special allocation.

The next meeting of the SBAC will be Nov. 18 at 3 p.m. at Ruidoso Village Hall.

## New director for counseling center

Lorenzo Sanchez is the new executive director for the Otero Mental Health Association that provides services for Lincoln and Otero counties.

The not-for-profit agency receives funding from United Way, Lincoln County, Otero County and the main source of funding, the State of New Mexico Health and Environment Department (HED).

Sanchez has a background of 30 years in treatment and administration. Since 1980 he has been at the University of New Mexico in charge of outpatient satellites and residential facilities for the chronically mentally ill.

Prior to 1980 he was executive director of a settlement house in Chicago in charge of a staff of 200.

"The residential program is the biggest need I see at this time in this area," Sanchez said. He plans to open a 24-hour-a-day facility that will be a halfway house and provide respite care for adults suffering from mental illness who do not belong at home.

Sanchez will live in Alamogordo and work in the Alamogordo office, the Ruidoso office and be in Carrizozo, Corona and Hondo for outreach work. The Alamogordo office has a staff of eight and the Ruidoso office has a staff of three.

"Our agency provides counseling for all ages,

juveniles, families, groups, individuals, etc., in all areas of mental health," Sanchez reported. He said the caseload is now at 100 and many of these are seen weekly.

"No one agency can do everything for a person," he continued, "So we will be networking with other service agencies to provide services for the people of both counties."

"We have a strong alcoholism program in Lincoln County," he said, and noted that outreach programs are conducted in the Lincoln County Jail as well as in the twice a month visits to Corona and the weekly visits to Carrizozo.

Emergency services are available 24 hours a day. "We work in all areas of mental health, such as depression, anxiety and all areas of schizophrenia," he said. "Our workers conduct individual, group and family therapy. Dr. Birgit LaMothe, Ph.D., is a member of our staff and is a certified leader of the Active Parenting program at Carrizozo schools."

"Mental illness can hit anybody of any race, religion or belief," Sanchez stated. "We will be working to help overcome the stigma of mental illness and try to educate the people. They need to know that each treatment plan is tailored

to the needs of the person and that each case of mental illness is different."

Sanchez said he will move his family to Alamogordo soon. At this time his wife Antonia, son Victor and daughters Mariseli and Yazmin are still in Albuquerque.

## Voter registration drive begins Nov. 18

"A voter registration drive will be held Wednesday, Nov. 18," Lincoln County Clerk Fran Siddens said Tuesday. "Deputy registration officers will be at all post offices in the county."

The non-partisan service is being provided by the county clerk's office to enable people to register to vote and/or to update their current voter registration.

"We want to make certain that voter registration information for all voters is correct and ready for the upcoming election year," Siddens said.

She noted a change this next year when voter registration books will close on May 10,

which is 28 days prior to the June 7 primary. In previous years voter registration books closed 42 days prior to the primary election.

Jan. 25, 1988 will be the date the governor issues a proclamation designating June 7 as the date for the primary election. Jan. 25 will also be the last date a person can indicate a change of party affiliation on their existing affidavit of registration until after the primary.

Voters may register between Jan. 25 and May 10 but registered voters may not change their party affiliation until after the primary.

## Grant would create a master plan for Capitan

Mark Sawyer, representing the Southeastern New Mexico Economic Development District (SENMEDD), appeared before the Capitan Village Council Monday night to discuss the town's application for a Community Development Block Grant (CDBG) in the amount of \$25,000.

The grant will be used to develop a comprehensive master plan for the village of Capitan.

This would deal with the past, present and more especially the future and would look at goals and objectives with possible modifications.

It would address all infrastructure such as water, sewer, culverts, transportation, traffic signals and safety, land uses and impact of future growth; review all ordinances and make recommendations.

Sawyers reported that 15 engineering firms have expressed an interest in this master plan and more are expected. The cut-off date for resolutions is Nov. 30. The proposals will be reviewed by the Capitan Village Council, a local task force, planning and zoning, and SENMEDD. A point system will be used in selecting the engineering firm.

Mayor Benny Coker advised those present that bids will

be opened Dec. 2 with reference to Phase I and Phase II of the water construction. Coker stated he will meet again with architect Jim French and the state highway department to work out something to solve the water drainage situation on 4th Street.

There has been a \$1,064.00 demand charge a month from Otero County Electric Cooperative with reference to the new well. Mayor Coker is to meet with officials from Otero

# Gwen Jones is EMT of the Month

The departments and personnel devoted to the well-being of citizens of New Mexico are numerous. Their coordination of efforts makes possible efficient, speedy and excellent care for those in need.

In Lincoln County cooperation between fire departments, EMTs and police is outstanding, and often the chief factor in saving lives.

The person chosen by the Lincoln County EMT Association as the EMT for November is Gwen Jones of Fort Stanton.

She was born Gwen McCarroll in Chico, CA, and moved many times during her formative years. She has one brother and one sister. Her father, a carpenter, took his family to the sites of his construction jobs. Gwen received her elementary education in Hawaii. She attended high school through her junior year in Ruidoso, then graduated in Sacramento, CA.

After graduation, she spent a year in Yerington, NV, the home of her grandparents, clerking in a retail store. She moved to Capitan the spring of 1977, and started work as an attendant in Fort Stanton in August 1977. She still works there.

"But now," she said, "I'm a 'Jack-of-all-trades' in General Services. I move from one building to another wherever assistance is needed, be it filling out forms, inspecting for safety regulations, or helping assemble furnishings. The work is varied, never routine, and thus interesting."

Gwen married Edmund (Eddy) Jones, son of Mr. and Mrs. Paul A. Jones of Capitan, in January 1978. They have two sons, Lance 8, in 2nd grade and Justin, 6, in 1st grade. She became a volunteer fireman at Fort Stanton, the only woman in the unit at first, although now there are nine women volunteers. In 1979 and 1980, Gwen attended the State Fire Marshal School.

"In 1981, I was pregnant,"

she said. "I couldn't attend the fire school, so I entered the EMT basic training course given at Capitan. I completed the course June 30, and Justin was born three days later. Six months later, I took the IV intermediate training course."

Gwen is still a volunteer fireman, as are the other Fort Stanton EMTs, Richard Vigil, Frank Romero and Phil Keller.

For four years after Gwen became an EMT, Fort Stanton did not have an ambulance, only Capitan. So she had to transport herself in her own vehicle when a call was received. She took her jump kit and often performed the basics before the Capitan ambulance arrived.

"The most memorable call," Gwen said, "as it was with many rookie EMTs, was my first one. I was awakened in the wee hours of the night to drive to Capitan. Jim Wright and Terry Bussey were already tending the patient, a woman injured in an automobile accident. With trepidation, I hurried to the victim. Thoughts had been racing through my mind before I arrived — 'would I remember to proceed as I had been taught? Could I make a mistake?' But as soon as I set to work under Jim's experienced direction, all doubts left me."

"We transported the patient to the Ruidoso hospital for stabilization, then on to Roswell. On the way home, I realized I hadn't even seen the vehicle or any of the individuals gathered around, only the patient. With that first call, my confidence was built."

"Since then, when I arrive at the scene of a call, I take a deep breath, and in a few seconds, assess the overall scene before proceeding. There are so many factors that might be pertinent to the aid needed. In a vehicle accident, broken glass, gasoline leaking, position of the patient, wedged in or thrown free, how many victims, which appear most critical, etc. Those few seconds

of observation can also be a help to police in making their reports. However, the over-all cursory glance never slows my steps reaching the patient."

One of the most important factors in the prompt, efficient care administered by EMTs is the initial report transmitted to them. It is very necessary to give adequate details of the location and conditions for making the call. Time can be vital. The emergency numbers for each area of Lincoln County are toll-free numbers into the county sheriff's office.

"With the information received at our call," Gwen said, "we are able to mentally prepare ourselves for the work of an EMT. Waking us from sound sleep, or mothering a child, requires throwing a mental switch to the brain work of a medical technician. With the time it takes to arrive at the designated point of our need, we are ready to do our

best in giving service."

Gwen is on call by radio several hours a week. She is very proud of the Lincoln County EMTs, saying, "They are the best volunteer group in the state." She served two years as secretary to the Lincoln County EMT Association.

## Officers elected

# Chamber hears case against consolidation of schools

Election of officers for the coming year was held at the Nov. 12 Carrizozo Chamber of Commerce meeting. Betty Howell was re-elected for another year as president and Phyllis Schlegel was re-elected as treasurer.

Other officers: Rita Narvaez as vice-president, Ruth Hammond as recording secretary, Woody Schlegel as corresponding secretary and a board of directors who will meet once a month with the president and corresponding secretary. The directors are Danny Burnett, Pete King, Glen Ellison and Johnny Anderson. Installation of officers will take place at the Dec. 8 meeting.

Carrizozo school superintendent Danny Burnett spoke to the chamber about

the proposed consolidation of small schools. He said consolidation had already taken place years ago when the schools were closed in Ancho, Nogal, Claunch and Bingham and those students were bused to Carrizozo.

Burnett said he had written a letter to State Representative Maurice Hobson with an outline of issues in opposition to the consolidation. He said he tried to bring out the human element and readily identify reasons to not consolidate.

One reason is that people in the community now donate resources and time to the schools. He mentioned the long bus rides some students now take to and from school and said that consolidation would mean even longer bus rides for students.

Burnett suggested that people bombard legislators with letters stating that they do not want consolidation.

In other business, Phyllis Schlegel reported that donations were still coming in for the Christmas decorations that will be installed on poles on main streets in town.

The new fixtures will cost \$1,433.12 and more than this amount has been donated. Chamber members did not decide if the extra money will go for more fixtures next year or be used for replacements.

Debbie King agreed to chair the Christmas lighting contest. Judging will be held Christmas Eve. First place will receive \$50, second place \$45 and third place \$35.

King said that the first place winner last year was Buster Alford and that he would decorate again this year but would not compete in the contest.

Woody Schlegel said he had a request for Carrizozo to put in a park where RVs could park for no pay with no hook-ups for the night.

Ted Tatum said that this would be in direct competition with businesses that provide RV spaces. Glen Ellison agreed that the three local businesses should get the business. Johnny Anderson asked why a free business should be in the town.

Chamber members agreed that the chamber should advertise the three RV parks and not promote a free business.

Sue Stearns, Carrizozo Woman's Club president, asked the chamber for help in placing large signs at each end of town with a list of stores, churches and other facilities. The proposed sign is part of the Woman's Club beautification project.

Linda Haller, Carrizozo town trustee, reported that the street paving project is complete and the water project is beginning.

### BABY-PROOFING

The average home is a storehouse of unsafe objects for crawling babies. Reduce the common hazards around your house if visitors include knee-high guests.

—Be careful where you set house plants. Some have toxic properties, especially if pesticides have been used.

—Discard plastic dry-cleaner bags.

—Keep the number of your poison control center with other emergency numbers.

—Make sure doors of rooms are unlockable. Place a towel over the top of the door so it can't be shut. Off-limits doors should be kept locked.

—Turn pot handles in on stovetops or use only back burners when possible.

—Set your water heater at low to medium, no higher than 120 degree to 130 degree.

## OPINION

Justice sometimes takes a backseat to bureaucratic snagging in the court system. In Lincoln County we have the case of ranch owner Carolyn Lietzman who arrested two US Forest Service employees for trespassing on her land. The men admitted they were trespassing. Their bosses admitted they were trespassing. That being the case, one would think that charges against the men and the USFS would have some standing in the district court. Not so. District Attorney James J. Weldon, without explanation, plans to dismiss charges against the men and the USFS. Harry Wilcox Jr., senior trial prosecutor for the 12th judicial district, is a member of the DA's staff who volunteered to prosecute Lietzman's claim because he believed she was right and had a valid charge that deserved to be heard in court. Even after Weldon moved to dismiss the case, Wilcox was constrained to write his superior, District Attorney Weldon: "It is my opinion that this action (dismissal) will be prejudicial to the administration of justice. . . . I am constrained to ask you to reconsider, and allow this office to continue its posture in the case." I do not know yet whether Wilcox's request has been rejected or not. It makes one speculate as to Weldon's motive in dismissing a case that appears to have merit, and without explanation for doing so.

That leads to speculation that Weldon does not plan to run for the district attorney's office another term, which fuels rumors around the district that Weldon is seeking a job with the federal attorney general's office after his term in office expires. If so, it may explain why Weldon was so cooperative when the US attorney in Albuquerque asked him to dismiss charges against the two men and the USFS. According to our source, Weldon was anxious to "cooperate with the US attorney" and to not jeopardize friendly relations between the two offices. I cannot vouch for the truth of this opinion, but we will be watching with interest to see if Weldon does accept a position with the federal agency. If so, we can be assured that Weldon's capitulation to the US attorney was for personal gain, and that Carolyn Lietzman was denied justice and her day in court to further that personal gain.

Which brings me to a commentary called Instant Justice, written by Steve Bell. Steve is a nephew of mine, the only relative of record who deliberately impoverished himself by entering the field of journalism. He does scripts for Radio KPLU in Seattle, WA. This commentary deals with instant justice, guaranteed to us all in the US Constitution but denied us by the courts. How long has it been since you've heard the saying, "justice delayed is justice denied"? If one goes to court seeking justice, what he gets is an application of the law. Justice has little to do with the case, and not all laws relate to justice. For example, I know a two-legged swine who deserves, in all justice, to have his arms and legs broken. Justice says yes; the law says no. So the bum lives a better life than the just and the righteous. Well, Steve has something nice to say about courts, but suggests a different approach to achieve justice. Here's Steve:

Our court system is one of the best in the world but far from perfect. Justice can be very slow in coming and sometimes it doesn't come at all. I think all of us would like to see things speeded up, especially with the little day-to-day injustices that, even though are relatively harmless, drive us mad.

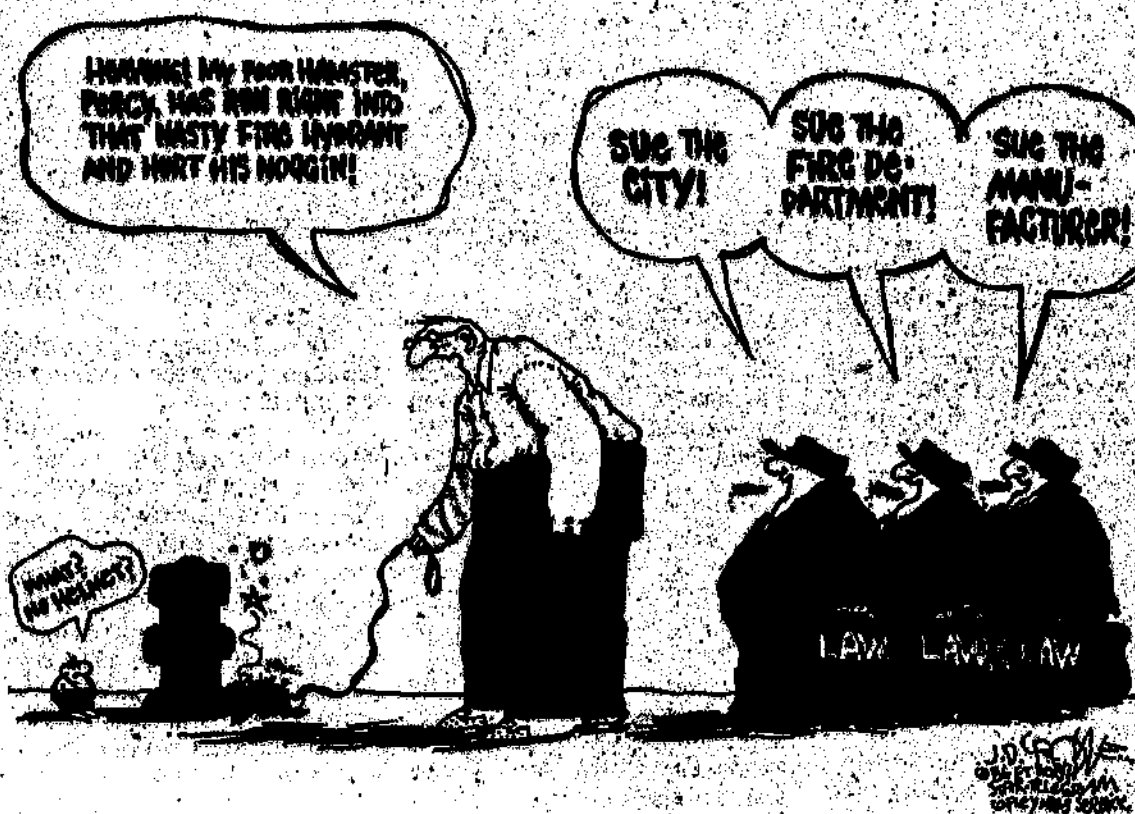
In my fantasy world referees like football refs would infiltrate every strata of society and mete out instant justice wherever and whenever necessary. Here's an example.

Your neighbor is forced to gather up five cubic yards of, of, well I think you get the idea, and deposit it on his lawn for a year or until it bears interest. Are we talking justice? I think we are.

Here's a case I think all of us can relate to easily. It's 7:30 a.m. on Saturday morning and you're sleeping peacefully and having a wonderful dream. As the trade winds blow through your hair the harpist reaches for the golden strings to sound that first chord. But instead the harp erupts with a pugnacious roar very similar to the sound a badly tuned chain saw would make. Your early bird neighbor is getting the worm. The referee, God bless him, launches the penalty flag with outrageous velocity and sternly pronounces, "roughing the sleeper" and ejects Paul Bunyan from the wood pile. Oh yeah!

This is what my world of instant justice would be like. It would be a happy world for considerate people and a yellow nightmare for thoughtless nabobs. I have a dream.



## Inside the Capitol

SANTA FE—I'm going way out on a limb and predicting that George Bush will win the New Mexico Republican primary election seven months hence and will proceed from there to win his party's nomination for the presidency.

PLUSES: Bush has many factors going for him at this point. He got an early start despite having to put his campaign on hold during the Iran-Contra hearings.

He is well organized both nationally and in New Mexico. He is the best organized candidate in the state for either party's presidential primary. With people in his corner such as Colin McMillan, Aubrey Cookman, Rep. Manuel Lujan and Rep. Joe Skeen, Bush is off and running.

The vice-president has already been to New Mexico to raise money and meet many of his volunteers. He is well ahead of his opposition nationally and in the all-important fundraising game.

Bush is an experienced campaigner, having given Ronald Reagan a tough race in 1980. Some of Reagan's backers still haven't forgiven Bush for some of his comments such as the voodoo economics controversy, but most have been very impressed with Bush's loyalty to the president.

Reagan's "11th Commandment" efforts to keep the Republican presidential candidates from beating on each other should work to Bush's advantage more than any other candidate if, in fact, the efforts do work. The first Republican debate among the presidential candidates was a lively affair with everyone but Bob Dole getting in their licks.

Bush's attacks were in self-defense but they were most effective, especially in responding to some of Pierre duPont's barbs.

Reagan also benefits personally if the other candidates lay off Bush since the veep is in the position of defending the administration.

The vice-president, as a candidate, is able to combine business with campaigning. The line between where one starts and the other stops always seems to be hazy enough to lead to arguments but little else.

History is also on the vice-president's side. Every time this century that a vice-president has wanted to make a run for the presidency, his party, whichever it be, has always been willing to oblige by giving him the nomination. That might work even more strongly in Bush's favor with such a big field of candidates.

MINUSES: On the negative side of the ledger, Bush faces some possible dangerous pitfalls. Everyone targets the front-runner and the first Republican presidential debate was a perfect example.

In uncharacteristic style, Dole appeared to be the peacemaker and tension reliever. As the second strongest in the race, Dole may have felt he could let the other

four candidates go after Bush and remain somewhat above it all, himself. Or, may he was just relieved he wasn't the one on the hot seat.

Since Alexander Haig is leading a rather successful effort to make toughness the major campaign issue this year, Dole needs to worry that his performance isn't seen as too laid back.

Haig has been brutal to Bush on the toughness issue. He turned the "loyalty to the president" virtue, which Bush proudly drove home to a cheering audience, around on the vice-president by offering that loyalty is not always telling the boss what he wants to hear.

But the sharpest attack by Haig was when he found a way to get the wimp issue before the audience.

Haig opposes the prospective treaty to ban intermediate weapons. Bush accused him of supporting the same idea in 1982.

Haig replied, "If you recall, I fought it like the bloody death but I never heard a wimp out of you."

## Reminiscences of Lincoln County and White Oaks, Part 2

# Getting to Las Vegas from the Capitans, rough going in 1886

George M.T. Fowler wrote this series of early-day adventures to the editor of the Lincoln County Leader, published by William Caffrey. This part appeared in that newspaper on Feb. 8, 1890.

This is the second of three episodes describing Fowler's adventures in Lincoln County a century ago.

In Part 1, Fowler and his group had stopped in the Roswell area, where they were successful in drilling the first good water wells in the valley. They then moved farther west, spending Christmas 1886 in the Capitan Mountains in the employ of the El Capitan Land & Cattle Co.'s logging camp, and with Andy Richardson as Boss.

Most all the boys that came with us from Texas found employment at the sawmill up in the foot-hills of the Capitan Mountains, which was owned by the El Capitan Land and Cattle Company.

Our father had taken the contract of boarding the sawmill hands, about ten in number, all of whom were lank, hungry kind of fellows; and it was like pouring grub into a sink hole to feed them. Andy Richardson, the boss, could eat as much as any four of the other boys. Andy was a jolly, old fellow, and was powerfully stuck on a Mexican senorita down at Las Tablas, near by the mill, and was loving a semi-American over

about Stanton, probably living across the road from Antonia Torris. Ta, ta.

Grub went down the guzzles of those mill hands so fast that we thought best to buy by wholesale at the railroad. So, on the 11th of October we were dispatched to Las Vegas for a four horse load of supplies. Having never been there we were somewhat puzzled as to which way to start, but finally lit out up through the Jicarillas. Here the roads forked and we took the left hand one which finally led us toward Washington Territory. Not knowing whether we were right or wrong we kept on hoping to meet some one who could tell us; but in vain we looked until one day while driving through the forest, among the high mountains, we stopped to slake our thirst from a little rapid mountain stream having had no water for two days, when some Mexicans near by told me the little stream was the head waters of the Pecos River. Again I was puzzled; couldn't talk Mexican, nor didn't know where I was; but anyhow I knew that I explored lots of New Mexico and perhaps some of Colorado before I finally reached Vegas.

We had to let our team rest a few days before we could undertake the perilous journey back, so you see we had time to take in the city. One night we heard some people shouting, as we thought, like what we had heard in Texas, and so we started up to enjoy the meeting; when lo and behold, it was a Mexican candidate for some Territorial office,

## Mismanaging the money

If it can prevent turbulence and panic (and who really knows?) is it ridiculous to conclude that the Fed also possesses the power to cause turbulence and panic? If they can really manage the money system "scientifically," who are we to conclude that they are not following a well-planned blueprint?

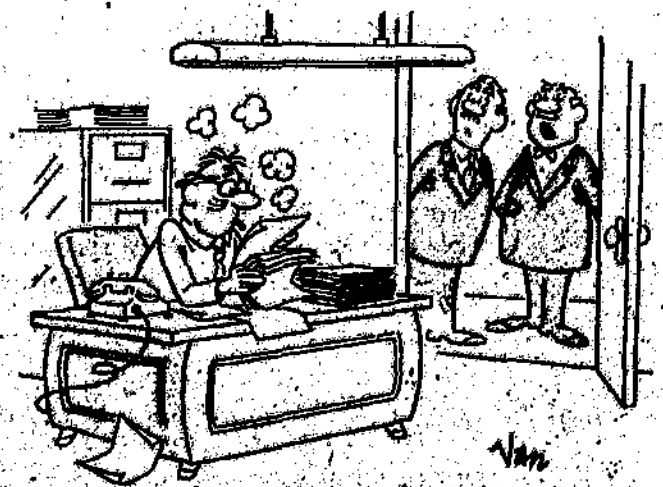
Yes, a great string of them came riding up to me on the

## Corona Cardinals fight way to state championship play

The high-flying Cardinals of Corona will play in the six-man football state championship game Saturday at 1 p.m. at Lake Arthur.

The Corona team earned the playoff spot after decisively defeating Roy last Saturday, 50-24.

The Corona clan played an efficient game both defensively and offensively, capitalizing on Roy errors, proving that the Cardinal team had improved considerably since the first meeting in September when Roy defeated the Cardinals, 28-18.

Corona began the game by blocking a low Roy kickoff at the 33 yard line and moving the ball to within the 20. Roy's defense held and Corona had to turn the ball over; but Roy's possession was short-lived as the ball was fumbled on first down, setting up a Tom Mulkey score on the next play.

Roy again suffered on the ensuing kickoff when Corona managed to confiscate the ball at the 25 yard line. Cardinals couldn't make the first down and had to punt; but on the next series of downs, Roy again fumbled and Corona recovered. Heath Brown caught a Mulkey pass for 6 more, and the kick was good for a 14-0 score at the end of the quarter.

Second period play proceeded with Roy unable to put together a drive; Corona got the ball on the 40 and moved downfield to the one foot line. After a timeout, Mulkey ran up the middle for a 20-0 tally. Roy came back with an explosive play that allowed a TD on a long run.

After the kickoff, Corona took possession on its own 3

yard line and moved it to the 9. Corona offense then detonated its own explosives, setting free Mulkey for a 71 yard scamper to paydirt.

With 5:23 remaining in the half, Corona's defense continued to hold, forcing a Roy punt. The offense again supplied some fireworks when Mulkey caught in the backfield, flipped the ball to an alert Dan Bell who ran down field for another Cardinal TD.

The half ended with Roy down by 28 points, making a first down on the Corona 38 yard line.

It was more of the same in the second half, with Corona moving the ball in the air and on the ground. Chad Brown caught a long Mulkey pass and Bell took it into the end zone three plays later.

Roy received an im-

pressive Corona kickoff and then took a 15 yard penalty that put the ball on their own 9 yard line. Roy held together and scored, making it 38-12.

Corona punt on next possession and watched Roy move within the 15 yard line before Bell greeted the Longhorn quarterback at the 20. Again, Roy was able to regroup and go in for a TD.

The Cardinals moved downfield from their own 15, then went in from the 5 yard line after two crucial Roy penalties. Corona ended the quarter by recovering another Roy fumble.

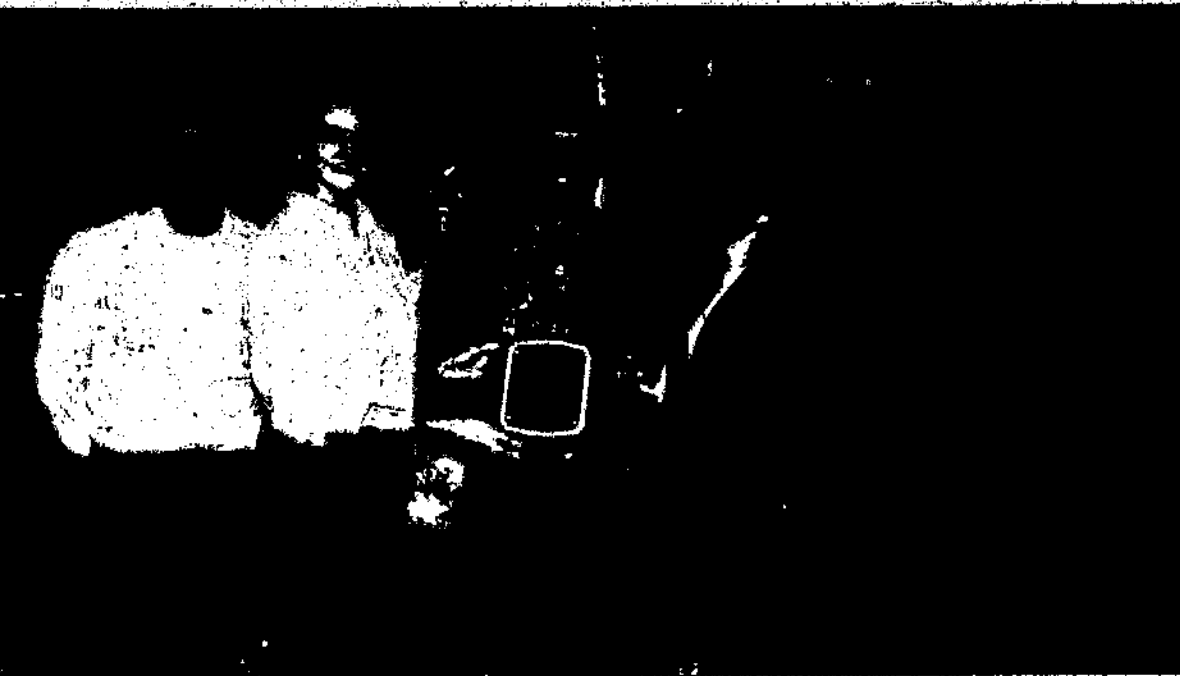
