Taxes may increase to pay for trash, equipment, and EDC/LC

Lincoln County property tax owners may be faced with a three mill tax levy to help pay for sanitary landfill costs, road department capital outlay needs, and economic development within the county.

The matter was discussed during a public hearing Monday. County commissioners Bob Hemphill and Karon Petty told the audience the county needs \$760,000 to meet the needs expenses. The county landfill

Lincoln County (EDC/LC) has requested \$130,000 this year from the county. Last year commissioners imposed a one-half mill levy to fund EDC for one year.

Earlier this year Petty had proposed a one mill levy with one-eighth mill to be used for economic development and the remaining seven-eighths mill to be used by the county for the landfill and road department.

According to figures presented at the June 26 meeting, one-eighth mill would generate \$35,000. EDC president Buddy Bundick and EDC executive director George Puckett asked commissioners to consider continuing the one-half mill funding for EDC. They explained EDC has actively pursued industries and businesses for all of Lincoln County which would help the tax base for the county

EDC board member Scott Shafer told the commission. "In my opinion, we (EDC) can continue to function effectively if funded one-fourth mill " He asked commission ers to consider one-fourth mill for economic development and three-fourth mills for other county needs. Action was tabled to the next meeting. Petty and Hemphill agreed that any tax imposed should be decided by all three commissioners. A decision should be made at the July 24 meeting because Santa Fe has requested mill levy information be submitted by Aug. I.

Approves budget, hires Beauvais and signs road agreements

Lincoln County Commis- ment is for the state to fund meeting. The final budget is \$686,171 more than the preliminary budget adopted May 30. A major change in the budget was the Alto debt service for debt service and interest in the amount of \$508,538. The preliminary budget had no debt service listed. After the final budget was approved, commissioners approved a resolution decreasing the amount of debt service by \$147,778 and \$4,467.23. Other increases in the budget were for audit, salaries, PERA, worker comp insurance, property insurance, special services for reappraisal fund, postage, advertising, mileage, professional services for the solid waste study Community **Development Block Grant** (CDBG), equipment maintenance, training, and construction in the Alto area paving district. Changes were approved for beginning cash balances and revenues for landfill gate fees, CDBG monies received, fire allotments increased, two-cents cigarette tax, onecent cigarette tax, and CDBG grant money awarded after interim budget. **Budget** adjustments included budget increased due to actual ending cash balances for fire departments, and the decreases for the Alto area paying assessment district. Road agreements with the state highway department were also approved. The County Arterial Program (CAP) will install culverts and base course to Magado Creek Road. The CAP is for the state to pay 75. percent of the cost while the county pays 25 percent. The school bus agree-






When asked why she joined EMS, Terry said, With three children at home and living so far away, I thought I needed it. Then as I



• China is top news today. On Jan. 1, 1979 President Jimmy Carter officially recognized China while at the same time withdrawing recognition of Taiwan, our valued ally. This decision of the president, made without consultation with congress, touched off the usual tirades of disagreement with the president's action. I was no exception. The following comment was made in this column on Jan. 4, 1979. Now, 10 years later, would you agree that the column was a bit prophetic?

Official US recognition of China is the biggest thing since the pet screw or even the skateboard. Anything smacking of China will dominate every phase of our culture this year, or until the first betrayal by the Chinese communists, whichever comes first. China was dragged through our city gates, like the Trojan Horse, in the dead of night. It was done by our Great President who once said he would never conduct the nation's foreign policy in secret. And it wasn't kept totally secret. There is the president of the Coca-Cola Company of Atlanta, Georgia, who is a dear and close friend of Mr. Carter. Just by coincidence, I'm sure, the president of Coca-Cola was able to announce his company's exclusive distribution franchise for Coke in China on the same day his good friend and our Great President announced the recognition of China. It is fair to assume that Mr. Coke knew of the impending recognition of China, else how could his company know to begin negotiations early enough to have the deal completed on the same day China was recognized by the US?

• Not many people are going to believe that the Chinese have done a 180-degree turn, politically or culturally. Or that overnight the Chinese can joyfully embrace blue jeans, disco dancing, Coca-Cola, love marriages, humor, jewelry and free speech. A culture that has been withdrawn from the mainstream of civilization for a thousand years isn't likely (except on command) to clasp to its breast the fabulous (and the foolish) culture of the West. Of course, the Chinese people were ordered into blue jeans, and to ape Western hoopla. And what do the rules of China expect in return for having their culture polluted? Well, the first installment appeared in Tuesday morning's San Francisco Chronicle. China wants \$36 billion in economic aid from the US, which is just for openers. Americans still believe they can buy an entire nation's love and respect, even with a dangling dollar. The Chinese knew we can't, but they play the game. They didn't become known as "inscrutable" for nothing.

• Just about the time I calculated the American people had run out of fads and notions with which to be temporarily obsessed, along comes China. Presto! A whole new world of the ridiculous looms before us, practically unsullied. First, the fashion designers are abready at work to bring the New Chinese look to discerning American women. Soon those black, baggy transers will be the fashionable rage among millions of the disco-delirious. Without these shapeless cotton crawers no woman can be expected to be stylishly dressed or to exhibit political class, and they will be available in all leading shops for only \$149.95 per drawer. The slanted-eve look will take off like a Chinese skyrocket (what other kind). Our long-suffering Children of Mao, who haven't had a good ideological orgasm since they blew up the last PG&E substation, will even bind up their feet to demonstrate solidarity with Mother China. The country will be covered to a depth of three feet with billions of those combination chopstick and assscratchers, exquisitely fashioned from bamboo at a cost of 2 cents each and sold at US outlets for \$14.95 plus tax. This is the way we hope to get back the \$36 billion in economic aid we have to pony up to the Chinese as partpayment payoff for the privilege of being permitted to recognize them as a nation. The Chinese langauge will be offered in public schools, with families receiving federal subsidies to enroll their children. It will be all the rage in adult education classes, financed by the federal government.

Bureaucracy runs wild while Ruidoso citizens slumber

Residents of Ruidoso may be facing a lack of domestic water, or they may be facing expenditure of millions of dollars to construct a pipe line—or both.

The dilemma arises over construction of a proposed golf course that would require 200 acre feet of water to adequately support the world-class golf course.

At a public meeting June 16 the. Village of Ruidoso council, through its manager, Mr. Potter, told an audience that water required for the golf course would come from an "effluent credit." This is a term coined by agreement with the State Engineer whereby a portion of the effluent water from the sewage treatment plant would be credited to Ruidoso for removal from the Ruidoso River in the upper canyon. Several restrictions are contained in the agreement which makes removal of this water impossible.

At the public hearing, the village manager was asked what would be the source of the 200 acre feet of water needed for the Jim Colbert Golf Inc. proposal golfcourse. The manager told the audience that the water would come from the effluent credit amount granted by the State Engineer. He also said no other sources of water for the project would be involved.

The village plans to drill a well to furnish water for the course. But . . .

No approval had been obtained by the village from the State Engineer which would allow the effluent credit water to be applied to a well yet to be drilled on the golf course. If this well does not produce the required 200 acre feet of water, one of two things would occur:

First, water could be diverted from Ruidoso's present domestic water supply.

Second, a pipeline and pumping station would be constructed to pump effluent water from the Ruidoso River, about eight miles away, at an estimated cost of several million dollars.

If a pipeline is constructed it will have to be financed by bonds, and tax increase, and Ruidoso already had one of the highest tax rates in New Mexico. There is also a possibility that Ruidoso is already taxed to limits set forth by the state.

Ruidoso citizens are advised to probe this problem thoroughly before embarking on what could be a disaster for the community.





It is beginning to appear as though signing a treaty of friendship with the US could be hazardous to one's national health. Well, what the hell. What are friends for if not to betray once in a while.

LAWMAN EXECUTED

How times change. Today motorists can attempt to threaten or bride a law enforcement officer over a traffic ticket. During the 1880s outbursts of gunplay in the streets was the biggest worry. Many times the person on the other side of the gun was not a mugger but a crooked cop, selected or elected.

Town fathers soon had toquestion their wisdom in hireye on a pretty widow. Harry Brown, son of a former Tennessee governor, also shared the attention of Sadie Preston.

LOCAL CUSTOM

Yarberry called his rival

or carried in plain view. Upon entering a saloon the about the small town police- rule required guns to be checked with the bartender. The opinion on the spat over a girlfriend was that if

Brown had not carried a pistol, it was his own fault.

TRIGGER HAPPY

Later, Yarberry was involved in another fatal incident. He was patrolling the streets and heard a shot. He demanded to know who had fired a gun. Someone pointed to a man who had the misfortune to be strolling by. Yarberry shot and killed the man, then danced and shouted gleefully: "I've

downed the SOB!" Again the town marshal entered a plea of self-defense. Yarberry was convicted of murder and sentenced to die by hanging. About 100 Albuquerqueans, to speed justice. assembled to plan a lynching. The condemned man was taken to the Santa Fejail for safekeeping.

JERKED TO JESUS

On Feb. 9, 1883, Yarberry made his last ride to Albuquerque's county jail. Citizens had been sent invitations to the hanging. Others paid up to a dollar for standing room on nearby rooftops. A carnival-like atmosphere prevailed.

Still protesting that he had killed in self-defense the marshal was outfitted with a black hood and noose and "jerked to Jesus" as the press of the 1880s bluntly put it. The body was buried with the rope still in place. Yarberry's

hanging was the first and

last execution of a peace officer in the New Mexico Territory.

The program is updated periodically to assure the USDA's soil and water conservation programs are responsive to the nation's conservation goals; increaslong term needs.
