

# Roofing Permit Oversight Proves Costly

A Ruidoso village ordinance regulating and restricting the use of wood shingles in the village was put on center stage at the November 24 village council meeting.

Because his contractor failed to obtain a permit for an \$8,000 new roof on a three-story luxury home at 509 Snowcap Drive, that oversight will prove costly to owner Sam Spencer of Roswell and Ruidoso or to his contractor.

Roadrunner Roofing Inc. represented by Rick Furr admitted to the council that the company failed to obtain a building permit. His roofing project was red tagged recently when a Ruidoso builder reported the apparent illegal extensive use of shake shingles in the reroofing project.

The roofer had completed some 20 to 30 percent of the project, using shake shingles, when the job was red tagged by the village. The village considers none-rated wood shingles a fire

hazard.

The job was contracted a year ago when a small area of the roof was repaired and the rest delayed until recently.

The village ordinance in essence says that all wood shingles on a home must be replaced if repairs to such a roof runs over \$500 in cost or if a certain percentage of shingles need replacement because of damage or leakage.

The council voted last week to force Spencer and Roadrunner to comply with the ordi-

nance. Apparently a rated substitute type shingle will have to be used throughout.

In other action, the village council last week:

—Voted to eliminate the crosswalk at the Ruidoso Post Office.

—Heard that water loss in village water lines has been reduced from some 40 percent to ten percent or less. Ten percent through leakage is considered normal for a system, the village manager reported. The village has been using leak

detection equipment on village lines.

—Approved two liquor license transfers, one from Rainbow Center to Ruidoso Bowling Center, the other requested by Texas B-G to be used at the Texas Club, 212 Metz Drive.

—Authorized refinancing of airport bonds (authorized an underwriters agreement) to provide funds for purchase of T-hangers and to generate funds beyond those needed to retire the bonds, for use in the general

fund. Bond life was extended to 20 years. Some \$3 million is involved. The interest rate is expected to be considerably lower than currently.

—Passed a resolution to be sent to the State Highway Department, calling for improvement of the road to Ski Apache.

—Authorized the village purchasing agent to determine what advertising is necessary

## Talks Begin For Design Firm Contract

At 10 a.m. today (Thursday, Dec. 3) members of the Lincoln County Solid Waste Authority (LCSWA) will meet to discuss a contract with a landfill design firm.

LCSWA members will gather at the recycling center in Ruidoso Downs to discuss the negotiated contract with Camp Dresser McKee of Albuquerque to draw up engineering designs for the proposed regional landfill. LCSWA members met with members of the Otero County Solid Waste Authority (OCSWA) on Nov. 19 and decided a 640-acre site about 21 miles south of Alamogordo near Orogrande as their first option for a regional landfill. The second option was a site in the Three Rivers area.

In a series of meetings with the OCSWA, LCSWA has established its full 50 percent status in the regional landfill project. The two authorities are made up of representatives of every municipality in the two counties and representatives from the two county governments. During the Nov. 19 meeting of the LCSWA and OCSWA in Tularosa, the two groups agreed to negotiate with Camp Dresser McKee, picked as the favorite of several firms which submitted proposals.

The Orogrande site is located on state and Bureau of Land Management properties and has the deepest ground water. Its major drawback is the distance to Lincoln County. OCSWA chairman Don Carroll said, in an article published in the Alamogordo Daily News, his group is committed to working with LCSWA to arrive at a mutually agreed sharing of the transportation costs.

The secondary site, located near Three Rivers, 25 miles north of Alamogordo. Ground-



## Ruidoso To Buy Grindstone Land

The village of Ruidoso apparently will take title to 220 acres of land around Grindstone Dam in the near future. Village council members at a regular meeting Nov. 24 voted to purchase the property from FDIC for \$450,000, a sum that will come out of the water fund, according to Mayor Victor Alonso.

Details leading to the purchase were worked out in closed sessions of the council.

"We felt it needed to be kept in executive sessions," Mayor Alonso said at the meeting. Village manager Ron Wicker sees no difficulties in getting approval of the purchase from the state Department of Finance and Administration or from FDIC.

Councilman Ron Andrews said he wanted to go on record as opposing the purchase.

Wicker said the action will provide legal road access to Grindstone Dam and will provide land for a water treatment plant and distribution system.

The village already owns 46 acres where Grindstone Lake and the dam are situated. The Grindstone Subdivision has been in limbo since the original developers filed for bankruptcy.

In other major actions at the Tuesday night session, the council set the process in motion to possibly annex property along both sides of Carrizo Road from the village limits to Carrizo Lodge. And the council went back to Square 1 in considering a mass transit or shuttle bus system for the village.

The Carrizo Canyon annexation possibility came about when James Porter, of the Carrizo Condo Homeowners Assn. and C-Net Resorts Inc., asked to be tied into the city water system.

Council members voted to proceed with possible annexation.

"This is just a beginning," the mayor said. Public hearings, extensive negotiations over details with C-Net and other considerations will be thrown into the hopper before annexation can occur. A three-person Municipal Boundary Commission, to be appointed by the governor, will be involved. Mayor Alonso said he would favor property owners, if annexation occurs, having the option to utilizing their individual water wells or hooking on to the village system. The question of whether the village would acquire existing water rights if the properties are annexed has to be worked out. Existing sewer lines would revert to the village.

Lore served on the Bank of Ruidoso board for more than 10 years and his contracting business was involved in the remodeling of Ruidoso Downs Race Track in 1989.

## Smokey Bear's Story Taped By USDA In Capitan Tuesday

Perhaps one of the most successful ad campaigns ever conducted turns 50 in 1994.

The cartoon image of Smokey Bear has promoted the Fire Prevention message since the end of World War II in 1944. The Smokey Bear program grew from a war-time effort to prevent any fires destroying vital timber interests to become a popular image promoted by the U.S. Dept. of Agriculture, Forest Service. While Smokey was a popular cartoon type image, he lacked a "living symbol" in the form of a real bear—until 1950.

In May, 1950, a fire roared up Capitan Gap in the Capitan

Mountains of Lincoln National Forest in Lincoln County. After the fire had swept past, a small bear cub was found by firefighters. The cub was singed and his feet burned.

Realizing the future potential of saving the bear to become a "living symbol" of the fire prevention bear, New Mexico Game and Fish Officer Ray Bell, who also was involved in the fire, took the cub home to Santa Fe. The cub was treated by a vet and with the help of Bell's wife Ruth and his daughter Judy, his life was saved.

That story and other reminiscences were shared by Bell, Bob Earl, Paul Jones, Dorothy Gray Guck, Harlow Yager, Sam Ser-

vis and Peg Pfinster, who all were involved with the Capitan Gap Fire. It was in the burn area of that fire that the little bear cub which was later to become known as Smokey was found.

Also interviewed were Kay Flock, regional Forest Service Supervisor in Santa Fe in 1950; Homer Pickens, director of Game and Fish then and J. Morgan Smith, assistant director in the Cooperative Forest Fire Program in Washington D.C. in 1950.

To document the history of the Fire Prevention Program, a film crew from the USDA office in Washington D.C. and contract producer Ann Carroll

traveled to Smokey Bear Historical State Park in Capitan to record the old-timers stories on Tuesday, Dec. 1. After the morning taping session, the crew and old timers traveled out Pine Lodge Road, which runs to the north side of the Capitan Mountains, and taped views of the old fire scar from the Block Ranch, near the Gap.

A 12-minute video of the interviews on the History of the Fire Prevention Program has been funded by, and will be produced for, the USDA-Forest Service to issue in the spring. Carroll was so impressed with the great amount of footage taped in the interviews that she wants to produce an additional 20-minute video. The videos will be sent to Smokey Bear Park in Capitan and to those interviewed.

The Forest Service came to USDA for use of its camera crew to tape the interviews, said cameraman David Black. He and sound person Susan Guss manned the video and sound equipment during the session.

Once producer Carroll got the old timers started on their memories, she had no problem keeping them going. Even after they had been taped, the old timers continued to reminisce.

They remembered Smokey's story of being found in the burn area, his trip to Santa Fe and finally to Washington D.C. to become the "living symbol" of the Fire Prevention Bear.

Smokey lived at the National Zoo in Washington D.C. until his death in 1976. His body was flown to Capitan and buried on the grounds of what was to become Smokey Bear Historical Park. With financial help from late Congressman Harold Runnels and the New Mexico State

# Supreme Court Rules In Favor Of Ruidoso

The New Mexico Supreme Court has unanimously upheld a decision in favor of the Village of Ruidoso in a suit by dissatisfied developers. The developers, Roy Wayne Dacy and Sandra Dacy, claimed that the Village had promised to zone for condominiums some land given to them in a swap with the Village, but it had violated the agreement.

Had the Dacys prevailed, the trial court said damages would have been \$255,173.

The Village's attorney, David A. Thomsen, argued before the Supreme Court that if there was a contract to zone land, this violated the rights of the public to be heard during the zoning process. The Court agreed, saying "By making a promise to zone before a zoning hearing occurs, a municipality...commit(s) itself to certain action before listening to the public's comments on that

action." Since the law requires a public hearing, such a contract is illegal, said Justice Seth D. Montgomery in the opinion.

Ruidoso Mayor Victor Alonso said that he was "glad the courts emphasized the right of the public to be heard. Zoning, like other actions, requires as much public input as possible."

The Village in 1983 traded land on Gavilan Canyon Road with the Dacys for some land near the "Y" at Sudderth and Highway 70. The Dacys petitioned to have the land they received zoned as R-2, allowing its use as condominiums, and the Village Council refused. The Dacys then sued, claiming that the contract for the exchange included a promise by the Village to zone as they had requested. Village attorneys Ron Harris, and later H. John Underwood, argued that there was no such promise. After two hearings, District Judge Sand-

ra A. Grisham ruled that such a promise was unenforceable.

Thomsen, presently providing legal services to the Village by contract, praised the Supreme Court's reasoning as well as the outcome. "The Court here gives guidance to municipal officials," Thomsen said. "The opinion goes beyond merely 'yes' or 'no'. We have some clear guidelines from our Supreme Court on what zoning actions will be permitted and what will not."

Fire and police protection were cited as pluses for property owners if annexation occurs. Taxes would increase from 23 mills to 38 mills, Mayor Alonso said. Owners of a \$45,000 home would pay about \$225 per year in taxes, he said.

Regarding mass transit or shuttle bus service, only one responder surfaced when the village requested proposals for a feasibility study. Some \$5,000 had been allocated for such a study. The council now has nullified any such plan for a study.

At the meeting last week, the council voted down a proposal for creation of a "Selection Committee" which would have determined if the sole responder was equipped to complete a feasibility study.

However a public hearing was set for January 11 when residents, including lodgers, will have an opportunity to provide input. Council person Barbara Luna said the village needs to look far into the future in weighing the advisability of having a public transportation system.

Councilman Ron Andrews said he thinks a study will show that some private funds would become available to provide a transportation service. He cited systems that are working in Melross, Hobbs and Carlsbad.

water there runs from 250 to 80 feet, according to an engineer's report.

According to the article, a large group of citizens present at the Tularosa meeting voiced no protest to either site.

The next steps in the landfill process will be more intensive studies of the site, such as archaeological, endangered species and types of soils. The studies will be required as part of the permit application. After filing for permit, public hearings will be held.

Today, members of LCSWA are meeting to discuss the negotiated cost of the Camp Dresser McKee contract to handle the permitting process through the state and manage construction of the actual landfill. An argument arose with the City of Alamogordo at the Nov. 19 meeting concerning which agency has the authority to negotiate the terms of the contract with CDM. Alamogordo reportedly wanted to conduct the contract negotiations, have the contract signed off by the chairmen of LCSWA and OCSWA then have CDM begin work on the landfill.

The groups finally settled on having Alamogordo negotiate, then the terms of the negotiations sent back to each authority for final approval.

A meeting of the LCSWA and OCSWA will be held at 6 p.m. Thursday, Dec. 17 at the Ruidoso Civic Center. The public is invited.

LCSWA will conduct its regular meeting at 10 a.m. Monday, Dec. 21, at K-Bob's Restaurant in Ruidoso. Following the meeting the group will have a luncheon to celebrate the holidays.

### Accident At Intersection Injures One

Rene Archuleta, 21, Carrizozo, made a southbound turn in her pickup onto Highway 54 off Highway 380, when her door swung open. She reached out to grab it, hoping to close it, when she fell out onto the street. The truck continued on without her about 200 feet and finally stopped when it hit the Crossroads Motel sign.

Archuleta sustained minor injuries and was transported by Carrizozo ambulance to Lincoln County Medical Center in Ruidoso where she was treated and released. Officer White cited Archuleta for no seat belt, careless driving and open container.

the charge of disorderly conduct. As a result of their pleas, the judge sentenced each to 30 days in jail and a \$250 fine, which he suspended. Each of the offenders must perform 50 hours of community service around Carrizozo within the next 90 days and will be on six month probation.

At 12:47 a.m. Thursday, Nov. 27, an anonymous person called into the Lincoln County Sheriff's Office in Carrizozo and reported a loud party with juveniles and liquor. The location was listed as across the corner from the Baptist Church.

At 1 a.m. White issued 11 arrest citations based on the state statute charge of disorderly conduct for each. One juvenile, at whose residence the party occurred, was referred to

juvenile probation office.

Each also must pay the mandatory \$30 court fees.

# AI's Musings

There are dog houses and then there are dog houses. Among items new pet owners must consider, according to the Animal Shelter people, is an insulated, warm house for canines.

Son Chuck and wife, Judy, recently moved from an apartment in Albuquerque to a home east of Tijeras. What they may not have realized is that the altitude in the Montezuma Subdivision is over 2,000 feet higher than Albuquerque. And wind currents and weather factors on the east side of the upswep Sandias somehow create more snow than what would seem normal.

Chuck, realizing that the lab he's had for a long time and another lab he recently acquired, both big dogs, needed warm sleeping quarters.

We couldn't believe the canine mansion he had constructed when we saw it over Thanksgiving.

Probably five and a half feet tall, eight feet long and five feet wide, the double walls have insulation between them, four inches of it. The flat roof and the floor are insulated. Weighing about 700 pounds, it is constructed so that it can be disassembled quickly and moved.

That may be common enough. But, a skylight? Yep, it's got that, plus a portable electric heater and indoor-outdoor thermometer.

Yep some canines have it lucky.

The antelope we saw between Willard and Corona coming back to Lincoln County, Saturday, didn't have such shelter. They wouldn't have fitted into a barn because there must have been 200 of the animals along the highway in four or five herds. We've never seen so many antelope in one location. Question? If there are 200 grazing along the highway, how many are back in the foothills? We may be overrun with antelope. Hunters would be happy to fill them out.

Snow doesn't only happen in mountainous country. Some of the "regulators" who have coffee every morning at Sun World spent Thanksgiving in Texas. They reported eight or nine inches of snow on the ground between Caprock and Tatum. That's flat ranch country. Where did all the snow come from?

Well, the Caprock can have severe weather. Years ago, John Barnett, who then owned KSWB-TV in Roswell, boasted the tallest man-made structure in the world. It was a TV tower sitting atop the caprock and standing 1,800 feet tall. Along came a super ice storm, and, zowie, the tower collapsed on a cold winter's day, virtually crushing the building at the foot of the tower. No one was injured

or killed, but they were lucky, considering what happened to that building.

Yep, the weather on the fringe of the staked plains can be wicked. Just be glad you didn't live in the last century and had to ride horseback through such weather to get from one place to another. Pioneers were tough.

Now that the village of Ruidoso is about to acquire title to the 220 or so acres of Grindstone Subdivision, we wonder what will happen to "excess acreage" after the village allots 120 acres or more for a water treatment plant, access roads, etc. Village manager Ron Wicker says that probably, under state statutes, the excess will be sold off via the bid process. There are some beautiful building lots above Grindstone Dam, complete with utilities installed. Some of the roads need much work to become first class. Developers of the subdivision went belly-up, giving the village an opportunity to eventually provide a super water source for an expanding area. Good news.

Mayor Victor Alonso has named three men to the Highway 48 Advisory Committee. Approved by the village council were Alan Briley, Wyatt Sparks, and from the council, Frank Cummins.

Highway 48 widening and improvement will bring about many problems. Recommendations by such an advisory committee of people directly involved should prove invaluable.

## Light Up New Mexico Day Is December 11

New Mexico Governor Bruce King has proclaimed December 11 as "Light Up New Mexico Day." This special day is for the people of New Mexico to join in lighting living Christmas trees. Together they will send a message of peace and joy from the state out to the world.

It is also a celebration commemorating the lighting of the first "Living National Christmas Tree" that was sent to Washington, DC from the Carson National Forest and lighted December 11, 1991. The National Tree was decorated with ornaments handmade by people throughout the state. The transportation costs for the 60 foot blue spruce came from donated funds.

In an expression of pride and good will, more than 70 municipalities in New Mexico lit their living Christmas trees at the same moment as the lighting ceremony in Washington last year. For this holiday season, many other communities are planning to plant and light a living Christmas tree. Individuals, organizations, groups, schools and families are invited to take part in this event by obtaining a living Christmas tree to light up at sunset on December 11, 1992.

Another chapter of the story...The National Living Christmas Tree was planted in the National Arboretum in February 1992. A commemorative plaque will be placed near the tree by New Mexico Federation of Women's Clubs in February 1993.



# Inside The Capitol

**SANTA FE**—Lawmakers past and present are converging on Santa Fe this weekend to rededicate the renovated New Mexico Capitol Building.

It promises to be a festive event as the 25-year-old, asbestos-free Capitol with cherrywood trim is officially reopened for business. Actually the remodeled building hosted the 1992 Legislature last January and February but workmen in hardhats were always in the background and moved back in full scale as soon as lawmakers left town.

Most everything has been complete for the past few months but legislative leaders were waiting until Santa Fe's tourist traffic lightened up and left some hotel space in town.

As luck would have it, the snow on Santa Fe's ski slopes, which is often almost nonexistent at this time of year, has fallen by the yards, attracting tourists by the droves. The ski basin opened to record-setting crowds on Thanksgiving Day.

But lawmakers and lobbyists, who had the foresight to make advance reservations, are flocking into town. Besides reopening ceremonies, current lawmakers expect to do a great deal of politicking this weekend. Virtually all of them should be in town. And where there are lawmakers, lobbyists can't be far behind.

Legislators, who served in 1967 when the current Capitol originally opened, will be special honorees. They can tell the new kids on the block not to worry about the flap over cherrywood desks. Controversies surrounding the location, design and furnishing of the original Capitol make that seem tame.

Twenty-five years earlier, in 1952, lawmakers caught even more heck for a capitol renovation that went far beyond the current effort. By the time they finished, the building had changed from Classical Greek, complete with dome, to Spanish Territorial.

Except for the cherrywood controversy that will cost as much as another \$1.7 million, this renovation has gone smoothly. Lawmakers note that's only a five percent overrun.

That's nothing compared to the problems one of our first territorial legislatures ran into in the 1850s. Tired of the 240-year-old Palace of the Governors, lawmakers got money from Congress to build a Capitol befitting American occupation. But they ran out of money and couldn't finish. Following the Civil War, Congress completed the building—for use as a federal courthouse. It would be another 20 years before state lawmakers got a new Capitol.

Rededication festivities are scheduled to last from noon to 7 p.m. Friday, 9 a.m. to 7 p.m. on Saturday, and 9 a.m. to 3 p.m. on Sunday. Receptions, with food and non-alcoholic beverages, will be held on Friday and Saturday evenings from 5 p.m. to 7 p.m. Friday evening's ceremony will honor past, present and newly-elected officials.

Saturday evening's ceremony will recognize the Capitol Art Foundation for its efforts in giving the building a truly New Mexico feel.

But these won't be the only ceremonies. Hospitality, entertainment and presentations will occur throughout each day. If you can drop by your Capitol this weekend, do so. You'll find activities in progress at any time. Tours of the building will be conducted and film presenta-

tions and exhibits will be available for public viewing at just about any time during the three days.

The festivities will cost upwards of \$20,000, none of which will be taxpayer money. Lobbying organizations have cheerfully chipped in for the occasion, sensing that this is a little bit of history being made.

So if you're in the neighborhood, stop by and see us. You'll be glad you did.


