

# Don't Water Outdoors In Ruidoso This Weekend

Despite recent summer rains in the Ruidoso area, village officials are asking residents and visitors to reduce or eliminate outdoor watering over the July 4 weekend (July 1-4).

During the regular meeting Tuesday, the Ruidoso Village Council heard village manager Gary Jackson say the large crowds expected in the village

during the July 4 holiday weekend puts about the greatest demand for water in the year, equal only to the Christmas holidays.

"There is so much demand on the system, if we have equipment failure, or a fire, it would dramatically affect water service and our fire fighting abilities," Jackson said.

To reduce the amount of demand on the village water

system, the council endorsed the voluntary water reduction plan, asking residents and visitors to reduce or eliminate outdoor watering on July 1-4. Jackson said the recent afternoon rain showers have decreased the demand for water considerably. "It's amazing to see the demand diminish with the afternoon showers," Jackson added.

Even with the rains, the Ruidoso area forests are very

dry because of the lack of winter and spring moisture, making them tinderboxes for stray fireworks. Jackson reminded the council and the audience present at the meeting that by ordinance fireworks are illegal in the Village of Ruidoso. Anyone found violating the ordinance will be subject to a citation and fine.

Fireworks are also illegal in the Lincoln National Forest. The public is invited to an

open house at Ruidoso's newest water treatment facility at Grindstone Dam at 10 a.m. Friday, June 30. Guests will be taken on tours of the facility which produces 1.5 million gallons of high quality treated water a day.

People living outside the municipal limits of the village, but who want to make a new connection or extension to the village water and sewer services are out of luck. Council-

ors voted unanimously to adopt an ordinance prohibiting NEW connections or new extensions of village water and sewer services outside the village corporate limits. The ordinance does not pertain to existing agreements for the services on file with the village clerk.

There was no public com-

## Capitan, C'zozo Receive Brunt Of Wild Storm

Wild weather hit parts of Lincoln County, ruining gardens in the Capitan area, and tearing apart roofs in Carrizozo.

About 5 p.m. Sunday, June 25 a severe thunderstorm ripped west to east, pelting the area with golf ball size hail in the west Capitan area, and tearing roofs and branches in Carrizozo.

An eyewitness reported seeing two funnel type clouds, at about 5:09 and 5:12 p.m. in Carrizozo. The clouds churned up dust, broke branches, including a branch that fell on a car in Carrizozo. The vehicle was extensively damaged on the roof and trunk.

Roofing on the old Gamble building on 12th St., was blown loose and had to be removed.

What might have been a lightning bolt hit Sturges Venture Market in Carrizozo, damaging refrigeration units. A portion of the roof was torn off by the whirlwind that went through the area.

## Carrizozo Firemen To Sponsor Fun Day At Spencer Park July 4


The Carrizozo Volunteer Fire Department invites the public to attend *Fun Day at the Park* on July 4 starting at 2 p.m. at Spencer Park.

## Rancho Ruidoso Valley Estates Roads Are Accepted By County

For more than six years, various developers of the Rancho Ruidoso Valley Estates have been trying to get the Lincoln County Commissioners to accept the subdivision's six miles of paved roads.

Various boards of commissioners have driven the roads and taken reports from numerous road managers about problems with accepting the paved roads into the county maintenance program. As a result, the roads sat idle with no traffic, especially when real estate sales declined in the Ruidoso area during the late 1980's.

But renewed real estate activity in recent years and a new developer spurred upgrade work on the paved streets.

Developer Ed Dodson got a tentative acceptance of the roads from the current Lincoln County Commission on June 3. He appealed to the commissioners to accept the roads, which had been rebuilt four years earlier. In October 1990, county commissioners Karon Petty, Rick Simpson and Bob Hemphill accepted the roads under a two year maintenance period, after which time the roads would have been inspected and if

found in good condition, accepted into the county road maintenance program.

But an election changed the commission board members, and resulted in a new manager. The two year test period came and went, and three years passed before developer Gary Dodson in early 1993 requested the county commission accept the roads into the county road system. Then county manager Andy Wynham directed a road inspection by engineering firm of John J. Jaquess and Associates. The inspection revealed numerous problems and a list was compiled.

In November 1993, Dodson wrote that the problems were being addressed. On November 23, 1993 Wynham wrote a memo to county road manager Bill Cupit asking him to meet with the White. Wynham commented that the roads were "deplorable."

Then in May 1994 another former road manager Tommy Hall wrote and requested commissioners accept the roads into the county maintenance program. Three months later, Tom White, superintendent of the McCarty Construction Co. asked to be on the agenda of the September 1994 county commission meeting regarding final acceptance of the roads. In September 1994

## Smokey Bear Stampede And Parade To Be Held In Capitan

The annual Smokey Bear Stampede and Parade will be held this July 4 holiday weekend at the Lincoln County Fairgrounds in Capitan.

The 40th Annual Smokey Bear Stampede kicks off at 7 p.m. Friday, July 1, with the crowning of the Lincoln County Fair Queen. Following the coronation, rodeo action gets underway.

A dance begins at 9 p.m. in the fairgrounds exhibition hall.

Rodeo action will continue on Sunday, Monday and Tuesday, July 2, 3 and 4 with Stampede performances beginning at 7 p.m. each night. A dance also will be held each night, beginning at 9 p.m.

On Independence Day, Tuesday, July 4, the 40th Annual Smokey Bear Stampede parade, sponsored by the Capitan Chamber of Commerce, begins at 10:30 a.m. on the west end of Smokey Bear Blvd. in Capitan. Parade participants need to line up at the east side of Capitan Elementary School before 9:00 a.m. to be judged.

The 15th annual Smokey Bear Fun Run will begin with registration at 7:30 a.m. Tuesday, July 4, at the parking lot of the Ruidoso State Bank in Capitan. The run, which begins at 8 a.m. features a 10 kilometer and 2 mile run along Highway 246 which

goes north of Capitan. There is an entry fee. Prizes and t-shirts will be awarded.

The Lincoln County Ranch Rodeo, scheduled for two performances on Saturday and Sunday, has been canceled.

## Fireworks Are Illegal In Most Of Lincoln County

Fireworks are illegal in most of Lincoln County, including the town of Carrizozo, village of Ruidoso, and the Lincoln National Forest. Fireworks are also discouraged in all other areas of Lincoln County and open campfires, including ones made with charcoal, are not allowed anywhere in Lincoln County, including private, state, and federal lands.

According to the town of Carrizozo ordinance, it is unlawful to sell, offer to sell, own, possess or discharge any firecracker, roman candle, sky rocket, torpedo, bomb, blank

cartridges or any other type or form of explosive commonly known as fireworks within the town limits.

Carrizozo Police Chief Duane Vinson said that any thing larger than a cap pistol is illegal.

Fireworks will be allowed at the fireworks display sponsored by the Carrizozo Volunteer Fire Department July 4 at the Carrizozo Golf Course Park. Children will be allowed to shoot personal fireworks ONLY with adult supervision. The fireworks display will begin at dark.

Cupit sent a memo to the county commission about the roads. Later that month Cupit made an inspection of the roads, which led to the list of problems that needed fixed.

Cupit's opinion was the hot asphalt mix used for the roads was done improperly. Cupit was directed to work with paving company representative White on the specifics of getting the roads to standard. But the time frame for paving, as recommended on the list, had passed.

Since last year, Cupit resigned as road manager. How-

ever, he left behind the list of work needed on the roads, which included repaving three miles on the main road.

Commissioners on June 6, 1995, again discussed the roads. They were hesitant to accept the cul de sacs in Rancho Ruidoso because they did not meet standards and amounted to about three miles of pavement needing a "fog seal". After considerable more discussion, commissioners finally voted, 4 to 1, to accept the roads after work is done, satisfactory inspection made by acting road manager

Albert Hernandez, and satisfactory results of a compaction test made on the roads.

County commissioner Wilton Howell voted no, because he was concerned how the county could make the developer upgrade the cul-de-sacs if they were not accepted along with the streets.

Final acceptance of the Rancho Ruidoso Valley Estates roads will again become a county commission meeting agenda item, when commissioners will again have to consider whether or not upgrade work will bring the desired inspection results to warrant adding the roads to the county road maintenance program.

Three months ago, commissioners voted to sell the newly acquired chip seal paving equipment, stating it was too costly for the county road program, and because former road manager Bill Cupit had the paving expertise. If commissioners accept the Ranch Ruidoso Valley Estates roads, it will add another three to six miles of paved roadway to the county maintenance program. Currently, any repair on the county maintained paved roads is done with contract labor.

"I'm concerned about accepting something that is going to last," said county commissioner Stirling Spencer during the June 3 meeting. "We're building on the backs of the county tax payers if the roads fall apart after two years. In the interest of the county tax payers, people should build good roads and spend their own money, instead of on the backs of taxpayers."

## Town Worker Is Injured In Hit And Run Accident

Carrizozo town employee Manuel "Manny" Vigil is home now.

Vigil, 56, spent part of the weekend in the Lincoln County Medical Center in Ruidoso undergoing surgery for injuries he sustained from a hit and run accident in Carrizozo early Friday.

According to Carrizozo police chief Duane Vinson, Vigil was doing his daily watering at the street median on the corner of E Street and Central Ave. at about 3:30 a.m. when a pickup southbound on E Ave. hit the reflector pole on the median, then came up over the curb and hit Vigil.

Vinson said it appears it was an accident. However, the driver of the vehicle left the scene. Vigil, injured on his left arm and side, was able to get in the town truck and drive as

far as the Outpost Bar. Soon after, about 3:40 a.m. a border patrol officer in his vehicle and Carrizozo officer Raymond Lueras Jr. in his patrol unit spotted Vigil's truck and investigated. As soon as they found Vigil, Lueras radioed for Carrizozo ambulance.

Carrizozo ambulance trans-

ported Vigil to Lincoln County Medical Center where he underwent surgery later.

Vinson said evidence was collected from the scene and sent to the state crime lab. He also said they have a few leads, but the accident is still under investigation.

## Suspect Arrested After Drugs Found In County

Discovery of an abandoned car in the county near Ruidoso, on June 21 resulted in the seizure of 18.5 pounds of marijuana, and arrest of a subject from El Paso.

According to Angelo Vega, Lincoln County Narcotics Task Force commander, El Paso police arrested Arturo Rosa Saldana, 24, of El Paso on charges of conspiracy to distribute narcotics (marijuana) with intent to distribute.

On June 21 Ruidoso police requested deputy assistance with a possible stolen vehicle at a location in the county in Paradise Canyon next to Ruidoso. Deputy Bobby Angermiller responded and assisted Ruidoso officer Dwane Gore. During their investigation, the officers observed some packages, which they suspected were narcotics. They then contacted Vega.

Vega said the officers did not move the vehicle or investigate the substances until he arrived. The alleged controlled substance was field tested and

showed positive for marijuana. During the investigation of the vehicle, the officers found (SEE PAGE 12)



**Conservation District Calls For Essay/Editorial Entries**

Sixty years ago, in 1935, the land was in far different shape than it is today. Deep gullies gouged the south. Dust clouds from the great plains darkened the eastern skies. Our nation's ability to sustain its natural resources, and thus its vitality, was in grave peril. Those tragic environmental events gave birth to a conservation partnership that has quietly, but effectively, worked to conserve and enhance the natural resources that are the key to our nation's future.

In an attempt to call attention to the need for continued natural resource stewardship and to salute the strides that have been made in conservation throughout our country since the Dust Bowl days, the Carrizozo Soil and Water Conservation District and the Southwest Region of the National Association of Conservation Districts (NACD) are sponsoring a Conservation Essay/Editorial Contest.

"We've come a long way on our conservation journey," Bill Hightower, district board member said. "We hope this contest will remind people throughout our region that conservation is not something that you do once and walk away," he said. "Conservation is an on-going effort that requires a long-term commitment."

There are two general public categories for the contest: under 16 years of age and over 16 years of age. The first place winner in each category will receive \$400, with runners up receiving \$100. In addition to the cash prizes, the winners' essay/editorials will be submitted for publication to local papers and to District newsletters throughout the region to help others understand the importance of conservation. Essays/editorials are limited to 250 words or less.

The theme of this year's contest is "The Value of Abundance: Conservation Pays," which is also the theme of this year's Southwest Regional NACD Meeting in Salt Lake City, Utah, Sept. 6-8. The contest is open to anyone who lives in Utah, Colorado, New Mexico, or Arizona. Entries will be judged on their adherence to the theme, creativity, and how well the author demonstrates the importance of continued natural resource conservation. Entries must be postmarked by August 1, 1995.



**Inside The Capitol**

**SANTA FE**—This is the week Gov. Gary Johnson targeted for closing the Fort Stanton medical facility of the state Health Department.

That will happen, but controversies surrounding the imposing 140-year-old fort aren't over -- by a long shot.

Actually, the shut-down occurred three months ago, for all practical purposes. By March 24, all the patients and a majority of the over-200 staff were dismissed. As of June 30, only a handful of staff will remain to oversee the property and facility operations for the next fiscal year or until the next tenant moves in.

The Johnson administration intended for the next tenant to be a private entity. A request for proposals was scheduled to be issued next month by the state General Services Department. But a new twist has the state Corrections Department interested in using the facility as a minimum security prison.

Rep. Dub Williams, who represents the area, figures the best solution is to go ahead with the requests for proposals to see what kind of interest may be out there and use the facility as another prison only if a satisfactory private offer isn't made.

A resolution to the issue is very much up in the air at this time. Meanwhile many Lincoln County residents have had their frustration level kicked up another notch by the latest change in plans.

Two of Lincoln County's biggest employers, Fort Stanton and Ruidoso Downs racetrack, both suffered at the hands of Gov. Johnson soon after he took office.

The governors quick signing of gaming compacts with Indian tribes and pueblos meant stiff competition for racetracks. A large group of Ruidoso citizens visited Johnson early in his term, asking him to level the playing field by supporting casino gambling for racetracks also. But the new governor refused despite a prediction by R.D. Hubbard, the track owner, that it would drive him out of business.

Then, on Jan. 13, Johnson announced Fort Stanton would close its doors on June 30. And in only two months, the deed was done. The state's most heavily Republican county had suddenly lost one of its largest employers and another was in serious danger.

Every since Fort Stanton was built as a military outpost in 1855, it had been a community facility. The post was established in order to protect the surrounding area

from raids by the Mescalero Apaches.

In 1899 Fort Stanton became a naval hospital for the treatment of tuberculosis. While the facility operated some 200 beds, it also served as many as 400 from the surrounding area on an outpatient basis. The same was true after the state took over the hospital in 1953.

With advances in the treatment and prevention of TB, the number of patients decreased. In 1966 all TB patients were transferred to Ft. Bayard, near Silver City, and Fort Stanton became a branch of Los Lunas Hospital and Training School for the treatment of developmentally disabled children and adults.

In January 1993 Fort Stanton was ordered by the court to begin transitioning its clients to community living. The state decided to modify the facility for long term nursing care. The transition was

nearing completion and the first nursing care patients were being admitted when Gov. Johnson announced the facility would be closed.

The closure was a major blow for the surrounding community which had relied heavily on Fort Stanton for its economic existence since the mid-1800s. The ensuing efforts by Johnson and other state leaders to prevent the closure of Kirtland Air Force Base in Albuquerque further angered area residents, who saw themselves being hurt much more than Albuquerque would have been.

But the Fort is too valuable to remain closed for long. Its 70 buildings are maintained in immaculate shape by the skeleton staff. It is ready for immediate use as a health care facility -- or for the additional minimum-security prison Johnson needs to carry out his promised reduction of "good time."

**Long-Time Farm And Ranch Owners Will Be Recognized**

"We believe it is high time that those who have maintained the agricultural base of this state are recognized and with the groundbreaking for the new ag museum this summer it is appropriate to remember that people, families built the ag community in this state,"

Sandra McKenna foundation president said.

The Farm and Ranch Heritage program will announce the first families to be recognized at the August 12 museum groundbreaking. Applications for the program are being accepted now. Forms to apply can be obtained from the Farm and Ranch Heritage Foundation at Box 30001, Dept. FRH, Las Cruces, New Mexico 88003.

A brief criteria for the program is ownership by the (SEE PAGE 5)

**Balanced Budget Could Help Small Businesses Grow**

Since President Clinton took the oath of office, America's national debt has shot up \$695,751,209,984.13.

Broken down, that increase in the national debt is costing American taxpayers more than \$302 billion per year, \$24 billion per month, \$816 million per day, \$34 million per hour, and \$567,000 per minute.

Mind boggling isn't it?

The numbers are so overwhelming that it's difficult for an individual to comprehend the impact. But here are some examples. Since 1992, the debt has grown \$2,654.79 per person. For a family of four, their share has increased by more than \$10,000.

Today, one-half of all individual income taxes go to pay interest on the debt. Unfortunately, when taxes go toward the debt instead of the programs and services they are supposed to pay for, the government must come up with more funds or reduce the programs and services. It's a lose-lose situation.

But, the daily grind of increased taxes, regulation, government spending and debt has a more devastating impact on one of our nation's most vital institutions. It harms the growth of small-business job creation and expansion. Often we hear stories about small-business owners who want to hire more people and expand their firms if more of their hard-earned money stayed in the business instead of going into Uncle Sam's coffers.

Many firms are still recovering from the 1993 budget bill which raised taxes retroactively on small business. For companies with thin profit margins--or no profits at all--that was a double blow.

But Main Street business owners are hopeful that this new Congress and the Clinton Administration will make the tough choices and finally balance the budget. The 600,000 members of the National Federation of Independence Business, the nation's largest advocacy group for small business, are backing proposals in Congress to balance the budget by eliminating federal agencies, wasteful spending, and programs that simply don't work.

Eight out of 10 NFIB members agreed in a recent survey that Congress should focus its attention primarily on deficit reduction through cutting spending, not by imposing new taxes or expanding existing ones. Reducing the deficit would strengthen the economy by lowering interest rates, improving purchasing power and increasing private investment for small-business owners. And, once the budget is balanced, the federal government would have no incentive to raise revenue.

Over the years, Congress has used the deficit to justify federal mandates on small business. With the books balanced, lawmakers could no longer use shortfalls as an excuse to force small firms to spend their money.

Along with spending cuts and a balanced budget, entrepreneurs want tax relief to further boost the economy, such as changes in estate tax law to allow families to hold on to their business without penalty for passing them on to their heirs, incentives for retirement savings, and reducing the capital gains tax and existing capital assets to inflation.

There is no doubt that some of the efforts to reduce spending will be difficult. But the bottom line is that the country needs a lean and fiscally

same family of a farm or ranch for at least 50 years. The property must be a working operation that grew crops, and/or raised livestock during the past 50 years. You must now own the farm or ranch. A line of ownership must accompany the application. Land in the process of being sold to a non-relative is ineligible.

"Entering the heritage recognition program will not mean you cannot make improvements or changes to your property," McKenna stressed. "We are only acknowledging the longevity of families and their farms and ranches to the ag history of this state. This is not a historical preservation certification that restricts property to its original looks or time frame. We know that agricultural production is dynamic, but its constant use and ownership by the same family makes it worthy of recognition," McKenna said.

spoke with Beffort after he and other cabinet secretaries met with Governor Gary Johnson earlier in the day. Beffort assured Cooney that the rfp will be issued as scheduled next week. And as a result of the cabinet meeting, the corrections proposal to turn Fort Stanton into a prison will be added to any other proposal offered in response to the rfp.

Howell told THE NEWS during a telephone interview Wednesday that he had requested the meeting Tuesday to discuss the corrections department prison proposal which he had learned about after calling several state offices to clarify the inclusion of a \$1 million lease fee in the latest draft of the rfp. Howell said that during the meeting Sec. Sannick said he had looked at Fort Stanton and found it could house 150 state prisoners for now, and employ 55-60 people with about two-thirds hired locally. After the first year, Sannick said the state would increase the number of prisoners to 250 to 300, and he was unsure how the state would handle the situation on the long haul.

Howell said Sannick quoted figures of \$61 a day to house prisoners in facilities out of state at this time, which could be lowered to \$31 a day if Fort Stanton was converted to a prison facility.

Converting the facility to a prison was proposed during the legislative session, shortly after Gov. Gary Johnson closed Fort Stanton as a hospital for long term medical needs patients in January. At that time, Dept. of Corrections, and all other state departments were uninterested in the facility.

A bill introduced by Rep. Raymond Sanchez to turn Fort Stanton into a prison and provide it a \$3.5 million annual budget died during the legislature, along with several other bills that proposed uses for the Fort.

Howell said he told the

correction secretary and under-secretary that Lincoln County is a community that thrives on tourism. "We're being saddled with a nuclear dump on one side and now a prison on the other," he said. "We don't need anymore band-aids."

Howell said the corrections under-secretary responded that Dept. of Corrections doesn't go to communities which do not want prisons. To this Howell said that Lincoln County already has one prison, and the majority of his commission does not want another prison at Fort Stanton. Howell also said he thought the community also does not favor the proposal.

If a prison is located at Fort Stanton it would strain the services of the county sheriff's office and state police and would put citizens in danger because there is no alert system to inform the public about escapes. Also, prisoners from Camp Sierra Blanca in Lincoln County are often brought to the Lincoln County Detention Center in the courthouse in Carrizozo for violations. With three to five camp prisoners coming to the jail often now, that number could increase to 25 if a prison is located at Fort Stanton. Howell said that could require the county to expand its jail.

Howell said he left the meeting with state officials agreeing to issue the rfp as planned, and to hold two public meetings in Lincoln County.

Cooney said that Sec. Beffort contacted her late Wednesday and said the rfp will be issued as scheduled, and there will be no need for public meetings on a prison, unless the Dept. of Corrections proposal is selected as the best respondent to the rfp.

We did manage to get to the airport without any emergencies and my daughter Trish had cleared with Brian Sullivan, my special grandson, that he was going to meet me in Denver and see that I boarded the right plane for Albuquerque where Tom had promised he would be waiting right at the gate for me when I deplaned. (Hope you are all sitting down and are comfortable, because the rest of the story is one for the book. Which book I have not decided but it certainly should be locked safely away in the family archives. When I deplaned, Brian was nowhere in sight. I waited a few moments and as I was carrying my father's cane with me in

It did muss up the paper somewhat, but they didn't mind. Back to my ticket. I told Brian to hold my envelope while I got the package unstuck from my carry-all bag and he sat down and handed me an album of their wedding pictures, because we were unable to attend the wedding in Las Vegas. I only saw two when Kim came rushing back from the telephone and said she was sorry that they had to go. I hugged them good-bye and sat down to wait for my plane. I naturally began looking for my ticket. I then started looking frantically for my ticket. I could not imagine what I had done with my ticket, I had just had it. Then it dawned on me. I had asked Brian to hold it for me while I dug their wedding gift out of my bag. I had about 20 minutes before take-off and thinking how good it would be home in my little old house by the side of the road. I realized that somewhere the ticket had gone on without me to some undecided place, so I took my cane and leaned most heavily on it, so I would look even more pitiful than I was already yet and limped up to the desk. Such a nice thought and such a nice thing for you to do. Am still looking forward to lunch. O.K. Any day next week will be fine or any other time. Hope to see you soon.

Congratulations to our new Lincoln County Chief Deputy Treasurer. Beverly I will miss you when I pay my gas bill, but I certainly am happy for you and someday when you can arrange it, would love to take you to lunch. Let me know when and where.

ment on the ordinance during Tuesday's meeting. The setting of a public hearing on a proposed ordinance became the topic of considerable discussion during the meeting. First listed as a routine item on the consent agenda, councilor Leon Eggleston requested the setting of the July 11 public hearing on the proposed ordinance prohibiting skateboards, roller skates or blades and bicycles on the MainStreet area sidewalks be brought into the regular agen-

da for discussion. Eggleston remained firmly against the proposed ordinance which he said will not solve the problem of kids being downtown. He voted no on the motion to set the public hearing. Eggleston and councilors Robert Donaldson and Frank Cummins were also concerned the council had no input on the wording of the proposed ordinance. Donaldson said councilors need to know what is in a proposed ordinance even before they set the public hearing date. Councilors asked that staff draft a policy resolution for guidelines on the drafting of ordinances.

In discussion about the proposed skateboarding ordinance, Donaldson wanted to remove the roller skates or blades from the ordinance, because he said those are not the problem. As for bicycles, he said those do create more problems than skateboarding. Donaldson said he will support the proposed ordinance if it does not include roller skates or blades, and if

the village builds the skateboard park as promised. He said practicing the "sport" of skateboarding on the MainStreet sidewalks does appear to cause conflict.

Donaldson agreed with Eggleston the proposed ordinance will not keep kids away from the MainStreet area. "Kids have a legal right to be downtown, just like a 56 year old person," Donaldson said. "The real problem is the generational conflict," he added.

The proposed ordinance is similar to one approved by the Santa Fe city council.

On a vote of 5-1, councilors approved the July 11 public hearing on the proposed ordinance. The public will be able to comment on the proposed ordinance at the public hearing to be held at the start of the regular council meeting.

Councilors also: --Approved the re-subdivision and vacation of Lots 35 and 36 Block 2 Mountain View Estates and Tract NE as recommended by planning and zoning.

--Adopted a resolution for the final amendment to the 1994-95 fiscal year budget to add \$11,158 in expenditures to the general fund to cover an extra pay period, which happens every 10 years.

--Extended for another six months the policy of reduced replat fees under summary procedure from \$100 to \$25. Since the policy began Jan. 1 there have been 30 summary replats filed, which was considered to be very successful.

--Rejected the only bid for janitorial services, because it came in over the amount budgeted. The village will re-advertise for a janitorial service bid.

--Approved appointment of Steve Talley, manager of Swiss Chalet, and reappoint-

ment of Kent Beatty and Ron Anderson on the Lodgers Tax Committee.

--Approved the consent agenda of change in insurance coverage from State Risk Management Division to New Mexico Self Insurers Fund; Convention and Visitors Bureau Advertising Plan of \$100,000 for the civic center and an additional \$109,450 for general tourism marketing and advertising, special events advertising will be

presented later after a policy is developed by lodgers tax committee; award contract for electrical services to WRC Electric Co.; contracted with Dr. David Eisler for a needs assessment analysis as recommended by the Arts and Film Board; contracts with financial advisor and bond counsel for general obligation bond issue Aug. 22; extended maintenance contract for radio maintenance with A & B Electronics (dba PCI Inc.); extended contract for plumb-

ing and heating maintenance with Lincoln Mechanical. --Met in closed session to update the purchase, acquisition of water rights and facilities and the purchase, acquisition or disposal of real property by the village. No action was taken after the council returned to open session.

a name "Arturo" and an El Paso telephone number written on a paper. With that small bit of information Angelo Vega and Lincoln County District Attorney investigator Leandro Vega went to El Paso on Friday. Once in El Paso, they contacted El Paso Police and a federal agency for assistance.

The officers called the phone number found in the preliminary investigation and spoke to an Arturo. The officers then met with the subject at Red Lobster in an undercover capacity, and confirmed the subject's identity. The officers interviewed the subject about the abandoned vehicle near Ruidoso, then escorted him to his residence in El Paso, where a vehicle allegedly stolen from Ruidoso Rental Company was located.

El Paso police then came to Saldana's residence, and took him to the police station for questioning. Angelo Vega contacted the New Mexico 12th Judicial District Attorney for a warrant for the suspect's arrest. The warrant was issued by Lincoln County Magistrate Judge Gerald Dean Jr. who set bond at \$50,000.

With the warrant El Paso authorities arrested Saldana who was taken before an El

Paso judge and waived extradition. Saldana was transported to the Lincoln County Detention Center (jail) in the Lincoln County Courthouse in Carrizozo Monday, where he awaits preliminary hearing with Dean.

A second subject involved with the incident may be arrested, Vega said.
