# **Bodies Identified; Old Cases Solved**

#### by Doris Cherry

Last week, the Lincoln County Sheriff's Department received final confirmation from the New Mexico Office of the Medical Investigator (OMI) about the identity of two bodies found in Lincoln County.

According to Lincoln County deputy Ken Jones, the OMI's Albuquerque office sent the official report that a body found in the Pine Lodge area

this spring belonged to Marilyn Boyd of Roswell. Evidence found at the scene and other information had led police to assume the woman's body was Marilyn Boyd, but as with cases of this type, her body was sent to the OMI for positive identification.

Finally, months later, the report was received.

While it seemed like a long time to wait for a report on such an obvious case, Jones was more baffled about the

length of time it took the OMI to make a final determination on some scattered human remains found in September 1992. also in the Pine Lodge area on the northeast side of the Capitan Mountains.

stated the remains belonged to 14 year old Roxanne Mosier who had been abducted from Oklahoma. The identification came from a positive DNA match made on bones found at the scene.

But what bothers Jones most, was he and other investigating officers suspected the remains belonged to the 14 year old at the time of the investigation. "We suspected the remains belonged to one of Jones said the OMI report two possible subjects," Jones told THE NEWS and added that "OMI was either unable or unwilling to test the remains to determine the gender of the person."

> "We never got an absolute okay on the gender until the

FBI lab did the DNA test," Jones said.

Jones who investigated the Mosier case originally, said he finally had to turn it over to deputy Larry Cearley because he was getting no response from the OMI. Jones admitted he called the OMI on a regular basis trying to get some information.


He learned just recently, that OMI during an OMI seminar this summer, openly admitted it made grievous

errors in the case, and they should have listened to the investigating agency.

## Seven Constitutional Amendments Are On The General Election Ballot

Sample ballots are now available for voters to review prior to the election.

Along with the candidates running for office there are seven constitutional amendments and four bond questions.

All the constitutional amendments and bond questions were proposed during the 1996 state legislative session and are now being brought before the voters.

This week THE NEWS will review these amendments. In future articles, THE NEWS will review the proposed bond questions, and on October 31, THE NEWS will list the candidates to the various offices.

On the general election ballot, voters are asked to vote yes or no to seven constitutional amendments. The amendments ask for changes in the following areas: 1. Permanent Funds Distributions

and Investment, 2. Education Technology lease-purchase, 3. Recall of Elected County Officials, 4. Procedures for Amending the Constitution of New Mexico, 5. Legislative per diem and mileage calculation, 6. Abolishing the state corporation commission and creating a public regulation commission, 7. Authorizing County Borrowing.

Amendment I proposes to protect the state's permanent funds against inflation by limiting distributions to a percentage of each fund's market value, and by modifying certain investment restrictions to allow optimal diversification of investments.

The state's permanent funds are the land grant permanent fund, and the severance tax permanent fund. The land grant fund has a market value of nearly \$4.67 billion. Its earnings go to the state's

public schools and higher education institutions. Earnings from the severance tax permanent fund (taxes from oil and gas and mineral extractions) go the state's general fund to support operation of state government, including public schools and higher education institutions.

If passed the amendment would allow the state to invest up to 65 percent of its permanent land grant funds in corporate stocks listed on a nationally recognized list of stocks or stock exchange (such as American Stock Exchange or NASDAQ). That is a change from the current 50 percent, and the requirement that corporate investment be limited to stocks just on the American Stock Exchange.

The amendment would return the dividend and interest income from investments

The amendment also removes the current requirement that the state can only purchase stocks which have shown 10 consecutive years of dividends, and remove the prohibition of purchasing foreign stocks and replace it with a limit of 15 percent of value of the fund to be invested in foreign stock.


Amendment II proposes to enhance education by authorizing school districts to incur debt without an election for the limited purpose of acquiring education technology equipment (computers and software included) through lease-purchase agreements. The amendment will allow school districts to purchase computer equipment without having to have bond elections, thus offering a less expensive method to upgrade equipment. The amendment specifically will allow lease purchase agreement for technology only. Any other lease purchases agreements for any other types of equipment must be subject to an election by voters.

Amendment III proposes to add a new section to provide for recall of elected county officials. The section will allow recall by petition on grounds of malfeasance or misfeasance in office or violation of the oath of office. The petition must be signed by at least 33.3 percent of the number of registered voters of the county if the official was elected at large, or, of the district from which the official was elected and who voted in the election prior to the election which put the official named on the petition in office.

Before the petition may be circulated, allegations must be presented to the district court, and the petition will be circulated only after a hearing where the court finds probable grounds for recall. Currently a

Arguments for the amendment are it will provide a way to remove county officials before their terms expire if they are guilty of misfeasance (the performance of a lawful action in an illegal or improper manner) or malfeasance (wrong doing or misconduct by elected official). County officials serve four years.

Arguments against are it is unnecessary because county officials now can be removed from office for cause, with the grand jury method. Also allowing such recalls would politicize local government decisions too much.

provides Amendment IV additional methods to amend the constitution and directs the secretary of state to inform voters about the constitutional amendments. The amendment establishes a process for an independent (appointed) commission to prepare amendments to be submitted to the legislature for consideration and changes the constitutional convention process to allow all or part of proposed revisions to be submitted to the voters.

The proposed amendments will have to be advertised in both English and Spanish, and other indigenous languages and other minority language groups.

Arguments for this are it will add a third method to allow more comprehensive constitutional change instead of the current "piece meal" method, by allowing an appointed body to make recommendations without the high cost of a constitutional convention.

Arguments against are the amendment will allow "logrolling" of different subjects together into one amendment, and it will empower an appointed body, not responsible to the people through an elected process.

Amendment V proposes to limit legislative per diem and mileage to an amount allowed by the Internal Revenue Service. This amendment will increase the per diem and mileage for legislators (the only fee legislators are given during session) to the amount currently allowed by the IRS, as of July 1996, \$124 a day and mileage to 28 cents. Mileage is the distance per mile traveled in going to and returning from Santa Fe, once each session and to interim legislative committee meetings. Currently legislators receive \$75 a day and 25 cents per mile, which were set in 1982. Arguments for the amendment are the high costs of staying in Santa Fe during the legislative session. Also it gives more flexibility for per diem and mileage amounts, because no set figure is put in the constitution, which thus eliminates the need for future amendments to adjust the amount. Arguments against the amendment are the state constitution will reflect an amount set by a federal agency, per diem reimbursement at Santa Fe rates should not be given to a legislator staying in another community to attend interim committee meetings and the title of the amendment is misleading, because it does not limit per diem and mileage, it mandates reimbursement at an increased level. Amendment VI proposed to abolish the state corporation commission and create a sinkie regulatory agency for corporations, public utilities, transportation companies, transmission and pipeline companies, insurance companies and other public services as provided by law. The amendment would repeal 14 sections and add a new section creating a public regulation commission with five

The early voting satellite poll at Ruidoso Civic Center opened Wednesday, October 16 and is open 10 a.m. to 2 p.m. every day, and will also be open Saturday, Nov. 2.

tell the teeth belonged to a young person.


While the girl's bones were scattered at the location where they were found, her hands had been mummified, leaving the fingerprints intact. These were also sent to the OMI, with instructions from the investigating deputies that OMI should take fingerprints to establish the body's identity. Jones said it apparently was never done, because OMI later informed his department that the hands had deteriorated and they were unable to take prints.

It was mentioned last week that someone wants to put a roping arena at Fort Stanton. Another roping arena in Lincoln County? If we aren't careful we will have fence to fence roping arenas in Lincoln County with little space left for people.

One thing we do know is that there is not a shortage of roping arenas anywhere near Lincoln County while there is a shortage of places for people, especially people with special needs. The elderly patients with Alzheimers had a lovely place to live but that ended when governor Johnson dumped them out and closed Fort Stanton last year. Now the Alzheimers patients don't have anywhere to go but there is a request for more roping arenas. It is ironic that our elderly are without a home but the ropers are bidding for another place to ride their horses. We have no objection to horses but anytime a horse can take

precedence over an elderly helpless person something is very wrong with the way our leaders are taking care of their duties. The first thing that the people here in the United States and here in New Mexico should do is make certain that not one helpless person goes without proper care. Now that governor Johnson has turned his back on the elderly Alzheimers patients that is exactly what is happening. There are numerous elderly Alzheimers patients being deprived of their basic needs and it appears few if any of our elected officials are willing to help.

We have asked governor Johnson repeatedly for an answer as to why the elderly were tossed out of their homes but he either doesn't care or is ignoring the situation. Just because he has the money to pay for private care for an elderly person doesn't mean that everyone has that kind of money. Just because he is more concerned with picking up trash than making certain elderly helpless people are being cared for properly doesn't mean the rest of us are as unfeeling as he is. Just because he is in a position to force elderly helpless people out of their homes doesn't

mcan the rest of us will walk away from our responsibilities. Last week a friend asked why Lincoln County is spending our tax dollars for another roping arena while Alzheimers patients are being deprived of their basic needs. This friend said that in the money was spent to build a nursing facility for Alzheimers patients here in Lincoln County it would help the economy by putting people to work as well as by bringing visitors to the area. People would be in Lincoln County regularly visiting their family members with Alzheimers. Sounds like a good idea.

Here in Lincoln County we have an excellent place for an Alzheimers care facility at Fort Stanton. Two of the buildings are ready for patients and could be used immediately. It would be, as was decided by a state-financed study, the perfect place to provide care for elderly Alzheimers patients as well as for people with brain damage and other elderly geriatric patients. If our local elected officials would work as hard at trying to

convince governor Johnson of the need to use Fort Stanton as an Alzheimers care facility as they are at trying to build more roping arenas we might see results. If our local elected officials were as concerned about elderly helpless people, as they are about horses and ropers we would have something to brag about.

Alzheimers patients aren't able to ride motorcycles and have little in common with governor Johnson. Alzheimers patients can't get out and trek for trash which probably puts them on the governor's crap list. Alzheimers patients aren't likely to ask for that five minutes a week that governor Johnson is willing to spend with the public which means their needs aren't important. Any government can be judged by the way it cares for the

elderly. It is time we demand that our helpless elderly receive the care they so desperatley need. Fort Stanton is the ideal place. Fort Stanton for horses or people?





SANTA FE—Early voting began yesterday. And remember, you don't have to have a good reason for voting early. You can do it just because you want to.

In 1993 the New Mexico Legislature established a procedure whereby registered voters can go to their county clerk's office any work day between 8 a.m. and 5 p.m. and cast their vote. Clerk's offices will also be open on Sat., Nov. 2 from 8 a.m. to 5 p.m. so you can vote early.

It's a great opportunity to miss the long lines on election day. General elections in years having a presidential contest are the busiest of all at the polls. The latest surveys show that although New Mexico is leaning toward reelection of Pres. Bill Clinton, his election isn't sewed up yet. Come Nov. 5, it appears Clinton has a lock on the election, voter turnout won't be as heavy. But don't bet that will happen. New Mexico's first year of experimentation with early voting worked well. But we did learn some things. In 1994 early voting began at the same time as absentee voting, 40 days before the election. Voting patterns showed that the process was used most during the first week of voting and the last two weeks. Not much happened during the intervening three weeks. So the 1995 Legislature shortened the early-voting period to 20 days. Absentee voting needs to start earlier because most of it is done by mail, sometimes from foreign countries. For that reason the start of absentee voting still is 40 days before elections. Another reason lawmakers may have shortened the early voting period is that they don't like "same day voter registration," a process used in some states that allows a person to register and vote in the same day. A few years ago lawmakers killed such a proposal, but starting early voting 40 days before election day inadvertently gave voters 12 days during which they could do both. Texas got the early-voting trend started in 1991, By 1994 nine additional states were trying it, mostly in the West. Arizona, Colorado, Nevada and California have early voting. Others are joining the bandwagon this year.

didate debates still hasn't caught up with early voting. But then the one New Mexico television station that tried scheduling an early debate among congressional candidates ended up with only the challengers present because Congress was still in session.

Eleven Albuquerque high schools did a little early voting of their own on Oct. 2, which was National Student Voter Education Day. Secretary of State Stephanie Gonzales held voter registration activities and then conducted a mock election among seniors at 11 high schools chosen to proved a diverse populace representative of New Mexico's population. Included were six public high schools and an alternative school, three church schools of differing

836-426, with Ross Perot at 119 and Ralph Nader at 66. Sen Pete Domenici beat Art Trujillo 936 to 368. Rep. Steve Schiff bested John Wertheim 938-246. Clinton lost two high schools. La Cueva, in Albuquerque's far Northeast Heights gave Dole a 116-104 margin and Hope Christian School gave Bob Dole all 37 of its votes.

Gonzales and her staff conducted FIRST VOTE activities around the state last spring registering nearly 3,000 rural high school seniors. About that many were registered in the Albuquerque sweep this fall. This is the 25th anniversary of the constitutional amendment that gave 18 year olds the right to vote.

Luebben; Appeals Court Judge, Position 1--Democrat Victor Lopez, Republican M. Christina Armijo (incumbent); Appeals Court Judge Position 2--Democrat Michael Bustamante (incumbent). 


US Congressman Republican Joe Skeen won with 187 votes to Democrat Shirley Baca's 178, a close race for the 16 year incumbent Skeen.



Councilors will act on the policy changes by resolution at their next meeting.

Councilors applied the new language to a lease of property offered by Flying W Diamond Ranch, which wants to construct a private hangar at the airport. Although reviewed and approved by the airport advisory board, staff had concerns about wording which will allow the lessee to sublet the property for an additional 40 years, at the end of the initial 40-year lease,

I milled around the press platform, which was up several steps with a somewhat wobbly hand rail Several of the reporters stayed in the tiny bit of shade given by the press platform. Growing bored, I began to mill about, looking closer at the small signs taped to the backs of shirts of former workers at Casino Apache in Mescalero, vowing to vote for the other guy if the president didn't fire a certain U.S. attorney who had pushed for casino closure. I tried to find a closer spot to take pictures, realizing too late I should have taken the longest telephoto lens I owned.

While the sun baked down we waited and waited. Local choirs and musical groups sang. As it came closer to 1 p.m. when the president's Air Force 1 was due to arrive, police and volunteers began to toss out the shiny gold and red ribbon shakers, and pass out more signs. The crowd began to get more excited. I grabbed some shakers for the girls, and realized the best place for taking pictures, was really on the press platform.

Then came the candidates. Democratic candidates Eric Serna, Art Trujillo, John Werthheim, Shirley Baca and Bill Richardson spoke. Sometime during their speeches, Air Force 1 flew overhead. Within 30 minutes, the White

House Press began to arrive. Staff pulled in bags and bags of camera equipment directly past the crowded public, and past the New Mexico press. In a short while, the White House Press Corps overflowed a platform of equal size to our little New Mexico media.

Waiting in the hot sun too long, the crowds got a bit testy. They yelled at the press for standing on the steps to the press platform to sit down, even when no one was on the podium.

After the candidate speeches, the president's arrival became very apparent when the numbers of secret service people increased, moving about the crowd in distinguishable dark blazers, probably cooking in the Indian summer heat of Albuquerque. Police and special security were everywhere. The parking garages in the downtown area within view of the president's podium had been closed, and all upper floors of buildings within view had been searched and emptied. Police scoured the area with high powered binoculars, and spoke repeatedly on hand-held radi-OS.

Then there the president was on the podium. The crowd went wild, cheering and waving signs, some with little messages about the Mescalero situation.

Shortly after the president began his speech, a man who

was close to the dense crowd on the south side of the intersection of 5th street began yelling out questions about dealings in Arkansas to the president. Within moments, he was escorted out of the crowd by Albuquerque police and secret service. Some in the crowd looked distressed, only one photographer and myself seemed to be the only press that actually observed the incident.

During his speech, the president looked young and vibrant, and soon like everyone else, a bit cooked under the brilliant New Mexico sun. After his speech, he shed his suit jacket and came down from the podium to meet the crowd. The throng got tighter.

Try as I might, the closest I came was about three people away from shaking the president's hand.

As soon as the president was escorted to a waiting vehicle north on 5th Street, the crowd began to leave. Soon the intersection was filled with nothing but a group of barriers, and a street paved with trodden signs and empty plastic water bottles. The group of dignitaries that were on the podium platform with the president, and who had been escorted into a small room in the Kimo theater were allowed to trickle out. A few people waited for family, and friends. The press es-

Skeen said tourism is the biggest industry, in Lincoln County and New Mexico. He advocates the transfer of federal lands to state and local control, which he said will not result in selling off those lands to just the rich.

Skeen said he invited the officials to come to his office at anytime for help with beneficial government programs like law enforcement, fire response, and emergency medical response.

'You have unique problems, that's why I'm here today," he said.

One of the unique problems is the Mescalero Apache Tribe proposal to annex the former Carrizo Lodge, or place it in trust, thus taking it off the private property tax rolls. Skeen said the tribes have limited "sovereignty".

For gambling, Skeen said there is need for more compromise and cooperation between the tribes and the legislature. "The legislature should have done something a long time ago," Skeen said.

Other comments were made about the drought legislation, to which Skeen responded. "we have a natural disastér here every year."

Skeen was asked if the

federal government could do anything for Fort Stanton; such as for a museum, or other historical facility. Skeen said there are federal dollars available, "once you make up your mind locally what you want."

Water was brought up by all officials. Skeen said that control of water is a state's rights business.
