Prisoner Transport Costs Are Lower Than Claimed

The County of Lincoln pays most of the costs for transporting prisoners, regardless where they are arrested.

Transport of nearly all prisoners from the Ruidoso area is sole responsibility of the Lincoln County Detention Center, or Lincoln County Sheriff's Office. Last budget year, Lincoln County had budgeted \$9,000 for transport of prisoners in the detention center budget and \$5,500 for transport and extradition of prisoners in the sheriff's office budget. That's a total of

\$14,500 budgeted for transporting prisoners to the Lincoln County Detention Center from all locations, including out of state.

Jail logs show that the majority of prisoners came from Ruidoso, transported by county officers. In two years of jail logs Ruidoso police only transported seven prisoners. In those same two years state police officers transported about 80 people they had arrested to the county jail.

According to Ruidoso Chief of Police Lanny Maddox most people arrested in Ruidoso are held in the Ruidoso police

department which has 10 detention cells--four for females and six for males. The department can hold adult prisoners for up to 72 hours at their small holding facility; they cannot hold juveniles in the cells anytime.

Some of the people arrested in Ruidoso go to municipal court, where municipal judge Mike Line makes most pay fines, or do community service. Occasionally, the judge orders jail time and the person is taken to the Lincoln County Detention Center in the courthouse in Carrizozo. Because the county does most

transferring of prisoners from Ruidoso, the village does NOT have a separate line item fund for prisoner transfer costs.

Most people arrested in Ruidoso are taken before magistrate judge (usually Bill Butts) for arraignment on their charges, before the 72 hour limit to hold them in the small Ruidoso detention cells. Once arraigned in magistrate court the prisoner becomes the responsibility of the coun-


The Village of Ruidoso has included construction of a new police department in its five year plan. But the high cost of constructing prisoner holding cells may delay such a project. Instead Madoux believes that a new county jail nearer to Ruidoso could provide his department with the detention area for village prisoners and provide the county with revenue for keeping Ruidoso prisoners.

But if the new jail is located any further than the Sierra Blanca Regional Airport area,

Maddox said his department cannot afford prisoner trans-

Claims that most of the prisoners in the county jail are from Ruidoso are true. According to jail logs from July 1997 to the first week in January 1998, of the prisoners booked into the Lincoln County Detention Center, 83 listed Ruidoso as their residence; 47 listed residence as Ruidoso Downs; 36 were from out of the county but within the

Two Arrested For Murder Of Ruidoso Woman

The search for missing 27 year old Elizabeth Ballard/Lankhorst of Ruidoso ended early Tuesday when police found her body in a shallow grave north of Tularosa.

Shortly afterwards two suspects. Chastopher Faviell. 32, Ruidoso, and Chaffles Martinez, 39, (residence not lifted) were arrested on charges of murder in the first degree and conspiracy to commit murder in the first degree. A warrant for the two men's arrests was signed by 12th Judicial District Judge Frank Wilson. Ruidoso police arrest ed Faviell and Martinez was arrested by Albuquerque police at a residence in Albuquerque.

According to police reports, about 8:50 a.m. Tuesday April 7. officers from Ruidoso police department and canine handler Robert Ferreyra of the New Mexico Corrections Department and his dog Opie, recovered the body of a young female they thought to be Lankhorst. The body was located in a secluded area off of Highway 54 on land that was previously owned by the family of suspect Faviell. A forensic anthropologist and a team of experts were sent to process the gravesite. Clothing remnants and personal items found at the gravesite were used to assist in identifying Ballard/Lankhorst.

Ballard/Lankhorst disappeared from her mother's home in Ruidoso on March 8 when she borrowed her

County Commissioners To Meet Tuesday In Carrizozo

County manager and jail administrator jobs will be under scrutiny Tuesday, when Lincoln County Commissioners meet in their chambers in the Lincoln County Courthouse in Carrizozo.

Starting at 9 a.m. commissioners will re-evaluate the county manager's position immediately after the pledge of allegiance, roll call and approval of agenda. County manager Frank Potter said he was not informed of why the item was added to the agenda.

Nunlev said he was asked to add the item to the agenda to answer some questions some commissioners have about the county manager's performance. Commissioner Monroy Montes requested the agenda item, said a source in the courthouse.

About two months ago county commissioners tried to give Potter a raise, but Potter declined because of the tight county budget.

At 1 p.m. is public hearing on proposed amendments to the Lincoln County Subdivision Ordinance.

After public hearing is request for summary review and plat approval for Jane Lewis and Jeffrey Allyn.

Consideration of bids/rpfs Commission chairman Ray include: bid for repair to Glencoe Rural Events Center roof; bid for metal building for clerk for storage of voting machines; bid for tractor for Glencoe Rural Events Center: bid for resurfacing county road D003 and Agua Fria subdivision; bid for operations and management of the Lincoln County Detention Center.

The Right To Vote



THOUGHTS

Dung Developers?

Next Tuesday the Lincoln County Commission meeting has an extra long agenda, which is nothing unusual. Re-evaluation of the county manager's position is the first item of business, as requested by county commissioner Monroy Montes. A couple of months ago the county commissioners wanted to give the county manager an increase in pay but county manager Frank Potter declined because of the tight county budget. Few people decline an increase in pay. Now "some" of the county commissioners have questions about the county manager's performance? Maybe they want to praise Potter for the presentation he made at the community update in Ruidoso last week about the county-wide 911 rural addressing system.

Tuesday's agenda also includes spending more money on the Sales Barn for the roof and a tractor. Wonder if "some" of the county commissioners will tell us what other expenses will arise for the Sales Barn that were not in the budget last year. Insurance money the county received will pay for the roof and some of the costs for the gold plated bathroom facilities but we haven't been told where the money will come from to pay the remaining costs for the rest rooms and to buy a tractor. "Someone" probably knows.

Privatizing the road department is another important agenda item. Years ago county commissions were road commissioners. Now it appears the Lincoln County Commission is considering changing that designation and eliminating maintaining county roads by privatizing road maintenance. Do you suppose the county is willing to be responsible for the quality of work when performed by private companies? Do you suppose the county will respond to complaints by residents about the roads or tell people to talk to the private contractors? Do you suppose privatization of county roads will mean the road department workers have more time to work at the Sales Barn? The new name for the road department could be the Horse Manure Picker-Uppers or the Dunghill Developers.

The Lincoln County Detention Center is also on the agenda and once again "some" of the county commissioners will tell the people why a country club type jail needs to be built to pamper prisoners by providing them with luxuries many people can't afford. There will be the usual double talk we've heard before from "some" of the county commissioners and members of the ad hoc jail committee about how much money the Village of Ruidoso spends to transport prisoners, even though the Ruidoso Police Department doesn't spend enough in transport costs to have a line item in their budget for transport costs. There will be NO mention that Lincoln County budgets ONLY \$14,500 each year for transporting prisoners. And Lincoln County pays most of the costs for transporting prisoners.

SANTA FE: Some state officials have been taking life a little too seriously.

Consider the events of just one week - April Fools week. no less, when everybody should have been prepared to react with good humor to unexpected events.

The week started with Taxation and Revenue Department Secretary John Chavez firing off a letter to Legislative Finance Committee Director David Abbey accusing his staff of inappropriate and illegal behavior punishable by a fine or jail time.

The LFC's crime was the filing of some bogus tax returns to test the tax department's new \$35 million avatem designed to recognize suspicious returns. The returns were filed under the names of Bozo and Bozette Clown, Rin T. Tin and Lassie Collie. The computer caught them.

So what's the big deal? Well, Chavez explained, if the computer hadn't caught them, the department would have been criticized. Apparently Chavez felt the criticism would have been unjustified. His department does have its own internal methods of testing its system, but an outside test by the body that appropriated the money for the computers seems like a reasonable activity.

Chavez points out that it is a felony to submit a false tax return, but the matter here seems to be one of intent. Had Rin Tin Tin been mailed a refund, it would have gone to the LFC's address and been returned — along with the fanfare that Chavez feared.

It wasn't as though the test was a surprise. The legislative staff had notified the tax staff of the test, but the fax folks wanted the LFC to use the department's testing method rather than its own and wanted to wait until they were ready to be tested. Perhaps there is a way for that to be done without the test being compromised, but it sounds as though the tax department wanted no surprises.

Chavez and Abbey are both pleasant people. Maybe their subordinates through whom the test was handled are graduates of the Lou Gallegos School of Tact. By the way, Gallegos, Gov. Gary Johnson's chief of staff, once was a very personable fellow. Maybe Gary's working him too hard.

Next it was Gov. Gary's turn to get more upset than he should when a reporter asked him about some of the daredevil activities listed on his web page. Among his listed accomplishments were hang gliding, bungee jumping and

the amateur record for rollerblading down Sanda Mountain. Johnson reportedly demanded to know which of his staff members had put that information on the Web. The governor says he has never bungee jumped. He has hang glided only once. And he doesn't hold any rollerblading records.

Johnson spokeswoman Diane Kinderwater says over the years various people have added to his Web page. I can imagine a proud staffer stretching the truth a little. Johnson has roller-bladed down Sandia Mountain. He received much publicity for his hang gliding adventure. And that scary ride he takes every year at the State Fair resembles a bungee jump.

Lt. Gov. Walter Bradley weighed in the same day with an over-reaction to a request for business cards to help a dying boy break a world record. Bradley sent a card and passed the request on to cabinet secretaries. One of the



More Students Are Attending Capitan And Ruidoso Schools

The Community Update, hosted by Ruidoso News, held in Ruidoso Civic Events Center March 31 gave area schools a chance to show their stuff.

Capitan Municipal Schools give students an educational experience in a small setting steeped in community values is the summary for the presentation offered by Capitan Municipal School District. Representatives presented a computer generated slide presentation of the district's missions, goals, student offerings and future needs. School superintendent Diana Billingsley presented statistics that showed Capitan schools enrollment has grown 180 percent in the last 20 years. In the last six years enrollment increased 33 percent. The school district ranges from north of the Capitan mountains, includes Capitan village, Alto Village, Ranches de Sonterra down into the north end of Ruidoso. ...

The Capitan Class of 1978 nad 15 graduates. This year 42 will graduate on May 23. Billingsley said the district needs more classrooms especially in the elementary and high school. In 1978 Capitan elementary had one class per grade. In 1998 there are four kindergartens, three first and second grades and two third, fourth and fifth grades. Next fall the district must hire another third grade teacher, Billingsley said. To make room for the new third grade class the elementary special ed class will be moved to the administration building

The high school needs more room to increase the variety of classes offered to students. There are needs district wide. including heating, air conditioning, landscaping and parking. Billingsley stressed the improvement in technology available to students, and added that it takes money to keep technology updated in the future. Billingsley said the school board has considered a bond issue to build a new high school to provide more classroom space.

The program highlighted district goals and missions of providing the best and safest teaching environment for all students and student offerings including extra curricular and student organizations.

Capitan School board members Beverly Calaway, James Hobbs and Freda McSwane answered questions after the slide presentation written by Borowski and directed by media assistant Sherry Gowen. They said the community and students at Capitan" have stressed the need for strong values.

An audience member commended Capitan schools for

their polite and neat students. In response to a question of why the high school did not have a full time counselor, Calaway said the main reason is the school's size. McSwane. said the board has heard parent input of how the counselor does not have enough time to provide counseling to seniors especially. This year the counselor was also athletic director and boys head basketball coach. "It usually comes to how we can afford to have a full time position and spread the other responsibilities around," McSwane said. "I believe it is very important to have a full time counselor. especially for the seniors."

Calaway said the board has budgeted a full time counselor for next school year.

Another audience question dealt with a concern for the bus stop at a restaurant and bar on Mechem Drive in Ruidoso. McSwane said there are few safe locations for bus stops on the highway between Capitan and Ruidoso, and those being used are the safest. McSwane thanked the property owners where the buses stop, and she acknowledged problems of traffic congestion and other situations.

Attorney Patricia Ortiz asked if the district had a GED program for kids who don't do so well in the regular classroom. Capitan schools refers students to the GED program with Eastern New Mexico University center at Ruidoso.

In response to a question about a possible bond issue, McSwane said the board needs more information on a possible bond issue, and how much the board would need for future needs. Currently, based on valuation and existing bonds, the district can only sell up to \$7.5 million in bonds. "We'll decide as a community," McSwane said. Calaway said the district plans to involve the community in future planning. Planning for the 1998-99

school year has been the topic of two school board work sessions. Billingsley told THE NEWS that the Capitan school board members committed to giving a nine percent across the board raise to all employees during their budget workshops conducted over the last two weeks. The state legislature passed a budget that included enough education money for the nine percent raise. A nine percent raise equals

to an additional \$322,000 media center director Becky needed to cover the raise and associated deductions and "We will receive benefits. "We will receive \$202,000," Billingsley said. The district will have to offset the additional \$120,000 need by taking \$97,000 out of a reserve operational building fund and other operational

New Capitan Post Office

Even though box holders will have the same number in the new post office as at the old post office, the old keys will not work in the new boxes. So starting at 8:30 a.m. Saturday, Currin will exchange keys, the old box keys for the new box keys. There will be two lines to the office windows in the new post office. The key exchange line be clearly marked with a sign. The other line will be for regular business.

Currin said patrons should get their mail at their old box before trading in their key. Otherwise that mail in the old box will take a few days to come to the new post office. "It will take only a few minutes to empty your old box before you trade your key," Currin said. "If I have to do it (empty the old box of mail), it . may take a few days."

Also, the only person authorized to exchange keys will be the person responsible for the box or a spouse. Currin said he will not allow children, friends or neighbors to exchange keys for box holders. Each box holder can exchange key for key up to two keys, or pay \$1 for each key issued.

Patrons who are unable to exchange keys on Saturday may do so later Currin said. However, they cannot get their mail at the new post office until they have a new

On Saturday, those who need a stamp and don't want to wait in line can utilize the new stamp vending machine located in the new lobby. Another new feature at the new post office are the 36 parcel post lockers. The lockers allow box holders to get packages after regular business hours. At the old post office packages larger than a box had to be picked up at the window. At the new post office, parcels larger than the box can be gotten out of a special parcel locker.

Patrons will be notified they have a parcel by the presence of a key in their box. Attached to the key are instructions of how the patron should check the locker with the corresponding number. For instance if the key indicates locker 8. The patron will take the key, open locker 8 and remove the package. The key, once turned, stays in the lock Currin asks that patrons who and can only be removed by must pay for a key to bring post office staff. Once turned,

(Con't from Page 1) the box door stays open and does not relock, in case the patron looses grip of the door and it swings closed.

Handicapped accessible, customer and employee friendly are the best terms for the new facility. Currin said he thought of his patrons in wheelchairs when he requested the special lower business window. Wheelchair patrons will also appreciate the lowered desk in the box area. Handicapped parking includes two wheelchair accessible spaces on the south side and two reserved spaces on the west side of the building closest to the boxes.

Along with the more than 1,000 boxes from the old post office, the new post office will

have 800 additional boxes available.

While there is plenty room in the lobby, which is illuminated by the south facing windows, some of the largest space is behind the scenes. The large working area features separate mensi and women's bathrooms, wood guard railing on all work area; walls, splash guards on doors, radiant floor heating and cooling with thermostat tim-: ers, a heated separate storage bay, and new work benches and sorting areas. The newfacility has so much space it would take four old post offices to fill it.

Some very behind the scenes features will make it: easier for repairs and save; money on utilities. All electric: plugs in the lobby will be turned off after business: hours to prevent theft of electricity and possible injury by: children. A utility hall gives. direct access to all plumbing.

Outside there will be: drought-tolerant landscaping on controlled drip irrigation; to be completed after the weather warms.

Even though they will have more room, there are no plans: to increase the number of: staff, Currin said.

Telephone numbers for the: post office also will remain: the same as now--354-2269.

The box lobby will be open: 24 hours and includes the vending machine and parcel boxes. The business window. hours will be the same as now 9 a.m. to 12:30 p.m. and 1:30. p.m. to 5 p.m. Monday through Friday and 8:30-11:30 a.m. on Saturday.

main topic of the April 16 regular school board meeting. Billingsley said the board plans to conduct a community meeting to generate ideas on spending sometime after the April 16 meeting.

Ruidoso Schools also presented a computer slide show of its district mission that all children can learn in a positive caring environment. Ruidoso Schools had a total enrollment of 2,429 this school year. The district has a 48.7 percent mobility factor, meaning the turnover of students year to year, due mostly to the community's resort situation.

Ruidoso School board president James Paxton said the district has zero tolerance to violence and destructive behavior. But it needs to work harder to get more community, involvement. The district wants full day kindergarten, but got no help with funding the full day from the legislature.

Of future needs, Paxton said the district is looking at building a school in Ruidoso Downs area. Work on plans for a cultural center begins this summer with construction set for the fall or next year. The district's valuation increased more than 20 percent this past year and the district had undertaken several major repairs including metal roofs at the high school.

Ruidoso school superintendent Mike Gladden said district enrollment is up nine percent over the last five years, but was slightly short of its projected enrollment this school year.

Ruidese School District ranks third in the state for average teacher salaries and fifth in the state for its training and experience, index for teachers. It is 73rd in its cost for administration per student, which means that most of its funding is going directly to student instruction.

The slide presentation highlighted all district schools.

At the noon luncheon several Ruidoso High School students made an emotional plea to the community to hear the voice of young people. As a result Ruidoso Mayor Robert Donaldson established a Mayor's Advisory Council on Youth that will include students from Ruidoso and Capitan and business and government leaders.



the idea of money going to the school districts. "So we should keep within the compound of the village," he said.

Trustees accepted Renfro's special police chief Carrol Durbin to represent the village, Maxine Schrup for the library, Angela Autrey for baseball, Larry Bandy from forestry, and Shorty Sanders for the fairgrounds. Village dlerk Deborah Cummins sugrested Durbin set up the first meeting of the committee.

Also at the special meeting, trustees approved pursuing a new general obligation bond for infrastructure needs. A \$600,000 village general obligation bond matures in July. If the bond was renewed it would not increase property taxes, Renfro said. He added that there will be numerous public hearings on the proposed bond issue which voters must approve at a special election. Cummins said a special election could only be held in October because of the June primary and November general elections.

Renfro said the bond money

because this year, the state legislature did not fund the village requests for city hall, police/fire station and museum. Village attorney Robert Beauvais said bond money can only be spent for things listed on the ballot.

Montes questioned if a \$300,000 bond issue would reduce taxes, but got no answer. Capitan Municipal Judge Jack Johnson said a village bond issue could affect the outcome of a bond issue election that Capitan school board is considering for February 1999. After some more discussion trustees unanimously approved pursuing a bond issue.

Capitan won't be able to keep police officers unless they pay a competitive salary, trustees agreed. At the time of the meeting, the village was down to just police chief Durbin who was on call 24 hours. The other two officers had resigned and the village was in the process of advertising for two replacement officers. Durbin said of the 10 certified persons who applied could go for infrastructure, he had three selected to interview. He said 24 non certified persons had also applied.

Montes suggested hiring one certified officer and one non-certified officer. Trustees agreed, if the budget allows, to pay more for a certified officer than previously.

Also at the special meeting, trustees accepted the proposal submitted by Engineering, Inc. to design the new well project. Proposals were submitted by Engineering, Inc. Dennis Engineering and, Livingston and Associates Trustees authorized negotiation with Engineering Inc. for the cost of the contract. Financing for the new well project comes from a Community Development Block Grant (CDBG) awarded last year. Engineering contracts can not exceed eight percent of the CDBG amount. Cummins said trustees were invited to sit in on the contract negotiations.

Trustees tabled action on selecting a proposal for the village master plan, until all evaluations were turned in from the committee. Dennis, Engineering, Inc. and Livingston also submitted proposals for the master plan.

In other business, trustees accepted \$25,000 from the state severance tax bonds. which was requested in 1997 for water improvements. Because it must be spent for water improvements, village maintenance supervisor Terry Cox suggested spending the money on special coatings for the water tanks.
