

# County Commission Passes Budget In Emergency Meeting

Tuesday night, Lincoln County Commissioners approved the 1998-99 final budget during an emergency meeting held in their chambers in the Lincoln County Courthouse in Carrizozo.

Commission chairman L. Ray Nunley opened the emergency meeting held at 6 p.m. Tuesday by saying he called the county attorney Alan Morel for his opinion whether the commission was within legal rights to hold an emer-

gency meeting for the budget approval. Nunley said Morel told him that the commission could hold the emergency meeting legally to approve the budget. Nunley said he then sought an opinion from another attorney who provides legal counsel for another county. Nunley said that attorney also said the commission was within legal rights to hold an emergency meeting to approve the budget.

Four of the five commissioners were in attendance, and

acting county manager Martha Guevara said she was unable to contact commissioner Monroy Montes. The county gave notice to the media on Monday about the emergency meeting on Tuesday night. By the commission's own open meeting resolution, they must give at least 24 hour notice on any emergency meeting. Emergency meetings can only be held when there is threat to the health, welfare and safety of the county.

Commissioner Wilton

Howell commented, "This is a self inflicted emergency meeting." He went on to say that when he left the special meeting on August 25, called to approve the final budget which commissioners failed to do, "I was angry, and I've been angry since then. That is not a good feeling."

Howell said the reason why he was angry was because he felt the process had been circumvented. "Not just the DWI process," he added. "We challenged the finance officer


and manager and I don't think that was right," Howell continued.

Howell said one reason he was angry last week was because he believed he had not received a copy of the final budget before the meeting. He said a copy of the budget was delivered to his place of business in Ruidoso where his office is being remodeled. "I found the (agenda) packet in my office," Howell said. "It had fallen between the desk and the file

cabinet."

"I apologize," Howell said. "It made me think of a lot of things." Howell said he had questioned commissioner Rex Wilson's seeking information about the budget before the meeting. "His questions made us uneasy about passing the budget then, which we were not more than 15 minutes away from passing," Howell continued. "But I wanted an

## CrimeStoppers Seek Information About Murder Suspects

Lincoln County/Ruidoso CrimeStoppers are offering a \$1,000 reward for information leading to the arrest of individuals suspected in the murder of a Ruidoso convenience store clerk last weekend.

According to a press release from Ruidoso Police Department, at 3:47 a.m. August 29, officers of the Ruidoso Police Department responded to a report of suspicious activity at the Allsup's store located at 127 Highway 70 west Ruidoso. Upon arrival, officers were unable to locate the clerk on duty and began a search of the store. The clerk was located in the men's restroom, an apparent victim of homicide.

The Lincoln County Major Crime Scene Unit, consisting of members of the Ruidoso Criminal Investigation Division, state police, and Lincoln County Sheriff's Office, was activated and responded to the scene.

The identity of the victim is (SEE PAGE 3)

## Special LCSWA Meeting Cancelled

A special meeting of the Lincoln County Solid Waste Authority was cancelled Monday, after a member questioned the legality of notification and the use of proxy votes.

According to Capitan Village Trustee Debra Ingle, who represents the village of Capitan on the Lincoln County Solid Waste Authority (LCSWA) board, she did not receive proper notice of the meeting which she had believed to be set for Tuesday, September 1. Ingle said at the August 17 LCSWA meeting, members agreed to meet every two weeks until Ruidoso had completed its transition from the authority. Figuring this, she believed the next meeting was to be Tuesday, Sept. 1.

Ingle said that no notice of the Monday meeting was called, mailed, delivered or faxed to her home or place of business or to Capitan village hall which she considers the proper place for notification of meetings to be delivered. Capitan Village Clerk Deborah Cummins said LCSWA did not fax or deliver any notice of the meeting to village hall. Cummins said LCSWA has not delivered meeting notices or agenda packets to village hall since Ingle was appointed to represent the village on LCSWA.

THE NEWS received a

faxed notice of the meeting. The notice states it was posted at 3:30 p.m. on August 26 by LCSWA office/personnel manager Beverly Foote.

But Ingle said they had agreed to meet on Tuesdays, and she had arranged her working schedule at her business, Smokey Bear Restaurant in Capitan, so she could attend the Sept. 1 meeting.

When she learned of the Monday meeting, Ingle said she requested Capitan Mayor Norm Renfro to attend with her proxy vote. Renfro and Capitan trustee Benny Coker did arrive at the Monday meeting, but the meeting had been canceled. Ingle was told that Renfro could not carry her proxy. Renfro was out of town and unavailable for comment at press time.

Ingle is also questioning the legality of the proxy vote, since Capitan, Ruidoso Downs and Carrizozo have only one voting member on the LCSWA board. "I'm bothered by the proxy vote, and I questioned our village attorney who also thinks the proxy vote is illegal since it can only be given to another member of the board," Ingle said. "Ruidoso has five members on the board and the county has two so one can give a proxy vote to another easily. None of the rest of the entities have that ability. So I questioned this."

Ingle has also requested a copy of the LCSWA Open

Meetings Resolution but as of Wednesday afternoon neither she or the village attorney Dave Thompson had received a copy.

LCSWA manager Jerry Wright was out of town and unavailable to comment on Wednesday. On Monday, Wright told THE NEWS that the meeting had been canceled because of the questions about the legality of the proxy vote and proper notice of meeting.

## Carrizozo And Hondo Schools Receive State Funding For Construction

Two Lincoln County school districts were awarded Public School Capital Outlay funding to be used for necessary construction projects.

Carrizozo School District was awarded \$600,000 and Hondo School District was awarded \$500,000 from the New Mexico Public School Capital Outlay Council. The council announced the awards on Wednesday, according to a release from Senator Pete D. Campos, D-Las Vegas.

The Public School Capitan Outlay Council is comprised of nine members including representatives from the legislative branch, executive

## Capitan Special Bond Election September 15

On Tuesday, September 15, the qualified voters in the Village of Capitan will be asked to vote on three bond issue questions totaling \$965,000.

Village Trustees authorized the bond issue election to raise funds to make needed improvements to the municipal water system, to acquire road equipment and to make improvements to public buildings. The village has been very successful in obtaining Community Development Block Grants (CDBGs) to finance several needed projects, including street paving, water storage tanks, waste water wetlands, fire hydrants and another well. Also the village has received Co-op funds from the New Mexico Highway Department for gravel on village roads. While the village plans to continue to seek these federal and state funds, some projects do not qualify for these programs. For example, the CDBG program will not fund improvements to village hall.

On the ballot, voters will find three questions to which

they may answer for or against. The first is: "Shall the Village of Capitan issue up to \$515,000 of general obligation bonds in one series or more for the purpose of enlarging, improving, extending or acquiring the municipal water system, including acquisition of water or water rights, necessary real estate or rights of way, bridges and easements and necessary apparatus for a water system, or any combination of the foregoing?" The question asks voters to approve \$515,000 in bonds so the village can finance the drilling of a new water well and/or installation of one or two additional 100,000 gallon storage tanks to regulate pressure and water flow to the subdivisions.

Question two is for road equipment: "Shall the Village of Capitan issue up to \$200,000 of general obligation bonds for the purpose of purchasing heavy equipment for use in laying off, opening, constructing, repairing and otherwise improving municipi-

## Industrial Accident In Ruidoso Claims Life Of Alamogordo Man

An Alamogordo man lost his life in an industrial accident that occurred at 8:45 a.m. Tuesday at the White Mountain Elementary School complex in Ruidoso.

According to police reports, 24 year old Alex Joseph Romero of Alamogordo was in an eight foot deep ditch installing plumbing when the sides of the ditch apparently collapsed, burying him. Police speculate that the dirt beside the ditch was saturated with moisture from the summer rains and was unstable, causing it to collapse.

Romero was working for Lane Plumbing of Alamogordo.

Police say that when the accident occurred Romero's co-workers and school staff tried to rescue him. However he was pronounced dead at the scene when Ruidoso EMS and police arrived.

opportunity to vote on the budget."

"Wilson had every right to ask those questions," Howell said.

Howell went on to say that, "Things were said about the manager and finance officer that should not have been said."

As for questions about the budget, Howell said the commissioners need to work through the process and get answers to their questions

before meetings. "I've gone over the budget several times since that meeting," Howell continued. "We asked a lot of departments to cut their budgets. Two departments we asked hard—maintenance and the clerk's."

He went on to say that the clerk has continued to live within her budget and has turned back money at the end of the fiscal year, even though the clerk's office budget has been cut nearly \$9,000 from

two fiscal years before. The only department not cut was the sheriff's office.

"We've asked many to sacrifice, except the commission," Howell continued. The commissioners budget increased \$3,000 this fiscal year from last fiscal year from \$90,000 in 1997-98 to \$93,000 in 1998-99. "If we ask others to tighten their belts, then it's time for us to tighten ours." He proposed cutting commissioners mileage and per diem from the \$10,000 listed to \$5,000 or \$1,000 per commissioner.

Last year commissioners spent \$7,018 for mileage and per diem, excluding airplane tickets. According to finance officer Punkin Schlarb, Wilson requested reimbursement of \$1,994, commissioner Bill Schwettmann requested \$1,559, Nunley requested \$2,365, Montes \$100 and Howell nothing. According to the a commission resolution, commissioners are entitled to mileage if they meet outside their commission district. "I think part of being a county commissioner is coming to the meetings," Howell said. He said that the resolution establishing mileage and per diem reimbursements states that each commissioners' district is the place where we do business. "But I think the place of doing business is the courthouse, since we are required by law to meet here at least four times a year," he said.

Howell then made a motion to reduce the per diem and mileage to \$5000. He got no second.

Schwettmann said that some don't realize that some of "us" are in the courthouse three to four days a week. "You're seldom here except for meetings," Schwettmann said to Howell. "I'd like to go all the

attorney fees for the last six months per individual," Schwettmann said. He went on that he had no apology for taking the mileage. "Now if you had said give back the salaries, or per diem, I'll do that," Schwettmann continued. "But some of us use it and use it well."

Schwettmann then offered to provide a complete list of his mileage and per diem reimbursements for the last 5.5 years. He then said how Howell takes an extra \$5,000 for health benefits on his salary when he takes no benefits. "It all balances out. I'm getting tired of this goody, goody stuff which is all air and no substance," Schwettmann said.

"I believe you missed the point," Howell responded. "You might be better off if you did consult the attorney for his services."

"What are you talking about?" Schwettmann wanted to know from Howell.

"The point is," Howell responded, "We asked a lot of departments to take cuts. We need to cut. I'm not trying to pinpoint who, we just need to cut expenses and I'm trying to talk about setting examples."

Nunley then interrupted and directed discussion back to the budget resolution. "Didn't we already approve the budget?" Schwettmann asked.

But commissioners had not approved the final budget. Nunley asked if county treasurer Joan Park had any comments about the budget. Park who was unable to attend the emergency meeting had left notes for her staff member Glenna Robbins who said that Park had gone over the budget with Schlarb.

Schlarb said after all the changes were made last week, she doubled checked finding some errors. One area in question was the 414 fund for facilities expenditures where a purchase order had been issued to pay for the radio repeaters on Buck Mountain. Schlarb said the purchase order for the two repeaters is still outstanding and not paid. The generator was paid for in the last fiscal year which was shown in the 414 fund audit.

Schlarb said the contractor advised her Monday that the repeaters were up.

Wilson also questioned \$8,651 in data processing, which Schlarb said was for the Global Information System used in the assessor's office.

Howell again tried to reduce the mileage and per diem for commissioners by \$2,000 by offering to not take the \$2,000 budgeted for himself. "As I don't intend to take mine this year," he said.

Lincoln County Clerk Martha Proctor suggested the budgeted mileage and per diem for Howell be used as a savings account to be carried over to the next fiscal year.

County resident E. J. Fouratt asked what the ending balance from last year is, which Nunley said has been several different amounts ranging from \$300,000 to \$160,000. Schlarb said for all departments and funds the ending unspent, unbudgeted balance is \$3,502,162.96. For the general fund, the ending unspent, unbudgeted balance is \$199,647.06, Schlarb said.

Fouratt suggested commissioners give the vehicles to the sheriff's office and employees a three percent raise beginning October 1. "You've got the money and these are righteous expenditures," Fouratt said.

Schlarb then said that she had called each of the commissioners to ask if they had any changes to make to the budget before the meeting and each of them had said they had no questions. "So I request you approve the budget now, as presented," she said.

Wilson made the motion to approve the final 1998-99 budget as presented, Schwettmann seconded the motion. Before they voted, Janice Silva, sheriff Tom

Sullivan's administrative assistant asked on behalf of Sullivan, who was unable to attend the meeting because of a flat tire, to allow a transfer to the secure fund to allow purchase of a four-wheel drive four door vehicle. "This will not affect the final balance," Silva said.

Nunley then tried to make a motion to allow this, but the motion to approve was on the floor. Nunley then suggested amending the motion, but Schwettmann said they had "massaged this till our tempers are raw. The budget is an estimate of money received and spent. It is a calculated guess of the cost to do business. We know we will make budget adjustments. We need to get this budget approved, or DFA will come down here and they'll run the departments."

With that Nunley asked for the roll call vote required for resolutions. Nunley, Schwettmann and Wilson voted yes, Howell voted no. Then they adjourned at 8:28 p.m.

The 1998-99 final budget approved lists general fund expenditures of \$3,156,652 and general fund revenues of \$3,717,906, with an ending cash balance of \$793,391.48. The required cash reserve for the general fund is \$789,162.91.

The grand total budgeted expenditures for all funds including general fund, grants and special programs including Lincoln County Medical Center (LCMC) and Carrizozo Health Clinic and the special remodeling project at LCMC, are \$10,246,558. Revenues for all funds and programs are budgeted at \$8,254,493.

pal alleys, streets, public roads and bridges?" The village is seeking to purchase road equipment such as a blade, roller and water truck needed to continue to provide maintenance for village streets. Village gravel roads could benefit from the use of a steel roller to smooth out "washboards," said the village road supervisor during the last trustee meeting.

Question three is for public building improvement bonds: "Shall the Village of Capitan issue up to \$230,000 of general obligation bonds for the purpose of constructing, purchasing, rehabilitating, or remodeling, or any combination thereof, public buildings, including additions and improvements thereto?" The village proposes to use the funds to improve village hall with offices, storage, handicapped access restrooms, map room and conference room.

Village hall is in need of improvements. The facility has had little done to it since it became village hall in the 1980s. Anyone who has attended a village trustee meeting knows there is limited space for the public to sit. Sometimes residents stand in the back of the room, with no space left to place another chair.

According to a brochure produced by the Bond counsel, approval of all \$963,000 in bonds will increase the village property tax rate by \$2.00 per \$1,000 of assessed, taxable property valuation. The current tax rate is \$9.092, and if all three bonds are approved the new tax rate will be \$11.092. During the meeting where trustee authorized the bond election, bond counsel said if only two of the three bond questions are approved, property owners could realize no increase of taxes over the current level. This is due to

an old bond that expired in July. If voters turn down all the bond questions, they will see their taxes decrease by \$2 per thousand dollars of taxable value from the current rate.

Examples of what will happen to property taxes if voters approve all three bond questions are: if the full value of a property is \$25,000, then the increase in tax per \$1,000 of assessed value of the property (which is one-third of the actual value) is \$16.67 a year; if the property is valued at \$50,000 the tax will increase by \$33.33; if the property is valued at \$75,000, the property tax will increase by \$50; if the value is \$100,000, the

property tax will increase by \$66.67; if \$125,000 the property tax will increase by \$83.33; and if \$150,000 the property tax will increase by \$100 a year.

Trustees authorized the bond issue based on actual need. They realized that without the extra funding, the village cannot afford to upgrade the water system, or upgrade its village hall facilities or purchase road equipment. Upgrading village hall and purchasing road equipment are not eligible for CDBGs or state funds. Village trustees expect to sell the approved general obligation bonds in November.

How many bonds, if any, will be sold is now up to the voters.

On the special election day, Tuesday, September 15, polls will be open from 7 a.m. to 7 p.m. at the Lincoln County Fairgrounds office. Only registered voters who reside within

the village, or Lincoln County residents who own property within the village, can vote. Lincoln County residents who own property in Capitan, but do not live there, can cast a ballot by requesting and filling out a non-resident form. The forms are available from the village clerk at village hall anytime during regular working hours.

Voters may also cast absentee ballots. The deadline for absentee voting in the special general obligation bond election is at 5 p.m. Thursday, September 10. Absentee applications are available from the village clerk at village hall or by writing PO Box 246, Capitan, NM 88316.

branch, state department of public education, the state school board and the school boards association. School districts that are indebted more than 75 percent are eligible to apply for the grants from the council.

Funding for the capital outlay projects comes from legislative appropriations from the state general fund, the sale of severance tax bonds, lottery proceeds and the proposed sale of general obligation bonds that will be on the November ballot.

### Judges may appear

The Lincoln County Commissioners meeting Friday, Sept. 11 should be very interesting. One agenda item could be for the judges to address the statements made by county commissioner Wilton Howell at the June 29, 1998 county commission meeting. All the judges, including the four district judges from the 12th Judicial District, the two Lincoln County magistrate judges, and three or four of the municipal judges in municipalities in Lincoln County may be at the meeting. Plan to attend if you want to know what happens, what subjects will be discussed, and who gets mad again.

Another agenda item will be the grant funded senior programs as requested by county commissioner Morrey Montes. If you care about continuing the senior programs in Lincoln County you should be at the meeting and tell the county commissioners. The senior programs provide a necessary service for senior citizens and should not be jeopardized because someone is mad about something else.

Keeping private business separate from public business is one thing all elected officials need to do. Private grudges should not be the basis for making any decisions that affect the public they were elected to represent. When an elected official uses his or her office to "get even" with someone or some group, the entire democratic process is tarnished. When an elected official uses his or her office for revenge the public is deprived of a fair and just government.

Effective government can be achieved only if elected officials do the job they were elected to do. Approving a budget each fiscal year, and spending taxpayer money in a prudent manner is one of the most important jobs facing county commissioners. Tuesday the 1998-99 fiscal year budget was finally approved at an emergency meeting. We fail to see why it was an emergency to approve the budget Tuesday and wonder how approving the budget qualifies as a threat to the health, welfare and safety of the county, which is supposed to be the basis for an emergency meeting. The budget could easily have been approved at the August 25 meeting or it could have been approved at a special meeting later this week, instead of calling an emergency meeting just to approve the budget.

Cooperation was the main factor in reaching an agreement on the budget. Cooperation will also be a main factor in reaching agreements on other important county issues and that cooperation can be achieved only if business is conducted properly instead of the bickering that has been evident in recent county commission meetings. Disagreements are one thing, but bickering in public?

Actions taken by the county commission affect the residents and one of the most important actions commissioners may take soon is deciding where to build a new jail. We don't know when the report from the consultants will be released but there are many rumors that the decision has been made in advance. Some people insist the evidence is in favor of building the new jail in Carrizozo and others say the new jail will be built in the Grindstone Dam area in Ruidoso, while some think it will be built on Fort Stanton mesa.

Recommending a location and methods to pay for building a new jail and suggestions for management of the jail are supposed to be in the report with estimated costs. The county commission is supposed to make the decision based on those recommendations.

Everyone with concerns about Lincoln County should plan to attend the county commission meeting Friday, September 11 in the Lincoln County Courthouse in Carrizozo at 9 a.m. Agenda items could include judges, senior programs and maybe the new jail.

#### Letter to the Commissioners: OF LINCOLN COUNTY

On August 11, 1992, I met with an inmate at the Lincoln County Detention Center who presented to me that he was happy that his schizophrenia was coming out of his ankle. I asked him if he would mind showing me, and he immediately pulled down the three tube socks he was wearing, exposing a two-inch open, weeping infection in his ankle. He was happy, again explaining that he was sure this wound was the evil mental illness leaving his body. Medical attention was immediately sought by the Detention Center Administrator, then Wayland Hill. This was my first time in the detention center, and I was overwhelmed by how this facility was underserved in the needs of the mentally ill population, and that services were mere, at best. At that time six years ago, I have made a commitment in serving the county as a mental health crisis intervention professional.

I find it to be a sad day when six years later, my credentials are in question, and not only are my qualifications questioned, I was not afforded the courtesy of a phone call or letter to address this. Rather, I read about it in the newspaper. I am enclosing a copy of my transcripts from Graduate School, as well as copies of my diplomas from both undergraduate and graduate school. I am also enclosing my resume, proof of professional liability insurance, which was effective the same day I opened my private practice. I am also providing a copy of my business license, as well as my Independent Social Work License. I would like to take this opportunity to remind you that I did include all of these documents to you when I first applied for the contract with you in July, 1996.

When I attended the preliminary budget hearing as you requested in May, 1998, I was commended on the job I do for the County, stating "... You save lives in our county," and I was informed that the letter of commendation from the Sheriff's department that included me was read aloud at your previous meeting. I was asked if I was being paid enough, and again asked if I needed any more money, which I declined, adding that I am satisfied with my contract just as it is. I added that if anything was changed, I would like to be considered for Health Insurance Benefits, at which time I was reminded that I am not a County employee, so this was not an option. I was content with that decision.

Since I began my private practice, Better Days: Treatment & Crisis Management in December, 1996, I provided mental health counseling, substance abuse assessment/referral within the detention center, and crisis intervention

## Inside The Capitol

**SANTA FE:** Lt. Gov. Walter Bradley says he doesn't know of any other governor- lieutenant governor relationship, at least back to the 1970s, that was as good as the one Gov. Gary Johnson and he have.

I agree. And most of the credit probably goes to Bradley for understanding the role of a lieutenant governor. Johnson has demonstrated an inability to get along with the other two branches of government. In an unprecedented action, the state Supreme Court declared him in contempt. Democrat legislative leaders hold a similar contempt. Republican leaders often are unhappy with him, but keep their feelings to themselves. And the governor has fired members of his personal staff and cabinet who have disagreed with him.

Gov. Bruce King's last term was marked by an amazingly stable staff and cabinet — and the most unstable relationship between a governor and lieutenant governor the state likely has ever seen. That includes the days when governors and lieutenant governors ran separately and sometimes were of opposite parties.

Lt. Gov. Casey Luna's problem was that he couldn't wait to be governor. Like Johnson, he'd been his own boss for so many years that not being the top dog really bothered him. Luna viewed the lieutenant governor's job as being a deputy governor, the governor's top aide, who would participate in running government and who outranked everyone on the governor's staff.

But that's not the way our founders envisioned the job. Lieutenant governors were to preside over the Senate and to take over when the governor left the state or if he died. It wasn't until 1971, when Lt. Gov. Roberto Mondragon talked his old legislative buddies into making it an optional full-time job, that lieutenant governors even came to Santa Fe except for the legislative session.

Former Lt. Gov. Tibo Chavez, a Belen lawyer, used to joke that his duty as lieutenant governor consisted of calling Santa Fe every morning to inquire about the governor's health and upon finding that Gov. Ed Mechem was still in fine shape, he could roll over and sleep a little longer.

Gov. Garrey Carruthers and Lt. Gov. Jack Stahl had a congenial relationship. Stahl didn't take the full-time option and drove up from Albuquerque to Santa Fe only

for cabinet meetings and to take over when the governor left the state. Carruthers said Stahl contributed many excellent ideas at meetings. But Stahl was much more conservative than Carruthers.

The philosophical rift never showed except for the time that Democrat senators rigged the vote on a budget bill supported by Carruthers so that Stahl had to break the tie. Stahl voted against the measure, forcing a controversial special session.

Gov. Toney Anaya and Lt. Gov. Mike Runnels had an amazingly good relationship considering their fiery personalities. Runnels was a very active lieutenant governor, indicating the two had carefully hammered out the areas in which Runnels would work.

Gov. Bruce King's two terms with Lt. Gov. Roberto Mondragon exhibited few outward signs of tension — until Mondragon ran against King as a Green candidate for gov-

ernor many years later.

Gov. Jerry Apodaca and Lt. Gov. Bob Ferguson had a good relationship. Ferguson stayed in Artesia, tending to his considerable business interests and didn't take the full-time option, thereby lessening opportunity for a clash. At the end of their term, Ferguson competed with former Gov. Bruce King for the Democrat gubernatorial nomination, with Apodaca's strong support.

Lt. Gov. E. Lee Francis wasn't Gov. Dave Cargo's choice for a running mate. This was before the full-time option so Francis wasn't in Santa Fe often, which probably was just as well.

Republican Gov. Ed Mechem got along reasonably well with his two Democrat lieutenant governors but was much happier when he could serve with Republican Tom Bolack, who later appointed Mechem to the U.S. Senate.

## Free Parking At Bonito Lake To Be Eliminated

The Lincoln National Forest will begin reconstructing the road around Bonito Lake in early November.

The reconstruction is intended to widen the road to make it safer and to benefit the riparian area of the lake by retaining the crumbling and eroding lake side below the road. But the end result will take away the free parking areas currently used by people who fish the lake and by many who just park and enjoy the views.

While parking areas were listed as alternatives for the project in the US Forest Service Lincoln National Forest draft environmental assessment, that alternative was dropped in favor of "drop off areas," said Lincoln National Forest District Ranger Jerry Hawkes. The drop off areas will be located along the half mile stretch from Littleton Canyon to where Bonito River enters the lake. City of Alamogordo, that owns the lake and surrounding properties, plans to construct stairs for access from the drop off areas to the lake side.

No fee will be charged for persons who briefly stop to sightsee or to drop off people to fish in those drop off areas, Hawkes added. But long term parking by the lake will be allowed only in a designated parking area at the mouth of Kraut Canyon, owned by the

City of Alamogordo, where a fee will be charged. The parking lot is about a half mile from the lake side.

Notice of the intent to reconstruct the road around Bonito Lake was published in the Alamogordo Daily News on July 7. The public was given 30 days to comment on the project, but no comments were received. Hawkes said the notice was published in the Alamogordo Daily News because the project was approved by the forest supervisor whose office is located in Alamogordo.

The project was brought to the attention of THE NEWS by Robert Runnels whose family has owned property above Bonito Lake for generations. Runnels is concerned about the city of Alamogordo's plan to charge fees to park, especially since the city raised

# Capitan Trustees Split Vote Over Well Bids

The Village of Capitan has a Community Development Block Grant (CDBG) to drill another water well and to install 15 new fire hydrants.

But when the bids came in on the well project both exceeded the costs estimated by

the village and its engineer. Trustees, during a special meeting Monday, considered then rejected on a two to one vote the two bids it received from K.D. Huey Drilling of Capitan and Baylik Drilling of Rio Rancho. Huey had bid \$156,980 and Baylik bid \$172,500. Included in the bids

were alternates in case the drill site does not produce water.

The engineer's estimate on the project was \$115,000, but only after village staff worked with the firm to reduce the estimated costs of several

items. Originally the engineering firm had estimated the cost of the well from \$150,000 to \$175,000.

Trustee Leroy Montes, who works for Alto Water Company, said his company drilled a similar high volume well for

thousands less than the bids. "I think the bids are over stacked," Montes said. He thought the engineer's specifications were too extreme.

Trustees then asked the opinion of village water department supervisor Terry Cox. The second well will be used alternately with the existing well, Cox said. He thought the engineering firm had too much information, but he defended the bidders who had to work with the specifications given by the engineer. Cox thought trustees could negotiate the bids to a lower price on several options, such as the size of the casing and testing. "I feel a lot of stuff could have been done differently," Cox said.

However, the village must have an engineer for all CDBG projects. Because of problems with the engineer's estimates, the village had postponed bid openings three

Village clerk Deborah Cummins said there were

areas in the engineer's estimate they thought were too high and that was why they had worked with the firm to lower the estimates.

Trustee Benny Coker said the testing could be done by the state environment department to save money.

Cummins suggested trustees accept the low bidder then negotiate to bring down the prices. If they could reach no agreement with the lowest bidder, then they could negotiate with the second bidder. If then no satisfactory price could be reached, trustees could reject the bids and advertise for more bids.

But trustees wanted a lower well bid, so any funds left from the well project could be applied to installing additional fire hydrants. The village has the \$268,000 from the CDBG plus the \$13,400 village match for the well and hydrant projects. The engineering firm, Dennis Engi-

to Lincoln County with no contract until August, 1996. During that time, I provided about \$13,000 worth of services with no compensation, and never asked for any. I was awarded the Mental Health Contract for \$10,000, and continued to provide services. At the end of the 1996-97 fiscal year, I provided figures indicating that I had provided more than \$23,000 worth of services, requesting my contract be considered for increase to \$20,000. This request was approved, and I continued to provide services for this past year.

No, I did not offer figures to you at the end of this past fiscal year, and I was never asked to. In answer to the concerns of "some of the commissioners" (Monroy Montes and Wilton Howell) regarding who monitors my work, I would answer that the Detention Center, Sheriff's department, Magistrate courts/judges, District court/judge, District Attorney's office, Public Defender office, and family members of suicidal/mentally ill individuals all monitor the work I do. If I was not doing my job, you would be the first to be informed. Since I read the article in The Lincoln County News, I have compiled figures to indicate how many hours I worked to fulfill this last year's contract, which I have enclosed. In the process of putting this together, I realized how many more hours I (again) provide to the county with no compensation, this year nearly \$9,000 over the contract limits. It is for this reason I do not bill the county at the set hourly rate, as I would run out before the end of the fiscal year. Since the hourly rate was also mentioned, let me remind you the competitive hourly rate runs between \$65-90 for my colleagues with the same credentials. The hourly rate I charge the county does not take into consideration that I am on call 24 hours a day, seven days a week, 52 weeks of the year. I am called out on emergencies in the middle of the night, weekends, and holidays, for which there is no extra compensation, not to mention the fact that I am required to be AVAILABLE AT ALL TIMES.

In general, the clientele I serve is typically defensive and skeptical to begin with. I do not need for two of the commissioners to publicly discredit the work I do and the services I provide. If you have personality problems regarding me, I would ask that in the future, you keep your PERSONAL problems to yourself. If you have any further PROFESSIONAL questions or concerns that I have failed to address, please feel free to contact me by telephone or letter.

its rates for picnicking and camping this year. Runnels said Bonito Road is in bad shape and needs work, especially below the lake and above the lake to Bonito Stables, but the road around the lake where the project is planned is in good shape.

Hawkes told THE NEWS that the Forest Service only owns the rights of way to the road around the lake and not for the three miles from Highway 37 to the dam. Two years ago, the forest service, City of Alamogordo and County of Lincoln were negotiating to upgrade the three miles from Highway 37, but negotiations deteriorated and were never resumed.

The Bonito Lake road reconstruction project does include widening the steep section of road that climbs up from the river valley to the dam, but does not include the section of road that goes to the forest service owned South Fork Campground. Hawkes said eventually the forest service plans to redo the road to South Fork Campground.

Money for the road project is coming from a Lincoln National Forest budget special fund for road construction and riparian improvement.

Hawkes said currently the forest service does not charge to camp or picnic on forest owned lands except at the developed South Fork Campground. However, the service plans to start charging fees to picnic and camp on forest lands, including Argentine Canyon, under the Fee Demonstration Project. Hawkes did not say when the Fee Demonstration project will begin.

The Fee Demonstration Project returns 90 percent of all revenue collected back to the area to be used for improvements. So far this year the forest service has collected about \$30,000 from fee demonstration areas. Hawkes continued. Currently he is working on a list of projects the public wants, such as handicapped access and showers at South Fork Campground.

Elsewhere in the Lincoln National Forest the service is

reworking the parking and viewing area at Windy Point and reconstructing the road and camping areas at Oak Grove both located off the Ski Run Road.

neering will get a set fee of \$30,000. Under the terms of CDBG, the village has 16 months in which to complete the two projects.

Coker said he thought there were ways to reduce the cost of the well so the extra funds could be put toward more fire hydrants. The fire hydrant project calls for installation of 15 hydrants.

While Cummins convinced trustee John Whitaker to negotiate a lower price, Montes and Coker wanted to reject the bids.

Fire chief David Cummins said that whenever projects involve the government, the bids will be higher than in the private sector.

Cox said village staff will have to get with the engineer to come up with different specifications that will cost less. Cox also said at his urging the specifications call for equipment that is compatible with the equipment in the existing well. Plans are to drill the new well about 400 feet away from the existing well that is located north of Highway 380 about four miles east of the village.

Cummins said that the village will not pay the engineer any extra than the set \$30,000 fee for any changes or redefining of specifications.

Coker made the motion to reject the bids, Montes seconded it. When they voted,

Montes and Coker voted yes, Whitaker voted no, saying he preferred to negotiate the price with the low bidder in order to get the project going. Capitan Mayor Norm Renfro, who can only vote to break ties, preferred accepting the bid and negotiating. Trustee Debra Ingle was absent from the meeting.

Renfro said trustees and Cox should meet with the engineer to reduce the estimated cost. Cummins said trustees need to read the specifications as written now before they meet with the engineer. "So you can say this is what we want, or we will get another engineer," she said.

Trustees did accept the low bid from Smithco for \$47,420 to provide and install 15 fire hydrants. The village received six bids ranging from the low \$47,420 to a high of \$59,400. The project includes all plumbing, installation and repair of pavement.

In other business, trustees:

-Approved David Cummins

as fire chief, which is annually required by the state fire marshal.

-Discussed purchasing equipment and authorized getting two additional bids on a boring machine and quotes on a steel roller for the road department to smooth out washboards on gravel roads.

-Authorized holding public hearing on changes to the village criminal code at the regular September 14 meeting.

-Heard resident Wayne Mason ask for animal control to curb the dogs running at large. He said he was tired of picking up after everyone's dogs who come into his yard. Renfro said all three police officers are authorized to be dog catchers and he would meet with them the following day about the matter.

-Met in closed session to discuss pending litigation.

-After closed session voted unanimously to be a party, at no expense to the village, in the Gas Company's lawsuit.

## Capitan Accepts Well Bid From K.D. Huey

Capitan Village Trustees held a special meeting Tuesday and accepted the bid to drill a new well from K.D. Huey Drilling of Capitan.

According to village clerk Deborah Cummins, trustees rescinded the motion they made at the August 25 meeting to reject the two proposals for the well project because the bid amounts were much higher than the engineer's estimate. At the September 1 meeting trustees discussed the proposals with the engineer and expressed their concerns about the prices quoted by the two well drilling companies. During discussion trustees learned that the company awarded the bid for the fire hydrant project could not delay construction because it had other jobs waiting. Since any funds left from the well project were to be applied toward installing additional fire hydrants, trustees voted unanimously to accept the proposal for the well project from Huey Drilling and to negotiate the price.

While trustees recessed to an executive session to discuss personnel problems, the engineer and Huey negotiated the price of the well project to \$132,380. Trustees did not award the alternate to the bid that provides funds to drill at another location in case the first hole does not produce water. Cummins said trustees decided to wait and see what happens with the drilling

before they take action on an alternate.

A preconstruction meeting will be held with the engineer, trustees and Huey on September 10.

Also after the closed session, trustees voted to hire a temporary part time person for the Smokey Bear Museum and to send a letter of termination to police officer Rick Overmier, effective Sept. 2.
