Carrizozo Considers Water Conservation

Water conservation in Carrizozo and adopting a water conservation plan was discussed at the town council meeting Tuesday, May 14.

Cathie Eisen, water operator level III for the town, reported that the two town wells have been affected by the drought. Apparently there has

been a slight drop in production at the two wells and they are not pumping as much as they had been previously.

Eisen told The NEWS Wednesday that the wells are adequate for now but that another well and additional storage is needed. The town had applied to New Mexico Finance Authority for funding, but that applica-

tion was declined. Eisen said the town will apply again. The town has ample water rights to drill another well but will need to apply to the state engineer before any actual drilling begins.

The water conservation plan for the town was discussed but approval could not be given because it would have to be compiled as an ordinance with advertised public hearings and time for public input before the ordinance could be approved.

The water contingency ordinance for the town will be considered at a meeting of the town council sometime in the future. The ordinance will be about water conservation and have three phases; phase I will be

Trustees developed the preliminary budget at a special budget workshop held May 7. The prelum: nary budget includes salaries for the existing employees and an additional \$30,000 for a village administrator. At the May 7 workshop, trustees put the \$30,000 salary for the administrator in the executive and leptile tive fund which is for the mayor and trustees But at the May 14 meet ing, trustee George Tip pin asked for and got the \$30,000 placed in the financial/administrative line item. At 2 p.m. today, Thurs. day. May 16. Lincoln County Commissioners will hold a public hearing. on the preliminary 2002 2003 fiscal year budget, during the regular May county commission meet ang held in the lancoln County Courthouse in Carrizozo

County commissioners

worked on the preliminary budget during a budget workshop held May 2 in their chambers in the Lincoln County Courthouse in Carrizozo. Projecting a four percent

growth in revenues, commissioners county gave their tentative nod to the preliminary 2002-2003 budget that projects total budgeted revenues of \$13,041,361 and expenditures of \$14,301,641.

Of the total, the county general fund (which operates county government) is projected to have revenues of \$5,559,651 and projected expenditures of \$3,900,091 which includes \$1,669,463 in transfers from the general fund. The general



preliminary In the budget developed at the May 2 workshop, the budget shows that of the \$1,669,463 transferred from the general fund of that \$804,198 goes to the road fund, \$11,455 to the RC&D fund which helps pay the RC&D secretary, \$100,642 for various special agreements, \$31,000 for the county's match to legislative appropriations, \$737,778 to corrections/detention center. \$10,000 to the re-appraisal fund, \$100,650 to the emergency management system (ambulance services), \$100,000 for the juvenile detention fund, \$9,000 for the CLG historic grant for Lincoln, \$51,250 for the one eighth of one percent statutory reserve fund for the jail loan.

One major item of discussion at today's 2 p.m. public hearing will be how much hospital mill levy to set for the coming tax year. Since the Medicaid and Sole Community Provider payments are coming out of the indigent health care fund (which comes from gross receipt taxes), my recommendation is to take the clinic mill levy to .5 and the hospital mill levy to 1.0 for the coming tax year," wrote county manager Tom Stewart to county commissioners.

At last years mill levy amounts, the county was projecting \$642,697 in revenues for the Carrizozo/Corona and Hondo health clinics \$1,078,550 for the Lincoln County Medical Center (LCMC).

At the May 2 budget workshop county commissioners did not address the hospital mill levy, although Stewart suggested the amount of mill levy be lowered this coming tax year because the fund is "extremely

healthy." LCMC has requested \$800,000 from the mill levy fund to remodel the hospital for an outpatient ambulatory surgery area. Originally LCMC requested \$600,000 for the project. With the \$800,000 request from LCMC. the hospital mill levy fund has a carry over of \$1,718,750. County commissioner Leo Martinez said the commission needs to take a hard look at the increased reauest.

County commissioners also briefly discussed the county Indigent Health Care Fund, which Stewart considered *verv healthy". County commission chair Rex Wilson asked if the county could not collect the one-eighth of one percent gross receipt tax (which provides revenue to the fund set aside for low income county residents) for one year, because the fund is so healthy.

County attorney Alan Morel, Stewart and county treasurer Joan Park all said the problem is the fund can only be implemented once every six months, and must be collected for six months before using the reve-

Also in the preliminary budget developed May 2, the county is projecting receive additional revenues that are not part of the general fund. Budgeted revenues include \$49,200 in recording fees; \$238,832 for Bonito Fire Department: \$39,701 for Hondo Fire Department: \$42,848 for Lincoln Fire Department;

\$31,438 for Nogal Fire Department: \$40,236 for Glencoe Palo Verde Fire Department; \$28,539 for White Oaks Fire Department and \$27,939 for the Arabella Fire Department. All fire department budgets are "flow through" money that the county receives from the state and distributes to each of the volunteer fire departments.

Other revenues that come to the county include \$33,403 for the RC&D fund; \$880,376 from legislative appropriations, and \$177,000 from special gas tax; \$17,093 for Predatory Animal Control: \$10.544 Forest Title III; \$75,900 for Lodgers Tax Fund; \$551,000 from corrections (housing of federal prisoners); \$7,000 from inmate care; \$142,865 from the drug enforcement grant; \$114,00 from the re-appraisal fund (collected from property taxes); \$7,123 from services provided by Capitan ambulance; \$10,000 from services provided by Carrizozo ambulance: \$6,500 from services provided by Corona ambulance: \$6,518 from services provided by Hondo ambulance.

Other revenues include \$482,631 from the Zia Senior Citizens program; \$93,843 from the special environmental gross receipt tax (which goes toward payment of the regional landfill); \$650 from the treasurer's returned check fees; \$30,000 from the E-911 Data base/network fund: \$250,000 from Community Development Block Grant (CDBG); \$473,000 from indigent claims fund; \$73,493 from the High Intensity Drug Trafficking Area (HIDTA) grant; \$11,000 from the CLG historic grant for Lincoln; \$5,000 from the NM Traffic Safety Grant; \$473,000 from the oneeighth percent gross receipt income fund; \$10,000 from the oneeighth percent gross receipt debt reserve fund.

Revenues for the general fund. . . . include \$2,860,000 from current ad valorem property taxes, \$153,600 in delinquent property taxes, \$61,700 in delinquent discretionary mills (property tax); \$1,386,451 current general county mill levy; \$138,285 in penalties and interest; \$2,200 - from administrative fees; \$2,300 in liquor license fees; \$87,000 on interest on investments (a 56 percent decrease previous year); from \$120,000 from clerk's filing fees; \$990 in probate fees: \$12,000 sheriff's fees; \$6,000 subdivision filing fees; \$1,200 rental of county property; \$100 fax machine fees; \$8,000 photocopies and microfilm; \$53,300 from motor vehicle fees; \$1,700 from the two cent cigarette tax; \$575 from Bureau of Elections; \$1,250 voters registration systems; \$22,500 for sheriff's forest patrol; \$625,000 in PILT; \$9,000 from emergency management grant; \$6,500 from Fort Stanton museum.

The federal Payment in Lieu of Taxes (PILT), budgeted at \$625,000 was much lower than the \$778,636 PILT Lincoln

County received last fiscal year. County treasurer Joan Park said she had gone to Washington D.C. and talked with Senators Pete Domenici and Jeff Bingaman who both thought the PILT payments would be higher this year. Since her visit the county received notice the PILT payment will be lower than last year.

Park did not criticize the reduction, rather said the president was looking to using the PILT funds in other areas.

Because of the possible reduction Park said the county will hold off on any capital outlay purchases, which PILT traditionally is used for.

"We've taken a pessimistic view of revenues," said county manager Tom Stewart when county commissioners began review of the budget. County commissioner Bill Schwettmann said that was a good way to start.

Stewart said the significant change in the 2002-2003 preliminary budget compared to the 2001-2002 budget are the increases for the newly elected officials who take office in January 2003. The three new county commissioners will get a 31.6 percent increase in salaries, from the prior \$13,121 to the \$17,264, beginning January 1. 2003. This will bring the salaries of the three new commissioners salaries to the salaries now received by county commissioners Rex Wilson and Leo Martinez.

Wilson and Martinez receive base salaries of \$17,284. In addition to Wilson's "salary," "the county pays \$1.070 in FICA, \$250 in Medicare. \$1,580 in Public Employees Retirement Association (PERA), \$8 in workers compensation, \$6,643 in group insurance for a total of \$26,815. In addition to Martinez's base salary the county pays \$1,070 in FICA, \$250 in Medicare, \$1,580 PERA, \$8 in workers comp and \$135 in group insurance for a total of \$20,307 for Martinez.

County commissioners Ray Nunley, Rick Simpand Schwettmann each receive base salaries of \$15,192. For each the county pays \$920 in FICA, \$220 in Medicare, \$8 in workers comp. Nunley opted for the PERA which the county pays \$1,390, and the county pays \$135 for group insurance for Nunley for a total of \$17,888. The county also pays the \$135 group insurance for Schwettmann for a total of \$16,498. Simpson did not opt into the PERA but the county does pay \$6,974 for group insur-

For more than 100 years. Fort Stanton has served Cemetery Merchant Marine veterans. In 1899, the U.S. Merchant Marine Tuberculosis Hospital opened at Fort Stanton and operated the cemetery until the U.S. hospital closed in 1953. During this time, 1.554 burials took place at the cemetery. There are 1.650 graves at the cemetery now. The oldest military cemetery is location a short distance from the current cemetery and has about 24 graves dating from 1879 to 1970. In 1896 the bodies of 58 military men and their dependents were disinterred and reburied at the national cemetery in Santa Fe.

New Mexico Department of Hospitals purchased Fort Stanton in 1953 and operated a state tuberculosis hospital until 1968 at which time the facility was converted to a hospital and training school for developmentally disabled people. Department of Hospitals/Health operated the hospital and school until it was closed by the govemor in 1995, and maintained Fort Stanton Cemetery. Since 1995 the NM General Services Department has been in charge of the hospital facility and cemetery.

In year 2000 the New Mexico Veterans' Service Commission assumed administrative and planning control of Fort Stanton Cemetery. Currently there is a proposed \$2.5 million grant from the U.S. Department of Veterans Affairs to finance expansion of Fort Stanton Memorial Cemetery from the current 13.5 acres to 27 acres, to construct offices and a committal shelter, and purchase of maintenance equipment.

Veteran military honor details are provided free of charge by the Department of Defense to all honorably discharged veterans at Fort Stanton Merchant Marine and Military Memorial Cemetery or any other cemetery of the veterans' choice. A minimum of at least two members of a uniformed armed forces, one being from the same military service in which the deceased veteran served, serve on the honor detail.

With encouragement from the Department of Defense for local veterans organizations to serve in honor details, the Capitan and Ruidoso American Legion Posts and Veterans of Foreign Wars have

funeral honor available for ceremonies in this area. These organizations also are available to furnish pallbearers upon request. The honor details can be requested through the funeral director or by contacting one of the local veteran service organizations.

Veterans should make

their family members aware of where their DD-214 service records are kept. The DD-214 must be presented in order to be buried at a veteran's cemetery. Also, to bury a veteran's spouse at a national or state veteran's cemetery, it is necessary to have a copy of the veterans DD-214 and a copy of their marriage license.






The first time we went to a Capitan village council meeting it was a surprise to be offered coffee and cookies. This was a homey touch that seemed to make everyone comfortable. And we thought it was a good idea. Recently we heard that Capitan is no longer serving coffee and cookies at village council meetings. If it was because of a legal issue, so be it, but it is a shame that a friendly cup of coffee could ever be considered a bribe or a threat. Then again there was that time a person didn't know freshly made coffee would be not and spilled the coffee and sued and got mucho \$\$. Or did that person know the coffee was not and was willing to suffer burns to be able to sue and get mucho \$\$?

One person's cup of coffee could be another person's cause to sue and get rich quick. And that seems to happen more often than we would like, one person getting rich quick while another person has to pay and pay and pay for only trying to be a good neighbor. Oh, it would be nice, but just as with the coffee snafu, there are other considerations. One reason many people


choose to live in town is to have someone else take care of the streets, weter and sewer situations. Any time you live outside the municipal boundaries, it is your responsibility to take care of these matters. It is commendable that the mayor of Capitan wants to help these people, but it is not part of his job description as mayor. And if he chooses to spend time helping non-Capitan residents, the people should thank him, but do not assume that this is his job.

Keeping obligations separate from wants is sometimes a difficult thing to do. The mayor of Capitan wants Capitan to hire a manager to make decisions when the voters expressed their desire to have him be one of those people making decisions, not the "hired help." If he can't accept the responsibility of making difficult decisions, that will be for him and the public to discuss. That is if the situation is discussed in public. Apparently at the budget workshop that Capitan held last week, the village council went into executive session for pending litigation and personnel. And it was announced that the Lincoln County Solid Waste Authority was part of the pending litigation. Was it really?

It would have been nice if there had been a tad bit more information. Was this pending litigation something that the other four entities in the county are not aware of, or was it just that the mayor wanted to discuss his reasons for not

wanting to continue with LCSWA as Capitan trash provider. Eventually the public will know, but our question is why haven't the other entity members of LCSWA had to discuss pending Higation in closed session? Was it the hot coffee? Sometimes there is truth to the rumors, and sometimes more dur, be accomplished by discussing things in open.

total of \$23,337. The preliminary budget also brings the salaries of the newly elected clerk and treasurer to \$43,301. However, until the newly elected clerk and treasurer go into office in January, the budgeted salaries for these two positions, will be \$38,106. Also budgeted for Proctor, who will be in office until December 30, was \$2,363 FICA, \$553 Medicere. \$3,487 PERA, \$8 workers comp and \$2,653 for a total of \$47,168. For Park, who also will be in office until December 30, the county budgeted \$2,363 in FICA, \$553 in Medicare, nothing in PERA, \$8 in workers comp and \$5,469 in group insurance for a total of

The county assessor salary was budgeted at 443,301, with the county paying \$2,685 FTCA, \$628 Ledicare, \$3,962 PERA, \$8 workers comp and \$135 group insurance

\$46,498.

The preliminary budget will also pay all assessor's employees out of the general fund. Previously two salaries were paid out of the re-appraisal fund, which is separate from the general fund. Moving these two positions under the general fund will create a \$116,468 recurring expensive to the general fund. However, this will free up the re-appraisal fund," which has an \$80,913 surplus, to be used for the assessor's reappraisal ideas, Stewart said.

Sheriff Tom Sullivan was budgeted with a base salary of \$45,141, with FICA \$2,799, Medicare at \$655, PERA \$8,351, workers comp \$8 and group insurance at \$5,747 for a total of \$62,700.

The \$2 an hour raise for sheriff's deputies and dispatchers and salaries for two new dispatchers were also budgeted into the law enforcement department budget which

for a total of \$50.718.

of the general fund. The preliminary budget also included a new Geographical Informational System (GIS) department separate from the planning department in the manager's office. No new

personnel will be needed for this new department. The general fund will also begin paying \$36,457 to the sheriff's office to replace the funding pro-

vided by the FAST Cops grant which has expired.

As the day long workshop wore on, it was evident three county departments were cutting their budgets more than others. "Historically over the last few years when we cut the preliminary budget it is always the manager, clerk and treasurer offices that get cut," said Park. "Its ironic in county government that some departments are givers and others are

takers." Assessor Rick Silva wanted the county to use the re-appraisal funds to construct a new facility just for the assessor's offices. Re-appraisal funds previously paid the sala-ries of two appraisers in the assessor's office.

But Silva's request did not sit well with county commissioners, or the other department heads. "If all the departments are not willing to chip in and cut, that's not right and does not serve the

tax payers," Park added.

Wilson said the manager's, clerk's and treasurer's departments are the most comparable because of the services they provide. "We need to work and pull together." Wilson acknowledged. "We've never had these kind of conversations where we have the finger pointing like this."

During discussion Silva suggested the county get the state office of the courts to construct the district judge a new courtroom complex, freeing up the space now occupied by the court-rooms, judges offices, district court clerk offices and law library,

Stewart suggested they get the judge to move the law library to the old detention center area that is being used for storage and as one office for the sheriffs investigating deputy. .

In discussion how to cut department requests to meet the state required reserves for the general fund (figured at threetwelfths of the general fund total), Stewart recommended the \$175,000 in the Capital Improvement Fund be cut until the final cash balances from the previous fiscal year are known. In order to meet the state required reserve for the road fund, Stewart suggested reducing the funding for road gravel by \$65,000.


Before getting down to paring down the various county departmental budgets, county commissioners heard from groups making "external requests." After all presentations, county comaccepted missioners Stewart's recommendation to fund \$1,050 for the NM Bookmobile; \$1,000 for the South Central Mountain RC&D; \$4,500 in dues to Southeastern New Mexico Economic District Development (SNMEDD) which does lobbying and grant writing services for the county; \$2,000 for Capitan Public Library to be provided on a monthly basis as requested; \$50,141.65 as the county's one-third share for funding the Cooperative Extension Service; \$1,000 for the RAS-CAL after school program in Ruidoso.

Also in external request funding was \$2,000 for the Claunch Pinto Soil and Water Conservation District; \$2,000 for Lincoln County Big Brothers/Big Sisters program; \$3,000 for Zia Therapy for respite care, and the Lincoln County First Offenders program that works with youth involved with their first brush with the legal system; \$25,000 for the Humane Society of Lincoln

County; \$19,090 for the New Mexico Association of Counties membership. dues: and \$2.600 for dues to the Coalition of Coun-

Copies of the proposed preliminary budget will be available at the 2 p.m. public hearing today, Thursday, May 16, in the Lincoln County Courthouse in Carrizozo.

SANTA FE INSIDE THE CAPITOLS

SANTA FE - New Mexico is going bananas. A few weeks ago, Republican gubernatorial candidate John Sanchez referred to our state as a banana republic. He quickly retracted the statement, apologizing for a poor choice of words, but by then it had taken on a life of its own.

Republicans Democrats, and detractors and apologists, grabbed onto the term, fashioned their own definitions and proceeded to explain whether they agreed or disagreed with the remark. The trouble with banana republics is that few dictionaries define them. Even William Safire's 900-page "New Political Dictionary" lacks a definition.

Generally a banana republic is considered to be a small, corrupt Latin American country that produces only one crop, such as bananas, and is dependent on foreign capital. Political instability is usually associated with banana republics but most New Mexicans responding to the remark preferred to go with a tin-horn-dictator definition.

To Democrats that dictator is Gov. Gary Johnson, who has tried every trick in the book to circumvent the legislative and judicial branches of government. To Republicans, including John Sanchez, it is the Democratcontrolled Legislature that has been around for most of the last 75 years.

Republicans also see republics as being controlled by a patron system. The original banana republic probably was Guatemala, which at the turn of the last century was controlled by the United Fruit Company.

In New Mexico, Republicans equate that to control by government at all levels, including weapons facilities and military bases, which produce a comfortable status quo for patr-

. And Bill Richardson is the ultimate patron, says Sanchez. So now we have the legislature, controlled by Senate Majority Leader Manny Aragon (no mention is made of Senate President Pro Tem Richard Romero) teaming with Richardson to continue New Mexico's banana republic.

The analogy works well enough. to make an argument that will convice many, although Sanchez has quit

using it. But state GOP Chairman John Dendahl and others have taken up the battle cry. The New Mexico Business Weekly concurs, saying we must admit our problems before we can fix them. Jim Belshaw of the Journal concurs, saying we must be hit over the head with "banana republic" to get our attention.

But Sanchez's Republican gubernatorial opponents disagree, arguing that it is a politically immature statement, undermining years of hard work by the Johnson administration and making it very - difficult for Sanchez, if he were to become governor, to promote New Mexico.

Indeed it may have been politically immature for Sanchez to have dubbed New Mexico a banana republic. The last political figure to do that was former Democrat Gov. Toney Anaya, who suffered for his statement the rest of his term and now calls it unfortunate and inopportune and concedes it gives New Mexico a black eye.

Anaya was using a different twist of the name. He was referring to the political tenor of the times when people were trying to wipe him out, not with bullets, but with "investigations, ugly words and innuendoes.'

Sanchez's opponents are right in contending that someone who might become governor shouldn't be calling his state a banana republic. That is a term for Dendahl and others who are trying to unseat the Democrat-controlled Legislature to use. After all, two of our last three governors, for 12 of the last 16 years, have been Republicans.

The thinking of Sanchez and his advisers undoubtedly was to tie Richardson to Democrat legislative leaders. It worked beautifully four years ago when Senate President Pro Tem Manny Aragon and House Speaker Raymond Sanchez were tied around the neck of Albuquerque Mayor Martin Chavez in a campaign theme Gov. Johnson dubbed "Manny,

Manny has been knocked down a notch and Ray isn't around anymore but that probably won't matter. And who knows, since Bill Richardson and banana republic have the same initials. maybe there's even a subliminal connection.


The preliminary budget includes salaries and benefits for 15 employees. Of these 15 employees, one position for police officer is currently vacant.

Other discussion about the preliminary budget included the Lincoln County request that the village provide funding for dispatch services provided by the Lincoln County Sheriffs Office dispatch. The village first proposed to put \$10,000 toward hiring additional dispatch personnel in the Lincoln County Sheriff's Office, which provides dispatch services to Capitan. But Terry Cox, who is assistant fire chief. suggested the village send the county a letter advising them the village will not pay the \$10,000 because the village provides fire department services to county residents and houses the county ambulance in the village public safety facil-

At the May 14 meeting, trustees agreed to remove from the preliminary budget the \$10,000 expenditure for the village's share for dispatch service. They also agreed to add \$3,000 for the Capitan Library taken from the recreation funds and adjusted the funding for the Humane Society from \$9,000 to \$5,000. Sederwall said he negotiated with the Humane Society to lower the annual fund-

Lady Grizzlies Capture 1A Title

Once again the Carrizozo Lady Grizzly track team has captured the prestigious blue trophy, ending their season as Class 1A Champions.

Class 1A and 2A State Track/Field was held on Friday and Saturday, May 3 & 4 at the University of New Mexico's track stadium. Track teams ran preliminaries on Friday with the exception of some field events and the 800-meter run, for which there are no preliminaries. The top eight in each event qualified for finals on Saturday. The Lady Grizzlies competed in all but three events, the 3200-meter run, the pole vault, and the high jump.

The Lady Grizzlies got off to a strong start advancing to the finals in all qualified events. Friday's competition left them in second place with 28 points while surprisingly Rehoboth Christian was in first place with 36 points. But that did not weaken the Lady Grizzlies' dream of pursing their second state title. The strength of both the Grizzlies' bodies and hearts proved to be too much for any of the other teams to compete with.

Led by the pair of Ariel's, Burr and Valleion the Lady Grizzlies overcame the 8 point deficit and emerged victorious with 84 points. Rehoboth held on to a second place trophy. earning 65 points. Burr was high point individual for Class 1A, racking up 31 points for her team, while Vallejos earned 261/2 Burr placed first in the 100, 200, and 400-meter dash, and triple jump. Vallejos captured gold medals in the 100 and 300 hurdles and also placed second in the long jump and third in the 100-meter dash. Both of these athletes were in the 1600-meter relay which also placed first. The two others in the relay were Lacey Burd, who placed third in the 800-meter run and fifth in the long jump, and Bianca Baca, who placed second with her 800 meter relay and 1600 medley relay team. Baca also competed in the 400 relay. Other Lady Grizzlies who contributed points were 8th grader Whitney Whittaker and Mary Beth Shivers (800 meter relay & medley relay), and sophomore Adrianne Zamora (5th in javelin). Other Grizzly participants included freshmen Stephanie Brewer (1600-meter run), Tierney Burd and Sonya Vega (400-meter relay); sophomore







Watering will also be said the CCNG legal fees prohibited between 10:00 a.m. and 3:00 p.m. in phases 1 and 2.

In another water related issue, Howard Shanks of the RC&D asked the town to adopt a resolution endorsing the preparation and publication of the Tularosa Basin and Salt Basin Regional Water Plan,

Shanks explained that the regional water plan documents the need for water, there is a limited supply, and there is a water plan. He said the regional water plan, a 40 year plan, looks at three things - supply, demand and alternatives.

Shanks said there is water underground but well water needs to be treated, possibly by reverse osmosis or some other method. He also said water to the west picks up salts.

The resolution is an agreement acknowledging participation in the preparation of the Regional Water Plan (RWP) and authorizing publication of the RWP which covers the closed hydrologic area known as the Tularosa Basin which is about 6,500 square miles. The 2,400 square mile Salt Basin is included in the plan.

The final draft of the RWP will be presented to the Interstate Streams Commission on May 23 in Santa Fe. The town council approved the resolution.

Watering parks in town and filling the swimming pool was also discussed... Town foreman Jim Payne said water began running into the pool at noon Tuesday and would probably be filled in two days. Payne also said watering is bad at the parks. the wind has been blowing for 10 - 12 to 15 days and the town gets some water in the streets.

Town trustee Eileen Lovelace asked if parks could be watered at night, which is the best time to water. Payne said not with the help the town has.

In other business the town council approved hiring Albert Padilla Jr. as full time police officer.

-Gave approval for the town to participate in the DWI grant program application.

-Discussed code enforcement and the request from police chief Angelo Vega to have the town attorney "on board."

-Approve purchasing meters for the detention center and one for the number 2 well. Both meters had already been bought, apparently on an emergency basis.

--Gary Stout reported that the Carrizozo web site averaged 43 "hits" per day with 108 maximum one day. The total was 1,291 "hits" for April. Stout said people from all over the world have been viewing the Carrizozo web site.

Vega said the only increase in the CCNG budget was for the backhoe, trencher, etc. Vega also said that Bob Beauvais had resigned as CCNG attorney. CCNG is asking for RFP's for attorney. Vega said the town attorney for Carrizozo had contacted the court and asked that all CCNG litigation be put on hold until CCNG gets an attorney.


The town council approved the CCNG budget. -May 27 - June 1 was designated clean up week. Clean up day will be June 1.

--Trustees approved the use of Fred Chavez Park for the Santa Rita Fiesta July 20 and 21 and gave permission to close Third Street during the Fiesta. A discussion was held closing Birch about Street and it was decided to wait until the next town council meeting.

-- Trustee Lovelace was appointed to the Southeastern New Mexico Economic Development District (SNMEDD) board.

--Angelo Vega was appointed to the Lincoln County Solid · Waste Authority (LCSWA) board. Vega asked for permission to use a town owned vehicle to attend the LCSWA meetings. He said he would not accept mileage money and as a representative of the town wanted to use a town vehicle and did not want to hear flack. He was asked if he would use the police car and the mayor said it would be a town car. It was not explained whether the police car would be used some of the time or not. It was also not explained if a police car or town vehicle would be used for transport to the CCNG meetings.

-Mike Gieb was introduced. He may be appointed to the town planning and zoning board at the next meeting.

for the exact location of where they need to go to vote, or they can call the county clerk's office.

The new voter registration information cards were mailed to voters last week, but so far this week the clerk's office has received many of these back, with no forwarding addresses. Many of the returned cards are for residents in Ruidoso who have not updated their voter registration forms to reflect their house addresses, instead of their former post office box numbers.

The clerk's office cannot change the address on the voter registration card without the voter updating his or her voter registration form. However, the clerk's office can provide the voter with the information on the card, said Bureau of Elections Clerk Sam Chavez.


While voters are not required to present these voter registration cards at the polls on election day. the cards do help poll workers and voters determine if they are at the correct poll.

Lincoln County Clerk Martha Proctor has encouraged voters to update their voter registration forms to reflect the new house mail addresses, or if the voters have changed residences. Although it is too late to update voter registration forms before the June 4 primary, voter registration books re-open on June 5 and will run through September for the November general election.

Another way to avoid confusion on the June 4 primary election day is to do absentee voting. Paper ballot absentee voting began on April 25 and continues through the June 4 election day. In person absentee voting began Wednesday, May 15 with an In Person Absentee voting poll in the Lincoln County Clerk's Office open from 8 a.m. to 5 p.m. Monday through Friday. The In Person Absentee voting satellite poll in Ruidoso is open from 9:30 a.m. to 3 p.m. Monday through Friday, at Ruidoso Senior Center (by the swimming pool on Sudderth Drive) in Ruidoso.

This year voters at the In Person Absentee poll at the clerk's office will vote on electronic voting machine. Prior to this year, early voters at the clerk's office cast paper ballots.

To do absentee voting by paper ballot mailed to your home, call the Lincoln County Clerk's Office at 648-2394 to request an application for absentee ballot. Chavez recommends voters request this application by May 20 so they will receive it soon enough to return it my mail for the absentee ballot. As soon as the voter receives the appli-

fill it out, sign it and return it either by mail or in person at the county clerk's office. Remember to put a 34 cent stamp on the application for absentee ballot.

Once the voter has re-. ceived the paper absentee ballot in the mail from the clerk's office, the voter should chose his or her favorite candidates by filling in the arrow beside their choices with the tiny pencil enclosed

with the ballot. If the tiny pencil is lost, fill in the arrows with a soft #2 lead pencil.

Once completed, the voter should sign the absentee ballot with pen, date it, seal it in the envelopes as instructed and

It costs 57 cents in stamps to mail the absentee ballot to the clerk's office.




