Filing day for the board elections is Tuesday, Dec.

17. Any registered voter who desires to be a school board candidate must file a declaration of candidacy between 9 a.m. and 5 p.m. on December 17, with the Lincoln County Clerk in the clerk's office in the Lincoln County Courthouse in Carrizozo.

Anyone desiring to be a candidate for a board of education for a school district within Lincoln

County must be registered to vote in Lincoln County and reside within the school district for which they are seeking office.

Filing day for write-in candidates is December 31. Registered voters wanting to be write-in candidates must file before 5 p.m. with the Lincoln County Clerk in her office in the Lincoln County Courthouse in

Absentee in-person voting for the school board elections will be held in the County Clerk's office beginning January 10 until 5 p.m. January 31 for voters in all county school districts.

Blasting and Closures Continuing Through December on US 70

As road work continues on US 70 in the Hondo Valley, motorists are reminded that shoulder and lane closures will continue through December.

According to Mary Ann Wootten, community relations liaison for the project, those planning on travel through the area should allow for an extra 15 minutes to their schedules to accommodate construction.

Weekday highway closures for rock blasting will also continue through December. During the weekdays, blasting begins at approximately 1 p.m. and can last up to one hour. The 2002 Lincoln County property taxes become delinquent on Wednesday, Dec. 11 and subject to late fees unless at least the first half is paid by 5 p.m. Tuesday, Dec. 10

Lincoln County Treasurer-elect Beverly Calaway reminds everyone who owns property in Lincoln County to pay their 2002 taxes. Taxes can be paid in two parts, with at least the first half due by Dec. 10.

Calaway said mailed in property tax payments are considered to be on time, and not subject to a \$5 late penalty, if they are postmarked by 5 p.m. Tuesday, Dec. 10.

So far this tax season, the treasurer's office has collected more in the 2002 property taxes than for the same time in the 2001 and 2000 tax seasons, said Calaway. She commended property owners for paying their taxes on time.

C'zozo Council To Consider Sewer and Water Rate Increases

Carrizozo Town Trustees at their regular meeting Tuesday, December 10, will schedule a public hearing for a proposed ordinance to increase sewer and water rates.

The town meeting will begin at 6 p.m. at the town offices in the Carrizozo Rec Center.

According to town clerk Leann Wethbrecht, trustees will be asked to schedule a public hearing on a proposed ordinance that will increase the sewer and water rates. Weihbrecht told THE NEWS that the town has not raised its water rates since 1996, and she was unsure when sewer rates were last increased.

Weihbrecht said the proposed changes to the water rates will also change the minimum gallons per household per month from the current 3,000 gallons to 4,000 gallons. The proposed water rate increase is from the current \$10.25 a month for the first 3,000 gallons of water used to \$14.50 per month for the first 4,000 gallons of water used.

The current charge of \$2.25 per thousand gallons used beyond the minimum gallons used will not change, Weihbrecht added.

Proposed sewer rate increase is from the current \$5.50 a month to a flat rate of \$11 a month.

Other proposed increases are for water and sewer meters. Currently it costs \$300 to install a water meter. The proposed increase is to \$350.

crease is to install sewer meters. Currently sewer meters cost \$150, with the proposed increase to \$350.

Weihbrecht said the discussion about rate increases will be open and will be based on the costs. Part of the reason for raising the sewer rates is to help pay off the \$490,000 loan from the Rural Utilities Service (RUS) that will go with the grant to upgrade the waste water treatment facility, and to provide funds to operate it once it is constructed and in use.

Weihbrecht said at the Dec. 10 meeting trustees will actually schedule a date for a future public hearing on the proposed ordinance to increase rates. Weihbrecht said she was unsure how much discussion trustees will have about the rate increases during their December 10 meeting.





Considering the conflicting accounts of what happened at the October and November meetings of the Lincoln Solid Waste Authority (LCSWA) we tried to decipher just exactly what business transpired. Reports state that when the matter of "rate setting safeguards" was brought up that the agenda item was tabled at the request of the Carrizozo representative on the LCSWA board. Sounds logical. Then in another article it was reported that Carrizozo LCSWA representative Angelo Vega said he stopped a proposed policy to allow the LCSWA board to set trash fees. Does he actually believe the "rate setting safeguards" are the same as setting fees? Or was that another item on the agenda?

One other question is how one person can "stop" any action that should require a majority of the board? It seems that it would be impossible for one person to "stop" any matter that was presented to the entire LCSWA board. The situation of "rate setting safeguards" was tabled again at the November meeting, which was held the week after Vega gave his report to the Carrizozo Town Council. Makes you wonder how one person has that much power.

Now there is another issue that we question. Seems the LCSWA board came out of closed session during their meeting November 19 and Vega directed the LCSWA board chairman to "take care of that business" that was discussed in closed session. Thank goodness the attorney advised the LCSWA board to be more specific. Apparently the two items to be discussed in the closed or executive session were the village of Capitan's request for payment for the Capitan landfill and the other item to be discussed was the letter the mayor of Capitan had sent to the state Attorney General. Seems as if neither of these matters had anything to do with requesting additional reports from the

LCSWA operational manager. Did we miss something? Frequently issues will overlap, but we see no way that a letter to the AG or discussing payment for the landfill could involve asking for additional reports from the operational supervisor. We have no complaint with the LCSWA board asking for verification about expenses, especially for hours worked or for travel, and we do believe that if the LCSVVA board had instituted this policy with the previous manager there could have been fewer problems about the budget.

Usually entitles do require documentation about hours worked and travel expenses and we would hope LCSWA will incorporate this policy in writing, not just for person now holding the position of operational manager but for any person who may be hired for that position in the future.

Some other questions we have are why the mayor of Capitan would write a letter to the AG. Why dkin't he bring up any issues at a LCSWA meeting instead of contacting the AG? Seems that would have been the way to do it.

Eventually some of these questions may be answered. Maybe someone will explain how one person can "stop" or

change procedure without concurrence from the others.

Despite the innuendos about us loving LCSWA, it is our contention that LCSWA is doing a good job and deserves support instead of the nit-picking by certain individuals.

One person LCSWA board?

We bemoon the fact that our children go elsewhere to make a living and bemoan the fact we have so little: growth. What we do have is tourists, snow birds, retiress and a few. artists. All of who have their psychock coming from some other means outside the county. Now, in the name of deciding what is good for the county, we will limit subdivisions.

Limit the subdivisions where? We don't want ranches broken up in subdivisions. How for do we carry this? Can we tell large family reaching operations that they cannot aplit the reaches between children upon the death of the parents? Or we tell them they can only split twice and decide between three children where the split is? Do we say you have to aplit only in 25 section increments? What if a ranch is only 20 sections? No split between children? What if a ranch only has 5 sections of desided land in say, a 20 section ranch? No division or you can only build one house and the other sibling must live elsewhere? Does this mean we can't buy the pasture next to us because that would be sub-dividing the original ranch? Where does the terminology of "original ranch" begin or and? Does a person have the right in Lincoln County to bay deeded property and make a living. as heishe so desires or do we decide what is right for them? If we allow this to happen are we so different than the environmentalists? Where does thinking about the good of Lincoln County infringe upon personal property rights? We don't want any more ranches cut up and "by god, we are going to do something about it." At the cost of whose private property rights? Be very careful when you listen to

AS LONG AS POSSIBLE"

SANTA FE — Legislative junkets were a big issue in the recent political campaigns. Sens. Richard Romero and John Arthur Smith drew extensive criticism in attack ads by their opponents in the 1st and 2nd congressional district races.

The ads revealed the two had traveled to places like Dallas, Milwaukee, St. Louis and even San Francisco and. New Orleans at taxpayer expense. Reportedly similar ciriticisms also arose in local legislative races.

Those attacks were the subject of a spirited discussion at a recent meeting of the Legislative Council, a group composed of leaders from both parties in both houses, which runs the Legislature in between sessions. Sen. Ben Altamirano of Silver City asked that the Legislature find a way to help the public understand that the trips lawmakers take to meetings and conferences are for the public good.

A great many of us have gone to similar gatherings at one time or another in our businesses. We pick up valuable information, learn what others are doing to solve problems similar to ours and become part of a network of people we can call for advice when needed.

 And we usually find time to see surrounding attractions. Meeting planners know the way to draw a big crowd is to hold these conferences at attractive locations. And we also know that some people go to conferences at company expense and never do much more than stick their heads into a meeting.

Would you believe that legislators are just like real people? They attend meetings and conferences where they are entertained and given tours of the city. They learn a lot that can be applied to legislative substance and process back home. And there are a few who mainly just have a good time.

The one additional thing that happens with legislators is that their meetings are a matter of public record. And when they run for re-election. opponents can fish out the information and make those trips appear sinister and a waste of taxpayer money.

Altamirano proposed a public used to it.


It was interesting that neither Romero nor Smith responded to their opponent's attacks. U.S. Rep. Heather Wilson and former state Rep. Steve Pearce must have attended some meetings of their own. Members of Congress seem to go on fact-finding missions all the time. Why weren't such things brought out?

Sen. Romero, who was chairing the Legislative Council meeting, answered that he didn't have the money to run ads defending himself. But, he said, that's part of running for office. Those things happen. He thanked committee members for their concern and told them not to worry about it.

During the discussion. House Speaker Ben Lujan suggested the best public information campaign would be to compare what New Mexico lawmakers receive as travel reimbursement compared to other states, most of which also pay salaries to their legislators. But again the consensus was that the public really doesn't care about the plight of its legislators and that candidates should run for office knowing it.

Sen. Lee Rawson of Las Cruces, the Senate Republican whip, noted that lawmakers from the far reaches of the state are at a disadvantage when investigative reporters tally total travel expenses for legislators.

A newspaper report from last summer that was used against Romero in attack ads and also against Senate Democrat Whip Mary Jane Garcia, also of Las Cruces, failed to take note of the fact that her high travel expenses were partly due to of traveling so far to meetings, most of which are in Santa Fe.






Reading levels are determined at the beginning of the school year by a test called the Star Test. Students read when they are in the library and at some periods in the classrooms.

Teachers started this program because they wanted students to develop reading skills. Children have been reading for a long time in Carrizozo Schools.

economy, and the best way to do that is to attract good paying jobs that put more hard earned." cash into workers' pockets. Cutting personal income taxes over the next three years will the stimulus provide necessary to brighten New Mexico's future. Mexicans need to know they're working for themselves and their families, and not the government.

If we cut our income taxes, high wage earners, such as doctors, company executives and high technology workers, will stay in New Mexico -instead of fleeing to live in low OIL neighboring states - and that will lead to better health care and stronger economic development. Business owners thinking of relocating their businesses will move to New Mexico because they know their dollar will go further here.

Middle income workers, like teachers, retail workers and everyone else who works hard for a living, will get a much needed tax break under a phased in, across the board personal income tax cut, which will put more money into everyone's pocket by increasing take home pay. That

means ordinary New Mexicans will buy more groceries and household goods, eat more dinners out, spend more money on clothes and buy more services - spending that will lead to an economic synergy that will generate high paying jobs, growth and vitality, and more tax revenue for important government services. such as funding public schools.

Ordinary New Mexicans will also benefit from a gradual phase out of the gross receipts tax on groceries and medical services. It simply doesn't make sense to tax food and medical services, especially in a state where so many people are going without such necessities.

With any tax cut, we need to be sure we don't cripple state and local governments and the services they provide. Public schools, health care and financial assistance for less fortunate New Mexicans, road construction and maintenance and public safety programs cannot be allowed to suffer. But they won't have to under a well reasoned. phased in personal income tax cut and a phase out of the tax on food and medical services.
