# Ruidoso Creates Task Force for Lodgers Tax

With a chorus of lodgers asking for a task force to examine the village lodgers tax, Ruidoso Village Council rejected a proposed increase in the occupancy tax.

During their meeting May 27, Ruidoso Councilors heard from several lodgers who carried the same message about a

president of the Lincoln County Hospitality and Tourism Association representing 15 lodgers, said the lodgers are not against the tax increase. "But is the money being used properly and for the best bang for the buck?" Videau asked.

"We believe this is a good time for a task force to review the issues and how

> Proposed was an increase from four and onequarter percent to five percent on the tax that is collected for each dollar of lodging cost per night. The proposed increase, which was to have begun in October, was estimated to raise an additional \$150,000 a year. It was argued that the increase was

needed to provide money to maintain and upgrade the convention center.

Lodger Chuck Craig and Videau asked if the additional money raised would go for the arts commission and its projects. Last October the council approved a one-fourth percent increase which is dedicated to arts commission projects and to pay part of the salary of the arts coordina-

Videau said people who call for rooms do ask about the tax rates, but he did not think the small increase would make a negative impact on the

Another lodger said the tax raises about \$1 million a year. "That's a lot of money and we need a new vision of what to do with it," said Bob Romney who owns some condos. "We need the task force be-

# County Now Requires Permits for Fireworks

Anyone selling legal fireworks within Lincoln County must have a permit from the county manager, under rules of a new ordinance passed on May

Lincoln County Commissioners at their meeting Tuesday, May 20 adopted Ordinance 2003-06 that establishes restrictions on fireworks in all unincorporated areas of the county. The ordinance was adopted as an emergency measure, which means it took effect immediately after adoption.

Ordinance 2003-06 deals with fireworks. County commissioners also adopted a separate ordinance that regulates the handling of fire. Previously the two issues were combined into one ordinance.

The fireworks ordinance allows for the sale of permissible fireworks, except during extreme drought conditions when aerial or ground audible devices are prohibited. However, permissible fireworks may be sold only between June 20 and July β of each year and six days preceding and including New Year's Day, and three days preceding and including Chinese New Year, the 16th of September and Cinco de Mayo of each year, "except that permissible fireworks may be sold all year in retail stores whose primary business is tourism."

order to In "permissible" fireworks, a permit must be obtained from the office of the county manager, located in the Lincoln County Courthouse in Carrizozo. Permits cost \$25 a year and shall be issued for one year beginning February 1 of each year.

Public and/or private displays are also allowed, provided the organizers obtain a permit from the county manager's office and the displays are officially supervised.

The ordinance allows enforcement by any Lincoln County Sheriff's Deputy or any appropriate state or federal certified law enforcement officer. Persons charged will be

cited into magistrate or district court within Lincoln County.

Also in the enforcement section the ordinance allows "injunctions of public nuisance of threat of irreparable harm." This allows any county or other law enforcement agencies to seek in a court an injunction against any person or entity who uses fireworks in violation of the ordinance. If the county prevails in such an action, the county shall be entitled to recover reasonable attorney fees and court costs in addition to

any other relief granted. The ordinance took effect immediately after passage and recording into the county clerk's of-

fice.

"permissible" fireworks and includes restrictions and penalties are available from the office of the county manager in the Lincoln County Courthouse in Carrizozo.

County commissioners also adopted Ordinance 2003-07 regulating improper handling of fire and open burning. The ordinance establishes powers of the county manager, emergency services coordinator and peace officers and establishes provisions for declaring severe fire hazard restrictions and fire danger emergencies, gives authority mitigate. Under the ordinance the county manager or emergency services coordinator may declare that critical fire weather condi-

# County Raises Income Limits for Indigent Care

A person making up to \$20,527 a year may be eligible to have medical expenses paid by the Lincoln County Indigent Health Care Fund.

Lincoln County Commissioners at their meeting May 20 adopted on a 4 to 1 vote, changes to the county indigent health care ordinance that raises the limit of income earned to qualify for the indigent health care funds. County commissioner Leo Martinez voted against the changes.

County indigent care fund administrator Teresa Montoya had asked for higher limits of eligibility. She said that last year seven claims were denied because the applicants did not meet the income guidelines. And even with the higher income limits, three would still not have qualified, she added.

Montoya said even with the increase she did not foresee any big changes in the pay out from the indigent fund. "We have to take (into account those who do not apply because they do not meet the in-

come guidelines," she said. "The biggest problem are two to three person households which are usually over the limit."

Montoya had requested a 24 percent increase on the income guidelines, the largest allowable under the federal HUD guide-

County manager Tom Stewart recommended only a five percent increase from the previous limits. "We can't afford the 24 percent," Stewart said.

Raising the income limits by only five percent could have helped three of

cause the lodgers tax ordinance can be interpreted in a hundred ways."

Romney said the village needs to develop procedures to quantify the use of lodgers tax. He then asked why the chair of the village lodgers tax committee works for N'escalero Enterprises.

Mayor Leon Eggleston said lodgers tax committee representation is established by state statutes, which can only be changed by the legisla-

Chuck Duncan, who owns several cabin units in Upper Canyon, said a problem with lodgers tax is when customers use credit cards. He said the lodger who accepts credit cards must pay a credit card fee based on a percentage of the total room cost, including the lodgers tax. "This comes right out of our pockets," Duncan said. "It costs us to collect the lodgers tax for the village.

Eggleston said communities interpret the state guidelines for use of lodgers tax funds very broadly. In the statute there are six uses for the funds--for cost of collecting, administering and auditing the funds; operation, maintereconstruction, nance. land and equipment purchase for any tourism related facilities such as the convention center; transportation system; premiums for revenue bonds: promotion. advertising, publication for attractions, facilities and events in the area; police, fire, solid waste for tourism related events; or any combination of the above.

> Each year the village dedicates \$50,000 of funds for "special events" such as the motorcycle rallies, art festival, etc. The remainder of the funds go to Grindstone Graphics for village promotion and advertising, Ruidoso Valley Chamber of Commerce for its visitor center, \$150,000 to subsidize the convention center operations, and for the Billy the Kid National Scenic Byways center.

Groups that receive lodgers tax funds must match each dollar from the village. "And they have to bring their receipts, which is a way to audit," said councilor Deborah Marcum Byars.

Convention center director of sales Barbara Crane said the convention center needs work. The center was opened in 1992 and

although has been very well maintained by the village staff, is in need of a new roof, carpet replacement and other needs. Crane said she is concerned if the convention center is not upgraded by 2004, Ruidoso might be overlooked by convention groups more attracted to the new Inn of the Mountain Gods 35,000 square foot facility, or the new facility to open in Las Cru-

Village manager Lorri McKnight said it will cost an estimated \$625,000 just for basic improvements to the convention center. With roof replacement and other major needs the improvements could cost more than \$1 million.

Councilor Ray Nunley said the convention center could be self sustaining and he proposed putting 30 percent of the revenue from the center back into its maintenance.

Laura Doth from Grindstone Graphics then spoke. Her company has contracted with the village for five years to provide marketing and promotion for the village. Since her company took over marketing and promotion the lodgers tax has increased 79 percent, she said. "For a community with a population of 8,000 permanent residents, Ruidoso is ranked fourth in the state for lodgers tax collections," Doth added.

But that was challenged by those who said the lodgers tax revenues increased because of the dramatic increase in the number of rooms and the increased costs of rooms.

This year her company is focusing on the "drive market" of visitors making day and overnight trips. 'In three hours vou can be here from Albuquerque, Doth said.

Rene McAllister, who owns vacation rentals, said she does not get a lot of calls for rooms from people who said they saw an advertisement about Ruidoso, "How do you track your advertising?" she asked Doth.

Doth said they try to advertise in publications that have some type of response card and now they are going to a 1-800 system that will better track responses. Doth also said she needs a new conversion study to show the effectiveness of the advertising, but it is expensive.

Patric Pearson, director of Ruidoso Chamber of Commerce, said at the last chamber board meeting. members thought a task force a good idea. Some of the members concerns were about the use of lodgers tax for the arts, and some questions about the use of Grindstone Graphics. "A task force is a great idea," Pearson said. "Set a deadline to answer questions and make recommendations. make all information available to the public. If we don't educate everyone we'll have the same questions."

After more comments, councilors discussed the idea of a task force. Bob Sterchi favored it, although he also favored the increase. Nunley said the task force was in order and he wanted lodgers, Grindstone Graphics, the chamber and the village manager to be on it. Eggleston invited anyone in-

terested in being on the low the village to purchase task force to call McKnight or himself before May 31.

Byars said the task force should have at least 90 days to meet and make recommendations.


Councilor Ron Hardeman encouraged nonlodgers to participate on the task force. Councilor Ron Anderson said he was glad the lodgers at the meeting were cordial.

Councilors unanimously to reject the ordinance for the tax increase and to establish the task force which will have 90 day time line.

Later in the meeting, when councilors were considering the preliminary budget, Byars made the motion to move \$46,000 out of lodgers tax fund and put it toward the operation of the convention center. As proposed the preliminary budget would have transferred \$150,000 from the general fund to the convention center. Byars said reducing the transfer would ala new code enforcement vehicle from the general fund.

Councilors tied their vote on the motion with Byars, Sterchi Hardeman voting yes, Frank Cummins, Anderson and Nunley voting no. Eggleston broke the tie in favor of using the lodgers tax funds for the convention center (As budgeted, the lodgers tax fund was to have had a \$96,372 projected cash balance at the end of the 2003-2004 fiscal

# County Adopts Tight Budget

With interest rates continuing to drop, and expenses, especially in corcontinuing to rections. rise, Lincoln County adopted Commissioners on a 4 to 1 vote a preliminary budget that met required reserves and dropped the hospital levy to 1.1 mills without having to raise property taxes.

During their meeting May 20, county commisadopted the sioners budget that shows \$6.1 million in general fund revenues, \$4/1 million in general fund expenses and a \$2.2 million in transfers out of the general fund to various programs including corrections.

Total budgeted revenue of all funds is \$14,404,606. Total funds include the general fund, road fund, all fire departments, senior citizens programs, ambulance, hospital levies, gas tax, special programs,

Total budgeted expenditures are \$16,581,301. While the totals are in deficit, the deficit will be made up from the total budgeted unaudited beginning cash reserves of \$6,823,752, leaving a total budgeted estimated ending cash reserves (as of June 30, 2004) of \$4,647,057.

commissioner County Martinez voted against the budget because it includes only \$25,000 for the Humane Society, which had asked for an increase to \$40,000.

The preliminary budget commissioners adopted was five percent less than the proposed preliminary budget presented at the May 2 budget workshop.

The adopted preliminary budget does not include any salary increases, except for a one-time \$200 merit pay to be given to each of 13 deputies on July 1. Deputies have their: own separate collective bargaining.

County commissioners will look at any potential salary increases in December or January based on how the budget looks when they make mid-year budget adjustments.

Introducing the preliminary budget, county manager Tom Stewart said he had reviewed every department budget with department heads with a goal of reducing operational expenses by five percent. "When the revenue is there, we will track. the cuts and go back and selectively reinstate funds," Stewart said.

The preliminary budget is figured on estimates, including of cash left from the 2002-2003 fiscal year (which ends June 30). At the May 2 budget workshop, the general fund ending cash balance was only \$160,379 which was below the state required reserves. Counties are required to have in reserve three-twelfths of the total general fund, or what is equal to three months of operating cash.

Once the current fiscal year ends, and actual cash left will be calculated, the final budget will be adjusted. Historically, Lincoln County departments have underestimated the amount of ending cash balances from the previous fiscal years. A final hearing will be held on the budget, including the adjustments from the state department of finance and administration (DFA), will be held by county commissioners on July 15.

Stewart outlined how each department had reduced its budget by five percent, many taking funds from mileage and per diem, attorney fees, capital improvements, professional services, data processing, printing and publishing, etc. All capital outlay equipment and vehiele purchase requested were also denied at this

## Budget Problems

Money matters are being cussed and discussed at the different governmental meetings as fiscal year budgets are being prepared. Preliminary budgets must be sent to the state department of finance and administration (DFA) for approval. DFA is thorough in review of the budgets and makes adjustments before final budgets can be approved.

One problem with governmental budgets is that during the year not all adjustments to the budget are recorded in a manner with a proper audit trail. It seems that any time an adjustment is made to the budget during the year these amounts should be reflected in a way that will indicate to the public that there was an increase or decrease in a line item. The public has a right to know when more money is being spent than was originally budgeted and approved.

Not providing proper information to the public is the cause of much misinformation and accusations that money is not being spent properly. We questioned how much Capitan spent for the attorney advice about the Lincoln County Solid Waste Authority (LCSWA) because it seemed this was a waste of public money. We question why there will be an increase in water and sewer rates in Carrizozo.

Evidently some elected officials also have questions about proposed budgeted expenses. A request in Ruidoso to increase lodger's taxes was denied; and a task force will be organized to review the lodger's tex situation. Getting the correct information is necessary and may help explain what is happening, where and why. The Carrizozo lodger's tax has two line items in the budget, which always causes questions to be asked. One line item is for advertising and the other line item is for improving or building a tourism facility, which could mean making Rec Center repairs or it could mean something else. It can be quite confusing.

You may also question why the county budget does not include a cost of living increase for county employees but does include money for outside interests. It seems county officials should take care of county owned facilities and county employees before distributing money to others. It seems that county priorities should be set and followed:

We are aware the budget process can be long and tiring and not everyone will be happy. A few years ago county commissioners spent what appeared to be surplus money; which was not what it appeared to be, and even though the money was appreciated for recreation, it later caused problems in the budget because it was not surplus money.

One thing to remember is there are certain criteria to be followed when preparing a budget. Money earmarked for a certain use may not be spent in another area. And just because painting the flagpole is your favorite project, does not mean it has priority over providing locks for the doors

Even If you disagree with the budgetary decisions being made, remember that the budget is public information, or rather it is in some governmental entities, and you have the right to review the budget and budget information.

Spending millions of dollars may not be as much fun as it could be, but it is a duty officials have to do. Let's hope they can live with the decisions they have made this year.

were denied, Stewart said. But with raising the limits by 24 percent, the county cannot calculate how many claims will be filed, Stewart added.

The indigent fund comes from a special oneeighth gross receipt tax collected county wide.

Martinez argued against increasing the income limits because he was concerned it would affect the Sole Community Provider payment for Lincoln County Medical Center (LCMC) which is managed by contract by Presbyterian Healthcare Services.

Stewart said under state statutes the county commission is responsible for overseeing the indigent fund and the sole community provider funds. The sole community provider funds are matched with three federal dollars for every one dollar provided by the county. These funds are used by the hospital to reimburse "charity" care costs. "That's why they go together," Stewart added.

"So we set the guidelines." on the sole community provider payments but the hospital can pay if it wants," said Martinez.

LCMC administrator Jim Gibson said the hospital does not use the Indigent Health Care funds for the sole community provider payment. The federal government sends the sole community provider match regardless of who qualifies," Gibson added.

Martinez said the situation is "always confusing."


## An Onion A Day?

SANTA FE -- Santa Fe has been reputed to be the nation's second largest art market, trailing only New York. The claim is now seen in print much more often, sometimes being linked with Taos and everything in-between as one area.

With the emergence of numerous other art markets around the state in Silver City, Roswell, Carlsbad, Las Cruces and other locales, New Mexico, itself, is now being seen as a world-class art market.

The ony problem with proving our

ranking is that lists never seem to be published, showing gross sales of the major art markets. That's because. high-end art dealers and buyers have: long arranged to avoid sales taxes. So dealers aren't anxious to report their gross sales because some government official might get wise and check the amount of gross receipts tax art dealers are paying.

The sales tax scam is about to come

to an end, however. Federal and state prosecutors in New York are cracking down. Earlier this month, the news was full of reports about Samuel Waksal, the ImClone Systems founder and friend of Martha Stewart: pleading guilty to conspiring with a dealer to dodge \$1.2 million in sales tax on nine paintings that cost him a total of \$15 million.

The Manhattan district attorney announced a few days later that 34 Manhattan families had coughed up \$6 million in back taxes on art purchases. And Tyco CEO Dennis Kozlowski has been indicted on charges of evading \$13 million on art purchases.

This isn't income tax evasion. which we are so accustomed to seeing. This is sales tax, some of which goes to state and local governments. Gov. Bill Richardson is sure to discover this new revenue source soon and go after it to help pay for all his new programs. He seems to be a little miffed that lawmakers found the untaxed out-of-state oil and gas royalty recipients to fund their increased retirement benefits. He wanted to find that first. . .

Anyway, with New Mexico being such a big player in the art world, it shouldn't be too surprising, I suppose, that state Sen. Shannon Robinson, of Albuquerque, came up with a proposal for the state to invest \$50 million in great works of art and fine musical instruments. Robinson wanted to use state severance tax permanent fund money to buy expensive art and

musical instruments to display in New Mexico. He said he'd even consider letting the musical instruments be used by the Santa Fe Opera and other leading orchestras:


The bill specified that the instruments must have been made in Italy, France, Germany or England in the 17th, 18th or 19th centuries. They must be worth at least \$150,000 and less than \$8 million, All purchases would be sold within 10 years of their

Robinson noted that New Mexico is the only state in the union that has a fund such as our severance tax permanent fund. It is separate from the land grant permanent fund with its federal restrictions, so we can be more flexible in using it for putting resources into non-traditional investments.

Robinson argued that there is very little risk to his plan because fine art by the masters only appreciates in value. During the economic downturn we now are in, are and precious musical instruments still have appreciated And he is excited about the word getting around the art world that New Mexico is acquiring fine art. Since governmental agencies don t pa sales tax, evidently the state would get that break too.

So is this an off-the-wall idea that will go nowhere? Robinson secured: the endorsement of the State Investment Council on which the governor sits. The bill passed the Senate and House with big margins, but Gov. Bill Richardson vetoed it anyway, contending that the investment would not be prudent or produce a reliable income stream.

tions exist which are favorable to the ignition and rapid spread of uncontrolled fire. Upon determining such critical fire weather, the manager or coordinator may impose a temporary restriction on all open burning, permitted or otherwise with five exceptions. The exceptions are open burning for ceremonial purposes; barbecuing; heating purposes in fireplaces; noncommercial cooking of food for human consumption and for warming by small wood fires at construction sites.

The ordinance gives authority to the county commissioners to declare fire emergency and prohibit all open fires during declared periods of ex-treme drought, ongoing critical fire weather or any combination of conditions that pose a significant risk of uncontrolled fire. The emergency services coordinator or authorized peace officer shall enforce the prohibition when the fire declaration is in effect.

When the critical fire conditions exist and any fire is sighted, the county manager, emergency services coordinator or any certified peace officer may enter upon private land without a warrant to determine if a fire emergency exists. If conditions on private land pose a real threat appropriate action may be taken to mitigate the risk.

During the public hearing on the ordinance, the section that gives author ity to come onto private without warrant caused considerable discussion. Oscuro resident

Jerry Carroll requested smoke, as the ordinance that law enforcement personnel be allowed on private property only if there is a "clear and present danger" with actual fire visible, not just smoke. Carroll said no authorities should be allowed to enter private land without a warrant or at least without permission from the land

County emergency management coordinator Bill Martin said the issue is sensitive, but there are problems with vacant lands where the owners are not present. Martin said that while land owners will be called if smoke is seen, the first intent is know of any location in New Mexico that the fire department or forestry division will stop at the gate to get permission (before responding to a fire)," Mar-

Carroll said no one goes. on his property without permission as they will get sued. The county attorney recommended adding words that a reasonable attempt will be made to contact the property owner. If an authority sees smoke and feels there is danger, then there is probable cause to enter the land to investigate," said attorney Alan Morel.

Sheriff Tom Sullivan said common sense will dictate action, for example if smoke is seen on a windy day, his office will investigate.

We have to rely on the deputies to have common sense and be prudent," said county commissioner Earl Hobbs.

The ordinance allows the county to issue permits for burning under circumstances. certain Along with the permit from the county, anyone wishing to burn must obtain an 'air quality' permit from the NM Environment Dept: and must notify the Lincoln County Sheriff's Office within 24 hours of the intended burn of the exact location of the burn for each day of burning.

Enforcement of the fire ordinance is the duty of the Lincoln County Sheriff and his officers. The county manager or emerto investigate. "I don't gency coordinator are also authorized to order an individual to cease and desist from burning if it is determined to be a risk, even if a permit has been issued. Failure to comply with an order to desist when a severe fire hazard or fire danger emergency has been declared may result in a citation.

Violations of both ordinances are considered misdemeanors punishable by fines not to exceed. \$300 or imprisonment of not more than 90 days or both Each day the ordinances are violated is considered a separate offense.

As with the fireworks ordinance, the regulating of improper handling of fire ordinance was adopted with an emergency clause meaning it went into effect immediately.

Copies of Ordinance 2003-07 handling of fire are available from the office of the County Manager at the Lincoln County Courthouse in Carrizozo, 648-2385.

## County Tourism Receives Grant

The Lincoln County Tourism Council has received a grant of \$2,235 from the Rural Economic Development Through
Dourism (REDTT) project.

The grant will help pay for four festivals in Lincoln County. Those are the second annual Fiber Festival on May 17-18 in Lincoln; White Oaks Miner's Day and Voices from the Past performance on June 7 in White Oaks: the sixth annual Arts in the Orchard event in Glencoe on Sept. 7; the fourth annual Starry Night Star Party in Lincoln on May 10.

The Lincoln County Tourism Council has received \$24,652 in REDTT grant funds to date. Lincoln is one of the five original counties in the REDTT service area.

Additionally Lincoln County will share with DeBaca County two REDTT grants: The first is for \$2,800 for the Third Annual Billy the Kid Country Writers Tour of locations in Lincoln and DeBaca Counties during August: \$550 for the second annual Billy's Last Ride trail riding event which was held in April in

DeBaca County.
REDTT is part of the New Mexico State University Cooperative Extension Service. It provides education, training and technical assistance to 18 New Mexico counties.

# County Adopts Tight Budget

"The sheriff's budget has gone from \$660.000 in 1992 to \$1.4 million now," Martinez said. Martinez advocated consolidating dispatch with the municipalities to save money, and he also questioned why the sheriff's office was dispatching for Carrizozo and Capitan at no cost, and providing police coverage to Capitan.

Martinez was also concerned about the cost of purchasing and operating the full sized Sport Utility Vehicles purchased by the sheriff's office.

commission County chairman Rex Wilson said the county is not buying any vehicles at this time.

Stewart said it was the county commission that had approved sheriff Tom Sullivan's request for vehicles in the past.

County commissioner Earl Hobbs asked if Capicompensates the county for dispatch and police services.

Sullivan said last year they requested the village provide funds for dispatch but none were provided. "I could cut off Capitan from dispatch, but that would be a disservice," Sullivan said.

Hobbs then apologized to Sullivan for his questioning at the May 2 workshop. "If I upset you I apologize," Hobbs said to Sullivan. "My purpose was not to upset rather to take care of things I feel are my responsibility. I have a deep respect for you per-

Stewart said the money will come from the New Mexico Dept. of Tourism. "The sheriff says no money will come from his budget for the Billy the Kid project,"

"Why don't we get the department of tourism to fund investigation into the McKnight and Katina Chavez murders?" Martinez asked.

"The department of tourism will fund Billy the Kid." Stewart responded.

The budget also includes an increase of \$35,000 a month from the previous contract amount for Corrections Systems Inc. that operates the Lincoln a year. County Detention Center. While county commissioners said such an increase was a renegotiation of their contract, Stewart turned from DFA in July. said he was on the "horns of a dilemma."
