

The Town of Carrizozo may have a new town hall by next year. So hopes the which town council approved unanimously rough plans for a new 3,770 square foot building similar to the new magistrate court facility.

Trustees approved the rough plans brought to them during a special meeting on Wednesday, May 28. Trustees also held a budget workshop at the same meeting.

want a metal building for town hall. He also said the reason for going to the UNM school of architecture is because it will take less time than the town going to an architect.

In discussing where the new building will be constructed, Weihbrecht said the intent is to close 4th street between the old town hall and the small veteran's park. The street and curbing will be torn out and the new building constructed so the front entrance can be seen from Central Ave. The office area of the old town hall will be demolished and that area used as parking. The mayor also said plans are to remove the cottonwood trees in the park and

Municipal Judge C.O. Rominger requested the conference room of the old town hall be retained and remodeled for a municipal court room and offices. Currently municipal court is in the police department building. Rominger said it would be better to have the court and police department in separate facilities.

The old town hall portion then would be connected to the new town hall with a breeze way.

Weihbrecht said the poplars at the old town hall will also have to be removed because their roots are causing major problems with the old building. Rominger suggested poisoning the roots be-

# Carrizozo Budget Workshop Tonight

Carrizozo Town Council will again review the proposed preliminary 2003-2004 budget at a workshop at 5:30 p.m. tonight, Thursday, June 5 in the town offices in the recreation center.

At a special meeting workshop held Wednesday, May 28, trustees reviewed the figures for the proposed preliminary budget that has no salary or cost of living increases for employees. A one time merit pay for each employee has been budgeted, but only will be considered at mid year if revenues allow, town clerk Leann Weihbrecht told THE NEWS.

approved preliminary budget forwarded to the New Mexico Department of Finance and Administration (DFA) by July 1. And DFA this year is requiring municipalities to do budgets for the 2004fiscal 2005 year, Weihbrecht added.

Weihbrecht said the proposed general fund budget is basically the same as last year's budget.

Most of the town's general fund revenues are from gross receipt taxes. proposed Weihbrecht budgeting gross receipt taxes revenues at only \$4,000 more than last year's budget. She based the percentage of increase

The town must have an upon the increases in the tax revenue received over the last three years.

> Weihbrecht said her DFA budget analyst had recommended the gross receipt tax revenues be higher, but she wanted to be safe and go with the lower increase.

As proposed, the preliminary budget shows a total of \$386,695 budgeted for the general fund. General fund revenues proposed are: franchise fee of \$4,800; municipal gross receipt taxes of \$105,000 and state gross receipt taxes of \$105,000; property tax of \$29,000; dog license/pound fees of \$450; business registrations of

In presenting the basic floor plans to the trustees, town clerk Leanne Weihbrecht said the layout is basically the magistrate court building there in Carrizozo. Weihbrecht said the 3,770 square foot building will include a 967 square foot meeting room that can hold up to 125 people. Public access to the building, including the meeting room, will be from a front entrance. While trustees and Weihbrecht preferred not having a direct meeting entrance, room Weihbrecht said the architects might add that and other features if they are required for fire codes.

"We want to send this floor plan to the UNM school of architecture to see if their students can draw up plans," Weihbrecht said.

While hoping to avoid paying engineering and other fees, the town has just under \$70,000 left in a grant that could pay for engineering fees needed, she added.

While the floor plan for the new city hall is similar to the magistrate building, town officials want the exterior of the building to be stucco walls with metal roof, instead of all metal like the magistrate facility. "We don't want a metal building, we want pretty," something Weihbrecht said

The mayor said a lot of people in town do not

# Woman Injured At 54/380 Intersection

A 62 year old Bosque Farms woman on her way to Ruidoso was injured when her vehicle was Tboned in the Highway 380/54 intersection in Carrizozo on Sunday morning.

According to Carrizozo investigating police officer Johnny Rivera, at 9:20 a.m. on Sunday, June 1, Elsie Knight was driving east on Highway 380 in her 1994 red Blazer S-10 when Abel Garcia of Dodge City, KS in his 1997 Ford Expedition was south bound on Highway 54. Rivera said Garcia stopped briefly at the intersection, then proceeded at which time he collided with Knight.

Rivera said Garcia told him he thought it was a four way stop.

The impact of Garcia's vehicle pushed Knight's vehicle out of the intersection over the curb and into the Four Winds parking lot causing it to collide with a parked Ford Blazer owned by Jessy Rossi who was sitting in the car.

ambulance Carrizozo transported Knight to Lincoln County Medical Center, Rivera said. Neither Garcia or Rossi was injured.

Garcia was cited for failure to yield right of way. A similar accident occurred at the intersection the week before, Rivera told THE NEWS. That time it involved a person in a pickup truck pulling a horse trailer going south on Highway 54, who just paused and drove through the intersection without looking. That time the vehicle hit was going west on Highway 380.

Rivera said the intersection is dangerous, as it appears people do not read the traffic signs on Highway 54 that advise that "cross traffic does not stop." Rivera said a flashing light to alert south bound travelers on Highway 54 about the intersection is needed.

> Municipal court expenditures are budgeted at \$35,810, which is \$1,017 higher than this year, due to the \$328 one time merit increase for the employee.

> Financial administration (clerk and deputy clerk) is budgeted at \$122,284. which is about \$2,000 higher than this year. Increases are in travel, the merit pay for two employees, and increased health care and general liabilities insurance costs. Some items, such as computer upgrades/maintenance, utilities/telephone, budgeted lower than this year.

When trustee Tommy Guevara said he hoped the employees don't spend too much time in the employees lounge, Weihbrecht said the lounge is the only place employees will be allowed to eat. Trustees also agreed the floor should be tile, with the mayor wanting tile similar to that in the new museum.

As with the magistrate building, the new town hall public areas will be accessed through an enclosed entrance vestibule that opens to a public reception area, ADA compliant public restrooms, storage rooms and a room just for the copy machines.

Offices for the town clerk, billing clerk and **Motor Vehicle Department** (MVD) clerk will be separated from the public with a glass wall that has service windows. MVD photos will be taken in the reception area.

The public will be able to access the town offices only through a "buzz" door. Rear offices, closed to public access, will include a janitor's storage area, employee lounge, mayor's office, men and women staff restrooms, vault and supply room. There will be rear entrances to the east and west side of the building

aside for furniture that can be purchased from the state correction industries.

**Trustee Eileen Lovelace** said the magistrate court cost \$225,000 just for the metal building which was purchased as a package from Mueller metal building manufacturing company. "Mueller did the plans already," Lovelace added. "So there should not be much more to do to the plans. Just figure the cost without the metal siding." The mayor said the new building will have all the same features, such as metal framing, as the magistrate building, but will have the stucco siding.


Trustee Wes Lindsay suggested the town work with the church across the street for a parking area that would benefit both the church and town hall.

## Prehistoric Burial Site Found On US 70 Project

On May 22 equipment operators. for Sierra Constructors Blanca (SBC) uncovered a prehistoric human burial during construction of a culvert trench on the US 70 Hondo Valley project.

SBC stopped all construction work in the area and notified the Lincoln County Sheriff and Office of the Medical Investigator: these offices determined that the remains were prehistoric and not part of a crime scene.

con-The NMSHTD tracted Parsons Brinckerhoff to excavate the remaining portions of the burial and the burial pit.

Samantha Ruscavage-Barz, Ph.D. Cultural Re-Specialist. source NMSHTD Environmental Section, stated: "We have been very pleased with the interest the local media has taken with cultural resources in the Hondo Valley. We welcome the opportunity to inform and educate the public about the Valley's rich cultural

heritage." Brinckerhoff Parsons (PB) excavated the burial between May 27 and May 30. Kirsten Campbell was the project manager for PB. excavations were directed by George Arms of PB?

All artifacts and skeletal remains were collected and will be analyzed by specialists. The NM Historic Preservation Division will consult with Native American tribes to determine if any tribe claims cultural affiliation to the burial and to determine final disposition of the burial. If no tribe claims affiliation, the burial and its associated artifacts will be curated at the Museum of New Mexico in Santa Fe.

Soil samples were collected for analysis, these will be analyzed for microscopic plant and pollen remains that can tell us what kinds of plants were available for food and other uses in the past.

Charcoal samples will be submitted for radiocarbon dating to give us an idea

## **Ruidoso Man Drowns** In Grindstone Reservoir

A 20 year old Ruidoso man drowned in Grindstone Reservoir on Monday in what state police : call an accident.

According to information provided by State Police, the body of Nathaniel Leslie was recovered by state police divers on the morning of Tuesday, June З.

State police were called to the lake about 2:30 p.m. Monday, June 2, by Ruidoso Police who were first to respond to the report of a drowning. The state police dive team was called in and divers were only able to do two dives to search the cold waters of the lake before calling the day on Monday. Early Tuesday, the body was found on the first dive. According to reports from witnesses, Leslie had gone out on the lake floating on a log. Apparently he decided he could not get back to shore and he jumped off the log to swim back to the shore which was about 100 feet away. Apparently Leslie succumbed to the cold temperatures of the lake water and the weight of his clothing and went under. Witnesses assisted police divers in locating the body on Tuesday.

During the search, the lake was closed with all boats called off and fishing shut down. Boats and fishing were again allowed once the body was recovered, State Police Lt. John Bowers told THE NEWS.

The drowning is considered an accident at this time, Bowers said.





## THOUGHTS FROM THE EDITOR'S DESK Pretty or Useful?

Budgets were and are being discussed, but Carrizozo has another matter to discuss, a new city hall building. The proposed basic floor plan for a 3,770 square foot building will include many changes from the city hall building that has been used for many years. The meeting room will be larger, parking space may be added, and access to offices will be through a locked door which will open only when an employee inside pushes a buzzer. The proposed main change will be the location of the new city hall building. The proposal is to close the portion of 4th Avenue between the present city hall building and the Veteran's Park and to place the new building in that space which is now a street.

Upgrading the old city hall building had been proposed at one time, but now officials are planning an entirely new building. We do hope the wiring will be adequate for new computer upgrades in the future, and a priority should be that insulation be more than adequate. In the past there have been complaints about the lack of insulation in the present building and it being cold in the winter and hot in the summer And there were constant complaints that the cooling system had problems and did not work properly.

it seems the town council should get opinions from the public as to which features are most important in a new city hall building before making final decisions. Apparently some things were either left out or not thought important when the last city hall was built, because too many things were wrong with that building. What one person may think is important might be completely forgotten by another.

Letting the public help make decisions and suggestions is necessary, otherwise something that might prove to be of impostance later could be overlooked. It would be wise for officials to consider engineer and architect suggestions, but sometimes their suggestions are for municipalities that are larger or have different needs. The local public is much more aware of what is needed in Carrizozo than engineers and architects from somewhere else. Let the public make their suggestions and then consider if these ideas should be included in the final plans for the new city hall building.


Doesn't it seem there should be public restrooms, not just staff restrooms? Doesn't it make sense that the room used for copy machines should be equipped with cooling and heating to maintein an even temperature at all times? And wouldn't it be a good idea to implement a safeguard to protect against the possibility of another lightning strike?

Instead of merely copying another building, it might be wise for town officials to ask for input as to what the public really wants in the new city hall building. Maybe the public does not want the cottonwood trees removed and replaced with Afghan pines. Maybe the public would prefer another type tree and native plants instead of grass. Allowing the public to be involved will help make it their building too.

Not having an outside door to the meeting room would be a definite change, and may or may not be appreciated. Only the public can say what they prefer or don't prefer.

Getting the public involved, before final decisions are made is the best way to keep city hall a public building. Public may have good ideas





SANTA FE -- The Official State Scum. Sound pretty impressive? New Mexico doesn't have one yet. With the addition of several new state critters during the past legislative session, the list may be so long that a state scum will be the only possibly deft.

Actually, we even have a candidate. Dave Clary, down in Roswell has taken up photography and, as with everything else he tries, he's becoming a pro very quickly. Recently he photographed some unusual algae and lichen at Bitter Lake National Wildlife Refuge northeast of: town. He sent the photos to an expert on such things, who went out and collected samples for analysis. He suspects they may be newly-found strains and the algae may be native only to New Mexico.

What better candidate for official state scum? Pending lab test results, I've encouraged Clary to find a lawmaker to introduce a bill. But first I advised him to find a classroom of enthusiastic kids to endorse it and go to Santa Fe as a lobbying team. That's the surest way to gain acceptance.

Adoption of official state critters. slowed down during the Gary Johnson administration. if it wasn't something he could race or climb, he wasn't much interested. But Gov. Bill Richardson can spot promotion value a mile away. He knows there's bound to be algae aficionados and lichen lovers all over the world who will descend on Roswell. They are unlikely to equal the number of UFO nuts, but then pond scum isn't likely to attract as many intergalactic visitors. Roundhouse rail birds warn of trouble, however. There is little hope, they say, of getting an official state scum bill past both houses of the Legislature without someone substituting the name of their worst political enemy in place of the algae. Former state GOP Chairman John Dendahl. enjoys wide bipartisan support in early returns. Specialty License plates were another category of bills proliferating the Legislature this year. Former Gov. Johnson liked to yeto license plates too. At last count, lawmakers created more than a dozen new plates this year.

with wildlife themes. designed to bring in extra money for research on "low-profile species" such as bats, lizards, songbirds, Sandia hairstreak butterflies and maybe even some pond scum

The special plates cost an extra \$25 for initial issue and an extra \$10. annual renewal fee. The Game and Fish Department is hoping to make. close to \$200,000 from the program next year.

Gov. Richardson has also agreed to help reopen the investigation of whether Billy the Kid shot two deputy sheriffs when he escaped from the Lincoln County jail back in the days of New Mexico's next-most-famous governor, Lew Wallace, back in 1881 There seems little doubt the Kid killed them, but since he was being held for execution in another capital murder case, Sheriff Pat Garrett didn't figure there was much sense going to the trouble of pinning two more murders on him.

But 122 years later, seemingly there is much reason to investigate. The present Lincoln County sheriff and the governor's office both insist. this is not a publicity stunt aimed at boosting tourism. And if you believe that, you probably believed Iraqi information minister Baghdad Bob's reports that coalition troops were being crushed, even as they were pounding on his door. Unfortunately, after 400 years of existance, Billy remains New Mexico's most famous personality. So if we can buff him up a little, maybe the Wortley Hotel in Lincoln can afford to reopen. We can only hope, however, that increased fame doesn't do to Billy what it did to Smokey the Bear, when he had his middle name unceremoniously dropped about 15 years ago.

# Capitan Village Budget Unresolved

#### by Doris Cherry

Capitan Village Trustees will again consider the 2003-2004 preliminary budget at their regular meeting Tuesday, June 10. The meeting begins at 6:30 p.m.

Trustees held a special. meeting on Tuesday, June 3, to continue discussion on the preliminary budget At a previous workshop village clerk Kathryn Griffin submitted a proposed budget that included a five percent across the board salary increase for all employees: The increase would provide a cost of living adjustment and to cover some of the 14 percent increase in employee's cost of health insurance.

Proposed preliminary budget figures show projected general fund revenues of \$560,000 and expenditures of \$559,140; deficits in the water fund, Smokey Bear enterprise fund and balanced budgets for the remaining departments. Copies of the proposed. budget are available from the village clerk,

Most of the discussions at the June 3 special meeting were how to increase revenues to the village in order to pay for the salary increase and to hire another police officer. Capitan police chief Chuck George said he needed another officer because he could not continue to. work overtime and days off.

Bus less owner Joe Ferrell also requested another officer. He said his businesses had suffered at least \$15,000 in losses fre n burglary, vandalism

and lost items in the six years he has owned the business.

Ferrell encouraged trustees to raise the gross receipt taxes to raise revenues to cover the cost of an additional police officer. Currently two Capitan officers are attending the police academy and are not available for work,

Trustee Bobbi Shearer said the only remaining gross receipt tax left for the village to impose is the one eighth of a percent gross receipt tax for infrastructure and a one-sixteenth of a percent gross receipt tax for capital outlay. These must go to referendum to be approved.

We won't come up with any big money with all of them." Griffin said.

Ferrell supported an increase in gross receipt taxes, which he said will increase as the community and businesses grow. He also supported a road assessment on subdivision properties in order to get the dirt roads paved. He said the road assessment would be immediate return of money and the gross receipt tax would be a long term situation.

Trustee Leroy Montes said the additional gross receipt taxes will not cover the costs of upgrading the subdivision dirt roads.

"But if we get to a point where we have enough growth, then we should go with the gross receipts," Shearer responded.

Shearer suggested that the March 2004 municipal elections include ques-tions for the gross receipt taxes and the road assessment.

Griffin said a referendum would not be needed

for an assessment. Another resident suggested the village hire another cop to slow traffic in the subdivision as one way to reduce the dust we can figure how to get because of the recently more money for roads," he formed. added.

"And extra police, water, sewer and so on," Shearer added.

Shearer also reminded trustees that in 16 years, the village will no longer get the \$107,000 a year payment from Ruidoso for purchase of the Eagle Creek properties.

"Plus the \$60,000 a year we get from the lease of the Eagle Creek water rights to Ruidoso could go; any time," Montes said.

Once again the group got off the subject of approving a preliminary budget before July 1.





Without answering Cox. ficer was not added to the proposed preliminary budget. "The only way we can guarantee an extra police officer is to increase the property tax line item," Shearer said. If the town requests additional property tax, the state Depart-ment of Finance and Administration DFA will adjust the village property tax accordingly, Shearer added.

Residents then challenged why there was so much money in the bank, and why it was in Certificates of Deposit and why that money could not be used for streets and police.

After several minutes of discussion without any resolution or compromise on the budget, chief George said procrastination has killed the police department. "I brought to you a department clearly functioning that has been able to clear cases," Chief George said.

"In the past six years, the village has run off qualified officers because of the failure to make a decision-You trustees have brought this issue to the table then never brought it back. I asked you to put the police officers on the PERA to better draw qualified applicants," George added.

"I'll do what I can to make the police department work," George said. "I'll work eight hours a day and you figure how to cover the rest of the time." When trustees all were asked if they wanted another officer, Montes said the village does not need another officer as he had not seen anything in the newspaper.

Discussion on the extra police officer and other budget issues continued, with some in the group raising voices and asking trustees if they were going. to take action.

Ruidoso village council- waste, recreation, convenors adopted the 2003-2004 preliminary budget at their meeting May 27.

The preliminary budget projects general fund revenues of \$7,397,199 and general fund expenditures of. \$7,187,465, with projected ending cash balance of \$1,156,725. The: balance provides for the state mandated onetwelfth reserve at \$598,955. and the village's own fiscal policy required reserve of \$557,770 for the general fund.

In all village restricted. funds, which in addition to the general fund in-clude the utility fund (water/sewer) airport, solid

tion center, revenues are projected at \$14,153,877 and expenditures at \$17,421,955, with ending balance of \$1,714,036.

Revenues in all restricted funds which include cemetery, grants, infrastructure gross re-ceipt, traffic safety fees, lodgers tax funds, arts committee, capital improvement bonds and grants, and debt service funds for revenue bonds and other debt requirements are projected at \$10.643,132, with expenditures of \$11,894,610 and ending cash balance of \$3,626,658. Councilor Deborah

Byars asked if they could use lodgers tax funds to cover the convention center operations, which are subsidized from the general fund by \$151,000.

When Byars asked for \$98,000 to be transferred from the lodgers tax councilor Bob Sterchi said there has always been a balance left in lodgers tax to cover promotion of special events throughout the year. Finally Sterchi suggested a compromise of \$46,000 from lodgers tax to the convention center, which Byars accepted.


