US Senate Looking At 4 Lane Hwy. 54

Senate Bill 290 has been introduced by US Senator Jeff Bingaman to fund projects to reconstruct US Highway 54 from Tularosa to Wichita, KS to four

If the bill succeeds and millions of dollars in federal funding are appropriated for the project, US Highway 54 may become a full four-lane highway through New Mexico.

This information was presented during the public hearing held July 22 in Carrizozo about the US Highway 54 project from Carrizozo to the junction of US 60 and 285 south of Vaughn.

Officials with the New Mexico Department of Transportation (NMDOT) and the private Louis Berger Group which conducted the US Highway 54 project Environmental Assessment (EA) presented information during the public hearing. Another meeting was scheduled for July 23 in Corona.

Copies of the US Highway 54 Environmental Assessment (EA) can be

viewed at the office of the county manager in the Lincoln County Courthouse in Carrizozo. Comments about the EA can be submitted to the NMDOT until August 8.

The hearing was held to review and take comments on the recently completed Environmental study of a 77-mile segment of US 54 from US 380 in Carrizozo to US 285/60 just south of Vaughn. At the end of the

review, officials closed the public hearing and discussed the future of US

Officials spoke about the initiative called SPIRIT to four lane US 54, that has gained momentum with

Former Ruidoso Downs Judge Found Guilty

A Lincoln County jury returned a guilty verdict after several hours of deliberation in a 17 year old child sex molestation case against former Ruidoso Downs Municipal Judge Martin Valenzuela.

According to a press release from district attorney Scot Key, the jury found Valenzuela guilty of criminal sexual penetration in the third degree and criminal sexual contact of a minor under age 13. Both crimes are third degree felonies.

District Judge Karen Parsons ordered Valenzuela to undergo a 60 day tencing.

Valenzuela was elected as municipal judge in March 1986 to a four year term. In 1987, two sisters who were then 12 and 15 reported Valenzuela had sexually molested them while they were in New Mexico visiting their grandparents. Shortly after the sexual molestation accusations surfaced and

Matt Ferguson Chosen To Fill Vacancy


Carrizozo Board of Education wants Matt Ferguson to fill their vacant Position 4 school board seat.

White Oaks Seeks Fire Mitigation Help

As more visitors find the "ghost town" of White Oaks, residents there worry more about wildfire that could start in the overgrowth along County Road A041.

Seeking help to do fire mitigation, White Oaks Fire Department volunteers Walt and Ruth Birdsong went to the county commission at the July 15 meeting in the Lincoln County Courthouse in Carrizozo.

"It is very dry," Ruth Birdsong said. "And we have a lot of tourists. All it would take is someone to pitch out a cigarette to start a fire."

"It's a county road and we need help in clearing the frontage," Birdsong added. "We don't have the equipment to move or dispose of this, that's why we're asking for help."

As an example of tourists, Birdsong said there were 1,500 people at the Miner Day event in June, also people travel on the road for the artist studio tours and for sight seeing. Also there are some families who live in an older

development that has only one access out, on A041. "We've become a tourist area," she added.

In response to a question from county commissioner Earl Hobbs, Birdsong said the road in question is the gravel road that goes north from the

end of the pavement in

White Oaks. County manager Tom Stewart said the White Oaks road only has a prescriptive easement of 18 to 20 feet, with an arroyo on one side. "You need to get

FOG Sends Complaints Against Capitan To AG

The New Mexico Foundation for Open Government (FOG) sent a letter on July 16, 2003 to Assistant Attorney General Albert Lama, Director, Civil Division, of the New Mexico Attorney General's office concerning complaints about violations of the Open Meetings Act by the Capitan Village

The FOG letter to the AG's office states:

Dear Mr. Lama:

Please investigate for some concerned citizens of Capitan the following complaint about violations fo the Open Meetings Act by the Capitan Village Council. The council held a regular meeting on July 8. The agenda was not posted in accordance with the Open Meetings Act or the Village's legally required Open Meetings Resolution. The act says that the council determines what is reasonable notice, and the council determined in its resolution that the agenda will be that the agenda be posted at three public places, including Village Hall.

Rose Barton, a resident of Capitan, complained that no agenda was posted in the glassenclosed bulletin board outside Village Hall. Doris Cherry, a reporter for the Lincoln County News, noted the same omission and reported that she was told by Capitan residents that "no notices were at the store or other locations in the village on the day prior to the meeting" and that she inquired about this at the meeting.

She said no member of the council responded but that Clerk Kathryn Griffin said she had given the agenda to the village police officer to post. She quoted Ms. Griffin as saying, "People take the notices down at the post office and the store, and one wasn't put out front in the Village Hall

glass enclosed bulletin board". The agenda includes as Item No. 11: "Discussion/Action on threatened or pending litigation." This lacks the specificity required by the act, and of course a single matter of litigation cannot be both threatened or pending. It must be one or the other. Ms. Cherry says the council went into closed session with a motion and roll call vote but with no specificity as to the subject. When the open meeting resumed, she reported, the council voted to authorize the city attorney to draft "a position paper for trustee review and approval at the next meeting." That action suggests the litigation probably is pending. If so it should have been identified by case number to meet the specificity requirements in the agendaand in the motion to close the meeting.

The council apparently habitually votes on items not on the agenda. Examples:

The March 11, 2003, minutes show that the council voted to approve the agenda "with the following additions: 1.) Discussion on Lincoln County Solid Waste Representative; 2.) Discus sion of Dust Control for subdivision roads, 3.) Ordinances by Trustee Whitaker." The minutes on these issues are so skimpy that it is difficult to tell whether there was action or only discussion. However, on No. 3, the minutes recite that: "the decision was made to put George Tippin on the Ordinance Review Committee, allowing him to choose four more people to review all the Village Ordinaces and recommend changes." That certainly looks like an action.

On April 9, the minutes show, the council approved a motion by Trustee Whitaker to add "Blue Ribbon Proclamation" to the agenda. The council then approve a motion by Mr. Whitaker to declare April 22-28 Blue Ribbon Week. And the mayor "presented a proclamation that was signed by himself and all council members" to

Lincoln County Commissioner Leo Martinez apologized for using inaccurate dollar figures when discussing the Carrizozo Cinco de Mayo Festival request for lodgers tax funding. But he did not back down on his request accountability for county lodgers tax money

spent. During the county commission meeting July 15 in the courthouse in Carrizozo, the Carrizozo Chamber of Commerce president Cynthia Culbertson attended the meeting to correct information about county lodgers tax funding the chamber received. for its Cinco de Mayo Festival. Culbertson had been directed by chamber members at their last meeting to respond to inaccurate figures Martinez used at the June county meeting commission when discussing the lodgers tax funds approved for the chamber's Cinco de

Mayo event. Culbertson had sent the commissioners a letter about the chamber concerns and a list of receipts from the Cinco de Mayo festival submitted to the Lincoln County Lodgers Tax Committee for reimbursement. The lodgers tax committee had approved the chamber's request for \$2000 for advertising and \$1000 for operational expenses for the Cinco de Mayo festival. However, the chamber only spent \$2207.23 which was submitted for reimbursement. She also sent a copy of the July 3 issue of the Lincoln County News that quoted Martinez questioning "\$7,000 of lodgers tax funds" to the Carrizozo Chamber of Commerce.

In her presentation to the county commissioners Culbertson said she was unsure if Martinez's words were taken out of context in the article, but regardless she wanted to "set the s record straight about the numbers."

"We did not spend an examount orbitant money," Culbertson said. Martinez said (county commissioners) were "pulling out numbers" during the discussion on the lodgers taxes in June. Martinez said he

out the statement from




Martinez said he and the other commissioners have concerns about accountability, and how the lodgers tax committee needs to establish rules on who gets the money and how much depending on how

County Finalizes 2003/'04 Budget

Lincoln County Commissioners approved the resolution adopting the final 2003-2004 fiscal year budget at their meeting July 15 in the courthouse in Carrizozo, with minor adjustments made by the NM Dept. of Finance and Administration (DFA). County commissioner Leo Martinez voted against the budget approval, with no explanations.

The resolution set the general county government at 2.75 mills, Lincoln County Medical Center at 1.1 mills, and the rural health clinics at .9 mills.

The final budget also did not include the expenditures for three construction projects, because county commissioners had rejected all construction bids which were higher than budget.

Because of a higher than projected federal Payment in Lieu of Taxes (PILT) and a high unaudited ending cash balance from the 2002-2003 fiscal year that ended on June 30 the actual 2003-2004 budget has \$1,421,179 more than projected in the preliminary budget. The county expended only 95 percent of what it had budgeted in 2002-2003, a traditional pattern for county departments.

Wilson said according to information he read the PILT is still only 55 percent of what it should be. The PILT is a payment from the federal government that compensates counties that have large acreage of Bureau of Land Management lands.

"This was a priority we presented to Congressman Steve Pearce when he visited the county," county commission chair Rex Wilson said. We need to remind Congress the PILT is not exactly where it should be."

Even though there was significantly more in the ending cash balance than budgeted, county manager Stewart recom-Tom mended budgets for county departments remain at the same level until mid year. All departments had cut their requested budgets by five percent during the budget fund.

Stewart said in December he will make budget recommendations, including pay increases. Both the clerk and assessor had asked for 10 percent salary increases.

A 10 percent salary increase across the board would cost an additional \$298,236 a year, Stewart said.

commissioner County Earl Hobbs said he thought the 10 percent increase was excessive but something was needed because "our employees" are deserving."

County commissioners accepted the 2003-2004 final budget with changes to the appraisal fund as requested by county assessor Rick Silva.

Silva asked for and received \$5,400 for a seasonal worker, \$1,000 increase in per diem and mileage, \$7,000 for vehicles and \$2,000 for a copier.

Other minor changes were in the law enforcement budget (sheriffs) to provide for an \$8,044 federal grant to purchase new light weight high tech bullet proof vests for deputies. The department had to match the grant by \$4,022, and some salary adjustments.

Hobbs questioned whether officers now have vests. Sullivan said they do, but the new vests provide side rib coverage and are lighter weight.

Hobbs also: Stewart if the county road fund was adequate. "I think so," Stewart responded.

Other budget adjustments included an addition of \$74,166 from a federal "Weapons of Mass Destruction" (WMD) appropriation to help prepare local responders for hazardous materials and other types of emergencies, and \$150,000 for an emergency 911 four year database project.

Several fire departments had carry over funds mostly for equipment and vehicle purchases.

Senior citizens also had carry over funds enough to balance out the proposed \$19,238 subsidy from the county general

\$685,000 into the county facility fund that was to be added to the \$66,294 carry. over from the previous fiscal year. The total of \$751,294 would be used as a reserve for mid-year adjustments. Martinez then said he





Open or Closed Meeting?

Considering some of the information presented in the letter the New Mexico Foundation for Open Government (FOG) sent to the state attorney general's (AG) office last week about complaints made by concerned citizens about violations of the open meetings act by the Capitan Village Council, the results and finding by the AG's office could be interesting. The entire letter is published in this issue of The NEWS and will better explain what the complaints are.

Our main concern is that all governmental bodies follow the state open meetings act and conduct governmental business in open session as required by the state. Yes, we are aware there are some items that may be discussed in closed session, and we accept that, but we do object to an agenda item of "threatened and/or pending litigation". because it is not specific. Certain litigation matters may need to be discussed only in private but the public has a right to know which litigation matter is being discussed.

Meetings held by elected bodies and any of their appointed boards and subcommittees should be open to the public. Excluding the public for no precise reason gives the impression some officials are trying to hide what they are doing. Is that really what governmental bodies want? Or would officials prefer that the public feels comfortable with the way governmental business is being conducted?

Perhaps you don't know or forgot that a similar letter was sent by FOG to the mayor of Camizozo three years ago this week. The letter dated July 20, 2000 to the mayor of Carrizozo listed concerns and a copy of that letter, as designated by cc: at the bottom of the letter, was sent to the AG's office, the FOG executive committee, Cecilia Kuhnel, this editor, and the Carrizozo board of trustees.

Lame excuses were made that the complaints against Carrizozo were not true, but were disproved when the AG sent a letter to the town attorney dated September 20, 2000 that stated that information available indicated that the town violated the open meetings act, and listed each of the allegations. The AG's opinion explained each finding and the AG sent the latest issue of the open meetings act compliance guide to the town attorney with the letter.


Allegations are just that, allegations, until proven to be true or false, and the best thing we can all do is wait for an answer from the AG's office as to whether the allegations made against Capitan are true. The AG's office was very thorough when investigating the Carrizozo allegations and we are certain the AG's office will continue their diligence.

If each and every governmental body complied with the open meetings act there would be no need for the act, but as was proven three years ago, some allegations are true.

Naturally, it would be nicer if all boards would make an effort to do more governmental business in the open, but some officials believe they have the right to do what they want, not what is best for the people they are serving...

The FOG executive committee and directors are people from all around the state, influential people who work to help keep government open. Thank goodness they do. Secrecy has to valid place in governmental business.

AG will make decision

SANTA FE - The New Mexico Supreme Court has taken its lumps for a decision upholding Gov. Bill Richardson's right to remove public members of the Judicial Standards Commission without stating or proving a cause.

Newspaper editorials, letters to the editor and people on the street think it is a very bad idea. They charge that:

-- the governor doens't have the power to remove commissioners whose terms haven't expired.

-- terms are staggered to insure continuity and prevent partisan mischief. -- it is an assault on the commission's

independence. -- it violates the separation of powers

-- it was a paritsan decision by an all-Democrat court that had frequently ruled against former Gov. Gary Johnson, including a case involving Johnson's removeal of current Lt. Gov. Diane Denish from the New Mexico Tech board of regents.

since the governor appoints the six public members of the 11-member commission, he now can control the commission s actions.

-- future governors will now remove all previous governor's appointees. -- it was a heavy-handed move by Gov. Richardson to grab total control of state government.

In its well-reasoned 37-page opinion, the court already had considered all these claims and agreed with many of them, sometimes unanimously. The major decision came down to whether the governor has the power to remove lay members of this commission.

In a 3-2 vote, it relied on Article 5 of the state constitution outlining executive authority. That article gives the governor the power to remove appointees "unless otherwise provided by law." In creating this commission, neither the constitution nor statutes provided otherwise.

The majority opinion cited the creation of the State Highway Commission by the same Legislature in which lawmakers included a provision which greatly limited the governor's removal authority. Legislators, stated the court's majority, obviously knew they could have included the same provision for members of the Judicial Standards Commission.

The majority noted that the Denish case dealt with an attempt to after the length of board member terms rather than with removal.

The two dissenting members of the court argued that the commission's

staggered terms, established by the Legislature, strongly implied that it intended to limit the governor's removal authority. Their dissenting opinions spelled out the concerns later cited by newspapers and the public. They also noted instances when the court had taken into account such factors and ruled otherwise.


But the majority said the court would be overstepping its authority to interpret the law by implying the intent of a past legislature. It pointed out that a future legislature could impose limits on a governor's removal authority. That appears to be a very good idea.

So the court will get its criticism. But courts, especially Democrat ones, are often criticized as being judicial activists for making new law with their decisions. The court, in this instance, avoided that, I personally know four of the five justices and can youch for their fairness and impartiality. I don't think any of them would have voted differently had the governor been Gary Johnson or anyone else.

The justices are smart enough, although some editorials weren't willing to grant the point, to realize that we will have Republican governors in the future who could use the decision to pillage the Judicial Standards Commission.

The court went a step further and may get itself in more hot water by suggesting that the lack of legislative funding for the commission may pose an even greater threat than the governor's recent action. The commission has four staff to investigate 923 complaints received last year. The court says the small staff is inadequate to ensure that the commission fulfills its mission of overseeing judicial conduct.

Now that is bravery under fire.





IDENTITY THEFT

In the course of the day, you may write a check at a store, charge gas on your credit card, mail tax returns, call home on your cell phone, or order new checks. More than likely you do not give these everyday transactions a second thought. But someone else might.

Today, we have a new group of criminals called identity thieves. Their stock in trade are your everyday transactions. Each transaction requires you to share personal information:

* Your bank and credit card account. numbers,

* Your social security number (SSN). * Your name, address, and phone number.

An identity their takes your personal information without your knowledge to commit fraud or theft.

While you probably can't prevent identity theft entirely, you can minimize your risk. By managing your personal information wisely, cautiously and with an awareness of the issue, you can help guard against identity theft:

Before you reveal any personally identify. ing information, find out how it will be used and whether it will be shared with others. Ask If you have a choice about the use of your information.

* Pay attention to your billing cycles. Follow up with creditors if your bills don't arrive on time. A missing credit card bill could mean an identity thief has taken over your credit card account and changed your billing address to cover his tracks.

* Guard your mail from theft. Deposit outgoing mail in post office collection boxes or at your local post office. Promptly remove mail from your mailbox after it has been delivered.

Sheriff Sullivan Refutes Reports

Lincoln County Sheriff Tom Sullivan is refuting recent television reports that the state of Texas is refusing to allow anyone from New Mexico to exhume the remains of Brushy Bill Roberts in Hico, TX.

"I've not heard anything about this," Sullivan told THE NEWS on Wednesday, July 2. Sullivan said the mayor of Capitan, who is helping the sheriff with the Billy the Kid project. has been in contact with a judge in Hico and the Brushy Bill Roberts museum owner. "We are not even to that stage of exhuming anyone in Texas." Sullivan said. .

Sullivan told *THE*.

NEWS on Monday, June 30, that he has been in contact with the Grant County Commission that has given their attorney permission to begin the legal paperwork to request the Office of the Medical Investigator (OMI) exhume the remains of Katherine Antrum in Silver City, Sullivan said Grant County is interested in the project to help boost tourism in their economically depressed area.

"We are going to invite the owner of the Brushy Bill museum to Silver City when we do finally exhume Katherine Antrum," Sullivan added:

Sullivan hopes to also look into a claim by a John Miller in Ramah, AZ that he too was Billy the Kid who had escaped Pat Garrett's gun in Fort Sumner, Sullivan said ac-

cording to a book written. about Miller, the dates and many of the stories are eerily plausible."

For now Sullivan and the mayor are working on the logistics of the July 19 ceremony for Deputy James Bell, one of two allegedly killed by Billy the Kid in his famous last escape from the Lincoln County Courthouse on April 28, 1881. The July 19 ceremony begins at 10 a.m. at the White Oaks Cemetery, Father Dave Bergs of Santa Rita Parish will conduct the ceremony to place a monument purchased by the NM Sheriffs. and Police Association. Bell's remains had been in an unmarked grave for 122 years. There will be refreshments and an old time gunfight at the White Oaks Saloon after the ceremony.

Sullivan on April 28, 2003 officially reopened an old murder case of the two deputies allegedly shot by Billy the Kid in 1881. Sullivan has extended the case to finding out whether the remains of Billy the Kid" buried in Fort Summer, NM are in fact those of the famous outlaw by using modern DNA testing. Even the governor has thrown his hat into the pursuit of the truth of the outlaw made famous by pulp fiction books.

Sullivan's modern saga of Billy the Kid is the feature story of the newest issue of "True West" magazine.



the communities, counties and states along US Highway 54. More information about the SPIRIT initiative can be seen at the SPIRIT group website at www.swpassage.org.

Since funding is the major issue for the US 54 upgrade, the New Mexico Dept. of Transportation (NMDOT) is planning to rebuild US 54 into a rural two lane highway with shoulders, with turning lanes in Carrizozo and Corona and possible passing and climbing lanes in appropriate areas. Estimated cost for the two lane upgrade is \$107 million.

Any work on the project is at least five years away.

NMDOT began the alignment study of US 54 in 1999 by identifying problems and concerns with the 77 mile segment to develop alternatives to

correct or reduce the problems.

US 54 is a principle arterial in the national highway system and an important link with Interstate 10 from the border with Mexico to Interstate 40. Fifty percent of the traffic on US 54 falls in the heavy category, commercial which is a big factor in the condition of the pave-

ment, officials said.

Using preliminary engineering studies and input from the public in meetings held in 2000, officials said the alignment study is recommending correction of the physical roadway and 'clear zone" deficiencies such as abrupt drop offs, lack of shoulders and sharp curves: eliminate potential safety hazards associated with wildlife crossings; improve roadway design

to accommodate heavy commercial traffic: provide adequate and safe off road parking in the communities along the highway and ensure system connectivity with other improved portions of 54.

Although traffic volumes on US 54 are projected to increase 100 percent in 20. years, highway officials said the numbers still do not warrant four lanes. However, if US 54 is four laned in different states, it. could result in more traffic, especially since US 54 is a NAFTA route.

In considering designs, three alternatives were developed. The first alternative to do nothing was rejected, and the second alternative is to reconstruct US 54 within the existing roadway alignment and the third alternative is to reconstruct the highway offset to the east of the existing roadway. Officials said this would allow traffic to have free flow while the new roadway, which will have eight foot shoulders and 12 foot lanes, will be constructed off to the side. This would prevent traffic delays.

The environmental assessment, is required to comply with the National Environmental Policy Act (NEPA). Based on the impact assessment, either of the two preferred alternatives create no significant impact to any human or natural resources in the project area. Some resources will be affected. but with mitigation meas-

ures, no effects would be significant. considered Some of the effects found during the EA analysis were threatened and endangered species, specifically the Kuenzler hedgehog cactus which was found in the vicinity of mile marker 136. The EA proposes to purchase land at the location four years prior to construction to relocate the cacti with mitigation measures in consulfation with the US Fish and Wildlife Service (FWS):

The NM Game and Fish Dept/ is concerned about the high number of accidents and wildlife kills in the section of US 54. In areas where wildlife crossing are known to be high, two build alternatives are for eight foot high fences, clearing trees in the rights of way for better vision and construction of concrete box culverts for wildlife crossings under the payment.

Other : environmental concerns are the potential to disturb 18 to 20 cultural resource sites that were identified in the Cultural Resources Inventory Report. Of these sites, nine are potentially significant archaeological sites. Field investigations will be done and mitigation measures developed in consultation with the NM State Historic Preservation Office.

Removal or disturbance of vegetation and potential for erosion were also listed as potential environmental impacts from the construction.

Other considerations were traffic control during construction, existing hazardous materials with seven suspected sites in Carrizozo, 12 suspected sites in Corona and two in Duran, Officials said these are primarily abandoned gas stations and/or underground gasoline storage

During the question and answer period, Sue Dickerson of Carrizozo asked why only two lanes. Traffic studies do not warrant three or four lanes, officials said. But some areas they are looking at passing and/or climbing lanes. turn lanes in Carrizozo and Corona.

Spencer, Stirling rancher north of Carrizozo whose property is dissected by US 54, asked that box culverts be installed at locations where they currently exist for livestock crossings. He said the metal culverts do not work for this.

Officials said they have identified some box culverts that are functioning as cattle crossings and these will be addressed in design process, whether for cattle or wild-

Property owners along US 54 who know of a box culvert crossing that needs upgrade or consideration in the design process should send a letter specifying where the culvert is located and the need for improvement, so their requests will be in the record.

Spencer said he tried to do that when US 380 was reconstructed, but culverts were installed to replace the old concrete box culverts used for livestock crossing. "You need to alert the property owners who may have their custom and culture affected by the highway design." Spencer said. "It has a great effect on livestock operations if done improperly."

be meeting with affected property owners about design issues. Spencer suggested highway officials ask property owners about water pipelines.

Patsy Sanchez of Carrizozo asked about the width of the shoulders and why the section between Tularosa and Carrizozo has such narrow shoulders. Officials said the section south of Carrizozo was only mainte-

nance, not reconstruction. Officials also said they have gotten many questions about the 55 mile per hour speed limit in the section south of Carrizozo. The 55 mile per hour speed limit will remain until the narrow box culverts are replaced.

County commission chair Rex Wilson asked about the US 54/380 intersection in Carrizozo. "That is a safety issue in our community," Wilson said.


zozo also asked about the US 54/380 intersection. NMDOT district engineer in Roswell Gary Schubert said they are looking to put flashers on the overpass on the west bound lanes. As for putting a four way stop, Schubert said that would give motorists on US 54 a false sense of security if someone co ing on US 380 does not stop.

Schubert said there are no plans for an alternate route around Carrizozo, as that would be a significant cost.

Sanchez suggested the DOT put in noise bumps to alert motorists to the upcoming intersection. Schubert said they are hesitant to make the roadway rough because of the potential for accidents, but he said they would consider her suggestion.

Bill Hightower who owns land along US 54 suggested that since they expect traffic to increase 100 percent in 20 years that now is the time to address the problem with a three or four lane road all the way through the state.

ter vouchers given out, regardless of the county's arrangement with the society.

Hobbs then again asked about the road department and if it has enough funds for gravel and other needs. Road supervisor Albert Hernandez said the department would be okay until January, then he would see. "If you want more from the road department, you have to have a bigger department. and bigger budget," Hernandez said.

Hobbs said he did not like "mid-course corrections" which "don't strike me as way to do things."

Martinez suggested the road department get funds by imposing a road frontage tax

Hernandez said it would be best done by subdivision for certain type roads, but he would not want it imposed on all county roads.

"Ten cents a foot is no big problem," Martinez said. "It was when we talked about going to \$1 a foot that was the problem."

County attorney Alan Morel said the way the county did road assessment was found to be illegal and the county had to pay back thousands in illegally collected assessments. "This is not intended to be assessed very long, either," Morel said.

Hobbs said it appeared to be a "real booking nightmare.

Wilson said the road assessment should be a process of a special assessment district where the property owners come to the county.
