# County To Negotiate Clinics Management

Before a meeting room packed with individuals in support of the current management at the Carrizozo Health Clinic, Lincoln County Commissioners authorized negotiations with all three medical companies that submitted proposals to operate the county supported

During their meeting Tuesday, September 16, in their chambers in the Lincoln County Courthouse in Carrizozo, county commissioners voted unanimously to negotiate with Presbyterian Medical Services (PMS), La Casa de Buena Salud, and Presbyterian Healthcare Services (PHS) which re-

request for proposals (rfp). At the August meeting, county commissioners tabled the rfp because of concerns that the proposal from the current Carrizozo Health Clinic provider

PHS was rated last. The

PMS proposal rated high-

est with La Casa second. Lincoln County was required to go through the cal providers for the Carrizozo, Corona and Hondo clinics because they receive special clinic mill levy revenues collected from county property owners.

County attorney Alan Morel explained to county commissioners that according to the state procurement laws they could

or they could negotiate with any or all proposals that are deemed responsive. Morel said all proposals received were re-

sponsive.

Morel said the rfp was very complex as the Village of Corona and Hondo Schools own their clinics and the Carrizozo Health Clinic employees have lots of legitimate concerns and

# Phone Harasser Pleads Guilty

A Ruidoso man who was charged with 10 counts of harassment telephone pleaded guilty after he was found competent to stand trail.

According to a press release from the District Attorney's office, on September 8 defendant Darwin Kinzhuma appeared in front of District Judge Karen Parsons for a competency hearing on the harassment charges Kinzhuma was represented by attorney Tim Roce and the state

was represented by assistant District Attorney Shauna Hill.

Judge Karen Parsons entered an order that the defendant was competent after expert testimony from Dr. Marc Caplan and a stipulation of the parties that the defendant is competent for trial or en-

ter a plea. Following the competency determination Kinzhuma plead guilty but mentally ill to the ten counts of use of a telephone to harass occurring between January 1, 2002 to April 8, 2002. Each count

is a fourth degree felony. The charges arose out of repeated phone calls which Kinzhuma made to several women in the Ruidoso area claiming to be their "secret admirer."

Kinzhuma faces maximum sentence of up to 15 years on the charges with the possibility of each count being enhanced by one year due to the defendant's prior felony conviction for a total of 25 years possible.

A sentence hearing will take place in October.

# County Goes With C'zozo for Animal Shelter Services

Despite a last minute lower priced offer from the Humane Society and the news that the society is now taking animals from and giving spay vouchers to county residents, Lincoln County Commissioners voted to go with the Town of Carrizozo for shelter services.

At their meeting Tuesday, September 16, in their chambers in the Lincoln County Courthouse in Carrizozo, county commissioners voted 4-1 to enter into an agreement with the Town of Carrizozo to provide \$12,500 for a year of shelter services and \$10,000 towards construction of a shelter at the new county jail. County comvoted no.

At their August meeting, commissioners county agreed to give the Humane Society final opportunity to propose an acceptable arrangement for sheltering animals picked up in the county. While the Humane Society did not send a proposal prior to the September 16 meeting, society director Keith Atkins and attorney and volunteer John Underwood presented an offer at the meeting.

Atkins said he went back to the Society board after the last county commission meeting and suggested the per animal payment schedule commissioners wanted. He said the board did not acmissioner Leo Martinez cept that proposal and

then sought outside advice from Underwood. Atkins said the board had another session with Underwood and after reviewing is financial situation decided to request the county pay \$30,000 a year for the next two years of shelter services.

That is \$5,000 more than the Society received from the county last year. Originally the Society was asking for \$40,000 a year, an increase of \$15,000 from the previous year.

Also Atkins and Underwood said the Humane Society is again taking animals at the shelter and giving out the spay/neuter vouchers to county residents. Underwood said this service was resumed

# Is It A Recreational Pet Or Livestock

If you own a horse to ride occasionally, don't assume it is a recreational pet. State law requires all livestock, whether used for recreational purposes or not, be reported to the county assessor's office.

State law defines livestock as cattle, goats, sheep, horses, mules, llamas, swine, buffalo, ostriches or emus.

If you own any quantity of these animals, you are required to report ownership of these animals to the Lincoln County Assessor's Office.

The Lincoln County Assessor's Office is requesting all owners of these animals to contact the assessor's office at 505-6482306 to avoid being in violation of state law. Livestock report forms are also online available www.lincolncountynm.net

Apparently some people believe their animals are recreational pets and it is not necessary to report ownership to the county assessor. The definition of livestock per NMAC 2-18-1-7 includes the animals listed and also includes livestock considered as a

Kinzhuma had a prior felony conviction for rape and spent time in prison for that offense.

District Attorney Scot Key stated the newest conviction of the defendant is important for the citizens of Lincoln County because of Kinzhuma's potential to escalate his acting out from mere phone calls to personal contacts to something more. "I am grateful Ruidoso Police Department took this case as seriously as we did," Key commented.

"This is far more to us than a business decision," Hightower said. "It is a life and death matter."

County manager Tom Stewart said a letter was mailed to the mayor of Carrizozo requesting the town have a representative on the evaluation committee and someone was going to attend the evaluation session, but had to cancel at the last. minute. Stewart also said he mailed letters to Hondo School Superintendent and the mayor of Corona who had representatives.

Speakers from Carrizozo included Norm VanGorder who said Gonzales saved his life. He scolded county commissioners for thinking they are leaders, because to him they are public servants and "we the people" are the leaders. "I vote for what we have," he said.

Ruth Hammond of Carrizozo urged county commissioners to reconsider their rating of the proposals and select the one that will provide the best care. She said Carrizozo clinic serves many people county-wide and the county commission's main concern is how to continue the quality care. Hammond said clinic staff should be included in the negotiations. Then she praised Gonzales who was personally responsible for saving the lives of two people special in her life-her business partner Peter Aguilar and her husband Bud Hammond. "Many of us care that Ernie saves lives," Hammond said.

Carrizozo resident and ormer clinic advisory board chair Joan Means asked county commissioners to consider the quality of people working at the clinic. "You are worried for the taxpayers' money," Means said to commissioners. county "I'm worried about the taypayers' health."

County resident and chair of the Democratic Party of Lincoln County Doris Cherry told commissioners to "quit nickel and diming our county's health care system. I encourage you to listen to the public."

Oscuro resident Jerry Carroll also said the rfp evaluation process was flawed and Carrizozo was left out, so he recommended the proposals be re-evaluated so there will be no complaints.

Carrizozo resident Mary Lou Nickels praised Gonzales and Carrizozo clinic staff. "We trust them with our lives, and we trust you with this decision also," she said.

# The European War

Little is new in the European war the past week, except changes in position of the armies and the reported reverse of the German army near Paris. Russia continues her victorious action against Austria, having added an additional victory to those already won over the Austrian troops. The Austrian army is reported to be so badly demoralized that it is considered no longer formidable to the Russian invasion.

The almost continuous success of the German army in the west, operating against, French, Belgian and English troops, has, apparently, run its course. The German army near Paris met with a very serious reverse the 8th, and were compelled to retreat. The German Imperial Guard, which was commanded by the Crown Prince, was the heaviest sufferer among the vast army of the Kaiser. It is said that this splendid division of fighting men was annihilated by the allies. In her near approach to Paris, Germany has performed a wonderful feat of arms, and came very near doing what she set out to do: "The Walls of Paris September 5th, in Paris September 15th"

The indications now, however, are that Germany has shot her bolt as an aggressor, and that her fighting in the future will largely be on the defensive. The allies on the west are being constantly reinforced -- British and Russian troops are pouring into Belgium, and whatever superiority in numbers that was possessed by Germany at first has been overcome.

No additional nations have become involved during the past week, although a declaration by Turkey is expected at any time. If Turkey enters the contest, on the side of Germany, it will mean that other Balkan states not now at war will line up on the side of the allies; and quite likely also Italy. In other words, all Europe seems against Germany, just as it was against France one hundred years ago. There can hardly be a doubt as to the result.



Hobbs then asked Gonzales to speak. Gonzales said he appreciated the community support. He said the clinic is trying its best and would like to continue to keep its profits in the area. "I understand if we have an overage (with PMS) that would go to Santa Fe to bolster their other clinics," Gonzales said. "That is not conducive to us here."

Gonzales said it has been good working with PHS, even though there were some problems when PHS took over the management of the Carrizozo Clinic a number of years ago. He said those have been worked out.

Gonzales said the clinic serves patients from Ruidoso Downs, Ruidoso, Hondo Valley, Lincoln, Capitan, Alamogordo, Socorro, Tatum.

Dr. Goad said for the record Carrizozo Clinic staff is 100 percent behind PHS.

Martinez then asked who was minding the clinic while the providers were at the county commission meeting. Lincoln County Medical Center (LCMC) administrator Jim Gibson said he thought the issue was important enough for staff to be at the meeting that he authorized the clinic be closed for several hours that day. LCMC is managed by PHS and oversees the Carrizozo Clinic operations.

County commissioner Rick Simpson said no one wants to change medical providers.

County Commissioner Maury St.John said she did not want anyone to think the commission does not care about health care and the clinic employees "you love and trust." However she said the county has to adhere to the laws.

Morel said the county legally had to do this process "whether we liked it or not" and has been working on the rfp for three years. He said the management contract would not be awarded that day, rather commissioners would direct negotiations

with the proposers.

After all the pro-

After all the praise, a Capitan resident Anna Gail Grassie said she has paid the clinic mill levy but has not been able to get services from the health clinic. She said when she was looking for a dentist, she called the Carrizozò clinic and was told Dr. Goad was no longer taking patients. So she called Stewart who directed her to Gibson.

Although cautioned to not talk about any elements of the proposals that were subject to negotiations, Martinez asked PMS representatives to speak. Dr. Larry Lyons, chief medical officer for PMS, said PMS operates 24 rural medical and dental clinics around the state. Lyons said he chose to work for PMS and he has not been disappointed.

Gibson then spoke about PHS which he said has a long history in New Mexico. He told of the PHS clinics in Lincoln County as well as the PHS clinics elsewhere in the state. Then Gibson said he "felt a great responsibility and angst because in our naivete we made an assumption that our financial background was self evident."

"We were remiss in making that declaration adequate in the proposal," Gibson said about the PHS proposal. "So I apologize because I led the effort in writing the proposal."

Gibson encouraged county commissioners to look at the financial aspects and the impacts of transitioning the employees to another company. "If you choose PHS to negotiate with, we will rectify the wrongs left out of the original proposal," Gibson added.

Morel then reminded commissioners they could authorize negotiations with all proposers.

"When you say negotiations does that mean award?" Hobbs asked.

"No," Morel said. "You are free to negotiate with one, two or all three."

"You cannot come up

with the highest and best offer without negotiations," Morel added.

Martinez made the motion to open negotiations with all three proposers. All commissioners voted yes.

After the action, Gibson asked if they would push the deadline for the selected provider to take over operations from October 1 to January 1.

Commissioners said they would discuss in closed session who would be included in the evaluation/negotiation committee.



# Raw Land? No Way!!!

Did you know that "raw land" around Carrizozo sells for about \$1,000 an acre? Don't ask us where this "raw land" is because we don't know, but we do know people who are more than willing to pay that much, especially if the "raw land" has highway frontage. And if the "raw land" has any improvements, such as electricity on the property and water lines for imigating the "raw land" it is even better.

It was stated that the golf course is "raw land" and "raw land" sells for about \$1,000 an acre and the town would want about 10 percent extra. Then it was stated the town would take \$2,000 an acre. There was no mention of improvements such as electricity and phone lines on the property, or that the building had restrooms and the other improvements.

Letting anyone convince you that the golf course is "raw land" is similar to being buffaloed into buying the Brooklyn Bridge in downtown Colaroa, which at one time had been a community in Lincoln County. If the Brooklyn Bridge is in Coalora or anywhere else in Lincoln County, please let us know, and if not, forget about it and forget about the golf course in Carrizozo being "raw land" because it is NOT.

Evidently certain people believe they can convince the guilible people the golf course is "raw land" and that the town will sell this "raw land" for \$2,000 an acre. Apparently a prospective buyer from California has been contacted and is in the process of securing the funding to purchase the golf course before town officials change their minds.

There are probably others willing to gamble on this "raw land" and have no qualms about spending \$45,000 for the green rebuilding because they know the golf course is an asset. It is a shame town officials prefer to unload this "raw land" than to bring it back into shape and be utilized by the public. It is a shame town property might be sold quickly.

And if there have been problems with leasing the golf course, wouldn't it be better to work out the problems than to sell the golf course? There have been many problems with the swimming pool through the years. Will it sell next?

Like it or not, town officials should realize their job is to take care of things, not get rid of things they don't want to do. If you have an opinion about this, tell town officials.

Keeping the golf course might mean extra work, but most things worthwhile are the result of hard work. The golf course is not "raw land" and is worth lots of work and effort. Who will benefit?

SANTA FE - Which is better? Should a governor or an elected state Board of Education control our public schools?

The question has been debated since our territorial days and every possible structure imaginable has been tried; Witness the present state board with 10 elected and 5 appointed members to get an idea of the unusual compromises that: have been cobbled together.

Territorial governors were in charge of education. It can be argued that the system worked because it took tremendous efforts by Govs. Edmund G. Ross, a Democrat, and Brandford Prince, a Republican who followed Ross, to establish a system of free public schools for New Mexico. Both expended considerable political capital in a bipartisan effort to wrest education from the Church.

At statehood, voters opted for an elected state superintendent of public instruction, with an advisory Board of Education appointed by the governor. In the 1950s, during the latter days of that system, the 600+ school districts in the state were consolidated down to 90 amidst bitter and sometimes armed confrontations.

In the late 1950s, educators decided they would be better off with an elected state board and an appointed superintendent, who would be a professional and not a politician. Votets approved the constitutional amendment -- as voters do when they are given the opportunity to elect more people.

At that point, school consolidation wasn't quite completed. Districts of under 100 students still existed but they were able to convice the elected board members from their districts to protect

During the period since statehood. the governor still controlled the financial side of education through the appointment of what was first called an educational budget auditor and later a chief of public school finance. The elected board controlled education programs, requirements, licensure and other professional aspects of the schools.

In the 1980s, the education community convinced the Legislature that the system wasn't working well, with program and finance separated.

The elected board, it said, needed to perform both functions because it knew best what each school needed. That's when the current structure was

devised. School finance was taken from: the governor in return for giving him the power to appoint five additional members to the elected board.

Subsequent governors have not been happy with the system, saying it is ridiculous for the governor to have no power over public schools, which are nearly half the state general fund. Gov. Richardson says the most frequently asked question he received on the campaign trail was what he would do about the schools...

Several times during the past 20 years, the Legislature has been asked to abolish the elected state Board of Education and give the governor authority over public schools. Twice lawmakers agreed to put the question on the ballot and both times it failed. The conventional wisdom both times said voters were rejecting an effort to take away their right to elect public officials.

But now Gov. Richardson is

combining that gubernatorial request with a bold plan for financing and improving education, hoping voters will


see that both are needed.

Will it work? Most opposition is being directed at the amendment to dip further into the Permanent School Fund for additional financial support. Except for the Green Party, all individuals and groups opposing that amendment seem to be giving Richardson his reorganization amendment. It appears to definitely be headed for victory.

The education community is somewhat reluctantly supporting the amendment, mainly because it likes the funding amendment so well. But an elected state board works better for

Board members can be lobbied and their deliberations and actions occur in public. Governors are often inaccessible and aren't required to consult with others before taking actions. And some governors aren't particularly supportive of what educators want.

The question is whether voters still feel sufficiently confident in the governor they elected to give him the OK to try it his way.







because of the money raised at the successful Fur Ball" fund raiser and the settlement of a potential lawsuit.

commissioner County Earl Hobbs said the new offer was a step in the right direction, but for him the county had entered into an agreement with the Town of Carrizozo that was "very willingto work with the county during the time when the Humane Society was not."

"So thank you but the county needs to go on its own," Hobbs said...

County resident Jerry Carroll said the county residents are the ones to suffer in the shelter arrangement with Carrizozo. He said the town does not have a good track record in taking care of animals in a humane manner.

Atkins said the counteroffer was made in good faith as an attempt to undo the harm done with the "take it or leave it proposal," He said he sin-cerely requested the county give the Humane Society the job.

County commissioner Rick Simpson said the commissioners have gotten beaten up in the last two to three months on the issue. He said at the time the first request was made the county was cutting its own budget five to 20 percent. "We made the best offer we could to keep the Humane Society at the same level," he added."

Now that the final county budget has been approved there are sufficient reserves for all departments, plus funds above reserves. Simpson said if they increased all the county departments they are talking about hundreds of thousands of dollars in cost.

County commissioner laury St.John then Maury showed several thank you cards from children in the RASCALS after school program supported with a small amount of funding from the county... "We didn't increase the amount we give the RASCALS, yet. we get all these thank you cards," St.John said.

# C'zozo To Get Golf Course Appraised

Town of Carrizozo will have the golf course apsome praised because residents believe it is more valuable than "raw land."

At the Sept. 9 regular council meeting,

town trustees held a public hearing on the sale of the golf course. In response to a question residents learned the town will retain ownership of the lake, ball field and playgrounds if the golf course is sold.

Clark Hust has bonded his mining property in Big Bear Canyon, near Nogal Peak, to H. S. Hanner and James Lee, of White Oaks. Messrs. Hanner and Lee with Mr. Lee's family and D. Smith, were camped near this property, and in prospecting around found some very promising mineral of sulphide nature, and they believe, with development, a good paying gold vein may be opened. Hence the leasing and bonding of the property in question.

Judge Emmett Patton came up from Roswell Saturday and remained until Monday. The judge is register of the land office at Roswell and just took a short leave to see our mountains at first hand for the first time.

Some heavy rains have fallen the past week in the county. This particular section has been almost devoid of moisture, however, which is pleasing to those who are cutting hay.

Lewis England was here this week from his Little Creek home. Mr. England recently returned from Texas, from which section he shipped in a car load of fine cattle.

Resident Barbara Culler asked why the town wants to sell the golf course and is there already a buyer.

The mayor said the town can no longer afford the golf course which he said is getting worse. He said it will cost \$45,000 to rebuild the greens, and now the. town is just keeping the greens green. "It is raw land," the mayor said.

Culler asked if the golf course would remain publie if sold or if the land would be used for housing.

The mayor said those interested in buying the golf course have said they will keep the golf course public with a possibility of adding another nine holes. The mayor said on the edges of the golf course "we may see housing."

When Culler asked how much the golf course is worth, the mayor said it should be priced like raw land, about \$1,000 an acre, with about 10 percent extra. "We would take \$2,000 an acre," he said.

Culler then asked if the town will get the golf course appraised.

The mayor said the town has to get an appraisal.

Another resident asked how much it costs to keep the golf course.

Town maintenance supervisor Jim Payne said it costs about \$1,400 a month just for electricity for the irrigation pumps. On top of that is labor, fertilizer and wear and tear on the equipment which is worn

out. Resident Ray Dean asked if the town will sellthe water rights with the golf course.

The mayor said the irrigation water rights will not be sold.

The mayor said that was the first public hearing on the golf course, "We may have to close the gates and let it go back to cow pasture," the mayor said, "I feel it would be better to put it to bid for someone who will work it and promote it."

The mayor said the idea of those interested in buying the golf course would make it a great asset and will provide more tax dollars to the town. "It will be better than letting it go back to tumbleweeds," he added.

Culler asked why the town doesn't lease the golf course.

The mayor said the town had problems with leases before.

Trustee Eileen Lovelace said in the lease situations before the lease holders wanted the town to pay for everything.

Trustees then discussed if the town would have to

go to bid for an appraisal. Leann Town clerk Weihbrecht said it would not have to do formal bids if the cost was under \$25,000.

An audience member asked if the town has to have approval from the State Department of Finance and Administration (DFA) to sell the golf course.

The mayor said the town does have to go through DFA:

Police chief Angelo Vega said the town will have to do a resolution for the sale which must be forwarded to DFA for approval.

Trustees made no decision about the golf course that night.

Also September 9, trustees tabled the choice of Airport Road at the entrance of the Industrial Park for a new location for the Lincoln County Solid Waste Authority (LCSWA) roll-off container until town LCSWA representative Ray Dean can present the location to LCSWA.

Dean said he and trustees LeeRoy Zamora and Wes Lindsay looked at three potential sites. He said they decided the site that best would serve the town is on Airport Road. Dean said the location is very visible which will help in keeping the site area clean.

Anyone with questions whether such a site being kept clean should look at Capitan which has had the same location for three years, Dean said. He said there is no loose paper or trash at the Capitan site.

Trustee Lindsay said the other sites have the same. problems as the current roll off location, in that they are in areas where they are not seen. "If it is on the street we can see it and monitor it," Lindsay added.

The mayor said he hadno problem with the chosen site if it can be kept clean. He also said the roll off is only for building materials, brush and large items, not for household waste.

Lindsay also said another site had the possibility of trash blowing into the cemetery which is not acceptable. He also said LCSWA has agreed to build the eight foot fence and provide a lock for the roll off site.

Vega suggested LCSWA install a light for security because LCSWA has extra money.

Dean said he will check whether LCSWA will pay for the light and he will advise LCSWA operational

supervisor Debra Ingle about the chosen location.
