LCSWA Wants Action From DA

Lincoln County Solid Waste Authority (LCSWA) wants to see some action from the district attorney toward resolving the criminal charges against a former authority manager.

At their meeting Tuesday, October 28 in their offices in Ruidoso Downs, LCSWA chairman Don Coleman asked LCSWA attorney Angie Schneider if it is possible to get a decision from District Attorney

Scott Key about the Rick Simpson case. "Or should we refer this to the attorney general?" Coleman asked.

Almost two years ago LCSWA sent to DA Key allegations of fraud against former LCSWA manager Rick Simpson (who is also a county commissioner). LCSWA alleged Simpson while serving as LCSWA manager had not properly documented travel and perDA Key, but nothing has been done since, and now the statute of limitations of

two years is approaching. Schneider said she called Key but he did not get back with her before the meeting. She said she thought she had little leverage with Key and she was concerned that a prior agreement between LCSWA and Simpson (for repayment of the per diem and mileage) will preclude the current complaint from



Ski Run Fire Is Not Contained

Fire crews are working to surround a 250 acre fire on the ski run road that was human started late on Mondav

According to New Mexico State Forestry Fire Special-ist Bill Duemling who spoke to *THE NEWS* late Wednesday afternoon, the Ski Run Fire started about 8:17 p.m. Monday night in the switch back areas from mile marker 6 to just above the Oak Grove Campground on the ski run road. The cause of the human started fire is under investigation by the Lincoln County Sheriffs Office, Duemling addcd.

Considered zero percent contained by Wednesday afternoon, Duemling said the fire is burning in a mosaic on a very steep area

along the ski run road which is very narrow and hard for fire equipment to pass. "There is a lot of work to do to contain this fire which is scattered and spotty,' Duemling said.

At one point on Tuesday, fires had crowned into tree tops in an isolated area, but overall most of the fire was on the ground. Duemling added.

Five hand crews and a US Forest Service "short crew" of permanent employees are fighting the fire. Duemling said the Smokey Bear Hot Shots, who are seasonal employees, are not available to help with this fire.

Crews have help from three helicopters and two Single Engine Attack Transport (SEAT) airplanes cur-rently stationed at Sierra Blanca Regional Airport.

No houses or structures have been burned in the fire which is about three fourths of a mile from Oak Grove Duemline ground

Duemling said there are 22 houses in the Eagle Creek summer homes area and 15 in the Villa Madonna area, most of which are used seasonally. He said the full time residents in those areas were voluntarily evacuated Fuesday and the road to the Mon Jeau Lookout tower and ski run road were closed to the public.

Ski run road will remain closed except for residents who live along Eagle Creek and emergency crews. Duemling said none of the residents who live in the lower part of Eagle Creek

"At this point there is minimal risk from the fire to the Ruidoso or Sun Valley areas," Duemling said. "However, we never say there is no risk when talking about wildfire.

As of Wednesday afternoon winds had not been much of a factor in spreading the fire, but the weather service is forecasting winds

Ruidoso Downs Annexation Decision Delayed

When the City of Ruidoso Downs went before the New Mexico Boundary Commission on October 23, city officials hoped they would get the go ahead to annex 591.5974 acres of county land. Their main reason to annex was to hook septic systems on lands in the annexation area onto the regional waste water plant facility which has imposed upon it the strictest phosphorus standard in the nation.

What they got was a seven day delay, given in response to a request from property owners who oppose the annexation.

City of Ruidoso Downs City Clerk Carol Virden told THE NEWS on Wednesday, Oct. 29 that the boundary commission had not yet scheduled a follow up meeting, and may let her know by Friday, when the follow up meeting will be held.

People opposing and supporting the annexation filled the City of Ruidoso Downs meeting room at the fourhour long boundary com-mission hearing held on October 23.

City officials first made their case by presenting information in nine exhibits showing the city's legal processes and how the city has ability to provide water and sewer services to the annexation area and how the regional waste water treatment facility has enough capacity to deal with the additional sewage.

The exhibits and testimony from city officials also showed how the main

reason for the annexation is to reduce the river pollution caused by septic tanks in the

annexation area. Currently the city has a moratorium on hooking sewer systems located in the extraterritorial areas (county lands sur-rounding the city) until the regional waste water treatment facility is upgraded to meet the Environmental Protection Agency (EPA) mandated phosphorus level, which is the most stringent in the US.

City officials reasoned that annexing these proper-ties, most along the Rio Ruidoso east of the city, will allow the properties to hook into the regional sewer plant, and will bring added property taxes and bonding base to the city in order to provide funds to upgrade the sewer plant.

Among those opposing the annexation were valley property owner Ralph Rome of and attorney Bob Beauvais representing other property owners. They asked the boundary commission members to keep the records presented by the city open for a week to allow review and possible rebuttal because some of the information was made available to the public only on the day of the boundary commission meeting.

The City of Ruidoso Downs was represented by city attorney Dan Bryant who questioned city manager John Waters about the city's process of the annexation and other information about water rights, or is acquiring rights, and has enough "wet" water to provide services to the area to be annexed.

The city also showed in exhibits how its gross receipt tax revenues have continued to grow, how the city is able to provide police and fire protection and in the city Infrastructure Capital Investment Plan (ICIP) how

the city plans to expand water and sewer services to the area to be annexed.

By state law, two elements must be met for a municipality to annex land the land to be annexed is contiguous to the municipality and the municipality must be able to provide city services to the area to be annexed.

Bryant said he had met with Ralph Romero who was representing land owners opposing the annexation. He said they discussed the concerns about the avail-ability of "wet" water and the ability of the waste water plant to handle the additional volumes of sewage from the areas to be annexed.

Beauvais said the proposed annexation area was "cherry picking" and "patch-work annexation" that leaves out lower income subdivisions in Palo Verde Slopes while taking in higher valued Agua Fria developments.

Bryant asked Waters about Palo Verde slopes area.

'It would have been nice to include the area, but monetarily the city is unable to do that," Waters answered.

Waters also said several of the property owners in the areas to be annexed have offered to help pay for hooking into the sewer and water services.

Boundary Commissioner Pat Casey said annexing the Palo Verde Slopes area may be a subject of discussion in the future. "But for the present I see you have a very pressing need to assure the quality of water in the Rio Ruidoso," Casey added. Yet to leave out a subdivision that ties back to your ability to remove phospho-rus and leaching I don't understand."

Casey said he understands the function of money and where the city is willing to spend money to provide services. "But when I see big gulfs of land to be excluded I get concerned."

Also during testimony from the city department of public safety chief Robert Logan told how the city has two paid fire department employees and 16 fire department volunteers and 11 police officers who would be able to respond to the areas to be annexed. Logan said already the city responds to fires and police calls in the annexation area.

After the city officials presented their testimony, Boundary Commission vice-chair Carmen Garza told the audience that by law the boundary commission does not have to take public comment or public participation, but as courtesy they would allow publie comments. Garza said she grew up in Ruidoso and has a real interest in the area and what the residents have to say

Those opposing the annexation were first allowed to comment.

Beauvais asked for 30

on it, was ready to do that," Martinez added.

"We are taking care of business," Martinez added. "It's not right nothing has been done. We turned this investigation over to. Key last December."

The LCSWA board once again also discussed the forgiveness of debt by the Village of Capitan and the pay-

ment of landfill closures by the Village of Capitan. The two items have been on the LCSWA meeting agendas for years. Shearer said the Capitan trustees unanimously voted at their October 14 meeting to not forgive the debt or pay the landfill closure because of comments made by Ronnie Montes who was the Capi-

tan construction landfill manager. Montes "had a different spin on who dropped the ball" on the landfill closure, than the comments from former LCSWA manager Joe Lewandowski.

"I recommend we set a mediation or a joint meeting between Capitan and the authority," Shearer said. Schneider said she pre-

Schneider said she preferred to talk with Capitan attorney Marc Prelo and set up a meeting between the two entities instead of going to mediation at this time. But Shearer thought medi-

ation was best to keep both sides out of court.

Martinez said he did have a problem with mediation, but he does not understand the situation. He said he does not intend to attend the Capitan village meeting to learn more, but as he sees the situation all other entities involved with LCSWA had forgiven their debt because it was considered "double taxation."

Capitan wants the forgiveness of the debt to offset the cost of closing its landfill, Martinez added. "We're talking about a debt of \$17,000 more or less with interest."

Martinez then suggested that while he wants Capitan to work with LCSWA, the LCSWA board will be liable for the cost of monitoring the Capitan landfills for 30 years. He said Capitan should forgive the debt to stay with LCSWA and share in the cost of monitoring the landfills.

"Are you suggesting if Capitan does not pay for the landfill closure it should get out?" Shearer asked.

Martinez then said Capitan costs LCSWA a lot of money.

Shearer said Capitan is keeping the two issues of

debt and landfill closure tied partly because the trustees are unsure if they have all accurate information about the landfill.

"I think we should mediate," Shearer said."But when you talk Capitan getting out of the authority, you are opening a door that we thought was closed a year ago."

year ago." "I think Capitan is willing to do what all the other authority entities did, but we want to make sure the landfill closing costs are our obligation and if we dropped the ball on the closure. That is why we have kept the two issues tied."

Carrizozo LCSWA representative Ray Dean suggested the landfill issue be resolved first, then go back and resolve the forgiveness issue.

Schneider said that is the way she is approaching the situation and she feels she is making progress by talking with Prelo. Schneider then asked the board to let her go to mediation with Capitan and not let the issue go any farther.

When discussing who would serve on a mediation board, LCSWA operating supervisor Debra Ingle suggested the New Mexico Environment Department (NMED) solid waste department official be asked to be involved and to bring in all information submitted about the Capitan landfill closure. Martinez asked if Capitan will accept the information from the NMED about the landfill closure.

Shearer answered, "Give me the facts and I'll look at them objectively."

Coleman concluded the discussion, which has become redundant to LCSWA meetings, by instructing the attorney to get with the Capitan attorney about the situation.





As the Lincoln County News nears the century mark of being in existence (1905-2005), we will be randomly publishing articles that have been published in the NEWS from old files. The following article appeared in the "Lincoln County News" -- on May 15, 1959.

Ramblin' Around Lincoln County

(Ed Note: The author of the following article on Lincoln County has asked that his name remain anonymous.)

Some years before his death I had the opportunity and the privilege of visiting with and talking to John Meadows, one of the colorful pioneers of Southeastern New Mexico. John Meadows had been a trusted and valuable deputy sheriff of Lincoln county under George Curry, he had served with great credit to himself and to Curry, who became sheriff of the county at a time when there was little semblance of either law or order.

At the time of my visit with him, John Meadows was living in Tularosa, a small hamlet at that time in Dona Ana county whose early day residents would be anazed today, could they see and know the growth and development which the Army and Air Force installations to the south have brought to all of the Tularosa Basin. A large business building in Tularosa still bears the name "Meadows Building".

The Occasion of his coming to Roswell was an Old Timer's meeting and program which was given for the benefit of the Roswell Museum and which was sponsored by Mrs. Corrine Whitney, Mrs. Amelia Church, Mrs. W.W. Phillips, Mrs. C.D. Bonney, and others and which incidently made a considerable amount of money which was used most judiciously by these pioneer women in furthering the interests of the museum.

John Meadows was the "Old Timer" and was to answer any and all questions put to him concerning the very early days in Lincoln county, when this great county reached from the Rio Grande on the west to the Texas line on the east, and where for a number of years there was probably less law and order than in any like area in the United States.

camp at night, with the camp fire burning, the Dutch oven and the coffee pot on the coals, and the cowboys there resting on their saddles, after a hard ride during the day. John Meadows was the Old Timer providing the answers and Hiram M. Dow and C.D. Bonney were the questioners.

There was a lot of talk back and forth that night about Billy the Kid, Albert J. Fountain, Oliver M. Lee, pat Garrett and others who had made colorful history in the great Southwest. The hall was packed. The large crowd did not want to miss the rare opportunity to hear early and authentic history first hand. Indeed, it was an occasion never to be forgotten.

During the occasion of John Meadow's visit to Roswell, and in a private conversation later, he told me that after Billy the Kid had killed his guards, Bell and Ollinger at Lincoln, Billy came to the Meadows ranch, arriving late at night, and then and there told Meadows all of the circumstances surrounding his escape and the killing of the two deputies who had been left to guard him while Pat Garrett attended to official business on that day in the then booming mining town of White Oaks.

John Meadows said that he warned Billy the Kid that Garrett would surely kill him and advised him to leave the county immediately and go to Mexico. Meadows further said he told Billy that he would give him the best horse that he had.

"I know Pat Garrett," Meadows said he told Billy the Kid, and "unless you get out of the country at once, he is certain to kill you as you are sitting there right now."

On this occasion John Meadows disclosed that Billy said he knew that if he remained in the territory or the United States for that matter, Garrett would kill him, since he had been elected Sheriff of Lincoln county on a law and order platform and was an utterly fearless man.

"I want to make a last visit with my girl at Fort Sumner," John Meadows said Billy told him, and "after this visit you may be sure I will leave the country forever."

History records that Billy the Kid did go to Fort Sumner, and later Pat Garrett, acting on a tip from White Oaks, together with two deputies, John W. Pope and Tip McKinney, went to Fort Sumner and there in a dark room in the house of Pete Maxwell, beat Billy the Kid to the draw.

Property Taxes Are Due Nov. 10

Lincoln County Treasurer Beverly Calaway reported that the 2003 tax bills are in the mail. A total of 28,820 tax bills were delivered to the Carrizozo Post Office on Thursday, Oct. 23, an increase of 604 tax bills from last year.

Tax bills are due on November 10 and become delinquent after December 10. Taxpayers have the option of paying in full or paying half with the second half due on April 10, 2004 and delinquent after May 10, 2004.

State statutes require the county treasurer to mail the bills by November 1 of each year.

The Lincoln County Treasurer bills, collects and distributes taxes for the state, the County of Lincoln, five municipalities in Lincoln County, five school districts in Lincoln County, Lincoln County Medical Center, rural health clinics, Eastern New Mexico Univer-



SANTA FE - The search for Billy's bones has begun. The sheriffs: offices in Lincoln and DeBaca counties have filed a petition asking the Grant County District Court to order exhumation of the body of Catherine Antrim, Billy the Kid's mother.

This exhumation may be easier. than previous efforts to dig up the remains of Billy and other celebrities because this one is being done as part of a reopened investigation of the Kid's death, 122 years ago.

Sherry Tippett, an attorney representing Lincoln and DeBaca county authorities says the normal procedure is to get a permit for exhumation from the state medical investigator's office. But Tippett says she and the sheriffs decided to go to District Court for an order so the process will be open and any complaints can be heard,

And there will be complaints. The mayors of Silver City and Fort Sumner both have announced their opposition to unearthing Billy's mama's bones.

unanimously agreed it was William Bonney, although stories persist that the jury didn't arrive until after the body was buried.

Gov: Richardson says he wants a thorough analysis of what happened. His main interest seems to be the pardon the Goy, Lew Wallace reportedly promised Billy in return for his telling all he knew about the Lincoln County War. Billy apparently upheld his end of the deal but wasn't let off as some others were who testified.

The sheriffs and Gov. Bill Richardson are trying to untagle some of the historical questions surrounding the Kid's death. There have long been stories that Billy may not have been killed that night in Fort Sumner. Sheriff Pat Garrett may have shot someone

The coroner's jury, in its report to the New Mexico attorney general, attested that it viewed the body and

he wants the investigation to be right at all costs and not make any mistakes,

That's not easy 122 years later. But Richardson says he's going to appoint a prosecution and defense to argue the case in Silver City, Las Cruces, Lincoln and Fort Sumner. That obviously has its publicity and tourism value but the governor is. playing with fire. He likes to be in control, but other people, with possibly other motives, also are involved.

Tutoring

Carrizozo has made some improvements on their after school tutoring program. The purpose of the program is to help the elementary students with their homework or basic skills, particularly in reading and math. Students meet on Monday, Wednesday, and Thursday in the elementary computer lab after school, from 3:30 to 4:30 p.m. Students are helped by three teachers - Martha Bond, Margaret Barela (aide), and Anne Serna, as well as seven high school students Nathan New, Sam Ungaro, Brandon Morales, Brent Dixon, Jake Riddle, Francesca Rossi, and Victoria Rossi. It seems to help out a lot. They have been finishing their homework and being able to get on CCC or Math Facts in a Flash. I think we are a real big help for the elementary students. I'm glad that they started this program for them. I think it will work out real nicely!"

to facilitate the physical delivery of groundwater directly into the Pecos River under certain, specified conditions, the purchase and transfer to the wellifield of existing groundwater rights in the Roswell Artesian Basin ("RAB") by the ISC, and the purchase and retirement of irrigated land within PVACD and CID. The Settlement Agreement also defines the conditions under which the land purchased by the ISC in the CID will be allotted and receive water. 1 Satisfaction of Conditions Precedent. The obligations of CID; the United States, PVACD, ISC and the State under the Settlement Agreement, and the force and effect of the Partial Final Decree are contingent upon either the satisfaction or waiver by express agreement of the Conditions Precedent set forth in the Settlement Agreement on or before December 31, 2004, or such later date as the Parties may agree to: The Conditions Precedent include: A. B Initial Purchase of Land: Augmentation Wells. ISC shall acquire at least 4,500 acres of land on the CID assessment rolls that are entitled to the delivery of Project water, and 7,500 acres of irrigation water rights in the RAB. In addition, ISC shall construct; lease of purchase Augmentation Wells sufficient to undertake the augmentation pumping plan outlined in the Settlement Agreement, to a minimum capacity of 15,750 acre-fleet of water per year.

C. Federal Contracts and Environmental Compliance: Bureau of Reclamation, CID, and ISC shall enter or extend contracts to effectuate the purposes of the Settlement Agreement, Bureau of Reclamation shall complete all necessary environmental compliance related to those contracts, including compliance under the National Environmental

Policy Act and the Endangered Species Act. 2 Supplemental Well Pumping. Notwithstanding the FDR limitation of 3,697 acresfeet per acre per year of land within CID set forth in the Partial Final Decree, nothing in the Settlement Agreement shall limit CID's authority pursuant to NMSA 1978 \$73-10-16 to approve transfers of allotiments from the acreage to which the allotment was originally made to other acreage within CID, which may result in total water deliveries to the land to which the transfer is made in excess of an PDR of 3.697 acre-feet per acre per year, provided, that for purposes of determining the diversion limitation for any supplemental well on the land from which the allotment has been moved for stacking

SUMMARY OF PROPOSED PARTIAL FINAL DECREE

A COMPLETE COPY OF THE PARTIAL FINAL DECREE MAY BE REVIEWED AT THE LOCATIONS LISTED ABOVE

The following summarizes the proposed Partial Final Decree submitted to the Court by the United States, CID, the State, and PVACD, addressing the claims of the United States and CID in connection with the Carlsbad Project. The proposed Decree judicially establishes the maximum allowable annual diversion and storage rights of the United States and CID, and CID's right to deliver water for the members of the CID. minutes to make his presentation but used about half questioning the city's information on water rights and ability to expand its services. He especially questioned the city's ability to provide sewer outside their city limits when the Parker Lane area inside the city and next to Rio Ruidoso has septic tanks and is not hooked into the city sewer.

Other opposing property owners, including Smokey Davis who developed the Agua Fria subdivision and sold the city the spring that provides most of the city's water, questioned the in-

crease of property taxes. which Waters said would be a significant increase.


Some business owners in the annexation area were opposed because their gross

receipt taxes will increase. Those who favored the annexation, about half of the group who attended the meeting, included many people who live in the Rocky Mountain Trailer and RV Park on Highway 70. Many of the park residents chose to let park owner Rhonda Vincent speak on their behalf.

Vincent emotionally told how her park will be shut down by the New Mexico Environment Department (NMED) if the park is not allowed to hook into the waste water plant soon. She said she and her husband

bought the park in 1996 with the understanding they could hook into the regional sewer plant. But when they went to the Regional Waste Water Treatment Facility Board (which consists of members from the Village of Ruidoso, City of Ruidoso Downs and County of Lincoln) requesting to hook into the sewer, they were refused. Now the park is having its septic tanks pumped daily, which is be-ing allowed by the NMED as a temporary measure.

"This is about the people. who live here with me," Vincent said. "If we are not allowed to hook onto the sewer these people have to move. They pay property



taxes and own their mobile homes and are low income." If I am not annexed, my

business will be no more, Vincent added. NMED ground pollution

prevention section geologist Kurt Vollbrecht who also attended the meeting confirmed what Vincent said. He also told how the Rio Ruidoso valley is vulnerable to the impacts of septic tank leach fields which are not designed to remove nutrients especially nitrogen.

Other property owners in favor of the annexation were Bonnie Richardson who said the services are essential as police and fire departments are needed immediately and because the adjoining communities are not paying for these services they already receive. Jady VanWinkle who

owns Circle B campground also favored annexation. and said the city's annexation proposal is not "cherry picking as Beauvais claimed. VanWinkle said they asked to be annexed into the city, and also they believed the city-needs to bring in those properties that are illegally hooked. into the sewer system.

Don Coleman, chairman of Lincoln County Solid Waste Authority (LCSWA) favored the annexation which will bring in the property that LCSWA recently purchased east of Ruidoso Downs.

Warren Beaver favored annexation because of ambulance and police services.

Melissa Casehagen, representing the Village of Ruidoso Planning Department, said the village is in favor of the annexation because of the sewer issues. Ruidoso holds the majority vote on the Regional Waste

Water Treatment Facility board because the village creates most of the waste water treated in the facility.

At the end of comments from the audience, Tom Lewicki who owns 12 acres of land on the north side of the river in the area to be annexed, spoke in opposi-tion of the annexation. He said he wanted to be in the county, not in the city.

Beauvais concluded his comments by citing several court cases and other legal information.

At the end of public comments, Garza, said she thought the request to keep the records open for seven days was appropriate: "I believe we need to leave the records open for seven days as requested;" Garza said.

Then we will come back to conclude and render our decision."

Boundary commissioners voted unanimously to continue the boundary commission meeting. Boundary commission was assisted by Assistant Attorney General Alvin Garcia,

Exhibits presented by the City of Ruidoso Downs have been forwarded to the Local Government Division of the Department of Finance and Administration where the records can be obtained, Garza added.

Bryant then said the records presented by the city would be available for viewing at city hall during the seven days.

No date has been set for the next Boundary Commission meeting.


