

# LCSWA Budget Includes Increased Yard Waste Fees by Doris Cherry (includes salaries for supervi-

Lincoln County Solid Waste Authority (LCSWA) board at its regular meeting July 29 adopted a balanced 2004-05 fiscal year budget of \$2.6 million in revenues and expenditures.

The budget shows projected revenues of \$1.862,771 and expenditures of \$1,795,807 in the LCSWA collection system. The figures are based on trash collection rates and the percentage of actual payment of these rates. LCSWA operational supervisor Debra Ingle said the county residential trash collection payments came in at 99.9 percent in fiscal year 2003-2004 which ended June 30.

The 2004-2005 fiscal year budget also has \$22,000 in revenues for administration

Total general operating fund has a beginning cash balance of \$206,544. estimated total revenues of \$1,995,943, cash transfers of \$300,000, budgeted expenditures of \$2,248,527 with an estimated ending cash balance of \$252,960.

In addition to the general operating funds, LCSWA budgeted an estimated \$138,900 in revenues from the New Mexico Severance Tax Bond with the total amount budgeted to be spent.

LCSWA also received environmental gross receipt taxes with a beginning cash balance of \$214,067, estimated revenues of \$489,534 and budgeted expenditures of \$2,622,849. This leaves an estimated ending cash balance of \$422.139

The budget includes a New Mexico Department of Finance and Administration (DFA) required one-twelfth reserve fund of \$187.461 leaving an ending balance of \$234,678 above the required

LCSWA board members questioned why so much was put into the employee overtime. Last fiscal year overtime was budgeted at \$68,153, this fiscal year

overtime is budgeted at \$126,617. Ingle explained that the LCSWA board earlier this year had adopted a policy to limit the amount of compensation time for employees and to pay overtime instead of giving time off. Ingle said before when comp time was allowed to accrue some employees accumulated weeks worth of the comp time, creating scheduling problems when those employees decided to take their comp time.

The budget also includes the increase in the yard waste collection fees to those areas in the county that opted into the grapple program. LCSWA board received no negative comments about the yard waste rate increase, including for vacant lots, when they held a special hearing on the issue in July. The yard waste fee is only charged to into the program,
Ingle said the only un-

known in the 2004-2005 budget is the cost of yard waste pick up for vacant lots because that program is just beginning.



Ingle also reported that the request for proposals (rfp) for the engineer for the new LCSWA facility to be constructed on the new land on Highway 70 has a deadline of August 16, with hopes of awarding the proposal at the August 24 regular LCSWA meeting. Ingle told THE NEWS she hopes to move into the new LCSWA facility by early 2005.

#### Washed Away In A Flood

Herman Schele, traveling salesman for the American Tobacco company, was caught in a flood last Sunday evening, losing samples of his stock and personal belongings, and he would have lost his life had it not been for the fact that he is a strong swimmer.

When about eight miles south of Carrizozo Schele was caught in a rain storm and drove his car under a railroad bridge to adjust chains to the tires. Before he had completed the job a wall of water several feet high struck him, carrying him and his car along. He threw most of his sample cases out of the car, but the torrent carred them away. There was a couple of feet of water in the car and, fearing that it would turn turtle, Schele crawled throught he window and got on top, staying there until the water reached him. He then divested himself of his outer clothing and plunged into the raging current.

His skill as a swimmer served him well and he managed to reach terra firma. Finding the railroad track, he had walked several miles toward town when he was overtaken by a car and given a

When the waters receded the following day the car was located, half buried in mud and silt. It was hauled to the Western garage and found to be little injured. Mr. Schele's personal loss is: \$150, and the company loss is tobaccos and sample cases is about \$300.

#### Watermelons -- Nit!

"Watermelons produced near Carrizozo, N.M., are displacing the Georgia product on the eastern markets, says a market publication. Now to find a Georgia native who will believe it." --El Paso Herald.

To find a native Carrizozoan who would belive it would be still more difficult. Watermelons, however, have been grown here on several places by experimentalists, notably on the McCall and Foreman farms west of town, but not. in commercial quantities. Cool nights and a scarcity of water for irrigating purposes are not favorale for melon culture, and these conditions prevail here.

The country surrounding Carrizozo is fast developing into a rich agricultural section. Cereals and other farm stuff grow here to perfection, and the yield per acre will compare favorable with some of the Mississippi valley states. Apples, pears, plums and other fruits are grown in the mountain valleys.

# Ruidoso Reacts to County Notice to Terminate ETZ

Village of Ruidoso is not happy with the notice from the Lincoln County Commission that the county intends to hold a public hearing to terminate the Ruidoso-Lin-coln County Extraterritorial Zone (ETZ).

At the Ruidoso Village Council meeting on July 27. the mayor, councilors, residents and one member of the county ETZ Commission discussed the implications of the county's intent to termi-nate the ETZ. Many said the ETZ is needed to protect the health, welfare and safety and the "cash cow" of properties in the county areas around Ruidoso and Ruidoso Downs that are growing by leaps and bounds.

Ruidoso planning director Charles Rennick presented councilors with a nine-page summary of the Ruidoso-Lin-coln County Extraterritorial District which was established by agreement between the village and county com-mission on May 11, 1982. An ET zoning authority and commission were established and members appointed. On May 24, 1983 the ETZ Authority adopted a zoning ordinance and zoning map and appointed the Ruidoso Planing and Zoning enforcement officer to administer the ETZ Authority also at that time expressed its support of splitting the expenses of administering the ETZ equally between the village and county Rennick

The decision by the county commissioners at their July 20 meeting to call public hearings to terminate the ETZ came about during discussion on a request from the village of Ruidoso for \$21,000 in funding to help administer the ETZ. "The request for funding was the item on the county commission meeting agenda." Rennick said. He went on to say that the county commissioners went from that request to discussion of terminating the ETZ which in his opinion is. in violation of the Open

Meetings Act.
Frank Higgins, who lives in Alto and for the last two and a half years has served as a county appointed to the ETX Commission, said he may not be on the commission much longer once he spoke his thoughts. He said he supports the ETZ which is needed to control how the area around

Ruidoso develops.

"We don't want to zone
Oscuro. San Patricio or Corona." Higgins said. "It
would be short sighted (of
the county) to kill this (ETZ)

Higgins as well as Rennick admitted the ETZ Code is in need of a re-write and enforcement is a concern. "The ETZ has been lacking." Higgins said. "But under Chay. (Rennick's) guidance it is getting better.

Higgins said the hIZ benefits the village by "getting a grip on the growth" in the county areas around the village which need to be pro-tected or they will be "trash-

"We (Ruldoso and sur-rounding ETZ) are all part of the county and the county needs to recognize that. Higgins added.

Councilor Ray Nunley said he wanted to discuss the county's intent to terminate the ETZ with the county commission, not through the newspapers or letters to the

For most of the discussion about the ETZ councilors were unsure if the county had village about its intent to hold hearing on terminating the ETZ. After several minutes of discussion Ruidoso mayor Leon Eggleston was given the letter sent to the village from the county manager dated July 20 which advised the village that the county commission had denied the request for \$21,000 to help administer the ETZ. and also that the county was giving the village 60 days notice of public hearing to terminate the ETZ

Higgins said the county commission action of July 20 was almost like an "aside" to the discussion on the ETZ funding request. Higgins said in the time he has served on the ETZ Commission only twice did a county commissioner attend a meeting.

Councilor Ron Hardeman commended Higgins for his comments about the ETZ.
"Without an ETZ there is no recourse and someone can do something with his property that everyone objects to along the rights of way to Ruidoso and Ruidoso Downs." Hardeman said. This is cause for alarm."

"This is also another example of Ruidoso going to the county for help with lunding and getting turned down by the county." Hardeman add-

A resident of Ruidoso whose property looks down on the ETZ along Gavilan Canyon Road said she has tried for years to get the ETZ. Commission and Authority to change what she is looking at in the ETZ--porta potties and sheet metal buildings. She said some neighboring properties which also look down on the porta pottles have been for sale for two

"I would hate to think what," it would look like without an ETZ." said property owner

ETZ and hope it continues." Joe Zagone, realtor, said if the ISTZ goes away, the commercial and other zoning in the ETZ will also go away. The camp was denied through the ETZ process.

Lagone said the ETZ has served the people in the zone. by preventing signs and other detrimental things. "I am not always happy with the ETZ. but we need our county commissioner who is supposed to represent Ruidoso to do so. not just her own little part of the county and neighborhood." Zagone added.

Councilor Deborah Byars suggested Ruidoso "broker"



#### A Pile of Rubble

When will the new city hall be built in Carrizozo? We are asked that question many times each week and we don't have an answer. Hopefully the city hall will be built soon, but the project is to be completed in phases. One of the most important phases will be for someone to make certain there is a lightning arrester on the building to help keep the same thing from happening as happened before.

Remember how many state legislators and officials were under the impression the building had burned and there was nothing left but a pile of rubble? And all it was was a lightning strike that burned the fuse box. The same thing could happen to the new building unless there are precautions against damage in the event of lightning.

Every time people have asked us about the situation and if the new building would include safety equipment to help preserve the building, we refer them to city hall. Many people object to town offices having been moved to the Rec Center instead of the electrical problems being corrected in the former city hall building to keep it open.

Controversy about specifications for the building has kept construction on hold. Now that the cement and other debris from the former city hall is being cleared away, the building project, or phase one, may finally get started ...

Knowing what is happening is not always that easy. Little is known about the tower that was to have been built near the railroad that would help improve cell phone service in this area. People who were waiting patiently for better cell phone service have about stopped waiting...

And the wait continues for a new city hall building. The street was closed while the former city hall building was being removed and many people assumed the street would remain closed forever, which is the plan because the new facility will be built in a slightly different area. And maybe someone will realize the location is not 4th Street but is 4th Avenue. Too often the physical address for city hall is given as 4th Street and that is incorrect.

Governmental entities frequently want confirmation of addresses of people. Isn't it reasonable for officials to know the physical address of city hall? And isn't it also reasonable to request town officials to verify if there is to be installed a lightning arrester or some type gadget to help keep this new building from receiving damage to the electrical system and burning the building to the ground?

Except for the fallacy of the previous building having been burned down, and except for the fallacy of electrical damage causing a building to be rendered totally and completely unusable instead of being cleaned, this has been quite a learning experience for residents. And a new city hall building may loom up from the ashes. And it may have instructions as to where the electrical box is.

SANTA FE -- One of the hot new shows on TV glorifies the '90s. That's a good decade to choose because more people remember it than any other. There also is a show about the '70s. but as one of those who can remember a few more decades back, I would choose the '40s as New Mexico's most exciting decade.

The 20th century began as New Mexico was busy becoming a state. Those stories are worth a separate column. The next decade saw us go to war. New Mexico enjoyed the '20s as much as any state did. The '50s were a happy, nostalgic decade. The psychedelic 60s saw a social concern that lasted another decade. The '80s were the Me Generation when we began working on self improvement.

But the decade that stands out for me is the '40s. It began as we came out of the Great Depression of the 30s. A year later we went to war. For New Mexico, World War II began a year earlier than for most of the nation. Our state's National Guard was activated at the beginning of 1941 and sent to Fort Bliss in El Paso for five months of retraining to turn a avairy unit into the 200th Coast Artillery.

In the summer of '41, while the nation watched Joe DiMaggion extend his hitting streak to 56 games, a big chunk of New Mexico's young men were headed to the Philippines, where they were destined to become the most decorated U.S. regiment in World War II. The war had a tremendous impact on our state that extended throughout the rest of the century.

Ranchers, miners, and prospectors were kicked off a huge area of south-central New Mexico to make way for a military bombing range. After the war, captured German V-2 rockets were brought to the range for testing, and a missile program was born that soon may culminate in the nation's first commercial spaceport.

Meanwhile, 250 miles up the Rio Grande, in a remote corner of Santa Fe County, a completely new form of energy was being harnessed to aid the war effort. As New Mexico soldiers were moving into their fourth year of incredible hardships in Japanese prison camps, the world's top physicists exploded an atom bomp at Trinity Site on the same bombing range we spoke of earlier.

The super-secret Manhattan Proiect led to what became two of the

nation's most prestigious government laboratories at Los Alamos and Albuquerque. Those labs, along with supporting government installations and private businesses, caused Albuquerque to explode from a population of 35,000 at the beginning of the decade to almost 100,000 ten years later and over 200,000 in 1960.

Two years after the war ended; the world experienced its first encounters with UFOs. Although reported worldwide, New Mexico quickly became the focal point, when many sightings were reported in the vicinity of Trinity Site, the location of the planet's first nuclear explosion:

The most famous of the UFO incidents occurred north of Roswell in early July of 1947 and resulted in a news release from the Roswell Army Air Force Base announcing that it had captured a flying saucer. A day later it was denied by higher authorities, but the genie was out of the bottle. Forty years later the incident began spawning books, movies, museums and news coverage at a rate that has made it a going business.

In the same vein, we do know that Dr. Robert Goddard really did bring over a decade of rocket testing at Roswell to an end earl in the aus when the Army whisked him off to apply his talents to the war effort.

In the late '40s, in the name of tourism and economic development, governors turned their heads as clandestine casinos sprang up in resort and border areas of the state. The fun ended when Cricket Coogler's body was found in the desert, leading to sensational trils and charges that she was on her way to a border hot spotnear El Paso.

#### Tips to Avoid Lightning **Strikes**

Lightning kills more people each year than tornados or hurricanes. Hundreds more are injured and some suffer long-term debilitating symptoms, including memory loss, attention deficits, sleep disorders, numbness, dizziness, fatigue and depression, according to the National Weather.

The agency recommends people take shelter in an enclosed building, hardtopped vehicle or cave whenever they hear thunder. Lightning can travel sideways for up to 10 miles, and most peoplestruck by lightning are not in the rain.


#### The following tips are recommended:


- \*When trapped in a storm, try to be in the lowest point in the landscape. If above treeline, quickly get below treeline and into a grove of small trees. In an exposed area, crouch down and keep twice as far away from a tree as it is tall.
- Get out of the rain and avoid leaning against vehicles.
- Avoid metal by dropping metal-frame backpacks and staying away from fences.
- \* Stay several yards away from other people rather than huddling in a group.
















Extreme Gardening

by Doris Cherry

#### Harvest time: Enjoying the gifts of your labor

August dog days are now with us, bringing hot mornings and in some areas afternoon showers.

Finally summer rains have brought some needed moisture relief in most parts of the county. There are some exceptions, such as Nogal, 8 Mile Crossing, O-Bar-O Ranch areas where not enough rain has fallen and conditions are bleak. In those areas, old oak trees, black walnuts and cottonwoods are dying from lack of water.

Hopefully for the extreme gardener watering has been eased by the rains. But unless rainfall is significant; more than half an inch in a week. you must still supplement water if your garden soil is dry one inch down. Make sure you have mulch to retain moisture.

Even a little rainfall can produce significant amount

of water in a rain catchment system. If you have gutters on your home, garage, etc. you can have a rain catch-' ment system. Several suppliers, including one in Cloud-croft, have the poly tanks that hold up to thousands of gallons. These tanks can be plumbed with valves that can hook onto a hose for gravity feed watering. Or a small pump can be attached for a high pressure, however it will use up your water faster. It is amazing how quickly 1.000 gallons can be used in the garden. Watering from a tank will teach you how to be more water thrifty.

Rainy cooler days also provide an opportunity to plant a fall crop of lettuce and spinach, and to set out broccoli and cabbage plants for a very late fall harvest. Prepare lettuce/greens beds with moderately rich soil, enriched with well aged manure and compost. Smooth out and sprinkle lettuce/greens seeds. Wa-

ter with fine mist and allow mustards were pulled and the soil to wash up over the seeds, instead of covering the seeds with dry dirt then wa-tering. Give the lettuce/greens bed a shade cloth covering. This will help retain the moisture needed for the seeds to germinate and will shade the seeds and new baby plants from the bright morning sun and heat. Wait until the baby plants are up and about four inches tall before mulching as they will be extremely delicate. Plant out broccoli and cab-

bage seedlings on a cloudy day or in the afternoon. Water unless it is raining and mulch. Give the little plants a paper collar around their main stems just above the ground level. This will keep sow bugs and other chewing insects from munching on the stem and reducing the plant's ability to survive and thrive.

properly composted, the beetles left the bed and migrated only to a nearby hollyhock.

This leads to a short discussion about allowing what might be considered "weeds" in the garden. If these weeds attract a particular nuisance insect, leave the weeds and encourage the insect onto them, not onto your garden produce.

Speaking of weeds, that is another thing that happens when it rains. Seems it only takes a thimble full of rain to make ragweeds, kochilla weeds, goathead weeds and tumbleweeds explode in size. Learn to recognize these weeds when they are small, and as soon as the soil is damp enough to pull do it. Later when those weeds are big the pulling chore is much

Here is an easy recipe for stuffed zucchini: It contains baked tofu which can be substituted with eggs or meat or

left out entirely. Garden Fresh Stuffed Zucchini

-- Large one-foot or longer zucchini fruit cut in half, lengthwise, baked in a 300 degree oven until tender.

Scoop out the seeds and meat down to 1/2 inch thick shell. Chop the pulp, season with salt, fresh ground pepper, pinch of chipotle chili powder. I tsp. dry oregano leaves. Mix the seasoned pulp until mixed well, Add 3 grated carrots, one cup of chopped greens, 1/2 cup crushed dry bread crumbs (you will also need another half cup of crumbs for the topping), four chopped green onions, one half-pound package of basil flavor baked. totu. ( Y ou can also use haltpound cooked sausage. ground beef, pork or shredded chicken instead of tofu.)

Mix seasoned pulp and added ingredients with one egg. Mix well and add a half cup of grated sharp cheddar cheese, half cup grated jack cheese and half cup mozza-rella cheese, mix well again.

### Campfires Okay In Forests and **BLM Lands**

Camplires, chargoal grills, smoking and other forms of open flames are now allowed in the national forests and on lands managed by the Bureau of Land Management within Lincoln County.

Because of recent rainfall fire danger has been reduced from high to moderate allowing officials to lift the camplire and smoking restrictions in the Smokey Bear Ranger District of the Lincoln National Forest and the Mountainair Ranger District of the Cibola National Forest and on BLM lands. Fire restrictions were in place for about 58 days,

Smokey Bear Ranger District includes the Sierra Blanca Mountains near Ruidoso, Capitan Mountains, Indian Divide, Carrizo and Patos Mountains near White Oaks and the licarilla area. Mountainair Ranger District of the Cibola National Forest includes the Gallinas Mountains area near Corona.

Although restrictions are fifted, visitors and residents are reminded to be very careful with campfires, smoking and use of chainsaws.

Camplire safety is a concern for forest and BLM officials year round. Visitors who are camping are urged to build camplires away from overhanging branches, steep slopes, dry grass, pine nee-dles and leaves. Pile extra wood away from the fire.

Never leave a camptire or any open fire unattended. Drown the fire with water. and/or dirt and stir until cool. Do not bury coals which can smolder and re-ignite later. Make sure the campfire is dead out before leaving.

Village of Ruidoso and County of Lincoln have also lifted their restrictions on open fires. Charcoal grills are now allowed in Ruidoso. however open camplires are prohibited in the village.

The former word, "elder," should be used when one refers to members of the same family; thus, "My elder brother left for Europe today," not, "My older brother."

But "older" should be used in referring to

But "older" should be used in referring to members of another family, and in referring to objects. Thus, say, "He is the older of the two brothers," and "This table is older than that chair," not "elder."

The same rule is applied to the words "eldest" and "oldest." One should say, if he had more than one brother, "My eldest brother left for Europe today," not "My oldest brother."
"This chair is the oldest of the three," not the "eldest." "eldest."

When direct comparison is made between two persons use "older," as in the sentence, "My mother is older than my father." But when the comparison is not made directly, use this form: My mother is the elder of my parents.






