Billboard Stays In Carrizozo

A "spectacular" billboard, twice the legal size limit for large signs, will stay up in Carrizozo.

Despite what some described as a conflicting message from the town attorney, Carrizozo trustees at their meeting Tuesday, February 8 unanimously generated a variance

to the existing billboard owned by Quail Outdoor Advertising, located behind Four Winds Restaurant. A contingency to the motion was the existing sign will not be lighted, and it will not serve as a precedence to allow any more signs larger than the maximum size allowed by town ordinance.

Stevens spoke for trustees when resident Barbara Culler asked each one to say why he or she favored the variance. Culler said trustees and Stevens had first told the public that the billboard would not qualify for a variance. Culler was also concerned the variance would set a

Stevens said he advised the trustees during executive session (held prior to regular business to discuss pending litigation) to grant the variance. "Based on errors by town of Carrizozo administration and representations made to Quail Outdoor Advertising it is in the town's

best interest to avoid the cost of litigation necessary to remove the sign." Stevens said.



Fort Stanton Celebrates Sesquicentennial May 7

Fort Stanton will celebrate 150 years of history and service to the nation on May 7.

On May 7, Fort Stanton, Inc. a non-profit historical preservation organization, is sponsoring history and humanities events to commemorate the founding of the Fort in 1855.

The event will be held from 9 a.m. until 5 p.m. and includes presentations by historians; people who lived or worked at Fort Stanton; and tours of the old Fort lead

by archaeologists and architects. Presentation topics will include first-person dramatizations on Apache history, the military years, tuberculosis hospital years, World War II German interament camp years and the state hospital and training school years.

Registration fee will in-

clude lunch, and afternoon high tea with a Fort Stanton birthday cake hosted by "Lydia Lane" (dramatization) who lived at Fort Stanton during its miliary years.

Fort Stanton's history involved the Apache wars, Civil War and the Lincoln County War. Fort Stanton became the nation's first military tuberculosis hospital and the first German internment camp. In its later years it served as the state hospital and training school for developmentally disabled adults.

Some famous personalities associated with Fort Stanton included Kit Carson, Victor-

Friday, February 4, 1955

Request Made to restore Stanton Lands to Indians.

A Joint Memorial, introduced by Sen. Murray E. Morgan, Memorializes the President of the United States of America, the Congress of the United States of America, the Secretary of the Interior and the Secretary of Health, Education and Welfare requesting recognition of the ownership and return of possession to the Mescalero Apache Tribe of the Fort Stanton Reservation.

The text of Memorial No. 6 follows, in part: Whereas, the Mescalero Apache Tribe has from time immemorial held Indian title to the land known as Fort Stanton Reservation, which is in the heartland of the Apache country, and ... whereas the Mescalero Apache Tribe has never surrendered its title to said land, and the Indian title thereto has never been extinguished, and there exists at the present time a pressing need for additional grazing land due tothe substantially increased population of the Tribe, and

Whereas, the economic level of at least half of the Mescalero Apache Tribe is depressed by the lack of this grazing land, "Now, therefore, be it resolved by the Legislature of the State of New Mexico, that the President of the United States of the Congress, the Secretaries of Interior, and Health, Education and Welfare are hereby memorialized earnestlyto recognize the title of the Mescalero Apache Tribe to Fort Stanton Reservation, subject to the proper and just determination of any other claims or rights that may have existed at the time of the withdrawals of such land for public purposes, and to return said land to the Mescalero Apache Tribe without delay, thereby restoring the possession of the land for its own use.

"it is understood that the Mescalero Apache Tribe makes no claim for so much of the land within the Fort Stanton Reservation upon which, the Marine Hospital was erected and such other land used in conjunction with and essential to operate of such hospital which is now being administered by the State of New Mexico".

Ramblin' **Around**

Fort Stanton is again under fire, this time a two-pronged attack from members of our own State Legislature. One measure would deal a death blow, but quick. It is a joint memorial sponsored by Rep. Luis Page (D-Guadalupe) and others that asks the State Welfare Board to get rid of Fort Stanton hospital, which it says is duplicating the services of the state tuberculosis san-

itorium at Socorro. The other proposal, said to be a memorial to Congress, sponsored by Sen. Murray Morgan of Alamogordo, asks that the reservation be turned back to the Indians. Lincoln County strongly protests any change in the status quo at Fort Stanton.

Under the provisions of a bill introduced by State Representatives S.M. (Sally) Ortiz and Herbert D. Bays, restrictions would be placed on applicants for driver's permits and would also broaden the driver training program. The bill would tighten restrictions on those who have had driver's licenses suspended for infractions of the law and those infractions fo the law and those convicted of reckless driving.

Two traffic deaths within a period of a month on the same curve 3 1/2 miles west of Capitan mark this stretch as one of the most dangerous stretches along Highway 380. One driver, a young woman from California, was killed there late in December. Another young woman from Florida was killed last week when the car she was driving left the pavement and overturned several times. In both accidents the cause was laid to "excessive speed - failed to negotiate

Billboard issue divides town

Did you decide yea or nay in favor of the billboard? It seems some people believe that only 10 people object to the billboard while other people say most don't care. And those who object know there are many more than 10 who do not like the billboard but are afraid to say anything. The main thing is that the billboard issue is more about how all the town ordinances are enforced than about the billboard. It is unfair to punish one person for a suspected crime and allow others to flagrantly break town laws.

Instead of selecting which laws to enforce, wouldn't it be better for everyone involved to enforce ALL town laws? Comments made by an elected official at the town council meeting Tuesday night give the impression that certain laws WILL be enforced. What about other laws?

Sometimes people are confused as to what the issue really is and this seems to be one of those times. It has been confusing getting two different answers to the same question, and even more confusing to have explanations given one way one time and another way at a later time. It even sounds confusing to tell what actually happened.

Carrizozo residents have a right to voice their opinions either way. They have a right to ask questions and expect answers, not double talk. Just as it is not fair to select which laws and/or ordinances to enforce, it is also not fair to deem that the majority is in favor of actions taken by elected officials without proof. Secret ballots, such as we have in our election system here in the USA, is one of the very few ways to verify if the majority approves or not.

Of course if you want to believe what a spouter says instead of the facts, you may reach any conclusion you want. If you prefer blatant percentages that float around in the air and are pulled out at random, you may say you have basis for the conclusions you reach. But if you want to know the truth, you will probably ask questions and expect straight answers before making your own decision.



SANTA FE -- Do we have a tax-

cutting governor or what?
Well, he's probably more like'a tax-shifting governor, he's cut here and added there. But perception is what counts, and on that count. Gov. Bill Richardson has done a great job of portraying himself as a tax cutter. The governor never lets an opportunity slip by to call himself a tax-cutting governor.

I has worked well. Those comments have been picked up by conservative national journalists and broadcasters who have given him credit for being a tax cutter, some making a big deal of a Democrat ever doing such a

Some Republican lawmakers are up in arms over Richardson's success. Sen. Rod Adair, on his Web site, provides his computations of Richardson's tax cuts and tax increases and comes up with a \$130 million increase for the governor's first year in office.

Of course, numbers always are subject to interpretation. As the old says goes, "There are three kinds of lies: lies, darn lies and statistics.'

This session, Gov. Richardson is proposing another \$42 million of tax cuts, many of them aimed at helping the state's economic development eff-

Missing in the governor's initial proposal was any help to alleviate the 'pyramiding" of gross receipts taxes on businesses that buy goods or services on which they have to pay those taxes. But since cutting that tax was the top priority of the state Association of Commerce and Industry, Richardson agreed to take a closer

The result is a 15 percent tax reductin on some services that businesses buy, such as legal or accounting. If passed, the hit on the state general fund will be about \$4.5 million.

Many years ago, I was a partici-pant in a New Mexico First town hall meeting on state revenues. Even back then, pyramiding of gross receipts taxes was a major concern. It seems that most other states especially those with sales taxes lwer than New Mexico's has found ways to solve the problem.

White led me to ask what might be the effect on state revenues if we lowered our gross receipts tax to a measly one percent, but taxed everything that is bought or sold. In other words, we would eliminate all exemptions to the tax.

After digging through the ample source materials that New Mexico First provides for their town halls, my work group discovered that the revenue produced would be almost the same as the very complicated system

It sounded like a capital idea to me. It was perfectly simple and probably a lot more fair -- a true flat tax. The idea lost its luster, however, when Rep. Max Coll, a member of the work group, noted that although the concept might be compelling, every industry that currently had an exemption would see to it that the proposal met a quick death.

A possible tax increase considered by Richardson is getting him in some trouble with the state's oil industry.

After the 2003 Legislature, the governor appointed a tax sutdy panel to "reform New Mexico's tax system. Because "fast-forward Bill" gave his blue-ribbon body very little time to accomplish the daunting task, he wasn't happy with many of its recommendations, especially those to increase taxes.

One of the suggested tax increases was to raise the so-called Emergency Oil and Gas School Tax rate on oil from 3.15 percent to 4 percent, which already is the tax rate on natural gas.

Although Richardson didn't like the idea than, it looks better now that he may need a little more revenue for some of his programs and to offset some tax cuts. But it has the oil producers screaming.

Oil Jobbers in Santa Fe currently are screaming about pumps being installed at Sam's Club, a Wal-Mart subsidiary. Gasoline prices in Santa Fe always fall when legislators come to town, for fear there might be another price-fixing investigation. This time, prices may not go back up at session's







Former Students Visit



prudent to go into litigation." During audience comments prior to the vote on the motion biliboard opponent Tona Macken from Nogal Mesa asked trustees to not grant the billboard because it is so much bigger than the town's zoning ordinance allows and because it encourages travelers to drive on through Carrizozo for cheaper gas and better food thus affecting local businesses. She said a variance is an exception to an ordinance, and the town zoning ordinances does not allow a variance solely based on financial hardship.

Asking again for the estimated cost of removing the existing sign in order to comply with the town ordinance of a maximum of 300 square feet (each sign face is about 650 square feet), Culler again did not receive a response. Culler said she agreed it was the town's responsibility for the error that allowed the sign in the first place. However there came a point when the owner of Quail Outdoor Advertising knew there was a problem with his sign but he put it up anyway, thus assuming some of the responsibility, Culler said.

Resident Marie Watkins said the town ordinance states that no variance is allowed when profit is the motive. "This was clearly done for profit." she said. "The town will pay for lawyers and it will get sued. And we will see several conflicts of interest when it is done."

"If you leave the sign up, it will fragment the community, if you make them take it down we will all work to minimize the effect," Wat-kins said. "The sign is not

After Gary Joe Lovelace asked if the state Dept. of Transportation (DOT) had pulled the permit for the billboard. Stevens sai: OT had but then issued a new permit subject to the sign becoming compliant to the town zoning ordinance.

Sign opponent Ray Dean said the DOT in September 2004 had given the sign owner 30 days notice to remove the sign or come into compliance. Dean said he feels the town trustees in 1974 had adopted the limit on sign size to prevent larger outside businesses from competing with Carrizozo businesses. "Your vote for the variance says you approve of businesses going away,

Carrizozo planning and zoning committee chair Mike Gieb read a prepared statement of his own opinions in which he said the issue with the billboard is really about "how we honor our own laws." He told of how the P&Z was told a variance for the billboard was not applicable. He too was concerned a variance would set a precedence for future billboards.

Be a proactive government with courage to admit mistakes," Gieb said. "Honoring the existing law sends a message of equal protection under the law with a high standard of ethics.

Barbara Ward said the existing sign is an eyesore because of the paintball vandalism, which she thought would continue.

Hans Brakob, owner of Quail Advertising present at the meeting, said he is offer-ing a \$2,000 reward to anyone who provides infor-

mation about who did the vandalism or for any future acts of vandalism on the sign, and once they have a conviction his company will file a civil suit for damages. The mayor said the

town has a good police department that knows what "shameful adults" are doing to the sign. "They are going to get caught," the mayor added.

Dean said the vandalism is illegal and what the trustees are doing with the variance is also illegal. This is not a matter if

the sign violates the ordinance," Stevens said. "It does. Rather, due to mistakes made by the town administration, it is more economically viable to grant the variance."

"This is strictly a business decision, contrary to what the legal counsel from Albuquerque or others with legal opinions tonight think," Stevens said. "I do not believe granting the variance violates the ordinance."

Jane Levy, attorney hired by Watkins, said there are three big legal problems with the billboard issue - the letter to the NMDOT approving the sign was a mistake and without authority: comments and approval by a trustee whose hus-band poured the cement for the sign; variance of the ordinance for the sign based on the cost of lawsuits. Levy said Watkins has authorized her to bring the legal problems with the variance to the attention of the courts.

"While no one likes to go to court, if you issue this variance which contravenes the (town) laws of 1974 (when the zoning ordinance was adopted) a lawsuit will be filed." Levy

Culler again asked each trustee their reason for supporting the variance. Trustee David LaFave who made the motion to approve the variance with conditions, said it was based on the advice of the attorney. Trustee Max Saucedo said Stevens' advice was his reason.

But the law is on my side." Watkins said. "The pay offs are on you."

LaFave immediately responded that there were no pay offs. Culler said she did not believe that either.

Trustee Wes Lindsay said he had mixed feelings, but no problems with the sign to begin with. He said he talked with local people who say the same.

Newly appointed trustee Van Shamblin (appointed to fill vacancy created when Eileen Lovelace resigned

after being elected county commissioner) said her decision was because she heard things in executive session she had not heard before and the attorney's advice.

Macken asked if the town had done any mediation with the sign company. The mayor of Carrizozo said there were lots of meetings which finally got down to the sign company agreeing to not light the sign.

Macken said she contacted Brian Parrish, marketing director for the Inn, about the billboard and was told they were unaware of the conflict but their intent was to stay within all codes in their ad-

vertising, Mrs. Brakob said Parrish did not pay to put the sign structure in Carrizozo, just their company.

The mayor said the town plans to revamp the zoning ordinance to "prevent this from happening again."

Watkins said there is no need for a new law when the town will not uphold its current laws.

The mayor said he and trustees have the authority to change ordinances

Stevens then said Watkins seems to be accusing people of being bribed or having received some financial gain in connection with the sign.

When Watkins and Dean both said Stevens had told the town's own P&Z not to base a variance on financial aspects, Stevens said that advice was given prior to his being informed about the acts of the town administration or former members giving consent.

The mayor said the Inn will provide about 2,500 jobs, including for people in Carrizozo, "To believe the sign will take business away from Carrizozo is wrong. the mayor said.

"We only have 10 people here in town who think the billboard is an eyesore," the mayor added.

Stevens finally suggested the billboard opponents get with Brakob to discuss options and possible solution. But Brakob said he would not meet with anyone and he would not remove the advertising for the Inn because that is freedom of speech. He said he talked with town people and businesses surrounding the sign and half the people were not even aware of the controversy and the other half did not care. He also said some businesses said they are having more busi-ness because of the sign.

Brakob said had he known

about the size limit he would have installed a smaller sign. but it would take several thousands of dollars to make the sign smaller now. "I will

not take the sign down at my own expense just be-cause you don't like it," Brakob added.


lage wide yard sale weekend. All members agreed to table further discussion on the flea markets until Phyllis Macaw can make a report.


