With recent completion of the Highway 70 improvement project, Lincoln County Commissioners developed a punch list of additional needs, especially the intersection of Highway 70 with Highway 380 in Hondo.

At the county commission meeting September 20 in Carrizozo, county manager Tom Stewart presented a letter addressed to NM Trans-

portation Sec. Rhonda Fraught. In the letter it thanks the state for the improvements then offers a punch list of other areas in need of im-(1. j. provement.

County commission chair Rick Simpson said the new design of the intersection of Highways 70 and 380 has already led to a series of accidents and needs reconsideration. Along with the intersection, the letter states that there is no west bound turn lane-

entry at mile markers 269.3 and 269.8; no west bound turn lane at mile markers 272.2, 272.9, 276, 279.1, 281.1 and 283; no west bound turn lane and need of erosion control at mile marker 277.5: no east bound turn lane and need of erosion control at mile marker 277.6 and need to continue coating of wire mesh retaining wall from mile marker 279.1 to 279.7. Simpson said the crosion

needs to include some type of diversion for storm water to, the river, which is now dumping into a field.

The letter also states that in general the wire mesh supporting the roadway on the fill side of cuts and fills needs attention because many areas are bulging and in danger of collapse.

County commissioners also considered correspondence. received from the highway



Ruidoso Lodgers Tax To Maximum

Beginning January 1, 2006, lodgers tax on all lodging es-tablishments in Ruidoso will go to 5 percent.

Currently lodgers tax, imposed upon every dollar spent at a lodging establishment (includes motels, hotels, nightly condo and home rent-als and RV parks) is 4.25 percent

Ruidoso village council approved the ordinance that imposed the tax increase after a public hearing at their regular meeting Tuesday, September 27. No one from the public commented on the increase that was considered and recommended by the village lodgers tax committee.

The increase will provide an additional \$160,000 a year for the Lodgers Tax fund, which is primarily used to promote tourism. Under the terms of the ordinance, the \$160,000 will be split with half of it (\$80,000) going to the Ruidoso Convention Center for needed upgrades, \$40,000 (or 25 percent of the increase) to Fly Ruidoso with a minimum five year contract, 12,5 percent (\$20,000) to Ruidoso Village Parks and Recreation Department and 12.5 percent (\$20,000) to the **Ruidoso Regional Arts Coun-**

Councilor Michele Rebstock wanted more percentage to go to the Arts Council be-cause the draft village com-

prehensive plan recommends the village pursue the arts as a way to attract tourism. Kathy Alexander, director of the arts council, said the group needs about \$71,000 a year to conduct art workshops, promote outdoor sculpture, concerts and other arts events, as well as funding the office and her salary. She said in the last two years, while the lodgers tax committee had agreed to fund the arts council up to \$70,000, the amount was re-scinded. "This is too little support," Alexander said. "We are asking for more per-centage to go to the arts council.'

"I don't say it is necessary to fund the arts council, but arts

Hospital Charity Costs Cut Into Building Fund

The rising costs of charity medical care at Lincoln County Medical Center (LCMC) are cutting into the county's mill levy fund enacted to provide money for construction at the county owned hospital in Ruidoso, reported LCMC administrator Jim Gibson to the Lincoln County Commissioners at their meeting September 20 in Carrizozo. He was seeking a county supplemental payment for the Sole Community Provider Program. Gibson explained that for every dollar contributed by the county, the federal program will provide four. This year, LCMC will be allocated \$172,094 to help pay for charity care, however, the county must provide a match of \$44,228 in order to receive the funding.

So far this year, LCMC is taken from the hospital mil \$995,000 over its budget for uncompensated care, and last year LCMC had more than \$2 million in charity care. Gibson said he believes the hospital will reach \$5 million in total uncompensated care by the end of the year. "It is sharply up over the previous years,' Gibson said.

New Mexico is the second worst state in the nation for numbers of uninsured residents. This is partly due to growth of "Mom and Pop" businesses that are uninsured or under insured.

"I don't know many people who are not insured who can afford to pay \$5,000 to \$10,000 for medical care," Gibson continued.

The county has complained about the ever increasing supplemental payment, which is

levy approved to provide funding for construction and other hospital needs. Gibson said a solution to ease these requests is for LCMC lease holder Presbyterian Healthcare Systems to take over operation of the county EMS ambulance service, which would save the county general. fund about \$155,000 a year.

County manager Tom Stewart said the \$44,000 supplemental payment will have to come out of the hospital mil levy fund in which there is \$2.56 million to do the next phase of construction at LCMC. The supplemental payment is in addition to the \$565,208 already budgeted for charity care in 2005, Stewart added, making the

Fire Burns In Jicarilla, Hoecradle **Canyon Set**

The Lincoln National Forest Smokey Bear Ranger District will conduct prescribed fire burns in the Jicarilla and Hoecradle Canyon areas from Septem-ber 27-30 and October 3-8 weather conditions permitting.

A prescribed fire simu-lates the natural cycle of fire in the ecosystem and clears the forest floor of accumulated needles, ground fuels and branches. The benefit of prescribed fire is in the event of a wildland

fire, the intensity of the fire is decreased, reducing the damage and costs. Another benefit will be to increase grass and forbs, providing better forage for various woodland animals.

Residents in the area may see and smell smoke for the duration of the burns.

Mitch Hibbard of PVT said the company would prefer to make a one time payment of \$300 plus \$4 per "rod" (16.5) of space needed for the device which will bring digital subscriber line (DSL) service to the Hondo Valley area.

Hibbard also offered to assist the county with rural addressing in the Hondo area, since the new county rural addressing ordinance requires an address in order for utility companies to install services. He said now people are waiting up to 10 days before they are able to get an address from the county rural addressing person.

Shortly after considering the PVT request, county commissioners approved on a 4-1 vote a request from Stewart to hire three additional temporary employees in the road department who will be assigned to helping rural addresser Connie Stone. Stewart said two of the temporary employees will install road signs and the other will work in the rural addressing office to reduce the backlog which has increased because of the mandatory address requirements of the Rural Addressing Ordinance. County commissioner. Maury St. John voted against the request because she thought some of the work now being put into the rural addressing office should go to another office, such as the mapping. Wages for the temporary employees will be \$9.09 an hour.

Replacing Our Water

RAMBLIN' AROUND

In a statement from Washington several weeks ago, U.S. Sen. Dennis Chavez suggested that the towns most interested in Lake Bonito water organize into a water district and "argue their interests in Lake Bonito." The Senator further expressed the belief that what the Government takes it should also be willing to replace.

The Army, or the Southern Pacific, or Alamogordo, or all of them together, are completing details to take most of Bonito's water to Alamogordo, and as far as Carrizozo is concerned, no effort has been made to replace anything. Carrizozo is expected on the other hand, to expend thousands of dollars in an attempt to find a source of supplemental water supply.

Before limiting our supply of a known source of good water, it would seem that the transferors would first do some exploratory work at their own expense and discover a source of domestic water for Carrizozo. Then they could say in effect to Carrizozo: "We have found good well water. If the quality meets your approval, we'll "develop it and pipe it to your town to exchange for certain of your rights to Lake Bonito water."

Stewart said before the end of the calendar year he will propose a more permanent solution to easing the backlog in the Rural Addressing office.

Jack -- Well, it may have been the carpet she had me on, but it seemed more like a red-hot stove to me! The Southern Pacific would probably be reluctant to do further water exploration work in this area as they tried it unseccessfully in the early days. But the Army might be willing.

The question is what are the rights of Carrizozo and other county towns to Bonitowater. That is a metter for the court to decide.

In the beginning the Southern Pacific diverted the Bonito stream system to furnish water for its boilers and for its employees along the line from Carrizozo northward. There is a question which the SP put firts, the boilers or the employees, but no doubt it was consideration for the latter that prompted the territorial engineer and later the court to permit the diversion of water across the divide.

Now that the diesels have replaced steam boilers the Southern Pacific wants to get rid of the natural water resource they developed, even if it means transferring it to another county. The Lincoln County communities which have been using the water are being given an allotment, but it is not sufficient for summer usage or for future development, and they are expected to find at their own expense supplemental sources of supply. Times have changed in New Mexico in the past five years. Many towns and cities

Times have changed in New Mexico in the past five years. Many towns and cities have had unparalleled growth and development, Alamogordo for one. That town. would not have been interested in Lake Bonito a few years ago. It is possible that Lincoln County may also have considerable growth in the future, and will need all available water.

There are rumors that a uranium processin plant might be built at Capitan. Should this take place, there would immediately be a demand for a source of good water such as that in Lake Bonito.

It is still not too late for Lincoln County communities to get together and "argue their interest in Lake Bonito.





No End In Sight?

There seems to be a battle brewing in Lincoln County about a subdivision that was approved in the late 1960s but was not built. Apparently plans are in progress to not only build the subdivision but also to build another golf course in Lincoln County. One concern is availability of water.

Evidently there was no clause in the approval for the subdivision that specified a time frame for construction. Now more than 40 years later, many things have changed, including whether there will now be enough water to build another golf course. There are more people in the county, there are more homes and businesses than in the 1960s, and there are constant battles over water in the entire state.

Rationale is that a subdivision was probably welcome in the late 1960s, but now some people are asking the county to limit subdivisions. Mainly because of the water issues.

Moratoriums were evidently not in place 40 years ago, but this is an example of the need for a time frame or some sort of moratorium on several situations that could arise in the county. Time frames are usually put in place because they are needed, not because anyone wants to limit growth.

It seems the county should consider what other issues need to be looked at thoroughly. Maybe there is a time bomb of some sort just waiting to crupt. This situation may not be a time bomb, but it should make more people aware of what might possibly happen with other county issues.

Not all portions of the nation are having problems with non-abundance of water. The hurricanes brought in too much water. People in other areas can drill as many wells as they want without a permit. Not so here in New Mexico where rural domestic wells may soon be required to be metered to determine use or possible over-use of water.

Although too many people waste water, others are more conscious and now xeriscape their lawns. Manicured lawns are normal in wet Missouri and Arkansas and Oklahoma but native plants should be used more often here in New Mexico. The problem there is that some people don't like to see yucca and cholia and other cactus in their yards.

The need for conservation of water is as important as the need to conserve fuel, home heating as well as vehicles: Necessary maintenance on vehicles helps improve the fuel consumption, just as insulation and storm windows helps reduce heating costs. Putting plastic over windows is also a great way to reduce heating costs. There are numerous ways to inexpensively reduce heating costs at your home.

Escalating fuel costs will be a problem for everyone this year. It might be time to drag out the long-handles and plan to wear several layers to keep warm this winter. Another way to keep warm is to be near, but not too near, battles over subdivisions. There will probably be plenty of heat when that battle crupts. It may begin almost immediately...



Request for Road Traffic Survey

On August 10, Lincoln County Commissioner Earl Hobbs sent Stewart a letter requesting a traffic survey of High Mesa drive area. In the letter. Hobbs stated that many residents within Alto Village are concerned about the ongoing development of Lincoln Hills, to the east of Alto Village and accessed by High Mesa Drive. Hobbs wrote that most concerns are about the increased traffic on High Mesa Drive and other streets

"Most of this traffic concern revolves around construction vehicles, including heavily loaded trucks, interfacing with increasing personal vehicle and golf cart traffic," Hobbs wrote. In his letter he suggested traffic ' veys be taken on High Mesa just off Highway 48 and the other just east of the Kokopelli town home exit. Stewart advised that he sent a letter requesting such to the State Department of Transportation and received a reply on August 18. In the letter, from the District 2 engineering support manager, it stated the department had already planned to conduct traffic counts in the Sun Valley, Fort Stanton Road area at the Alto Post Office, and that they should be able to add the traffic counts on High Mesa Drive.



Another item on the form. which is notarized, is a statement that the applicant intends to reside in Lincoln County and a statement that the applicant understands that according to state law if the applicant provides any false information the applicant may be charged with a fourth degree felony, punishable by a fine of not more than \$5,000 per violation or imprisonment for not more than 18 months. or both.

The form was requested because of potential problems created when people in a half-way house that relocated from Roswell to Ruidoso Downs began to apply for indigent funds.

County commissioners requested a form that would emphasize that the indigent program is for county residents.

ployment. "I am resigning my position of planning director, effective immediately, based on the creation of working condi-tions that have made it impossible for me to continue in this position and that amount to a constructive discharge,' Rennick wrote.

'At all levels above me, the administration has repeatedly, with malice and without cause, subjected me to harassment, abuse, retaliation, discrimination, humiliation, obstruction and demotion. among other things," the memo continued. "This pattern of abuse has affected my well-being, has undermined my authority in the planning department, and has compromised my ability to ade-quately and fairly serve the

public." "I find that I am not able to continue in this position under these conditions, and am resigning from village employ-


"I am in receipt of your written warning (of Septem-ber 22), which indicates that I failed to call in sick on that date," Rennick wrote.

received notice that the Lincoln County Flood Plain Administration Ordinance had been accepted by FEMA. Ef-, fective August 15, Lincoln County residents now have opportunity to purchase FEMA endorsed flood insurance coverage.

In the letter, FEMA further advised that the flood insurance may be purchased from any insurance agent or broker licensed to do business in the state in which the property to be insured is located.

There is a 30-day waiting period before a newly purchased flood insurance policy takes effect, or for an additional coverage or endorsement that may increase policy limits. The waiting period ends and the policy takes effect at 12:01 a.m. on the 30th calendar day after the insurance policy application date and payment of premium.

There are two exceptions to the 30 day waiting period, the first being when the flood insurance is purchased in connection with a loan and when the insurance is related to a revision or update of a Flood Hazard Boundary Map or Flood Insurance Rate Map. Flood insurance coverage takes effect at 12:01 a.m. the day after coverage is purchased for a structure located in a Special Flood Hazard Area which is an area subject to a one percent annual chance of inundation by flood, as indicated on the flood map.

Coverage limits under the flood insurance is \$35,000 for a single family dwelling with content coverage limit at \$10,000. Renters can also purchase content coverage. For commercial properties, building and contents coverage limits are both \$100,000. Higher limits of coverage will be available at a later time.

Lenders must require borrowers whose properties are located in a designated flood hazard area to purchase flood insurance as a condition of receiving a federally backed mortgage loan in accordance with the Federal Disaster Protection Act of 1973.

do bring quality tourism," Alexander added. "If we don't start an aggressive campaign for the crts, we will lose these tourists to Socorro, Las Cruces and Silver City which are all pursuing their arts aggressively."

sively." Councilor Ray Nunley agreed the village needs to fund the arts council better, but he did not agree with taking more of a percentage away from the convention center. "The money for the convention center will benefit the arts," Nunley said. Councilor Ron Hardeman

Councilor Ron Hardeman asked if any of the revenue from the golf course lease could be used for the arts council. Councilor Deborah Byars said she hoped the golf course lease revenue could go to the Parks and Recreation Department which has been overlooked for years. Councilor Angel Shaw said

Councilor Angel Shaw said according to state statutes on lodgers tax, the funds from lodgers tax can be used to upgrade parks and recreational facilities that will be used to attract tourism. Plans for the lodgers tax funds include purchase and installation of lights at the little league ball fields.

gue ball fields. Byars said she thinks the Arts Council did an excellent job this year, with an outstanding office that is easily accessible, and in its promotion of such events as the Mardi Gras that was well attended despite cold weather and being a first year event.

Byars then made a motion to adopt the ordinance with the tax increase, with a contingency the arts council receive up to \$125,000 in the next two years from the golf course lease revenue, she got no second. "So they (arts council) will leave here without any money?" Byars asked. Mayor Leon Eggleston said the contingency for the golf course revenues going to the arts council should be considered separately from the ordinance for lodgers tax increase. As such he said he would place Byar's request on the agenda of the October 11 regular meeting. With that Nunley made the

motion to adopt the lodgers tax increase ordinance with the percentage stipulations to the convention center, Fly Ruidoso, parks and recreation and arts council. Because the ordinance had been postponed several times it read that it would become effective October 1, reminded village clerk Irma Nava. She said usually when an increase is approved, the village gives lodgers a few months before it is imposed. With that advice councilors added language to the ordi-nance to make the effective date for the 5 percent lodgers tax to begin January 1, 2006. Councilors unanimously approved the ordinance imposing the .75 percent lodgers tax increase.


The Tigers scored twice in the fourth quarter, one by Joe Gallegos on a pass and another by Arthur Salas.


