# Property Taxes Going Up

# **Public Says No To Housing At Fort Stanton**

While the public agrees that a public-private partnership is needed to help preserve historic Fort Stanton, the majority of the public in a series of public hearings held September 26-30 opposed the pro-posal to sell residential units as a way to raise the capital needed to renovate and operate historic Fort Stanton.

At the Fort Stanton Development Commission (FSDC) meeting held Saturday, October 1 at Fort Stanton, about 50 citizens attended. Again, most who spoke were op-posed to the housing concept in the draft master plan devel-oped by the Collaborative, Inc. which was hired by the FSDC. The draft master plan has proposed up to 600 residential units that would be constructed by a private comstate legislature, the FSDC was charged with finding ways to renovate and preserve the historic facility. "We were told by the state they did not want another study," Runnels said. "Rather they wanted a plan of action."

So this year, FSDC ac-cepted the proposal for the Collaborative, Inc. which was given only a short time to develop a concept for raising the estimated \$32 million needed just to renovate 1 restore the historic buildings at the Fort and the \$1.5 million a year needed to operate it in the future.

Runnells apologized if there had been any mis-communication about the proposed plan, because FSDC had not been communicating enough with the public about what it was doing. "We have always had a commitment to the pub-lic," Runnels said about Runnels said about FSDC Because of this, Runnels said, FSDC held the series of public meetings about the proposed concept master plan that seeks to find beneficial uses for Fort Stanton. Runnells said the responses from the public in these meetings showed that the public cares for Fort Stanton but everyone

At the Lincoln County Solid Waste Authority (LCSWA) meeting Tuesday, September 27 in Ruidoso Downs, board members approved the request for proposals (rfp) pre-sented by LCSWA operational supervisor Debra Ingle. As required by the NM Environment Department (NMED), ponds will be constructed to catch rain run off, and a septic system will be constructed to catch any run off from truck washing racks. Ingle said she hopes to award the construction bid by the end of November or early December.

To pay for the construction of the new Greentree transfer station, LCSWA is eligible for a \$2.7 million New Mexico Finance Authority Ioan. A public hearing will be held at the October 25 LCSWA meeting to consider and adopt a resolution calling for an or-dinance that will finalize the loan. In the interim, LCSWA has obtained financing from a private financial institution in order to begin the excavation and preliminary concrete work at the facility site, Ingle said.



Silva said it is not just Lincoln County experiencing the situation. He said Taos and Colfax counties, which have resort areas, are also seeing marked increases in nonresidential property values.

County commissioner Tom Battin asked if the increase in state debt service is driving the marked increase in non-, residential taxes.

Silva said while the state debt service has increased (.218 mills), the increase is mostly due to the state property tax director wanting all counties to come into compliance

"Especially when the assessor is putting taxable value on property at \$100,000 when it sold over \$200,000," Silva added.

Battin said it appears the county was too lenient in evaluating properties com-bined with a sharp escalation in values in the last five years. He asked if the state would allow the county to increase the nonresidential values over time.

"No, it has to be at 85 per-cent," Silva responded. "We



are supposed to increase nonresidential values to market value at all times.

St. John said the county needs to go to the state legislature and get the laws that require 85 percent value

changed. "This will break so many small businesses that are essential to our tourism base," she said. "We need to start a movement to get this statute changed.'

Silva said in the past the county tried to raise the residential property values in small increments. "It was not a pretty sight," he said about when the county was forced to bring the residential values to reflect the market in 1998.

"Let's just do it and get it over," he said about increasing the nonresidential values. Silva said many areas of the county have been under as-

sessed for value. Battin asked how the market values have increased for property. Silva said in Ruidoso market values have been increasing about two percent or more per month depending on the location.

"The highest increase has been in Carrizozo where market values have increased more than four percent per month," Silva said. "That blew us away." Battin said that although

property values increased in Ruídoso it does not mean an increase in income.

County attorney Alan Morel said Silva does not have a lot

# Friday, October 1, 1920 "Say It Ain't So, Joe!"

## EIGHT WHITE SOX INDICTED

Chicago, Ill., Sept. 28 -- seven members of the Chicago White Sox and one former player were indicted today by a Cook county grand jury, charged with conspiracy to commit an illegal act in connection with last year's world series, which they have been accused of "selling" to a coterie of gamblers.

The seven players were immediately suspended by Charles A. Comisky, president of the club, who thereby threw away all chances of winning the American league pennant this year.

The White Sox are only a half gamebehind the league leading Cleveland Indians today.

The "Old Roman," who has spent a lifetime building up his club, notified the accused players in the notice of suspension that, if they were found guilty, he would drive them out of baseball for the rest of their lives, if possible.

The suspended players are Eddie Cicotte, Claude Williams, "Chick" Gandil, "Happy" Felsch, Charles Risberg, (Shoeless) Joe Jack-son, Fred McMullin and "Buck" Weaver. The story Cicotte is said to have told the jury follows in every essential particular that was told at Philadelphia by Maharg last night. "In the first game at Cincinnati I was knocked out of the box," Cicotte told the jury, according to the court official. "I wasn't putting a thing to the ball. You could have read the trade mark on it when I lobbed the ball up to the plate. In the fourth game, played at Chicago, which I also lost, I deliberately intercepted a throw from the outfield to the plate which might have cut off a run. I muffed the ball on purpose. At another time in the game I purposely made a wild throw. All the runs scored against me were due to my own deliberate errors. I did not try to win. Following a conference in attorney Austrain's office, Mrs. Austrian appeared before judge McDonald with Joe Jackson and requested a private conference, saying Jackson had an important statement to make. After a short conference with judge McDonald, Jackson was taken before the grand jury. As he went through the door he turned to newspaper men and said: "I am going to reform." While Jackson was in the grand jury room it was reported at the court building that he and Cicotte would make a detailed statement telling how the 1919 world series games were lost.

of choice to put off raising the tax values now because with the increasing value of properties in the next two years, the tax increases will be even worse. "He is following pro-tocol and has no option to follow the laws.

Silva said his office staff is prepared to hear complaints from the public about the increases in property taxes. St. John said the state legis-

lators need to look at the state law because she feels it is not right. "I am very against this increase," she said. "Even though we have to do as the state statutes require. We need to see what we can do to change this because it is another mandate.

"I take all the blame," Silva acknowledged. "It would have hurt my constituents if I had raised property values in 2001 when I should have."

"This is what I had to do, the problem is it will eliminate a lot of businesses in Ruido-

so," Silva added. When St. John suggested the county go to the special legislative session to complain about the state law, Silva suggested the county instead start talking with other county commissioners and get their support before approaching the legislature. He also suggested the counties get the support of the speaker of the house, who was responsible for the five percent "yield con-trol" on residential property values, to sponsor similar legislation for yield control on nonresidential property val-ues. (Under yield control, val-ues of residential properties cannot increase more than five percent each evaluation cycle.)

Battin said in some situations small business income will not escalate as much as their property values.

Tax rates for 2005 were less than rates in 2004 in almost all school districts and municipalities in the county, except for Hondo, according to a chart provided by county trea-surer Beverly Calaway. Tax rates are listed by mills with one mill equal to \$1 per \$1,000 of taxable value of property. However, because of the increased taxable values of these properties, the actual property taxes which will be mailed in November to property owners, will be in-creased.

The following figures are taken from the official certification of tax rates for tax year 2005:

Ruidoso with a total taxable value of residential properties at \$236,634,311 and total taxable value of nonresidential properties at \$80,310,394. Tax rates for residential properties is 22.813 mills, for nonresidential properties is 27.132

Ruidoso Downs with total taxable value of residential properties at \$18,636,152 and nonresidential properties at \$16,919,489. Tax rates in Ruidoso Downs for residen-tial properties is 22,618 mills and for nonresidential properties 28.330 mills.

Ruidoso School district, but not in the municipality, with total taxable value of residen-tial properties at \$30,571,510 and nonresidential properties at \$12,460,513. Tax rates for residential properties are 18.230 and for nonresidential properties are 22,266.

Carrizozo, with total taxable value of residential properties at \$4,401,418 and for nonresidential properties at \$2,518,213. Tax rates for res-idential properties are 23.570 and for nonresidential properties are 28.654.

Carrizozo School district outside the municipality, with total taxable value of residential properties at \$6.610.784 and for non residential total

taxable value at \$15,960,772. Tax rates for residential prop-erties are 19.995 and for nonresidential properties are 24.403.

Corona, with total taxable value of residential properties at \$667,660 and nonresidential properties at \$1,374,891. Tax rates for residential prop-erties are 21,183 and for nonresidential properties are 25.392.



#### Tax Rates Will Go Though Roof

If you don't know in advance, you might be shocked when you get your property tax bill from the county next month. According to information presented at the special county commission meeting Tuesday when the tax rates were approved, taxes will increase immensely. There is justification for the increase, but the increase in rates could be a hardship for some property owners. Business property will be especially hard hit, according to the new tax rates.

Next month there will probably be a steady stream of phone calls to the court house asking questions about the increase. There will probably be an abundance of visits to the court house also. Hopefully the staff in the assessor's office and the treasurer's office will wear bulletproof yests to protect themselves from unidentified missiles that might be flung their direction. Then again, maybe people will be understanding and start saving now to pay those increases.

Conflicting opinions may be heard about contacting the state legislature asking for relief from the increases. Some are in favor of talking to legislators immediately while others may prefer to wait until the legislative session next January. If anyone has plans to ask a legislator to introduce any type legislation, the request must be sent quite soon.

Rather than wait, it would be a good idea to contact legislators now and ask if they would consider introducing the desired bill. Concepts should be composed as briefly as possible and presented to legislators. Right now is the time to make these contacts and get this bill process started.

Eventually legislators may agree to institute relief for the increased property taxes. It will take time and will be a long process. The main thing is to not get discouraged,

And for now, plan on a shocker when your property tax bill arrives next month. It might be a good idea to sit down before opening your tax bill. Just don't forget that you must pay your property taxes even if you file a protest.

Some of the other counties have similar situations and property owners in those counties will have increased tax rates. Hopefully residents in Lincoln County and these other counties will work together when trying to get relief from these property tax increases from state legislators.

Except for the property tax rates and the end of any plans to build a large housing development around Fort Stanton, the big news here is that this is the last week for Doris Cherry to be reporting for The News. She accepted a position in Santa Fe and this is a happy-sad situation for us. We are glad she has this opportunity even though we will miss her immensely. that will contain the eight roll offs. Also the well work has been completed with the well producing water at 100 to 125 gallons per minute. Ingle said they plan to install a two horsepower pump that will produce only 25 gallons per minutes, the amount of water needed for the facility operations. The sewer plumbing, which will be connected to the City of Ruidoso Downs sewer system, has been completed also, Ingle added. LCSWA has received a grant from NMED to do the engineering study on the proposed tire bail retaining and privacy wall, Ingle said. It will take 200 tire bails (made up of compressed and bailed old tires) to complete the wall. "The state says it wants to use our tire bail wall as a showcase of other entities to use tire bails," Ingle said. "So we will have no engineering fees for the wall, because the state will use the engineering study for the other entities wanting to utilize the tire bails."

SANTA FE - How much will the state Treasurer's Office scandal hurt New Mexico?

Not much, as far as the state's bond rating is concerned, according to major Wall Street rating firms. We've also told that trading in state and local bond issues has been normal.

Wall Street looks well into the future and isn't affected much by short-term factors. They look at the ability of a state to repay its debt and not whether there was a scandal, according to bond rating firms. New Mexico enjoys the second highest bond rating on Wall Street - one of the best of any states.

For the most part, the money that was allegedly extorted came from bond advisers, who reportedly could afford to share up to 75 percent of their payments with state officials and still do quite well. There have been worries, however, that trades are made too often, thereby increasing the number of commissions and fees, and that fees have been too high.

The only other positive anyone has been able to find in this embarrassing mess is that it may lead to some reform of the system. Gov. Bill Richardson says he plans to introduce "a bold anti-corruption package in the next legislative session. Richardson didn't say whether that would be the October 5 special session or the regular session next January. The announcement came two hours after he called a special session for "gas and home heating relief." It likely can be assumed that Richardson doesn't plan to clog up the special session with anti-corruption legislation. But he may be forced to deal with the Treasurer's Office scandal in spades. The public is not pleased with the deal worked out between the governor, attorney general and accused Treasurer Robert Vigil allowing him to "recuse" himself from having anything to do so with the Treasurer's Office while still drawing his \$85,000 salary. Republican lawmakers, and probably some Democrats, want him to. either resign or be impeached. The trouble with impeachment is that the

**Detractors** have called Richardson the nation's most powerful governor. but he has to share executive power with numerous other elected officials. Most voters are not able to name those elected offices or their current incumbents.

Yet the governor usually ends up with the blame for any misdeeds they might commit. So why not have a single executive responsible for all state government? Our federal government has survived over 200 years with the system.

Until recently, New Mexicans have been unwilling to surrender the right to a long ballot, but then we allowed judges a modified appointive system. And now Gov. Richardson has convinced voters to take control of public schools from the elected state **Board of Education.** 

Republican officials have suggested that state treasurer be appointed by a panel of public members. But then there is no one to answer for misdeeds of the person it appoints.

So New Mexico struggles with its tarnished image. Gov. Richardson may have even more trouble attracting new business to the state. And the





According to the report of J.M. Carahan of the Hudson district near Tucumcari, NM, much of the cotton produced in that part of the state will run over half a bale to the acre this year. With cotton selling at \$26 per hundred pounds, it is likely that there will be a greatly increased acreage next year.

Work has been commenced on the new road which will give residents of Grant county, NM, an outlet to the east through Sierra county, the first grading being done on the west side of the Black range. This piece of raod is of more tha tthe usual importance as it is the connecting line in a transcontinental route which has been a matter of agitation for several years. Eastern New Mexico is soon to have another great highway, which will be a cross connecting route with several of the other highways of the state. The new road will connect with the Bankhead highway either at Pecos or Van Horn, TX., and from there will go to El Paso. From that point the highway will go north through Carlsbad, Pearl, Lovington and Tatum, where it will cross the Dixie, Overland, Southern National and Borderland routes and then continue north through Portales and Clovis. The route will eventually go across the Panhandle into Colorado. The new road will not only cross some sixteen of the principal highways of the west, but will also furnish a direct route from all New Mexico points to Colorado.



More exciting yet, on Thursday, was the tickling concept of twin day, i.e., choosing someone to dress identically with, thus appearing to be twins.










<u>PRE-PARADE</u> Elementary students get ready to participate in homecoming parade.

ideas only came up with about \$12 million. Even with pri-vate donations and grants on a national level there would still be a gap in funding, Run-nels continued.

"So we asked how can we close that funding gap?" he said. A possible answer was provided in The Collaborative Inc. draft master plan concept for residential development. "This was just a plan," he added. "No one has voted to proceed with the 600 unit residential development."

Runnells said the public message was clear during the public meetings that funding should not be tied to residential development. Comments from the public included: maximize grants and donations all the way to a national level; assure that historical. cultural, archaeological, geo-logical and environmental assets be protected; any development have minimal impact on the historic core of the Fort: whatever is done must meet preservation goals and standards; further research be done on how much actual. "wet" water is available; a legal opinion be provided on the matter of the state Reversion Clause that

allows the state to take back the facility with only a year's notice; find wealthy donors to contribute seed money and/or matching funds; expand the options by seeking alternative funding sources and professional input: encourage activi-ties that will draw attention to Fort Stanton and its needs; need for critical mass of visitors and citizens to get involved.

Also at the meetings, the public said continuing public input is needed during every step of any development plan. "This is the core commitment of FSDC," Runnells said. "But we dropped the ball when public comment was needed all along." As for promoting activities

at Fort Stanton, Runnells said some ideas are to continue the Fort Stanton Live events into a full time "Fort Stanton Alive" concept. Other options were an institute that focuses. on the geological studies of the newly found Snowy River. Cave in Fort Stanton Cave. A suggestion was to have a "vir-Snow River Cave extual" hibit, since public admittance into the special area will not be allowed.

Included in the list of ideas is to identify specific areas of need and projects; seeking state funding to hire an executive director and part time assistant whose of-fices will be located at Fort Stanton; work on public input on a master plan; identify physical and infrastructure needs for engineering studies; restore and stabilize buildings on a priority basis; more organized fund raising; financial planning and liaison with private individuals and organizations and foundations, local, state, federal and tribal entities, including the Mescalero Apache Tribe.

In prioritizing, the administration building was considered the top priority, to reno-vate to move the Fort Stanton museum into the building, as well as administrative offices for an executive director for FSDC. Also, the public wanted the stables to be renovated so they could be used (for a fee) for the current equestrian activities on the surrounding Bureau of Land Management properties.

During the Saturday meet-ing, FSDC member Lynda Sanchez told of the reacti-vated Boots and Saddles group which is seeking to connect seven old forts around New Mexico. The original concept was presented by Con. Joe Skeen, but the idea was not pursued. She said the Boots and Saddles group could be utilized to help with funding for Fort Stanton.

Also mentioned was the need to construct a secure and environmentally sound area at Fort Stanton to display prehistoric artifacts taken out of Feather Cave, which is lo-cated just north of Highway 380 on BLM lands in the Lincoln Historic Zone. The unique artifacts were excavated years ago and were taken to Santa Fe and ENMU in Portae una return some of these artifacts to Lincoln County, with them to be housed in Lincoln at first. After the presentations by FSDC members, the public was given another opportunity to comment. Wayne Wilkinson, with the Hubbard Museum in Ruidoso Downs, asked if there are any long term goals identified in the proposed master plan. He said during the public meetings a narrow gauge railroad was mentioned. Runnells said any of these ideas will be incorporated in the Master Plan phase if they are appropriate historically and culturally. He said a lot of activities suggested at

the meetings are not revenue producing, such as museums which rarely make money, or institutions which may or may not make money. Sanchez said Governor Bill

Richardson's director of policy and issues Bill Hume attended two of the public meetings and talked with many of the public who attended. She said Hume has volunteered to look into some of the state issues.

Sanchez said she hoped Hume's visit would be an op-

portunity for those in Santa Fe to realize more money is needed to give Fort Stanton a "hand up". "Then we can con-tinue with help from the county commission in form of a mil levy or other funding,'

Sanchez said she believes in the need to incorporate BLM as a partner and to put pressure on Congress and local state representatives. FSDC member Tony Hoff-

man said there is need to get the state legislature to desig-nate a "Fort Stanton Heritage Area" because there is no widespread support to turn the Fort over to the federal povernment as a national monument.

Before adjournment, Sanchez encouraged everyone to continue to write and mail or email letters to the governor's office and to the state and federal legislative representatives and senators supporting funding for Fort Stanton.

The next FSDC meeting will be at 10 a.m. Saturday, October 22 at the Fort Stanton maintenance supervisor's office. The public is invited to attend all FSDC meetings.






The Tularosa and Sothwestern Oil Company are reported to be hard at work with good expectations.
