

# County Commissioners Just Say No to Drug Card

A resolution to approve membership in the National Association of Counties (NACo) prescription drug card program was recently voted down in a four-to-one decision by Lincoln County Commissioners.

The drug card plan, provided by AdvancePCS Health, L.P., would offer a card to all adult citizens of the

county, free of charge and regardless of age or income. The card could be used to purchase prescription drugs at a discount from member pharmacies.

Just a week before the county commissioners' regular meeting of October 18, approval of the resolution seemed likely. In a memorandum by county manager Tom Stewart dated October 11, he recommended commissioners

approve the resolution and adopt the program.

Stewart's memo referred commissioners to a July 30, 2005 article published in the Washington Post (staff writer Sandhya Somashekhar) and provided to Stewart by a NACo marketing director, that spoke quite favorably of the program.

Somashekhar wrote that in 2004, the program's pilot year, 17 counties nationwide

signed on. One county distributed 200,000 of the free prescription drug cards, resulting in a savings of \$500,000 to its cardholders, the article states.

During discussion to approve the resolution at the October 18 county commissioners meeting, county attorney Alan Morel addressed some issues in the AdvancePCS contract that caused him concern. "We were going to enter into a

contract where the public was going to draw the benefit, but they couldn't see the contract under which we actually agreed to provide the service," Morel told commissioners. "They did make some changes (to the contract) at our request," he said, "but I don't

know that it goes far enough." The contract states, according to Morel, that disclosure of manufacturers fees and other fees and payments are confidential and proprietary information. "Most of the information in this contract is

## County Considers New Prescription for EMS

A new lease agreement between Lincoln County and Presbyterian Healthcare Systems (PHS) could include the fiscal and operational management of the county's Emergency Medical Services (EMS). Speaking before the Lincoln County Commission at their regular meeting on October 18, Lincoln County Medical Center (LCMC) administrator Jim Gibson addressed the proposed changes.

The EMS ambulance service is currently managed through the LCMC at no charge to the county, Gibson said. Funding for EMS comes from the county's general fund, and will cost taxpayers an estimated \$155,000 this fiscal year.

Gibson recently suggested, at the county commissioners meeting of September 20 that a Presbyterian take-over of the EMS operations could ease LCMC requests for supplemental funding from the county, which comes out of the hospital mill levy. The move would also free-up the annual \$150,000 or so withdrawn from the general fund.

County commissioner Earl Hobbs acknowledged that there may be an advantage in having a single operator and a single contract, but added, "it's a little premature to sit down and start writing language. It would be foolish to enter into a contract without looking at other options."

Hobbs also questioned fellow county commissioner Tom Battin regarding his personal association with PHS, stating his belief that Battin was on the PHS Board of Directors in Albuquerque.

"About three years ago I was on that board," Battin said, "but I have not been since."

Hobbs asked Gibson for a brief accounting of the hospital's cash reserve account.

"That is a central bank account and all of Presbyterian's money goes into there," Gibson answered. "There is an accounting vehicle that shows

how much of our cash is in there and how it is invested." Gibson told county commissioners that LCMC began the year with about \$5 million in reserve, and has nearly \$6 million in the account at this time.

The addition of EMS operations control would represent

a significant change to the existing agreement, in which the county leases LCMC facilities to PHS for one dollar per year.

The new agreement, according to Gibson, would fall within the guise of New Mex-

## PLURAAC Plans Action for November Meeting

The Public Land Use and Rural Affairs Advisory Committee of Lincoln County (PLURAAC) received the resignation of its secretary Doris Cherry effective October 4. Cherry has accepted employment in Santa Fe and will be unable to continue her service to the committee.

It is reported in the PLURAAC minutes of the October 4 meeting that chair Sally Canning has also resigned, effective immediately,

though PLURAAC is awaiting official word from Canning.

PLURAAC member Duane Frost was elected by unanimous vote to fill the chair vacancy. Alternate member Robert Moeller was appointed to perform the duties of secretary until further notice.

In the meeting of October 4, a motion directing all PLURAAC members to prepare to discuss specific recommendations, revisions and

## Dumping Exemptions Sought by Ranchers

Some residents of Lincoln County who own 300 acres or more of land have raised questions regarding the Lincoln County Ordinance which requires the mandatory collection and disposal of garbage through the collection system operated by the Lincoln County Solid Waste Authority (LCSWA).

In the minutes of the October 4th meeting of the Public Land Use and Rural Affairs Advisory Committee (PLURAAC), acting secretary Robert Moeller reported that

committee members have received several questions and complaints regarding previous exemptions from the ordinance.

Stirling Spencer, the owner of a ranch near Carrizozo, has complained of what he views as cumbersome compliance procedures, and believes that those who were awarded exemptions from participation in LCSWA collection services in 1992 should be allowed to remain exempt.

New Mexico's Solid Waste Management Regulations allow for on-site disposal of domestic waste in cases where

there is verifiable evidence that disposal through a permitted solid waste facility is not feasible. Section 108-B of those state regulations includes a two-page form that landowners must fill out to demonstrate the need for an exemption.

In a letter to Spencer from the county's attorney, Alan Morel, Morel states that the New Mexico Solid Waste Bureau is proposing to do away with any disposal of solid waste except through an approved facility.

considered confidential intellectual property, and it says we can't disclose it except for when we're required by law to disclose it," Morel said.

Apparently, the contract requires the county to notify AdvancePCS of any requests for information regarding the contract, and to wait for a reply from the company before disclosing any information. "I've got three days to respond to freedom of information requests," Morel explained, "and I'm going to be violating the law 'cause there's

no way I'm going to be telling them that there's been a request and getting approval to disclose the information within this three day period. I mean, it's just not going to happen."

In response to a question from county commissioner Maury St. John about how he perceived that to be a problem, Morel tried to explain that he was being asked to enter into a contract to provide a service to the public, "but I can't tell them what the benefit is."

"Well, you're not going to be able to," St. John told Morel, "because when they go to the pharmacy and they give them that card and they plug it into their computer, then the computer's going to tell them, you know, how much of a discount they're going to get."

"The nondisclosure of information is what causes me the most concern," Morel reiterated. "The exhibits that are attached to the contract are blank 'cause they say it's proprietary information. They're not going to give it to us, so I can't really tell anyone what benefit they're getting by getting the card. I think they've disclosed to Mr. Stewart what it is approximately, 20 percent discount or something to that effect, but it's not in the contract."

"Well, nobody knows," St. John argued. "They're going to get a discount on it. And they also say that somebody like me, that has a drug rider with my insurance, can go to the pharmacy, and I can hand them both cards and see which one gives the most off."

"This discount card is not limited to those without insurance," St. John added. "It's everybody. That's what I liked about it."

In continuing to address his concerns, Morel read another section of the contract that would have the county agree to hold AdvancePCS harmless for any damages incurred by the company as result of any action by any third party. After reading the section aloud, Morel said, "now, I'm

not real sure what that means."

Lincoln County Assessor Rick Silva told county commissioners that the pharmaceutical companies presented this plan to NACO three or four years ago. "They were losing money in the north and in the south because people were going across the border to purchase prescription drugs. It was to keep the money inside the United States," Silva said.

"So this AdvancePCS, is that a consortium of drug manufacturers?" county commissioner Tom Battin asked. "Yes," Silva answered.

Jerry Carroll, private citizen from Oscura, told county commissioners that, although he'd like to have a discount prescription drug card, he thought the contract presented a potential liability that the county could not afford. Carroll went on to remind commissioners that violations of the Freedom of Information Act can carry fines of \$100 per day, and they could count on getting at least one request for information.

County commission chair Rick Simpson mentioned that if a used-car salesman couldn't offer more information than the AdvancePCS contract offered, he'd have to walk away.

St. John disagreed, referring to the Washington Post article. "We are not stepping off into unknown territory; other counties throughout the United States have done this. That's what this article is," she said, "to begin with, it's talking about the card and how many people have been helped and how much money they've saved."

Another comment described the contract as a riddle inside of a conundrum inside of a sealed sack.

In a motion to reject Resolution 2005-18 and not enter into a contract with AdvancePCS, St. John cast the only dissenting vote.

Throughout the meeting, no mention was made of a recent agreement by AdvancePCS to pay \$137.5 million to resolve federal allegations of kickbacks. The company was charged with receiving kickbacks from pharmaceutical manufacturers in return for the preferred treatment of drugs in contracts with health care providers. Similar allegations have been raised in 10 states.

Spencer, speaking to the county commissioners at their meeting October 18, stated that he had received letters from LCSWA ordering him to comply with the regulations by completing and returning the necessary forms to prove a need for an exemption.

Spencer indicated his belief that those exempted from the regulation should be "grandfathered in" and remain exempt.

"I'm tired of being asked to comply," he told county commissioners, "and I don't think the LCSWA should be telling me what to do."

Joe Lewandowski, a solid waste expert and senior consultant for Operational Consultants, stated his belief that the LCSWA has no power in the matter, that the state can permit dumping and ranchers should deal with the state directly.

Morel reminded county commissioners that the state will soon make it illegal to dispose of any waste on private land.

## With the Men In Service

Col. Maurice Lemon and family left last Monday for Randolph Field, Texas where he is to be stationed.

Lt. Col. T.A. Spencer, Jr., arrived home Sunday for a much needed rest, he is a Senior pilot and group operations officer. he has many decorations, including the distinguished flying cross, air medal and seven bronze oak leaf clusters.

Sgt. Albert Roberts of Kirtland Field, Albuquerque spent the past weekend here visiting his wife and mother and other members of the family.

Petty Officer Otto E. Prehm who has been in a hospital at Pearl Harbor for some time has been honorably discharged from the See Bees and is at home.

Coast Guardsman James T. Thompson, ship's cook first class, Fort Stanton, has returned to the states after having served more than 16 months aboard a Coast Guard-manned LST in the Pacific.

Veteran of the invasions of Cape Gloucester Sidor, the Admiralties, Hollandia, Aitape, Wake, Biak, Noemfoor and Sanspor: Thompson won commendation from General MacArthur for the storming of Biak and Wakde, and award from Admiral Barbey for action at Cape Gloucester. Thompson will spend his leave with his wife Flossye and 9 years old son James.

A U.S. Army Reconditioning Center, England -- In what condition does a hospitalized soldier return to duty? Is he in good physical shape? Is his state of mind healthy? The Army says yes.

Men released from hospitals, after battle wounds have healed, are now sent directly to United States Army Reconditioning Centers. These centers, modeled after British types have the job of rebuilding the soldier into the fine fighting man he is, the man that cracked into France, and is going back to finish the job.

But to finish the job, he must be in shape mentally and physically. This is accomplished through close coordination between the medical department and line officers who, too, have suffered combat injuries.

Here is what is happening daily at the reconditioning center in England. The soldier arrives after a stay at a general hospital. He is immediately assigned to a company commanded by a line officer who is responsible for his observance of military discipline. The next day he is given a complete medical examination and is graded according to his physical condition. He is then ready to start on the road back.

Each day his time is fully occupied. His physical training is under the direct supervision of graduates of the Army Physical Training School.

Calisthenics, games and remedial exercises are given with regard to his ability to perform them. Training films, lectures and demonstrations help to recall his military training. At the end of the week after a test march, he is ready for another medical examination. If the examination and the reports of his instructors so dictate, he is put in a higher grade where physical training is stiffer, the schooling more intense.

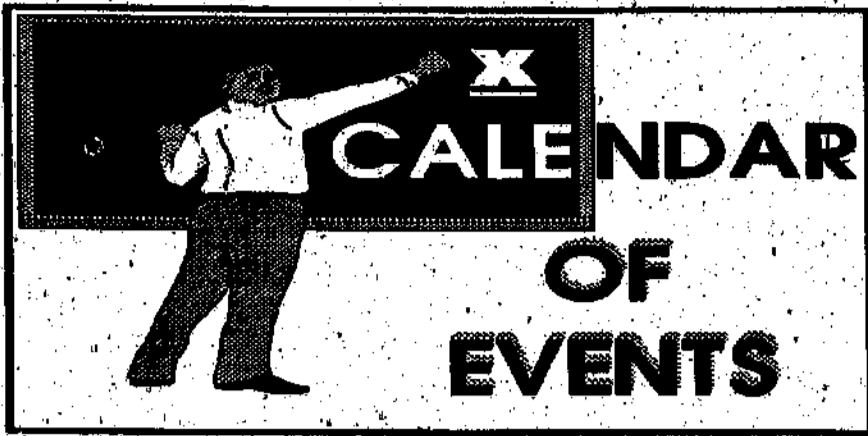

# Jeopardized Resources Spark Growth Management Plan

Growing demands on resources and a history of disinterest in planning have prompted the county to seek a Community Development Block Grant (CDBG) to fund a growth management plan. The grant application approved by Lincoln County Commissioners on October 18th paints a bleak picture of the condition of the county.

The application cites a near 60 percent increase in population in 10 years, from 12,219 in 1990 to 19,411 in 2000, and addresses the increased demand for second and retirement homes. "The demands for subdivisions on precious little land and water are becoming insurmountable," it says, and "without a logical plan for handling this explosive resort type development our natural resources appear to be in jeopardy."

The grant application also looks to the county's infrastructure which "is constructed in response to development rather than prior to development. In many cases it is undersized and creates health and safety issues with respect to roads and water access." Also referred to is the need for additional fire stations, fire hydrants and emergency vehicle accesses.

The application describes the county as "relatively inactive" when it comes to economic development

and suggests that, under a comprehensive plan, economic and demographic data will be compiled and analyzed for a potential economic development plan.

In identifying other substantial problems or needs, the absence of a water plan that impacts subdivision regulations was listed, and the need for affordable housing was described as "extreme."

The application requests a grant of \$50,000 from the New Mexico CDBG Program and promises \$10,000 in matching funds from the county. In open discussion at the October 18th meeting, county commissioner Earl Hobbs wanted to know how the money would be spent. County attorney Alan Morel told Hobbs that the county would issue a request for proposals (RFP) to hold meetings and solicit community input.

According to the language of the application, public involvement will be important throughout the process. Regular meetings will be held and active community members will be asked to serve on an advisory committee. During the first six months, a community task force or steering committee will gather and record public opinion, then report its findings to a hired consultant who will draft a preliminary growth management plan.

Hobbs expressed his be-

lief that the county should use its own resources. In a reference to the county's Public Land Use and Rural Affairs Advisory Committee (PLURAAC), Hobbs said "I'd like to see them get some of this money so they could do their jobs." He added, "I assume that the steering committee will be PLURAAC."

In an October 11th memorandum to county commissioners, county manager Tom Stewart wrote, "We look for an award in the December 2005 time frame at which time an RFP for a consultant will be prepared to assist with the effort."

A motion to approve the grant application passed by unanimous vote.

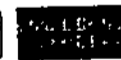

updates to the County Land Use Plan at their November meeting passed unanimously. The motion dictates that review and discussion of the plan be the only item on the agenda for November. PLURAAC members were also asked to consider whether the County Land Use Plan should become a county ordinance or remain a resolution, and whether or not an outside expert or subcommittee of interested parties be called upon to review PLURAAC's recommendations.

According to the PLURAAC minutes, committee member Ken Nosker stated his belief that a review of PLURAAC's recommendations by a "subcommittee of interested parties" is not needed, that PLURAAC's existing members and alternates are fully capable of doing the job. Nosker added that he would ask fellow members of the County Water Conservation and Resource Committee to make recommendations regarding water resources and

the Lincoln County Water Plan.

County commissioner Earl Hobbs was present at the PLURAAC meeting. What is needed, Hobbs reportedly said, is a comprehensive plan which employs various land use management tools, such as zoning, to protect the private property of county citizens. Hobbs' opinion, as reported in the minutes, is that the land use plan should be an ordinance so that the county has power to regulate it.

Another visitor to the meeting, Stirling Spencer who lives near Carrizozo, told the committee that the main issue is rapid population growth and inadequately controlled development. Spencer agreed that the Land Use Plan should have the power of an ordinance.

The meeting adjourned with members in agreement that the November meeting should produce some real recommendations and suggestions regarding the Lincoln County Land Use Plan.

**Daylight Savings Time Ends**

For those of you who might not know it, this weekend is when daylight savings time ends for the year. It never made much sense to take an hour off one end of the day and put it on the other end of the day. After all, time is time and the most important thing is to use your time efficiently.

April this year was when you lost that hour and now at long last, on Sunday, October 30 is when you get that hour back. Most people set their clocks back on Saturday night before going to bed, but you can change clocks on Sunday.

Considering that non-digital time pieces, such as sun dials and wind-up non-electric clocks, do not operate on the same frequency as digitalization, adjusting them is easy and instantaneous. Not so with internal clocks. Adjusting internal clocks takes longer than that one hour lost in April and regained in October. There is no apparent way to get internal clocks back in synch except to wait. And then just as the internal clock is settled, there is another time change.

Keeping track of which way to change clocks had been a problem for some people until "Spring Forward, Fall Back" became the catchphrase for daylight savings time. But some people aren't as good at springing and others are no in favor of falling. But, daylight savings time will be with us for another few days. Don't forget to change clocks this weekend or you will be an hour early for whatever. And maybe your internal clock can make the adjustment.

ico Hous. Bill 322, therefore the county would not be required to issue a request for proposals (rfp). The agreement would require that a lease amount be based on fair market value of all properties, goods and services included.

"We have engaged an appraisal. I've shared that appraisal with the county manager, and that would be a starting vehicle for us to look at what the fair market value of that would be," Gibson said.

Rick Silva, county assessor, asked that his office be provided an opportunity to review the appraisal.

A motion to move forward in the creation of a new contract with PHS that would combine county hospital, clinic and ambulance services, and replace the current contract with a fair market value lease was approved 4 to 1 with Hobbs voting against.

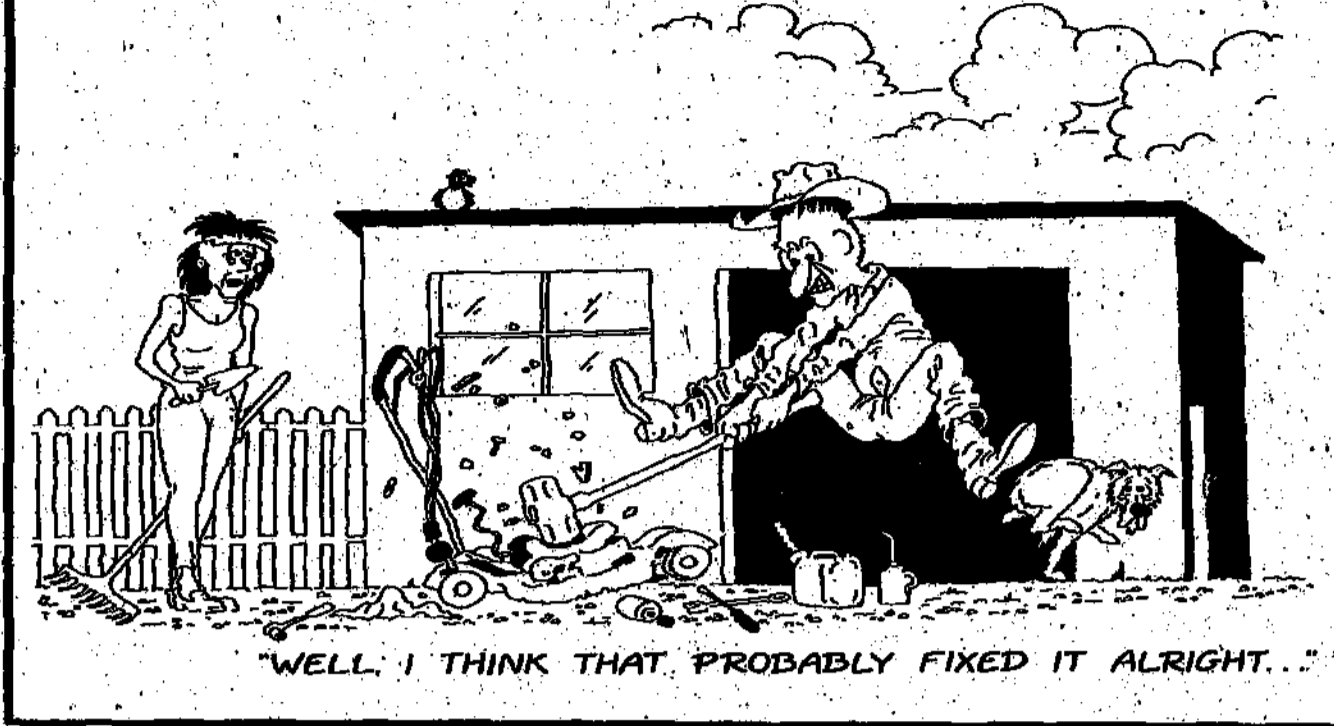
Also approved was a request from Jim Stover, director of Lincoln County EMS, to apply for funding to purchase a type 1 four-wheel-drive ambulance for Capitan EMS.

Stover will apply for a grant of \$62,750 through the EMS Funds Act Vehicle Purchase Program, which requires the grant recipient to contribute 25 percent of the total vehicle cost. With an expected cost of \$90,000 for the new ambulance, the portion to be funded by Lincoln County amounts to about \$22,500.

Stover hopes to replace a 1997 type 1 ambulance that shows 230,000 miles on the odometer and is the Capitan station's only ambulance equipped with four-wheel-drive.

**Inside the Capitol**

SANTA FE

**ALAMOGORDO** - While traveling this area of southern New Mexico for X Prize events, I've had an opportunity to see Otero Mesa again for at least the hundredth time. And still for the life of me, I can't see the pristine landscape that causes environmentalists and their political allies to oppose drilling in the area.

House Republican Whip Terry Marquardt, who represents this area in the state Legislature, has been trying to get the drilling started for five years, without much success. Now is the time, he says, to get serious about drilling.

With growing oil and gas shortages and soaring prices, this is the time, he says, to have a deliberative discussion about drilling. So Marquardt introduced a joint memorial in the current special legislative session, calling for the state Land Commissioner and the federal Bureau of Land Management to allow increased drilling on Otero Mesa.

Marquardt's effort won't go anywhere. Democrats maneuver the levers of power in Santa Fe and they are likely to rule that legislation relating to energy has no place in a session devoted to energy. That's just the way politics works. If Democrats liked Marquardt's idea, they would kill it anyway, and introduce an identical bill of their own.

And don't think Democrats pull these kinds of shenanigans because they are despicable people. Republicans do the same thing when they are in power.

And so, a good idea that would increase oil and gas supplies and reduce prices for New Mexicans will be dumped during a special session to address those exact issues.

We are told that Otero Mesa is the last of the untouched, pristine, wild Chihuahuan desert grasslands, unparalleled by any other in the world. It is home to over 1,000 native wildlife species, the healthiest herd of pronghorn antelope in the state and the largest, untapped fresh water aquifer in the state, called the Salt Basin.

The aquifer seems poorly named for a body of fresh water. But even if it were salty, scientists can do wonderful things with desalination -- and they're doing it everywhere but New Mexico, where people also find reason not to frill for water, either.

We wonder why New Mexico is last in most of the economic indices. It's because we're so good at keeping each other from doing anything. Recently this column complained about New Mexico's Indians finding any land of value in the state to be sacred. Environmentalists ate no different. It's all sacred to them too, even if it's a desert.

Other areas of New Mexico also are said to have large untapped, underground aquifers, but none of them ever seem to get tapped.

One of those large untapped aquifers is in the Estancia Valley, which could supply water to both Albuquerque and Santa Fe. But the farmers, under whose land the brackish water lies, have blocked efforts to develop it. And even if it were available, Santa

Fe wouldn't use it because of its no-growth policy that is justified primarily by a lack of available water. Go figure.

So environmentalists shouldn't give us any justifications about valuable water under the Otero Mesa, because they'll find reason not to ever tap it anyway.

Evidently their problem is that the drilling activity will foul the fresh water. But drilling methods have greatly improved over the years to the point they are much less invasive. Environmental requirements are not very strict.

The Bureau of Land Management, which administers much of the Otero Mesa land, ensures that drillers comply with those standards. The environmental restrictions written for Otero Mesa are the toughest the BLM has every required.

So it seems time to entertain Rep. Marquardt's suggestion to have a "deliberate discussion" about what opening Otero Mesa to more oil and gas exploration might do to increase our supply of oil and natural gas and reduce our dependency on foreign nations.

After a period of weeks of progress and after final medical examination, the soldier is once more the same man who crossed the Channel, and is ready to go back.

How is his frame of mind? That too, is taken care of. At the reconditioning center, under the command of Colonel S. L. Cooke, H.C. of Chatham, Virginia, it's not all work and no play. Col. Cooke, a veteran of the Sicilian campaign, knows well the mind of the wounded man. Recreational facilities are many. The Soldier can talk war, politics and peace with his buddies over coffee and sinkers at the Red Cross. He can pitch horseshoes, play in the baseball team or softball league, take French and German language instructions, see a movie, have a 'bitter' or two at the recreation hall. He is encouraged to attend religious services, Catholic or Protestant, at the Chapel, or transperation is provided to Jewish services at a nearby town. He just doesn't brood. And he leaves the center mentally fit.

The system is working. And its harvest will be reaped in the healthy condition and attitude of the veterans of this war.

One of the members of this rehabilitation center is: Pvt. Manuel C. Carabajal, Lincoln, NM.

## Our War With Japan

Can Japan hold up our powerful war machine very long? Your son, brother and friend in his Pacific foxhole wouldn't raise such questions because they are up against realities, not day dreams. They kill or are killed. They pray every waking moment for a sky-darkening cover of friendly planes. They thank America for giving them the finest medical care in the world when their rendezvous with destiny in a Pacific jungle is at hand. They know the war with Japan is just beginning.

Here are some other realistic realities so that you will understand why there must be a Sixth War Loan and why it is absolutely necessary that it be a success:

The Allied Military Command has estimated that it will take years, not months, to lick Japan.

Japan's present army numbers about 4,000,000 with 2,000,000 more men available and fit for military service who haven't been called up to date. Another 1,500,000, between the ages of 17 and 20, are not yet subject to the draft.

In the invasion of France, supply ships had an overnight run to make. In the coming Battle of Japan, ships in the Pacific will have long-reached round trips that often take five months to make.

Joe was born in Lincoln, NM and graduated from Capitan High School. He served in the US Navy during the Korean Conflict and is a member of DAV Chapter 33.

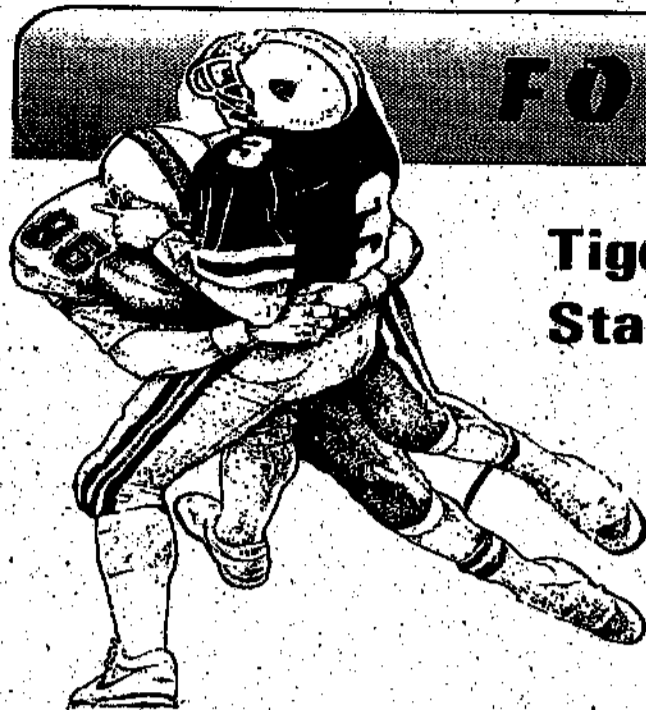
He retired from civil service at Kirtland AFB. Joe was a long time member of the Shrine of St. Bernadette Catholic Church.

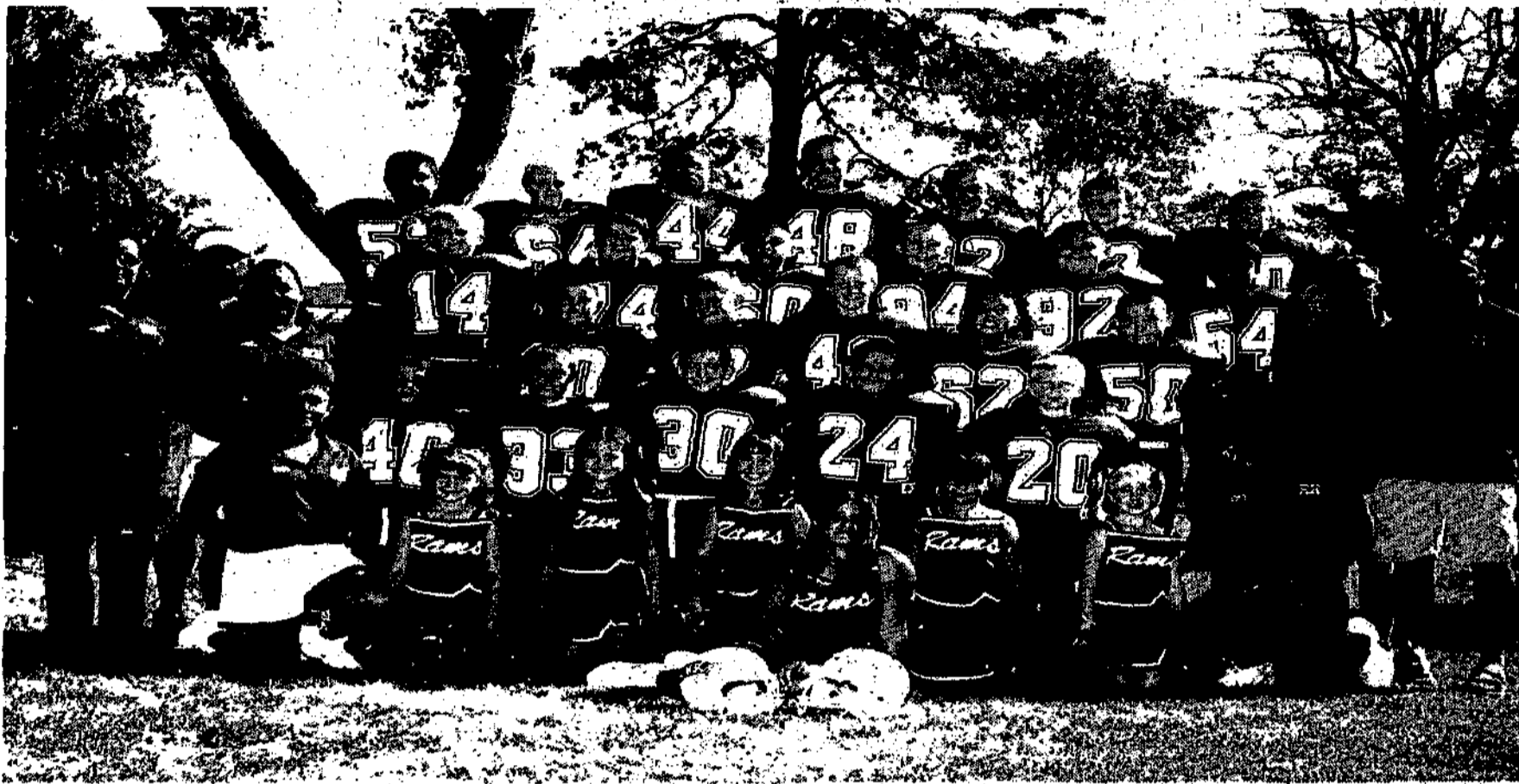

**Manager's Report**

In investigating the possibility of the county's enrollment with the New Mexico Retiree Health Care Authority, Lincoln County manager Tom Stewart has requested a presentation on the subject by authority representatives. In response, the authority has agreed to attempt to attend the November 15 meeting of Lincoln County Commissioners.

On or about August 5, according to an October 11 memorandum from Stewart to all departments, a fuel credit card was stolen from a Honda fire truck. Before the card was cancelled, the thief used it to buy gasoline, primarily along U.S. Highway 70, with purchases amounting to more than \$3,000.

Through the memo, Stewart ordered an immediate inventory of all county fuel cards, set new guidelines for the management and handling of the cards and halted the practice of using a common personal identification number for all persons authorized to use each card. The manager requests that anyone with knowledge of the stolen card, or of an individual offering to

purchase fuel in return for cash, contact the Lincoln County Sheriff's Office.

On November 1, the Ruidoso Senior Citizen Center will host a meeting to discuss Ruidoso's DWI program and the Collaborative for Underage Drinking. The meeting will begin at 4:30 p.m.

Stewart reported that he met with the state's Administrative Offices of the Court on September 26 and urged them to take back responsibility for the housing and security of district courts and district attorney offices. He suggested that, if left up to the counties, a great disparity between facilities will emerge due to varying abilities to support the projects fiscally. The group agreed to continue partial support of security, utilities and maintenance of the district's court facilities while they explore initiatives in other states.

Editorial

"Almost Everyone Will Fly"

Above is the caption of an article which reached our desk in pamphlet form a month or so ago, and about the same time we received a copy of "The Civil Aviation Bill" (H R 3420).

I read them both with deepest interest. In the pamphlet two sentences especially struck me:

"If your city has no provisions to accommodate Personal Aircraft, air travel will pass you by." and "To put your town on the Air map of the United States is an opportunity well within the grasp of any community." And these statements of course include Carrizozo.

We happen to have a nice little landing field, with a local young man, Marvin Roberts in charge, but when the war is won, these facilities will of necessity be increased.

Facilities for private flying in American haven't materialized yet, but they will; the utility of the airplane for personal use has been demonstrated right here, by several. One outstanding example was the late Mr. Kudner, who almost any day flew from his New York home to his Carrizozo ranch. He of course had a landing field at his ranch. We have plenty of space for these facilities when and if the people become air minded enough and enthusiastic enough to provide space for air parks, flight stops and air harbors. Again referring to the pamphlet, I see that 1.) "Air parks are to provide landing space for non scheduled planes, or personal aircraft. Air parks should be located near the business section to be convenient for the business man or housewife."

2.) Flight stops. Just what the name implies, are intermediate landings between cities spaced at intervals where the distance is great.

3.) "Air-harbors are to be located on bays, rivers, lakes, and sounds."

Of course the harbor part of it needn't worry us, as we aren't famed for rivers and lakes. But runways should be 2,000 feet long and 300 feet wide. The air parks should be constructed in the shape of the letters X, T, L, or V. They are considered very inexpensive in comparison with railroads and highways. At least 16,000 communities will be connected by airways following the post-war period and the government is urging communities to plan in advance for this new and progressive growth.

Assistant Secetar of Commerce, Mr. Wm. A. M. Burden says: "There must be a wide distribution of landing facilities for civilian flyers throughout the United States and these ports must be built wherever it is economically feasible, so that all Americans can take their rightful part in the growth of America's air future."

The Civil Aviation Bill (H R 3420) deals with the legal side of the air transport problem as it affects interstate and foreign commerce and it seeks to anticipate the conditions which must be met, such as lessening ground hazards and to extend and perfect the weather reporting service and to look toward improved administration of its governmental regulations. Of course states rights, alien control, zoning and safety are to be considered.

This next generation will travel by air about as much as the present generation travels by automobile. We have the good turf, grading and sodding are inexpensive and almost everyone can fix his own landing field -- when and if he gets his plane.
