

County Lodgers Tax Funding to Change

The Lincoln County Board of Commissioners on June 17th reviewed a request for Lodgers Tax funding for advertising and promotion of the annual Mountain of Blues Festival that is held in Ruidoso each June. The funding request for \$3,000 was presented to the Lincoln County Lodgers Tax Com-mittee on May 28th and, due to the amount of funds available, the committee awarded \$2,000 for the event.

During the June 17 meeting of the county commissioners. county manager Tom Stewart remarked on how the Lodgers Tax funding procedures would likely result in a finding in the county's annual

"The Ruidoso Mountain of Blues event has already oc-curred," Stewart said, "and the difficulty is that the procurement code requires that you issue a purchase order before you commit monies; this is kind of a recurring thing that I constantly run into," Stewart said. He explained that approving reimbursement after the event has already occurred is a violation of the procurement code.

"Either we start disapproving these things when they come in after (the event), or I need something from the board of county commission-ers saying that it's okay. Just know that it's going to be a finding in an audit." Stewart

County commissioner Jackie Powell told Stewart that she has participated in putting on a couple of events in the Ruidoso area. "When

last minute to present the request.

County commissioner Tom Battin said that an event promoter that he knows personally sometimes waits until all of the bills for the event have ing how much Lodgers Tax funding will be requested.

County commissioner Don Williams suggested that the simple solution to the pro-curement code violations would be to make it clear that funding requests need to be approved or denied before the event takes place. "Leave it up to the Lodgers Tax Committee to establish the rules for the applicants," Williams said. "They should be able to tell the applicants (for recurring events) that (for recurring events) that they need the request six months in advance," he add-

Battin suggested that a period of 60 days prior to the event would be an acceptable time frame for funding re-

Stewart said that a review

ers Tax Ordinance would probably be in order, and recurring annual events that regularly get support from the tax fund.

He recommended telling promoters that they need to come before the Lodgers Tax Committee at least 60 days prior to the event, "Waiting until a week prior, or just a couple of days prior, creates more problems than it's worth," Stewart said. "I think some administrative instructions are warranted."

The county commissioners agreed to approve funding for the Mountain of Blues Festival advertising, and to notify the promoter that he must present any future funding requests at least 60 days prior to the occurrence of the

Nogal Mesa Ranchman's Camp Meeting July 16-20

The evening sky fills with colors as the sun slips toward the horizon. The world is quiet, and hushed, as dusk develops. Then the breeze wafting through the trees begins to carry a melody, and soon the distinctive sounds of a piano drift a-cross the evening sky. As the western horizon darkens to blues and purples, more and more voices are raised in song until the air pulses with the music and words of Amazing Grace.

Thus, with a song and a prayer, evening services begin at Nogal Mesa Ranchman's Camp meeting. It has been this way for 68 years, as rural folk and their urban friends and neighbors meet together on Nogal Mesa to

worship and sing and meet with their Lord.

The first meal will be served on Wednesday evening, July 16th, followed by the first worship service. Thursday through Sunday the schedule is filled with four worship services a day, children and youth activities, and prayer meetings.
The evening worship service on July 20th will conclude the 68th annual camp meeting.

The concept of bringing the church to the cowboy was birthed over a century ago in the Big Bend area of Texas. The Bloys Camp Meeting was held each sum-mer in the Davis Mountains since 1890, Joe Evan's family was one of the early organizers of the Camp Meet-

Evans became friends with. Presbyterian missionary Ralph Hall, a circuit riding preacher. With his saddle and pack horse, Hall traveled the aouthwest to spread the good news of Jesus. When Hall arrived at

an isolated ranch, he joined in the work of the day, whether it was rounding up cattle, branding, fence building, or bronc busting. When the work was done, Hall would preach.

Evans persuaded Hall that New Mexico needed the same type of summer family camp, where far-flung neighbors could congregate for fellowship and worship of their creator. When the cowboys and the missionary

Carrizozo Hires Police Officer

The town of Carrizozo will have a new full-time police officer starting next week. The town trustees approved the hiring of Andy Hill Tuesday evening during a regular

meeting of the town council. Hill originally hails from Cincinnati, Ohio, but most recently from Lubbock, Texas, and has several years of law enforcement experience under his belt. In a brief interview with The News on Lucsday, Hill said he began his career in police work in Alamo Heights, Texas, in 1974 and continued as a detective and police investigator in Ohio. He earned a degree in Criminal Justice from the University of Cincinnati and is currently certified as a police officer in both Ohio and Texas.

Because of Hill's current status as a certified officer in two other states, he is eligible to be certified by waiver in the state of New Mexico. To achieve the local certification, Hill will be required to pass a three week training course in Santa Fe to familiarize himself with New Mexico laws and procedures.

Hill said that he and his wife Meg discovered Lincoln County during a visit to a motorcycle rally in Ruidoso, and both were immediately. impressed with the beauty of the Sacramento Mountains. Hill began to look into opportunities for employment in this area and just recently learned of the opening on the Carrizozo Police Depart-

The new officer was sworn in by Carrizozo Municipal Judge C.O. Rominger during Tuesday night's town council meeting and will begin his employment on July 15th.

He is hoping to find permanent housing sometime soon, but has been offered the use of a guest house owned by Stirling and Carrie Spencer until he can find a place of his own. Carrie Spencer is the Carrizozo Police Chief.

Hill's hiring comes at a time when some Carrizozo residents have complained about inadequate police coverage of the town, which has been provided by the police chief and two part-time officers only.

According to Spencer, the addition of Hill to the

Carrizozo police force will enable the department to provide better police protection, although budget constraints still make it impossible to have officers on duty 24 hours a day seven days a week

Hill's hiring will likely relieve some of the burden faced by the police chief, who said on Tuesday that she has donated thousands of

> In other parts of the country where markets exist within a hundred miles, Styrofoam is recycled at the rate of about. 10-12 percent per year.

> What can you do with Styrofoam as an alternative to recycling? When possible, instead buy other types of bioplastics that will decompose quickly in sunlight.
> Take Styrofoam peanuts,
> bubble wrap and some Styrofoam packing blocks to local
> shipping businesses like UPS

As the LINCOLN COUNTY NEWS goes into its 103rd year of being in existence (1905-2008), we will again be randomly publishing articles from old NEWS files. The following articles appeared in the "Lincoln County News".

Friday, January 30, 1919

The New Mexico Oil Fields

The Petroleum Age, in its January issue, carried several feature oil stories about oil conditions in New Mexico, Some of the biggest oil companies in the country have holdings in eastern New Mexico and 1920 is sure to see some constructive development work.

According to the Santa Fe New Mexican. the National Exploration company, which is now drilling at Picacho, and is preparing to drill south of there proposes to request that their large holdings in Chaves, Eddy and Lincoln counties be advertised by the state. and the oil leases sold to the highest bigger. Their attorneys were in Santa Fe a few days ago, and it is reported that they were there to complete arrangements for such action.

They gave out no definite information, but it was reported, the New Mexican says, that the form of the lease under this arrangement would require that a well be drilled each year, or in lien thereof the payment of a stiff annual rental to the state. It is said this plan has been under consideration for some time, but there has been a difference as to rentals.

New Mexico now has 37 wells partly drilled, it was learned last week from oil men. Of this number 27 have been closed down on account of bad weather but will

reopen in the spring.

Plans are under way to drill 207 new wells, Albuquerque operators said, as soon as the weather permits. Oil is being produced in a McKinley county well and a well in Union county has a good showing at a depth of 2,780 feet.

Never before in the history of Roswell has there been so many oil men here. Buying and selling of leases in all parts of the county has been spirited for the past few days with Orchard Park and Cumberland City the big centers of attraction. Leases in the vicinity of where the next well of the National Exploration Co. is to be drilled sold for as high as \$40 an acre, while the land itself sold for as high as \$100 an acre.

The Lincoln well No. 2 is now being dreilled by the Mescalera Oil Company. Work on cons-truction of the derrick and other preparations began there about six weeks ago and drilling has now started. This well is seven miles south of the first Lincoln well and about fifteen miles west of Espula. The casing in the first well was hung when an attempt was made to draw it from the hold, and this hung up drilling operations on the first Lincoln well. A fifteen and a half inch casing is now being set in the well of the National Exploration company, near Picacho.

J.F. Haynes, an automobile man of El Paso, is in Roswell completing arrangements for starting a daily automobile route from El Paso to Roswell.

He plans to have a car leave El Paso every morning, and one to leave Roswell every morning, making the trip of 275 miles in ten hours. He plans to run the route by way of Hope, Dunken and Pinon. -- Roswell News



met on the rim of Nogal Mesa and gazed on the panoramic view of the Tularosa Basin and the distant purple: mountains, they felt they had found the perfect site:

The Mesa has become a holy spot for many people in the ensuing years. First, ranch families came in wagons and horseback to hear the preaching and teaching. Today, cars and pickups pulling motor homes wend their way over the dusty road on the way to Nogal Mesa. Others who can't come to camp make it a point to come for the evening meal and services.

Today, more than 50 families make up a local committee which carries on the work begun in the middle part of the last century. They aren't all cowboys any more, but all are dedicated. to God's service and the

preaching of His word.

Over the years, this committee has built a wooden tabernacle perched on the



Special Meeting Tonight . . . WHY?

The Carrizozo Town Council has a special meeting tonight at 6:00 p.m. It was a surprise because there was no mention of a special meeting to be held on Thursday. July 10 during the town council meeting on Tuesday, July 8. Apparently the special meeting tonight is for personnel. unclassified personnel. The interesting thing there is that the town has only two unclassified employees, the town clerk and the chief of police. Makes us wonder which of the two is being singled out for possible public flogging.

However, the surprises started during the town council meeting Tuesday. The agenda was changed to move item #17 up to between item #5 and item #6. This meant that a standing room only crowd had to wait for an hour while the town council was in closed session from 6:05 p.m. to 7:05 p.m. That agenda item was for limited personnel matters, unclassified personnel. After the hour closed meeting and the attesting that nothing was discussed in the closed session other than personnel, the mayor asked for direction from the trustees to move the unclassified position of town foreman to classified. If that act has been performed, then that leaves two unclassified employees.

Realistically, what could have happened in about 13 hours to make it necessary to schedule a special meeting? Is there a truly serious situation that needs to be dealt with immediately and could not wait until next Tuesday when there is a special meeting scheduled for budget and other matters to be included on that agenda or not? Or is this a situation of ego surfacing? There are five elected officials that can and often do use their power to call for a special meeting. Which one or ones of the five is vying to uplift their status by being responsible this time? Hmm.

Or it could be a situation that should have been dealt with in an emergency meeting, not a special meeting. The town council meeting Tuesday did have some difficult minutes when some people DEMANDED the chief of police do something, as if doing something after the fact would have changed what happened previously. But the situation was explained in public and the chief did say the sheriff's department handled the police calls on June 20.

The first thing is that there are monetary constraints as to what the chief of police can and can not do, that is if the chief is the unclassified personnel being discussed. If it is the clerk, what happened in 13 hours to make it necessary to meet in special session? Or will the ego demon rear its head and roar to publicize what could have been handled quietly and efficiently? We may know about it tomorrow.

Governmental regulations as to how personnel matters are to be handled were put in place for a reason. As to the way this situation is being handled may or may not be the proper way, but it certainly is confusing to many of us.




