Candidacy Challenge Dismissed But Not Over

A petition signed by 25 voters challenging the legitimacy of Sheriff Rick Virden's voter registration and candidacy in the general election, and calling for a special master to oversee the November election in Lincoln County was dismissed in a District Court hearing in Alamogordo last week.

The petition filed by independent candidate for sheriff. Steve Sederwall, and 24 other voters alleges that Virden intentionally misrepresented his primary place of residence both on his voter the house in town. Virden owns two homes. one inside the city limits of Carrizozo and another about a mile outside of town.

The petitioners allege that Virden lives in the home outside of town, but declared the Carrizozo home as his legal residence in order to illegally vote in Carrizozo municipal elections.

Virden told The News recently that he is staying on the ranch while renovating zo house to be his primary residence and intends to move back into town when the renovation work is com-

Five of the 25 petitioners were present in court. Attorney for the petitioners, Timo-thy Rose of Ruidoso, argued that if Virden misrepresented reside at his legal residence.

voter registration, that regis-tration would be invalid, as would be his candidacy for the office of Lincoln County Sheriff.

'The remedy we're seeking in this case is to determine that Rick Virden does not and to strike that registra-tion," Rose said in court. "Without that declaration of candidacy, there is no proof that Rick Virden lives in the county," he added. Rose further requested that Virden not be allowed to file

an amended registration in order to correct what Rose alleges is an intentional falsification of legal residency.
Attorneys for the respon-dents in the case argued that

candidates for county offices are required to reside within the county, and that no one is disputing that Virden meets that requirement.

Fuqua began by saying that the petition does not just question Virden's legal residency, but is an attempt to have the incumbent Republican sheriff's name removed from the ballot for the November general election.

"To be qualified to run for Sheriff, Virden doesn't have to be a resident of Carrizozo; he has to be a resident of Lincoln County," Fuqua told Judge Ritter. "He doesn't have to be a registered voter. That's not a constitutional or statutory requirement for the office of Lincoln County Sheriff," he said. "The ques-tion of whether or not Virden is a qualified voter in the municipality of Carrizozo has no bearing on his qualifications to run for sheriff," Fugua

said.
"There is no allegation made by any of the petitioners that Rick Virden resides outside of Lincoln County,"
Fugua continued. "The evidence found in this court and through these petitions does, in fact, prove that he does reside in Lincoln County, As far as his residency is con-cerned, I think that's the only question that this court needs to answer," he told Judge

"That sounds to me like there's an argument that there's a failure to state a claim regarding residency of a candidate," Judge Ritter responded.

Also regarding the peti-tion's challenge of Virden's legal residency, Fuqua cited the state statute that sets a time limit for filing such a

challenge.
"You have 10 days after the last day for filing a registration of candidacy in which to challenge, specifically, the residency of a candidate and, if you don't launch your challenge within those 10 days, you waive the opportunity to challenge the resi-dency of that candidate," Fuqua explained. "That challenge is untimely under the

election code." Regarding whether or not Virden must be a registered voter to run for office, Rose argued that, by state statute, voter registration is used to determine the residency of a candidate. Language in the statute says that no person shall become a candidate for nomination by a political party or have his name printed on the primary election ballot unless his record of voter registration shows his residence in the district of the office for which he is a can-

didate. As to whether or not the petition to challenge Virden's candidacy was filed within the legal time frame mandated by the state, Rose referred to the statute that allows for the 20 or more signature netition to be filed signature petition to be filed no less than 42 days prior to the election. That law says that, if a person's voter regis-tration is found by the court to be falsified regarding residency, that registration shall be cancelled.

Fuqua argued again that there is no statutory require-ment that a candidate be a registered voter, and said that the statute cited by Rose was written to assure that candidates reside in the district in which they seek to serve of-

Forest Service Office In Alamogordo to Move

After 50 years in the down-town Federal Building, the Lincoln National Forest Supervisor's office will move into a new building on the north end of town.

As of Tuesday, September 30, the supervisor's office will be located off the Relief Route at 3463 Las Palomas, near the movie theater and pre-check office.

Employees will be available at the office on New York Avenue through the close of business on Monday. September 29. Phone numbers will remain the same, although service may be interrupted for a short time

during the move.

Traffic may be congested around the Federal Building on New York Avenue as the Forest Service moves out and Otero County moves in.

"Although we will miss are looking forward to serving the community from our new location," said Chad Stewart, acting forest supervisor, "and I hope the county employees who will soon occupy this building will enjoy it as much as we did."

The new office is a 'green' building, with interlocking concrete form walls, solar panels and energy effi-

cient windows. The reception area will be more inviting for our many visitors and parking is more convenient," according to Ren Wood, administrative officer.

In addition to the Forest Service, the Natural Resource Conservation Service, Farm Services Agency, and Otero Soil and Water Conservation District have already moved into the new office. Access to these three agencies is on the east side of the building at 3501 Mesa Village Drive. The old Federal Building

was built as the Post Office in 1938. In 1961 the Post Office moved out and the building was occupied by the Forest Service, the Federal Bureau of Investigation, the Internal Revenue Service and the Soil Conservation and the Soil Conservation

Service. In 2000, the building was listed on the National Register of Historic Places as a good example of Pueblo style architecture. Listing on the National Register honors the property by recognizing its historical importance. For additional information,

the court to determine that Mr. Virden doesn't live in Lincoln County," Fuqua said, "That's the only residency requirement that's relevant,"



Fuqua acknowledged that the debate about Virden's precise residency might be of interest to voters, but argued that it does not affect his

qualification as a candidate. He suggested that the petitioners were attempting to use the challenge of Virden's voter registration as a "back-door way" to subvert the legal requirement to file a challenge of his candidacy within 10 days after the candidacy liling date.

These kinds of things are supposed to be hashed out early for a reason," Fuqua said, "so that when we go into an election we are as certain as we can be that the people who are running are eligible to run for that of-fice," Fuqua said. "This was supposed to have been decided almost three month

guy needs to be removed from the ballot."

Fugua then addressed the petition's request for a Special Master to oversee the election. "The court's analysis needs to focus on the remedy that the petitioners are seeking," he said. "There's simply no basis, statutory, constitutional, regulatory or case law, there's no basis whatsoever for the appointment of a Special Master to do the job of an elected offi-cial," Fuqua said. "The alle-gations that Mr. Sederwall has made regarding Tammie Maddox and the other folks over at the Lincoln County Clerk's office are irrelevant," he said.

"You don't need to make any factual determinations as to whether or not Tammie Maddox has tried really hard to keep Sederwall off the ballot, or whether she's biased

against Mr. Sederwall,"
Fuqua told the Judge: "The reason you don't have to make that determination is because there's no authority in New Mexico law for the appointment of a Special Master to oversee an election. It's just not a remedy,"

Rose said that he could find no case law regarding the appointment of a Special Master to oversee an election. "However, in cases in which the courts have intervened and issued injunctions in other types of circumstances, I think there are circumstances where courts enforced the injunctions by appointing Special Masters,"
Rose said.

Following the hearing of the legal merits of the peti-tion to challenge Virden's tion to challenge Virden's candidacy, Judge Ritter recessed for about 45 minutes to review the arguments, applicable state and federal statutes and case law that were referenced by the attorneys

Upon returning to the courtroom, Judge Ritter said that he was prepared to rule on the legal arguments re-garding the petition, and said that the legal arguments warranted dismissal. The Judge said that a Penn-

sylvania case in which the sylvania case in which the qualification of a candidacy was challenged based on residency was not applicable to this case because the candidate in Pennsylvania had intentionally lied about his address in order to hide the fact that he was living with his flance.

'The court in Pennsylvania noted that Pennsylvania has two lines of analysis," Judge Ritter said. "There's a good faith mistake on those regis-trations, and they're very lib-eral about letting the public have a chance to vote for whomever they want, even in the face of a good faith mis-take. There are bad faith mistakes with intent to defraud the public," Judge Ritter said. "In this case, where the issue is does Mr. Virden live in one place in Lincoln in one place in Lincoln County or another place in Lincoln County,' either of which would qualify him to run for sheriff, I don't think (the Pennsylvania case) is on point," Judge Ritter said.

The Judge said he was analyzing the Virden candidacy challenge under the motion to dismiss and whether or not the petitioners failed to state a claim.

a claim.


"I'm trying hard not to go beyond the allegations in the petition," the Judge said. "The petition alleges that Mr. Virden is not a qualified elector in Lincoln County. New Mexico, and that his registration should be cancel-

As the LINCOLN COUNTY NEWS goes into its 103rd year of being in existence (1905-2008), we will again be randomly publishing articles from old NEWS files. The following articles appeared in the "Carrizoto News".

Friday, January 31, 1913

Supreme Court Opinion --County Seat

Supreme Court of the United States -- 322 and 483, October term, 1912.

S.T. Gray and Robert Brady, appelients (322), vs. Robert H. Taylor, Charles W. Wingfield and Romualdo Duran, the board of county commissioners of Lincoln county, territory of

New Mexico. The territory of New Mexico by its attorney general, Frank W. clancy on the relation of Jacobo J. Aragon, appellant (483), vs. the board of county commissioners of Lincoln county, New

Appeals from the supreme court of the territory of New Mexico.

January 20, 1913. Mr. Justice Holmes delivered the opinion of

The first of these suits is a bill in equity brought by tax payers to restrain the county commissioners of Lincoln county from erecting a court house and jail in the town of Carrizozo, the board assuming that the county seat has been changed from Lincoln to that town. The second is a quo warranto at the relation of a taxpayer against the same board to stop the same and other proceedings taken by the board on the same ground. The supreme court of the territory affirmed a decree dismissing the bill and also a judgment denying the quo warranto, 15 N.M. 742, 16 N.M. 467. Both cases raised the question whether the attempted change of the county seat was void, and turn on the same facts, which may be stated in connection with the several objec-

tions that the appellants take. In the first place, it is said that the statute under which the attempted change took place is void because it is a local law, and the act of Congress of July 30, 1886, c. 818, Sect. 1, 24 Stat. 170, provides that the legislature of the territory shall not pass local or special laws in the matter, among others, of changing county seats. The statute being c.80 of the Laws of New Mexico of 1909, is thought to be local because by Sec. 2 it enacts that the place to which it is proposed to remove the county seat "shall be at least twenty miles distant from the then county seat of said

county," and that no proposition to remove a county seat from a place situated on a railroad to one not so situated shall be entertained. It is argued at great length and is obvious that at any given time this enactment does not hear in the same way on every part of the territory. In its present form the statute may be specially favorable to the change from Lincoln to Carrizozo, if, as is said, the latter town is on a railroad and Lincoln is not. It may be admitted that a local act could be disguised in general terms, if a legislature would condescent to evading its duties under a constitution or organic act. It may be assumed that general words are not necessarily enough to disguise such an intent. But it is not lightly to be supposed that a legislature is less faithful to its obligations than a court. General words indicate and affirm a general intent, and if the fact that different sections are differently affected is enough to make a law local the field of legislation would be narrowed beyond anyting that Congress could have dreamed. It cannot have been intended for instance that no laws should be passed concerning cities or towns, yet such laws would be local in their application. The phrase local law means, primarily, at least, a law that in fact if not in form is directed only to be specific spot. If it has a wider meaning it involves questions of degree that cannot be decided by putting cases other than the one before us. We know nothing that would warrant us in declaring that this law was not intended according to its purport to regulate generally the change of county seats. Ritchie vs. Franklin County, 22 Wall. 67.

The full discussion in Codlin v. County Commissioners, 9 N.M. 565, has lost but little of its force and applicability notwithstanding the later amendment of the statute. The law is shown not to be a local law, and with regard to the twenty-mile limit it is said to be only reasonable to believe that

erwise meets the requirements of the Constitution and resides in the appropriate dis-trict," Judge Ritter said, "The Constitution describes the qualifications for holding office as a person who is a legal resident of the state and a qualified elector therein. In this case, where the election at issue is the general elec-tion for 2008, and where the underlying purpose is to de-termine whether Mr. Virden is qualified to run as sheriff, we've all agreed that the district is Lincoln County,"
Judge Ritter said. "The only
precinct named in this petition is Lincoln County, New Mexico. There is an allega-tion that Mr. Virden is not qualified to vote in Carrizozo municipal elections, but the Carrizozo municipal elections are not an issue in this case as far I know," he said.
"Nowhere in this petition does it state that Mr. Virden is not a resident of Lincoln County. To that extent, I believe the petition fails to state

a claim. Judge Ritter said that the petition states that Virden lives a few miles outside of Carrizozo. "Maybe I could take judicial notice that you've got to get more than a few miles outside of the town of Carrizozo to get out of Lincoln County, but maybe I can't," Ritter said. "If there's a real factual allegation that Mr. Virden doesn't live in Lincoln County, we can hold an evidentiary hearing on

"To the extent that the cancellation of voter registration in this case, which is what the statute authorizes the petitioners to attempt to do, is really being used as a device. to eliminate Mr. Virden from the election ballot, I don't think there's any basis in the law for the relief sought because registration as a voter is not a requirement to hold public office in New Mex-ico," Judge Ritter said. "The Constitution requires residency in New Mexico for 12 months and in Lincoln County for 90 days and the precinct for 30 days before the election, in this case the pre-cinct being Lincoln County," he said. "Candidates must be U.S. citizens, legal residents of New Mexico and qualified electors, meaning any person qualified to vote," he said. "A qualified elector is not a voter. A qualified elector must register to become a voter," the Judge explained. He said that the Attorney General determined in a 1965 case that registration as a voter is not a requirement of those seeking to hold an elected office.

"On the first issue, whether this court can entertain a petition alleging that Mr. Virden is not a qualified elector in Lincoln County, I don't think that the petition states a claim," Judge Ritter said. "If it did state a claim, I don't think that I'd be able to go beyond the cancellation of voter registration and reach what may be the petitioners' real goal; ordering that Mr. Virden be eliminated from the ballot,"

dismissing the challenge to tion is failing to state a claim voter registration. I find that and also is being time barred the petition is not timely under (state statute that sets the time limit) for challenging the residency of a political party candidate in the primary," the Judge continued.

"And finally, the petitioners asked for the appointment

of a Special Master to over-see the 2008 general elec-tion,"Judge Ritter said, "The request of overseeing is a little bit ambiguous. I'm not sure whether the petitioners' want the appointment of a Special Master to substitute for the elected County Clerk, or whether they want a Special Master to watch the County Clerk and report on any deficiencies in her performance," he said.
He acknowledged that

there is no law in New Mexico that provides the legal authority that would allow him to appoint someone to replace an elected County Clerk in the performance of his or her election duties. Judge Ritter said that the state provides enough safeguards to ensure a fair election, and said that the peti-tioners could file a complaint after the election if any deficiencies are suspected.

Daniel Bryant, the attorney for respondents Rick Virden and Lincoln County Clerk Tammie Maddox, said that the Judge had "exactly seized on the issue.'

"The question before this court is not is (Virden) qualified to vote in a municipal election," Bryant said, "Indeed, looking at the petition, if that's where it's now being suggested we go, the two elections that they're talking about, one was in '06 and the other was in March of '08. All of the dates for challenging or otherwise doing anything about those elections have long since passed under the elections code, the longest time limit that anybody has to challenge a municipal election result is 20 days after the election result has been declared by the village clerk, so that deadline passed some time ago in April,"

Bryant said. He further addressed the question of which house Virden actually lives in by refer-

ring again to state law.
Citing specific state statutes Bryant said, "the Election Code explicitly assumes that the voter can be away from his address and still be a qualified voter in terms of his address under the New

Mexico election code. Judge Ritter said that he would make a note that there is a factual dispute between the parties as to the residence. of Mr. Virden for voter registration purposes.

"That might help you through record on appeal," he told Rose, "but I will make a finding that there is no dispute between the parties that Mr. Virden resides in Lincoln County. New Mexico, because I think that's critical for my ruling that as a matter of law the petitioner fails to state a claim," Judge Ritter said. "I

"As a secondary basis for continue to construe the petilenges to primary candidates

of political parties," he said.
Judge Ritter said that he understood, based on the prior history of the case, that the petitioners may want to take the case to the Appellate Court as soon as possible.

Rose and Sederwall have each reported to The News that the petitioners will file an appeal, probably early next week.



Fort Stanton Is NM's **Newest State Monument**

SANTA FE -- Fort Stanton has taken another big step on its way to opening as a state monument. The fort, between Capitan and Lincoln, became a state monument in August of last year. It was constructed in 1855 for the protection of area residents.

Renovations have been taking place during the year. This month, the property was transferred to the Department of Cultural Affairs, which operates state museums and monuments. The state monument could open as early as next sum-

Fort Stanton is the crown jewel of frontier forts in the southwest.

Constructed of native stone, it is much better preserved than most southwestern forts, which were made of adobe.

I had not visited the fort since former Gov. Gary Johnson closed it as a state health facility in 1995. The interest in locating a state Veterans Museum at the fort renewed my interest in making another visit.

Historian and advocate for preservation of the fort. Lynda Sanchez, who made the Fort Stanton presentation to the Governor's Vetcrans Museum Task Force filled with saddles, spurs revealed that the facility was more than large enough. to be used as a state monument and a veterans museum.

The veterans task force made a decision to build a new museum in Las Cruses but my interest was piqued to take another look at Fort Stanton.

Sanchez gave me a great tour, pointing out areas that had deteriorated since Gov. Johnson pulled the plug 13 years ago and areas that have been improved re-

The parade grounds, intorian-style stone buildings around the quadrangle are in decent shape, well painted and feature porches with white columns.

Current educational and field discoveries are uncovering exciting new details. Recent oral history interviews have verified hidden underground rooms made by World War II Nazi pris-oners that contained Nazi flags, photos and paintings of Hitler.

In late 1939, a German luxury liner was scuttled in the Caribbean rather than have it fall into British hands. An American ship rescued the crew. Over 400 men of fighting age were detained, but not as prisoners, since we weren't at war yet. The captain of the ship was given his choice of where he wanted his men detained and he chose Fort Stanton.
The Germans remained

throughout the war and were housed just across the Rio Bonito from the fort, which at the time was a tuberculosis hospital for Merchant Marine seamen.

Later Japanese American detainees and then, a tough group of Afrika Corps Na-zis. That likely was the source of the Nazi memorabilia, which was burned by locals as soon as it was discovered after the war.

Sanchez believes there is a good chance more secret underground rooms may still be found. She is encouraging federal agencies to use ground penetrating radar to locate additional underground rooms.

Oral history interviews also have revealed rumors of the existence of a large dump area where wagons, tion.

and other supplies were buried when the fort was decommissioned by the Army in 1896.

Besides providing protec-tion in its early days, the fort also provided economic opportunities, jobs and social activities for Lincoln County residents. It played a decisive role in the Lincoln County War of 1878.



the legislature intended, in fixing it, to prevent cities and town situated within a few miles of each other from engaging in those injurious contests for the supremacy for the location of the county seat, based upon population only. The wisdom of these conditions is apparent, and it is within the power of the legislature to make them.

However it, may be as to the foregoing question, which arises under an act of congress, the other objections are of a kind as to which we have often intimated our strong leaning toward following the local courts, and therefore will not be discussed at length. Fox v. Hearstick, 156 U.S. 674, 679; TGreat v. Grand Canyon Ry. Co., 222 U.S. 448, 453. In the first place it is said tha tthe statue was not approved by the governor and does not appear to have reached him more than three days before the adjournemt of the legislature so as to become a law by Rev. Stats. Sec. 1842. Also it is said that the bill was not signed by the president of the council or the speaker of the house of representatives, as required by the respective rules of those bodies. But the act appears in the official copy fo the laws of 1909; it passed the two housed in fact, and in ample time to be submitted to the governor. The governor returned the bill to the council with the statement that he had allowed it to become a law by limitation. We agree with the court below that the governor's message is as good evidence as a note of the date on the bill that the bill had been received long enough before the return to make his statement correct. Gardiner v. Collector, 6 Wall, 499, 508, 509. The journals of the two houses showed the passage of the billand. we certainly should not reverse the local decision that the evidence, if necessary, was admissable and sufficient in aid of the act.

The next objection is to the form of the petition by which the proceedings for the change were begun. The statute provides that the board of county commissioners shall order a vote whenever citizens of a county equal in number to at least one-half the legal votes cast at the last preceding general election in the county shall present a petition asking for the removal of the county seat to some other designated place. The petition asked the board to "call an election and submit to a vote ... the proposition to remove the county seat of said Lincoln county to carrizozo," etc. It is said that this did not ask for the removal, and if read with extreme technicality it did not, in so many words. But the petition very well might be held to imply that the proposition to remove emanated from those signed, the only persons from whom it could emanate under the Isw that the petitioners

Again it is said that the ballot was in an unintelligible and misleading form. The board following the stature, Compiled Laws, 1897, Sec. 631, ordered that "the tickets voted shall contain "For County Seat" with the name of the place for which he voter desired to cast his ballot, either written or printed thereon." If the court was of opinion that the voters would understand that those in favor of Carrizozo would write that word on the ticket and those opposed to a change would write Lincoln, we could not say that they overrated the intelligience of their fellow citizens. There was no evidence that the voters were deceived, but it is enough that the statute was followed. There is no ground on which the law could be declared void.

It is objected that there was no registration of voters, as required in general terms by Sec. 1708 of the Compiled Laws. But that section required the county commissioners to appoint a board of registration sixty days before any election, and as the statute concerning the change of county seats in case of a special election required it to be called "at any time within two months of the date of presenting said petition" it naturally was held that the case was taken out of Sec. 1709 by the latter act.

It is objected that various allegations of the bill were admitted because not denied. If any such matter is open the allegations not denied were mainly if not wholly erroneous conclusions of law from the facts proved at the trial. Equitable Life Assurance Co. vs. Brown, 213 U.S. 25, 43. But it is not open. The arrangement seems to us to need. no further or more elaborate reply.

Decree affirmed. Judgment affirmed.

Now All Together

The unfavorable advertising that Lincoln county has received because of the county seat litigation, may now be turned to good account. It is true, the long drawn-out fight has had its heartbreaking incidents -- equally to both sides of the contest -- but perhaps no county in the state has become better known, and, unfortunately, none more studiously avoided by capital. Unsettled conditions retard any county's growth, and capital is wary of investment where costly litigation is in progress.

The final settlement of the litigation should. therefore, be hailed with a high degree of satisfaction by tax payers and all who want to see the county advance. Advancement will come more quickly by the investment of capital and the location of settlers -- all of which we now have a right to expect. And in this connection, allow us to again say: let us begin anew to build for a better and greater Lincoln county

Never was the outlook better for Lincoln county. The season has been excellent, prospects were never brighter for farmer and stockman. A spirit of advancement pervades the atmosphere. better roads are being built and still better are coming; we are to have an up-to-date auto daily mail service, beneficial to every part of the county; Carrizozo will have an experiment farm that should prove profitable to the entire farming community, and allow us again to say: Let us turn our faces to the future -- it's bright -- to rake over the dead ashes of the past will bring no profit.

Auto Mail Service

If no further hitch occurs or has occurred. -the old rawhide-stage line -- or rather three of them, between here and Roswell will be superseded tomorrow, Saturday, February 1, 1913, by an up-to-date auto mail line -- an auto starting each morning at both Carrizozo and Roswell. While I incoln county has a magnificent area -- sufficient in which to plant four Rhode Islands -- yet its people like to hear from one another occasionally and know what is taking place in various sections, which was a difficult problem in the past. This, we hope, ends tomorrow; and with a daily atuto service we may become better acquainted.


