O'Brien Appointed Interim Lincoln County Sheriff

In what was viewed by many as a surprising move, Lincoln County Sheriff Rick Virden announced his resignation from office during a special meeting of the Board of Lincoln County Commissioners last Friday.

The general public was first alerted to the fact that something had changed in the sheriff's department when the county manager's office issued the agenda for the special meeting, which

had been scheduled for the canvass of the votes from last week's general election of November 4th. The agenda included an item listed simply as "appointment of in-terim sheriff."

In a memorandum to the Board of Lincoln County Commissioners distributed by county manager Tom Stewart and dated November 5th, Stewart reported that Virden had submitted his resignation, effective Octo-ber 31st, 'to allow for some quality time with his family

Virden offered a brief explanation of his resignation during the meeting last Friday, beginning with an expression of thanks to the voters that re-elected him.

"Because of that support, I felt it best to use this forum to explain my decision to go ahead and resign the rest of this term," Virden said, "I have some personal issues that I'm going to have to take care of that are coming up that will require me to be out

County Continues Wolf Opposition

On October 21st, during the regular meeting of the Lincoln County Board of Commissioners, Rick Simpson gave an update on the Mexican Wolf Reintroduc-tion Rule Modification meeting that he attended in September.

The meeting was held to gather comments from cooperating agencies that might be impacted by an expansion of the wolf program, and was attended by 35 people repre-senting 15 counties, four federal government agencies and one Native American tribe.

The goal of the September meeting, and meetings to be held in the future, is to find and assess alternatives to the current policies of the wolf reintroduction program as a new Environmental Impact

Statement is prepared.

The reintroduction of the Mexican Gray Wolf into its natural habitat in New Mex-ico and Arizona began 10 years ago, and the federal Wildlife Service plans to use the knowledge gained in the first decade of the program to find ways to modify the wolf program for the future.

The Arizona and New Mexico wolf populations are protected by federal law un-der the Endangered Species

Much of the opposition to the wolf program stems from the cattle and sheep ranching communities, and that opposition was clearly stated during the September meeting of cooperating agencies in which Simpson is the repre-

Simpson also said that the wolf reintroduction programuses private property to further political goals, and suggested that expansion of the program would force ranchers to find other ways to make a living. He told the

county commissioners that the law does not allow a per-son to protect a family pet if that pet is attacked by wolves on public land, and that that law somehow violates a person's constitutional right to protect his or her private

property. "You do have the right to protect your family members. although you may have to ing to kill them." Simpson said.

One of the issues associated with the wolf recovery program that Simpson said bothers him the most is the policy of compensation to ranchers for lost livestock.

County Supports Animal Portection

The abuse of animals, including family pets, has time and time again been found to preclude or accompany violent acts against people. According to Nogal resident Bob Moeller, 11 states have addressed the issue of animal abuse as it occurs in conjunction with domestic abuse of family members in private homes across the country.

Speaking to the Board of Lincoln County Commissioners on October 21st, Moeller said that pets are often abused in domestic violence situations.

"It's been found that is a very strong connection that

links abuse of animals and domestic violence," Moeller said. "Abusers in domestic violence situations batter animals, the woman of the house and the children to demonstrate their power and control over the family, to force submission to their will and domination, to perpetuate an environment of fear, to prevent the victim from leaving or to coerce her to return or to punish her for leaving

bly just died of natural causes so, of course, they don't reimburse for those," he said.

Simpson suggested that in some cases, as in one re-ported incident of a prized rodeo horse being killed by wolves, the livestock owner should be able to take the case to a civil court and request damage compensation for emotional distress and the loss of a working animal as opposed to simply receiving compensation for the market value of the animal lost. He again suggested that the compensations should be paid for by the supporters of the wolf reintroduction program.

cooperating agencies produced a long list of concerns and issues relating to the wolf reintroduction program, including inadequate en-forcement of the Endangered Species Act and a failure to consistently prosecute poachers. Some participants in the meeting called for termination of the program altogether, stating that it is unconstitutional.

While opponents of the program cite damaging eco-nomic impacts to the ranching industries, others suggest that new industries might be developed that take advan-

The September meeting of tage of the eco-tourism interests in the wolves. There are arguments from both sides regarding the impact of the wolves on the deer and elk populations in the reintroduction areas. Some argue that the wolves will help improve the quality of the deer and elk herds by reducing over-populated herds and elimi-nating sick animals.

Those who profit from the sale of deer and elk hunting permits, or who work as outfitters for hunting expedi-tions, argue that the wolves cut into a commercial, for profit market that helps the state's economy.

Comments were made that suggest that grazing permits should be suspended on public lands within the wolf reintroduction area, a move that would perhaps reduce live-

stock losses due to wolf predation and provide the wolves with safer habitats of their own. The elimination of open range calving on public lands was also suggested. Others commented that someone other than livestock producers should pay for additional fencing to protect livestock on public lands, and it was suggested that ranchers should be reimbursed for lost livestock without having to prove that the loss was caused by wolves.

County commissioner Jackie Powell said that more counties should be represented in the meetings of the wolf recovery program, and suggested that the Wildlife Service has not fully disclosed the number of wolves currently existing in the reintroduction areas of southwestern New Mexico.

County commissioner Tom Battin, citing a consensus on the board of county commis-sioners, recommended that county manager Tom Stewart be authorized to contact the New Mexico Association of Counties and the Fish and Wildlife Service to organize a united front against the possible expansion of the wolf reintroduction program. Battin also suggested a meeting with representatives of the Mescalero Apache tribe to attempt to solicit the tribe's involvement as well.

"If you're a rancher, and you can prove that a wolf killed one of your calves, there is a group of supporters that put money together to reimburse at market value," Simpson said. "If you've got 10 other cows that don't have calves, that doesn't mean a wolf killed them, they proba-



Friday, November 9, 1917

Says Satan to the Kaiser

When Louis Syborkrop of Creston, Iowa, wrote the satire on Kaiser Willhelm which follows, he little thought it would attract attention which it has. Requests for copies have come to him from Theodore Roosevelt, Secretary of the Navy Daniels, Secretary to the President Tumulty and other notables. The article is in the form of a letter from his Satanic majesty to his human prototype. It says:

To Wilhelm von Hohenzollern,

King of Prussia, Emperor of all Germany and Envoy Extraordinary of Allmighty God.

My dear Willhelm: I can call you by that familiar name, for I have always been very close to you -- much closer than you could ever know.

From the time that you were yet an undeveloped being in your mother's womb have I shaped

your destiny for my purpose.

In the days of Rome, I created a roughneck known in history as Nero. He was a vulgar character and suited my purpose at that particular time. In these modern days a classic demon and efficient super-criminal was needed, and as I know the Hohenzollern blood I picked you as my special instrument to place on earth an annex to hell. I gave you abnormal ambition, likewise an oversupply of egotism that you might not discover your own failings; I twisted your mind to that of a madman with certain normal tendencies to carry you by, a most dangerous character placed in power; I gave you the power of hypnotist and a certain magnetee force that you might sway your people. I am responsible for the deformed arm that hangs helpless on your left, for your crippled condition embitters your life and destroys all noble impulses that might otherwise cause me anxiety, but your strong sword arm is driven by your ambition that squelches all sentiment and pity; I placed in your soul a deep hatred for all things English, for of all nations on earth I hate England most; wherever England plants her flag she brings order out of chaos and the hated cross follows the Union Jack; under her rule wild tribes become tillers of the soil and in due time practical citizens; she is the great civilizer of the globe and I HATE HER. I planted in your sould a cruel hatred for your mother because SHE was English and left my good friend Bismark to fan the flame I had kindled. Recent history proves how well our work was done. It broke your royal mother's heart, but I gained my purpose. The inherited disease of the Hohenzollern killed your father, just as it will kill you, and you became the ruler of Germany and a tool of mine sooner than I expected.

To assist you and farther hasten my work, I sent you three evil spirits, Nietzsche, Tritschke and later Bernhardo - whose teachings inflamed the youths of Germany, who in good time would be willing and loyal subjects and eager to spill their blood and pull your chestnuts, yours and mine; the

tective Orders," he said.

Moeller told the county commissioners that 11 states have addressed, or proposed to address, the protection of a family pet living with domes-tic violence. He said that leg-islation is expected to be proposed in New Mexico as well that would ensure protection for those animals that face the potential for abuse from violent family members.

"(It is) so that those ani-mals can be removed from the domestic situation and be put in a protective location where the offender cannot attack them, destroy them, kill them," Moeller said. "The cases have been horrendous. There have been batterers that have literally killed the family dog in front of a child, and other incredible cruelties.'

New Mexico Attorney General Gary King, author of the Family Violence Act, has proposed an amendment to that Act that would help to protect pets and domestic animals from abusive family members in the case of do-mestic violence. Moeller

"So that they can be re-moved from a domestic violence situation and be protected just like the woman and the children are," Moel-ler said, "and also permitting the shelters to accept the ani-

Moeller asked the county commissioners to adopt a resolution in support of state legislation for the protection of animals involved in domestic violence situations,

County commissioner Ei-leen Sedillo voiced a concern that such legislation might put additional burdens on domestic violence shelters, like The Nest in Ruidoso Downs, if the shelters were to be required to house the animals as well.

"There's no place to put the animals at The Nest," Sedillo said. "Is that going to make us liable for these animals?" she asked county attorney Alan Morel.

"I think what this does is support legislation that is yet to be drafted," Morel re-sponded. "I have a bigger concern with it just limiting." it to women, because domestic violence doesn't just involve women," he added.

Sedillo suggested that any costs resulting from the shel-

tering of animals involved in domestic violence cases might best be paid for by those who support the legislation.

We need to pay attention to this, if it does come up, to be sure that we don't become liable in some way," Sedillo

County commissioner Tom Battin reminded the board that the local shelters sometimes have to turn animals

Moeller argued that, with new legislation, domestic animals would be included in protective orders from the courts and placed in facilities that could accommodate them.

The county commissioners unanimously adopted the proposed resolution in support of new state legislation. The resolution acknowledges that 85 percent of domestic violence shelters indicate that animal abuse accompanies the abuse of a family member, and that 45 percent of women in dangerous domestic environments delay leaving out of fear that their pets will be attacked or killed. The resolution states Lincoln County's support for a provision that would include domestic animals in Orders of Protection.

You Read It HERE First

It was back in June, in fact it was June 26 when this column contained information that the national media was promoting one candidate for the presidency. Actually the column started with "what if" the national media was trying to skew the numbers instead of outright accusing the national media of doing just that. This column also had questions as to whether caricatures were on file that the national media would use when their candidate won.

Like it or not, the national media was one-sided in their reporting of the candidates and their running mates. They were in favor of one candidate and quite biased against the other candidate's running mate. Actual tallies of the one-sidedness have been published and it is no wonder that the national media's selected candidate won.

Lack of concern for the general public might be one way to describe this one-sidedness. Just last Friday the national medial interrupted the last three minutes of the programs being televised to break in and inform people that the president-elect would hold a meeting in 10 minutes. Apparently this was national media's way of even further foisting their one-sidedness on the public.

If we sound cynical, so be it. Will we be bombarded with interruptions of programs for other information such as that the president-elect is walking down a hall or that the president-elect is in the process of putting on a coat?

Being informed about national policy is one thing but to be told that the president-elect will hold a meeting is not quite in the same category as being told that a terrorist actually destroyed something. It is two months and seven days before the inauguration. Will we constantly hear of inconsequential things during this 68 + days of waiting?

Evidently national media wants people to know about what might or could happen, not what actually did. If this sounds confusing, it is. We believe that reporting should be reporting, not opinions passed off as reporting. And we believe that other than factual reporting is opinionated.

Rationale is that the candidates were trying to earn the votes of the people and national media skewed some of the information that may or may not have influenced the way people voted. Yes, the media has the right to endorse candidates, but it is our belief that beyond endorsing, other information should be very fair and quite factual.

And whether you agree with the results or not, the votes have been counted and winners declared. Now it is time to settle down to doing what is right, not trying to drag out the accusations and name-calling that was the main thrust of the elections, national as well as local.

Little did you know that published national reports on yesterday would indicate we were correct. The sad thing is that "You read it HERE first." We would prefer to have stated that national media was fair and not one-sided.

Lesser Prairie Chicken and Sand Dune Lizzard **Subject of Agreements**

Federal agencies to team with landowners, ranchers and energy industry to protect and restore wildlife habitat on state, federal and private lands

The U.S. Fish and Wildlife Service, the Bureau of Land Management and the Center of Excellence for Hazardous Materials Management have proposed to enter into an innovative, voluntary conservation program that encourages landowners, energy companies and ranchers to join the agencies in protecting and restoring habitat for the lesser prairie chicken and sand dune lizard in southeast New Mexico.

Included in the program are agreements for participants to voluntarily undertake or fund conservation measures for the species, which are candidates for protection under the Endangered Species Act. The Service recommends using the agreements to encourage conservation,

while providing greater certainty that if a species becomes listed as threatened or endangered despite their efforts, landowners will not be required to make significant additional changes in their activities on federal or non-federal lands.

SANTA FE -- Is the Republican Party dead? The question is being asked widely at the state and national levels. Some pundits are speculating that the GOP will go the way of the Whigs, who were replaced by the Republican party in 1856 as

being outdated. My answer is the same as it was last week. Republicans will come back. And if Democrats aren't careful it will be sooner rather than later. There was a similar euphoria 16 years ago after Bill Clinton won the White House.

The Democratic Leadership Conference, composed primarily of Southern governors and senators had forged a new Democratic Party based on centrist positions that would attract Democrats and Republicans alike.

Clinton had won his share of the Deep South and Border States plus four Rocky Mountain states. His message was compelling and he delivered it masterfully.

But in the first two years of his administration, the Clintons overstepped their bounds so far that Newt Gingrich was able to put together a new platform for the GOP that swept Republican majorities into both houses of Congress and kept them there for 12 years. Now that the tide has turn-

ed the other direction, some Republicans are suggesting that Gingrich be asked to lead another countercharge. At 65, Gingrich still has the

energy and enthusiasm to take on the task but he may not be the person for the job this time.

Republicans have long been the party of old white men and that's not selling well outside the Deep South, Appalachia, the Great Plains and some of the Rockies. It's not enough for a winning coalition.

Although some of the states are growing, the influx from the Northeast and the Rust Belt don't usually vote the same way. And these states don't have the large population centers and big electoral votes of the Blue States.

The soccer moms in the suburbs are changing their minds and beginning to vote more Democrat. The young never were with the Grand Old Party but most of them didn't voie so it didn't matter. But this time they voted. So did Hispanics -- the fast-

est-growing minority.
One can argue rural over big city values but the population is headed the other direction. The GOP must broaden its tent in order to continue winning elections. The focus this time was on appealing to its base, an ide-alistic group, unwilling to accept anyone but true believers.

Use of the term "the base" may not be wise either. The term has long been used by political scientists but a group of uncompromising Muslims has chosen the same name. My historical

"Uncle Sam" is getting ready for war and is preparing to meet everfy eventuality. No country, perhaps, ever entered a conflict so quietly, and yet determinedly, as the United States. While every department of the government is moving rapidly in all preparations, and people from every section of the union profering aid, either in money, equipment, plants and enlistment, yet there appears to be absolutely no excitement -- just grim determination to face the music and not look back.

Wealthy corporations -- the great steel plants. automobile factories and dozens of immense plants have either been offered the government fee of cost, or their products far below the ruling commercial price. Labor organizations have announced that strikes will not be countenanced while the nation is in peril, and every element seems to be woring absolutely in harmony with the idea that the interests fo the government ame first. With such a spirit, with such backing, with our untold resources the entry of this country into the maelstrom of war will have a decided effect.

District boundary, Candidates will file for and be elected to one of two positions. The candidate receiving the highest number of votes in each position number will be elected.



and the sand dune lizard uses habitat on intermingled federal and non-federal lands. Under the program a Candidate Conservation Agreement applies to federal agencies and ranchers or energy companies that lease lands

from the federal government.

A Candidate Conservation Agreement with Assurances applies to private landowners, state agencies, and entities leasing state lands.

Landowners who sign on to the Candidate Conservation Program could be asked to do some of the following: allow lesser prairie chickens to be placed on their lands; control mesquite which could impact habitat; make grazing modifications; modify fences to reduce collision by prairie chickens; avoid leasing habitat to energy development; keeping new surface disturbances out of dune areas; removing abandoned power lines; and, agreeing not to modify occupied and suitable shinnery oak habitat.

The Bureau of Land Management will work with the Service and CEHMM to identify projects and mitigation measures for landowners and companies that participate in the agreements. Earlier this year, the BLM com-pleted a Resource Management Plan Amendment for public lands in southeastern New Mexico to protect the species. The conservation measures to be applied under the Candidate Conservation program announced today will add to these efforts, and multiply the benefits to the two species. The mission of the U.S. Fish and Wildlife Service is working with others to conserve, protect and enhance fish, wildlife, plants and their habitats for the continuing benefit of the American people. About the Species: Lesser prairie chickens are grouse that use habitats with sandy soils supporting shinnery oak-bluestem and sand sage-bluestem plant communities in the high plains. The birds were common in the early twentieth century, but their populations have de-clined due to wide-scale conversion of the native prairie. The sand dune lizard prefers active and semi-stabilized sand dunes associated with shinnery oak and scattered sand sage. The oaks provide dune structure, shelter, and habitat for the species' prey base. Lizards are found in large dunes with deep, wind hollowed depressions called blowouts. They stay under vegetation or loose sand during the hot part of the day
