

Nogal Water Funding Denied

The continued efforts of The Nogal Mutual Domestic Water Consumers Association President Rick Rotert to improve the quality and quantity of water available to about 30 families in the small township met a snag in March.

During the regular March meeting of the Board of Lincoln County Commissioners, county manager Tom Stewart reported receiving word that a request for funding to essentially rebuild the association's antiquated water system and condemned

treatment facility had been denied by the New Mexico Department of Finance and Administration (DFA).

In a letter to county commission chair Tom Battin, DFA Local Government Division Bureau Chief Dolores Gonzales wrote that Nogal water system project did not meet eligibility requirements for the Community Development Block Grant (CDBG) for which it applied.

According to Gonzales, "there must be a substantial number of deteriorated or deteriorating buildings or public improvements throughout the area" in order

for the water project to be eligible for funding based on slum and blight criteria as was the water association's CDBG application.

The county will continue to assist the Nogal association in seeking financial aid for the needed system improvements, Stewart said on March 17th. Stewart said he faxed a document to the New Mexico Community

Development Council in hopes of finding funding for the project in monies allocated to the state through the federal American Recovery and Reinvestment Act of 2009.

"We're submitting under a different portion of allocation of funds under the stimulus package," Stewart said. "We're hoping that the Nogal domestic water project will be funded under this program since DFA made the determination that they are not eligible under the other program," he said.

"As the stimulus package has been published, all of the programs that are allocated are under a specific federal program that currently exists," Stewart explained. "For road projects it's all under local government type distributions. In this case, this program falls specifically under the rules of

the CDBG program. They're looking for projects that are ready to execute, and it appears that the Nogal water domestic project would be ready to execute within the time frame that we're concerned with," Stewart said.

Should the new request on behalf of the Nogal water association fail to get the needed funding, the county will still be able to submit a request for legislative funding in 2010, Stewart said.

Rotert told the county commissioners and county manager that he appreciated their efforts and willingness to pursue alternative avenues for funding, and indicated that the recent denial of funding might not be the end of that path.

"This disparity has provided a great deal of consternation not only to the association, but to the representatives from SNAHDD (Southeastern New Mexico Economic Development District) as well," Rotert said. "We've been given a number of explanations of the reasons for this disqualification, but they've been very unclear. It has been suggested to me that antiquated regulations were used to justify the disqualification," Rotert said. "We have repeatedly asked for clarification."

Rotert reported that a representative of the SNAHDD has made an appeal for the clarification of regulations, and "the explanation as to the reasons of those regulations to our representatives."

So far, the funding is not over at any level, but it is the county's hope that they are searching for funding in other areas, Rotert said. "We are in a very tight spot, we can be in a very tight spot, January 1st, 2010, we have been in a very tight spot, DFA," he said.

Governor Commits to Grocery Store

While he was in town last Friday to discuss the state's efforts to attract media production, Governor Bill Richardson also wanted to hear from Carrizozo citizens regarding capital funding priorities for 2010.

Richardson said that, due to budget shortfalls, the state legislature has less to offer in Capital Outlay funding this year, but added that New Mexico is better off than a lot of states financially and that things ought to improve by next year's legislative session. During a casual public meeting at City Hall, he asked the Carrizozo residents what they felt their needs might be in regards to future legislative activities.

"We're a little short of money, but we still have resources to be able to help and maybe there's some environmental or forest issues or tourism, that you may want to raise with me," the Governor said.

Fran Alteni, director of the New Horizons Developmental Center in Carrizozo, told Richardson that the Medicaid program for the disabled is vital to the welfare of the developmentally challenged residents of that facility.

Medicaid issues are always affecting us," Alteni said. "The impacts are great because we are the smallest residential developmental facility in the state."

Richardson told Alteni that, with the passing of the federal stimulus package, the state should be able to keep reductions to the Medicaid program minimal or possibly avoid cuts altogether.

Carrizozo Chamber of Commerce President Dirk Norris brought up the fact that the non-profit economic development group Carrizozo Works Incorporated

has been awarded some operational funding through the state's Certified Communities economic development program, but the funds have yet to be received.

"When you become certified, the state gives you \$5,000 to get started," Norris explained to the Governor. "Recently, I guess because of cuts, they contacted us and asked if we'd accept \$1,500. Our board members went out of pocket to be able to pay the \$750 we needed for the non-profit application, so even \$750 would be appreciated," Norris said.

Carrizozo Works Incorporated is a non-profit economic development group in Carrizozo, New Mexico. Richardson said that Carrizozo Works is a grocery store. He explained that it is difficult to attract new businesses and residents without a place to buy food locally. Dunnum said that Carrizozo has applied for \$350,000 in funding through a public-private program called the Smart Money Initiative, and that he'd heard that Carrizozo was listed in the top three projects for possible funding. The Smart Money initiative was initially established in 2004 to provide

loans to companies and individuals in under-developed communities for the creation of new businesses and new jobs.

"We're hoping that comes through, and if it doesn't we'll have to find some other way to get a grocery store," Dunnum said.

"Where do you get your food?" Richardson asked.

Dunnum explained that Carrizozo residents drive 20 miles to Capitan for groceries or 60 miles to Alamogordo.

"This is like groceries to eat," Richardson asked. "It's money taken back."

Dunnum said that the town could have made a lot more money from gross receipts taxes if the movie production crews that were working in Carrizozo for three months could have purchased food locally. He said that the funding bill that would provide the much needed start up money for the grocery store was in Santa Fe waiting to be signed. Richardson said that he would sign the funding bill.

"I'm going to sign it," Dunnum said.

You'll get your money, the Governor and Carrizozo Mayor Bob Hemphill said that, besides a grocery store, the town needs funding for streets. He told the Governor that Carrizozo has applied for a \$455,000 Community Development Block Grant (CDBG) for improvements to Airport Road. Richardson suggested that there may be other funding available through the state's Main Street program.

Flame Zamora, owner and operator of the nationally recognized Rock 'n' Roll Day Care Center, was awarded a grant from the state's Children, Youth, and Family Division (CYFD) last April. She told the Governor that she is still waiting for the Department of Finance and Administration to release the \$177,000 that will make it possible for her to

erect a new classroom building. The Town of Carrizozo has agreed to serve as fiscal agent for the funds.

Regarding the Governor Richardson Infrastructure Program (GRIP) which has awarded funding for road and highway improvements, the Governor said that 10 more projects have recently been added. Lincoln County Commissioner Tom Battin told the Governor that the county had been awarded funding through GRIP II to improve Cora Dutton Road, a heavily used school bus route that connects the Nogal area to Capitán, but the required matching funds from the county amounted to almost a million dollars, considerably more than the county could afford. Richardson said that there might be money in the federal stimulus package that could be allocated to Cora Dutton Road improvements.

Hemphill alerted Richardson to the plight of the Nogal Mutual Domestic Water Consumers Association, which has been very actively seeking funding to upgrade its water system. "The little community's been living off of one domestic well," Battin said. "It seems kind of impossible,

and we are having a little trouble right now with initial funding," Battin said. Governor Richardson said that he would look into all of the funding issues presented during the meeting, and headed over to a reception on 12th Street, the site of the filming of *The Book of Eli*.

Governor Discusses Film Production

Just as the set of the film *The Book of Eli* is all but gone from Carrizozo's 12th Street, New Mexico Governor Bill Richardson stopped by to discuss the value of attracting such productions to the state. In a town hall meeting in Carrizozo on Friday, the Governor and Eric Witt, the state's Director of Media Industries Development heard from Carrizozo residents not only their thoughts on having film crews in town, but their highest capital priorities as well.

"I was anxious to hear whether you thought the movie coming here was good or bad, could we do better in attracting these films, and your general impressions," Richardson said. "I also want to thank you for the great way that you received this film. I've heard from *The Book of Eli* people and they were enormously pleased with the hospitality," he said. "I came here to thank you for being good, hospitable friends to the movie industry."

Carrizozo Mayor Bob Hemphill told the Governor that having *The Book of Eli* filmed in Carrizozo was an excellent experience, that the film producers did everything they said they were going to do and there had been no problems through the course of building the set, filming and tearing the set down.

Hemphill said that, at the invitation of Michael Dellheim, location manager for the film, he and two town trustees were given a tour of the set that transformed the 400 block of 12th Street into a blown out, desolated, post-apocalyptic town. The mayor's grandson was hired to play an extra in the film.

"We had a great time," Hemphill said. Carrizozo Chamber

of Commerce President Dirk Norris told Richardson that he believed the whole town supported the production company coming to town, and that it had been a real pleasure.

Richardson reported having heard something about a pot luck dinner that Carrizozo residents hosted for the movie production crews and Norris filled him in on the details.

"When the first construction crew came to town we wanted to invite them, because they were going to be here for a couple months, and we wanted to let them know that they were welcome in our town, to answer any questions they might have, if we could help them out in any way and generally just be good neighbors," Norris said.

"We extended that hand and the chamber of commerce got together with Carrizozo Works, our local economic development agency, and came up with the idea of a potluck which was held over at the country club," he explained. "We had over 150 people show-up for the potluck. It was just a wonderful experience and time and again the crew came to us and said they'd never been welcomed like this in a town that they'd worked in before. That was a terrific feeling for everybody," Norris said.

"They spent money here, right?" Richardson asked. "Absolutely," Norris said. "They stayed in our motels, ate at the restaurants, bought gas; it was certainly an economic boon for the short term."

Norris said that housing provided some difficulties because the town only has three hotels.

"There were upwards of about 200 people here at times," he said. "They were

In a recent issue of the Lincoln County News there appeared an article written by Mr. Philip J. Rash, titled -- Who Killed Who in Lincoln County, N.M. and in the long list of 'Killed and Killers' were the names of George Parker and George Musgraves, the latter a notorious "Bad Man".

It may interest Mr. Rash (should this reach his attention) and other readers, to hear the story as it was told by an eye witness, taken from the Memoirs of my brother, Harry H. Aguayo, now deceased, who as a very young man-cast his lot with the cowboys in Lincoln County. He wrote the following story:

"The Murder of George Parker by George Musgrave Oct. 1897"

"On a warm October day riders for the Bloom Cattle Company held a cattle Roundup on the Feliz Canyon in Chavez County, N.M. about 63 miles South of Roswell. Dan Welch and I were riding the range together that day, when we noticed two men, their clothes ragged and torn, riding toward us. When they came closer we recognized one as George Musgraves who had worked with us a few years earlier. The other man was a stranger by the name of Bob Hayes, as we learned later.

"Musgraves called out to me goodhumoredly -- "Hello, Harry you're still here? You must be a good hand". "No, but I'm still here," I answered. He continued questioning me, "Who is the Boss here?" "George Parker." "Where is he?" "He's out on the drive." "About what time will he be in?" "In a while." "Who is the cook now?" "Sam Butler, the same as when you were here."

"Do you think he'll give us something to eat? We laid out last night and haven't had anything to eat." I told him I was sure Sam would feed them, so they rode down to the chuck wagon and we saw the cook set out the food for them.

"When they had finished eating they took out their Bull Durham tobacco, rolled cigarettes and sat down to smoke. By this time the boys had begun to drop in with bunches of cattle. Dan and I took over the cattle while the other men went to camp for drinking water. As the boys rode into camp the two outlaws began asking question of Sam Butler, the cook -- "Who was who? and Butler pointed out each rider by name, until the last three then rode into camp. Musgraves turned to me and asked, "Who are they?" I answered that one was Les Harmon, Block Iman and my good friend; one was Billy Phillips, VVman, and George Paker, our Boss in the lead.

"The cowboys' bedrolls were scattered all around the camp and Musgraves was sitting on a bedroll near the water barrel. Parker dismounted and walked toward the water barrel, nodding to Musgraves as he walked toward him; apparently not recognizing him. Musgraves stood up quickly and held out his hand as if to shake hands, but instead he pulled out his pistol and shot Parker four times. Parker fell, face down, and died instantly.


In the meantime all the cowboys had ridden into camp, including Dan and myself, after our herd had settled down for a rest. Most of the boys recognized George Musgraves, but none knew the tall stranger with him. When Parker fell this man drew his gun and turning to the boys said -- "Keep still, boys! I will kill the first man that moves," and he held the gun on the crowd of 15 or 20 cowboys until Musgraves spoke up and said -- "Boys, I don't want to hurt any of you but I came a long way to kill this -----! He has caused me a lot of trouble. He reported me to the Law for the

productions in individual homes and people had two or three workers staying with them.

Richardson said the state's financial incentives have been very successful in attracting film productions to New Mexico instead of other states or Canada, which he said is a big competitor for American film productions.

Witt told the Carrizozo people that the state offers a 25 percent tax rebate on every qualified dollar that film producers spend in the state, and offers an interest-free loan of up to \$15 million for projects costing \$2,000,000 or more to produce. The state also helps pay the crew costs in some cases, where mentoring programs train local workers in aspects of the production, and sometimes scouts for television production companies.

"A lot of our success beyond the strict financial incentives that we get is the folks like you that really make a difference in a film production," Witt said. "The reception that a production receives in a community is huge, it translates into the bottom line because it makes things logistically easier. When they're spending like they were on *The Book of Eli*, about \$300,000 a day, any cooperation that you get from a community eases production and keeps it going," Witt said.

He said that word travels throughout the film industry and that Carrizozo now has a great reputation as a good place to stage such

Richardson further suggested that a movie starring Denzel Washington will likely be a box office hit and draw even more attention to Carrizozo and New Mexico as a good place for film production.

"We certainly will promote you for future sites, and I would suggest that (through) your chamber and economic development, that be one of your facets, economic development and tracking films because right after *The Book of Eli* comes out you may see a whole bunch of movie companies look at you for future films," Richardson said.





Inside the Capitol

SANTA FE -- Film star Val Kilmer just won't go away. He keeps teasing New Mexicans about his desire to run for governor. Every time we almost forget him, he comes up with a statement that sounds a little more serious.

I've probably been to 10 movies in the past 50 years so don't know Val Kilmer from Patrick Swayze other than that both are Hollywood actors and both have had ranches in San Miguel County for many years.

So I did some googling of Kilmer to find out what kind of guy he is and whether there is anything in his background to qualify him to be governor of our state.

I learned that he's gained so much weight recently that people don't recognize him. Since I didn't recognize him before, I'm even with the world on that count. Kilmer says he gained the weight for a recent movie and he now knows that after 40 it is a lot harder to take it back off. He's now 49.

Evidently he is very serious about his business. He works hard, prepares meticulously and gets totally into his part. His first love is the stage and he's recognized as one of the best in either venue. Kilmer also is a singer-songwriter and even writes some poetry.

Most people report enjoying their work with him but a few don't. Kilmer says he works well with anyone -- who is intelligent. Uh-oh. Might we have a problem here? A hard charging, overweight governor who wants people to agree with him.

There may be more similarities. Richardson had rock star status when he returned to New Mexico after serving as United Nations ambassador and secretary of the Energy Department.

Kilmer is a movie star but he also could have been a rock star. He sang Jim Morrison's part in the movie "The Doors" so well that the original band members had trouble distinguishing him from the real thing.

The actor has some New Mexico roots. A grandfather was a gold prospector in the Gila Wilderness and is buried in Truth or Consequences. Kilmer has chosen to declare New Mexico as his home for the past 25 years.

He says he isn't interested in being governor for fame or notoriety. If that sort of thing was important to him, he would have lived in Hollywood all these years.

Kilmer says he loves his state and would be

comfortable representing its poor, hardworking, decent people. But will New Mexicans feel comfortable with Kilmer?

An interview with Rolling Stone back in 2003 won't help his chances on that count. The publication quoted him as saying, "I live in the homicide capital of the Southwest. Eighty percent of the people in my county are drunk."

Some New Mexicans contend Kilmer was kidding, which he sometimes does with reporters. State Sen. Phil Griego who represents the area where Kilmer lives, took him at his word and said he is welcome to leave San Miguel County.

Griego said Kilmer lives behind a gate and doesn't know his community. Since then Kilmer apparently has made an effort and says he is a responsible community member.

If Kilmer does decide

to run for governor, it will be as a Democrat. He recently changed his registration from independent. That means he will have to go to the state Democratic nominating convention a year from now and get 20 percent of the delegate vote in order to get on the ballot.

And that means getting to know not only his neighbors but the rest of New Mexico. Kilmer says he has an advantage because people want to meet him. But he will have to get to the right places to meet the right people and convince them he would be a good governor.

With additional nominating petition signatures, Kilmer can get on the ballot but no one taking that route ever has won a primary election.

And he'll have to beat Lt. Gov. Diane Denish, a native New Mexican who already has raised \$2 million for the race.
