# County Denies Road Variance

A request for a variance from the Lincoln County subdivision ordinance's requirements for road specifications regarding grade was de-nied by the Board of Lincoln County Commissioners fol-lowing a June 16th public hear-ing on the request.

Developer of the pro-posed five-lot Windmill Creek subdivision outside of Capi-

tan, Vic Currier of Currier Development, LLC, and sur-veyor Eric Collins of D.T. Collins and Associates pre-sented the request for a vari-ance from road grade require-

In a June 9th memorandum, Lincoln County Planning Director Curt Temple told the county commissioners that he believed a variance was not necessary.

"In my opinion, the

developer can conform to the that the plans submitted by the subdivision ordinance grades developer referenced only with some further design of minimum road standards and the existing plans, and not were not prepared by an engihave to have a variance for excessive grades," Temple wrote in the memo. "The de-

veloper has not shown that strict compliance with the requirements of the subdivision regulations would result in a substantial or unreasonable hardship to the developer."

Temple further wrote

were not prepared by an engineer as required by the ordinance. He referred to the language of the ordinance which

reads as follows: "Any section: proposed shall be based upon calculations providing adequacy. Referencing minimal criteria without appropriate engineering interpretations will not be acceptable."

According to Temple, one tract of land connected

with the proposed subdivision was split from the remaining. five at an earlier date. Temple

said that Currier is using the same restrictive covenants for the proposed Windmill Creek subdivision as were used for the previously divided tract which, in essence, amounted.

# State Coverage Insurance Back on Track

As talk of healthcare reform continues to create controversy across the country, a state and federally fund-ed medical insurance program designed for uninsured, working adults and small businesses in New Mexico is once again accepting new partici-

Scott Annala, Indigent Healthcare Coordinator for Lincoln County, briefed the Board of Lincoln County Commissioners on the progress of the State Coverage Insurance (SCI) program during their regular meeting of June

"I have great news about the State Coverage Insurance. It is up, it is running and it is going full-scale," Annala announced last week.

The SCI program began in July, 2005, with participation by Lincoln County citizens gradually increasing until funding ran out in September, 2008. The names of those wishing to enroll in the pro-gram as of September were placed on a waiting list until the funding issues were re-solved in February of this year. That waiting list grew to more than 10,000 names. Annala said, but they have all been processed and there is no longer a waiting list:
"They're wanting to

enroll as many people as they possibly can," Annala said.

The SCI program is authorized through a Health Insurance Flexibility and Accountability (HIFA) waiver from the Center for Medicard and Medicare Services, and will require another waiver in September to renew funding.

To be eligible for enrollment, applicants to the SCIprogram must be citizens and residents of New Mexico from the ages of 19 to 74 and of low to moderate income. Small businesses are encouraged to provide the coverage to their employees through a cost-share arrangement in which

the employer pays a portion or all of the premiums, which cost around \$90 to \$110 depending on individual income.

"Basically, if you make \$21,000 a year (or less), you can qualify for State Coverage Insurance," Annala said. "That breaks down to about \$1,800 a month, or if you make less than \$12.28 an hour," he added.

Annala said that there is some talk in the state legislature about having New Mexico counties fund the SCI premiums through their county indigent healthcare funds, a move that Annala anticipates would reduce the amount paid

out by the county fund for healthcare services. In theory, the county could pay about \$1,200 per year for the individual SCI premium rather than up to \$12,500 annually for treatment.

Annala said that he would assist anyone interested in applying for State Coverage Insurance. More information about the program is available through a web site at

half-dozen from Indiana and a now-retired ex-Indianapolis police officer now living in Colorado, will fly and/or drive to the Corona area and set up their station atop 8,637 foot Gallinas Peak.

From noon Saturday, Albuquerque time, to noon Sunday they'll operate three individual stations, transmit-

# **Ruidoso Downs Senior** Center Budget Cut

When county manager Tom Stewart received notification that the City of Ruidoso Downs would not provide funding for a driver and activities at the Zia Senior Center in that city, he offered the Board of Lincoln County Commis-sioners three alternatives to consider regarding operations at the center. Those options were discussed during the June 16th meeting of the county commissioners, with many interested citizens in the audi-

The loss of almost \$38,000 in support funding from Ruidoso Downs, \$33,000 for a full-time driver and \$3,000 for activities, could simply be added to the county's operational costs of running five senior citizen centers. However, the county is currently in deficit spending mode and with a dwindling

"In essence, we cannot survive such an uncompensated increase," Stewart said. "Under the circumstances, this is clearly not a practical solution.'

The second option, Stewart said, would be to close the Ruidoso Downs center, the busiest in the county, and use the savings of about \$225,000 annually to fund other needed projects including the Deer Park Valley Special Assessment District for which the county will eventually be reimbursed.

Option number three would be to eliminate the driver position that is no longing being funded by Ruidoso Downs, and find a way to consolidate transportation services to include the Ruidoso Downs seniors. Stewart said that Zia Senior Center Program Director Ada Hendryx was already working on the transportation reorganization.

Hendryx told the county commissioners that an alternative transportation service providing rides to hospitals in Albuquerque charges about \$300 for a round trip, a cost that most Lincoln County Seniors simply can't afford.
With the loss of funding for a
driver, she said, the biggest
problems will be getting seniors to doctors and hospitals in Albuquerque, Roswell, El Paso and Las Cruces, but also said that she believed the Carrizozo senior center driver could become the source of transportation for the Ruidoso seniors as well.
"I feel confident in

Mr. Stewart's recommendation of reducing one staff posi-tion, that we will be able to continue to serve the needs of the seniors of Ruidoso Downs," Hendryx said last week, "Hopefully, we can co-ordinate and consolidate some of those trips to Albuquerque, El Paso, Las Cruces and Ros-well, which are more costly than local transportation," she said. "I feel confident that we

can continue to provide all the services that are going to be required."

Hendryx said that she had recently received word that some additional funding from the Area Agency on Ag-ing will be provided to assist with the cost of providing meals to seniors. She said that a 2.25 percent reduction in state funds might be offset by some funding from the federal stimulus package. Hendryx explained that, while all of the services provided to seniors are equally important, providing nutritional meals to homebound seniors is the most criti-

In response to a question from county commis-sioner Jackie Powell, Hendryx explained that Medicaid reimburses a transportation provider for trips to certain doctor or hospital visits by qualified seniors, but added that most Lincoln County seniors don't qualify for the Medicaid bene-

"The (service) we provided helped those folks out, the ones that are not covered

by Medicaid," she said,
Powell commented
that eliminating the driver for
the Ruidoso Downs center
would also eliminate a duplication of services between the senior center and Lincoln County Transit.

Ruidoso Downs Mayor Tom Armstrong said that his community cares about its seniors, but is having budgetary problems of its

# Appointed to Planning Commission

During the regular meeting of June 16th, the Lincoln County Board of Commissioners approved one award of Lodger's Tax funding and appointed one new member to the Lincoln County Planning Commission.

A request from the White Oaks Arts Council was submitted to the Lodger's Tax Committee for \$600 to reprint

Committee for \$600 to reprint 30,000 brochures advertising Ruidoso area museums. 100,000 of the brochures were printed two years ago and are now gone.

The lodger's tax committee recommended approval of the funding and the county commissioners agreed.

Nogal resident Caroline McCoy was appointed to the Lincoln County Planning Commission after submitting a letter of interest to the county

An at-large appointment to that commission is pending.

to the creation of a six-lot subdivision. A subdivision resulting in six lots would fall into the category of a Type 3 sub-division for which the state and county requirements are more stringent and complex.
"There are discrepan-

cies in the restrictive covenants, and the disclosure statement about Tract 1 being in this development or out,' Temple continued.

Although the devel-oper indicated that the first divided tract is not part of Windmill Creek, there is a well on that tract that will be shared by home owners in the new subdivision.

"Just by looking at the submitted plat, it appears to be a six-tract subdivision," Temple wrote. "Tract I is being used just like the other pro-posed five tracts even though it was split out last year. This appears to me to be a common promotional scheme to circumvent our existing subdivision rules.

Beginning the June 16th public hearing on the vari-

ance request, county attorney Alan Morel said that some of the issues of concern regarding the proposed subdivision had been resolved, and the only topic for discussion during the hearing was the request for a variance from road grade requirements.

Collins told the county commissioners that the developer could not meet the rules of the ordinance without making significant cuts into the existing roadway. "We cannot, without

significant cuts into the existing roadway, meet the requirement by your ordinance to meet five percent (grade) 100 feet out of the intersection into the subdivision, and then go up at 10 percent," Collins said. "What we would like to request is to shorten that length as far as the 100 feet.

Collins said that com-pliance with county regula-tions would degrade the area, contribute to erosion problems and create an unnecessarily unattractive scar on the land-

Temple told Collins, "Cutting the road two more feet down, I don't see where that's a hard-

cut create a substantial hardship. I don't know if it's a hardship, but it does create a visible issue that I think you can take into consideration. You have to balance that with the health, safety and welfare issues that are involved. It does require you to find a physical hardship for the applicant," Morel said:

"Is the developer just trying to get out of doing it because he doesn't want to spend the money to do it, or is it something that, because of the topography, it would help if you didn't have to do as deep a cut, it wouldn't be as big a scar, it wouldn't look as bad?" Morel asked. "You can't do away with health and safety concerns in order to grant the variance, but if you can still look at the health, safety and welfare concerns and grant the variance, then the issue is solely whether it's a physical hardship," he ex-

Temple reminded Colcounty officials consider when hearing a variance request is whether or not compliance

# Billy's Bones Rest in **Peace**

FORT SUMNER, N.M. -- The dust and weeds covering Billy the Kid's grave in DeBaca County will not be distrubed.

Special Judge E.T. Hensley Jr. of Portales Tuesday denied a motion of Lois Telfer of New York City asking for a court order to move the bones of the famed outlaw from Fort Sumner to

The action orginated in Lincoln County largely through the efforts of the late Joe Sargent. who was a freind of Miss Telfer during her several visits to Lincoln County.

Miss Telfer, the only living relative of William Bonney, also known as Billy the Kid, made her request for the removal of Billy's bones because of what she called commercialization and neglect of the grave. The site, when visited by a NEWS reporter in January, was a shambles of broken fence, weeds and rubbish, hardly a

credit to any of the graves in the yard.

Judge Hensley said he denied the motion because it could not be determined which was Bonney's grave and which were those of two

friends buried near him. Louis A. Bowdre, a second cousin of one of the Kid's friends, testified that he wasn't certain which grave contained the remains of his relative. That's why he opposed the motion by Miss

Miss Telfer has 10 days in which to appeal the decision.

### Removal Attempt Made in 1925

Wilbur F. Coe of Glencoe, president of the Lincoln County Historical Society, wrote in a letter to the NEWS this week, that he favored reinterring the body of Billy the Kid in historic Lincoln Town, and "by this move great benefit will come to DeBaca County, as well as Lincoln County and the entire state of New Mexico."

### The Letter follows:

"I have read in the Lincoln county News several articles concerning the matter of removing the last remains of Billy the Kid from the Old Military Burial Grounds, near Fort Sumner, to Old Lincoln Town.

"It is true that the Kid was killed near Fort Sumner in 1881. He was buried in the Military Cemetary there because no other burial grounds were available int he vicinity at that time. The distance was too great to bury the Kid in Lincoln at that time.

"According to my father, Frank Coe, with whom Billy the Kid spent the fall and winter of 1877, in and around Lincoln, the only home Billy the Kid knew was in this area.

"Just because he was killed near Fort Sumner is no reason why some one of his relatives, or descendant of his best friend could not remove his body to his home ground -- Lincoln, New Mexico.

"It is fitting that Billy the Kid should be buried along side John Tunstall and McSween in Lincoln. Court records show that my father, Frank Coe, was a member of the Coroner's Jury when Tunstall was killed and he helped bury Tunstall in Lincoln, in the Spring of 1878.

"About 1925 my father made a special trip to Fort Summer to see about moving Billy the Kid's body to Lincoln, where he considered it belonged. Due to expense of the operation and poor transportation facilities he was unable to carry out his plans. My father died in 1931 still believing that Billy the Kid should be buried in Lincoln.

Since the removal of Billy the Kid's body to Lincoln is an issue at this time, I intend to exert







SANTA FE - The survey done for Lt. Gov. Diane Denish showing her demolishing former Reps, Heather Wilson and Steve Pearce in the gubernatorial race wasn't the only interesting political maneuver last

Albuquerque Republican Jon Barela has announced his candidacy for the 1st Congressional District seat currently held by Rep. Martin Heinrich.

Also present for Barela's announcement was Robert Aragon, a Democratic ward chairman and state central committee member who enthusiastically endorsed

Such surprises aren't. new for Aragon. In fact, they're not even surprises anymore. He has sided with Republicans anytime he felt it might be to his advantage.

The surprise was that Aragon's endorsement will be to his advantage. The chances appear good that Barela will face Republican opposition in next year's primary election.

Funeral home owner Kevin Daniels is said to be about ready to get into that GOP race, in which he is expected to be a strong candidate. Might Barela's warm relationship with Aragon be fodder for Daniels to use in strong Republican areas?

Barela obviously wants to show he can attract Democrat votes in the general election. But is this the time to demonstrate that?

The argument didn't work for former U.S. Rep. Heather Wilson in her Senate primary election battle with conservative Steve Pearce last year.

There appear to be some ties between Barela and Wilson. Barela has been endorsed by Bernalillo County Sheriff Darren White who also is a supporter of Wilson. And Barela is using the campaign manager White used in his unsuccessful contest with U.S. Rep. Martin Heinrich last year last year

Blogger Joe Mona-han says if Kevin Daniels does get in the GOP congressional primary, it will be an-other face-off between the two party factions still battling for power within the GOP.

If Barela makes it through the primary election. it isn't clear how many Democrats Aragon can attract for him in the general election. ragon's support of Darren. White last year didn't prevent a trouncing by Martin Heinrich. Aragon also supported Sen. John McCain.

Blogger Heath Haussamen quotes Aragon as saying he is a lifelong Democrat but always puts New Mexico first. Actually Aragon always puts himself first. Anyone who watched him while he was a state legislator or a regent of Eastern New Mexico University knows that.

Aragon's tenure in both positions was not lengthy. His actions in the state Legislature were such that he was beaten twice as an incumbent. He never was the powerhouse that his first

cousin Manny Aragon was. Barela held his news conference in Albuquerque's South Valley, saying that his deep roots in the area will help him attract the crossover votes necessary to beat Heinrich, whom he painted as a

Heinrich may be a liberal but his congressional voting record doesn't necessarily show it. He has voted against his party on some economic and budget issues

and on gun control.

He may have gotten passes from party leaders on those votes since his district can swing either way. He also may have gotten party help when the Armed Services Committee, on which he serves, voted to keep the 1,000 jobs associated with the 150th Air National Guard unit at Albuquerque's Kirtland Air Force Base.

Last month, I wrote about Gov. Bill Richardson being dubbed the "king of pocket vetoes." I observed that former Gov. Ed Mechem was no slouch in that field either. Pocket vetoes occur when a governor takes no action on a bill. I mentioned that some people thought Big Ed might have just been too lazy to go through all the bills sent him.

Mechem's daughter, Martha Vigil of Espanola, called recently to note that Gov. Mechem had four employees compared to Gov. Richardson's 40-some employees.



Koss got such a kick out of his getaway, including his visit to the International


