# New Policy to Address County Road Abandonment

Lincoln County's subdivision ordinance contains the necessary information for constructing roads that are to eventually be dedicated to the county, but the county has no written policies and regarding the closure or abandonment of

There has been some debate over the past few years about whether or not the abandonment of county roads and

subsequent release of the roadway property to adjacent property owners constituted a violation of anti-donation laws. With that thought in mind, the Lincoln County Board of Commissioners directed county attorney Alan Morel to draft a resolution spelling out an official policy for the closure or abandonment of road-

Morel told the county commissioners last week that the new resolution will identify the functions of the county's

road review committee, as well as establish methods for determining the value of land to be vacated and notification to affected property owners of a closure request.

With several changes to the draft pending, Morel said he still had questions regarding the fees to be charged for applying for a road abandonment, and the per-square-foot fees for the land vacated.
"In Ruidoso, they actually have

like 12 different fees they charge, based

on where the land is, because land has different values inside the city limits," Morel said. "Property next to the river is more expensive.

He raised other questions about the process of surveying land that might be abandoned by the county, whether the applicant should provide survey information at the time of applying or after the

abandonment has been approved.
"There's arguments both ways,"
Morel said. "If it's not approved, you hate

# Trinity Site Will

Trinity Site, where the first atomic bomb was detonated on July 16, 1945, will be open to the public Saturday, on October 3. There is no charge for the tour and no reservations are necessary. The historic site is open only two days a year, the first Saturday in April and the first Saturday in October.

There are tweentrances to Trinity Site:

The Stallion Gate entrance. Located 54 miles west of Carrizozo on US Hwy 380 and 12 miles east of I-25 on US Hwy 380, will be open from 8:00 a.m. to 2:00 p.m. Visitors are allowed to enter and exit unescorted any time between 8 a.m. and 2 p.m. through the Stallion Gate.

the Tularosa High School athletic field parking lot for departure by 8 a.m. This escorted caravan will arrive at Trinity Site about 10 a.m. and depart Trinity Site at 12:30 p.m. Those who wish to stay longer may exit through the Stallion Gate.

Photo ID will be required of all visitors to Trinity Site. Cameras will be allowed only at Trinity and McDonald House. Cameras must not be used on either of the drives from gates to Trinity Site. Vehicles should have a full tank of fuel and a spare tire because no services are available between the entrance gates. Visitors are encouraged to bring a lunch.

Trinity Site, the The Alamogordo 51,500 acre area which tour caravan will meet at was declared a National

Historic Landmark in 1975, includes ground zero where the atomic bomb was detonated, base camp, and McDonald ranch house where the plutonium core to the bomb was assembled.

Visitors to a Tinity Site Open House see ground zero, the Jumbo bomb casing, McDonald House, one of the old instrumentation bunkers, historical photos, a Fatman bomb casing and part of the original crater left by the explosion revealing Tinitie, the greenish colored glassy substance formed by the heat and pressure of the explosion.

## Carrizozo Could Have Temporary Police Officer

Carrizozo Mayor Bob Hemphili told the Carrizozo Town Council during its September 14th meeting last week that he would like to hire a member of the New-Mexico Mounted Patrol to serve as a parttime temporary police officer in Carrizozo.

As part of her monthly report and

in response to a question from town trustee Dennis Vega, police chief Rachel Weiser said that the Carrizozo Police Department responds to a variety of calls outside of the city limits, in areas that are actually the jurisdiction of the Lincoln County Sheriffs Department.

"The problem is, the sheriff's department is so widespread," Weiser said. "This side of the county is certainly not their priority when things are going on in other places. They don't always have deputies available to respond over here if they're in Hondo or Corona," Weiser said. "We kind of have this unwritten rule that if it's something occurring around the town area, we'll respond."

She said that the out of town calls can regard a matter as simple as a cow on the highway and Carrizozo officers are able to contact the livestock owner and resolve the situation more quickly than by having a sheriff's deputy drive from a long distance to respond to the call.

"But we've had some serious calls out in the county that the sheriff's department should have handled," she added.

In some cases, Weiser said, the Carrizozo police officers will respond to a call outside of the city limits and simply secure the scene until a sheriff's deputy

"If it's something that ends up being a DUI or an accident that needs to be worked, then we'll request a deputy and, at that point, they have to send somebody." she explained.

Vega asked if the Board of Lincoln County Commissioners could somehow establish an extended jurisdictional zone around the town and Weiser said that it could.

"The problem I have with that is

that (the sheriff's department) can become complacent. If we are county commissioned, they could just expect us (to respond)," Weiser said.

Following Weiser's report,
Hemphill told the town council that the

town has been using trained and certified officers of the New Mexico Mounted Patrol to assist the police department when needed.

"Right now they're not being paid," Hemphill said. "I would like to hire one of these certified mounted patrolmen occasionally so our town has coverage if the other officers are on vacation or some-

Hemphill said that two of the town's police officers will be out of town for training later this year, leaving the department with only Weiser to cover the

"That leaves one officer to cover the town 24-7," Hemphill said, "If the chief and one of the two officers were gone, that would leave one officer to cover 24-7 for sometimes three, four or five days," added.

Vega said that he would like more

time to research the proposition.
"We're strapped for money, and then hiring some temporary police officer," Vega commented.

"It would be very temporary, not another part-time officer," Hemphill explained. "It would be very limited."


The mayor explained that, in actually being hired by the town, a Mounted Patrol officer could patrol alone, rather than merely serving as back-up for Carrizozo police officers:

'I am not comfortable with an officer being out there by themselves if they are not hired by the town of Carrizozo," Hemphill said. "They need to be hired by the town of Carrizozo, but hired for a very

limited duration."

Vega again questioned whether or
not the town should expend money for another part-time police officer, and Hemphill explained that the new officer's pay would come out of the already budgeted line item for part-time police offi-cers' salaries.

for them to spend the money on a survey, but you really need to know exactly where it is and what the square footage is to know how to treat it if you do approve the abandonment and vacation," he said.

Property value would likely have to be determined

on a case by case basis, Morel said, depending upon whether or not the property includes any improvements.

"The way this policy is set up is up to \$2,500 it's just going to be a price per foot, but once you hit \$2,500 the policy provides for an appraisal that has to be done to determine the actual value of the property to be abandoned or received." Morel said

or vacated," Morel said.
"\$2,500 seems to be the number where the state
has a significant interest in the asset and whether you're getting appropriate value. When you hit \$25,000, you have to get Department of Finance and Administration (DFA) approval to sell the property, a completely separate statu-tory requirement," he explained.

There are basically three different requirements depending on the value."

County commissioner Dave Parks said that there are essentially two kinds of roads to consider, those that have been constructed and used by the public and those that have been platted and dedicated to the county but

never actually constructed or used.
"It seems like there's a big difference between taking a road that has been maintained and used, as opposed to something that has never been installed or used by the county at all," Parks said.

Lincoln County Assessor Paul Baca told the county commissioners that his office could do an initial assessment of land to be vacated by the county by estimating its

size and reviewing current sales prices in the area.

County commission chair Tom Battin pointed out that requests for road abandonment in the past have included property in remote areas as well as near subdivisions, and properties can vary greatly in value.

Morel added that, in Ruidoso, land values range from 99 cents to over six dollars per square foot.

"If this were a road out in the middle of nowhere that was 50 feet wide and a quarter mile long and requests.

that was 50 feet wide and a quarter mile long, and requested to be vacated, at 50 cents a foot it would be \$32,000 for that little segment of the roadway," Morel estimated. "It's not likely it would have that kind of value."

Baca said that his office has seen land values in Ruidoso reach \$14 per square foot, and up to \$1,000 per linear foot along the river. He said his office would agree to assist Morel in determining the appraisal requirements and associated fees for properties of less than \$2,500 in

Morel told the county commissioners that it is going to become more expensive to have property owned by the county abandoned or vacated. Historically, there has been no expense associated with the process and landowners have benefited by acquiring at no charge land once owned by the taxpayers. The new policy will put an end to that.

"You're going to have to pay the initial filing fee, which is set at \$250," Morel said. "You're going to have to pay for an appraisal which could be upwards of \$300 to \$500. You're going to have to pay the square-foot cost, whatever that may be, based on the assessor's estimate or based on an appraisal. You may see a lot fewer road clo-

sures in the future," he said.

There will also be costs for having a completed survey and legal description of the land to be vacated if the vacation is approved by the county's board of commission-

The Lincoln County Planning Commission will review applications for road abandonment. The information will be passed on to the county's road review committee, which will examine the property and make recommendations to the county board.







budget session of the New Mexico Legislature, appears headed for late October, according to Gov. Bill Richardson, who gets to make that decision. Lawmakers hoped for an earlier session but they and the governor are not as close to agreement as had been anticipated. Richardson wants a three percent across-the-board cut of all agencies, excluding edu-cation. Lawmakers want a four percent cut everywhere.

Both parties had generally agreed to no fur-loughs, no layoffs, no tax increases and use of some more surplus funds. But legislative leaders want to take a more cautious approach than the gover-nor. They want to look more than a year down the road. Richardson only has a year left in office.

It isn't pleasant cutting close to nine percent out of a \$5.5 billion budget but some states have had to trim more like a quarter of their budgets.

Big states and big cities have been hit hardest, along with states that were developing rapidly. That includes some of our neighbors. California, Arizona, Nevada, Las Vegas and Phoenix have suffered greatly.
California has had

to lay off 28,000 public employees so far. Almost half of those are teachers. Arizona has had to lay off 4,300 public employees. In Nevada, layoffs total 2,200. Layoffs nationally total over 111,000 including employees, 40,000 teachers and 4,000 police and firefighters.

New Mexico. Delaware, Arkansas, North Dakota, Oklahoma and West Virginia have reported layoffs in the sindigits. Gov. Richardson and lawmakers both seem determined to avoid layoffs and they hope to avoid furloughs if at all possible.

In several states public employee unions have agreed to furloughs in return for a guarantee of no layoffs. But many aren't so lucky. Hawaii, on top of 1,339 layoffs, has mandated that state workers take three days of unpaid leave per month for the next two years.

The Center on and Policy Priorities indicates that 48 of the 50 states face budget shortfalls and the total

before it gets better.
At this point, federal stimulus money is helping many states avoid additional layoffs but that isn't likely to be continuing. If that stops before state economies turn layoffs around, will. increase.

Nineteen currently are furloughing employees. On top of California's 28,000 layoffs, all employees must take unpaid leave every other Friday.

In New Mexico, Gov. Richardson has appointed five members of the executive branch to sit down with legislative leaders to work out a suitable plan to present to the special session of the Legislature.

The five members are Department of Finance and Administration Secretary Katherine Miller and Deputy Secretary Dannette Burch, Taxation and Revenue Secretary Rick Homans, and the governor's deputy chiefs of staff Eric Witt and Paul Ritzma.

Gov. Richardson has provided them with a five-point plan to get discussions started. In addition to three per-

disagree-With ments such as these ahead of the joint committee, it is possible there will be no agreement before the special session. In that case, a quick weekend session now envisioned by the governor could last as long as 30 days.

Decisions need to be made soon. The judi-cial branch of government has already indicated it already is on the edge with the two percent cuts already imposed by last winter's session. Last week the state temporarily bailed out a district court but that can't continue.

# Looking Back

Through Our Old NEWS files'

As the LINCOLN COUNTY NEWS goes into its, 105th year of being in existence (1905-2009), we will again be randomly publishing articles from old NEWS files. The following article appeared in the Lincoln County News

Friday, September 30, 1955

#### The Lost Mine at White Oaks

by Ted Raynor

It was about two o'clock one afternoon in the early 1890s when John Owens drove into the gold mining town of White Oaks in a covered wagon, leading an extra horse that he matched in races. Owens was out of money and he had to find work.

That night he stopped in at Whiteman's store, where miners met to talk over the happenings of the day. He edged up to the mine foreman and asked for sich Was he a miner? Owens replied he wasn't but

a job. Was he a miner? Owens replied he wasn't but he had strength and brains to do what a man told him to do. "I cannot use you unless you are a miner," the foreman said. A man sitting on the counter overheard the conversation and told Owens he needed help in digging a well in the Collier pastures. The job would

start next morning.

There probably would have been no story of the lost mine at White Oaks if the foreman had hired Owens.

Some 25 years later -- in 1919 -- Owens, former sheriff of Lincoln County, was having dinner in the home of Mr. and Mrs. D.L. Jackson, pioneer res-idents of White Oaks. After Owens had complimented the Jacksons on their baked sweet potatoes and had guessed rightly that they were grown at Portales

## Looking Back

Jackson asked Owens if it were true that he had made a gold find a few miles northeast of White Oaks in the 1890s.

"I will take an oath," Owens said, "to tell the truth, the whole truth and nothing but the truth," This is Owen's story as Jackson remembers

hearing it.

The day after I started helping this man dig the well he told me to take my two horses two and a half miles up White Oaks Spring Canyon to the spring. It was the only watering hole in that vicinity and the horses would have to come there for water.

We worked up to Saturday evening on the well. The man told me that on Sunday I could rife my race horse up to the spring and find my work horses. I found the tracks and followed them in a northeast direction. It was slow tracking, and about noon I stopped for lunch and tied my horse to graze in stirrup-high gramma grass.

I sat down on a rock which looked as if it had "grown" out of the ground. After lunch I picked up a stone and broke several pieces off the rock I had sat on. The broken pieces were yellow. I had never seen gold in a rock and I didn't know what it was. I put a piece of the rock in my hip pocket and spend the rest of the afternoon hunting for my horses. I came back to camp down Coyote Canyon.

Thursday afternoon, my boss, who was working at the bottom of the well, asked if I had heard about the new gold strike at the Old Abe in Baxter Mountain. I told him I found a mighty pretty piece of rock Sunday while I was looking for my

horses. "Send it down in the next bucket," he said.
"You got this rock at the Old Abe?" the boss called up to me. I told him I'd never been to the Old Abe. "Can you find the place where you got this rock?" the boss shouted.

"What is it?" I shouted.
"Gold!" he yelled. "Pull me up."
"I'll go to the livery stable and get a horse, and you take your race horse, and we'll ride out there," the man said. "First, we'll go to White Oaks Spring, keeping track of your work team and follow the tracks of your race horse which has small shoes.'

We took that route and rode until it got dark. At daylight the next day we went back to that vicinity, put in the whole day, scarcely stopping to take a drink of water from the canteen. When night came we still hadn't found the place, but I had found the paper bag I had my lunch in Sunday, though it probably had blown quite a ways from the rock.

We hunted every day for a week without results. By that time news of the find had leaked out, and men were as thick out there as flies around a pan of molasses. So many miners took off from their jobs to hunt for the rock that the mines had to shut down.

After about two months the searchers gave up. Then a peace officer in White Oaks said to me:

"I'll tell you what I'll do, I got a bunch of goats, I'll build a shanty and a corral. You run those goats on shares, half and half. Going over the ground every day, following the goats, you're bound to find the rock.

I accepted the proposition. I ran those goats a year on shares and by that time I feld myself getting "batty" so I gave up the goats.

But Owen, who died in Corona in the late 1930s, continued the search for years. Jackson said Owens would return to White Oaks several times a year to look for the rock Jackson himself has guided strangers on many searches.

What Owens found was a rock cropping. That cropping from which he idly broke off a few pieces some 60 years ago is a few miles northeast of White Oaks. No one knows exactly where. And whether it would have been as rich a gold strike as the Old Abe or the North and South Homestake Mines probably never will be known.
