Improvements Continue in National Forest

Lincoln National Forest Smokey Bear District Ranger Buck Sanchez appeared before the county's board of commissioners on November 17th, during its regular meeting, to update the commissioners on forest projects and programs in the area.

Sanchez's presentation came just after a discussion of alternative energy resources in the county, and he said that the Forest Service stands in support of efforts to bring clean, renewable energy to Lincoln County and the southwest regions of the United States

"As we're sort of the majority landowners in the county, the Lincoln National Forest, we cer-tainly have a role in energy and the environment and economic issues that affect the county," Sanchez said. "You should expect the Forest Service to work with you at this level to bring programs and projects that are well integrated with what you'd like to do as you go for-ward with that sort of thing."

Sanchez touched on two projects planned in the Bonito Lake area, the Bonito Forest Restoration Project and the Bonito Corridor Recreation Project, which he said would be among his priorities for the upcoming year. The environmental assessment for the first Bonito project is scheduled for completion in time to hold a public comment hearing sometime in January, 2010.

Sanchez said the State of New Mexico, Lincoln County, the City of Alamogordo and the

"That is a project to do thinning, logging, watershed and fuels reduction treatments in the Bonito watershed," Sanchez said. "We're looking at about 16,000 acres of the 28,000-acre watershed. I'm hoping to make a decision on that project sometime in 2010, and implementation would working on a comprehen-

The Smokey Bear District plans to initiate the NEPA process for the Bonito Recreation Corridor project sometime in 2010 as well. Sanchez reported. He recommended that the Lincoln County officials work with representatives of Alamogrado and the Forest Service in collaboration about how to best manage recreation on national forest and municipally owned lands in the Bonito . Canyon/Corridor area. He said that he is

"We've worked off and on over the years with the City of Alamogordo: they own close to 2,000 acres there where the lake and campgrounds are," he said. "We recently pre-pared an assessment that looks at some of the apportunities in the national forest, and would like to invite the county to be involved in the collaboration, because there are issues at the county level around recreation, around law enforcement and those kinds of things that I think

Navajo Jake and the Bear

Navajo Jake used to live along the bank of the San Juan River at Farmington. He was one of the persons who helped Farmington grow up by working on construction jobs. During the last few months of his life one of Navajo Jake's chief interests was a big brown bear in a cage at Woods Dance Hall about two miles east of town.

John Arrington Sr., Farmington old-timer, first took Jake to see the bear, and after that the Navajo visited and talked with the captive animal two or three times a week until his death around 1933.

Navajos claim they can talk with bears, Arrington says, and from the caged bear's actions it certainly seemed that the animal understood Navajo Jake. At times the bear appeared to

be crying.

When Jake came to visit his friend the bear, the animal would walk up to the edge of his cage and sit down. In Navajo, Jake would tell the bear how sorry he was that he was in captivity, for he knew that bears, like the Navajos, loved their freedom. Jake regretfully said he could not free the bear because teh Americans would kill him or lock him up if he opened the cage door so that his friend could escape.

As Jake expressed his sorrow in Navajo

to the attentive bear, the animal would nod or shake his head, look sad or wipe his eyes as though he were crying. Sometimes the bear made a noise that sounded like "hmmm" indicat-ing that Jake's words should be thought over

The Baby-Stealing Panther

Many years ago, when he was a small child in Hayes County, in the eastern part of Texas, S.L. Renick of Truth or Consequences heard the story of the baby-stealing panther.

This is the story as Renick remembers it: A ranchwoman returned to her house and found her baby gone. An alarm was spread, and a man brought his dogs to the house. The dogs picked up a pant her's trail and followed it for two or three miles until they came to a pile of leavers. The owner of the dogs and the other men

with him found the child asleep in the leaves in which the pantehr had hidden the infant.

Battles Over REAL ID Continue By Ruth Hammond

The battles about REAL ID and reasons for and against it are heating up. The interesting thing is that much of the rhetoric is the same on both sides.

Regarding the issue, one side states that the state is foolish to allow everyone to get a drivers license, including illegal aliens. That side asks why the state can't follow the rest of the country and issue licenses to legal citizens. Apparently that side is not aware that 36 states aren't participating in REAL ID.

It seems that some of those disagreeing are not keeping upp with what is happening nationally. It also seems that both sides object to anyone needing a passport to cross state lines. However, that appears to be what will happen in the next three weeks or so.

Before you fire off a heated letter, stop and find out what the issue is. One side mentions Russia requiring papers to cross state borders but neither side seems aware that carrying papers to travel from place to place was in effect in WW II, a long time ago.

Unless they have lived in a secluded place, these people should have had access to information about WW II and the havoe and how people had to sneak out of countries and request asylum for safety.

Listening to some of the gripes, it gives the impression these people consider themselves above the law, not that they should become involved. It is this type thinking that keeps awful things happening.

And many complaints have nothing to do with the issues that should have been addressed long ago when Congress was considering the REAL ID. Now the complainers want to know why there isn't a viable license at a reasonable cost for everyone available.

The entire situation will get worse before it gets better. There may be an extension for meeting the deadline of December 31, 2009, but that only prolongs the situation. And in actuality the REAL ID act can be enacted at any time with no warning at all,

Instead of trying to get a passport at a high cost just to be able to visit family in another state, it might be best for people to contact US Senators and Congress members and ask for a reprieve. Keeping the nation safe is one thing, but it should be sensible.

On the other side, consider whether REAL ID is in conflict with state rights and whether Congress sould reconsider the entire thing. Ask them about it.

Not everyone disagrees because one person with a valid drivers license went to another state and got a REAL ID and is legal to travel where he wants.



SANTA FE -Herewith are some random thoughts that crossed
my mind while floating on
the Amazon recently.

When the Uni-versity of New Mexico hired football coach Mike Locksley, it obviously wanted to hit the big time with more wins and national recognition it never has received.

That recognition came quickly with a botched investigation of a charge that Locksley had hit an assistant coach. ESPN quickly was all over it.

The lesson here is that internal investigations don't work. "We've investigated ourselves and found no problems," is something the public just isn't willing to accept any longer.

UNM isn't the only culprit. The military does it and so do police departments Over the years, I have talked with local police in several communities who say they dread being assigned to internal investigation units because they know they are supposed to protect their buddies even if they

know they're guilty as sin.

New Mexico has had its problems with disciplining guilty police. The Law Enforcement Academy Board can take action against local law enforcement officers who are reported by local police chiefs or sheriffs.

The problem is that almost no reports are made. The LEA Board also is empowered to hear citizen complaints but has not done so because it does not have the time or staff.

At times the board has even claimed it doesn't have the authority to deal with problem officers. Complaints by courageous citizens such as Paul Borunda of Las Cruces have forced Attorney General Gary King to issue a letter acknowledging the LEA Board has that authority.

Last month, Sen. Tim Eichenberg pulled out of Democratic lieutenant governor race. His departure was a surprise because money wouldn't have been a problem for him and he was the only non-Hispanic in the race.

Eichenberg told one source that he didn't want to make the investment because he didn't think current Lt. Gov. Diane Denish could win the gubernatorial race.

When the com-

ment became public, Eichenberg softened his words but it caused people to wonder if maybe Denish's campaign had applied some pressure on Eichenberg because he wasn't the right balance for the ticket.

How can Americans put any credence in the frequent scoldings by former Vice President Dick Cheney in which he constantly admonishes questioners to "remember?"

"You must remember" prefaces a large number of his arguments to justify actions of his administration. But his great memory completely failed him when called to the witness stand to explain how it was revealed that Valerie Plame was a CIA spy.

The revelation

ended Plame's career. She and her husband, former Ambassador Joe Wilson, and their children are now New Mexico residents.

Plame's outing came just days after her husband revealed in the New York Times that he had not found the evidence President George Bush wanted of Iraq trying to buy uranium from Niger.

To paraphrase Mark Twain, reports of the New Mexico GOP's death have been greatly exaggerated. When our state turned blue again last year, the New Mexico Republican Party was said by many to be in shambles.

Fundamentally that was wishful thinking.
True, New Mexico's Republican majority in Congress suddenly

A Unique Story

Friendships struck up among soldiers, especially in war time, are often unique. Reconnecting with old comrades in arms has a special meaning: old memories, good and bad, come crashing back as the years and decades melt away. That's what happened to Dan Scott of Carrizozo just before Thanksgiving.

A letter arrived from a man whose name he did not immediately recognize. But with it came a news clipping

and a picture that Dan says "hit me right between the eyes." It was picture of Dan as a 19 year old Spec. 4 taken in Vietnam in 1967. Pictured with him was "Shadow," a handsome German shepherd.

Dan and Shadow were a "scout team" with the 25th Infantry Division. The 1967 news clipping noted that Dan and Shadow were an "inseparable pair."

The sender of the letter was Gary Burnside. Burnside had donated Shadow to the U.S. military and while Dan and Shadow were in Vietnam, had corresponded with Dan.

Burnside's letter explained to Dan that he had sought for a long time to reconnect with Dan and finally had made the connection through the "Vietnam Dog Handlers of America" of which Dan is a member.

The 1967 news clipping quoted one of Dan's last letters to Burnside: "I wish this letter didn't have to be written, but I know you'd want to be the first to know. Last night we got mortared. Shad was hit here in Dau Tiang when two enemy mortar rounds came through the roof of the kennel. When I got to him he was dead. This morning I buried him beneath the trees. I'm going to make a headstone and put a little white fence around his grave. I feel like part of me is

Dan told Burnside about happier days. After Shad was killed, Dan said, he wrote a poem that recalled a better moment with Shad.

His unit had set up camp in a big field we were to use as an "LZ (landing zone). "I took off his collar and let him run through the grass chasing butterflies, and always looking back to see if I was coming." Dan sharedwith Burnside the poem he wrote to memorialize Shadow:

RAMBLIN' **AROUND**

by PAUL BAKER

An interesting bit of history on the building of Eagle Creek Lodge is contained in a newspaper clipping given us this week by Mrs. T.E. Kelley. Mr. Kelley was one of a committee who worked on the project of selecting a site for the proposed lodge of the Southwestern Fish, Game and Forest Protective Assn. Mr. and Mrs. R.E. Lemon and the George Dingwalls were also charter members of the Association, E.A. Orme-Johnson is the present secretary and treasurer of the organization.

"An Open Letter to the Public" written by S.L. Squier, secretary, in 1918, follows:

Since the founding of the Southwestern Fish, Game and Forest Protective Association about 18 months ago, its directors have been constantly engaged in looking for, and negotiating for a suitable location for the erection of a Club House as set forth in article V. of the Constitution and BY-LAWS of the Association. The first idea of the Association was to locate in the Gila National Forest, to purchase or lease land for the propagating of game and fish. After careful investigation, it was found that the price of such a place and cost of building a road to it was prohibitive, therefore the idea of locating in the Gila National Forest was dropped and other locations looked for where the expense would not be so great in construction of roads and the hauling of building material to the place of building the Lodge. After looking through the mountains of the Lincoln National Forest, our Directors decided on the North Fork of Eagle Creek as being the most logical location that could be found, and negotiations for a lease and building permit was at once begun with the United States Forest Service, and six months after our application was mailed them and a number of letters exchanged, we succeeded in getting through a fifteen year lease on a tract of land with a permit to build a lodge, and I am glad to inform our members and the public in general, that we have let the contract for the building material and have contract for the building material and have engaged a force of men to do the road work and expect to have this building completed within sixty

National Forest and the Mescalero Apache Tribe have been working together since 2006 on the 16 Stewardship Springs Project, the first Forest Service stewardship project under the authority of Tribal Forest Protection Act (TFPA). The TFPA permits the federal government to enter into contacts and agreewith Native ments American Indian tribes for work on public lands bor-

tribal lands. Sanchez reported.

He said an additional 5,200 acres were added to the 16 Springs project in 2008. The project is designed to reduce the threat of wildfire, improve watershed and forest conditions and limit the spread of invasive insects and disease.

In 2010, the Forest Service plans to treat about 4,000 acres within the Smokey Bear District with a combination of mechanical thinning and

"We're looking at a transition out of the usual forest-thinning treatment options and getting more into the maintenance of the thinning that we've done," Sanchez said. "We've treated thousands of acres and done millions of dollars of work over the last 10 years. To maintain that is going to require a concerted effort, whether it's prescribed burning, the of techniques. The things

The Forest Service has produced free maps of the Lincoln National Forest access roads, a use of herbicide or hand result of its recent grubbing; there's a variety reassessment of travel management within the

"This is a culmination of a couple years of work, the Forest Service Travel Management Regulation," Sanchez said, "to examine our motorized road and trail system. Lincoln National Forest didn't change our travel management system very much, so what we ended up doing was to make a notice of compliance with the federal regulation," he added. "These are roads that open to the public. This is the avenue that will provide information to the

public."

Sanchez said that the public roads within the forest will be fitted with signs whenever possible. but the new maps are the best source for knowing which roads and trails are available for public use.
The maps will be updated annually, he said.
"We'll be request-

ing input and advice from the county commissioners and others as we go forward on an annual basis to decide if we want to add roads or take roads off this system," he said.
