A Splendid Showing.

Statistician Dodge, of the government agricultural department, has just issued some official figures on western agriculture for 1889 which makes a very gratifying exhibit for our fair yet much-maligned territory, says the Santa Fe New Mexican. Figures which will prove of especial interest to a large class of our readers, not only the friends of statehood, but also to the hundreds of people at home and abroad who are now engaged in making it possible to enlarge the cultivatable area by the construction of irrigation enterprises. These figures show what New Mexico has done while handicapped in a manner that no other section of the union has ever been called upon to fight against; they make it plain that New Mexico will advance despite every obstacle, and when one considers that more than a million of dollars are now going into new irrigation companies which will reclaim within a year more 200,000 acres of New Mexico valley land, some idea of New Mexico's outlook from the standpoint of horticulture and agriculture may be arrived at. Statistician Dodge's figures for the corn crop are as follows;

Acres planted—Colorado, 42,883; New Mexico, 56,279; Utah, 35,175.
 Bushels raised—Colorado, 1,092,000; New Mexico, 1,126,000; Utah, 644,000.

Value of crops—Colorado, \$663,373; New Mexico, \$665,463; Utah, \$392,050.

The result of the wheat crop is from a more extended territory, as follows;

Acres planted—Colorado, 87,300; Nevada, 87,396; Arizona, 25,630; Idaho, 81,457; Montana, 85,000; New Mexico, 36,225; Utah, 111,878.

Bushels raised—Colorado, 1,851,000; Nevada, 335,000; Arizona, 337,000; Idaho, 1,140,000; Montana, 1,519,000; New Mexico, 1,096,000; Utah, 1,880,000.

Value of crop—Colorado, \$1,332,557; Nevada, \$251,250; Arizona, \$252,818, New Mexico, \$300,000; Utah, \$1,410,025.

The following is the estimate of the oat crop;

Acres planted—Colorado, 97,791; Idaho, 5,725; Montana, 85,337; New Mexico, 16,608; Utah, 39,668.

Bushels raised—Colorado, 3,129,000; Idaho, 1,000,000; Montana, 2,278,000; New Mexico, 340,000; Utah, 916,000.

Value of crop—Colorado, \$1,251,125. Idaho, \$40,135; Montana, \$1,134,382; New Mexico, \$142,602; Utah, \$412,408.

It will be seen that in quantity and value, excepting oats, of the three grains estimated, New Mexico ranks with Colorado and Montana.

ALGER IN THE RING.

Gen. Russell A. Alger, commander-in-chief of the Grand Army of the Republic and possible candidate for the presidency, was at Washington a couple of weeks ago with his wife and daughter. A correspondent of the Philadelphia Record furnishes his paper with the following spicy interesting correspondence regarding Alger's presidential aspirations:

Alger's public business here is to inspect the G. A. R. posts and to help on the G. A. R. efforts at pension legislation. His private business, of course, is to inspect the presidential field and to help on his own presidential boom. He understands that next year is 1891, and that the year after is 1892, and that tempus keeps fugiting. He proposes this time to make all his preparations early. His experience in 1888 was a costly lesson, but it was thoroughly learned, and by applying its teachings he expects to get his money back in presidential salaries. One thing that he learned is how to spend his money, which is perhaps the most important lesson of all. He understands that being a recognized millionaire, with railways, banks, and other evidences of wealth in full view of the public, he must spend money. But he knows that it is not economy to spend it as lavishly as he did before, and that it is not wise to spend it so recklessly. For example, he will not "buy his niggers" (to use the phrase of one of his competitors) so early in the day. They are not "honest as honesty goes in the New Jersey legislature," to quote the wit of Camden, for they will not "stay bought." He has learned, too, that personal persuasion goes further than money.

He is traveling over the country now in his special car formally inspecting G. A. R. posts, and informally making personal alliances for 1892. He has accomplished a surprising amount of work in this direction. He has apparently captured the leaders of the G. A. R., and the followers, too, as no other politician but John A. Logan has ever had them. In this effort he has had the assistance of Mrs. Logan, by the way, and of course Corporal Tanner and Private Dalzell. Naturally enough, the men, who for any reason are disappointed with President Harrison, have flocked to Alger's standard, which is the only one as yet unfurled in opposition to Harrison's. So it is that Alger has secured the support of Col. William Wade Dudley, and most of the other claim agents here.

More Stolen Stock.

Mention was made in last week's Enterprise of the arrest on the Gila of Frank Murray, George West, Harry Tacket and A. C. Dolores, with twenty-four head of stolen stock in their possession, besides three fine stallions which they were riding. Soon after their arrest Sheriff Whitehill intercepted a postal card from R. L. Morgan, an employe of Head and Heart's, in charge of Cow Springs ranch, asking Frank Murray to come and take away ten head of stock horses left at Cow Springs. This was a clue for the wily sheriff, and he sent down for the horses, subpoenaing Morgan as a witness. The stock was brought in and is now in the sheriff's charge. No reflection was cast upon Morgan in the transaction, as he is understood to be a first-class man, simply allowing Murray to leave the stock there until he could send for it.

On Monday West, Murray and Tacket were turned over to Sheriff Barola, of Dona Ana county, where they are wanted for a theft committed some time ago.

Since the capture it turns out that West and Murray are well known hard cases, and are badly wanted in Arizona and that a reward of \$1,000 is offered by Arizona parties for the capture of West. If this is correct the parties making the capture are in luck. The parties consisted of Deputy Sheriff Bud Moore, A. C. Windham, Steve Nickson and Frank Richardson, the three latter being up from the lower Gila, having come to town for the purpose of attending a stock meeting. They volunteered their services to assist in the capture, and left this city with the deputy about 12 o'clock Tuesday night making the arrest on the Gila early the next morning.

The recovery of the ten head from Cow Springs, with those found in the possession of the thieves on the Gila, making 37 head in all, is a capture of considerable importance. The capture of the thieves, however, is of far more importance and the chances are that it will be many years before they again come into the possession of other people's property.

The deputy sheriff and the three citizens who effected their capture deserve some recognition and consideration from the stock association which meets in the city to-day. —Silver City Enterprise.

Depew's First Fee.

For forty years after the supreme court began its work the fees of a lawyer were not so large as they are now. In fact, the most eminent attorneys received no more than \$25 for drawing briefs and presenting causes to juries. Those were the happy days for the client. Nearly all lawyers died poor. A rich lawyer at that time was as much of a novelty as a rich literary man is now.

How different at the end of this century? It is a common thing now-a-days to hear of attorneys receiving \$150,000 for the reorganization of a railroad or for organizing a trust, and queerest part of it is that his clients look upon him with a respect commensurate with his charges. Moreover the community applaud the attorney's moderation.

Clients are most illogical. They reason from no known commercial basis. In the early days of my career as a lawyer I wrote an opinion for a client and timidly asked \$5 therefore. He grumbled a great deal before paying it. Then he took the opinion to a famous New York advocate to find out whether it was all right. The advocate glanced over it, wrote across the first page the word "correct," and asked \$500 for his work. My client paid the sum gladly, and is yet talking about the kindness of the great advocate.

For the first legal paper I ever drew I charged \$1.50. A farmer was my client, and he beat me down to \$1. Twenty years afterward I wrote a paper precisely similar and received for it \$500 with many thanks.

Frank Burk, for several years clerk of the Santa Fe at El Paso, has robbed the company of about \$100,000 and pulled his freight. No man in the employ of the company was held in higher esteem than he. The thefts have been going on for over a year, and it is estimated that the returns for more than 200 cars of freight were never turned in to the company. Only a couple of months ago Frank and a traveling auditor had quite a row over a difference of \$235. Frank told the auditor that he was a chump and knew nothing about book keeping, and the sequel shows that he was correct. The day before he left he drew \$50,000 from the bank, sent \$20,000 to headquarters and got away with the balance. The rest of the money he is supposed to have squandered on women and wine. He spent money with a lavish hand, which was accounted for by the thin statement that he was winner at cards. He left his wife \$3000 in cash and a home in her own name. He is only twenty-four years old, and is said to be an exceedingly able young man.—Enterprise.

Washington, 12:45, p. m., Feb. 28.—In the corridor of the house, just now, ex-Congressman Taulbee was shot through the head by Charles Kincaid, reporter of the Louisville Times.

THE WOUNDED KENTUCKIAN.

Washington, March 1.—Ex-Representative Taulbee, who was shot yesterday afternoon by Charles F. Kincaid, is resting easy this morning. He is still at providence Hospital. At 10 o'clock this morning his physicians said there was no material change in his condition. It is thought he will recover.

The Responsibility.

Prescott, A. T., March 1.—The work of burying the victims of the late disaster is about completed. Thirty-nine bodies were recovered and identified while ten other persons are known to have been lost. Property at and below Wickerburg is badly damaged, but no loss of life occurred. It is impossible here to fix the responsibility of the accident further than that the dam was not properly constructed for the purpose for which it was intended. Adequate means for the escape of water in time of a flood were not provided.

Stockmen are much excited over the amount of stock thieving now going on throughout Grant. Said President Fleming, of the South West Stock Association: "The number of stock now being run off or killed by thieves in this and adjoining counties is alarming. I believe there are more stock thieves in the territory to-day than ever before. It looks as if the courts can't take care of them, too, when captured as a jury will seldom convict these fellows unless it is clearly proven they were caught in the very act of slaughtering or running off the stock. It may be shown that the stock found in their possession was stolen, or that meat and hides found in their wagon does not belong to them, yet this will hardly convince the average jury of their guilt. Now, it is very seldom, as you will readily understand, that these desperadoes can be caught in the act—they are too watchful for that. If stockmen can't secure their conviction on any other conditions there is little use in capturing them at all. Something must and will be done, tho', to put a check to this stock stealing—on this point stockmen are fully determined."—Stock Grower.
