**GRAND JURY REPORT.**  
In the Third Judicial District Court, Lincoln county, April, A. D. 1890, term.

To THE HON. JOHN R. MCFIE,  
Associate Justice of the Supreme Court of the Territory of New Mexico, and presiding Judge of the Third Judicial District Court thereof :

SIR.—Your grand jury, impaneled at the present term of court respectfully report that having investigated as far as the limited time allowed us would permit, all violations of the law brought to our knowledge, we have reported by indictment in all cases where the evidence justified.

We have returned some thirty indictments, for various offenses, many of them being for the unlawful use of deadly weapons. The large majority of the violations of the law prohibiting the carrying and use of deadly weapons, is properly chargeable to transient persons, coming into our Territory and county from adjoining states, many of them fugitives from justice, who attempt to practice here the lawless acts which drove them from their former homes. The prompt and vigorous enforcement of the law which such persons encounter is no doubt a revelation to them; instead of finding lawlessness rampant and a lawless community, governed by the Winchester and six-shooter, they find a peaceable, law-abiding community, composed of men who revere the law and have the ability to enforce it. Thus, while there is an apparent increase of crime, such crime is not to be charged to the bona fide citizens of this county, but rather to those whom we have alluded to as transient persons.

Your grand jury acting on your honor's suggestion, appointed committees to examine the books of the county, and to investigate the conduct of several of the county officers, as to the manner in which they carried on public business. The reports of the committees, having been adopted by the grand jury, are made a part of this report.

To the Grand jury :

Your committee appointed to examine and report upon the affairs of the county as shown by the Probate Clerk's and Sheriff's offices, respectfully report, that owing to the limited amount of time at our disposal, it has been impossible to obtain as full and extended a statement of the county finances as we would desire, and the people expect; but, with the valuable assistance of our efficient Probate

Clerk, we are enabled to make a report showing the indebtedness of the county, which is in our opinion correct.

**GENERAL NEWS.**  
From Various Sources.

**Plans of a Road Which Pleases Jay Gould.**

While Jay Gould sojourned in Dallas, he was approached by Mr. O. L. Houghton, of Las Vegas, N. M., with the plans for a railroad from such an unexpected source that he was willing to examine them, and of such a valuable nature that he called in his engineers to advise him.

With these plans Mr. Houghton went to Dallas to meet Mr. Gould. He called on the magnate and was granted an audience of half an hour. He unfolded his plans which contemplated a line southeasterly from Cerillos to Aransas pass. As far as the representative of the express could learn, the road makes as nearly a straight line as possible, Draw a straight line from Los Cerrillos, N. M., to Aransas pass and it will be found that San Antonio is on it.

Mr. Gould informed Mr. Houghton that he would consider the matter. The next day he sent for the gentleman and talked to him again about the plans. Mr. Houghton went away rejoiced, but he was joyfully surprised when on the third day the great railroader again sent

for him. This time two engineers were present and went over the plans with Mr. Houghton. They evidently thought favorably of the matter, for upon their report Mr. Gould took the plans home with him and Mr. Houghton expects to hear something in the near future.

Two considerations must have prompted Mr. Gould's interest. In the first place he believes in deep water at Aransas pass and intends to be there when the ships come. In the second place he sees the value of coal, not only for his Texas roads, but at the station of Aransas pass. Such a road as is contemplated would not only reach the coal at Cerrillos, but would skirt the vast coal beds around White Oaks, N. M., near the Texas border. —San Antonio (Texas) Express.

Geo. O. McCarty the well known livestock dealer and ranchman has just concluded the purchase of the cattle and personal property of the Black Range Cattle Company, from Chas. I. Davenport, of Silver City. He has also secured a lease on the ranches and ranges belonging to the company. Mr. McCarty is a thoroughly practical stockman and knows how to handle an enterprise of this kind. The cattle are all improved stock and the ranches are the best in the celebrated Black Range country. The consideration was \$70,000. —San Marceal Reporter.

Judge O'Brien passed upon the meat inspection law at Las Vegas, Saturday, declaring it void, just as every court in every state has done. The bill like the famous libel law, lottery law, and others, never possessed a particle of common sense, justice or practical force. It seemed to be the desire in fact, that a lot of these measures should serve but one purpose—to illustrate what an ass a New Mexico legislature can make of itself. The Democratic Central Committee of Lincoln County held a large and harmonious session, at which the several calls for conventions were promulgated that appear in this issue of the INTERPRETER. The Democrats of Lincoln county have thus early issued the various calls on account of the new county organizations and the determination to make a thorough and harmonious canvass. The party at present, is in splendid shape, and at the approaching election in November, will elect its ticket from top to bottom. The candidates for the various county offices in all the counties are gentlemen well and widely known, and at the approaching election, the factional difference heretofore existing has been eliminated. There is but one sentiment expressed, to forego all past differences and present a solid democratic front, whatever strife there will be, will be of the good natured kind in the conventions which in their wisdom will nominate such candidates as the citizens of Lincoln county will be pleased to vote for. The legislative nominations this year are of the utmost importance and at the Roswell convention in August, only good and strong men will be placed in the field. Our republican friends are already at work through Rynerson, Riley & Co., manipulating political affairs in Lincoln county, with a view to carry the three counties for their henchmen. Some weak and half bred democrats, who at heart belong to the Republican fold, have been tendered the nominations on the old plan to claim to be a democrat, but when they get to the legislature, Catron Rynerson, Riley et al., own them body and soul. Democrats of Lincoln county do not propose to be cajoled in the manner heretofore practiced. Lincoln, Chavez and Eddy, legislative district, must and will be reliably democratic this fall, local interests demand it, and from indications at present from all parts of the Territory, the next legislature will have a fair democratic majority despite the unfair apportionment.

Hoar's Federal election law is likely to be talked to death in the Senate.

Among the democrats mentioned as possible candidates are, J. P. C. Langston, Thomas Eubanks, and Capt. Roberts, for sheriff; Lucas, of Lincoln, Probate Judge; W. Taliaferro, and J. K. Byers, both of Lincoln, Probate Clerk; V. H. Lusk, of Weed, and Thomas Henley of Nogal assessor; J. E. Wharton, of Nogal, Co. Sup't of Schools.

It is generally conceded that the Treasurer's office and one Commissioner will go to the Mexicans.

The various aspirants are all well known men—of course at this early date, men will come and go as candidates.

We will endeavor to give our readers all the latest and most reliable news regarding the coming campaign, and the INTERPRETER is for the Democratic Ticket nominated, in the meantime, any candidate is at liberty to express himself through our columns.

We cannot say more in the matter of a new chairman than to quote what the Deming Headlight has to say:

"Mr. Harvey B. Fergusson, of Albuquerque, is talked of in connection with the chairmanship of the Democratic Territorial Central committee. It may be said for Mr. Fergusson that he is a good organizer—well balanced, shrewd, conservative, yet energetic—qualities that fit men for leadership."

The INTERPRETER would like to see this selection made and the gentleman accept.

**DEDICATION OF THE CONGREGATIONAL CHURCH.**

Last Sabbath morning, as the shadows receded back and up into the mountains, the decoration for dedicatory services of the new Congregational Church, was completed by placing a large number of blooming house-plants, on and around the pulpit and windows, which in addition to the evergreen wreaths that had already been artistically arranged upon the walls, added to the attractiveness of the house to be set apart for the worship of God.

At the opening of the services, as the notes of the organ were born upon the balmy air of that beautiful Sabbath morning, the large congregation joined heartily in singing the Doxology. Rev. A. M. Pipes, of Deming, N. M., invoked divine blessing on the services of the day. Rev. S. W. Thomas, of the M. E. Church of this place, then read the first scripture lesson, and a second lesson was read by the Rev. Mr. Pipes. Rev. E. Lyman Hood, Supt. of Home Missionary Society, preached the dedicatory sermon; Dr. N. W. Lane, the pastor, offered the dedicatory prayer, which was followed by the dedicatory service proper. The ordinance of the Lord's Supper was administered, the benediction pronounced.

The Trustees of the church and the building committee made a report of their labors, showing that the new church was to be built under contract with P. C. Bell. That he was to receive \$350, in money and the parsonage, belonging to the church, which was valued at \$1,000. That Mr. Bell, failed to fulfill his contract and the trustees were obliged to pay \$1,850. Twelve hundred of which had been paid and the balance was provided for and would be paid soon.

The failure of Mr. Bell to complete his contract, leaves the parsonage in the possession of the church, thus giving it a good stone church, 30x50 feet and a six room adobe parsonage. Both are situated on well located lots, almost in the heart of town. All of this property has been secured since the early spring of 1887, when the parsonage was built, and the lot on which the church now stands was purchased.

Much of the financial success of this Church is due to the Ladies, who have labored so faithfully, to build up in this community a building that would be sacred to the cause of Christ's kingdom—we doubt not the happy conclusion of the services last Sabbath, amply repaid them and all others who aided in its erection. The furnishing of the house is not completed, but will be soon.

**CATRON'S PURCHASE.**

Some time during February last Hon. T. B. Catron began negotiating for the purchase of an immense library in the City of Mexico, and having succeeded recently in closing the trade, has now in his possession one of the largest and most costly collections of books in this portion of the country.

The library consisting of about 3,000 volumes, was collected and owned by the Rev. Father Augustine Fischer, once private secretary to Emperor Maximilian. Father Fischer doubtless stood at the head of all bibliographers with respect to Spanish-American, and particularly in the branch of Mexican literature. In the course of his forty years' residence in Mexico he devoted a great deal of time to studying, sifting and collecting everything that could be obtained in the way of prints and manuscripts relative to and coming from our sister republic. During that period he formed four large libraries the last of which is now in Mr. Catron's possession. The other three have long since been sold and scattered over the country, and the one at Santa Fe is the only complete Fischer library in existence in the world. The literary treasures contained in this vast collection of books are valuable beyond a price, and few libraries will equal it in the matter of ancient and modern Spanish law.

In making this purchase Mr. Catron made a sacrifice, but in so doing he is entitled to the highest credit for the perspicacity and energy displayed by him in securing the much-coveted treasure, one that has been sought after by men of nearly all nations. Santa Fe and Mr. Catron may well be proud of having one of the leading libraries in the United States.—New Mexican.




