 Held at Lincoln, Lincoln county, New Mexico, July 6, A. D. 1891, it being a regular term thereof.

Minutes of last session read and approved.
 John K. Candler is hereby appointed Justice of the Peace for Precinct No. 9.

Now comes T. B. McCourt, School Superintendent, and files new bond as required by this Board at their June meeting thereof, examined and approved.

By an order of this Board made at last meeting, ordering Clerk to notify Herculano Chavez, Constable in and for Precinct No. 1, to file a new bond; the sureties of said Chavez having filed with the Board a petition praying to be relieved as such, and the said Chavez having been duly notified in the premises and failing to give a new bond as required so to do, therefore, the office of constable in and for Precinct No. 1, is hereby declared vacant, and there being no constable for said precinct, the Board appoints Jose Torres y Sedillo as constable and is ordered to qualify according to law.

Now comes C. R. Beideman and files petition asking to be rebated on \$430.00 erroneously assessed on taxes of 1891; considered, and ordered that the same be rebated from the original assessment.

M. V. Jeffers rebated on 150 head of cattle.

Lea Cattle Co. rebated on 1211 head of cattle from 10,000 head; rebated on 207 1/2 acres of land from \$2.50 to 1.25 per acre.

Petition of Three Rivers Cattle Co., asking to be rebated on the amount of cattle raised by the assessor, rejected.

Board adjourned till 2 o'clock p. m.

Pursuant to adjournment Board met at 2 o'clock p. m.

C. W. Wingfield is hereby appointed assessor for Lincoln county, and ordered to qualify according to law.
