





 Dear Vic and All,
 First, Vic, please send us the Ruidoso News. Check enclosed. It won't reach us for a week or so, but even old news is good news from Ruidoso.

Needless to say, we miss all the wonderful people in Ruidoso already and are looking forward to some of you, at least taking your next vacation, here. We've already found many interesting things of show you, which are unobtainable or overlooked by the tourist guides. They do a wonderful job, however, of entertaining and showing the major sights.

Today, Sunday, we went to see the Lurline dock (5-minutes from where we live). It was a very exciting experience. The Matson line goes into detail to make it nice for their passengers. The reception was with leis, hula dancers, bands playing and a very hearty welcome from the natives. These people are real artists at making the tourists feel wanted.

Then we stopped at the fishing docks where many native fishermen were catching what they called "pot luck", and we could see why they called it that. Blue, green, yellow, red all sizes and shapes of fish. We made friends with some of them and they told us where to go to buy a \$1.00 pole, some line, hook, and some Aka (Tuna) belly for 10c a bait. We did. Being old trout fishermen, we proceeded to thread up and cast in. One of the natives looked very sad, shook his head and said, "You not catch fish that way. Malahini (newcomer) I show you." He rethreaded the line placed it a certain way in the water and was quiet—more pleased with the situation. Very nice people.

A place the tourist guides are not allowed to go is the National Memorial Cemetery of the Pacific. It is one of the most beautiful and impressive places we have ever seen. Indescribable, but certainly worth every effort to see it. Carved row after row in marble columns are thousands and thousands of names of World War II casualties that "only God knows their resting place." It gives you a renewed pride and remembrance of what all these young men died for.

Another place we found was the Peleliu Cultural Center. You and Joan would especially enjoy this. The charge is \$2.00 for admission into the Center, but it is well worth the price. The Mormons own the land and rebuilt, life-sized, authentic replicas of the villages of Tahiti, Fiji, Samoa and others. They bring families from these islands to explain their cultures, crafts and habits. They are only allowed to stay two years. With the profit from the tours or any monies received, they give scholarships to the students in these islands so they can come to Hawaii to school. The buildings of each island are somewhat different in design, but mostly made of bamboo and grass and very practical. One had their floors made of bamboo so the air would come up through and keep it cool. Also, they didn't need a vacuum cleaner as all the dirt went through the floor, and the fishermen could bring their nets inside to drip dry. Each village has to furnish at least two of their native dishes for the banquet served at night. Then they have their various native dances for about 1 1/2 hours.

Even with a terrific traffic problem here in Honolulu, there seems to be a lot of driving courtesy. They have one freeway and others planned, but the speed limit is 38 mph, which makes for very pleasant driving. Lots of public parks, kept very clean and beautiful.

Things are shaping up fine concerning the insurance business. Quite a bit of waiting for security clearance to military bases, clearances with insurance Commission, etc., but glad to see they are cautious.

possible to bear our own burdens without at the same time helping others to bear theirs.

Individual burdens; yes, each of us have burdens that we feel that we alone must bear. But there are mutual burdens in which we must all be willing to share and the law that lightens these burdens is the law of God as set forth by his only begotten son Jesus Christ. I would like to call our attention to a very short poem by an unknown author and I quote, "That very law which alms a tear, and leads it trickle from its source, that law preserves the earth a sphere, and guides the planets in their course."

"Turning again to the seventh verse of the text, "Be not deceived; God is not mocked; for whatsoever a man soweth, that shall he also reap." God's, Almighty Power. Even as the sun shall surely rise in the morning, so shall a man reap that which he sows.

This brings us to the truth that man shall not glory in himself for that which he reapeth of himself is but short lived. Vividly the apostle reminds us that there is but one glory, and the stain of that glory was firmly implanted on the cross with the spilled blood of that glory. Had any other died on his cross it would have been still a gallows. Christ dies there and the cross becomes a shrine! Christianity is the religion of the cross. When we remember how much there is in the Bible about the cross of Christ, and think how little we hear about it in modern times, we may well wonder if we are not in danger of glorifying in other things and need to say with Paul, "God forbid that I should glory save in the cross."

Let us think of the glory of the Cross and set ourselves against the tendency of glory in anything else. The Cross has about it the glory of its own loneliness. The cross gives us a new conception of God. It rises above every other object on the horizons and worldliness and seems to reveal the light of that which is eternal.

Another glory of the cross is its mystic and super-natural power—it has a power quite beyond us. There is a mystic power to attract—account for it is you may—there is a strange power in the preaching of the cross.

It seems to demand an interest when all other subjects fail. The cross is eloquent in its power to convince the judgment and confirm our faith. It stands out in history as a lustre undimmed by the passing of centuries and un tarnished it stands a symbol of the Church, built upon the rock that the One who made it a lifeline is the son of God.

Yes the cross was once a hideous instrument of death; it is now invested with a solemn beauty that fills the heart with the hope of eternal life. It also reveals the infinite love of God. Read John 3:16. And God commanded his love toward us in that while we were sinners Christ died for us.

Myths About 'Billy the Kid' Debunked In Latest Book

Jesse Evans in Lincoln County. He recounts the Kid's entry into the vicious Lincoln County War of 1878; the ambush slaying of Sheriff William Brady on the main street of Lincoln town to which Brent's uncle, Bonifacio Baca, was a witness; the five-day siege at the Alexander McSwen home in Lincoln; the famous escape of the Kid from the Lincoln County courthouse in which two deputies were slain; and the Kid's death in Fort Sumner in 1881 at the hands of Garrett.

Here are all the dramatic events in Bonney's life told with the ring of truth and historical accuracy. As the book unfolds, Brent also attempts to give the reader an insight into Bonney's character and personality. He tells of the Kid's utter disregard for most other people, his drive to achieve stature as a badman, his reputation as a pathological liar, his fierce and changeable moods and his capacity to kill without the slightest hesitation.

While Brent admits that Bonney probably killed at least 11 or 12 men in a four-year span, none was slain in the oft-glorified western tradition of the stand-up gunfight. According to Brent, the Kid killed from ambush or shot from behind and only faced a victim when the cards were stacked in Billy's favor.

Brent seeks to bring life to the book's characters by use of conversation. In his foreword, he asks readers to accept this dialogue as reasonably correct. With a few exceptions, when the dialogue reads like a third-rate western, the author has used the device effectively.

Brent makes no claim to being an expert on Billy the Kid or the Lincoln County War; but his book makes it evident he's as close to this classification as anyone ever will be. He's done an honest, readable job and the book is a valuable addition to any western library.

As Brent puts it: "This story may fall flat on its face . . . but if it does, it won't be through a lack of factual data . . ."

These were some of the statements from the growers at the fruit meeting held last week at Hondo. Other ideas brought out were that either the grower has to raise a quality apple that can be packed or he had better pull the orchard out as it will not pay to raise low grade wormy apples.

Steps toward producing a quality apples are:
Frost—Whether you use smudge pots or not you have this as one of the problems. With smudge pots properly used you can protect your orchard to somewhere around 20-22° F.

Pollination—Many old orchards are straight Red Delicious which are self unfruitful. You need a pollinator. Most of the newer orchards have one row in four as pollinators generally Golden Delicious or Jonathan. I am going to recommend that any new planting have one row in three for better pollination. In ten years you will get more Red Delicious using pollinators than straight Red Delicious.

Insect Control—Recommendations are on an acre basis and if you do not use the proper amount per acre you cannot expect control 450 gallons per acre. This will be covered thoroughly at a meeting on Feb. 11 with Drs. Nour, Bryant and Coppock.

Recommendations of all were incorporated in the sketches. He showed drawings of floor plans and elevation sketches of the new school structures. The first stage in a series of

school buildings would include three buildings—two classroom buildings, each with six classrooms (three on each side), and with a covered "commons" area between them, and with restrooms—and utilities room at each end—and a third building to serve as a kitchen and cafeteria with administration offices. They would be connected with covered walkways and would have asphalt parking areas. They would be located in a triangle, but would be at one end of a future school complex. Buildings in the future would match the first three in architectural style and in function. Should the entire plan be completed as proposed, as many as a dozen buildings would be in the pattern.

The classroom buildings were drawn with optional sliding sound-proof partitions between rooms or with solid soundproof partitions—the final choice to be made by the board—probably based on cost. The removable partitions could allow for double size classrooms for combined classes to hear lectures, view motion pictures or other combination studies and teaching.

The cafeteria is designed to feed 160 students, and the capacity could be increased with minor changes in the structure when additional classrooms were built. The classroom buildings each would have a little more than 9,000 square feet, the cafeteria structure a little more than 7,000 square feet.

Buffington estimated that if the bonds to build the school were voted Feb. 16, and contract was let by March 25, the buildings would be ready for occupancy the middle of January in 1966.

He outlined costs to taxpayers on the bond issue if retired in 5 years, at 3% interest, as being \$11.67 per \$1,000 valuation, or \$6.31 per \$1,000 valuation with interest at 3 1/2% in

10-year period.
(In Friday's school board meeting, it was decided to issue the bonds on a 10-year retirement plan.) It was pointed out that if the bonds are not passed in the Feb. 16 election it will be two years before another election can be held.

Discussion of the site during the latter part of the meeting brought a remark from Supt. White that the location was no more dangerous to the school because of possible falling aircraft than the present high school site. "We are in a pattern at present of planes leaving and arriving in Ruidoso. The new site east of the airport is outside the pattern for landing and taking off," he declared.

He also discussed an attack by some trustee candidates on Ruidoso's high school, in their claim the school is not accredited. "We are accredited—students can get the proper credits in Ruidoso High School for entrance in any college or university in our state. They can earn more than the required credits here to enter any institution of higher learning—in fact we have graduates who are attending college in several other states as well as in New Mexico."

"We have brought our standards up considerably in recent months, and are almost to the point of securing North Central affiliation—or accrediting but we must improve our classrooms—we must stop using substandard classrooms to get the final North Central approval. We are accredited in other ways—with the state particularly, despite what some people may have been told," he declared.

102 Cooperators Are Assisted With Soil Saving Projects

The U. S. Department of Agriculture's Soil Conservation Service assisted 102 co-operators of the Upper Hondo Soil and Water Conservation District in planning and carrying out conservation measures on the land in fiscal 1964. Gerald Gordon, Work Unit Conservationist for the Soil Conservation Service in Capitan, said 12 new conservation plans were prepared in the Upper Hondo Soil and Water Conservation District during the period. These covered 30,732 acres. Another 10 plans covering 16,132 acres were revised and updated during the year.

The following is a listing of some of the conservation measures applied to the land: 6,077 acres of brush control; 439 acres of Conservation Cropping System; 1,716 acres of deferred grazing; 607 acres of irrigation water management. 66,128 linear feet of irrigation pipeline; 313,852 acres of range proper use; 49 acres of pasture planting; 189 acres of pasture proper use.

Soil mapping was recently completed on 20,000 acres of land in co-operation with New Mexico State University on the Ft. Stanton range. Two land owners in the district made plans for recreation enterprises, part of nearly 13,000 who did so nationally.

GAME AND FISH NEWS

Next month hunters will turn their attention on javelina as the season of this small, wild pig gets underway in New Mexico. The season opens on Feb. 20 and runs through the 28. The area open to hunting includes all of Hidalgo county and those parts of Grant county which lie west and north of the Olla River and south of U. S. Highway 70-90.

The limit is one javelina, either sex, and the shooting hours are one-half hour before sunrise to sunset. Two hundred licenses are available and the fee is \$10 for residents and \$25 for non-residents. The same application is used that was used for the 1964 elk and antelope hunts. It is available at all local vendors or in the Roswell office at 1723A E. E. Main. The deadline for receipt of the applications is Santa Fe 10 a.m. on Monday, Feb. 1.

Shotguns, rifles and bows are legal for taking this animal, subject to the regulations of the 1964 big game proclamation. All hunters must check in and out of a check station at the T. & T. Cafe in Lordsburg. The station will start checking in hunters at 6 a.m. on Feb. 19. All hunters are required to check out by 10 p.m. on the 28.

You may not apply for a license if you held a javelina license for last season. Javelinas are small animals with a maximum weight of about 60 pounds. The meat of the young javelina is succulent and tender, although care must be taken to remove the musk gland and cool and clean the meat. The little pig is found in three states in the United States—Texas, Arizona and New Mexico.





NOTICE OF SPECIAL ELECTION
Pursuant to the laws of the State of New Mexico and an order of the District Court of the State of New Mexico, in and for the County of Lincoln, entered on January 4, 1965, in the matter of the organization of Sun Valley Sanitation District, Lincoln County, New Mexico, No. 7654 pending in said court, notice is hereby given that a special election will be held on Friday, January 29, 1965, beginning at the hour of 8:00 o'clock a.m. and closing at the hour of 7:00 o'clock p.m. of said date for the purpose of voting a vote upon the following question, to-wit:

QUESTION
Shall "Sun Valley Sanitation District" in Lincoln County, New Mexico, encompassing the territory set forth in the Order of the District Court of the State of New Mexico and for the County of Lincoln, entered January 4, 1965, be organized for the purpose of purchasing an existing water supply and distribution system and constructing additional improvements thereto to constitute a complete water supply and distribution system?

At said election three persons who are taxpaying electors of the district shall also be elected to serve as directors of the proposed district if the organization thereof is approved.

Said election will be held at the following polling place: La Junta West Ranch at Sun Valley which is one mile north of Alto, New Mexico.

Notice is further given that only qualified taxpayers who are persons qualified to vote at general elections in this state, who have been bona fide residents of the proposed district for at least 30 days prior to the date of said election, and who have paid a general (ad valorem) tax on real or personal property owned by him or her within the district in the 12 months immediately preceding the date of election, are entitled to vote at said election. No registration shall be required in order to vote at said election, but each voter shall, before being permitted to vote, be required to execute an oath of election attesting a qualification. The voting at said election shall be by ballot. The ballot to be supplied the voters for their use at said election shall be the form set forth in the attached order of said Court. If at the election a majority of the votes cast are in favor of the organization of the district, the said Court at its Courtroom at Carrizozo, New Mexico, on February 8, 1965, at 10:00 o'clock a.m., shall declare the district organized, give it a corporate name by which in all proceedings it shall be known, and designate the first Board of Directors elected. Thereupon the said district shall be a governmental subdivision of the State of New Mexico and a body corporate with all the powers of a public or quasi-municipal corporation.

If the proposition to create such district carries, said district will contain all territory described in the notice of hearing on the petition for the creation of such district except for such territory as may have been excluded by the attached order of Court. Such notice was published in the Ruidoso News on December 18 and 25, 1964, and January 1, 1965.




