Real Wind, the Cinderella horse of the current quarter horse scene, captured Sunday's 13th running of the Rainbow

Quarter Horse Futurity at Ruidoso Downs. The filly — practically an unknown less than a month ago - ended the 400-yard dash with a full one-length lead and picked up \$120,858 out of the gross purse of

Real Wind now sports a perfect record of five wins from five starts. The Rainbow engagement was her first in stakes company, and she won with plenty of authority.

Jeff Fair got the riding assignment, once again. The filly is owned by J.D. and Elsie Kitchens of Ft. Sumner, N.M. Both are retired school teachers. Originally, Kitchens acquired Real Wind for a paltry \$2,000. A. D. Stowe does the training.

The fans established Real Wind as the betting choice on a muddy strip. The mutuel payoffs were \$6.60, \$5 and \$4.40. The winning time was 19.97 seconds. Real Wind's greatest hour — so far — was televised to a 15-state audience of some six

Megahertz, ridden by Terry Lipham for Larry Brumbaugh of Ft. Worth, turned in a hustling attack on the rail to finish second, earning \$58,070. The tote prices were \$6 and \$5. C. Ronnie Ferguson does

Third went to Cutie Kiss with Kenneth

Hart in the saddle. The filly picked up a paycheck of \$30,123 and handed out a show price of \$5.80. Cutie Kiss was only a neck behind Megahertz on the wire. The black filly is owned by Robert and Bruce Gentry Jr. of Lubbock.

My Easy Credit, the 7-2 favorite, came flying at the end to nail down fourth and earn \$15,969. The colt is owned by Harold Burford of Milton, Kans.

Here's the remaining order of finish with purse money earned: 5th - Faint's Deck (owned by Harold Knight of Bunch, Okla.), \$14,517; 6th - Roll A Coin (Mike G. Rutherford of Houston), \$14,154; 7th — Topless Dancer (R.E. Wise of Madisonville. Texas), \$13,791; 8th — Swinging Breeze (L.M. Bynum of Blanket, Texas), \$13,428; 9th — Kid's Rib (Gary Pogue and H.C. Werner Jr. of Kenedy, Texas),

Flight Director, a late scratch, collected \$12,339 nonetheless.

Even though Real Wind stormed under the wire in obvious control, the filly's handlers had to sweat out some anxious moments. Immediately after the running of the Futurity, Richard Bickel, who rode My Easy Credit, lodged a claim of interference against the winner.

A hush suddenly fell over the hefty crowd, and the stewards began reviewing the video tapes. The winner's circle, by this time, was filled with members of the winning camp. But everyone appeared to freeze, waiting for the verdict.

Finally, announcer Bob Dudich announced that Bickel's plea had been turned down, and a great roar shot up from the crowd. The intensity of the scream — and the jubilant dancing in the winner's circle - caught the composed Real Wind off

The filly gave a sudden start, and lunged toward the track, dragging several wellwishers out into the muddy slop. But she was calmed down quickly, and taken back into the winner's circle to get her picture

Bickel's point was that Real Wind drifted out sharply at the break, kept his horse from getting underway, then bothered him additionally in the first half of the race.

But the stewards, after taking a long scrutiny at the replay tapes, decided Real Wind's wayward course at the beginning did not bother My Easy Credit to any significant degree.

Real Wind, though slipping around, apparently, on some muddy turf, found clear sailing on the far outside and was

really jetting at the halfway point. Megahertz, never far off the early lead, moved powerfully in the final stages but never appeared capable of overtaking the leader.

Cutie Kiss, who got one of the early calls, evidently got a second wind as she neared the wire and was also trucking gamely at the end. My Easy Credit also gained plenty of prestige with the plucky way he poured it on in the final stages.

Swinging Breeze, part of a 7-1 betting. stumbled at the break and was never in contention.

Eleven Ruidoso high school students, accompanied by Raymona McAdams, English teacher, returned Thursday night from a five-country European tour.

The group left June 30 from Albuquerque with the Foreign League on Capitol airlines. Each student received one-half credit in Comparative Government and Cultures. They toured and studied in Italy. Austria, Germany, France and England.

The League provided a resident assistant who lived with the students in each country. Teachers in the country the students were touring offered classes and English-speaking guides were provided. The tours and classes were mandatory, with free time for optional activities.

McAdams, who completed her third tour with students, said, "It was very worthwhile. We had a wonderful time and went awfully hard. It takes time to catch up on sleep. It was devastatingly hot, but we incurred no rationing due to the

drought all over Europe.

"We stayed in student quarters which many American adults might consider primitive. There was not always hot water, but we did have three meals a day. We all became connoisseurs of hard rolls and bread.

"During our free-time we saw "Alda" in Rome, Leningrad's "Gizelle" in Paris and the stage play, "A Chorus Line" in London. We traveled by bus, train, boat and hover craft."

Students impressions were:

"It was all exciting. I like going to the . ballet, plays and opera. I enjoyed England and Austria the most" — Lisah Parks.

"I had a really good time. London was fantastic and I loved Austria. We did and saw a lot" - Zoe Ann Shaw.

"It was a lot of fun. I liked London the best, maybe because it was more like here. Austria is the prettiest and I liked the square in Venice. It was very romantic with violins playing" - Paula Ethridge.

"I'm glad to be home and saving my money to go again. It was my first time to fly over the ocean and that was exciting. I liked Austria the best because it reminded me of home. Eating escargot in Paris was terrific" -- Liza Cabot.

"Austria was the best and the people were the nicest. Italy had good ice cream. It felt good to go to London because we could read the signs and magazines for a change and the people were very nice" — David Scriber.

"I enjoyed England. We could understand and communicate. The whole trip was a real learning experience" — Gretchen Annala.

"I liked London the best because we could understand the people and they were nice. It was a good experience and I enjoyed it" - Patricia Reaves.

The error occurred through a monthly deduction for an annuity plan. Although the payments were sent in, they inadvertently were not deducted from the teacher's gross salary and the mistake did not surface for a

"It sure put a damper on my summer. I'd already been to and paid for summer school when the error was discovered," the teacher said.

Blood donors needed here

Blood Services of El Paso will collect blood Wednesday, from 2 - 7 p.m., in the conference room of Ruidoso Hondo Valley

"Previous donors are urged to contribute at this time," hospital laboratory director Chris Schneider said, "and an open invitation is issued to anyone able to donate blood to do so Wednesday."

All donors, whether already registered or first time, may call the hospital 257-7381 and ask for the laboratory, extension 35, to set an appointment time between 2 - 5 p.m., to avoid long waits occasioned by donors who are unable to come to the hospital until between 5-7 p.m.

"Blood Services, due to the expense involved in coming to Ruidoso, has set a minimum of 50 donors if they are to maintain a regular collection schedule here." Schneider said.

Blood collected in all of Blood Services operations is available to the Ruidoso

hospital in emergencies. In addition the hospital receives four units of blood weekly, with emergency supplies delivered by MAST helicopter or NM State Police relays. "Local cooperation will help insure, in

this time of a severe blood shortage, adequate supplies as well as a reserve source, if needed," Schneider said.

All blood from Blood Services is available to the recipient at the actual cost to process it, \$28 per unit, as Blood Services is a non-profit agency.

The Pink Ladies of the hospital will again provide juice and cookies for all donors during the rest period following the drawing of blood.

"The minimum number of donors is essential," Schneider said, "to insure that Ruidoso Hondo Valley Hospital will have a continuing supply of blood and one of our goals is to compile a list of donors willing to participate in each appeal to help attain

It is a story of a portion of William Bonney's life (that's Billy) . . . the portion dealing with the Lincoln County War . . . and how Billy the Kid did vow vengeance for the killing of John Tunstall and Sheriff Brady. And it's all about good guys and bad guys . . . and gunslingers . . . and there're posses . . . and lots of shooting . . . and bodies clutter up the landscape . . . and Billy's persecuted ... and incarcerated ... and he does engineer . . . on his own . . . 



A "hot rock dinner" is held at Carrizo Lodge during each session of the courses offered there. Not being an artist we were especially honored to attend one.



Betty Harless — her world is horses

"I'm fortunate to be where I am," Betty Harless commented. She has broken horses, shown horses, was a barrel racer, trained horses and is now a jockey at Ruidoso Downs -- she is doing well.

She has had horses all of her life but other girls are less fortunate. Betty is too modest to have told us herself but during our interview, Coy Hendricks, who is a trainer Betty rides for, interjected a few comments of his own. "Did Betty tell you about the horse she gave that girl in Tatum?"

She hadn't told us but that brought the story out. There is a girl, 13, in Tatum who has great potential as a barrel racer— Betty knew this— and since her parents could not afford a horse for her, Betty gave her one. She had already trained the horse — she loaded it in a trailer and drove to Tatum and back in one day to deliver the horse to the young girl.

When pert, petite Betty had come bouncing into the horsemen's cafeteria that morning we noticed that there was a young girl with her. She was Susie Baker, 11, and we found out Betty is also working with her and helping her with barrel racing. When we asked Susie if she wanted to be a jockey like Betty she smiled and said that she did.

Betty enjoys working with girls. In fact she has a four year old daughter herself who is already riding. She began riding when she was two. Betty said, "I find it a when she was two. Betty said, "I find it a little harder working with my daughter because I may expect more of her, but working with the other girls makes her want to do as well as they are doing."

She commented, "You can give someone a fish and it lasts one day but teach them

a fish and it lasts one day but teach them how to fish and they can enjoy it the rest of their lives." Betty gives of herself and receives satisfaction from seeing the girls excel at rodeos and in their riding ability.

Betty lives with her mother and daughter, Charmin. It may sound glamorous being a girl jockey but it is hard work — and it is still a man's world. It's a seven day a week job and her day begins at 6:30 a.m. when she hits the track to start galloping horses. When asked if she dates, she replied, "Not very much, I'm too tired and you can't afford to stay out late because it's important to stay in shape in because it's important to stay in shape in this business."

Being a girl jockey is rough and Betty

says she has to hustle all the time. But recently she won a race on a horse named Nobody's Perfect and in Belly rown words he's a real butlaw horse." Even some of the guys are leary of him but he responds to Betty and she can handle him. Nobody's Perfect even has a girl groom.

Betty may not ride every race day but her percentage of wins to the number of mounts isn't bad. One day recently she rode in two races and won them both. Later she said she realized that she had won the fourth race on the four horse and the eighth race on the eight horse, quite a coincidence.

Betty rides both quarter horses and thoroughbreds. She is concentrating right now on five hopefuls for the All American. She feels out of the five at least one will qualify for the All American Futurity. She plans to stay with them and hopes for a shot at the big race.

An accident interrupted her career here last year when she took a spill while

Cut the fish into 1/2-inch chunks and place in a mixing bowl. Cover with salted cold water. Allow to stand for about half an hour. Drain off the water and add enough lime juice to cover the surface of the fish. Marinate in the lime juice at room temperature for at least 2 hours or in the refrigerator for 3 - 4 hours, stirring occasionally.

When ready to serve, drain off liquid. Place fish in serving dish, add the green onions, tomatoes, green pepper and salt. Pour on the coconut milk or cream and stir gently but thoroughly until everything is

well mixed. Serves 6. Coconut Milk

Pour 2 cups boiling water over 4 cups fresh grated coconut meat. Allow mixture to stand for half an hour. Strain through a double layer of cheesecloth, squeezing to remove all milk. Cover and store in refrigerator. If you like a richer version (coconut cream), pour 2 cups boiling water over 6 cups grated coconut meat and proceed in the same way. After it is chilled, a creamy, thick substance will rise to the top. If you use dried coconut, substitute hot milk for boiling water. Either coconut milk or cream can be used in I'a

Now if you can't pretend enough to enjoy raw fish here's another Tahitian recipe for roast pork!

IO PUA 1 pork loin roast (4-5 pounds) Marinade: 2 cups dry sherry

juice of 1 fresh lime 2 tbs. Soy Sauce

¼ cup fresh or canned papaya, mashed 2 tbs. minced fresh ginger 1 clove garlic, crushed 1 teaspoon salt

Mix together all marinade ingredients and pour over the roast. Marinate in refrigerator for several hours or over-night. Roast in a preheated 325 degree oven, basting occasionally, until meat thermometer registers 185 degrees or about 3 hours. Serves 6.

CHALLENGE TIME

The greatest moment of bell ringing and jubilation is past, now. We are in our third century as an independent nation. The emphasis is no longer retrospective: Where have we been, what did we achieve? The question Americans must now ask themselves is, in sum: Where do we go from here?

There is an easy answer: We just move on along the same road, doing about what we have been doing, working hard to build the economy and keep our standard of living on the rise, maintaining our defensive strength at a level-chest to none, fulfilling our role as two perhaps also (as time and energy in the strength of the strength o strengthening the conditions that nur we equality and justice.

That may seem like enough, but as noted above it is an easy answer. The times demand something better.

The American Bicentennial coincides with an historic juncture in human affairs. Mankind is confronted with momentous problems: excessive population growth, dwindling resources, global degradation of the environment, a precariously slim leash on the threat of nuclear holocaust. These and other major concerns cannot be evaded; they must be dealt with. Our country's leading position in the world community requires of us that we bear a commensurate share of the burden of decision, action and sacrifice for the common good of man.

But isn't that straying from the Bicentennial theme? Not at all. The global challenges and the challenges here at home are interwoven. They are part of the same fabric. We can best measure up to our world responsibility by striving to realize more fully the potential the Founding Fathers envisioned. To do this we must drink deep at the American wellsprings, and dedicate ourselves anew to the great underlying principles upon which this nation was founded.

Aragon, 46, seeks his sixth House term in the general election. He was bounced out of the House majority whip's job by the House-controlling Mama Lucys in 1973 and replaced with Rep. Abel McBride, D-Albuquerque.

The present House division is 51 Democrats and 19 Republicans, Democrats are topheavy favorites to retain House control. The Mama Lucys elected Rep. Walter Martinez, D-Grants, as speaker in 1970, Martinez is expected to seek re-election to the powerful post. Martinez edged Fettinger in a torrid race in the House Democratic caucus. The first ballot was tied. Three House members, still unidentified, switched to give Martinez victory.

Rep. Aragon claims: "We have anywhere from 28 to 29 votes that are pretty well committed to us. We can't mention names because we promised the people that are with us that we wouldn't do this. Because there's an election coming up and we don't want people fighting in the campaign. This might start people campaigning against some of the candidates."

Rep. Aragon says: "We have had several meetings throughout the state. We call ourselves the "Responsible Legislators for the State of New Mexico" period. We are not the Mama Lucys. We. want people who will be responsible to the people throughout the state and not to just one little group."

Rep. Aragon says: "One of the main reasons this is happening is that we will not have one person serving as chairman of a committee and as vice chairman of another committee. We are going to spread the responsibility of the House on a wider base so that the responsibility is spread throughout the state."

Several Mama Lucys are on the key Appropriations-Finance Committee and also are chairmen of other important House committees. Mama Lucys also hold key interim lawmaker committee

assignments.

Rep. Aragon says: "The way the House is right now we have 51 Democrats. The way I see it, it won't be more than that in 1977. It could be less. I don't think it will change. If the people who are with us now stick to their guns, they cannot beat us.

"We do have the horses. We have more than enough votes to win if the House stays the way it is. If the Republican membership increases, we're still all right."

But the Mama Lucys — named for a popular former Las Vegas restaurant owner — still exert much muscle. They have managed the House for six years and will not yield control easily. Aragon contends: "The reason I'm not whip today is that they could not get me to go along as a rubber stamp for anybody, for the same

U. S. Sen. Pete Domenici, R-Albuquerque, will attend the National Republican Convention at Kansas City Aug. 16-19. Domenici's daughter, Lisa, 17, will be a page at the powwow. The Ford campaign wants Domenici in Kansas City to woo delegates for Ford.

Mrs. Mary Kay Stinnett, Portales, will be a Kansas City convention visitor. She is Roosevelt County Republican chairman. Mrs. Stinnett was a Ford supporter in the in-state Ford-Reagan fracas won by Reaganites.

Boat safety starts with common sense

safety, says Charles M. Hohn, Extension agricultural engineer at New Mexico State University.

Match your boat, motor and equipment to your particular ability. For example, one person in a 12-foot boat with a 3horsepower motor may be safe on a small lake. But loading 4 people in the same boat with a larger motor in a large lake can lead to disaster, cautions Hohn.

Make sure your boat and motor are in safe and sound operating conditions before each trip. Balance the load carefully and keep everyone seated in small boats. Be sure that you have adequate safety equipment to handle emergencies.

Most boats have a rating place attached on the back which states load and horsepower limits. These are maximum ratings, not necessarily the recommended

Carelessness often plays a part in boating accidents. Life jackets too often

Common sense, proper equipment and are thrown in the bottom of the boat "know how" are important to boating because they are too clumsy or awkward to wear. Hohn says that one possible solution is to wear a lightweight waist-type water-ski preserver and have an additional approved jacket or cushion for each passenger in the boat. Be sure that all life-saving devices are in good and serviceable condition.

Experience is the only way to acquire skill at handling a boat under varying weather and water conditions. Don't go out if the water is rough. Head for the shore if a storm warning is posted. In an emergency or in extremely bad weather, head into the wind and pull into the nearest shore rather than trying to get back to home port.

If you do have an accident, stay with your boat. Many boats are equipped with built-in flotation devices that keep the craft afloat. People hanging on to an overturned boat are safer and much easier to spot in the middle of a lake or river than are individual swimmers, adds Hohn.

Pyramid sales schemes always dupe investors

The lure of big money and instant profits through a sales scheme - known as multilevel distributorship or pyramid sales dupes investors every year. Potential investors should be aware of the pitfalls of these marketing schemes, says Jackie Pinson, Extension family finance specialist at New Mexico State University.

Here is an example of how one multilevel distributorship scheme works. The marketing plan provides four levels of distributors. They are retail distributors, sub-wholesalers, direct distributors and general distributors. The level at which you operate usually depends on the amount initially invested.

In addition to sales, emphasis is placed on recruiting other distributors to earn more money. Investors at certain levels were required to buy from distributors above them, but any level of distributor could sell on a retail basis to the public. The endless recruiting system requires the participation of more and more people until the saturation point is reached and no one else is interested.

If the new investor is required to pay an investment fee to become a distributor and also has to buy the products he intends to sell, he may be left holding the bag and have a garage full of unsold products.

In fact, this does happen, Miss Pinson says. One victim ended up with his garage filled with unsold automotive additives. Another family reported losing \$8,000 in a

beauty products sales scheme.

Investors should be leary of any program which places most of its emphasis on recruiting distributors and subordinates, without apparent limit. Your investment return and income come mainly from recruitment fees, overrides or bonuses for enrolling more distributors.

If unspecific or extravagant earnings are promised without regard to your own selling experience, beware. These

schemes also usually place emphasis on efforts of others you may recruit to sell, inducing you to engage friends and relatives as income producers.

You should also shy away from plans in which the amount of your investment for a distributorship is sizable, with little relation to immediate inventory needs. There are usually no provisions for refunds on merchandise that you do not

Be leary of programs in which the opportunities and distributorships offered are unlimited with no protection provided for early distributors.

Before entering any agreement to sell, consult a lawyer about the contract you are required to sign. What you are told may be far different from the contract requirements. The contract may be binding unless you can prove misrepresentation, the NMSU specialist says.

ACTS OF COURAGE SILAS DEANE AND DIPLOMACY SILAS DEANE AND DIPLOMACY

Silas Deane carried a very heavy burden as he sailed to France in 1776. Appointed as the first official American representative to a foreign country, Deane was instructed to obtain supplies from French citizens or the French government and to gain official French recognition if at all possible.

Deane was a popular man in Congress and a leading revolutionary figure in Connecticut, but his experience did not give any indication that he had the ability to deal with an autocratic monarch and his crafty foreign minister. Subsequent events proved that the first choice of Congress of a foreign diplomat was not the wisest decision it ever made.

Of course, in Deane's defense one must remember the sensitive French position that Deane had to overcome. France had to be very careful before it provided any public support for the rebellious colonies.
On August 11, before word of the
Declaration of Independence was received in France, Deane was received by the Foreign Minister, Count Vergennes.

The Count was pleased to hear Deane's prediction that the Americans could hold out until the end-of the year. Should the colonies declare themselves independent, Vergennes implied that open French

support might be forthcoming.

Following another meeting on August 20,
Vergennes promised arms to Deane and
recommended Caron de Beaumarchias as
the private agent to deliver the goods.
Beaumarchias, therefore, arranged for
the sale of merchandise on credit amounting to three million livres.

Even though Deane obtained the badly needed arms, this transaction plagued him to the end of his life. In 1778 Arthur Lee claimed that the goods were intended as a gift from France and that Deane and Beaumarchias had profiteered on the

transaction. This issue became such a controversial matter that Congress spent far more time on it for two years than it should have. Because of unavailable documents, Deane was never able to settle the matter. He was

was never able to settle the matter. He was ruined financially, and his reputation suffered from the dispute. Like others, Deane, whether, guilty or not, suffered greatly in the service of the new nation.

In a way, the Dominguez - Escalante expedition now underway in the Southwest also had diplomatic objectives. Primarily designed to open a route from Santa Fe to Monterey, California, for the benefit of all

Freezing captures flavors

Freezing can capture the summer fresh flavor of the produce from your home garden, says Mae Martha Johnson, Extension food specialist at New Mexico State University.

Freezing preserves quality — it does not improve it. So pick and freeze in small quantities. Rush the vegetables from the garden to the freezer.

Packaging materials should be moisture-vapor proof, durable, leakproof and easy to seal and mark. Rigid containers made of plastic, glass or aluminum are suitable, as well as plastic bags with or without waxed cardboard covers. Glass canning jars with straight sides can also be used successfully.

All vegetables, except green peppers, should be blanced or heated before freezing. Blanching stops enzyme action and helps preserve color, flavor and texture, says Mrs. Johnson.


Packages should be placed in the coldest section of the freezer for initial freezing. Food should be frozen as quickly as possible, so don't overload the freezer. Add only as much food as will freeze within 24 hours. This is usually two to three pounds

for each cubic foot of freezer space.

A readable label and a current inventory will help keep use of frozen foods up-to-date, the specialist says. Foods which have been frozen for the longest periods of time

should be used first. If the electricity goes off for a period of time, don't panic. Don't open the freezer. Food will stay frozen for one to two days if the freezer is filled with food and the door. is not opened.
