# Downs mayor: 'MJ sold at grade school'

Charges of marijuana traffic at the Ruidoso grade school were leveled at Monday's Ruidoso Downs trustees' meeting by Mayor Norman Wheeler, during a session in which the trustees passed a marijuana ordinance, aired garbage container problems and heard pointed complaints and positive responses to security and policing problems in the Hollywood Inn.

The trustees adopted an ordinance declaring possession of one ounce or less of marijuana to be unlawful, with violators to be tried in the Village municipal court.

The first offense carries a penalty not to exceed a \$50 fine and 15 days in jail. The second and subsequent offenses will be punishable by a fine not to exceed \$300 and 90 days in jail.

Amounts over one ounce will still be tried in Magistrate or District court.

Mayor Norman Wheeler said, "We have passed this ordinance because our police department has been embarrassed due to the city having no ordinance against marijuana. The DA won't mess with the little cases in district court; he just wants the big ones. In Magistrate court, Mr. Hart has been letting the offenders go or dismissing the cases because he doesn't want to step on any toes in an election year and I don't blame him."

"MARIJUANA IS BEING SOLD in the parking lot at the grade school every day at noon. Being a father, I guarantee you I don't want anyone selling my kids dope."

PAUL LUKENS, Ruidoso Chief of Police, upon being advised of the allegations made by Mayor Wheeler, and asked for a statement by The Ruidoso News, said, "No comment".

In other action, the council agreed to amend present ordinances involving trash containers. It will adopt an ordinance requiring each village resident to store their trash in a container within a rack, off the ground, and with securing lids. "A lot of these people around here cry poor mouth, but they buy good whiskey at my place. They can do without booze for a couple of days and buy adequate trash containers so the dogs can't strew the trash 10 miles in each direction," Wheeler said.

During the discussion to amend present ordinances, several people in the audience voiced their opinions that there would be no trash problem if the dog problem were eliminated. Wheeler said, "We're trying to work out a solution, but it's a matter of money. Do any of you want to make the first \$500 contribution for a dog pound?"

Trustee M. H. "Boots" Nelson asked whether the village has ordinances requiring bars or lounges with dance halls to hire security guards. It was determined that there are such ordinances on the books and the need for a security guard is "up to the discretion of the Chief of Police."

MARIE POWELL, owner of the Hollywood Inn, accompanied by two co-workers, objected to having to hire a security guard at \$5 an hour when he was ineffective in checking minors or quelling

fight. She said the Ruidoso Downs police should be responsible for keeping order.

Chief Lynn Martin said they would respond when called, as it was their duty, but that the village hasn't the manpower to answer repeated "fight calls". Powell then said that when the Ruidoso Downs policemen come into the Hollywood Inn that they sometimes stay over an hour and she requested their visits be limited to 15 minutes.

Martin and Wheeler told Powell the patrolmen often go into her place of business to observe possible suspects and that their presence can preclude a fight situation.

"WE'RE NOT GOING to bounce the place for you and we're certainly not in there to harass you. I will never step a foot inside to check the place again unless we're called," Martin said. "You're the first bar owner in this town to complain we're there too much. They usually complain we're not checking often enough and if your customers are made nervous by our presence, maybe you should get other kinds of customers."

The council agreed to table further discussion and check into the validity of the present ordinances requiring hiring of security guards, particularly in the winter months. They agreed that, "for the time being, the Hollywood Inn can operate without a security guard providing the owner can control the situation."

STREET IMPROVEMENTS totaling approximately 1 3/4 miles were assured by the receipt of a cooperative agreement from the NM State Highway Department, with the village share pegged at 21.46 per cent, or about \$10,300 of the estimated project cost of \$48,000. The improvement specifications call for a three inch sub base and a double penetration driving surface on a 20 foot street width.

The project will include the East Spring Street junction with US 70 to the junction of B Street and Spring Park Subdivision, B Street west to Reservoir Road, Reservoir Road from A Street to its junction with Entrance Road, Entrance Road west to Second Street, West end of Entrance Road

north to US 70, North on Second Street to US 70, from US 70 south on Height Drive to East Circle Drive, Entrance Road north of US 70 from the service road exit to the bridge.

DESPITE OBJECTIONS from the Mayor and Fire Chief Ray Walker, the council voted that any expenditure over \$100 must be approved by the council prior to the purchase. Wheeler said, "I need more cooperation from this council and I can't run down each trustee especially since two of you have no telephones." Walker said, "We are working on a grant and when I need a hundred dollar nozzle or other emergency equipment, I'm not

## Mayor Wheeler issues further drug statement:

Ruidoso Downs mayor Norman Wheeler early Wednesday issued the following statements to The Ruidoso News, concerning his remarks on the drug problem made at Monday's Ruidoso Downs trustees' meeting.

"We are working on it. The Ruidoso Downs Police Department is working on the alleged drug pushing problem at Nob Hill School."

"We do know that it is being sold at the high school parking lot and though we have no proof of this, it is suspected it is being sold at the grade school."

"It's the kind of a deal where you

have to catch them right smack in the act."

"We're hopeful of getting anything. They play it real cool."

"It's been going on at the grade schools for two or three years. We [Wheeler and the Ruidoso Downs police] know about it and I think somebody should do something about it, but it's out of our jurisdiction. It's being sold every day at the high school parking lot. Everyone knows it's going on."

"I'm not at liberty to tell you what we're doing, because it would blow the whole thing."

## Area health agency seeks appointee recommendations

Nominations are open for membership on the Planning District VI Health Systems Agency Subarea Council, serving Chaves, Eddy, Lea, Lincoln and Otero Counties.

Selection of agency members will be made Nov. 17 by the executive committee of the Southeastern New Mexico Economic

Development District.

Appointees must be residents of one of the counties in District VI with the membership to be broadly representative of the social, economic and geographic character of the area.

"What we're interested in," SNMEDD chairman Bill Hart said, "is to have people nominated who will be willing to work,

serving without pay, on health and hospital problems in the five counties."

The rules of the NM Health Systems Agency and federal law require that the Subarea Council be composed of a majority but not more than 60 per cent consumers and that the remainder be providers, of which not less than one-third are direct providers. Representation of

local governments is encouraged.

SNMEDD is soliciting nominations by individuals and/or groups, with written nominations to be mailed to P.O. Box 6639, Roswell, NM 88201, to be received by 4:30 p.m., Nov. 11. "All written nominations received prior to this notice," Nick J. Pappas, SNMEDD executive director, said, "will be considered."

## Village asking trash system bids

The Ruidoso village trustees Tuesday approved issuance of a call for bids for a new garbage pickup system to serve the business district and, at the outset, selected heavily populated residential areas, such as mobile home lots and condominium sites.

The system, operated on a trial basis last summer, requires animal-proof containers which are picked from the street and dumped into the truck's storage tank with a hydraulic system. The truck is designed for one man operation.

The call for bids, with the specifications suited to Ruidoso, will include the possibility of trading in one of the present storage compartments used on a rented truck body and chassis.

The village currently leases two truck units at \$500 a month each, with the leases to expire in December.

The plan under consideration will call for a lease/purchase agreement over a five year period. Cost estimates of trucks and containers indicate that the overall expense of the proposed operation, over

five years, could compare favorably to the present method of collection.

Under the proposed system the two loading units can also be loaded by hand, from each side, in areas where pickup points are scattered, or on hills, where automation cannot be employed.

In other action, the trustees: — Authorized village attorney John W. Thompson to prepare an ordinance preparatory to holding an election, tentatively set for Dec. 14, to authorize the collection of an additional 1/4% sales tax. Prior action by the trustees instituted the first 1/4%, which could be authorized solely by council action.

— Agreed to the request of Wayne Dacy to use space near the Hollywood Well for parking. The land will not be leased to Dacy and preparing and maintaining the lot will not be a village expense. The trustees stipulated that there could be no

restrictions on who used the parking facility.

— Acknowledged receipt of a letter from Cablevision of Lincoln County announcing intent to abide by existing franchise regulations.

— Announced that the Comprehensive Plan for the future growth of Ruidoso, as coupled with a similar plan in Ruidoso Downs, will be up for acceptance at the 7:30 p.m. Oct. 20 meeting of the Ruidoso Planning and Zoning Commission in the Multi-purpose Room of the Ruidoso Library.

— Were advised that the Eagle Creek Intercommunity Water Users Association will meet at 7:30 p.m., Friday in Captain's village hall.

— Authorized pursuance of a possible \$87,000 in grant monies to offset some preliminary expenses in connection with the proposed Eagle Creek dam.

## Swine flu vaccine decision due Friday for state residents

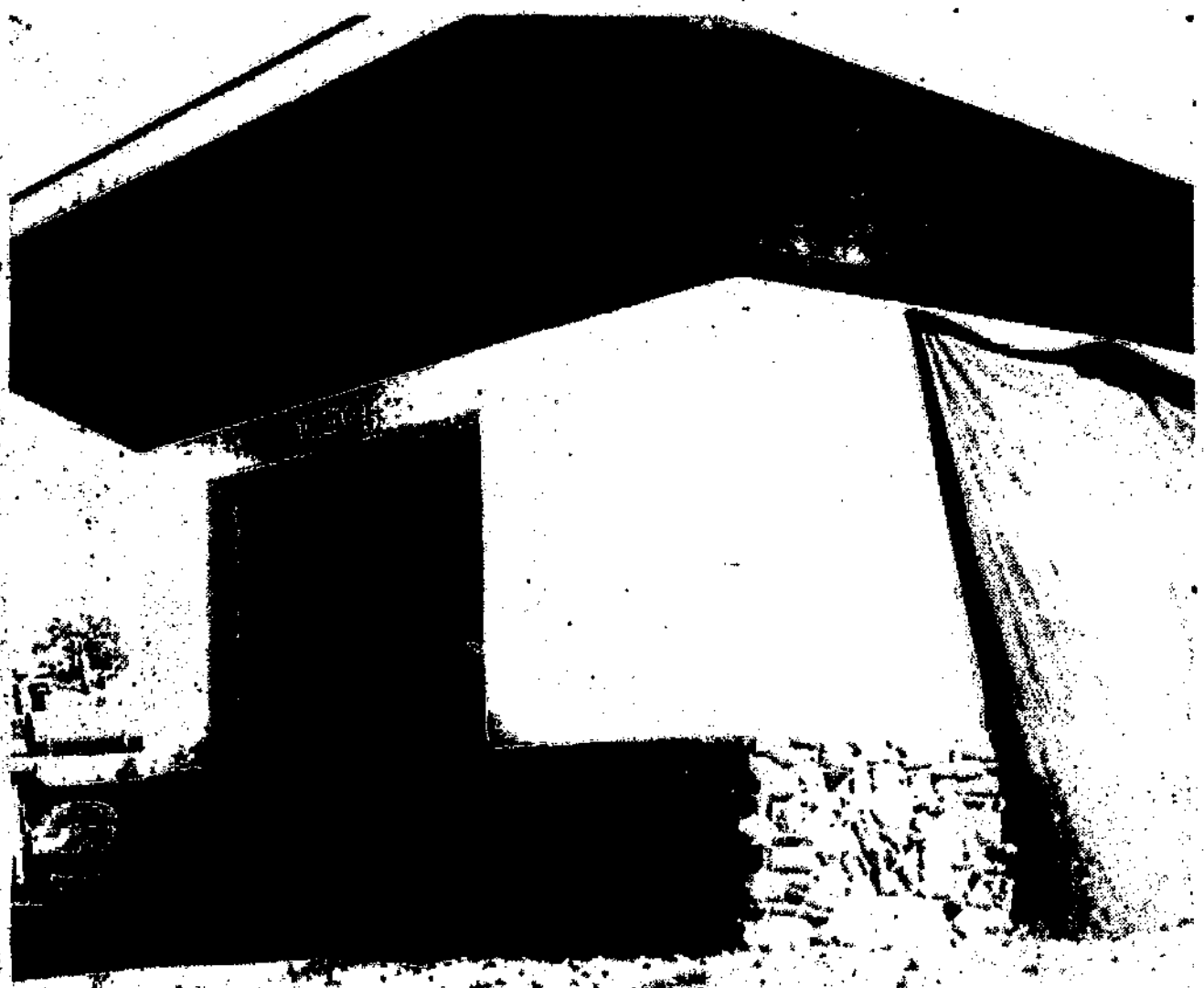

## School evaluation report to be given this evening

Pat Valliant, superintendent of schools, announced at Tuesday's school board meeting that a ten-person evaluation team from the State Department of Education will present its findings on the Ruidoso school system in a public meeting tonight at 7:30 at the Ruidoso High School library.

The team spent three days this week completing an in-depth study of the schools' curriculum. The group is composed of Janet Malone, early childhood; Sandra Barker, reading; Dell Ohlms and Jean Page, career education; Helen Thompson, visual arts; Rolie Helman, music; Sterling Garwood, math; Joe Baca, social studies; Mike Glover, ad-

ministration and secondary English and Bev Graham, science and physical education.

"This study is very important to our school system and very valuable to us. We urge all interested persons to attend tonight's meeting to hear the findings on what's right and what's wrong with our schools," Valliant said.

Dave Parks, board president, reported members of the school board had toured the new complex under construction at White Mountain School Tuesday. "It's coming along extremely well," he said. Architect Rem Alley of Alley and Associates, Roswell, accompanied the

board members on the tour and said, "There are no major problems. It's gone very smoothly from our viewpoint."

In other action, the board: — Granted a hearing on attendance policy to two students who violated the policy last school year.

— Received a waiver from the State allowing enrollment of 30 kindergarten students per session rather than the prescribed 25.

— Approved two budget transfers.

— Approved a draw of \$176,584.50 to the contractor.

Parks said that as the faculty increased, it has become traditional to have the October meeting at White Mountain to meet the staff and tour the classrooms. ## Clipped Comment

### BY ANOTHER NAME

Sticks and stones we've never thrown, but we've harmed a few with words over the years no doubt. Maybe it's a good time to say we're sorry and we didn't mean it.

About the only time we ever get into trouble with a typewriter — or our mouth, for that matter — is when we don't mean to. Anybody can be ugly and be understood. It takes a good bit more skill to feign ugliness and be misunderstood.

Nicknames seem to present a special hazard in this area. Personally, we think the word cop is perfectly acceptable when referring to a member of the village constabulary, but not everyone would agree.

The setting and context has a lot to do with appropriateness. Officers seems a sensible term when discussing them at a public meeting, but do you suppose the kids on the block would ever consider playing officers and robbers?

Besides, cops call themselves cops, and the simple, declarative sentence, "He is a good cop," is just about the finest accolade anyone could pay to a member of the law enforcement profession.

Ethnic groups present a special problem. Most of the hyphenated terms are out of vogue. Spanish-American and Mexican-American were stilted constructions and are no longer necessary. Spanish or Mexican is descriptively adequate, and has outlived its once odious stigma.

Sensitivity toward ethnic allusions is usually overcome when it is a two-way street. Some of the best human relations examples we know of are in groups where the members refer to one another as gringos and Mexicans, and always in totally good humor.

Negroes have an especially acute problem. They don't like colored and aren't especially fond of Negro, and in recent years have themselves popularized the term black, which has been resurrected from pre-civil war times when it meant nothing more than human property. Even after this, if they like it, it's fine with us.

Nigger has retained its ugliness and has never been suitable for any place except cruel racial jokes and novels about the Old South. Even in those contexts we cannot hear or read the word without mentally flinching.

In this part of the country we have no appreciation for and sometimes no understanding of other ethnic terms. When Archie Bunker talks about wops and polaks, half of his audience in Lovington is lost.

We frequently refer to Church of Christ members as Campbellites and they usually take it in good humor in spite of the fact it is an inaccurate allusion. Baptists used to be called hardshells but that seems to be passing. Are they softening up? Methodists, of course, fall from grace so

often they are referred to as backsliders. Incidentally, the word Methodist is itself a nickname, having been adopted from the methodical habits of followers of John Wesley.


Both Baptists and Methodists love "the chief seats at the council" and fall over themselves to be First. They are second only to banks in the illogical assumption that First means first.

And often we are oversensitized about our work. Title puffery is rampant. There may be no janitor jobs remaining. Even custodians have given way to maintenance technicians.

Or choking self-consciousness even extends to the products we make or deal in. Ever see a lingerie salesman who peddles underwear? Or, ask a mobile home dealer how much he wants for his trailer and he'll risk the sale to remind you it's no trailer, it's a mobile home.

But after you buy it you'll still call it a trailer, and when you run an ad in the Leader to sell it that's what everybody else will call it too.

Besides foolish consistency, nickname vanity is the hobgoblin of little minds. — Hop Graham, Lovington Daily Leader

# Apple art for kids

## ... a creative activity

Mix apples, kids, fun and imagination and you get apple art.

Nob Hill Elementary School students, supervised by Betty Day, teacher's aide, are creating withered granny figures, witches, plaques and pictures — all made from apples and their by-products.

The apple art will be entered in the Apple Harvest Arts and Crafts Show in Lincoln October 16-17. First through sixth graders throughout the county can enter and a red, blue or white ribbon will be awarded each exhibit.

The kids peel apples, carve facial features in them, wait about six weeks for completion of the drying process and a decrepit face is created. Apple seeds are then placed in the face as eyes. The body is formed from insulated wire covered with

modeling clay. The creature is then clothed in hand made clothing or duds borrowed from a favorite Barbie doll.

An applewood log is cut in discs which are polished and mounted. Students discovered an apple hiding within one log they cut up.

A plaque which could grace the walls of the most gracious home is made from thin slivers of apples, complete with leaves and stem, which were covered with a clear plastic varnish and mounted on wood.

And the sawdust from the log cutting is not tossed in the trash can. Students retrieved it, sprinkled it on glued paper and came up with clever picture designs.

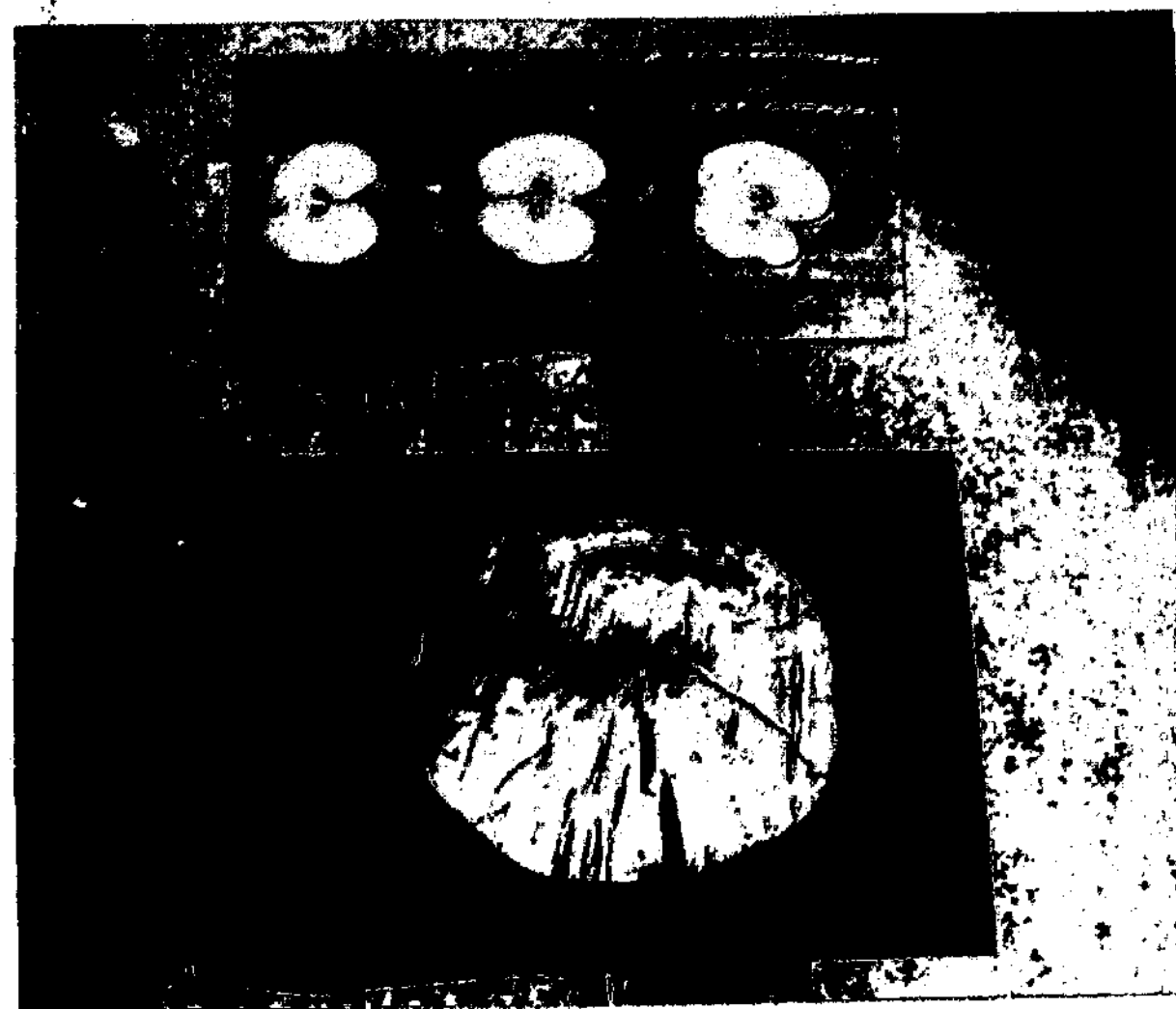

## News from the County Agent

As there are very few cattle contracts being written, you might consider feeding your own cattle in a commercial feedlot. Before putting your own cattle in the feedlot, be sure they now eat out of a feeder and use water from an automatic water trough. Anytime cattle are moved they are put in a stress condition. If they know how to eat from a feeder and find water they will go on feed quicker and better with less weight loss.

It generally pays to feed your cattle out of a feeder at home before they are shipped. How the cattle go on feed often means the difference between a profit or loss.

**Time to Repot House Plants:** Late summer and early fall is an ideal time to repot house plants. Repotting prepares house plants for the winter season and improves their overall performance. Use a good soil mix to get the repotting process off to a good start. Such a mix may be made by combining two parts each of garden loam and peat moss and one part of sand. Well rotted manure or shredded leaf mold may be substituted for the peat moss.

Garden soil alone is seldom suitable for potting plants because it is usually too low in organic matter. A good soil mixture provides the three things potted plants need most — support, good soil aeration and the ability to hold adequate moisture and nutrients.

Pasteurize the soil mixture to kill disease organisms, insects and weed seeds. This can be done by putting the soil mixture in a shallow pan and placing it in a 200 degree oven for 30 minutes. The soil should be moist but not wet when placed in the oven. As soon as the soil cools, use it to pot new plants or reset old ones. Always use clean tools and new pots or you will reinfest the soil with harmful organisms. Sterilize used clay pots in the oven and wash plastic pots thoroughly in hot soapy water.

# Inside the Capital by Fred Buckles

CLOVIS — Farmers and ranchers underscored low prices at a candidates' forum that drew 300 in Clovis.

New Mexico Farmers' Union, headed by Quay County farmer Paul Hudson, sponsored the forum. U. S. Sen. Joseph M. Montoya, Santa Fe Democrat, said: "I think you're going to have a real farmer (Jimmy Carter) in the White House."

Montoya and West Virginia Sen. Robert Byrd, campaigning with Montoya, said a farm bill will be introduced next year in Congress. Byrd played his fiddle in shirt-sleeves and won warm applause. U.S. Rep. Harold Runnels, D-Lovington, said: "If this nation is to remain strong and free, then agriculture must remain strong and free."

Runnels is heavily favored to carry Curry County Nov. 2. Montoya will likely lose Curry to Silver City Republican Harrison Schmitt. But Kenneth White Jr., Carter Curry County chairman, predicts Carter will win Curry by 1,000 votes and Montoya will carry Curry "by a bigger margin." Sen. Montoya lost Curry in 1970 to Lovington Republican Anderson Carter by 632 votes.

Sen. Montoya campaigned in Eunice, Jal, Tatum, Hobbs and Lovington in Lea County. He underlined his seniority and experience in 12 years in the Senate. He stressed the oil legislation he has sponsored. He opposes divestiture of major oil companies, a sensitive issue in Southeastern New Mexico.

Byrd, who claims enough votes for election as Senate Democratic majority leader in January, told Hobbs and Roswell audiences he opposes horizontal and vertical divestiture. Byrd hammered hard on the "investment" New Mexico has in Sen. Montoya in his service in Congress. He emphasized Montoya's key committee assignments.

Our soundings in Lea show Schmitt will carry Lea. The Ford-Carter race in Lea looks close. Jimmy Carter's Albuquerque speech last Friday may have tipped some voters in his direction.

Montoya concedes Chaves County to Schmitt. He has campaigned hard in Chaves County. He says he is trying to reduce the margin. Schmitt has canvassed strongly in Chaves, too. Carter will lose Chaves to Ford by a big margin and Schmitt will swamp Montoya if we read the auspices accurately.

In legislative races ex-State Rep. Lawrence Goodell, D-Artesia, looks like a winner over Artesia Republican Louis J. Bacher in Chaves-Eddy Senate District 33. In Curry County House District 65 State Rep. John Hays, D-Clovis, is favored over retired postal employee Emzy W. Gaydon, Clovis Republican. Clovis Democrat Caleb

Chandler is the apparent leader over highly regarded Clovis Republican Tom Battin for a Curry County Senate seat.

A close race is expected in a Guadalupe-DeBaca-San Miguel Senate district between Sen. Ray Leger, D-Las Vegas, and ex-Sen. Junio Lopez, R-Las Vegas. Leger defeated Lopez in 1972 in a heated race.

Eddy County may hand Jimmy Carter a small edge over President Gerald Ford. Montoya, aided by organized labor, will win Eddy handily.

Otero County is safely in Montoya's camp. But the Ford-Carter race in conservative, heavily Democratic Otero is close. Deep voter apathy is apparent in several East Side counties.

Chip Carter, 26, eldest son of Jimmy Carter, campaigned for his father in Farmington, Las Vegas, Carlsbad and Lovington. A peanut farmer, he displayed a welcome sense of humor and a grasp of issues.

Jimmy Carter attacked Ford's credibility before 7,500 in Albuquerque's Civic Plaza. He was on the offensive throughout his speech. The partisan crowd received him warmly but the effect on the presidential campaign in New Mexico was not immediately clear.

The Schmitt-Montoya and Ford-Carter races in Southeastern New Mexico look close over-all after a swing through Curry, Lea, Chaves, Eddy and Otero Counties. Voters view Carter as an unknown quantity but the Democratic push for Carter is strong.

Republicans present Ford as a president who has proved himself asking for a full four-year term. We often heard the comment from voters that the presidential race is a "choice between two evils." Voters in Curry, Lea and other areas are not turned on by Ford or Carter.

Significantly, Congressman Runnels seldom mentions Carter in his campaign talks. Runnels is running far ahead of Portales Republican Don Trubey in U.S. House District 2.

Hobbs Ben Alexander, Carter New Mexico chairman, says Carter is strongest in Northern U.S. House District 1, exclusive of Bernalillo County, and weakest in Bernalillo County. Alexander says the Ford-Carter race is even in Southern District 2. The Carter campaign brought 96 "Peanut Brigade" Georgians to New Mexico.

Contributors to the "Yes For Two" Committee campaign for two four-year terms for elected state officials included Karl Butt, Clayton, \$500; Mr. and Mrs. Donald Callaway, Eunice, \$500; Al Rosa, Sunland Park, \$500; George Gabaldon, Belen, \$1,000; Mr. and Mrs. Steve Gabaldon, Belen, \$500.

As a foster parent, you are responsible for the horse and own any foals it may produce throughout the years; however, the BLM or Humane Society can and may send representatives by your place to make sure the horse is being properly cared for, not sold for profit or used for commercial purposes. The government says it can no longer care for the thousands of wild mustangs and burros in the west, thus the birth of the "Adopt a Horse" program. The adoptive parent must pick up the horse wherever it's rounded up — could be New Mexico, Colorado, Utah, Idaho, southern California or Wyoming. For more information, write Adopt a Horse, Bureau of Land Management (330), Washington, D.C. 20240.
